The ornamental design for a cigarette package, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a cigarette package with an overlay sheet;

FIG. 2 is a top plan view of the package;

FIG. 3 is a bottom plan view of the package;

FIG. 4 is a front elevation view of the package;

FIG. 5 is a rear elevation view of the package;

FIG. 6 is a left side elevation view of the package;

FIG. 7 is a right side elevation view of the package;

FIG. 8 is a top perspective view of a second embodiment of a cigarette package with an overlay sheet;

FIG. 9 is a top plan view of the second embodiment of the package;

FIG. 10 is a bottom plan view of the second embodiment of the package;

FIG. 11 is a front elevation view of the second embodiment of the package;

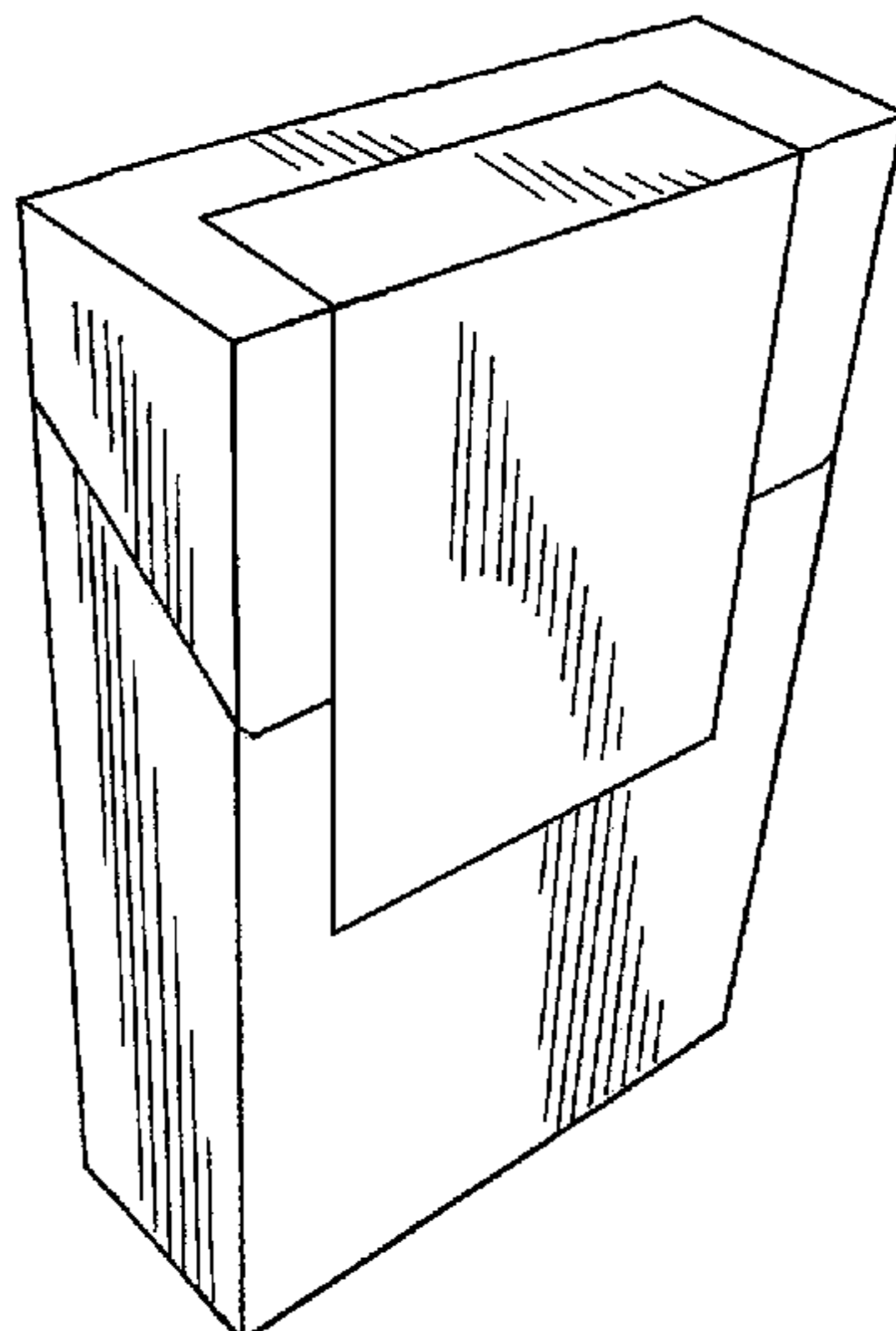
FIG. 12 is a rear elevation view of the second embodiment of the package;

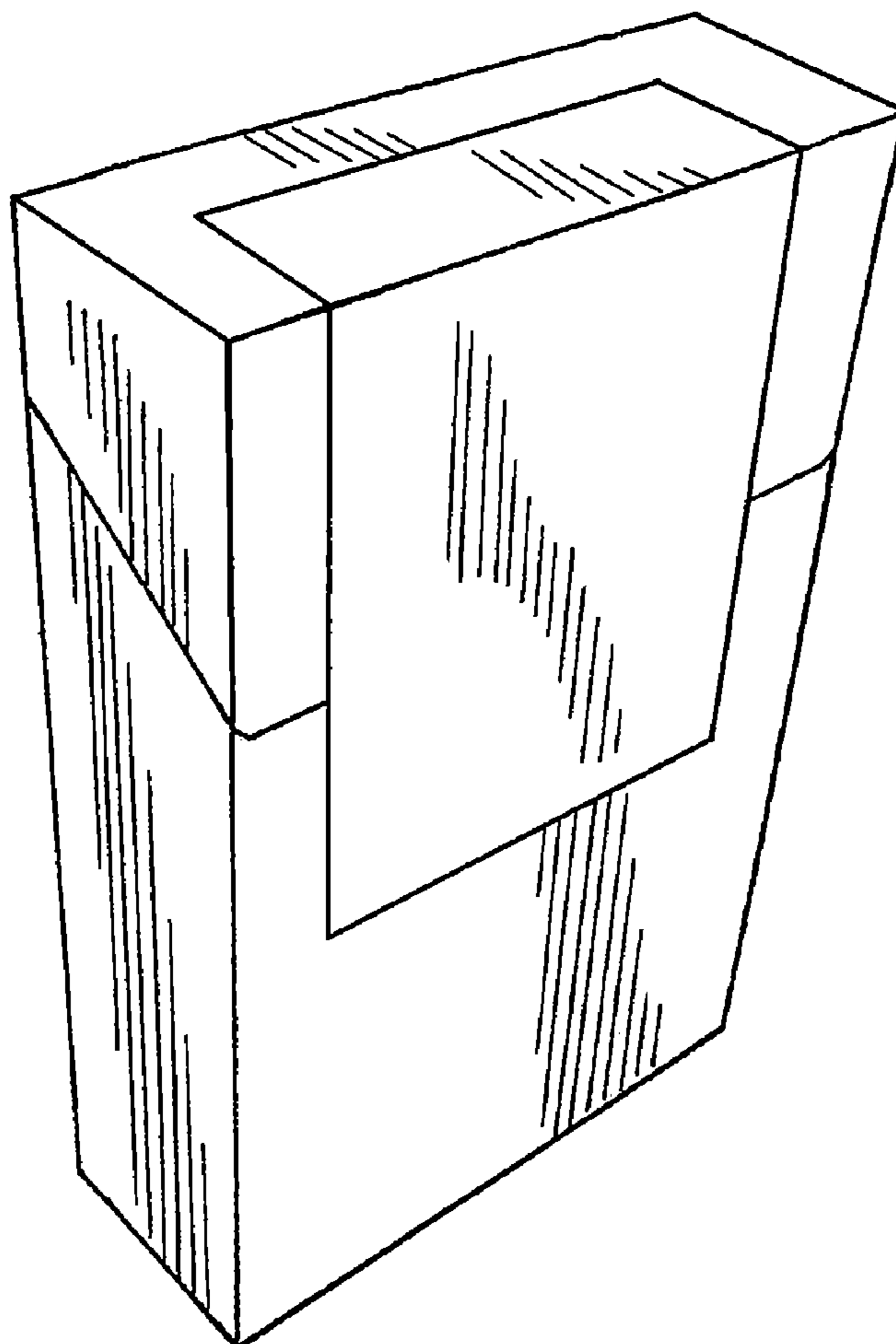

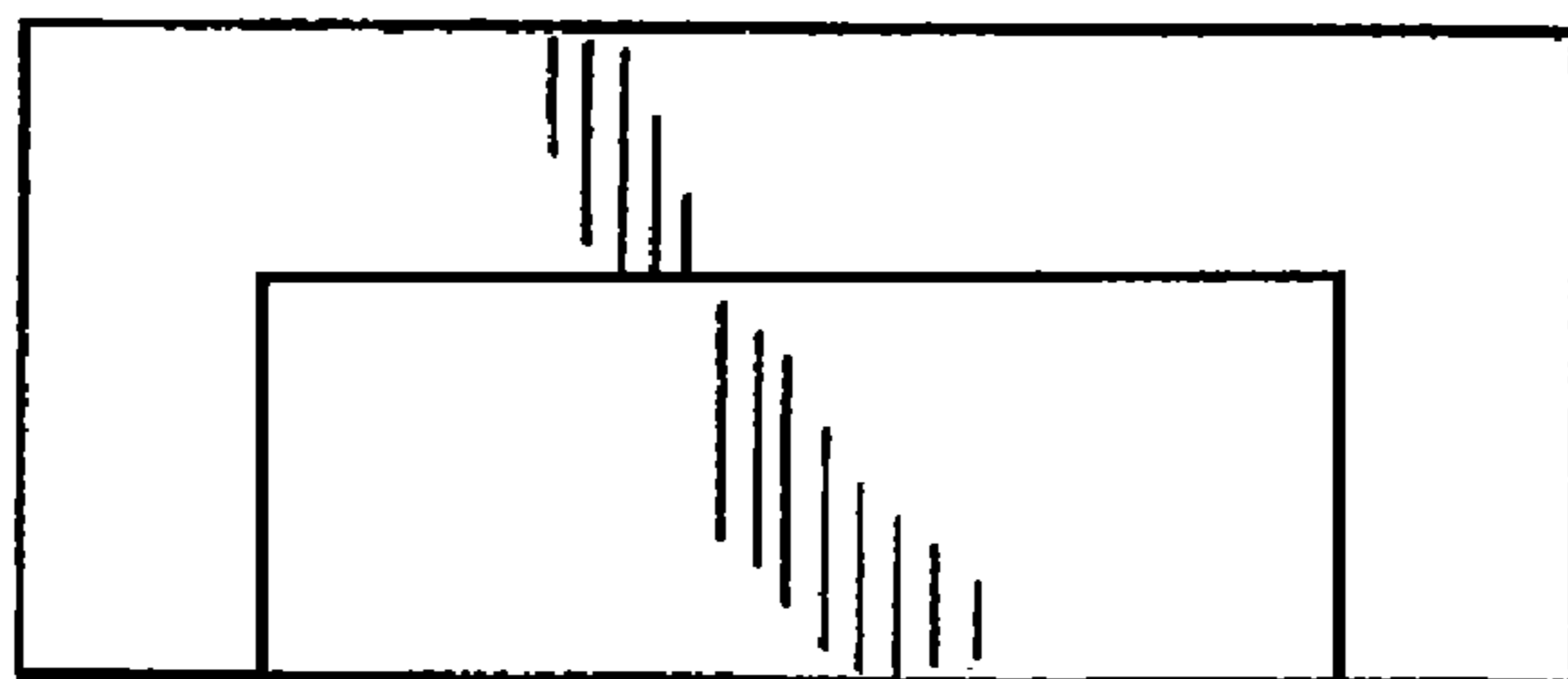

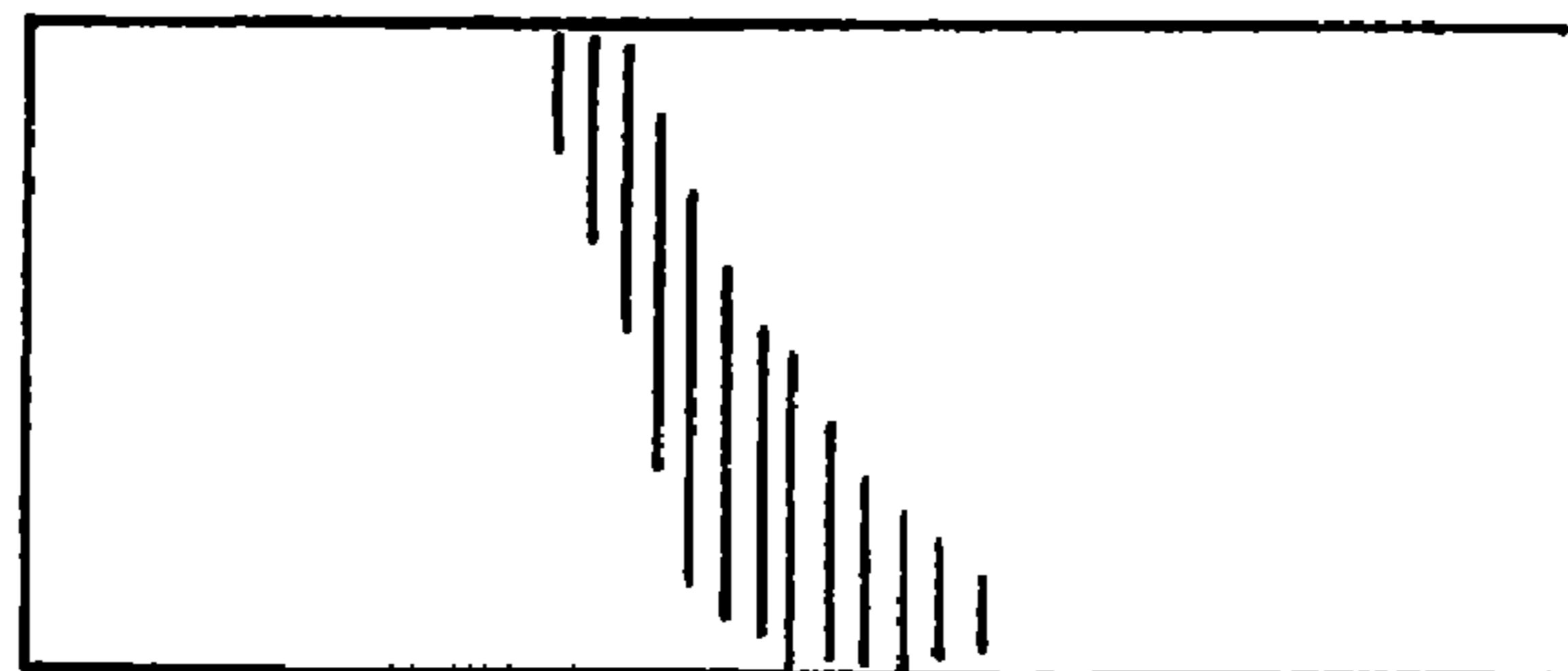

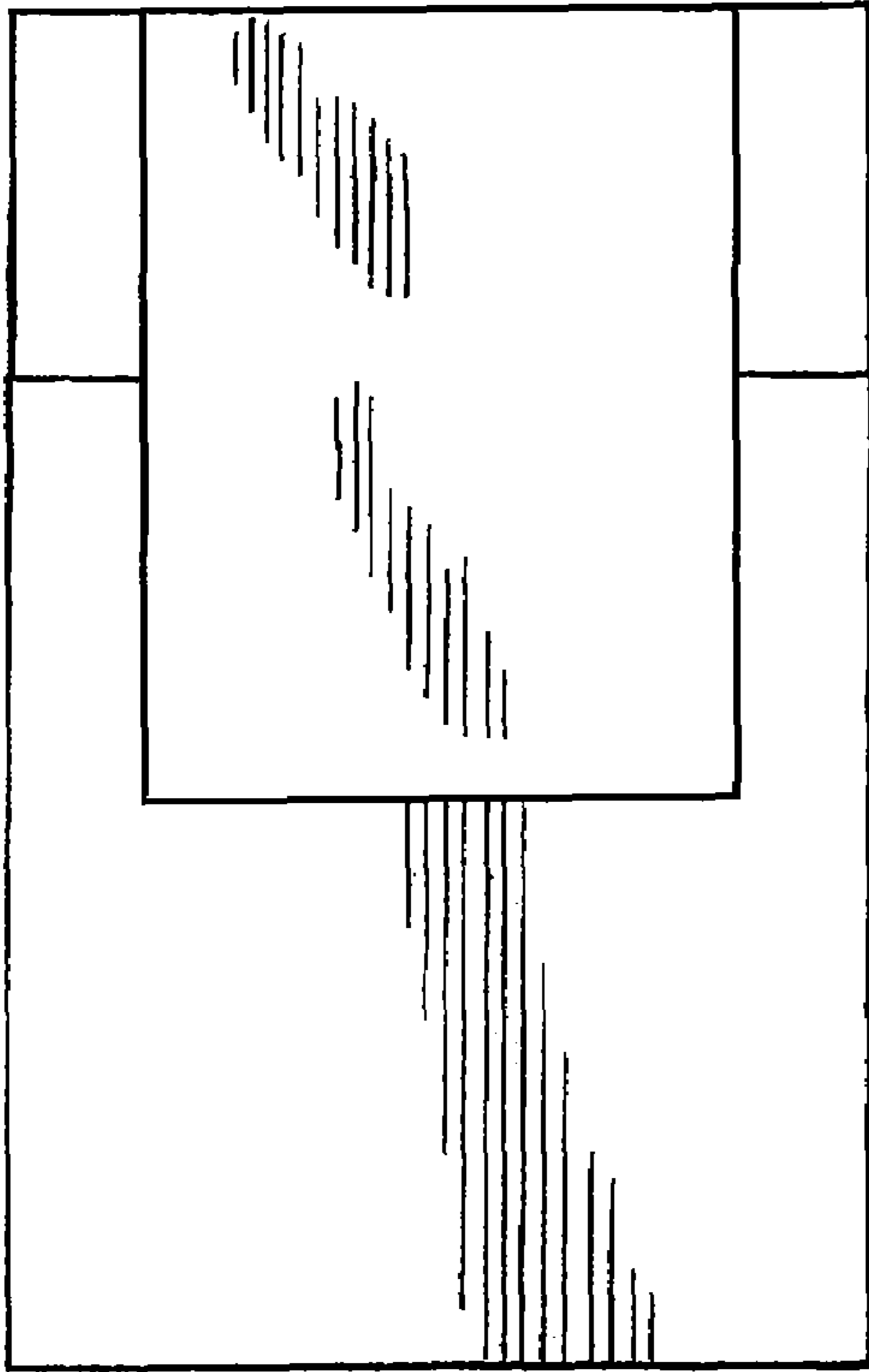

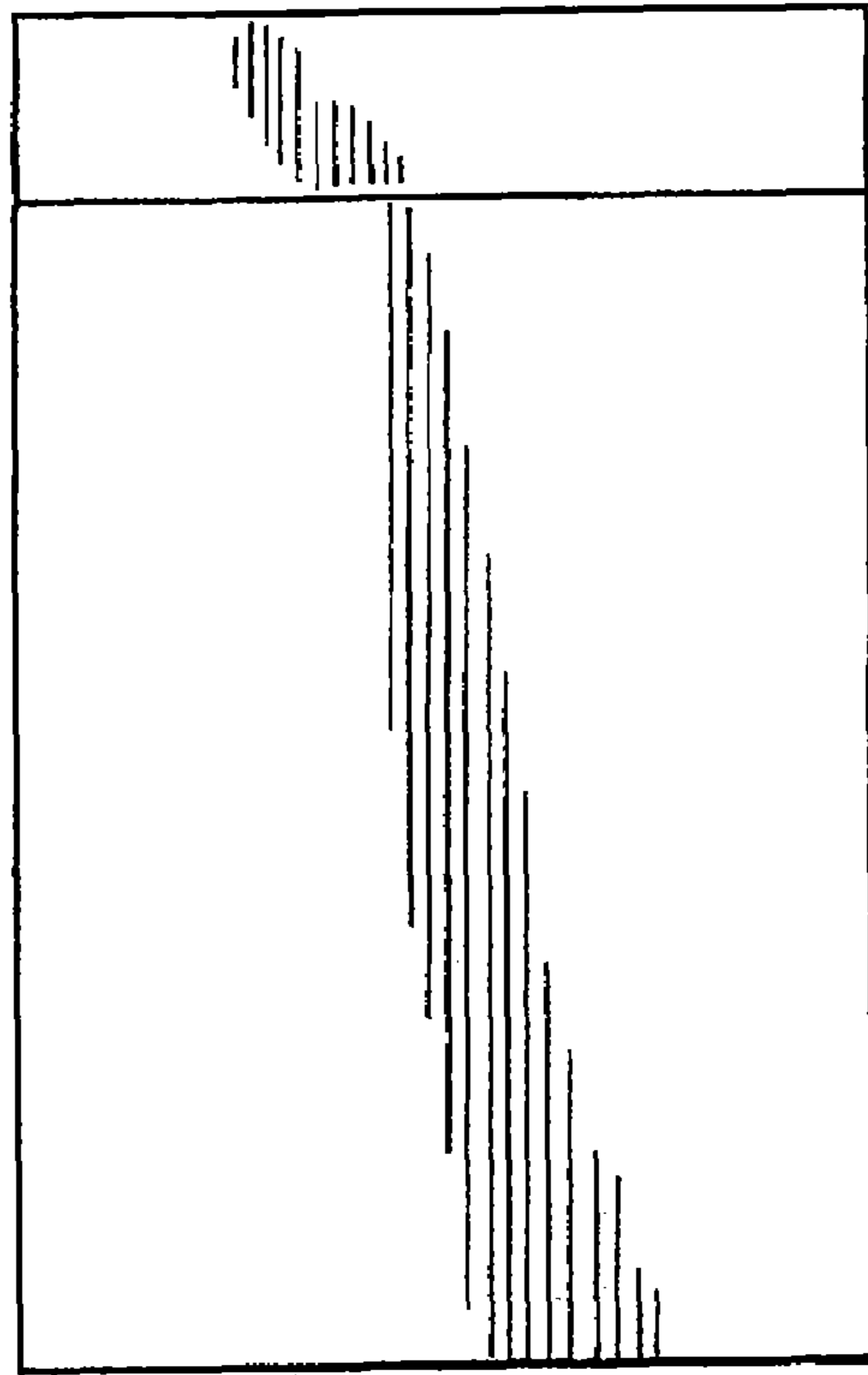

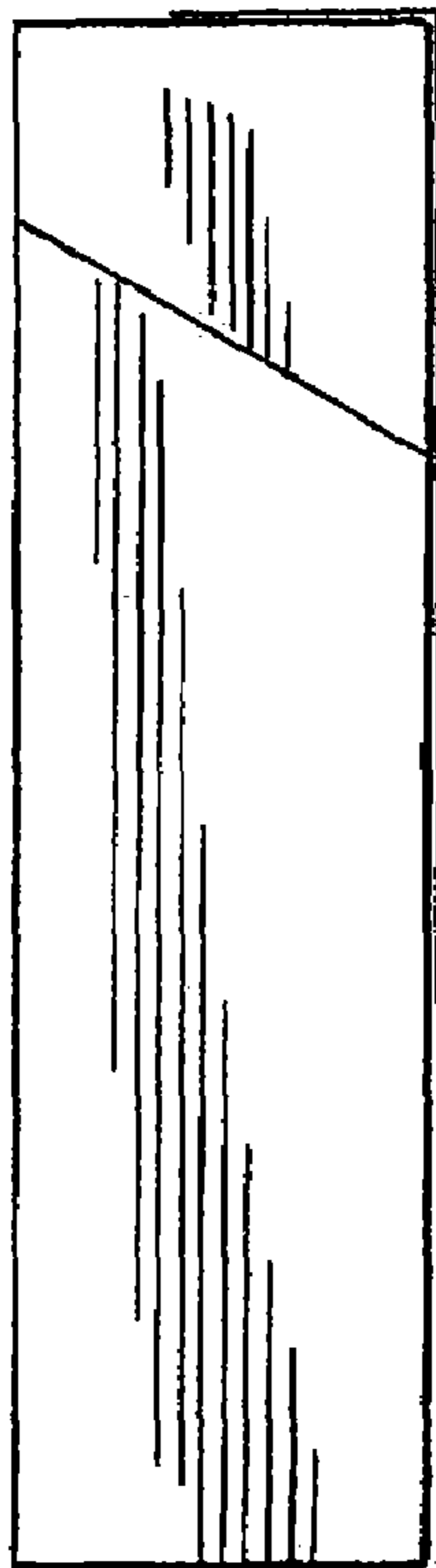

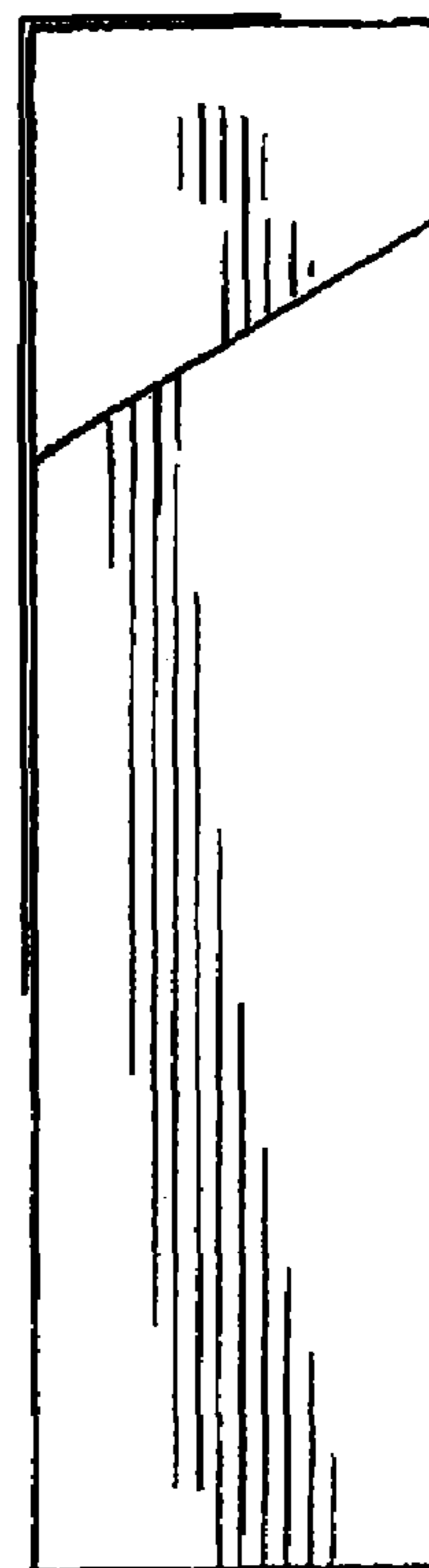

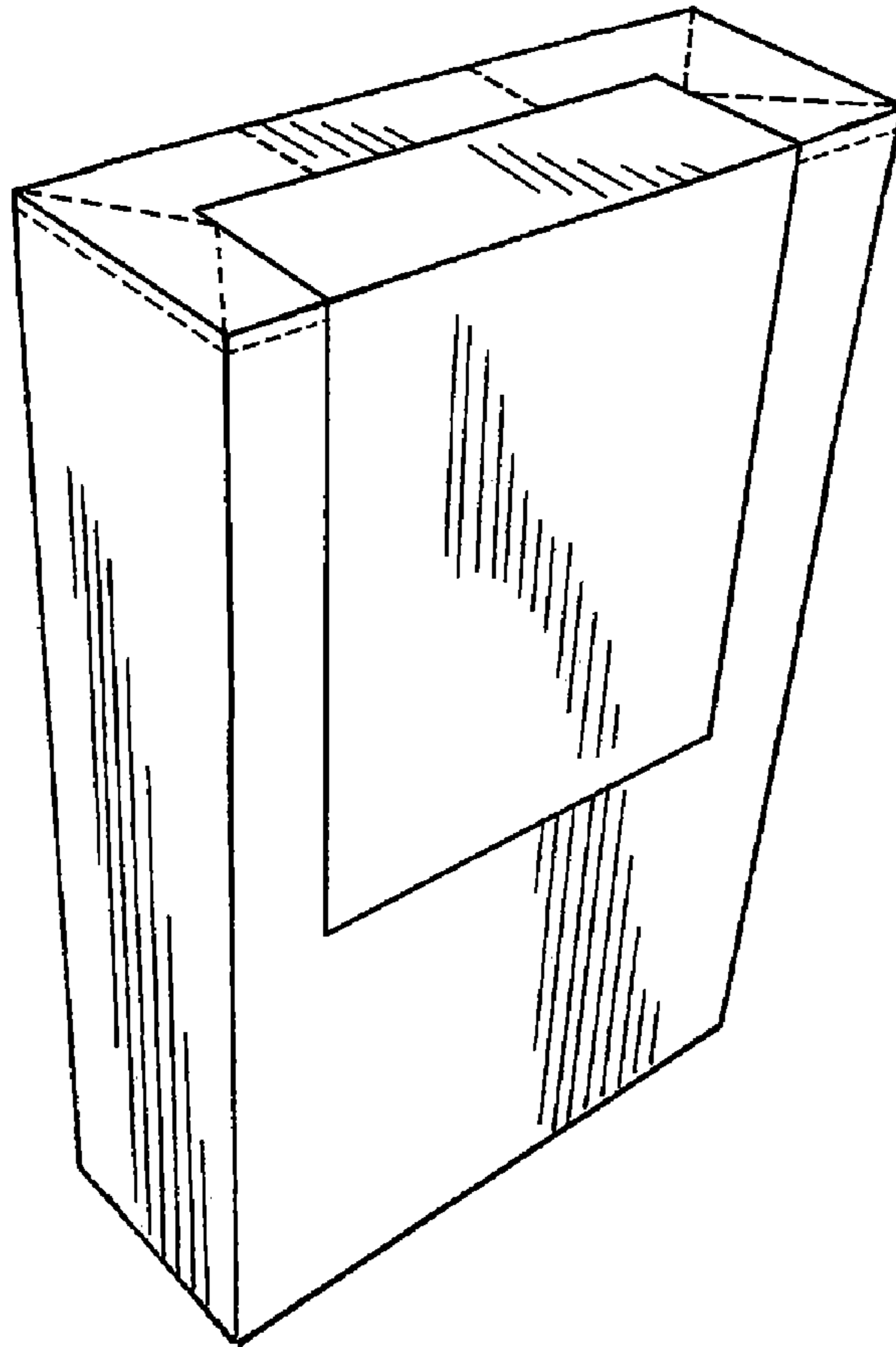

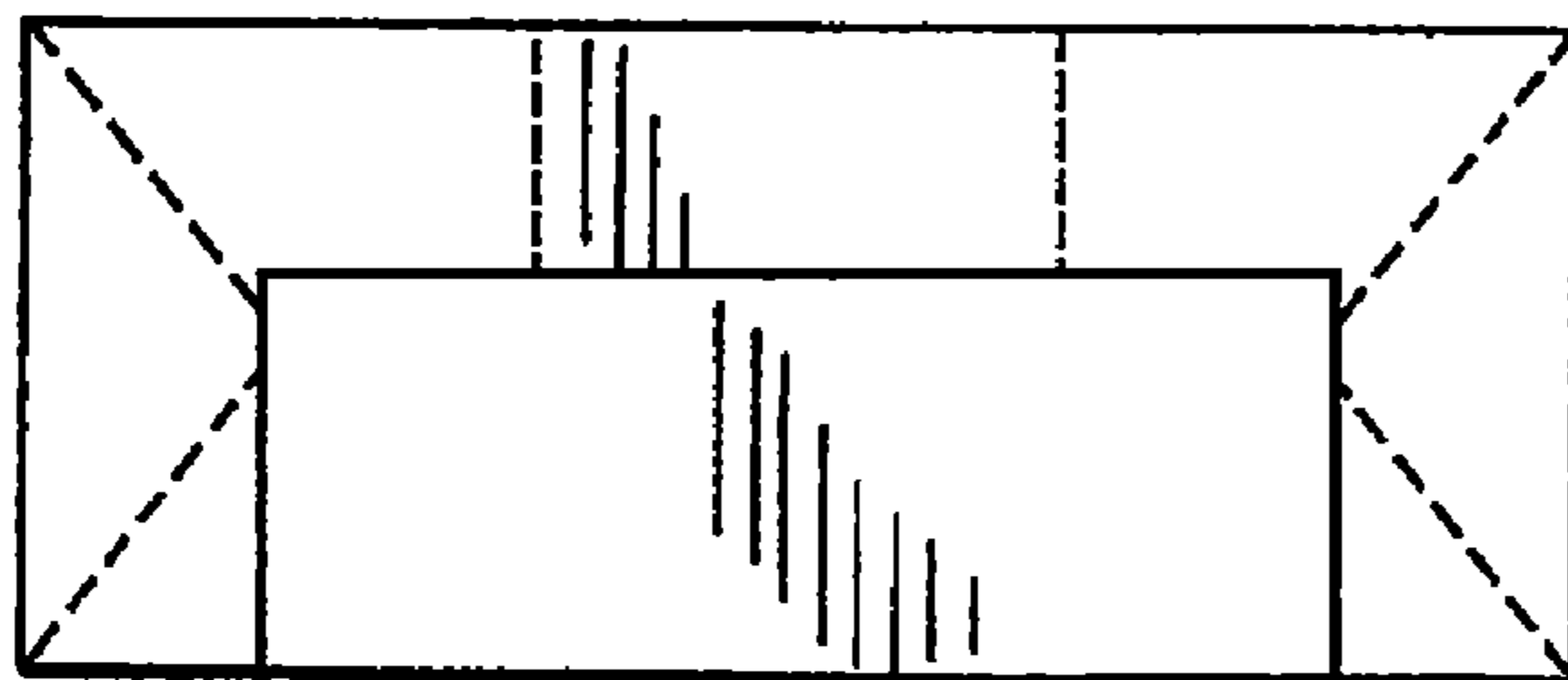

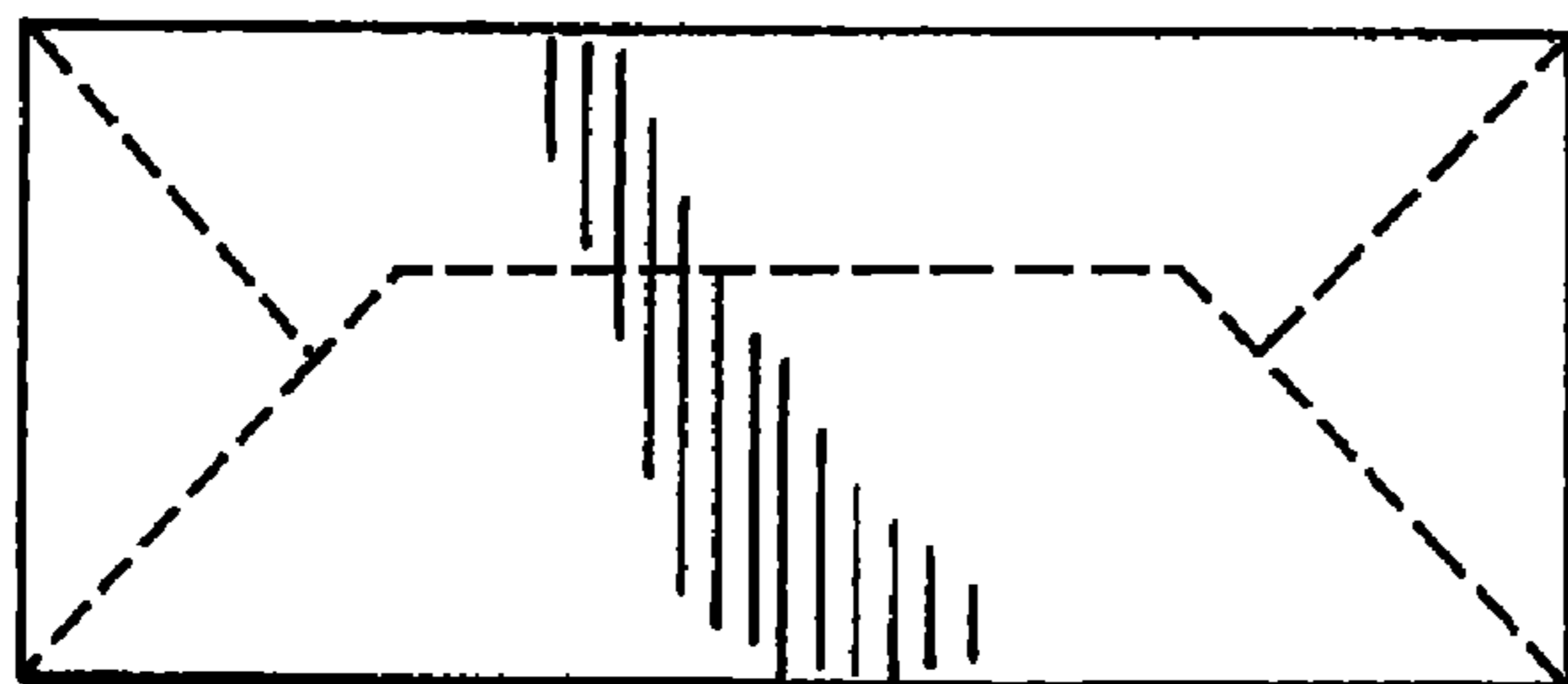

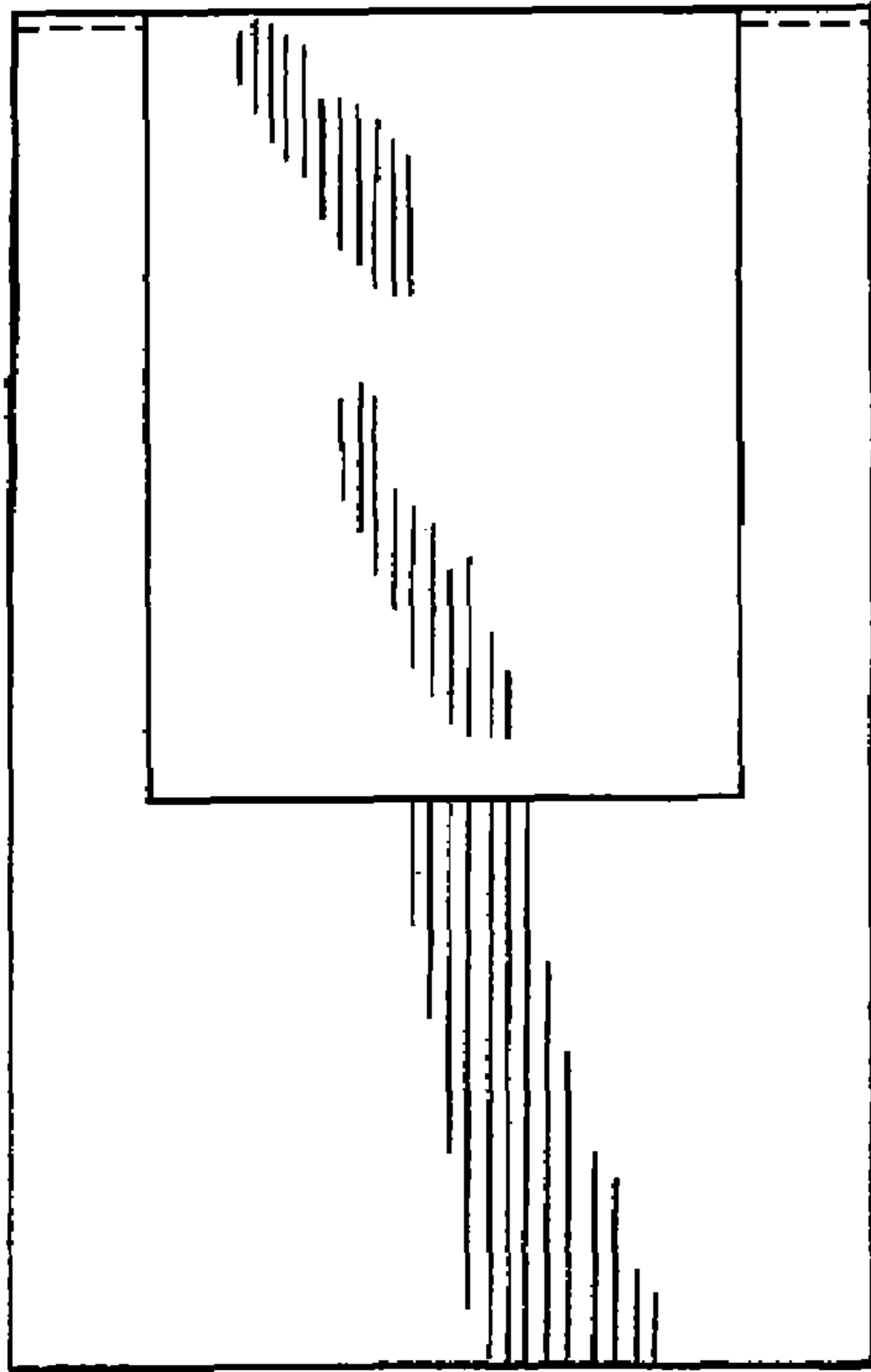

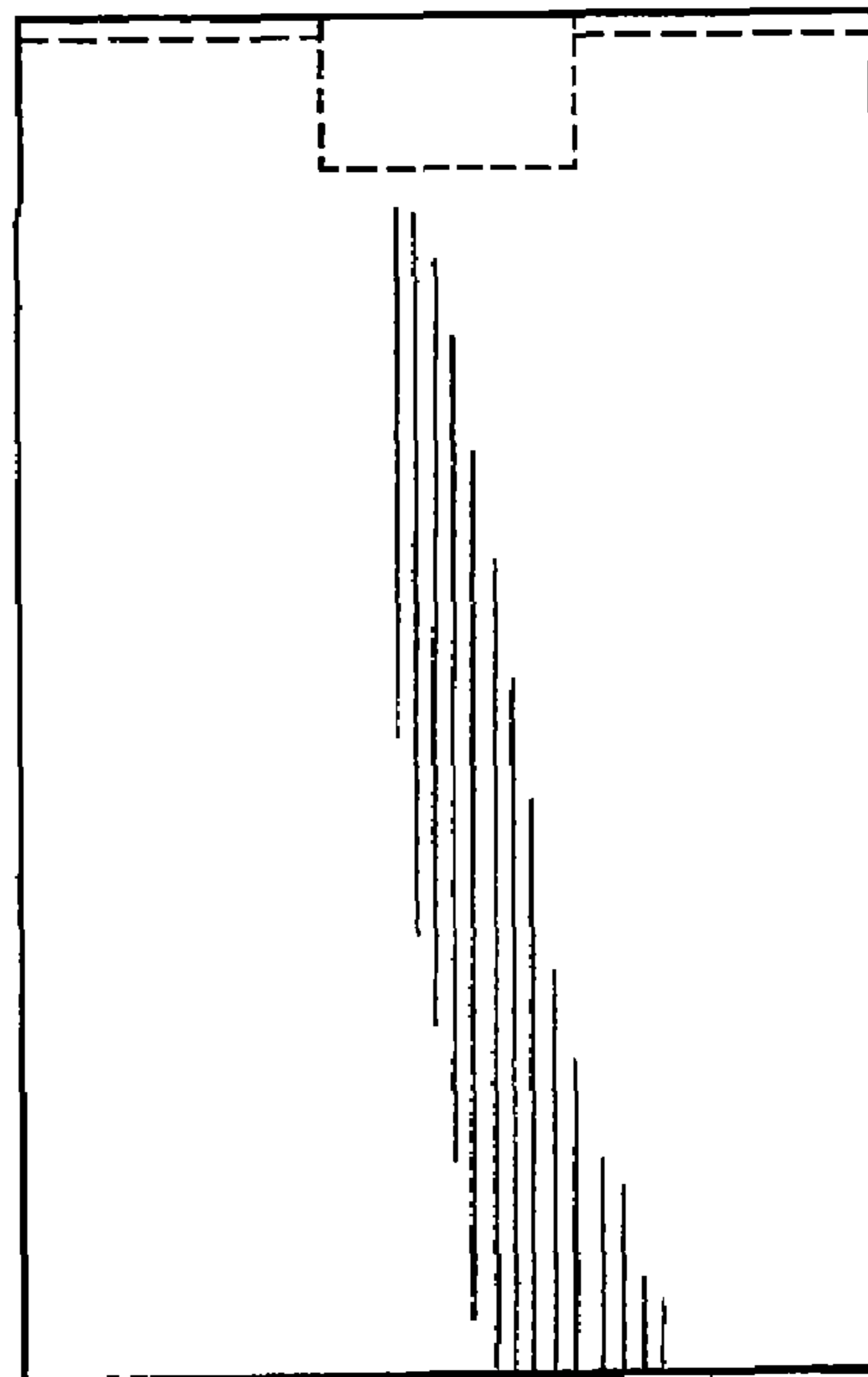

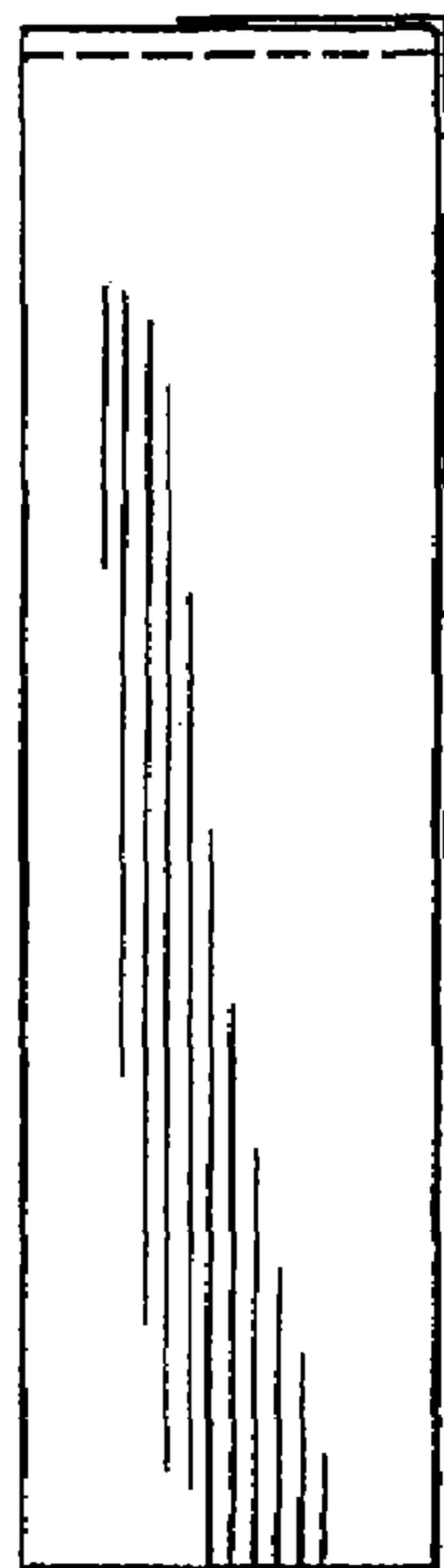

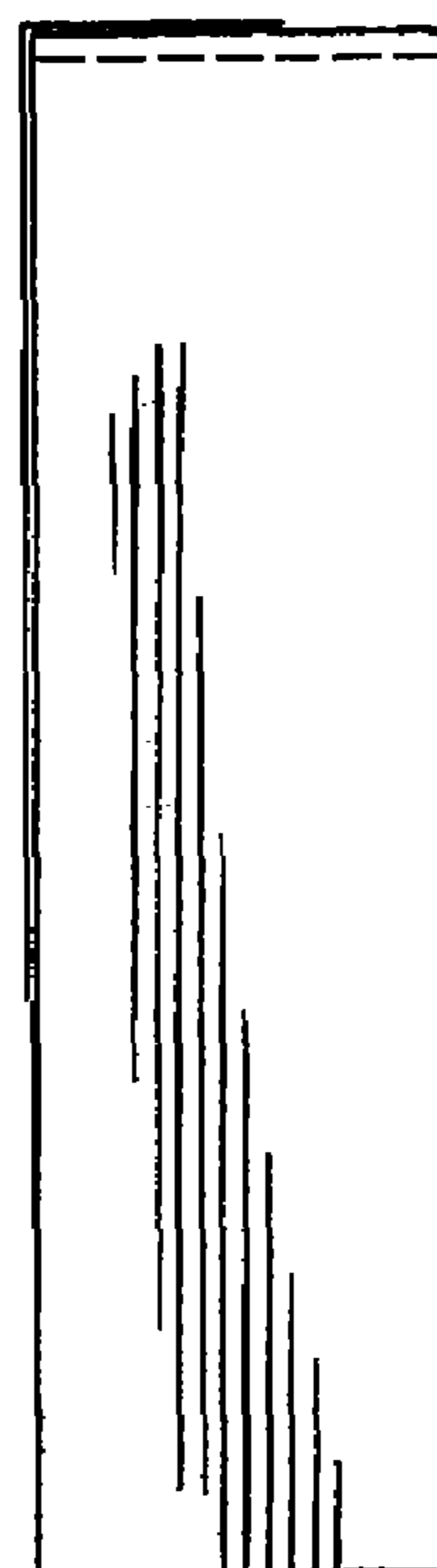
