The ornamental design for a bird feeder and house, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of my invention;

FIG. 2 is a left side elevation view, the right side elevation view being a mirror image thereof;

FIG. 3 is a front elevation view;

FIG. 4 is a rear elevation view;

FIG. 5 is a top plan view;

FIG. 6 is a bottom plan view;

FIG. 7 is a perspective view of a second embodiment of my invention;

FIG. 9 is a front elevation view;

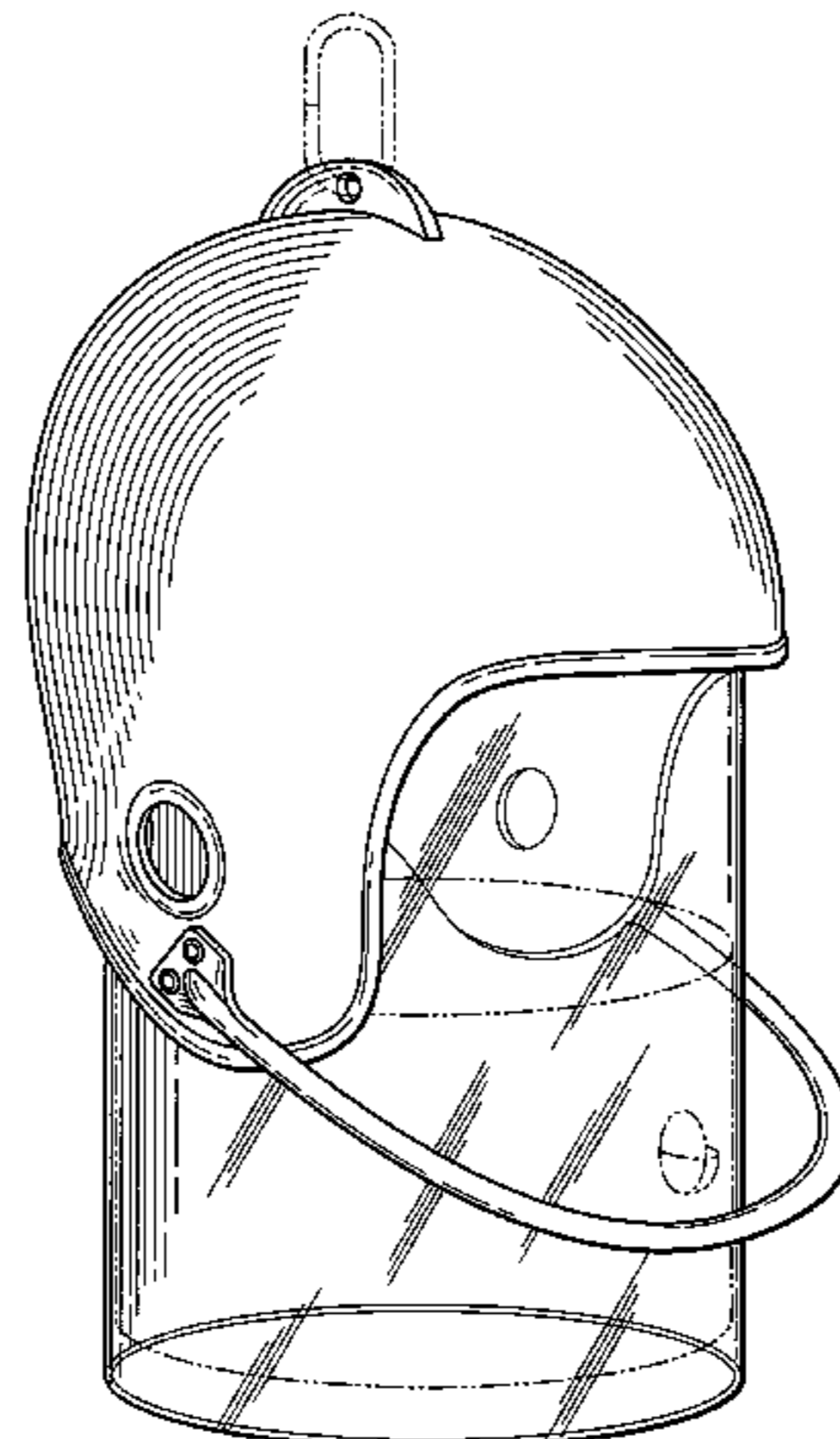
FIG. 10 is a rear elevation view;

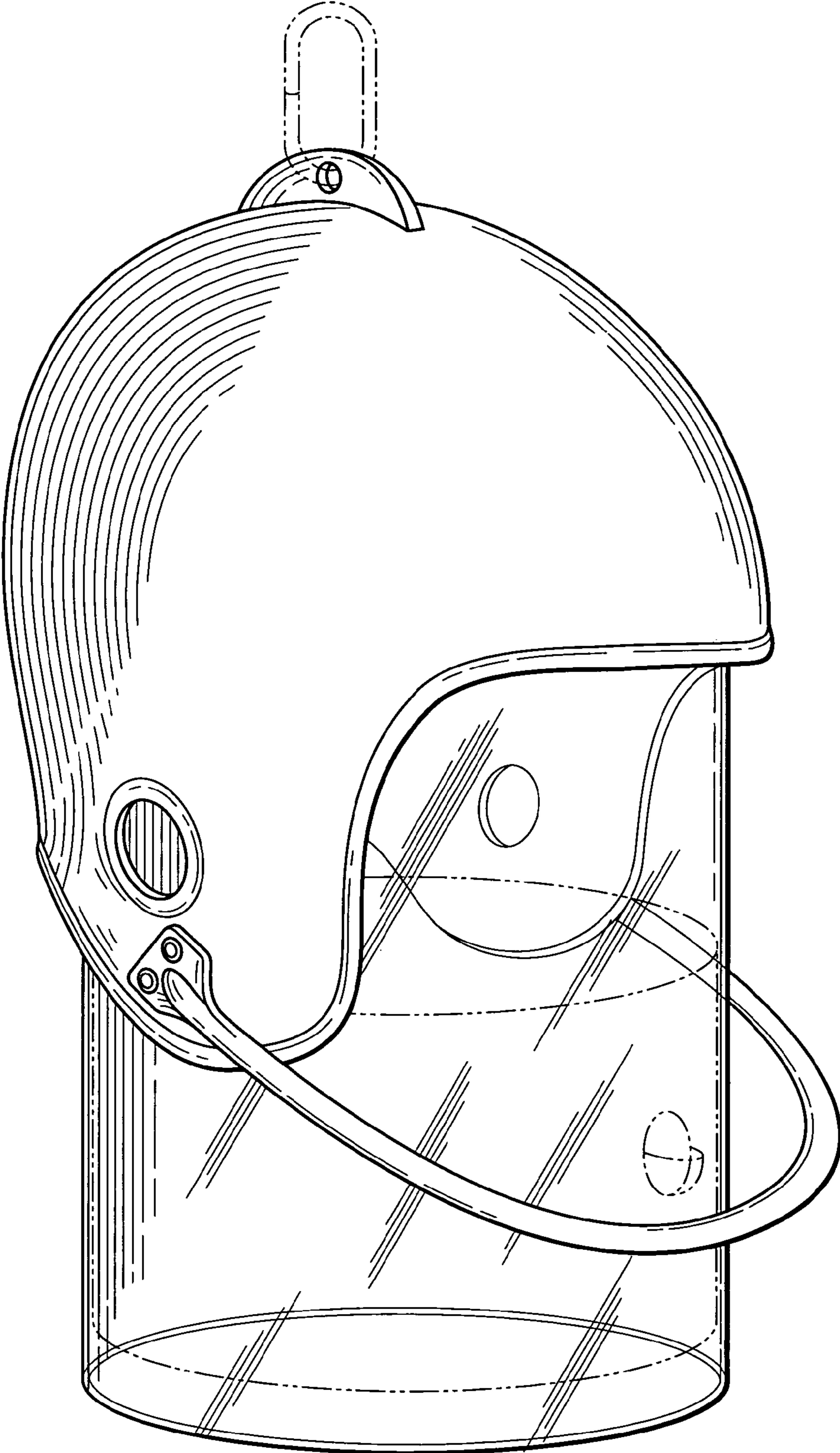

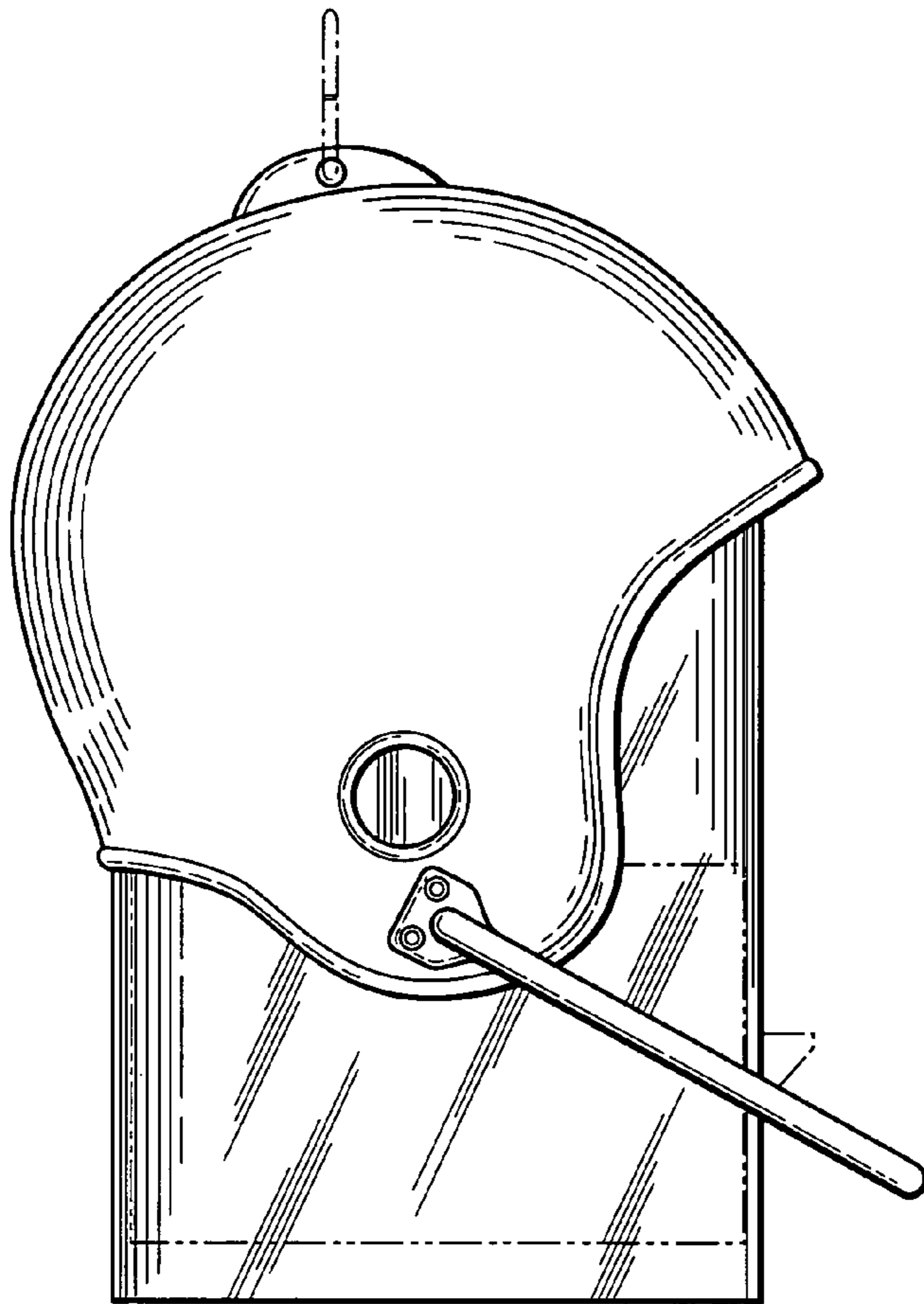

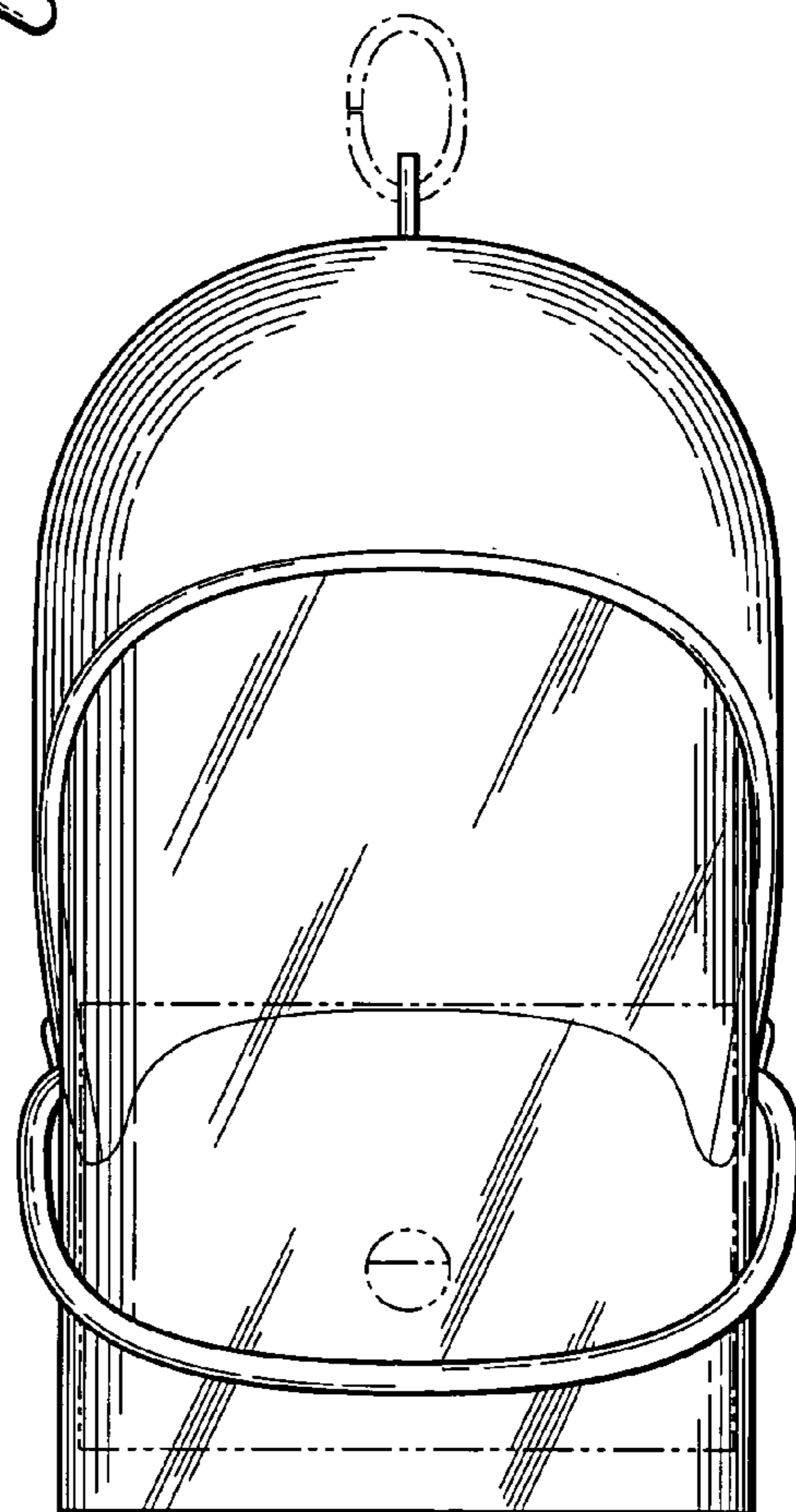

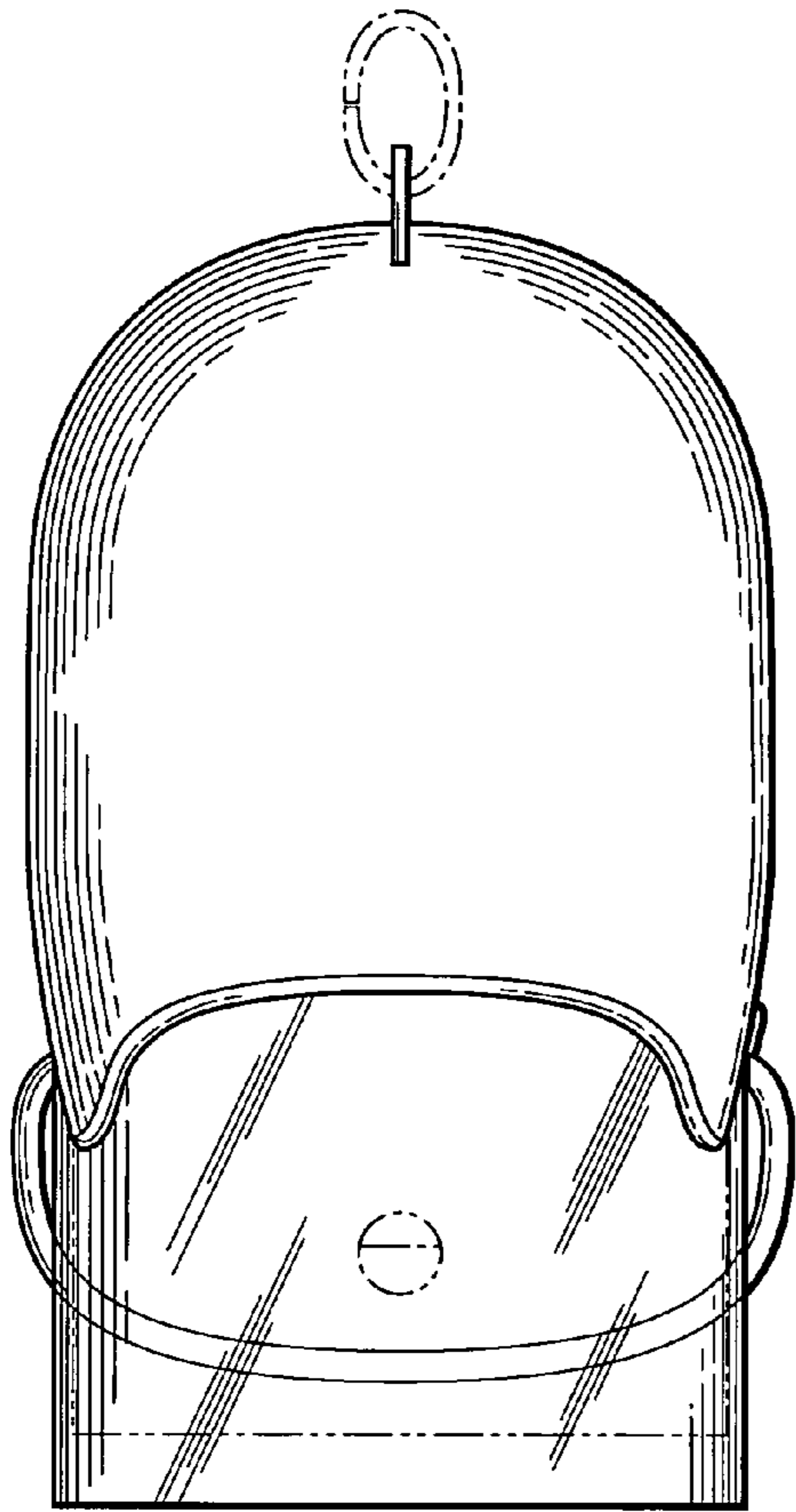

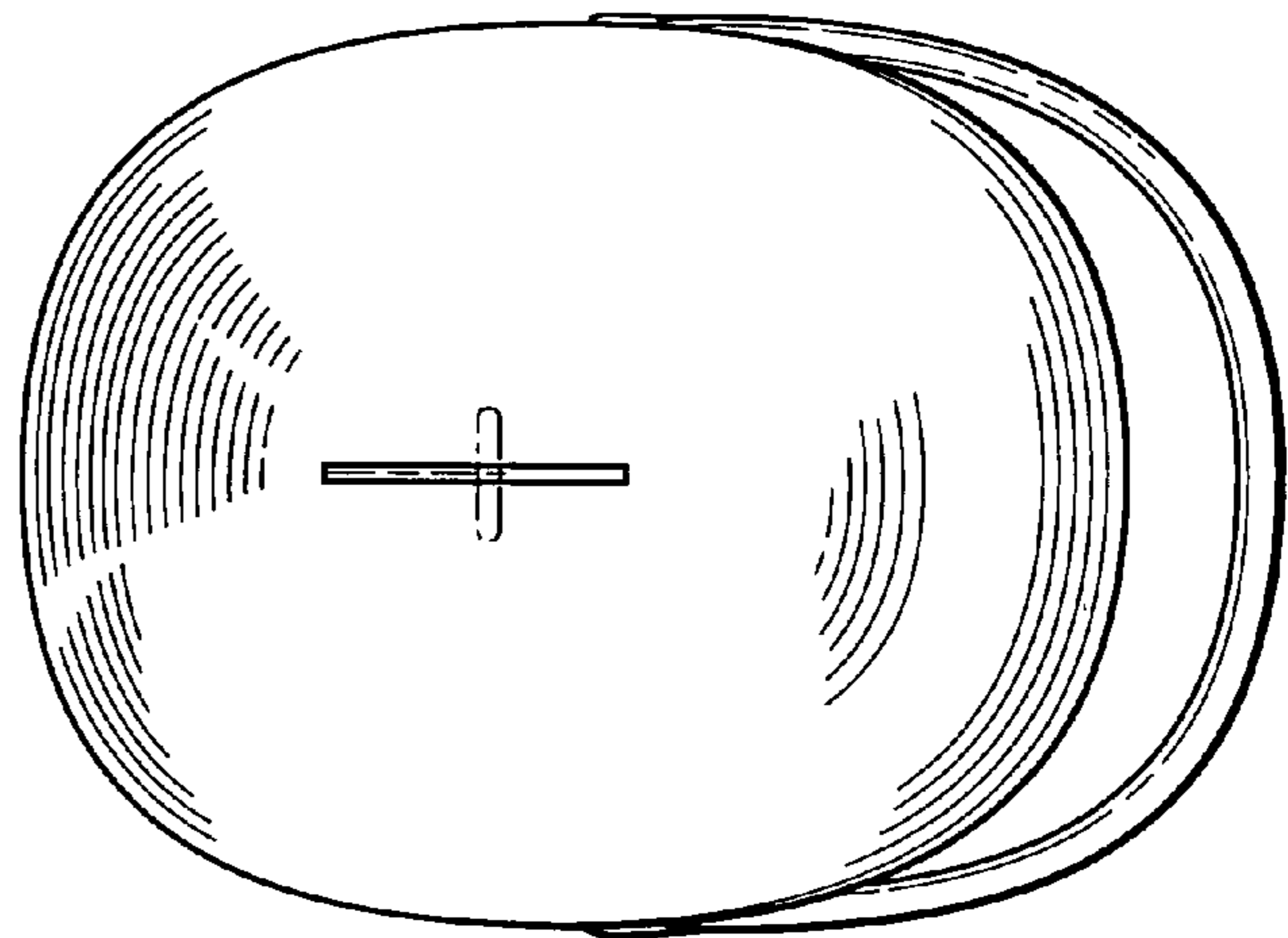

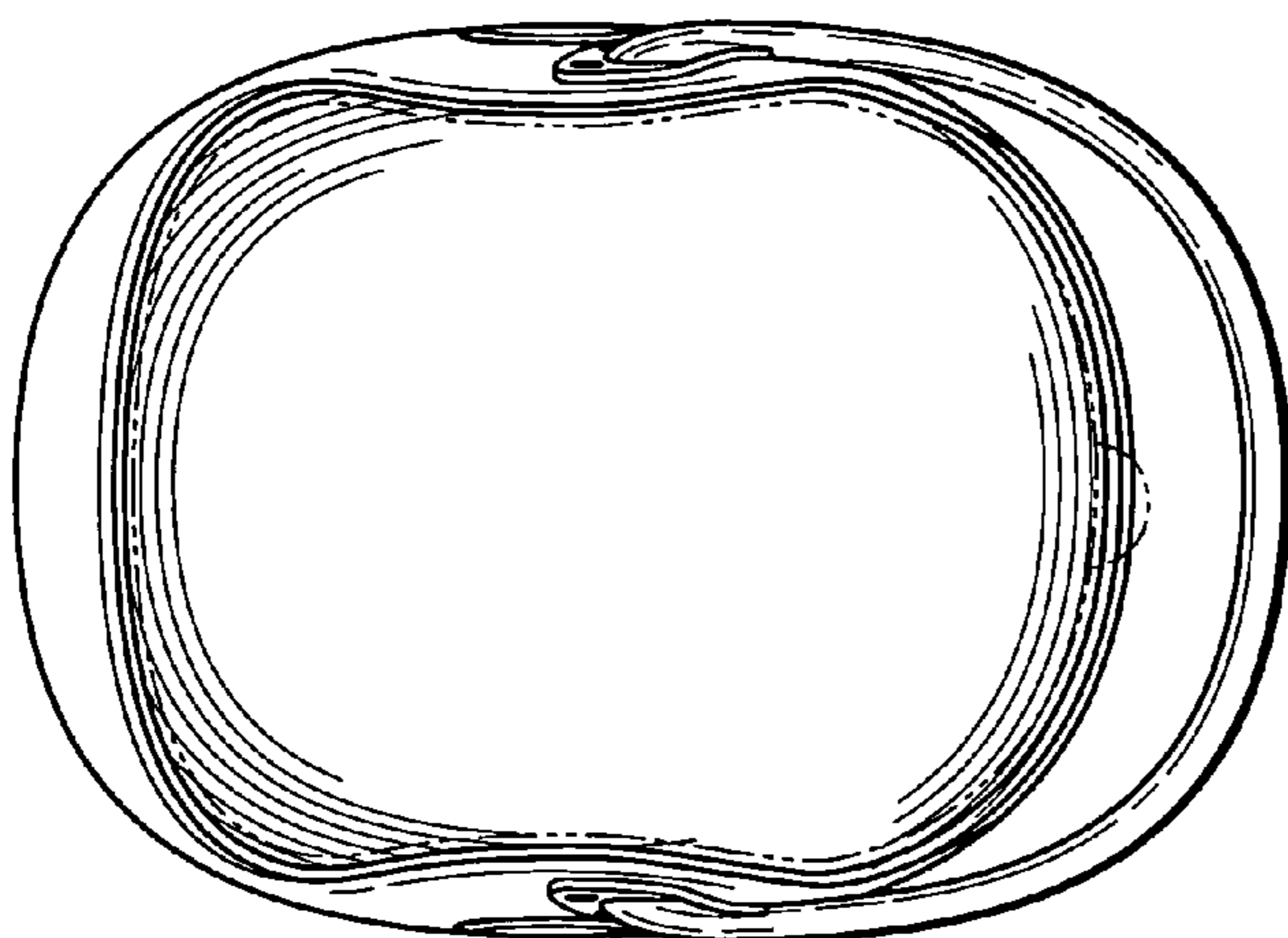

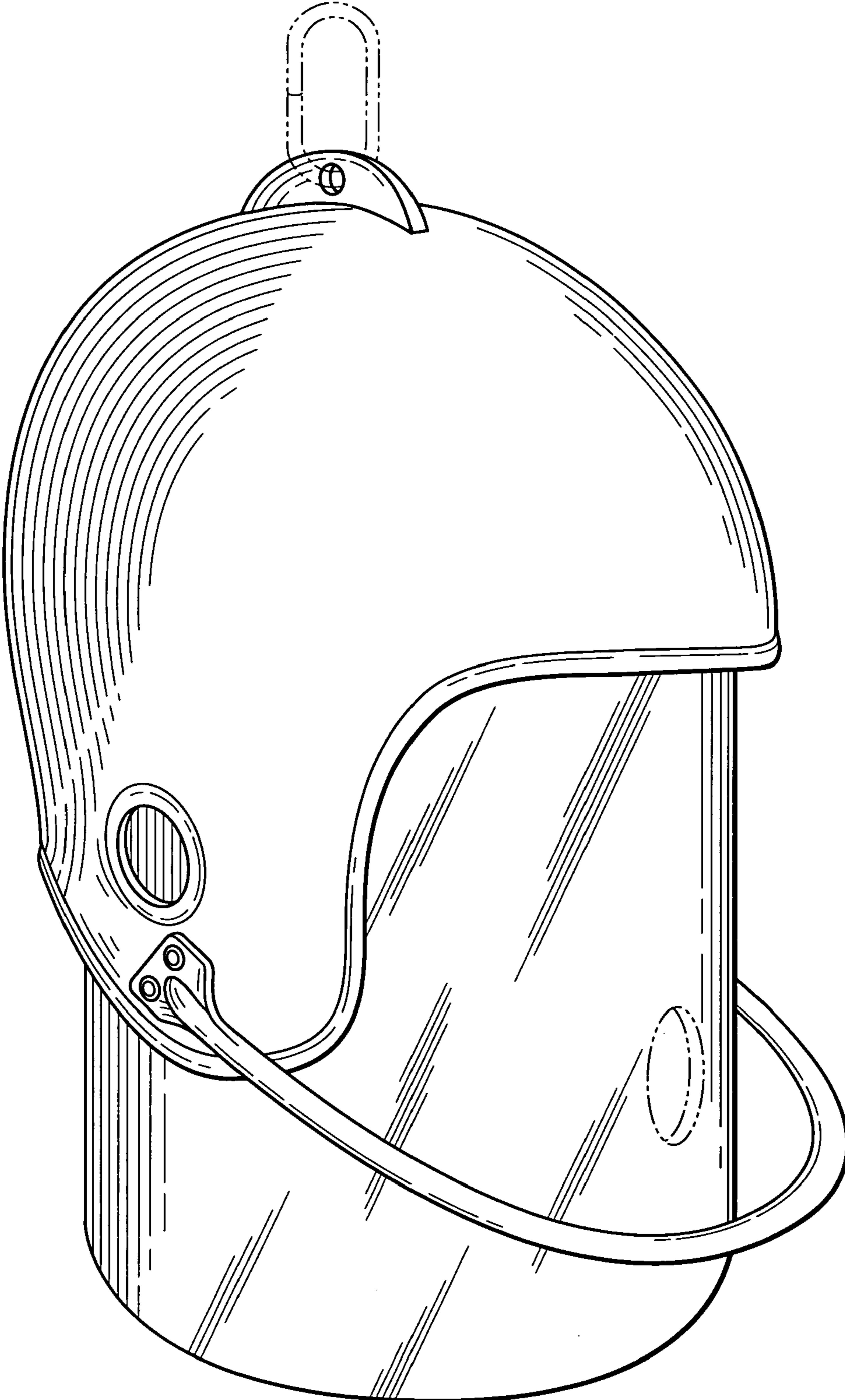

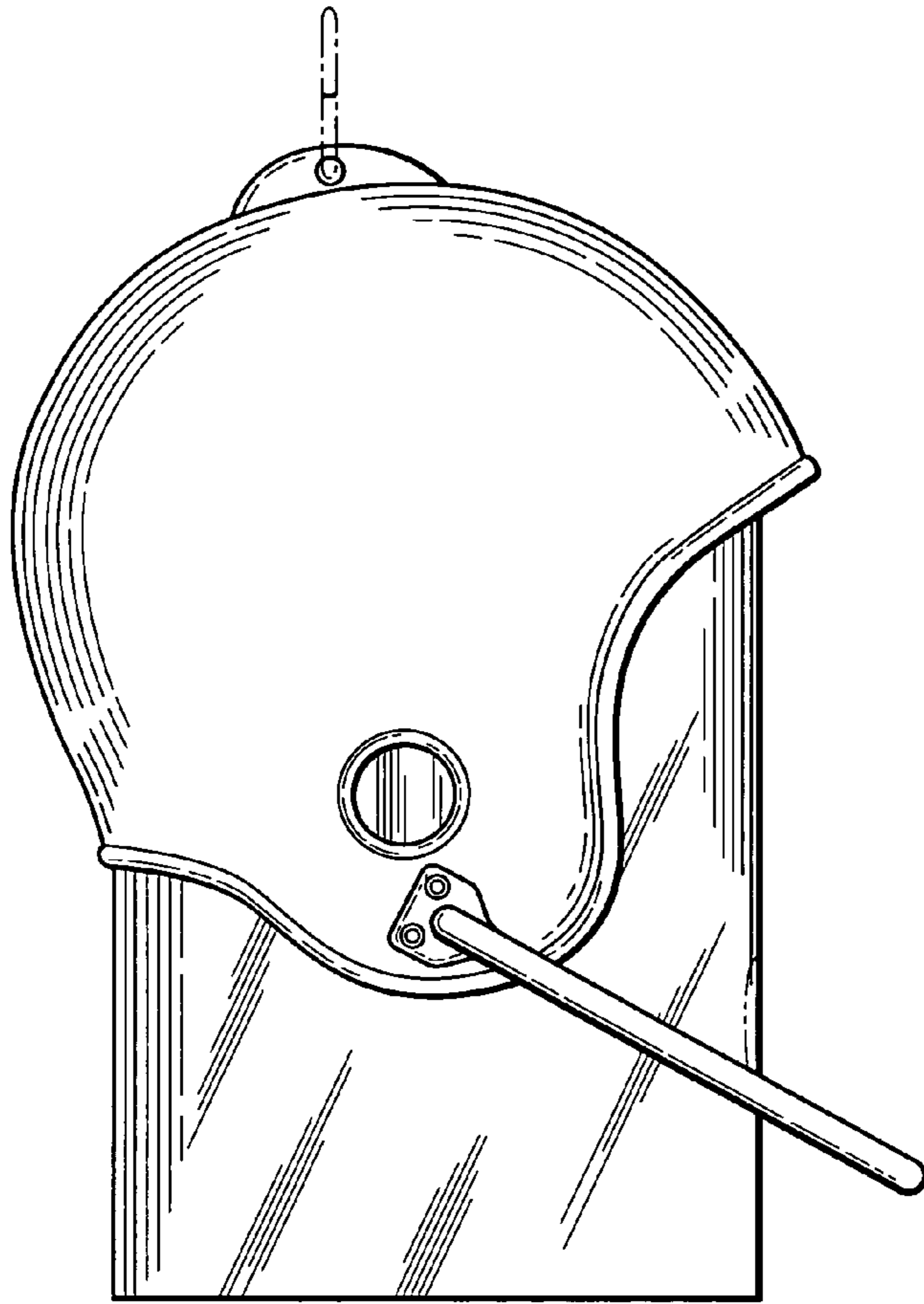

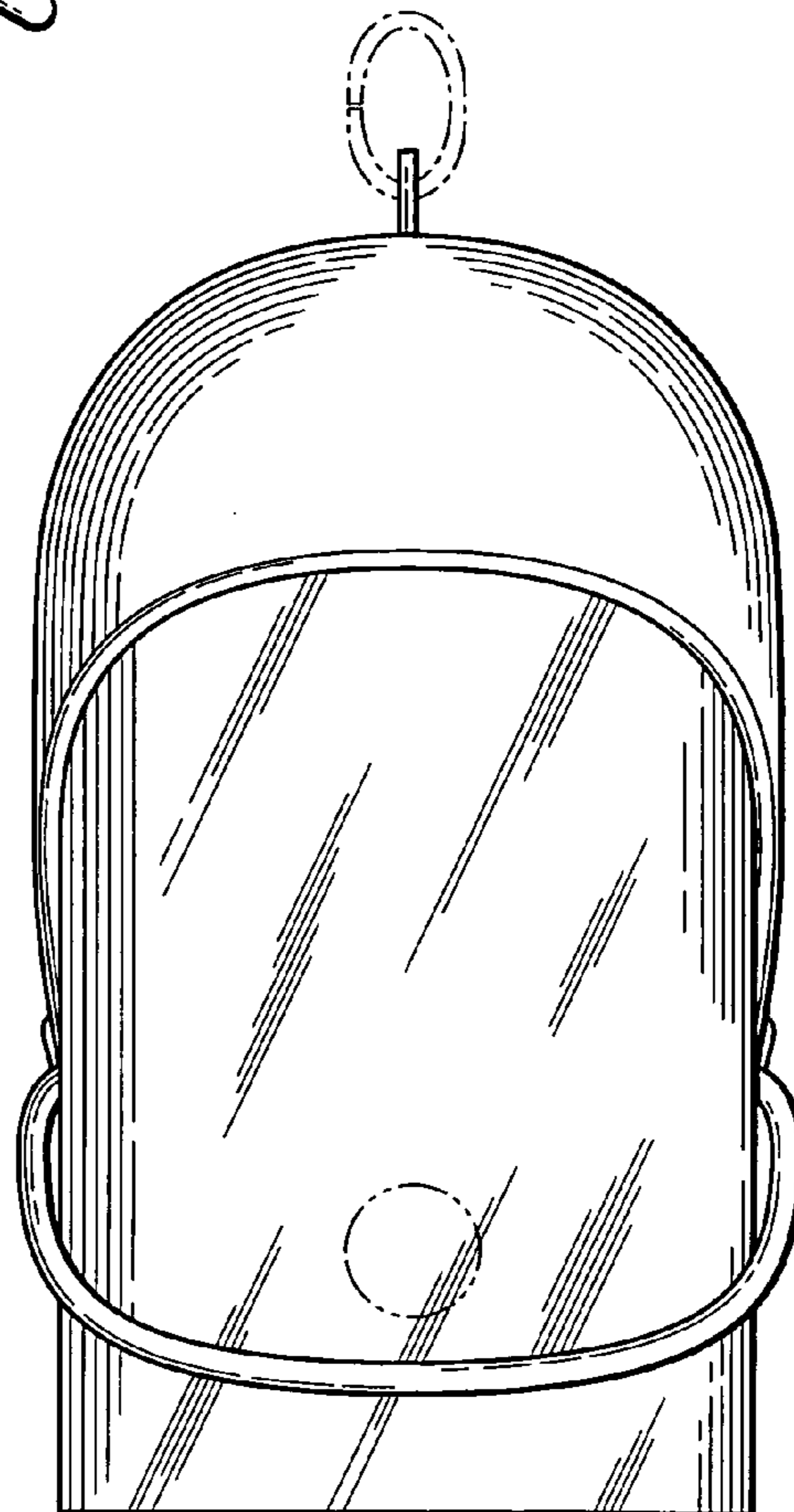

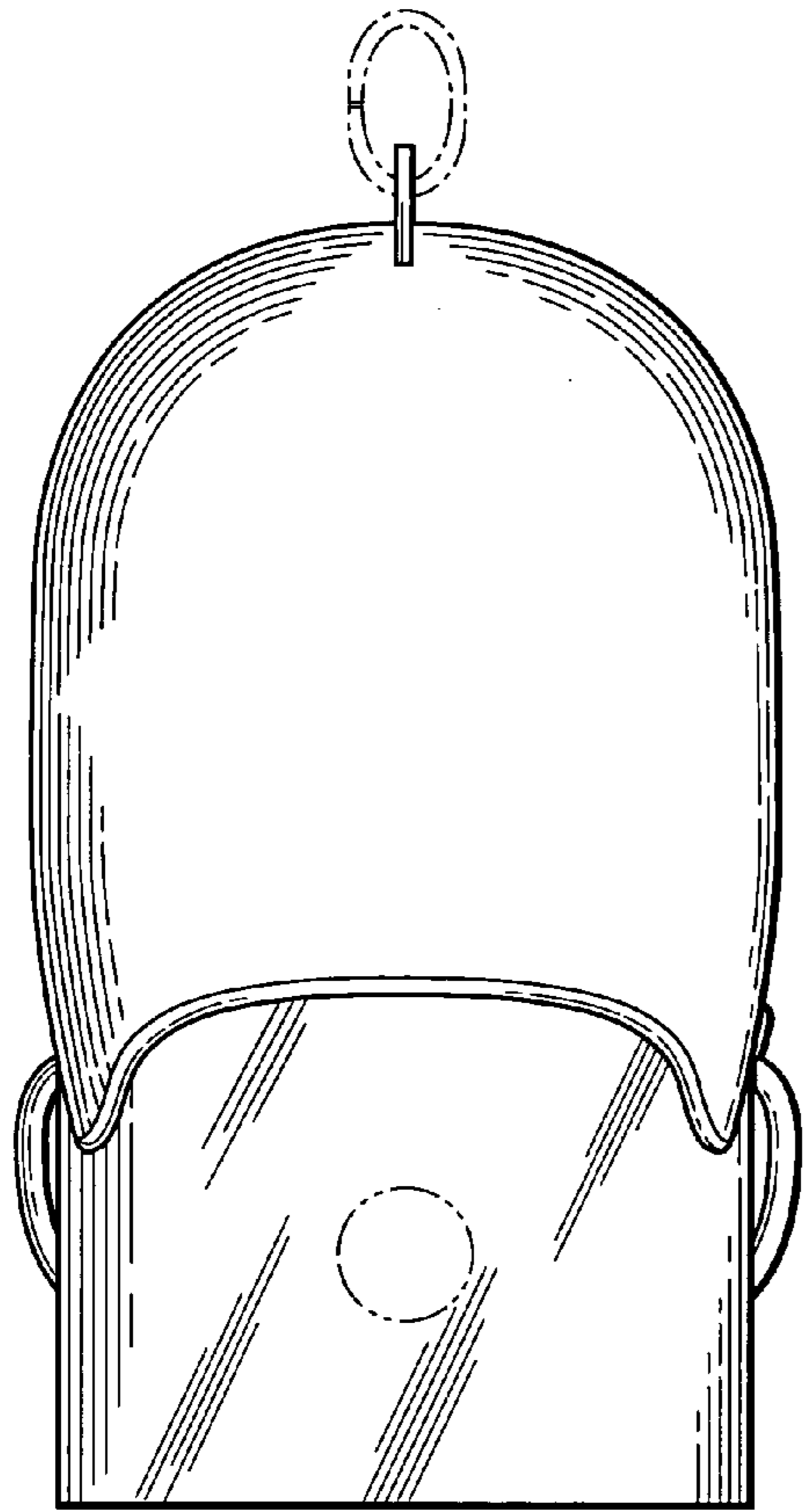

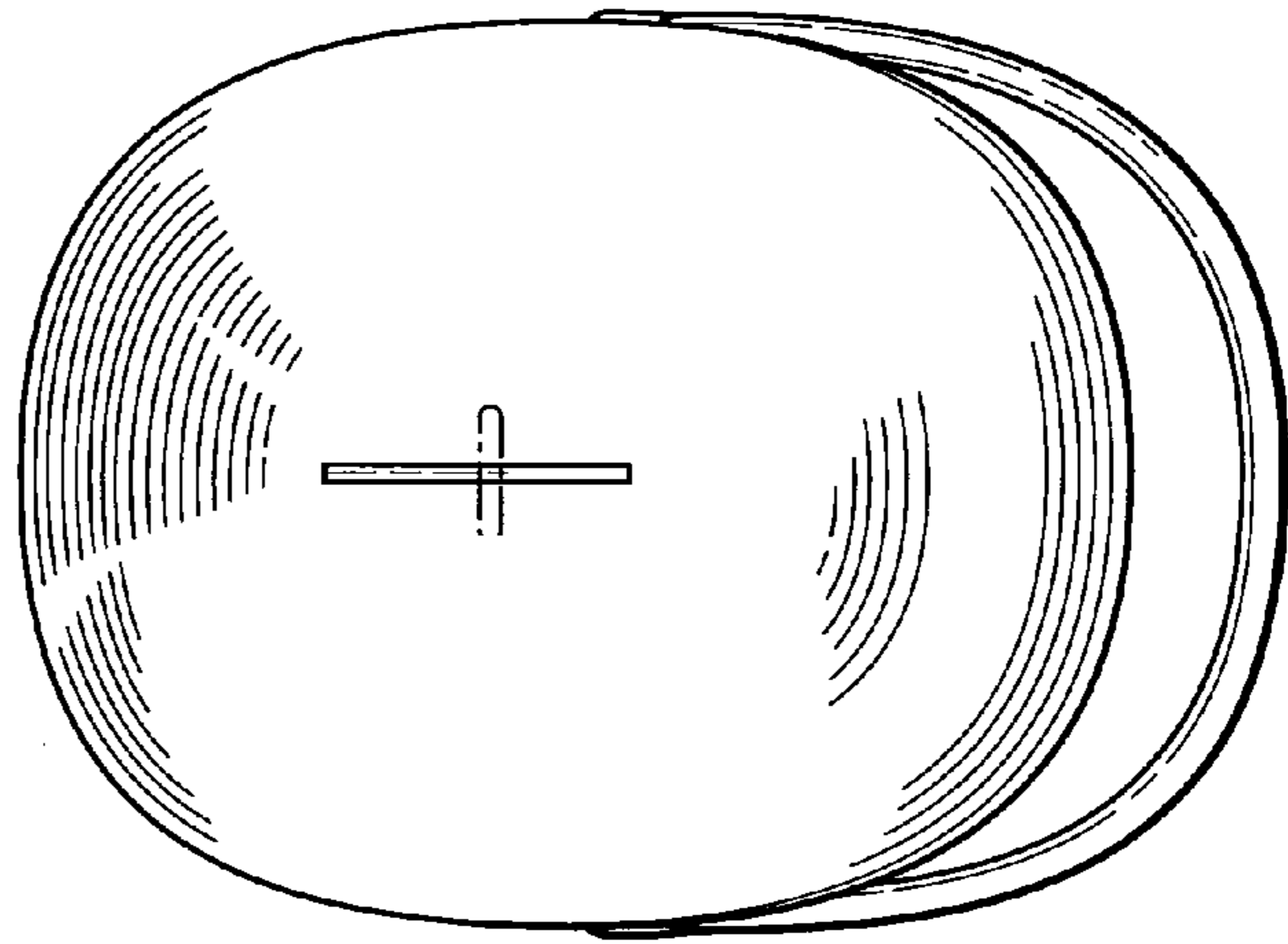

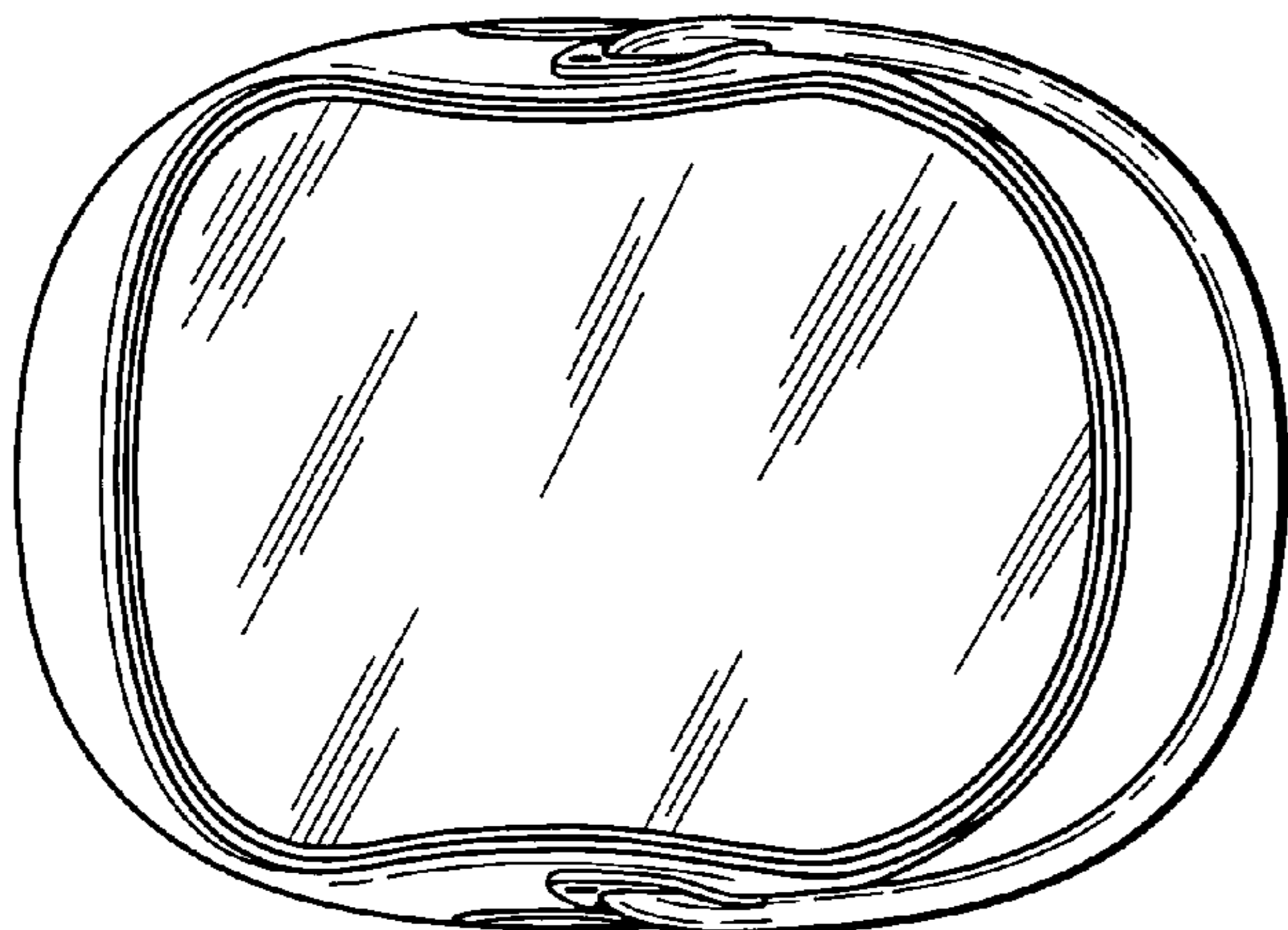
