The ornamental design for a bottle carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view showing my new design, wherein a bottle is shown in broken lines for illustrative purposes only and forms no part of the claimed design;

FIG. 6 is a rear view thereof;


FIG. 7 is a right side view thereof;




















