DESCRIPTION

1;

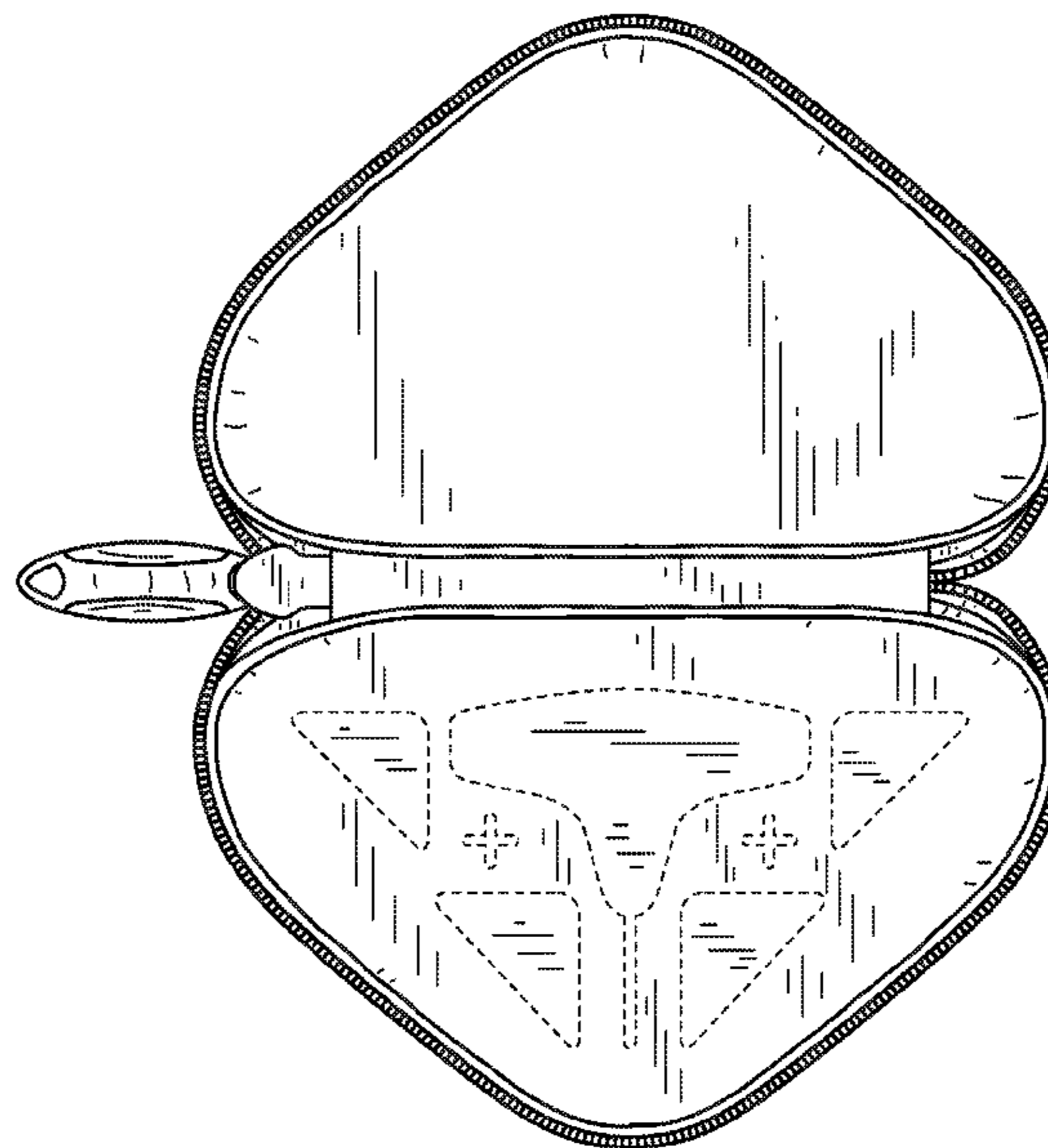
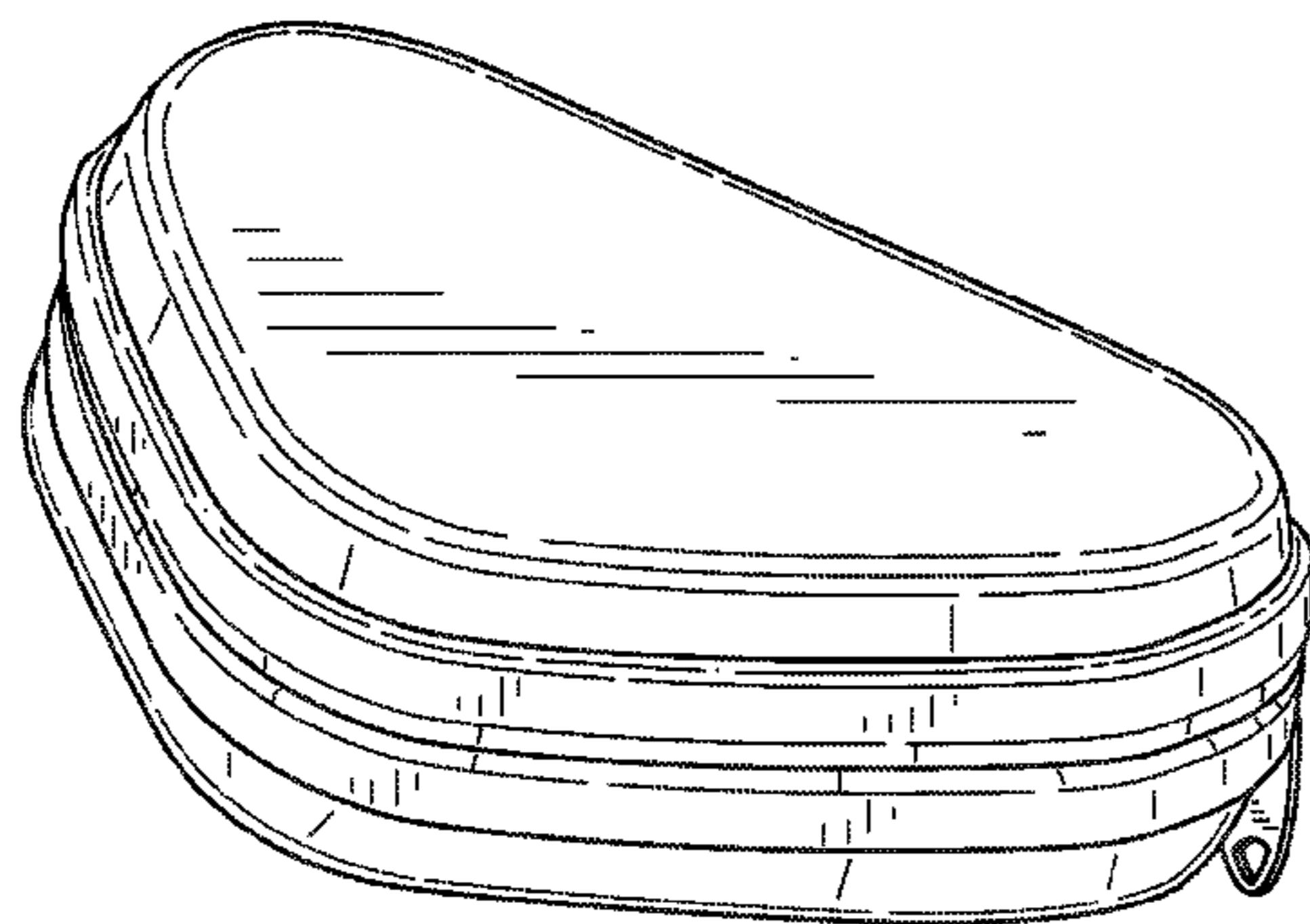
FIG. 7 is a rear view of the golf club weight kit case of FIG.

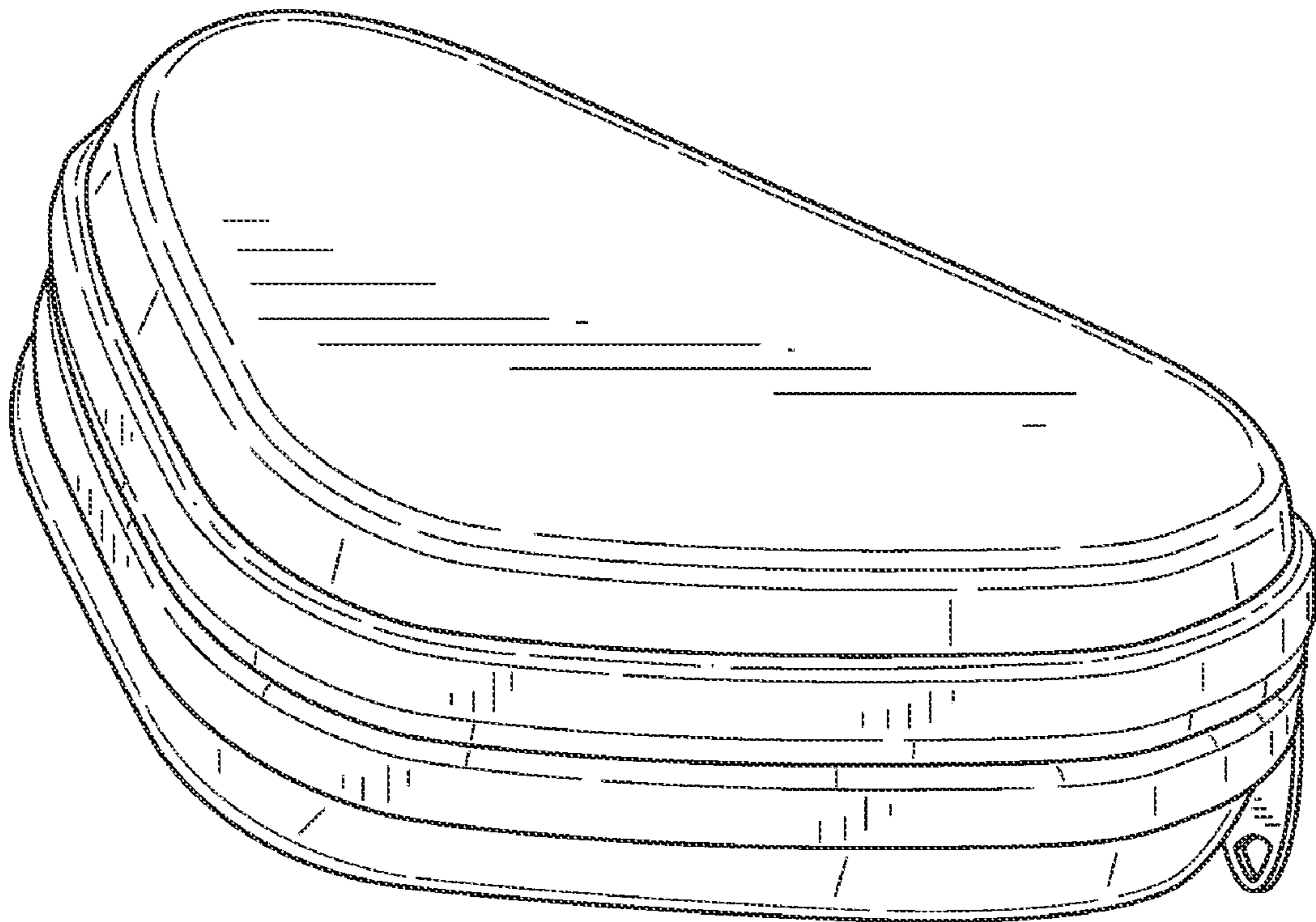

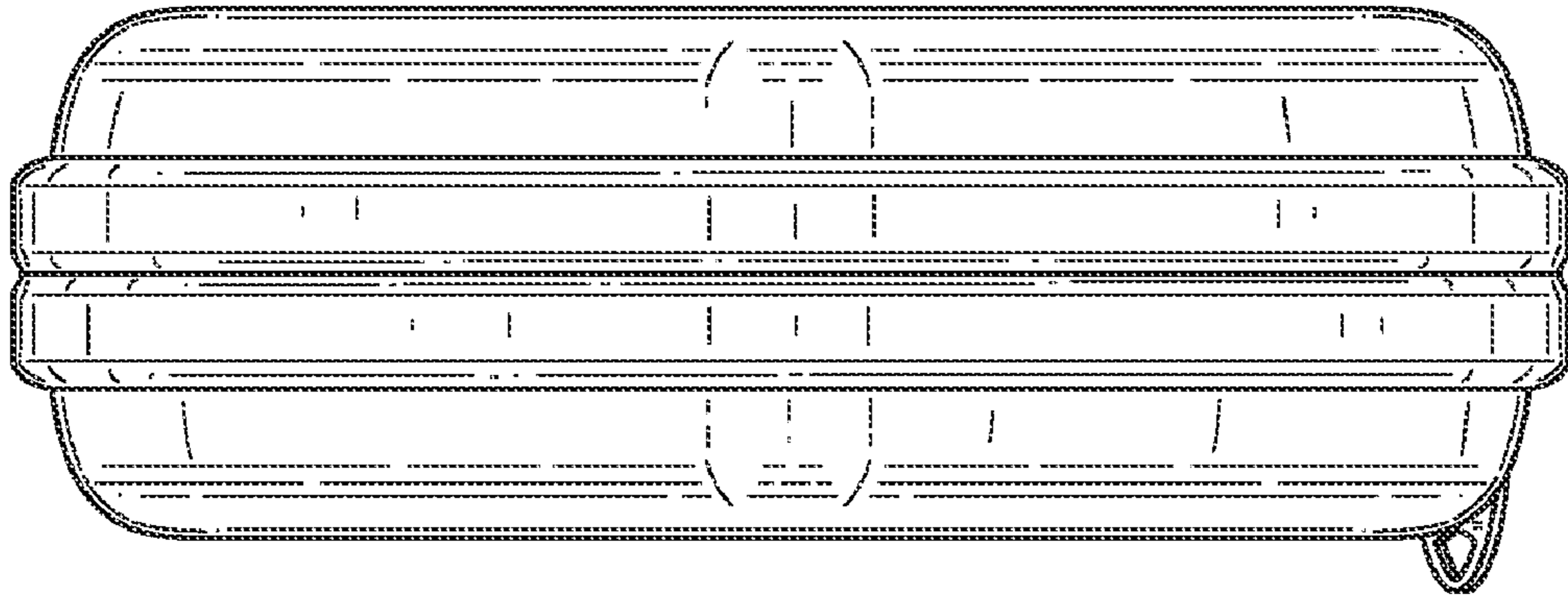

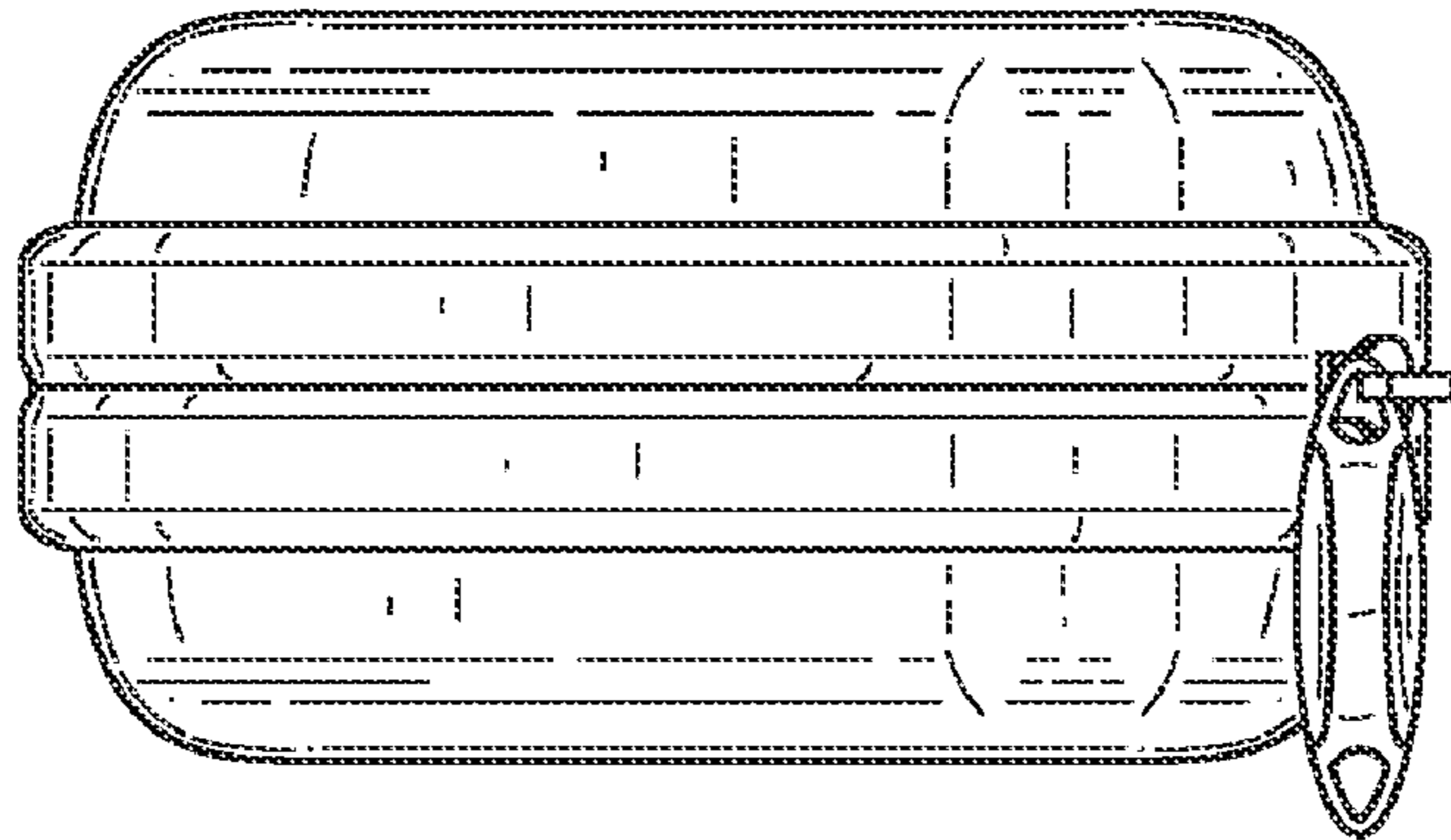

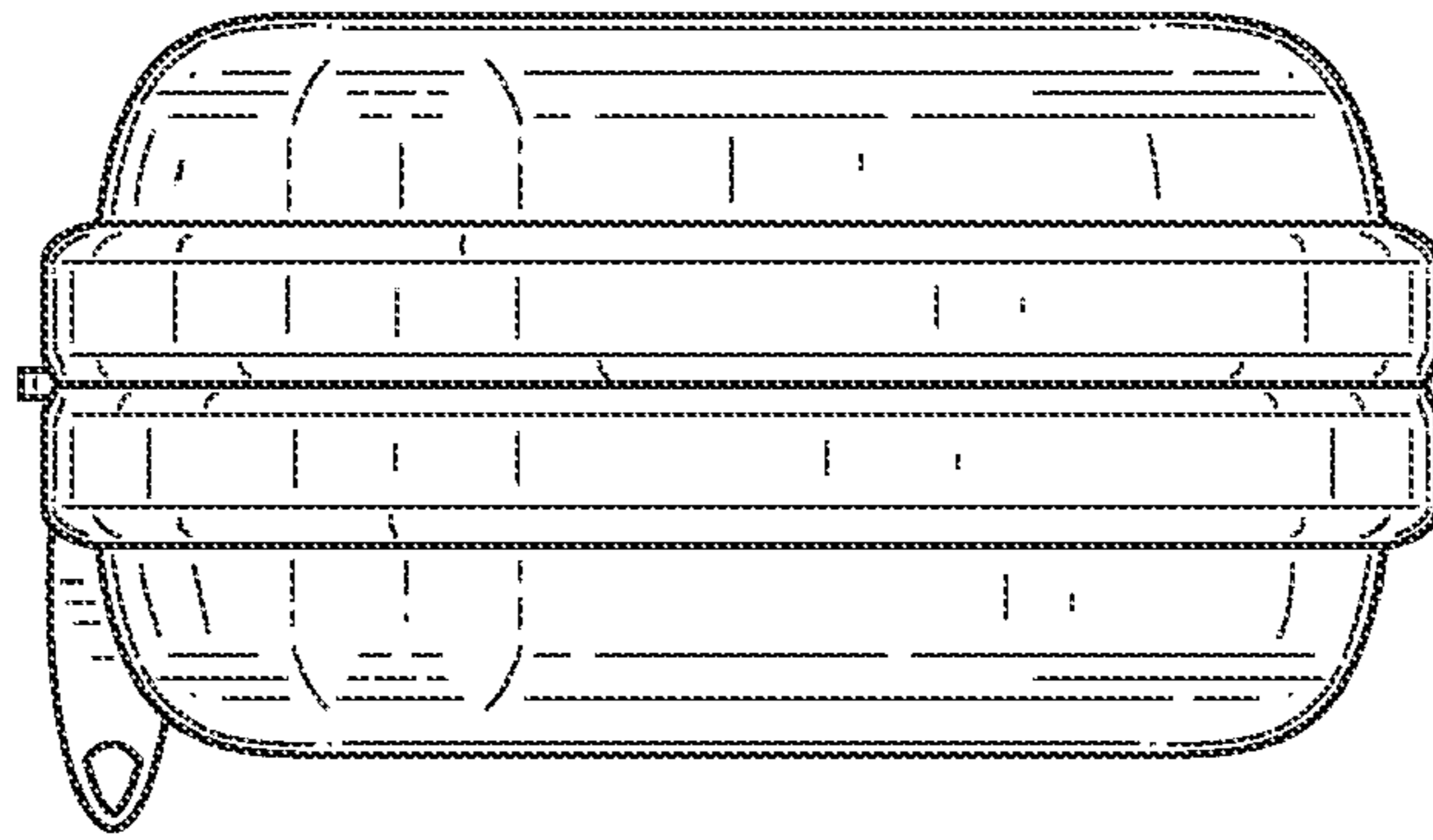

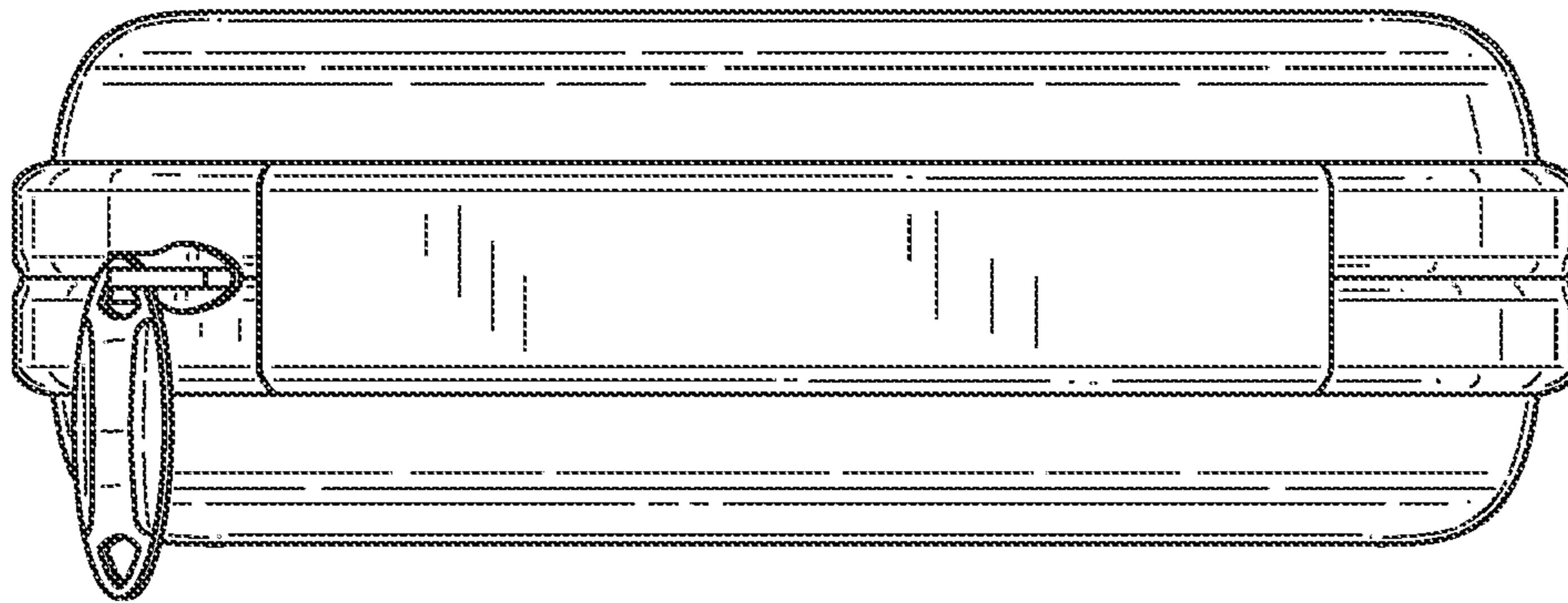

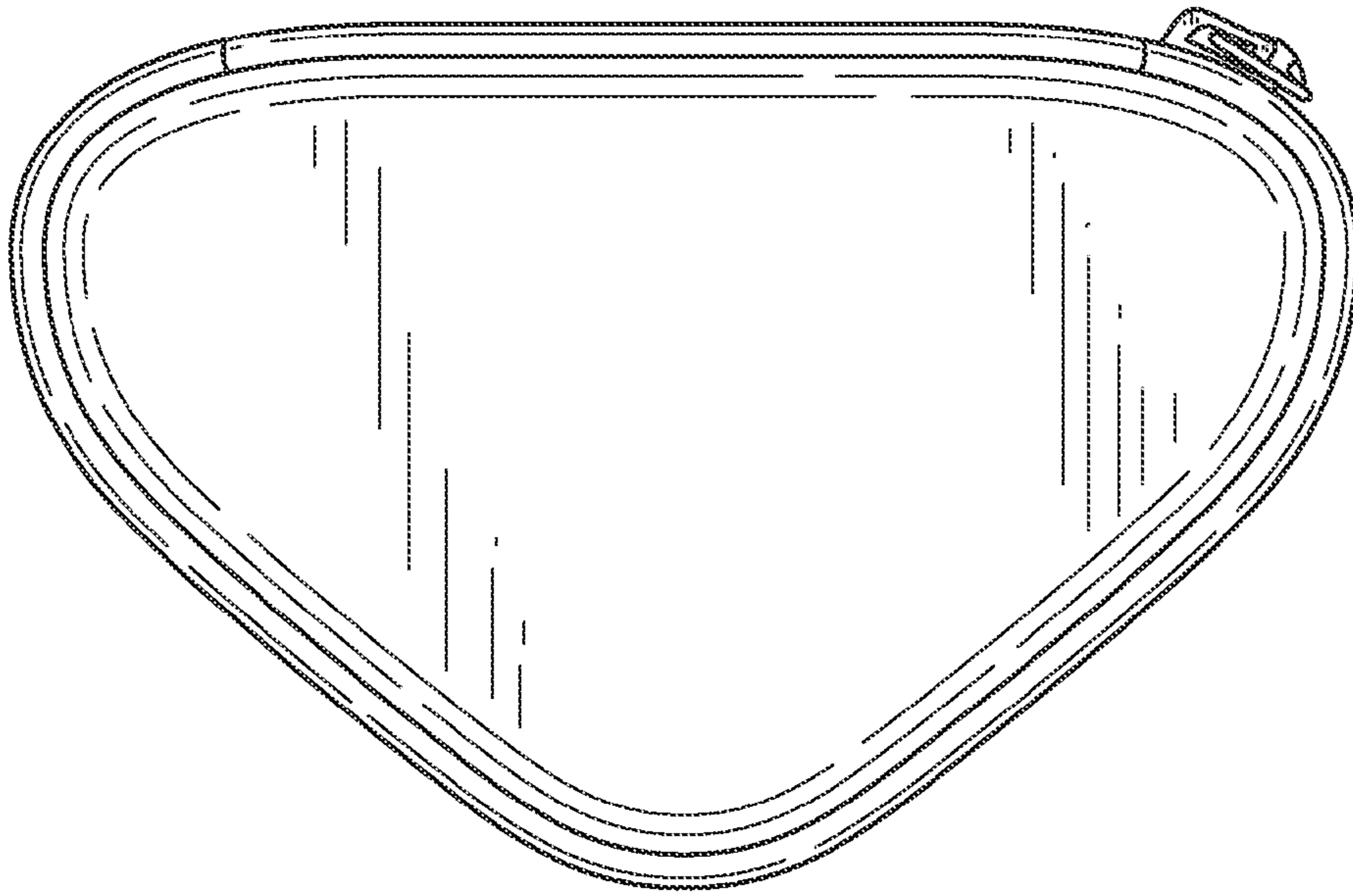

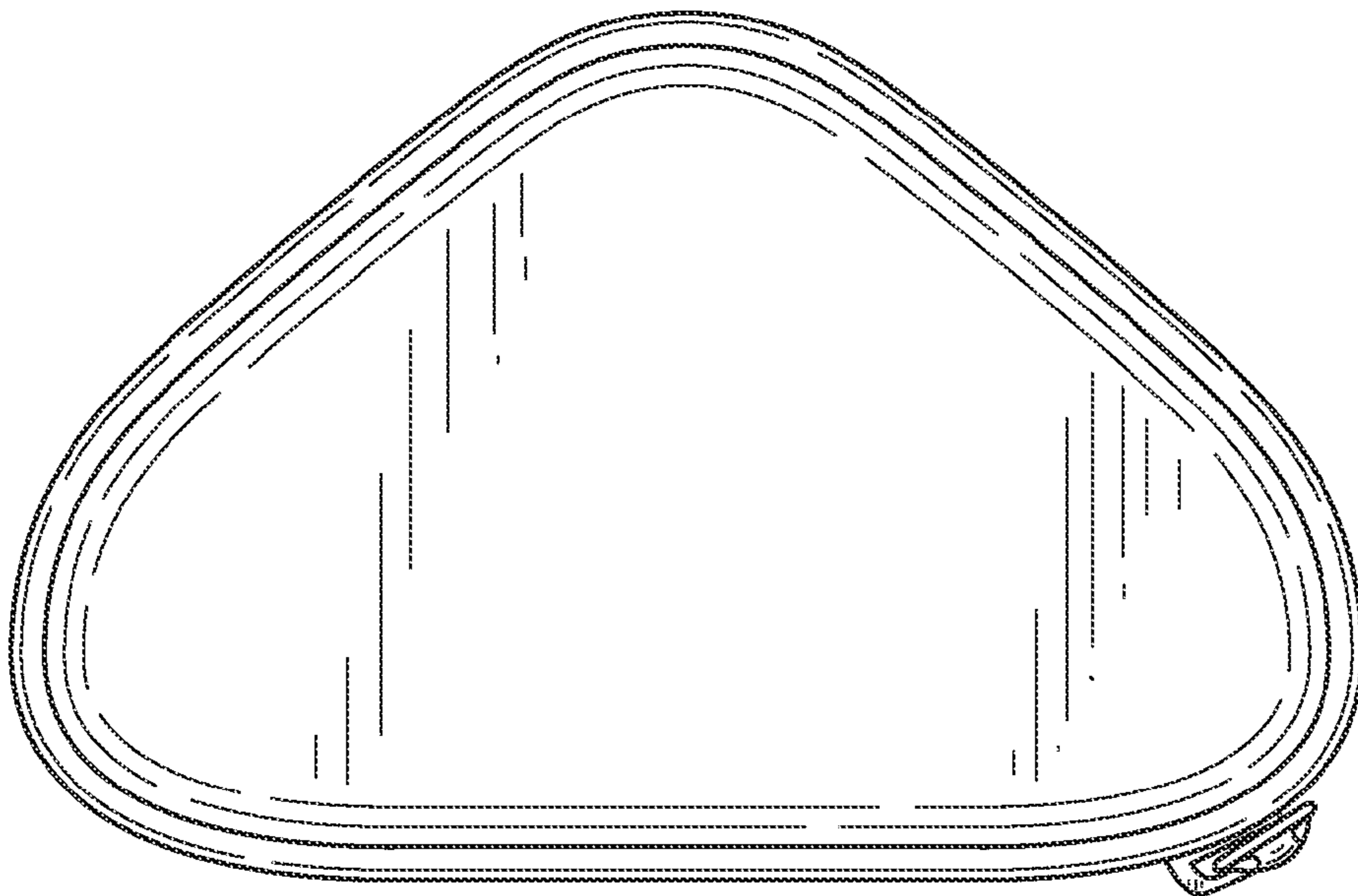

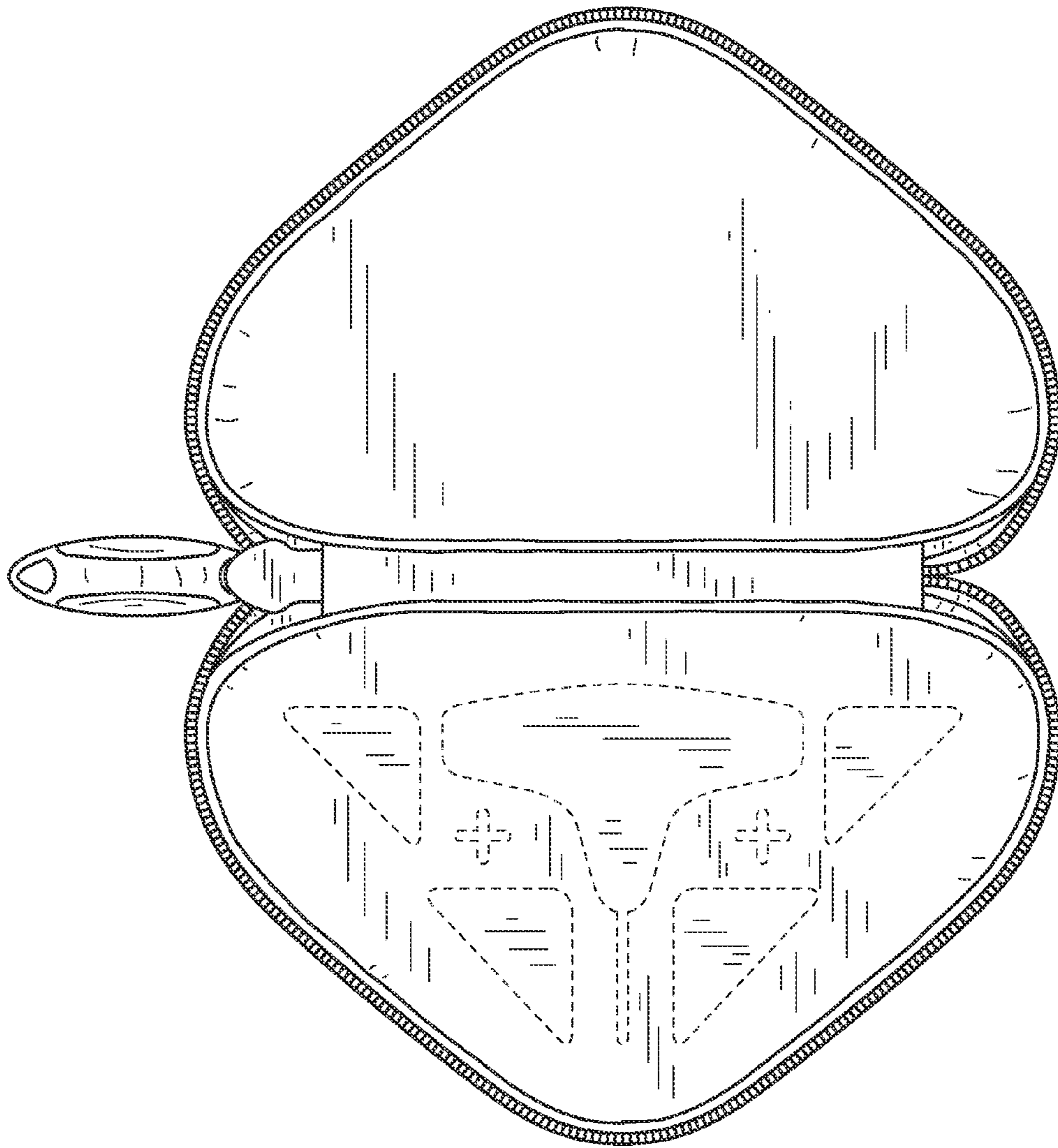

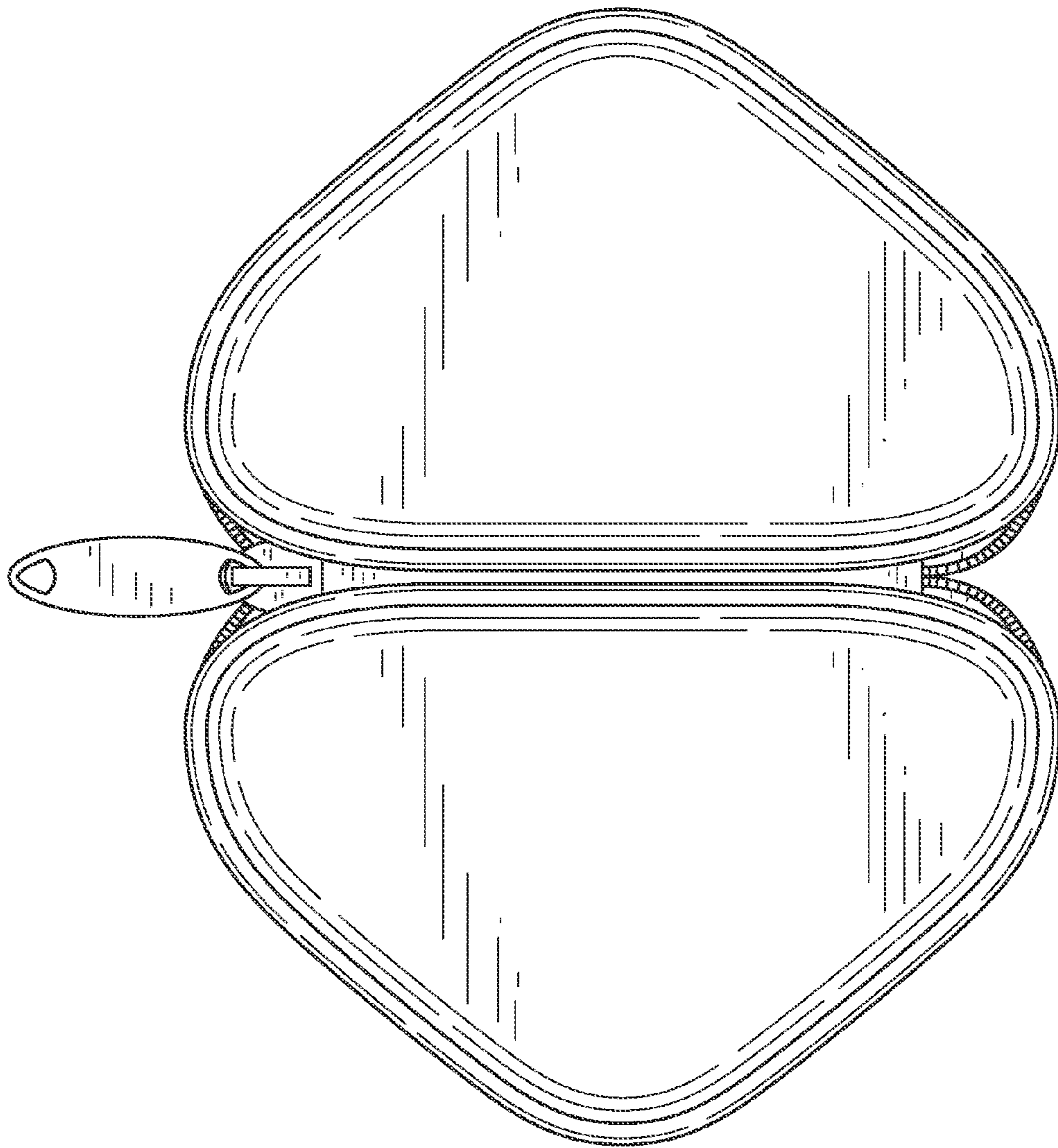
