FIG. 21 is a right side view of FIG. 19;

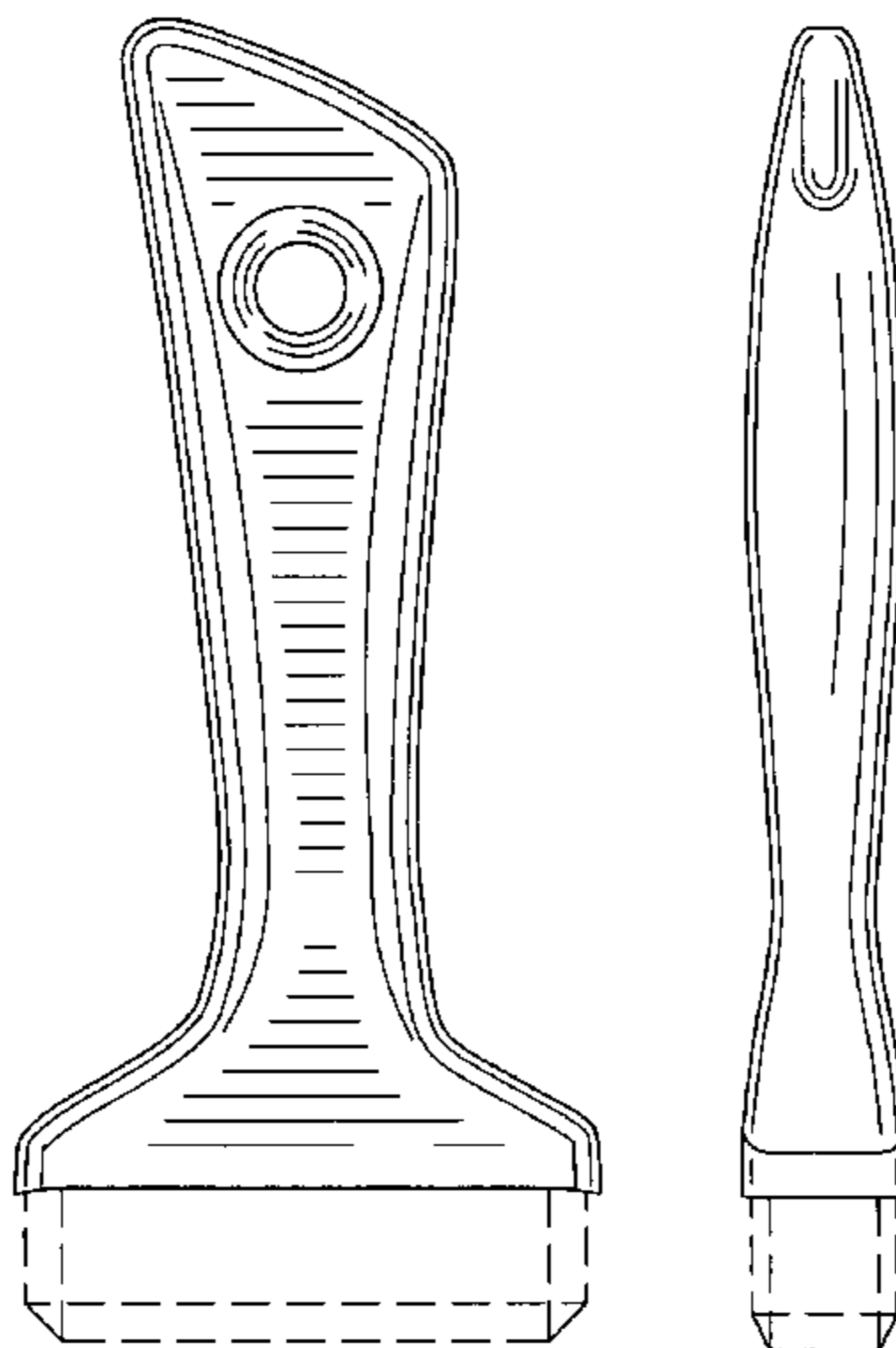
FIG. 22 is a left side view of FIG. 19;

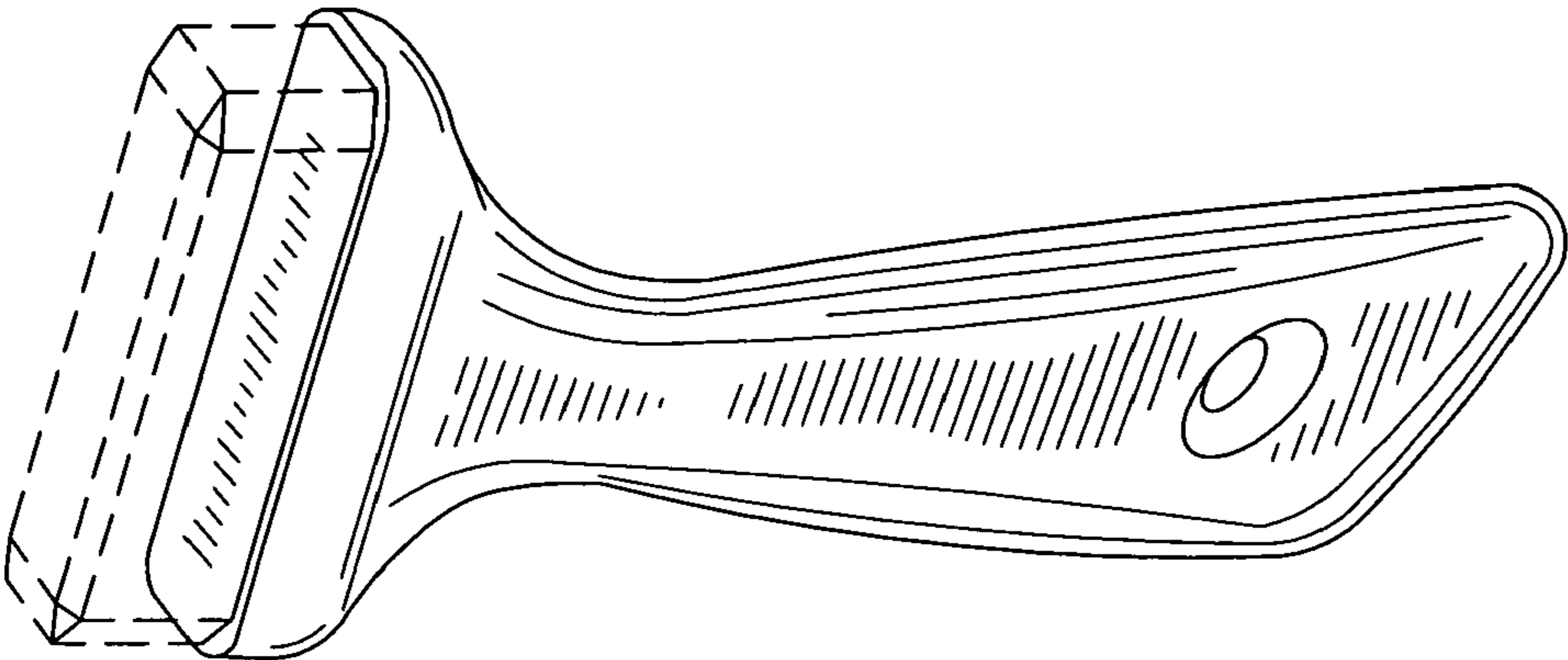

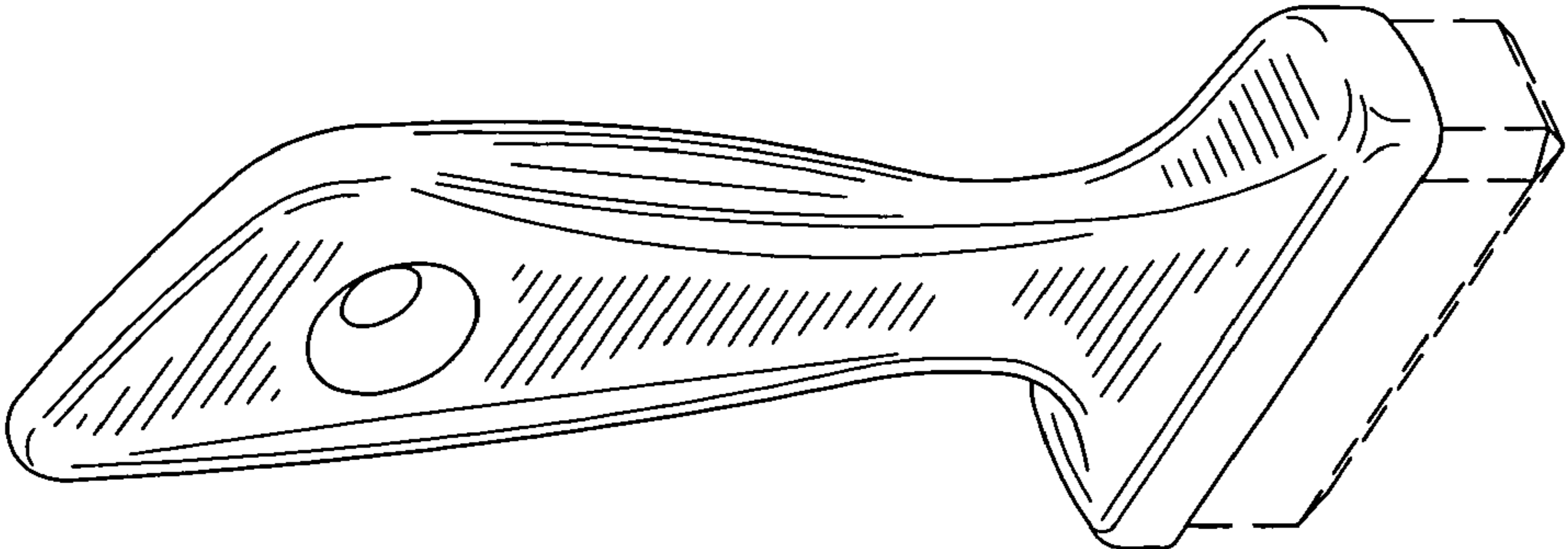

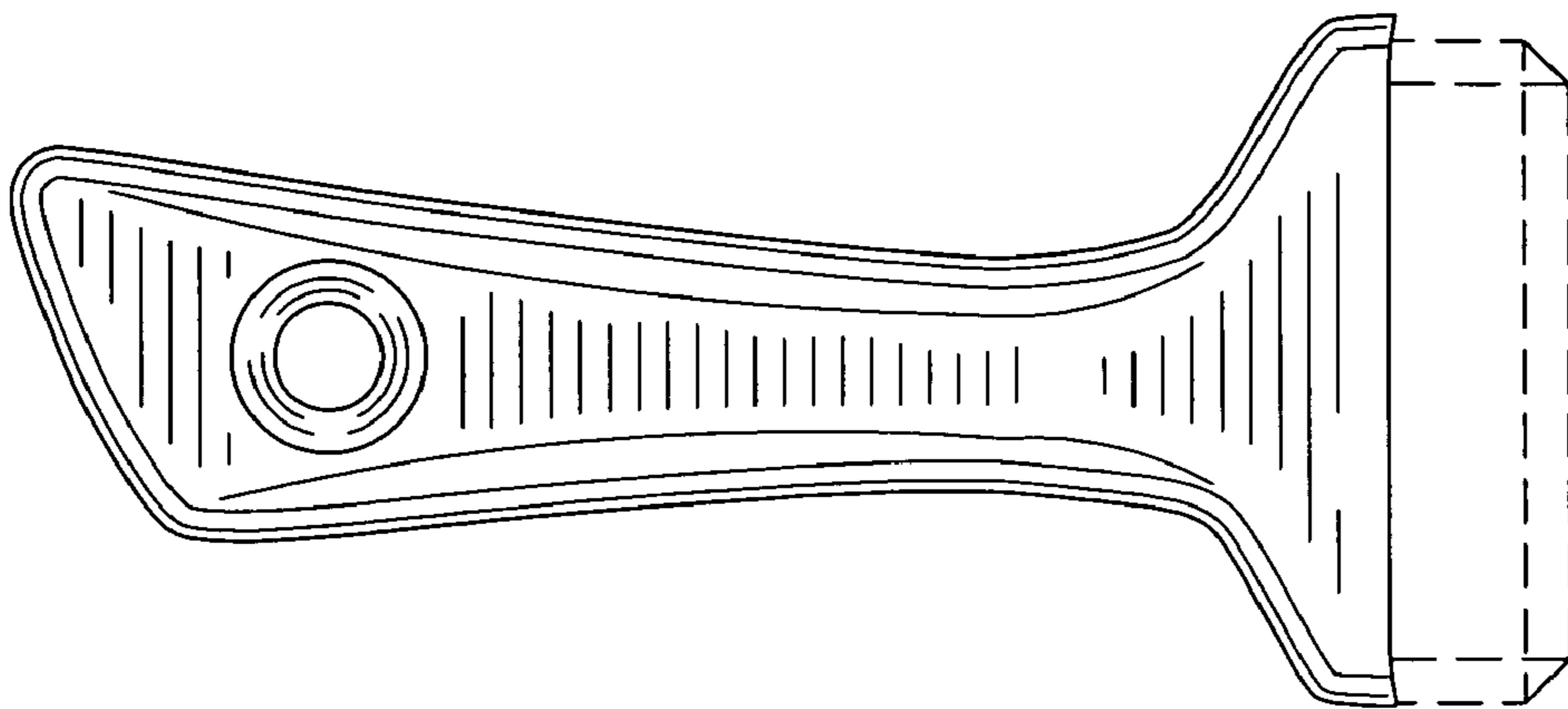

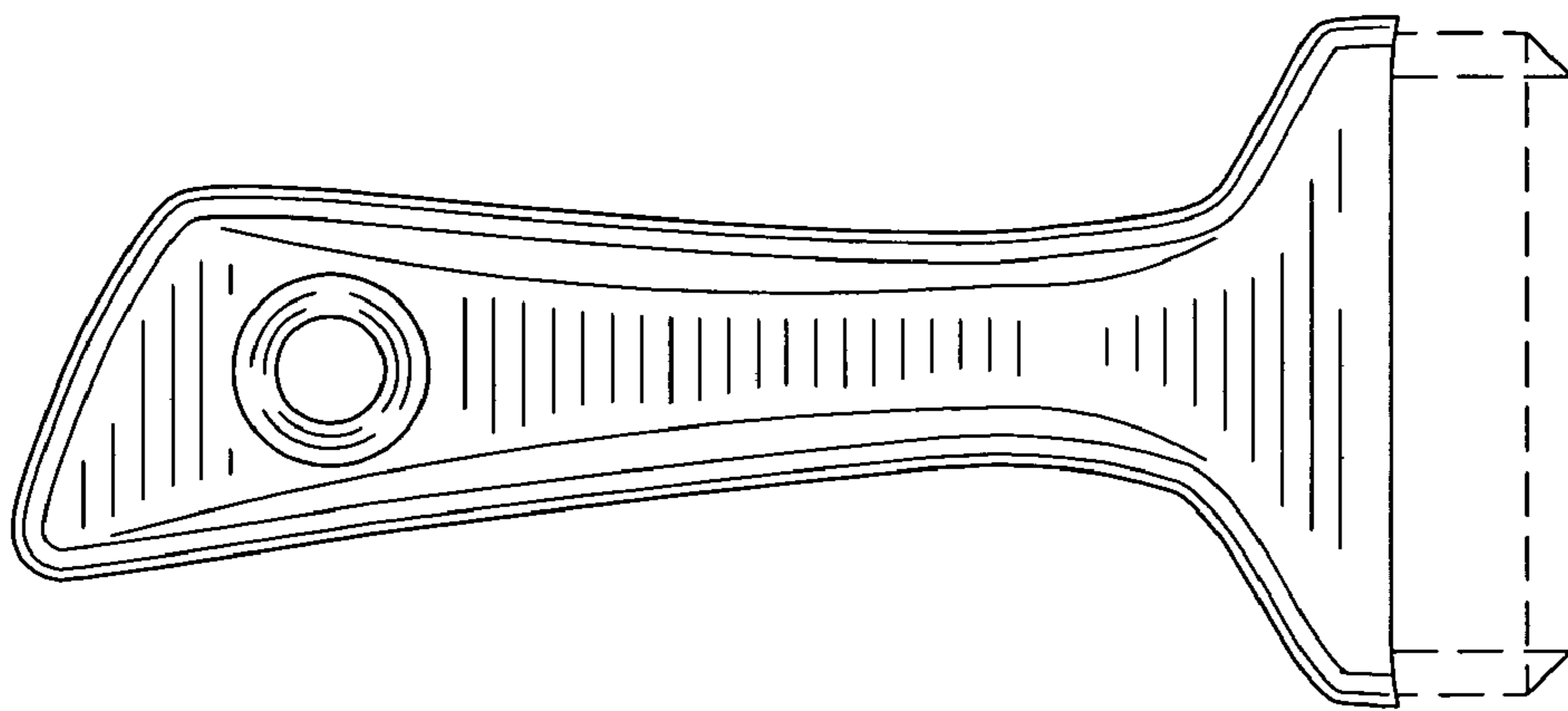

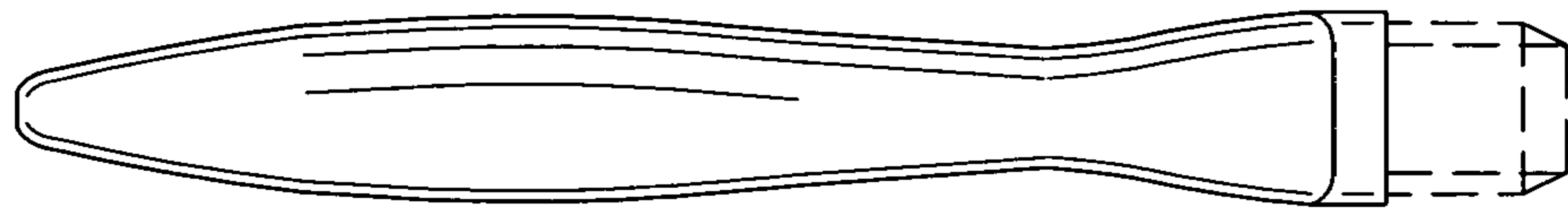

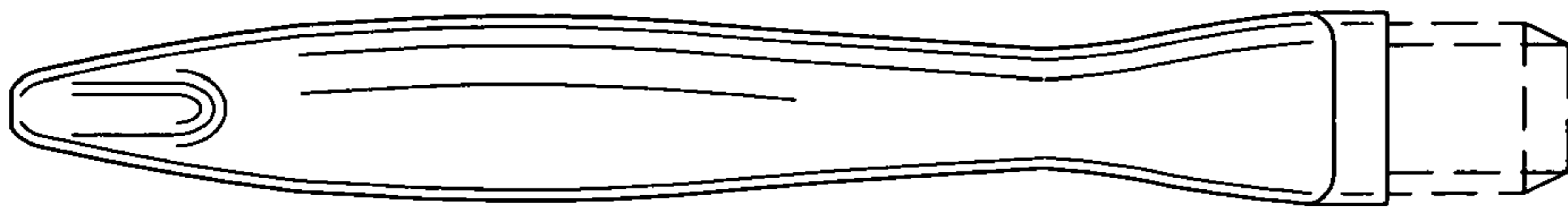

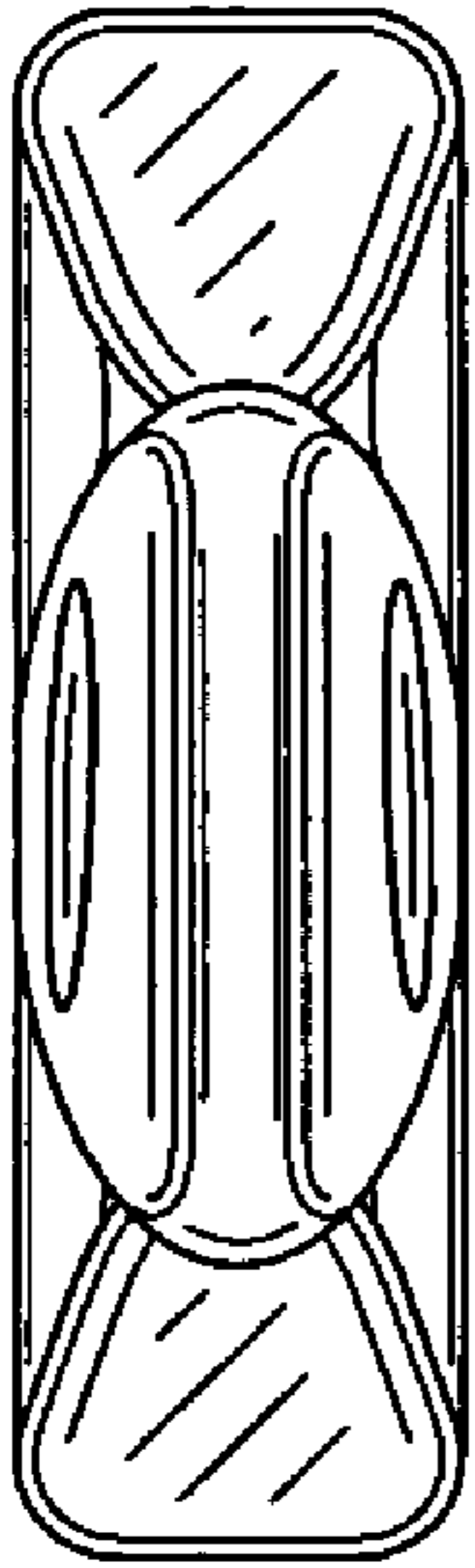

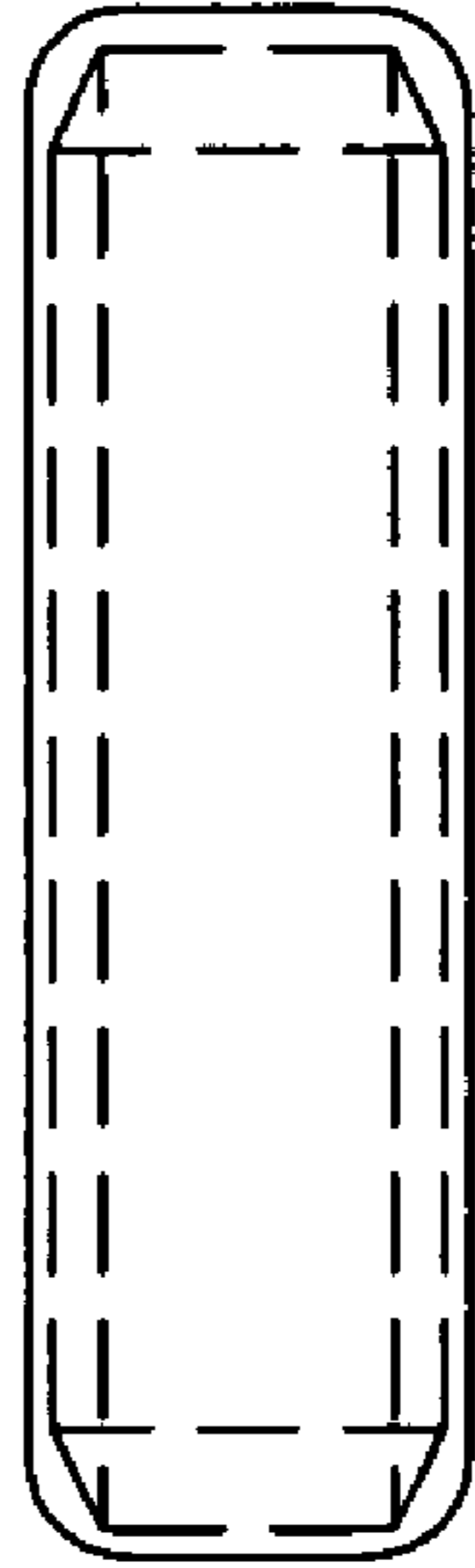

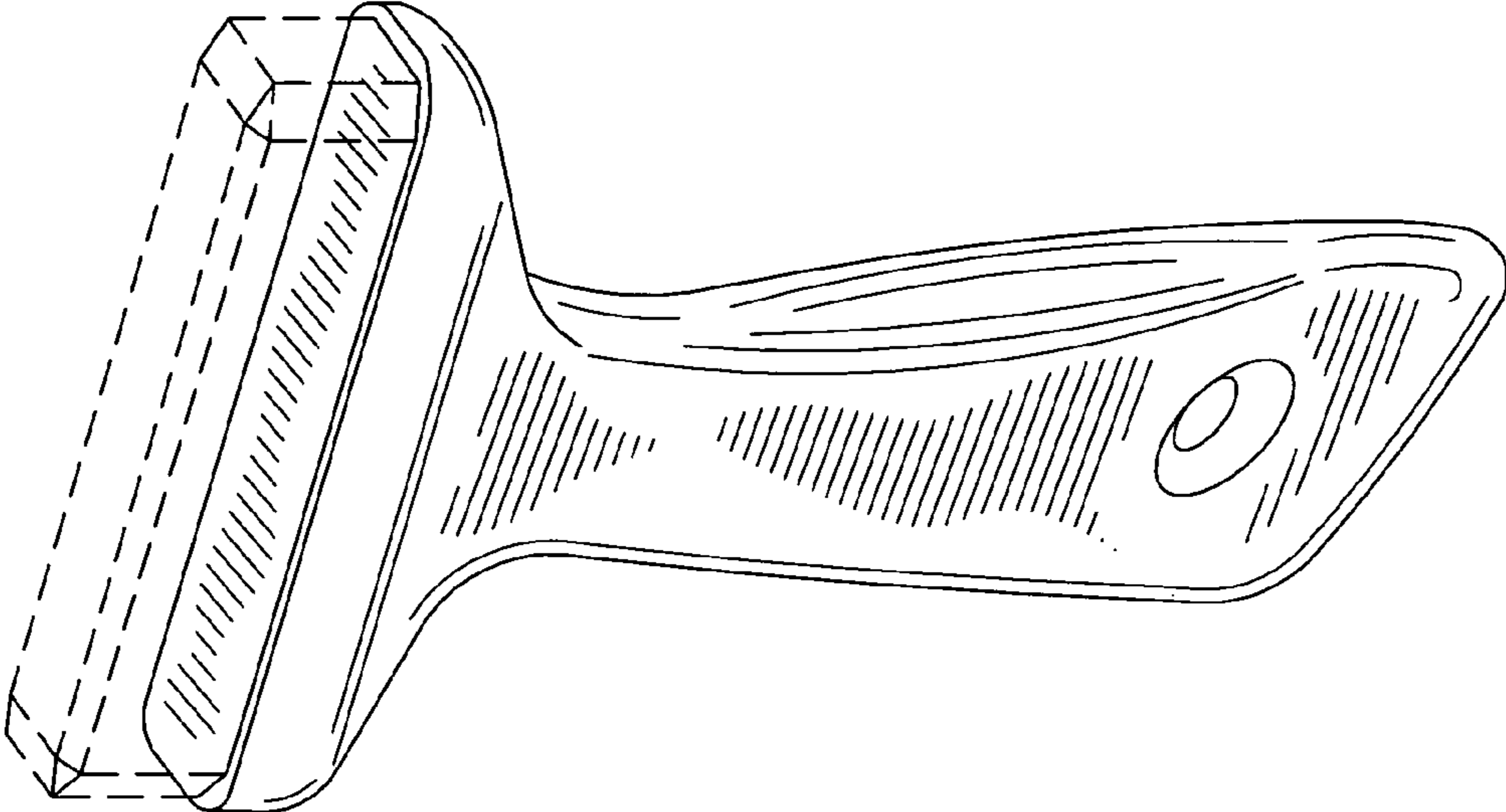

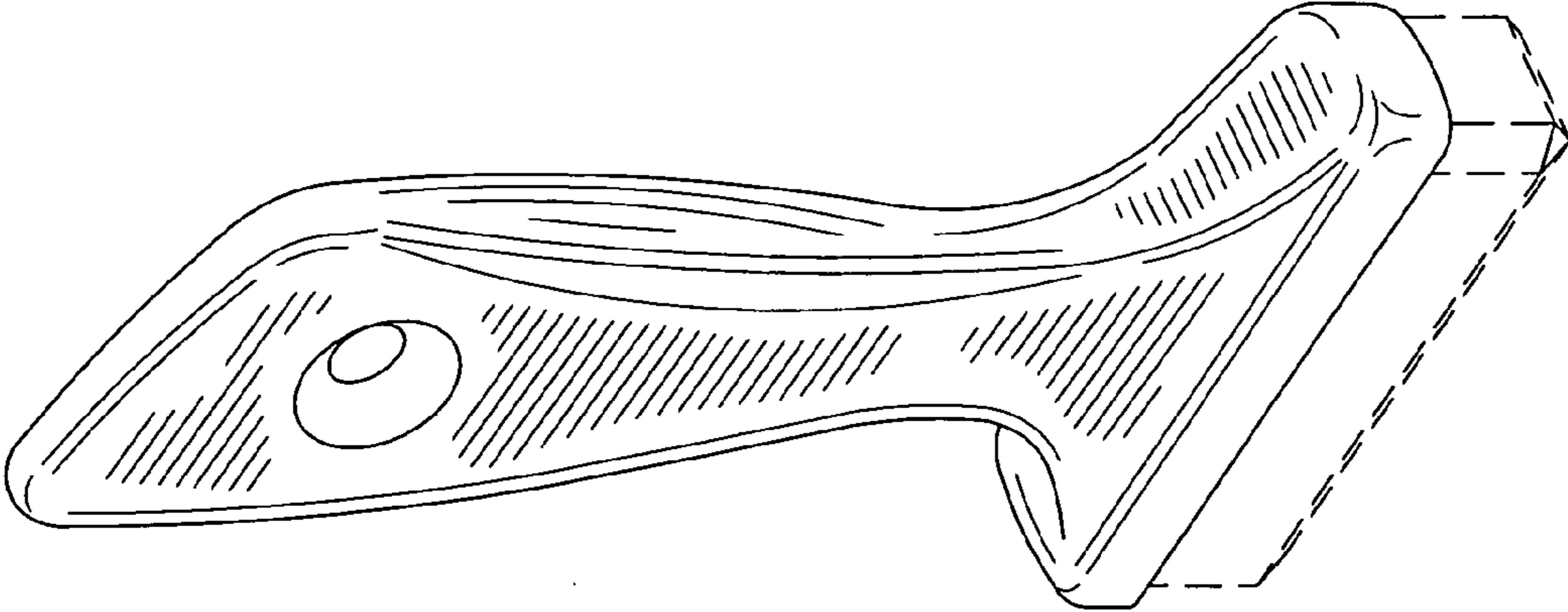

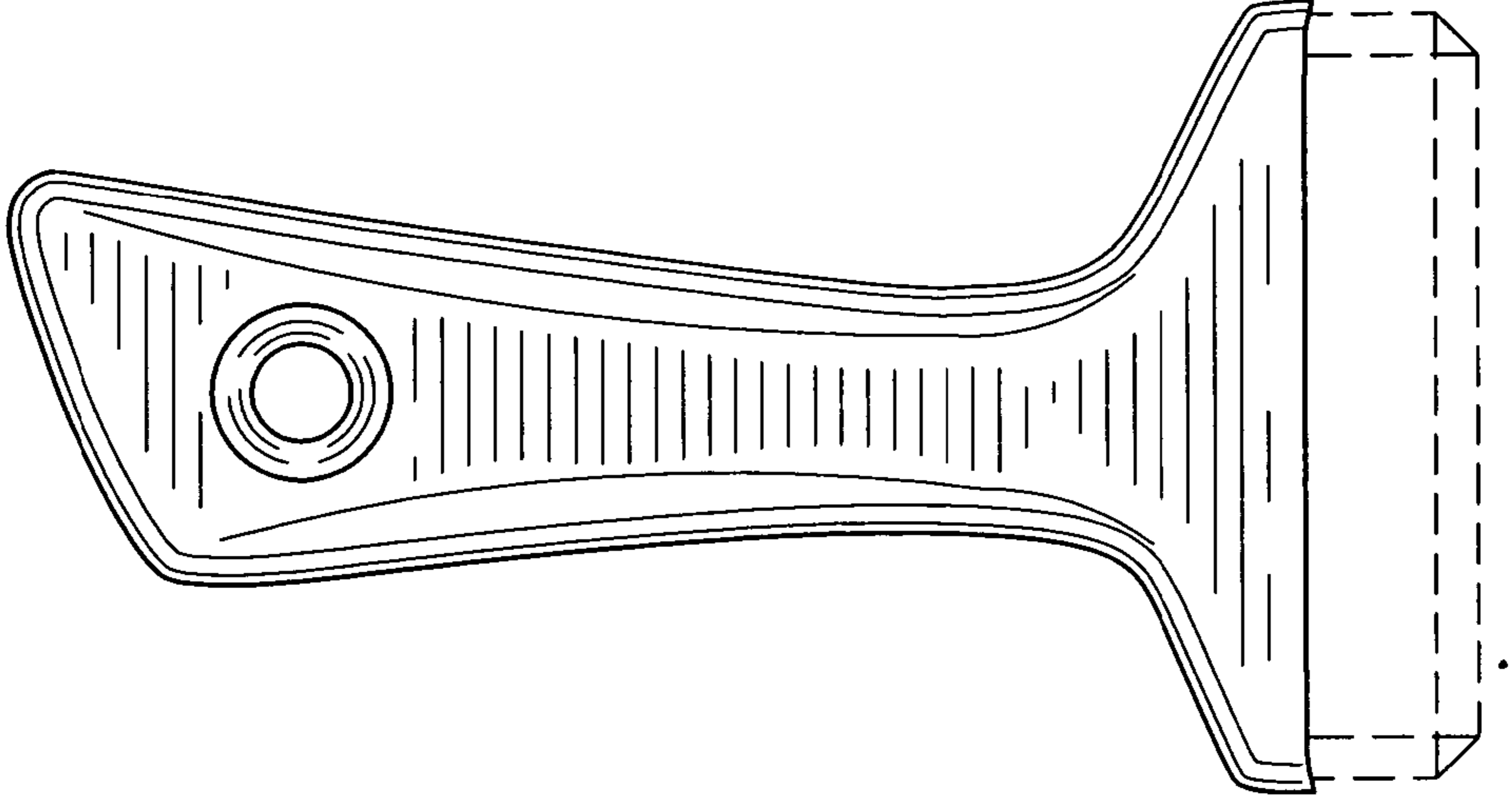

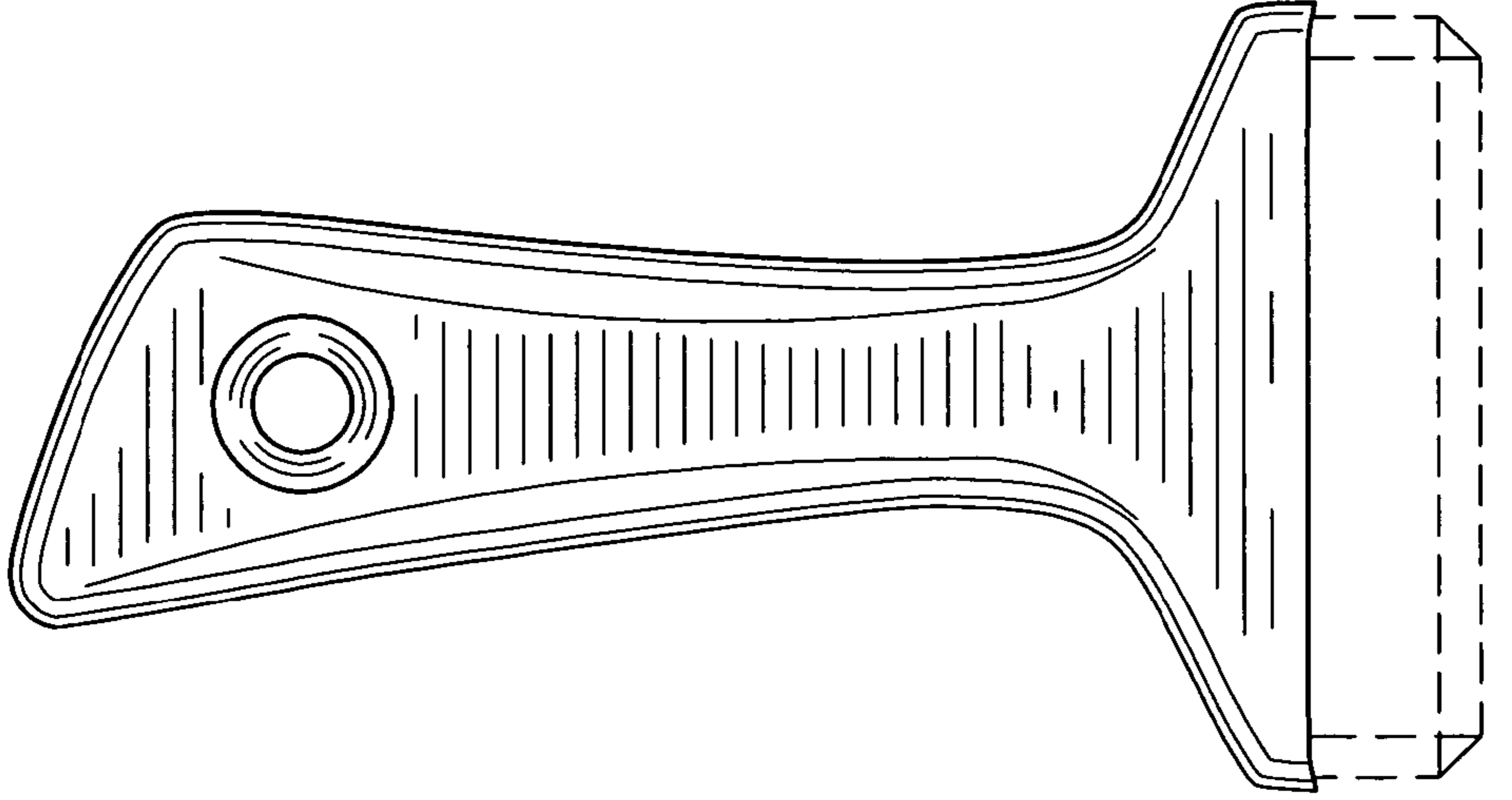

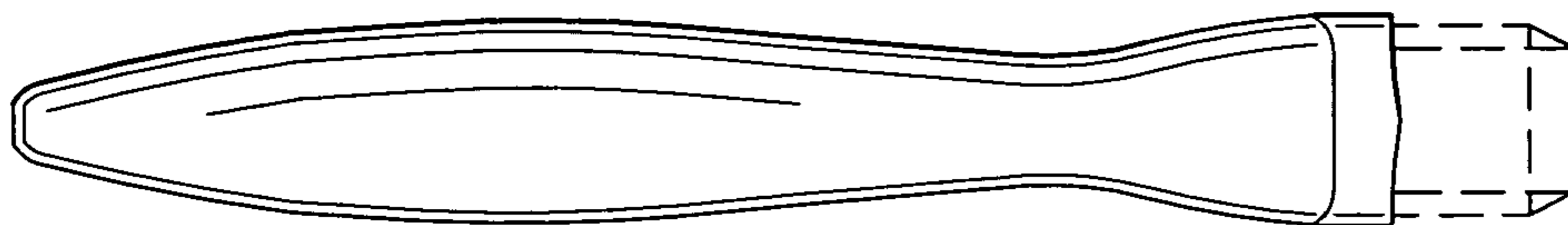

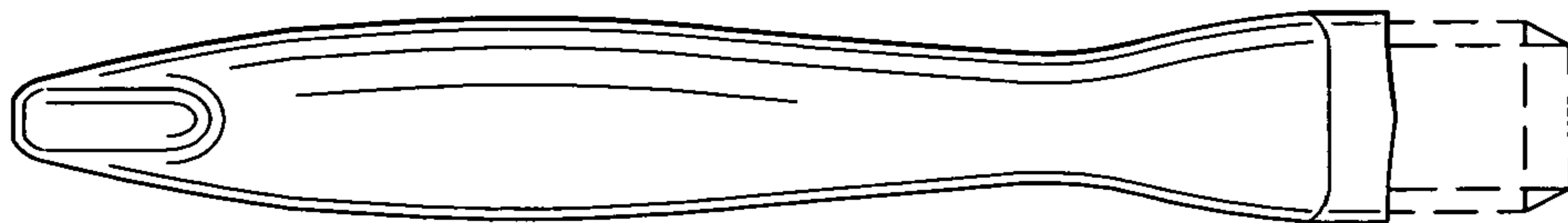

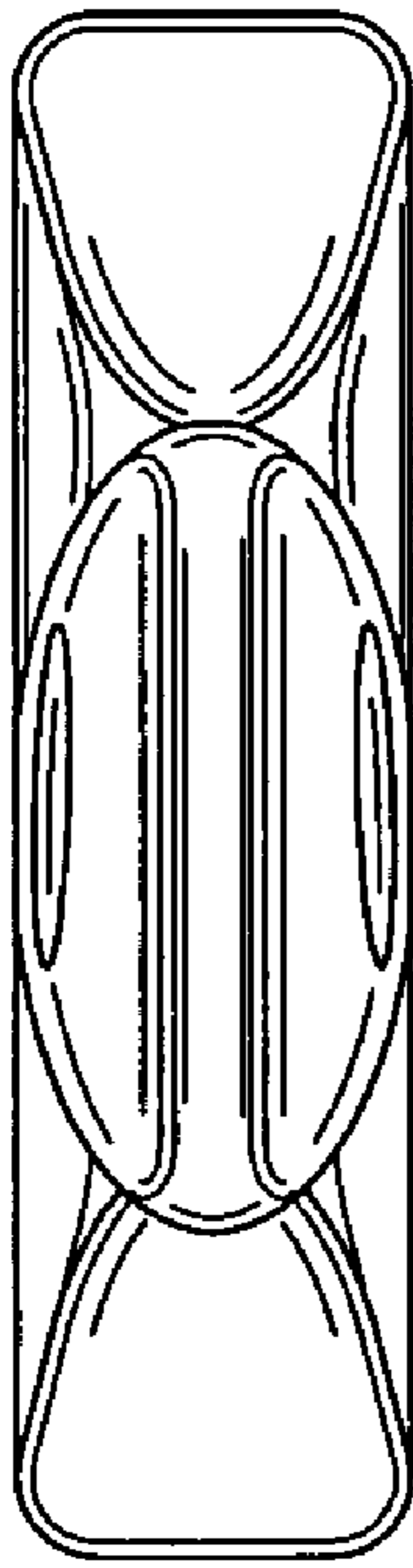

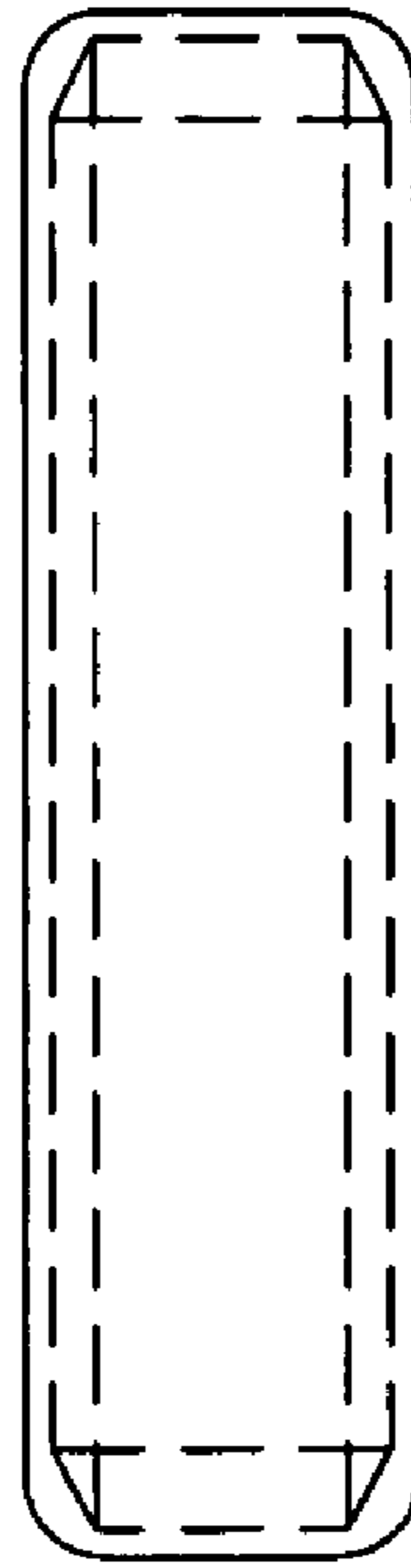

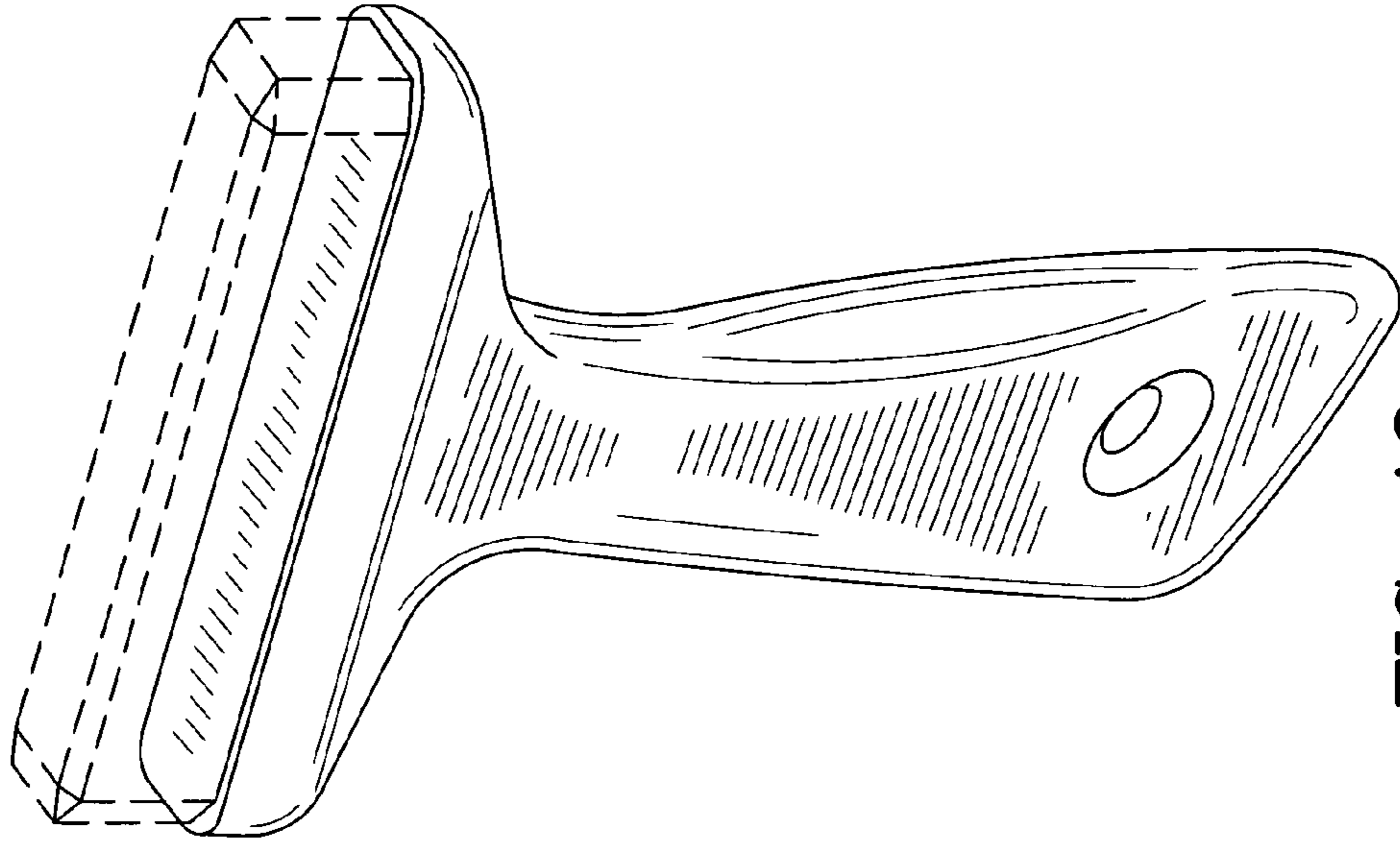

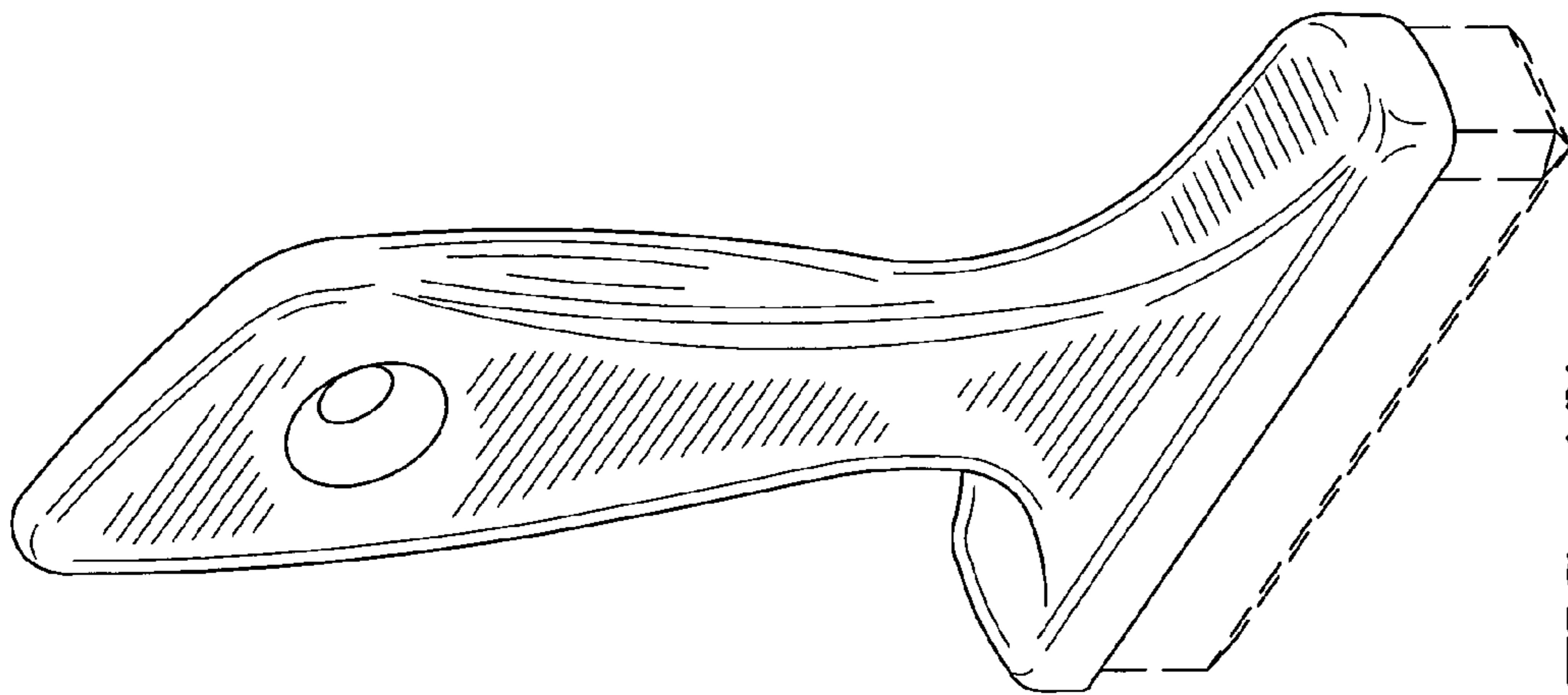

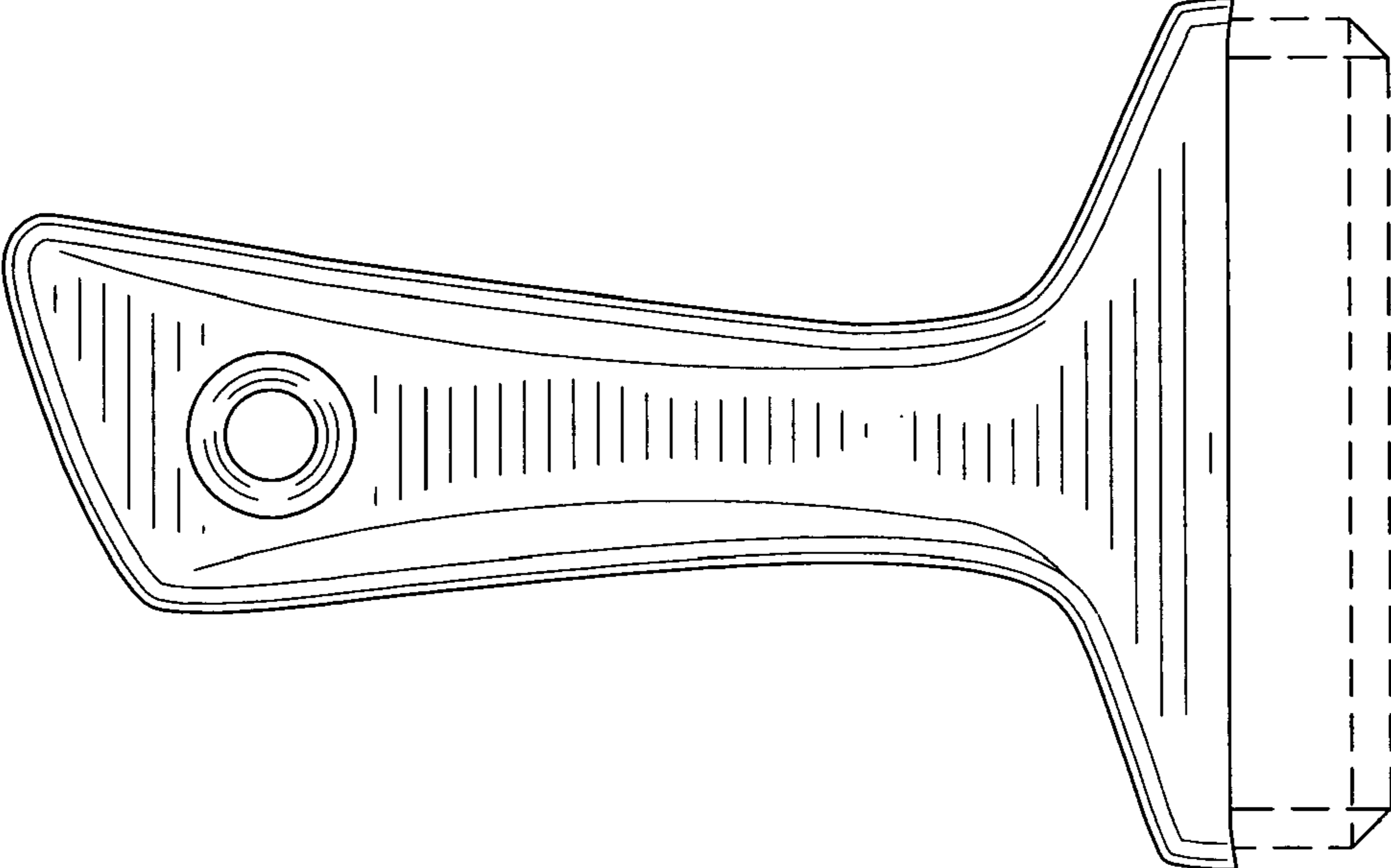

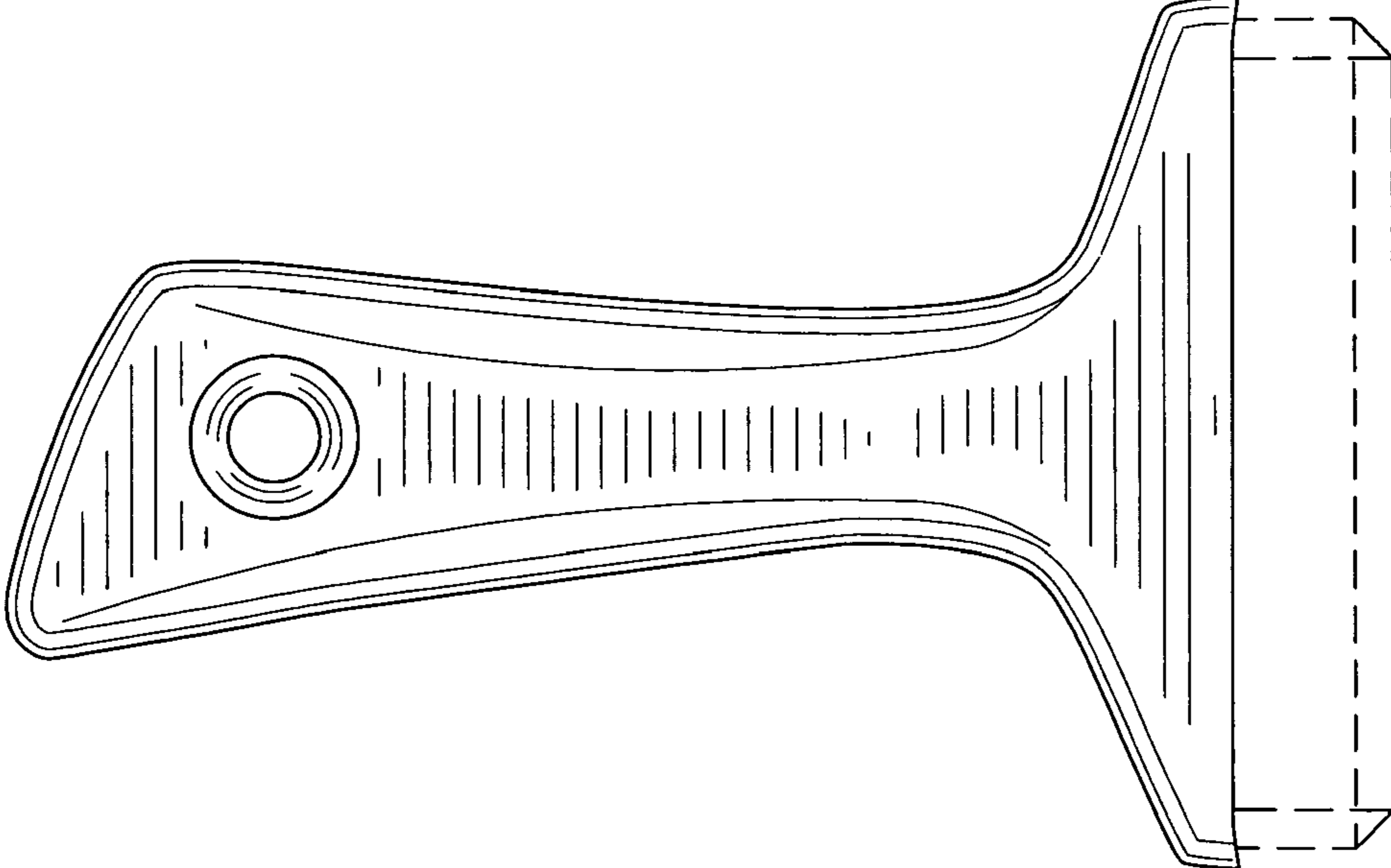

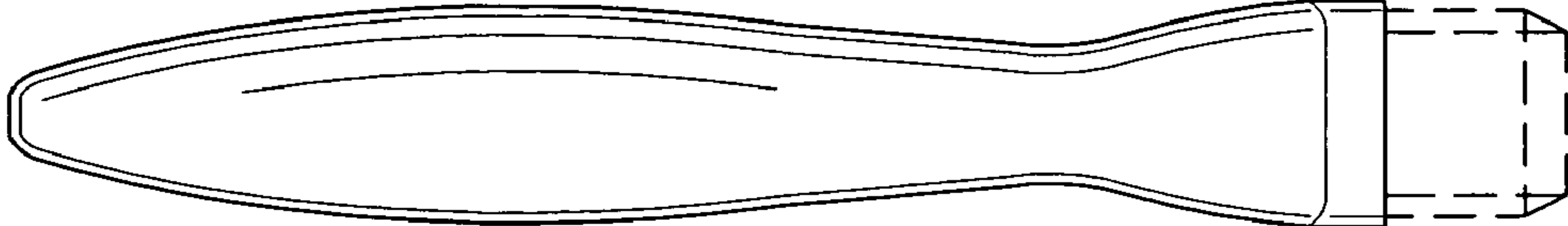

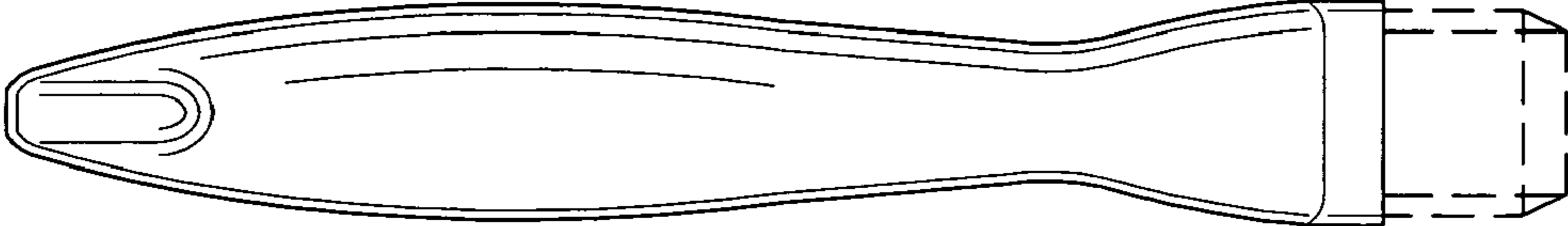

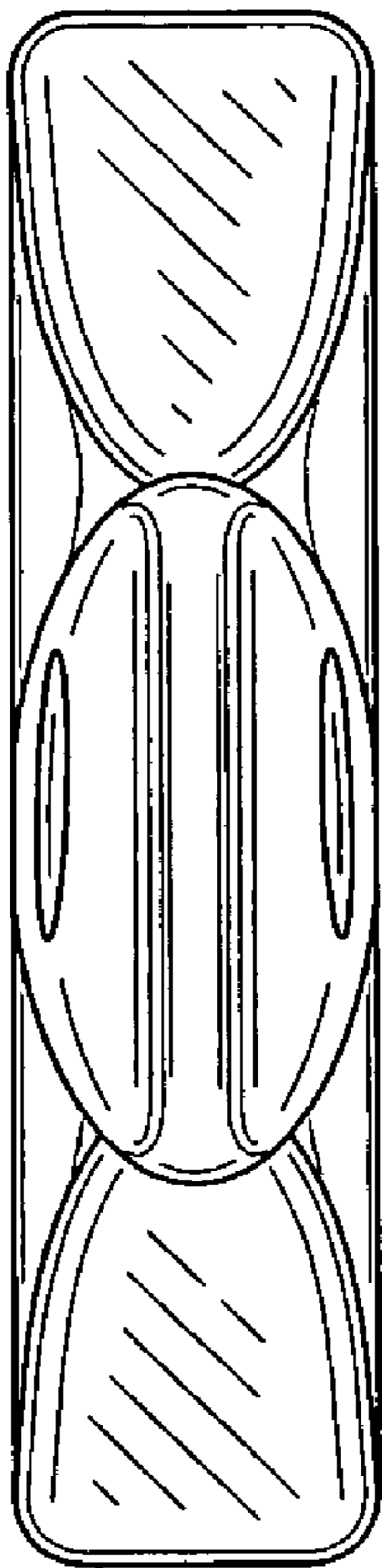

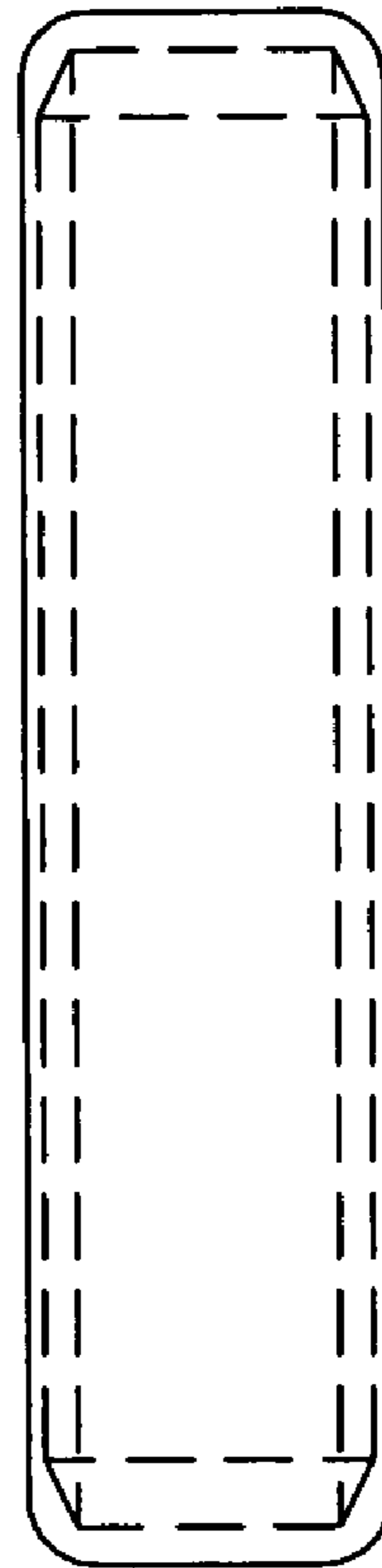
