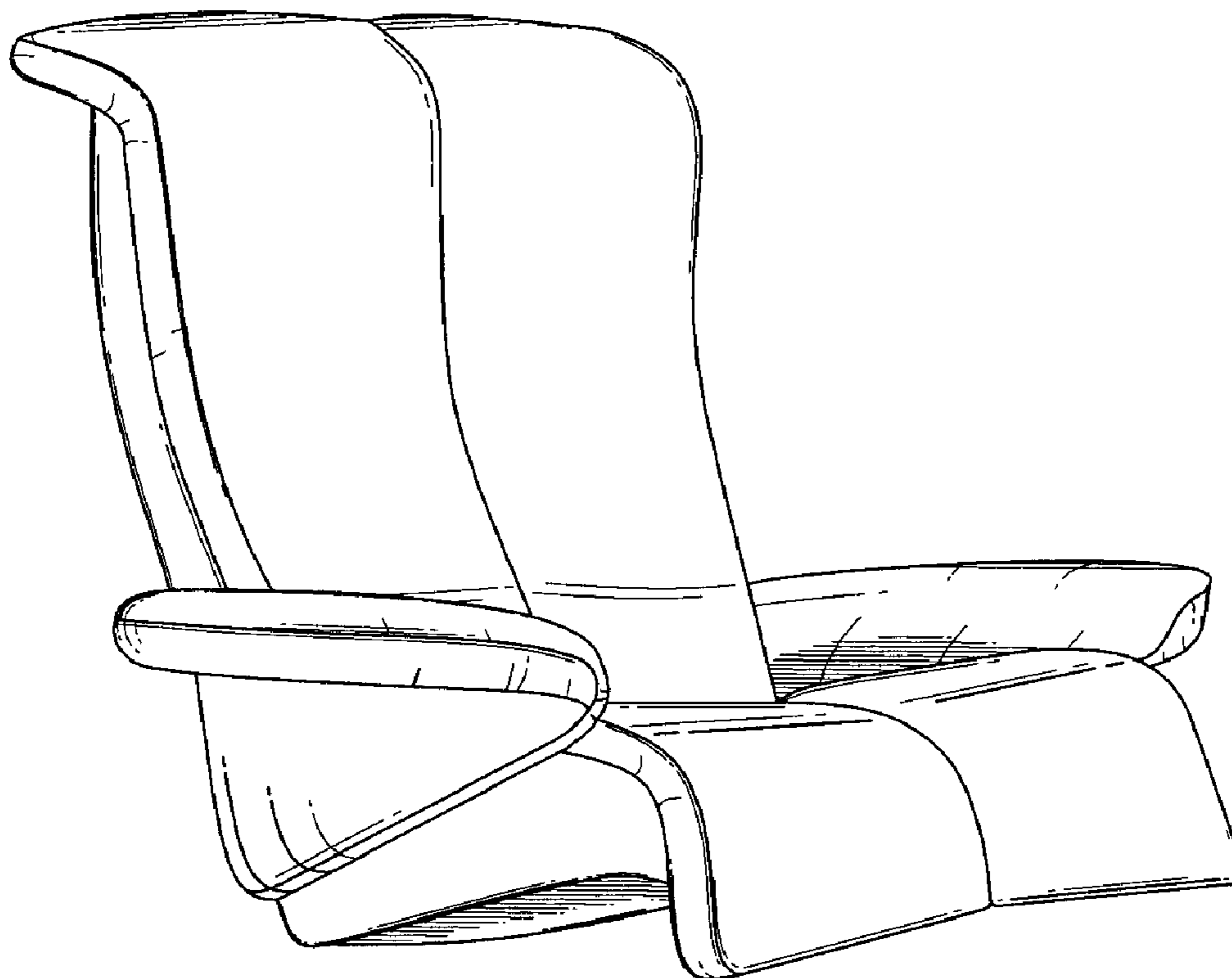
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a chair of my design.
FIG. 2 is a rear perspective view of the chair shown in FIG. 1.
FIG. 3 is a front elevation view of the chair shown in FIG. 1.
FIG. 4 is a rear elevation view of the chair shown in FIG. 1.

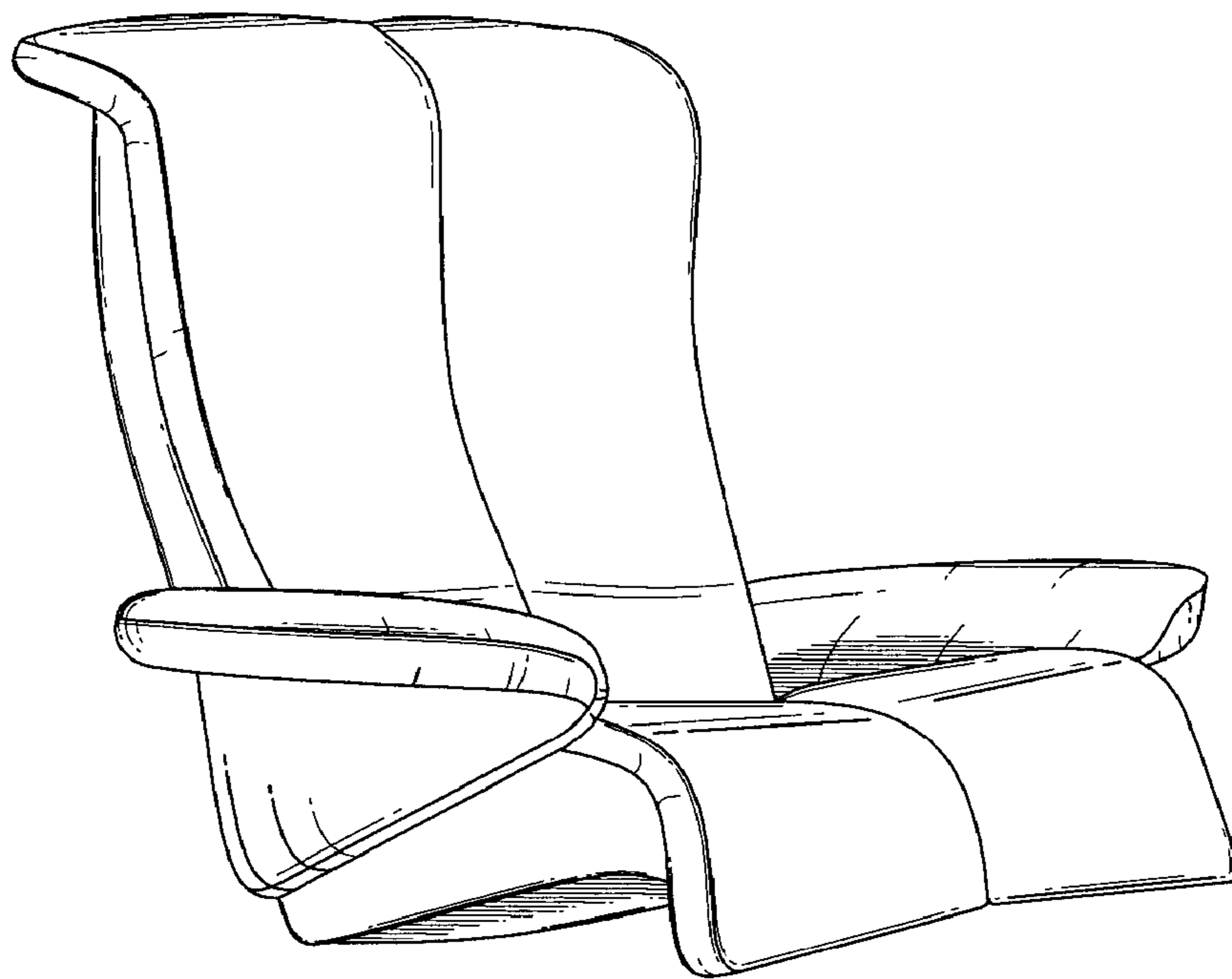

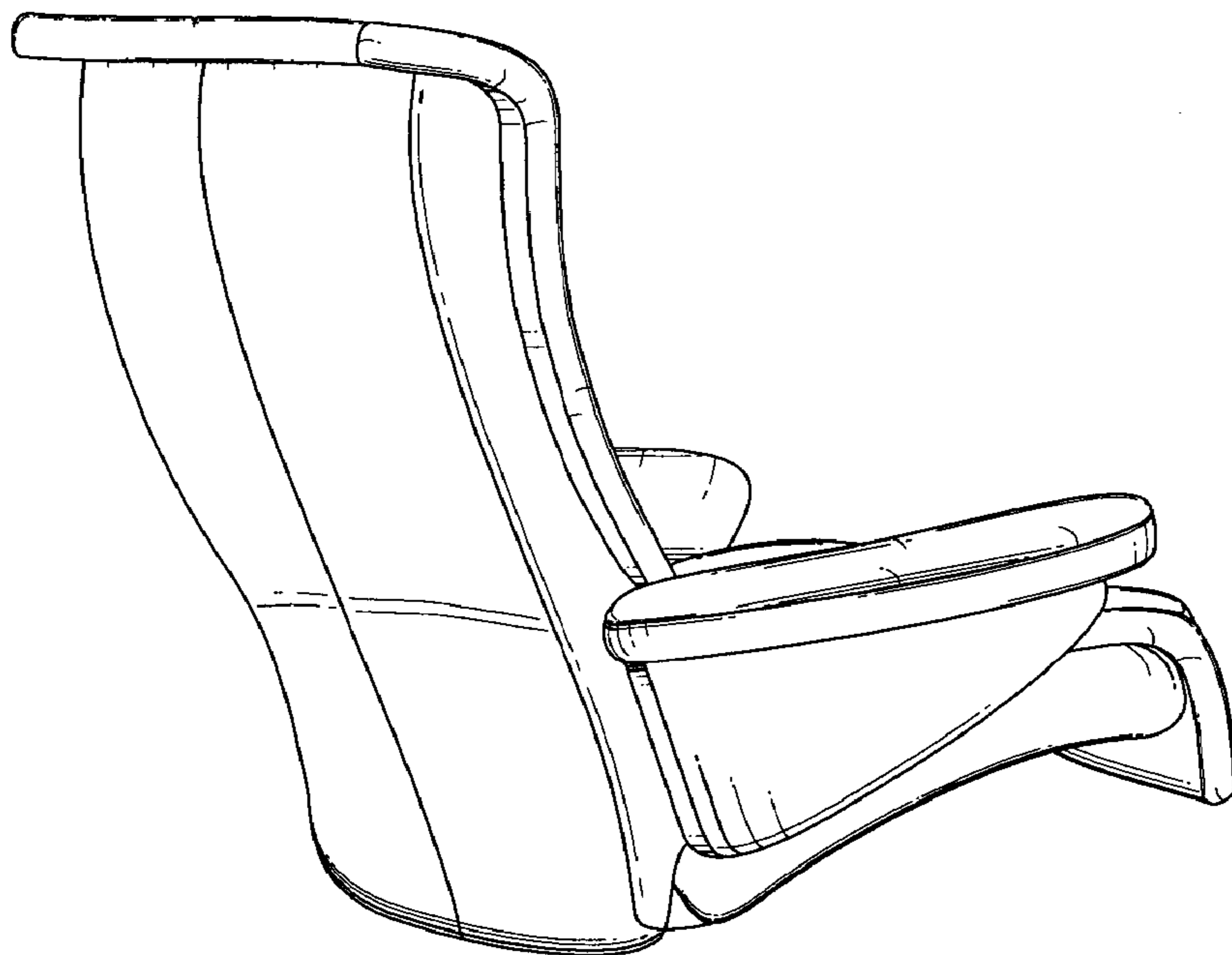

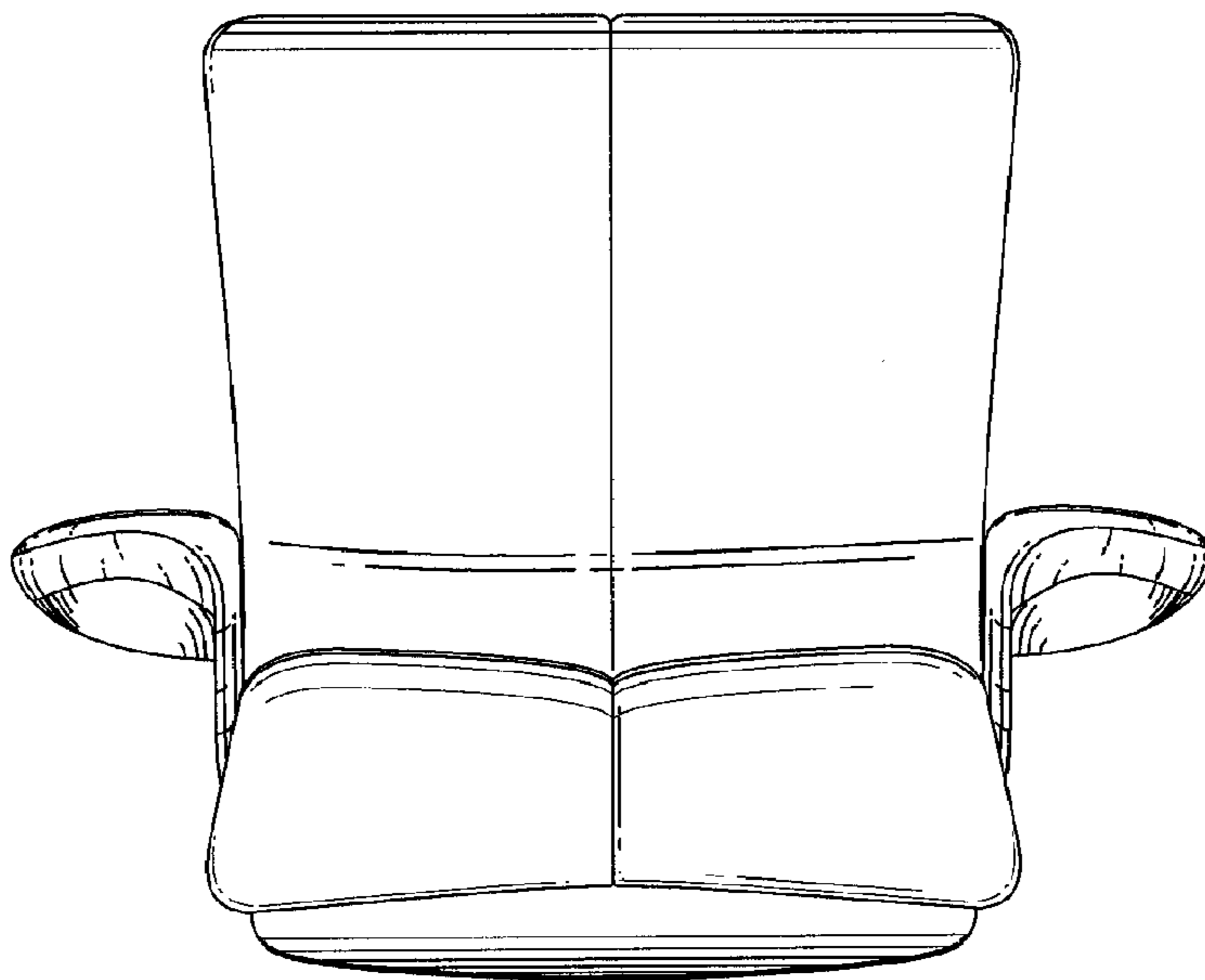

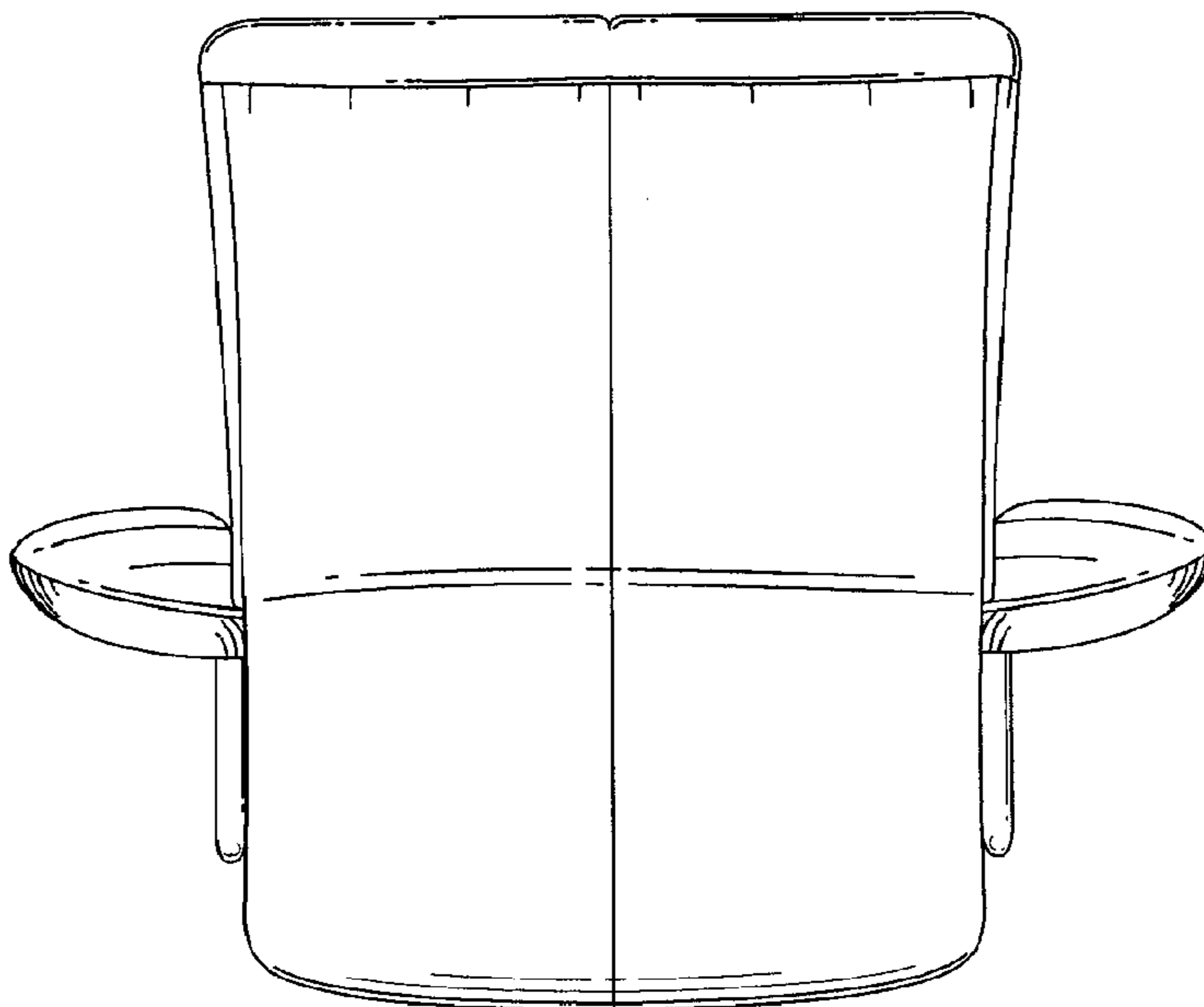

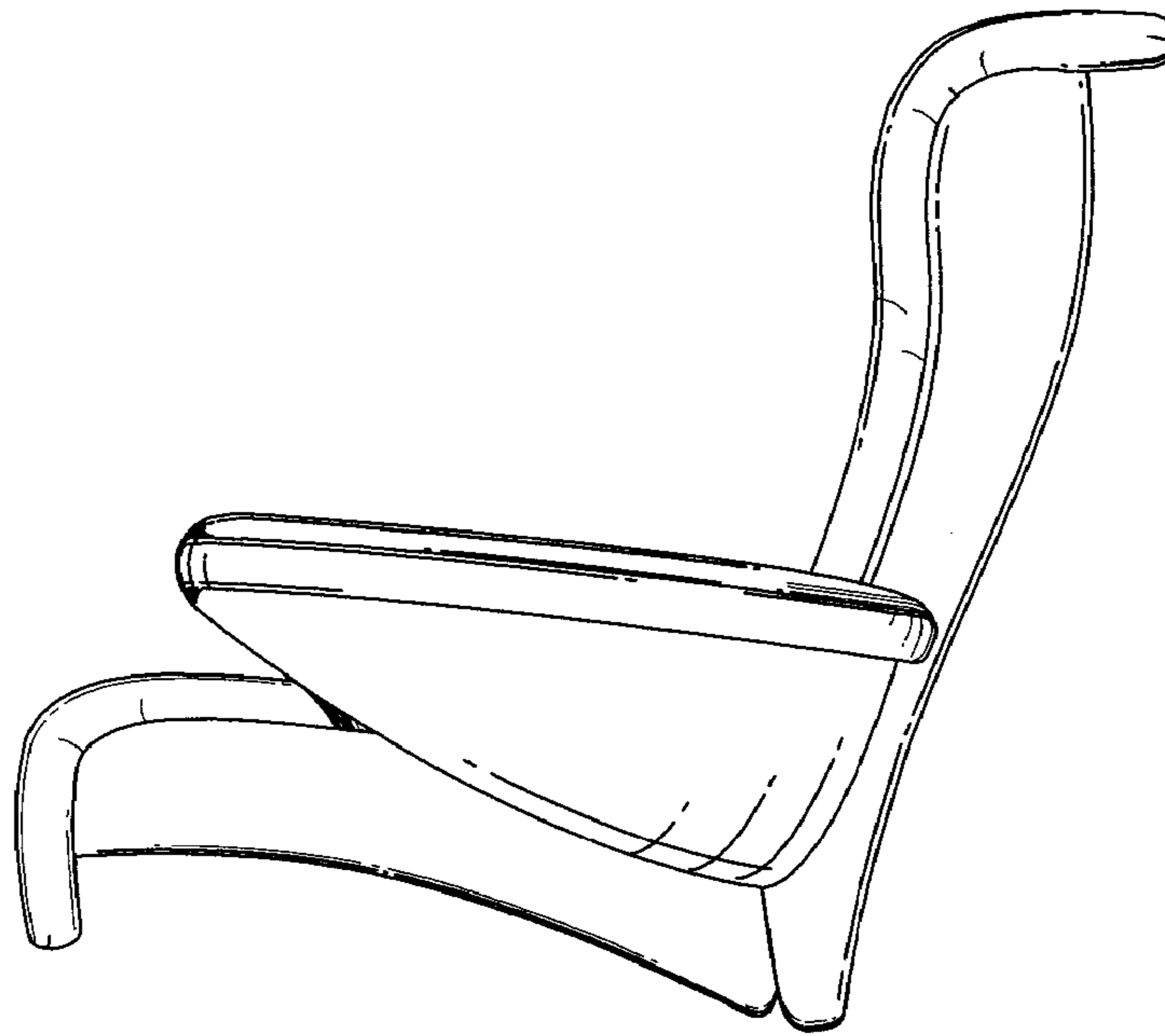

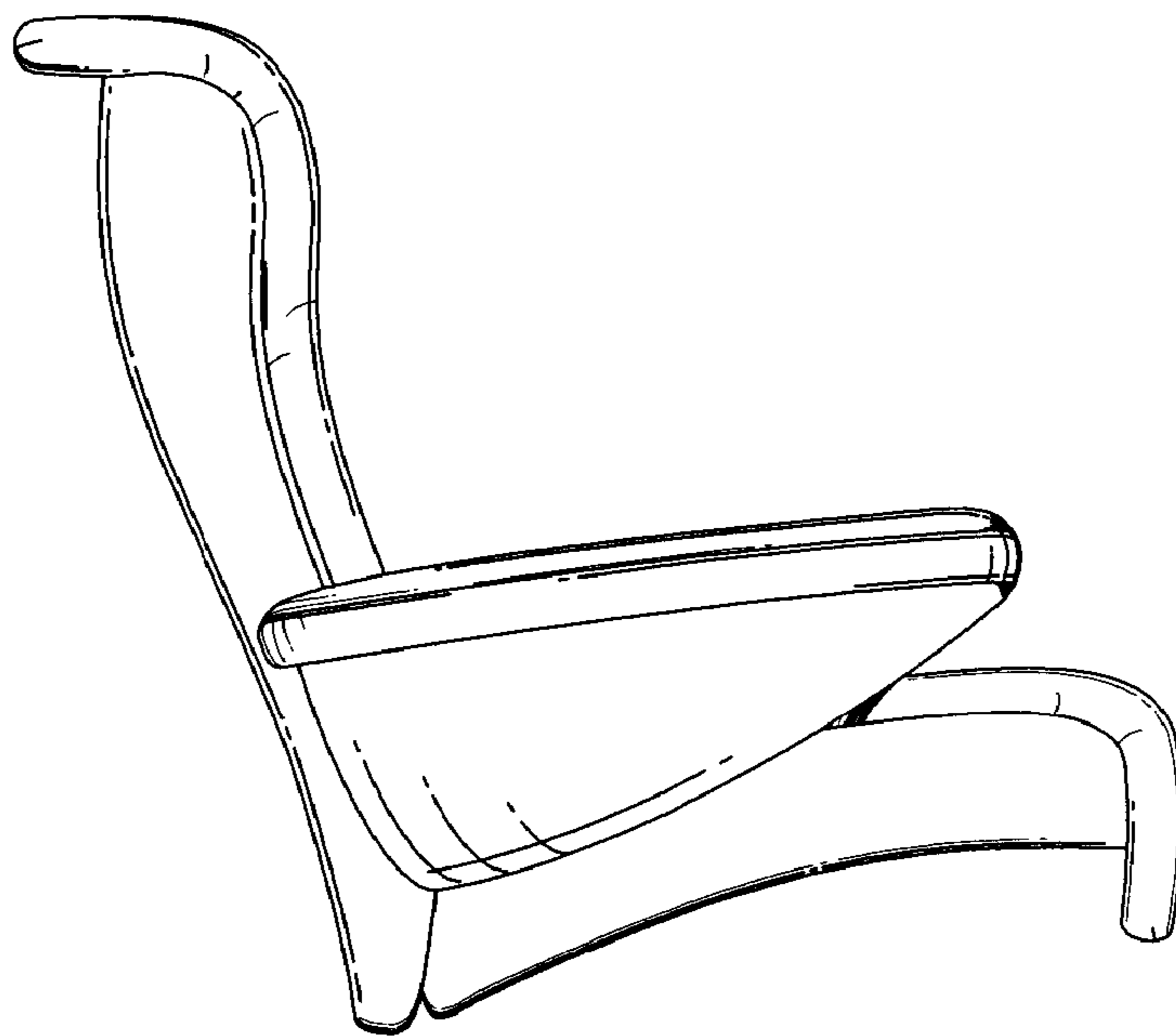

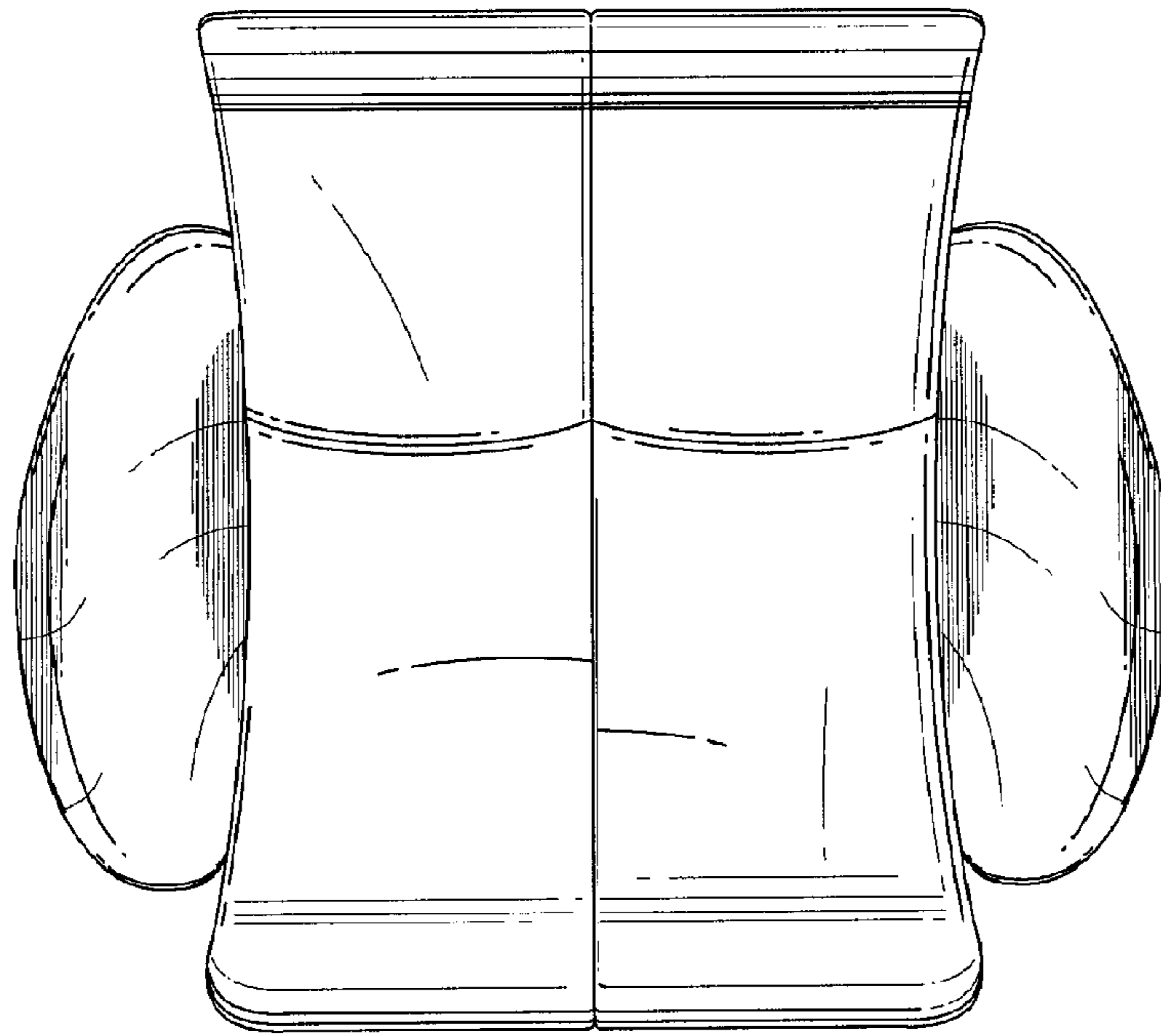

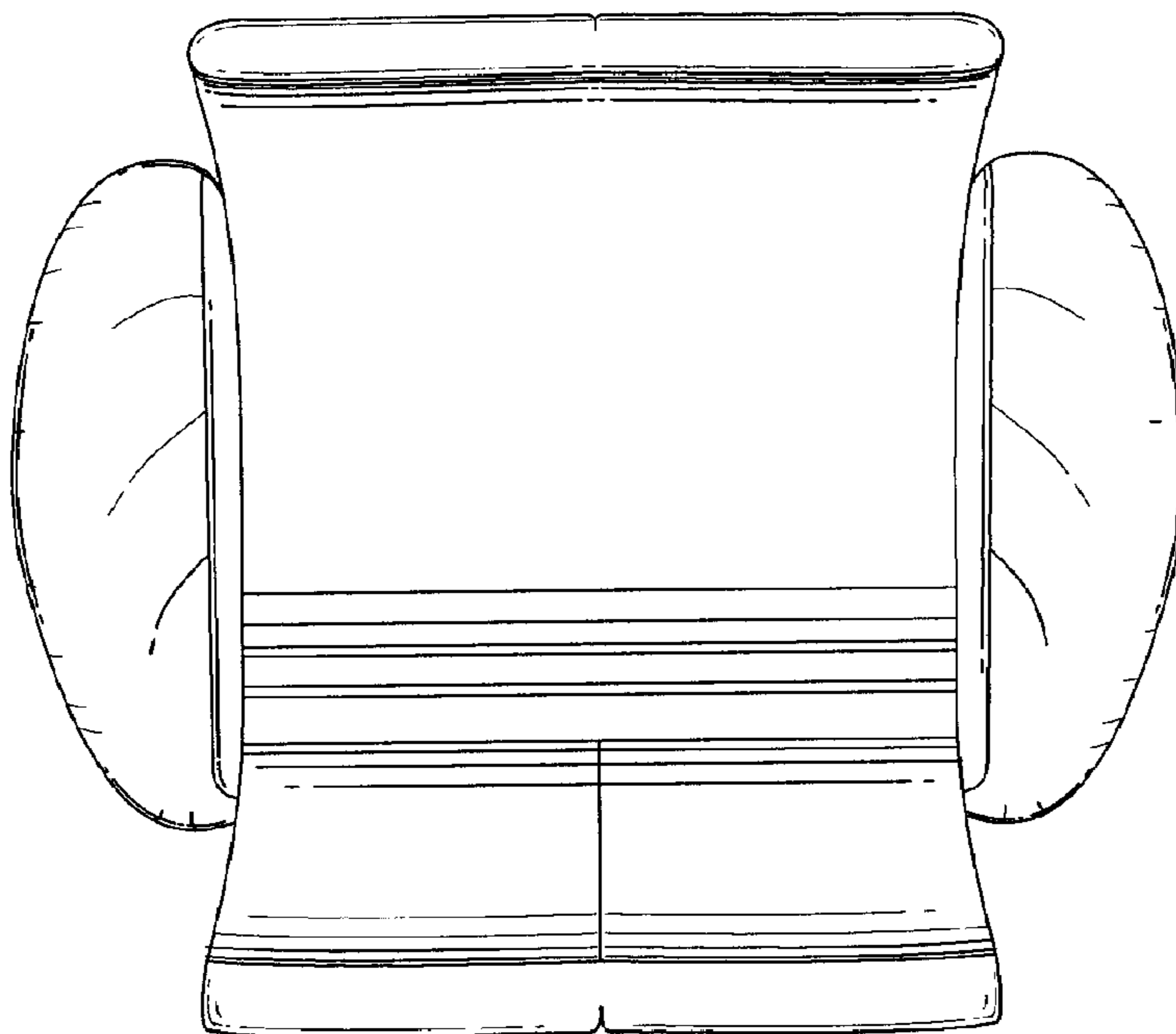
