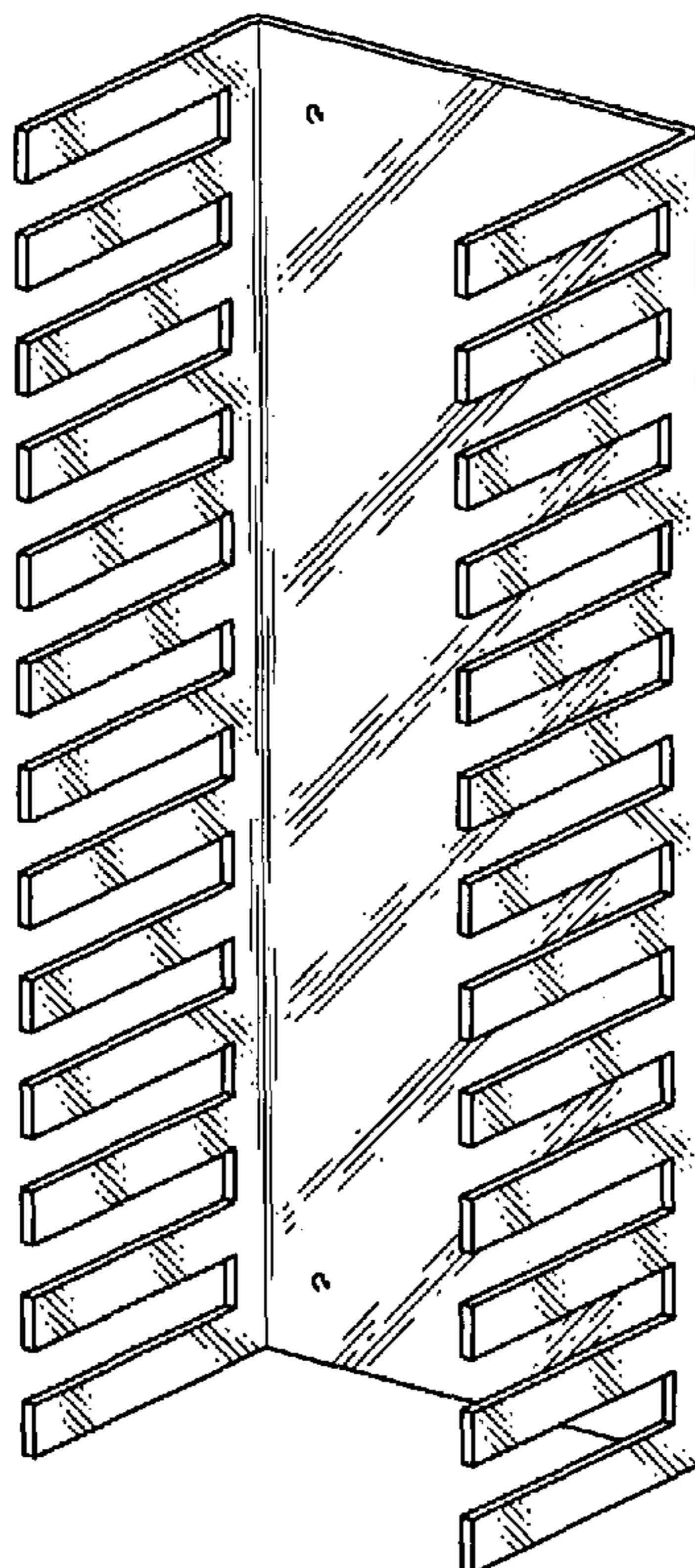
(57) **CLAIM**

The ornamental design for a tray support, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the tray support;  
 FIG. 2 is a front elevation view of the invention;  
 FIG. 3 is a right side view of the invention, the left side view being a mirror image;  
 FIG. 4 is a rear elevation view of the invention;  
 FIG. 5 is a top plan view of the invention, the bottom plan view being a mirror image; and,  
 FIG. 6 is a perspective view of the invention in use mounted to a wall with trays supported therefrom.  
 The broken lines in FIG. 6 are for purposes of illustration only and form no part of the claimed design.

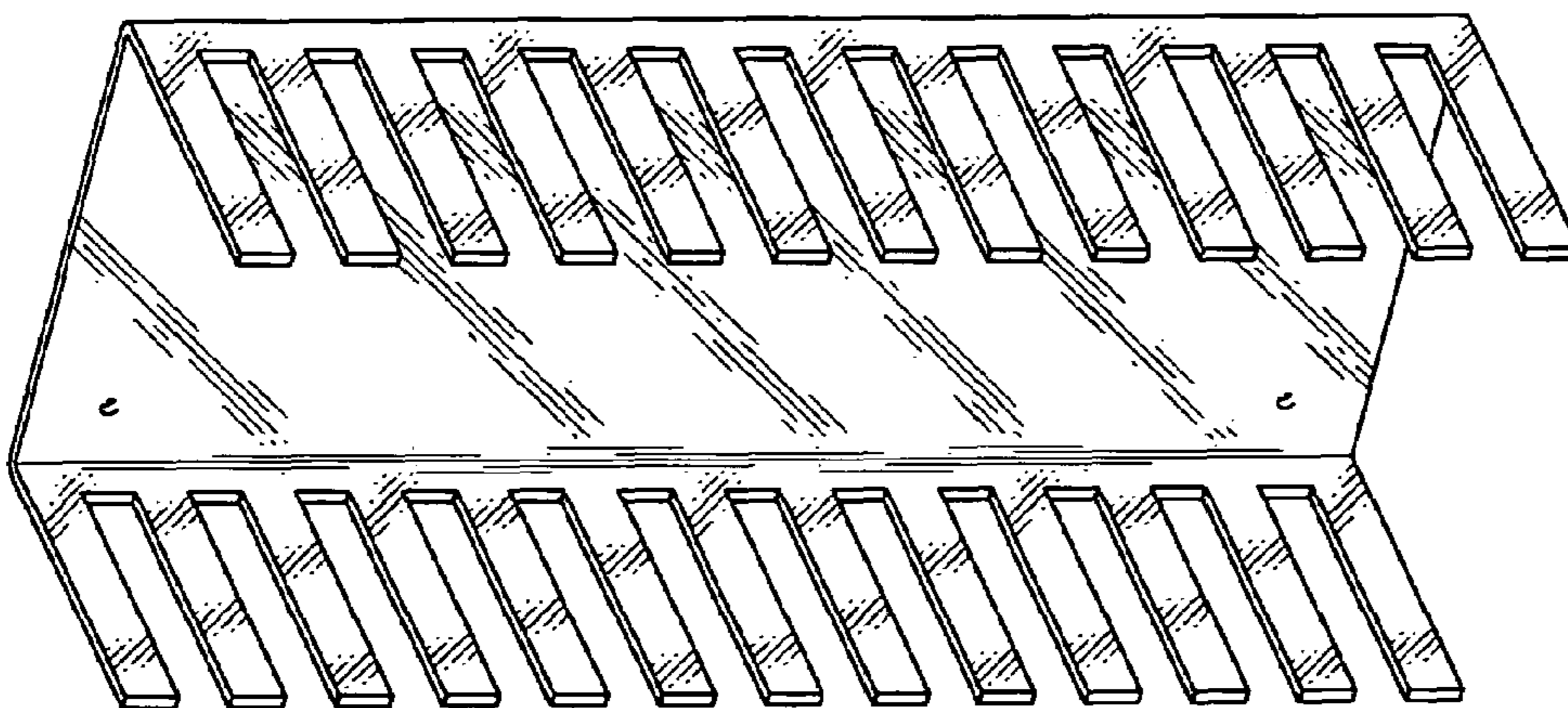

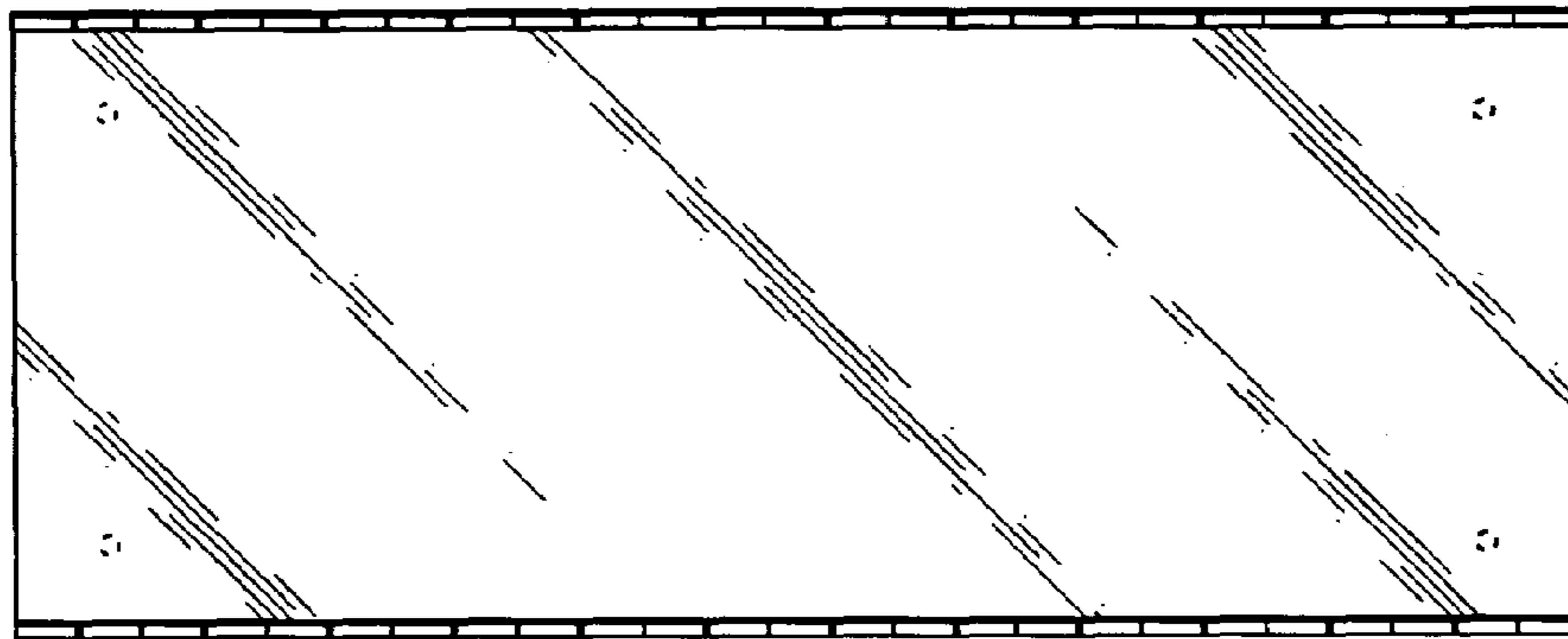

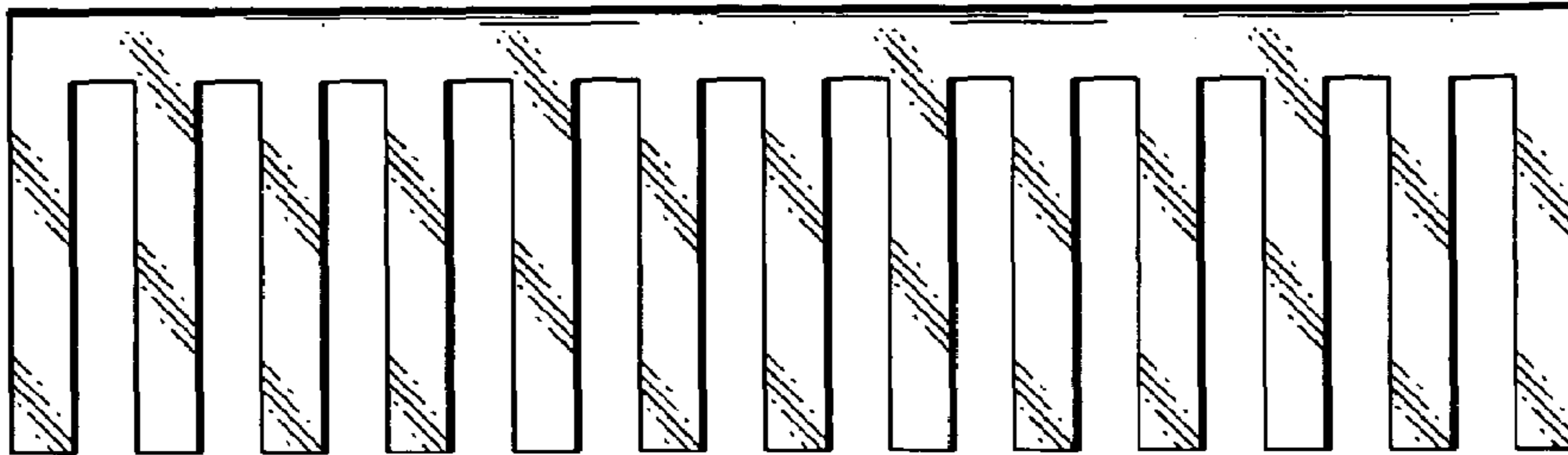

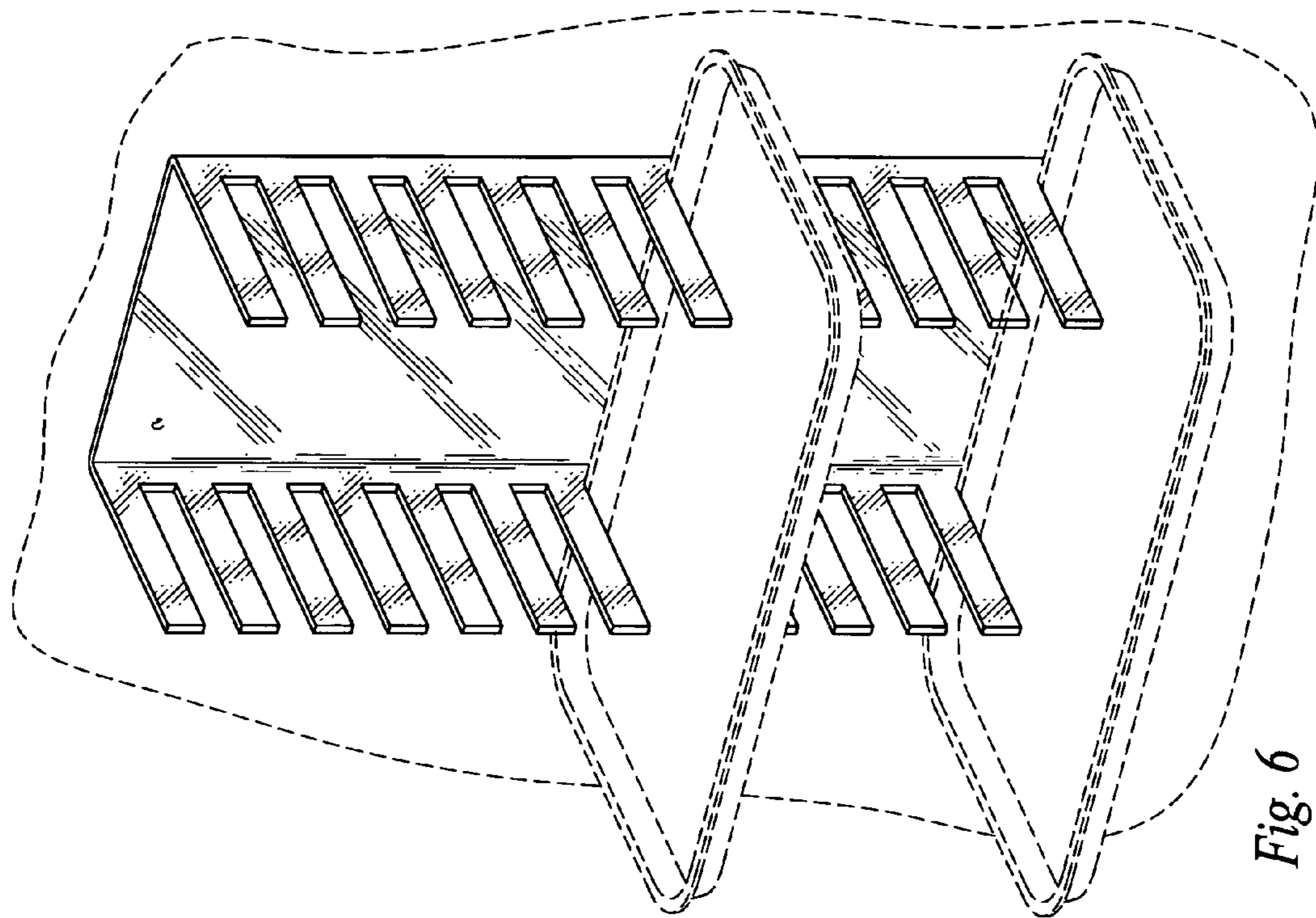

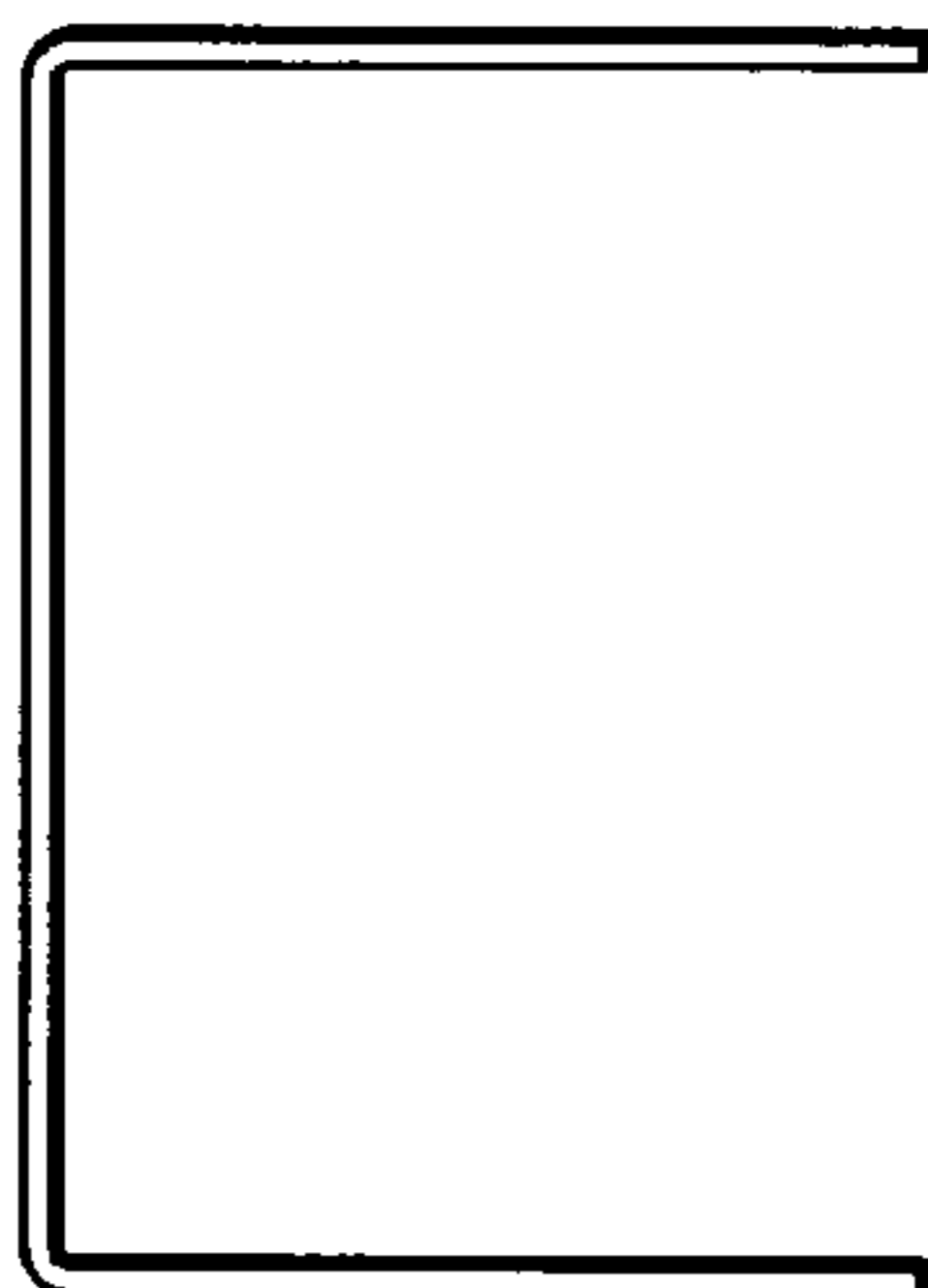

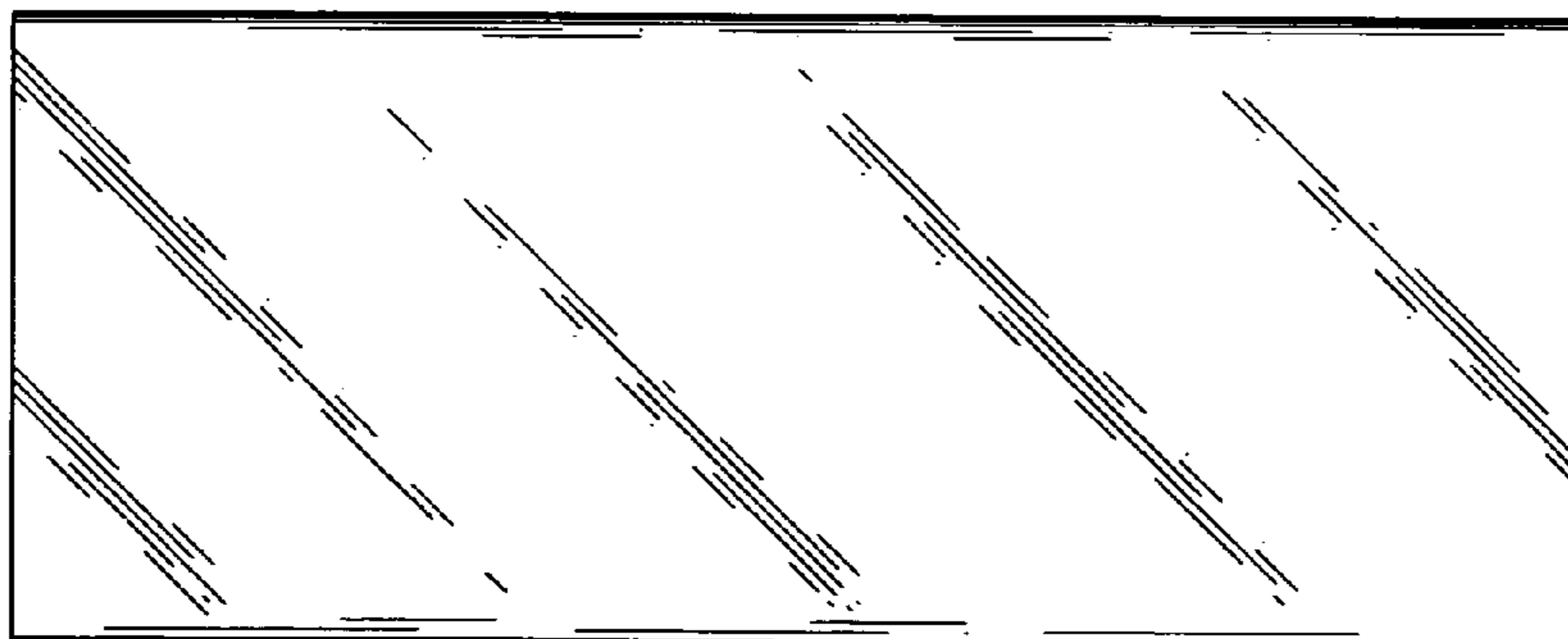
