(57) **CLAIM**

The ornamental design for a claw-shaped bottle opener, substantially as shown.

**DESCRIPTION**

FIG. 1 is a front view of a claw-shaped bottle opener in accordance with the present invention, the rear view being a mirror image thereof;

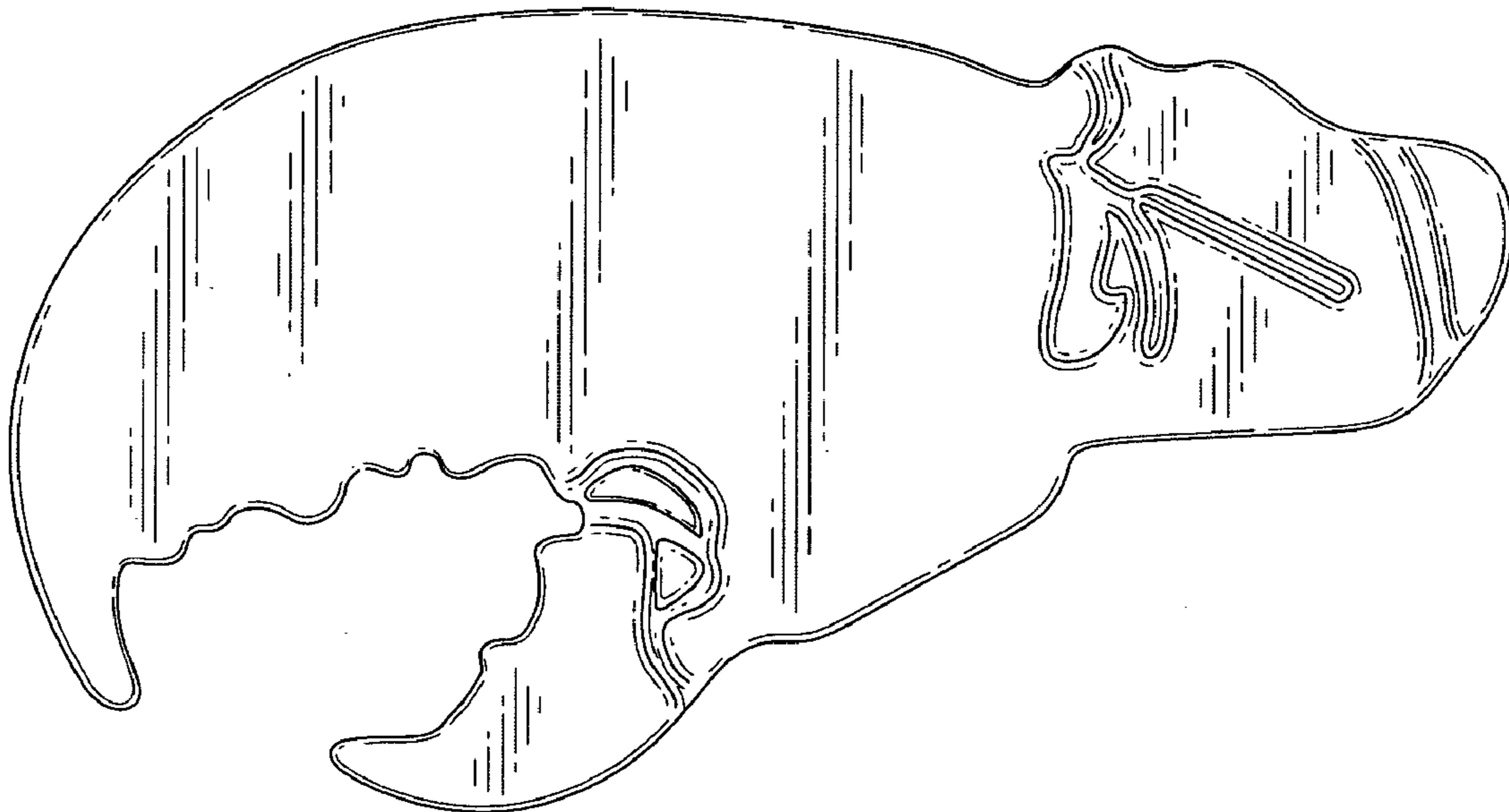
FIG. 2 is a top view of the claw-shaped bottle opener shown in FIG. 1;

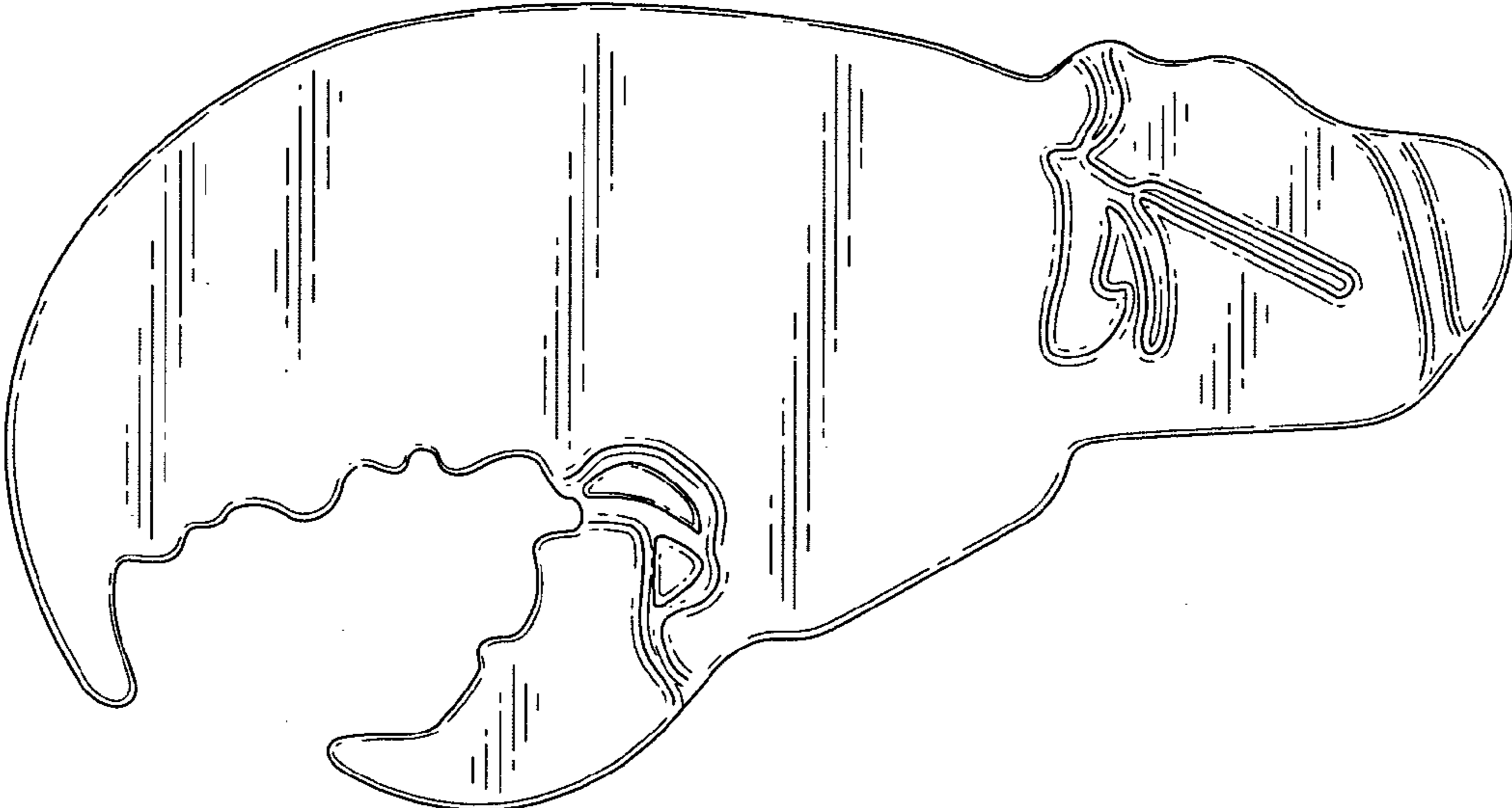
FIG. 3 is a bottom view of the claw-shaped bottle opener shown in FIG. 1;

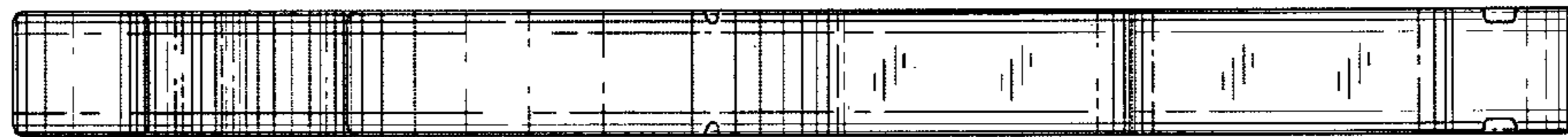
