FIG. 20 is another side view thereof;

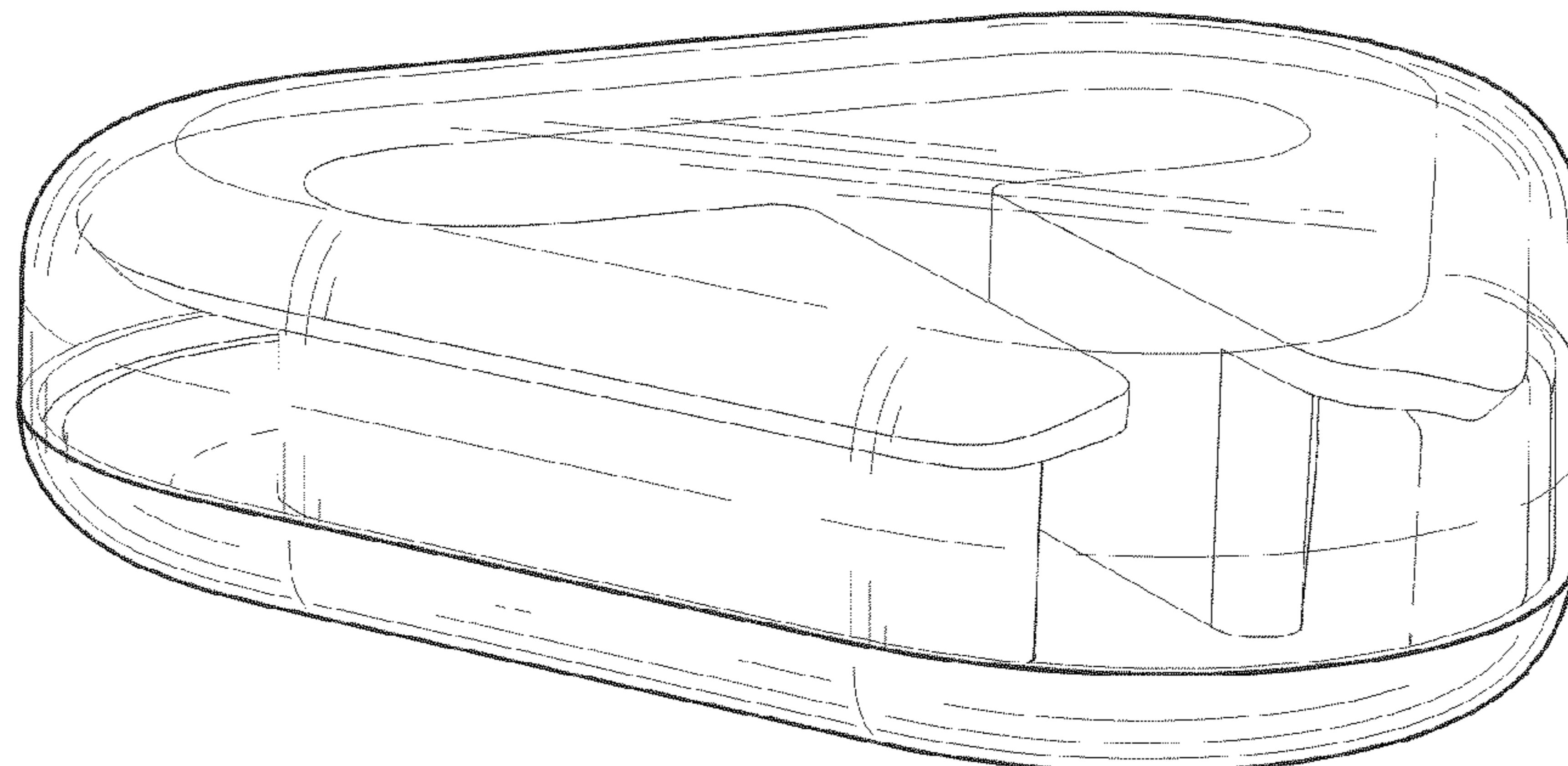
FIG. 21 is another side view thereof;

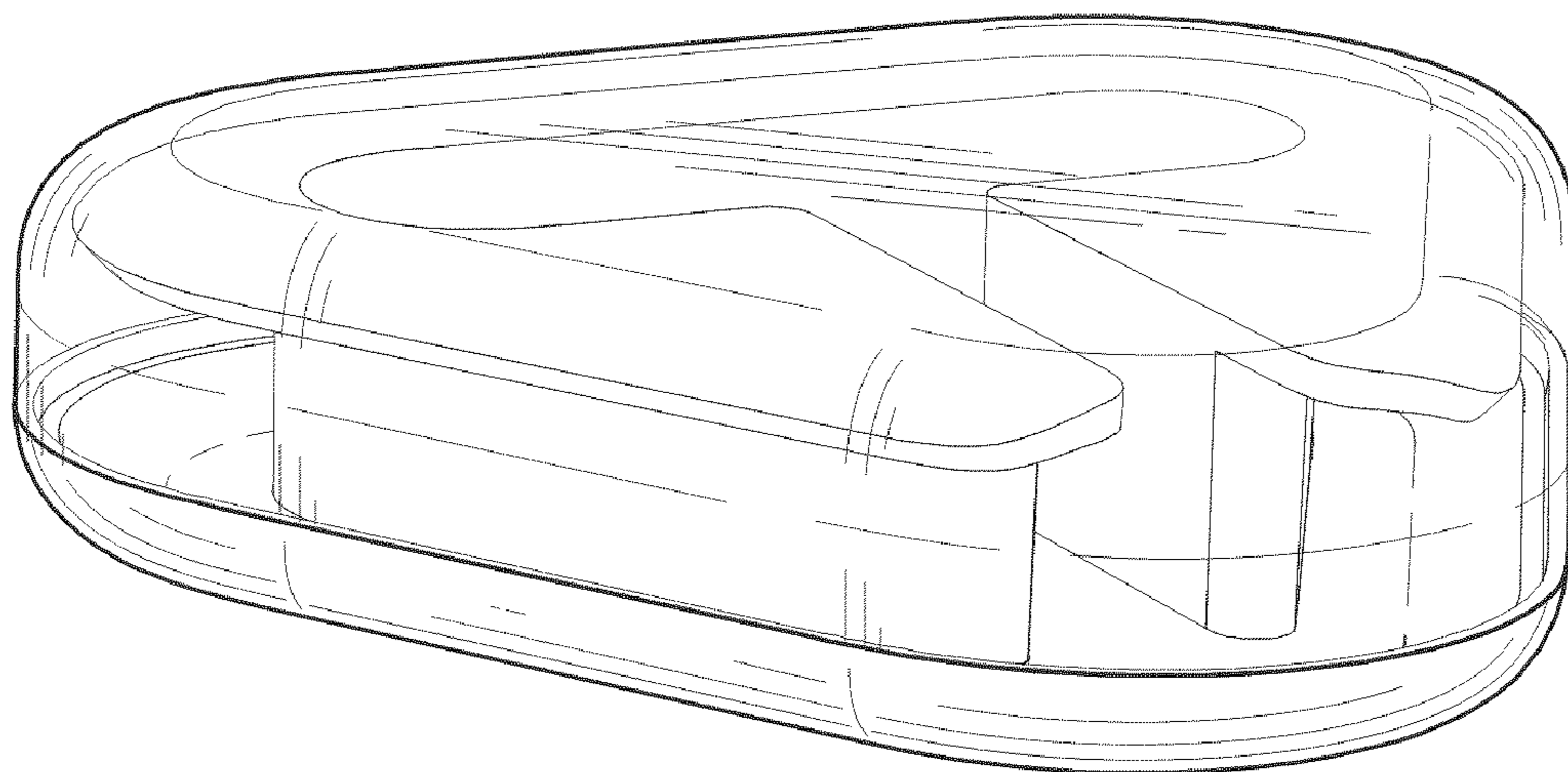

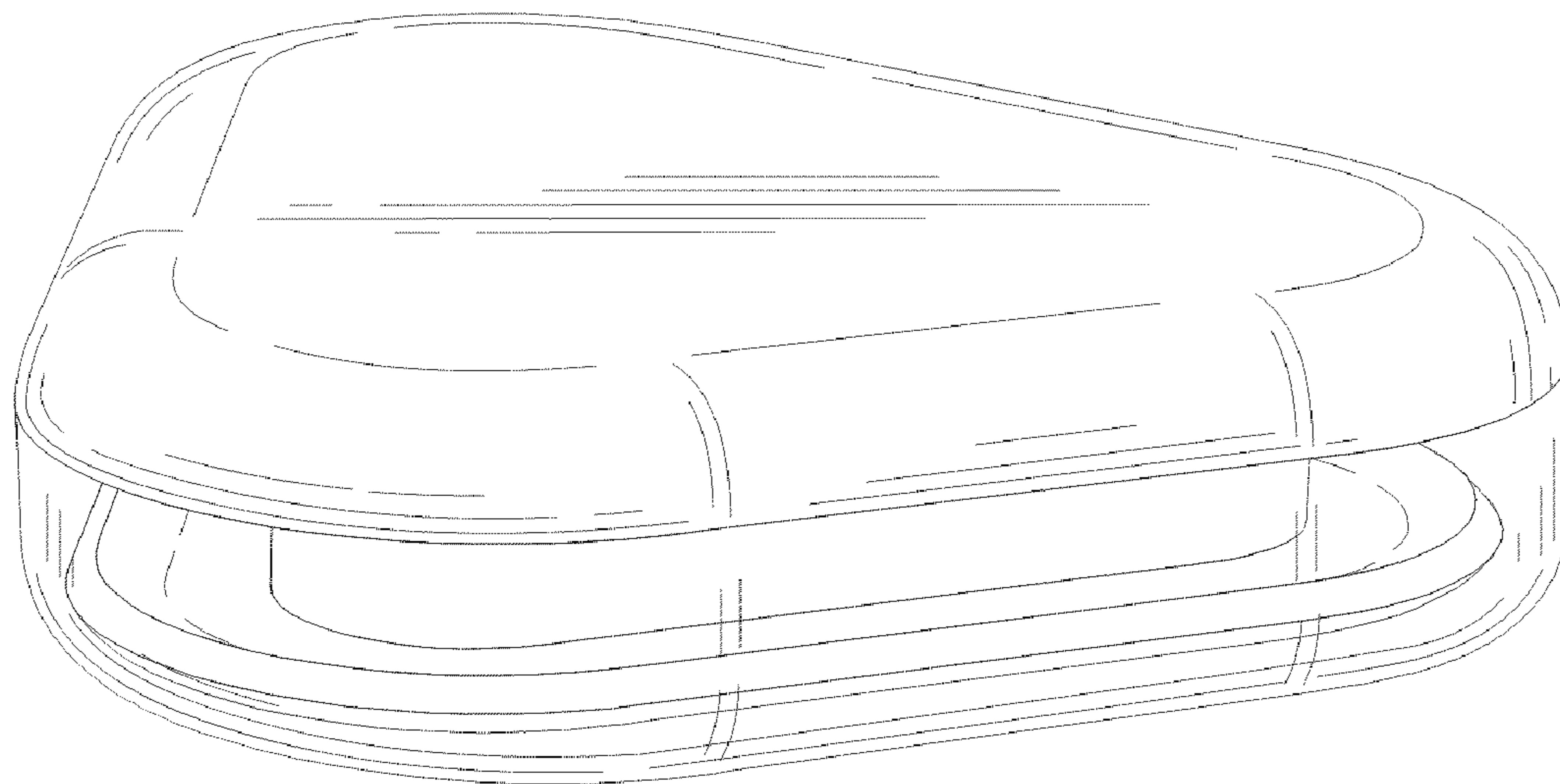

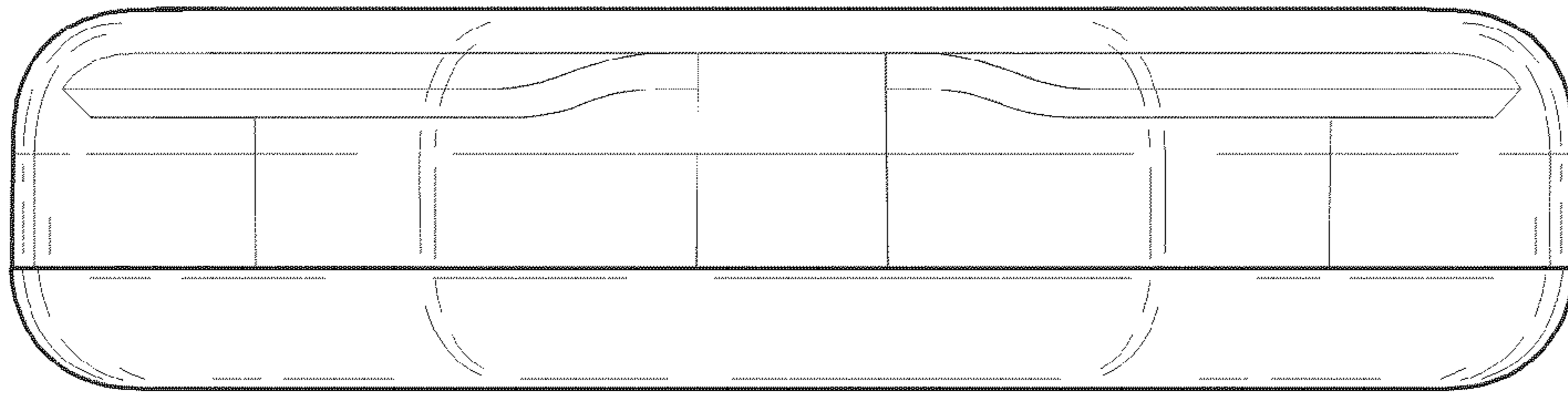

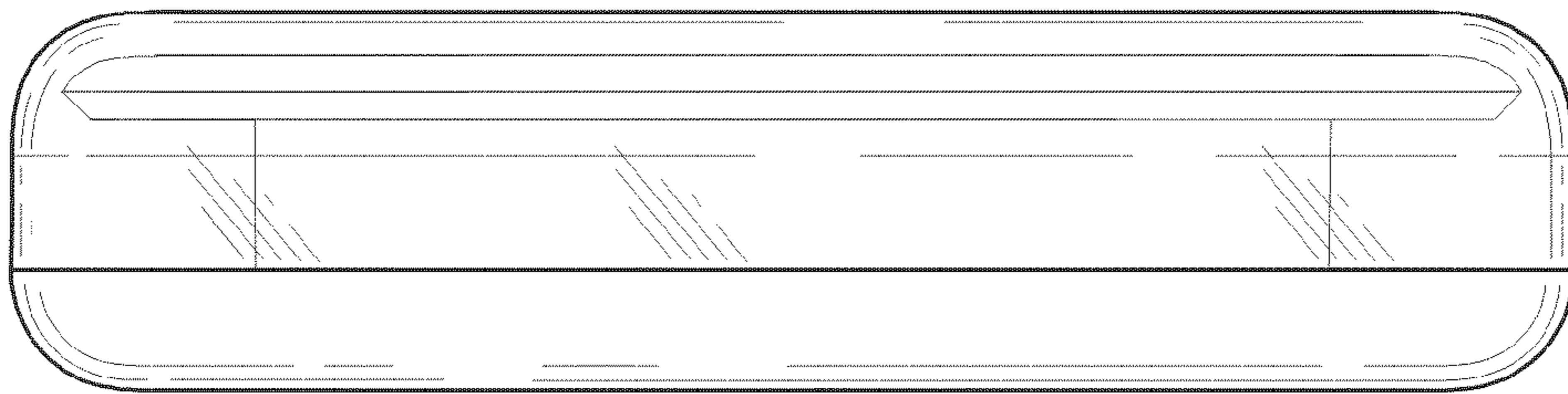

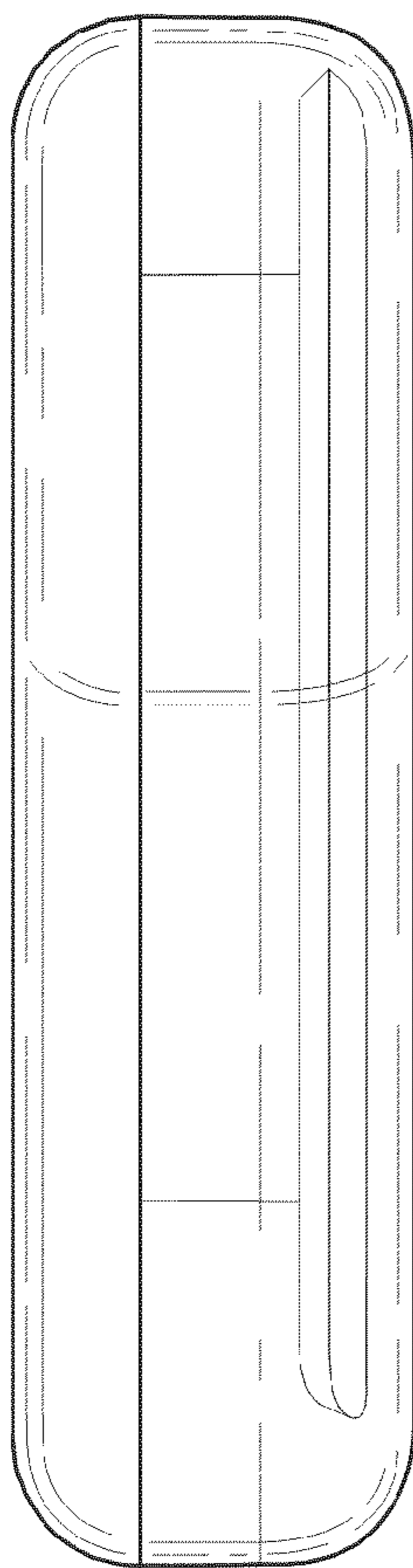

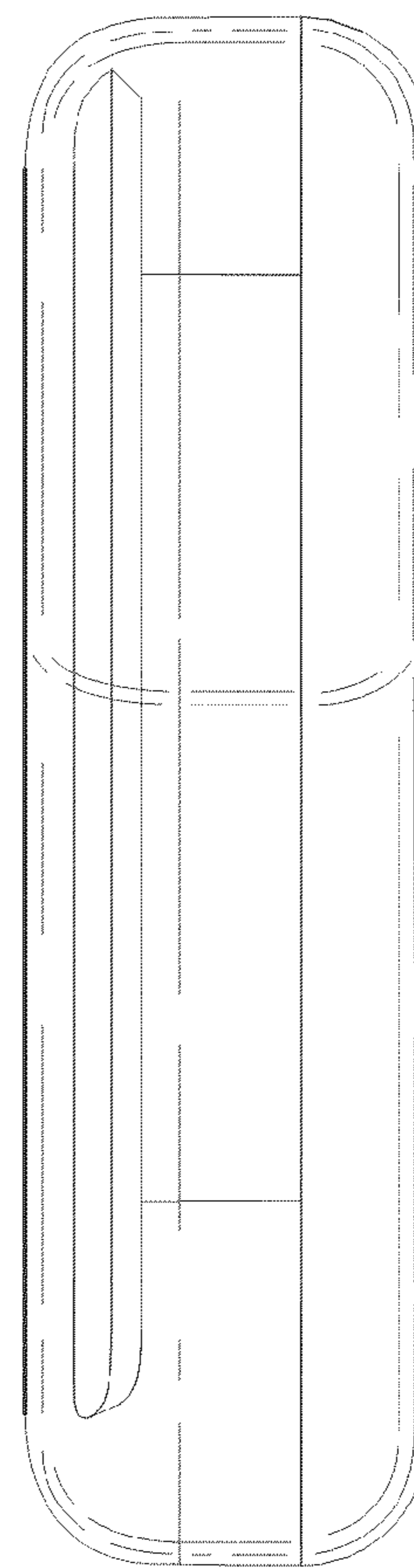

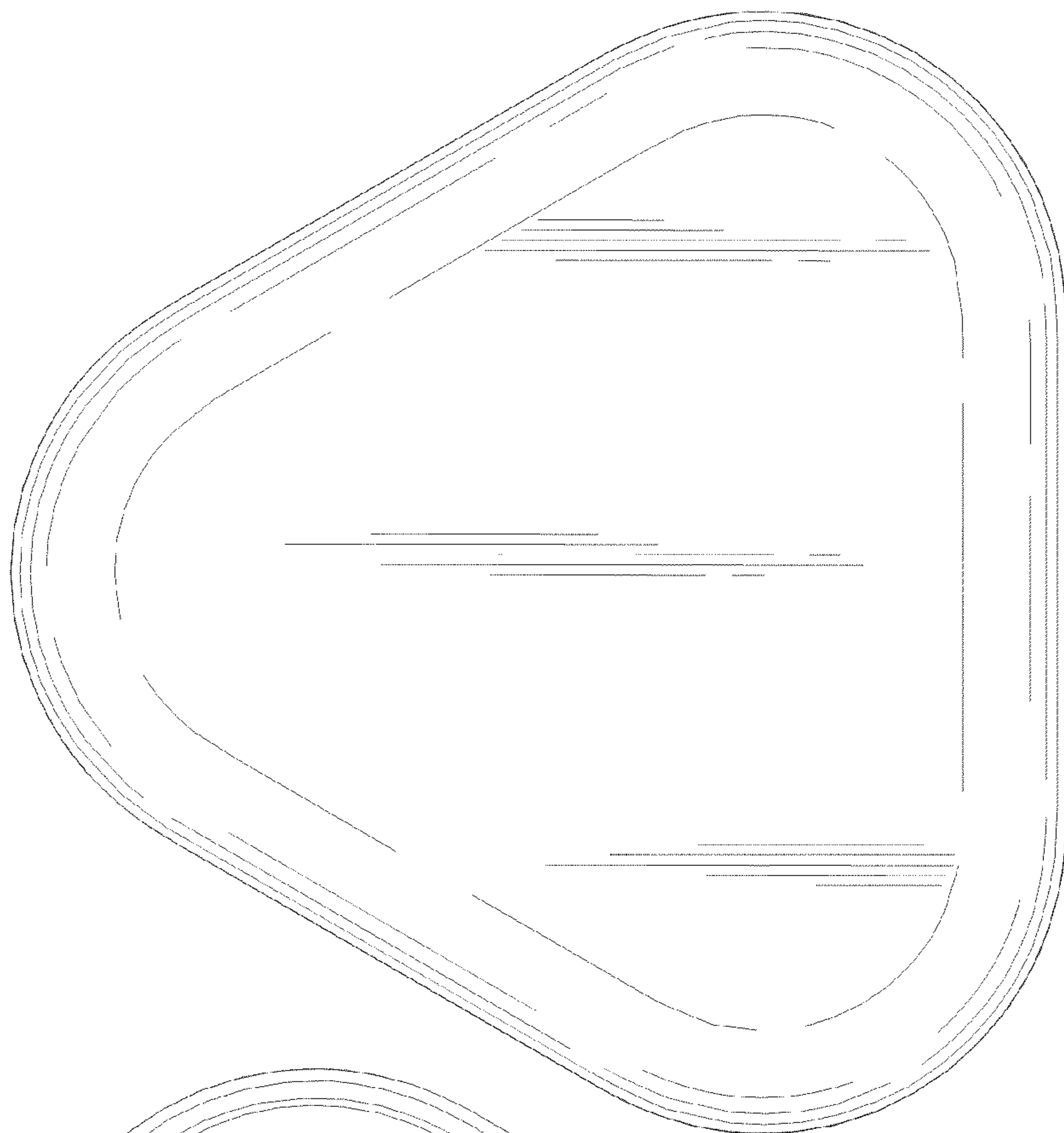

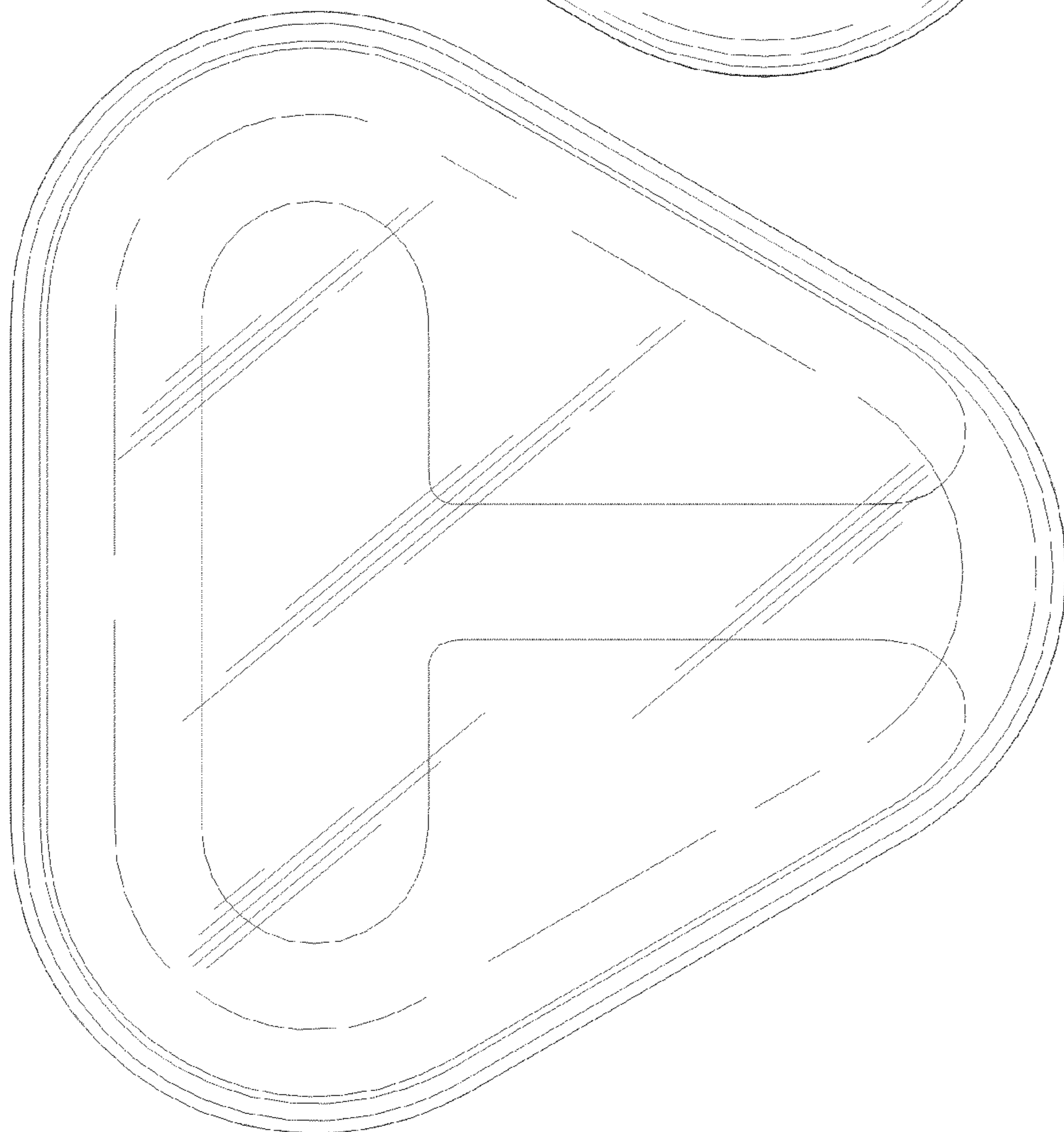

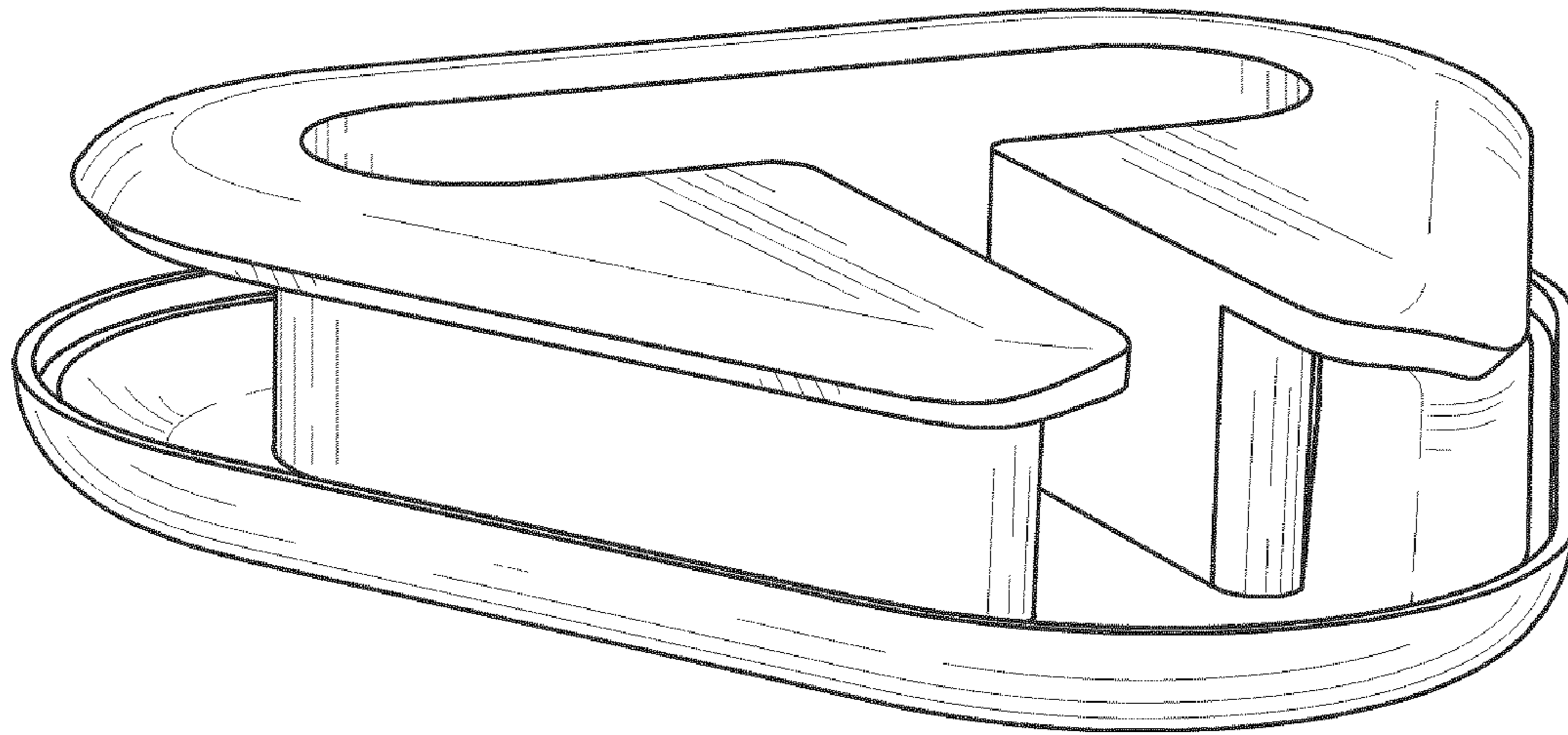

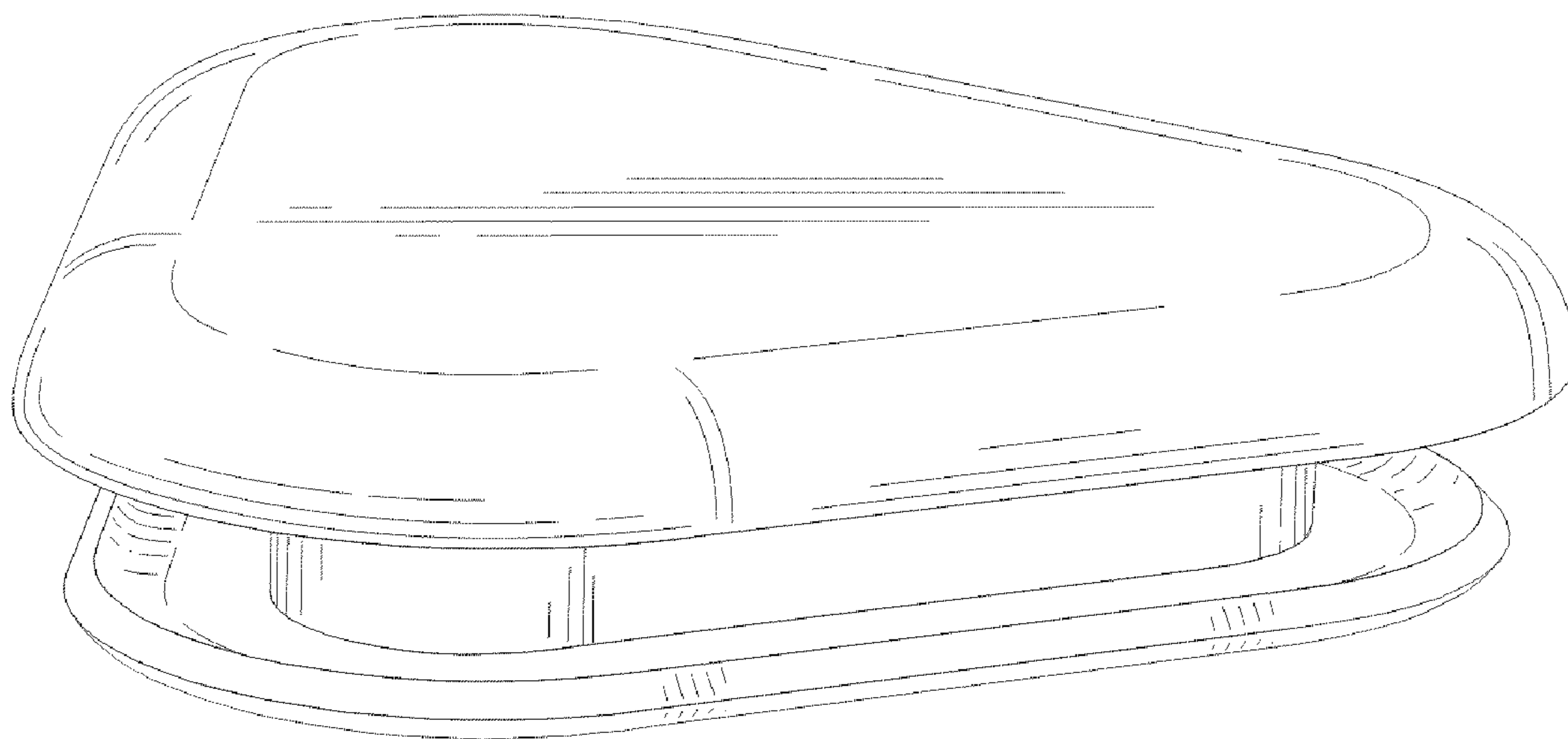

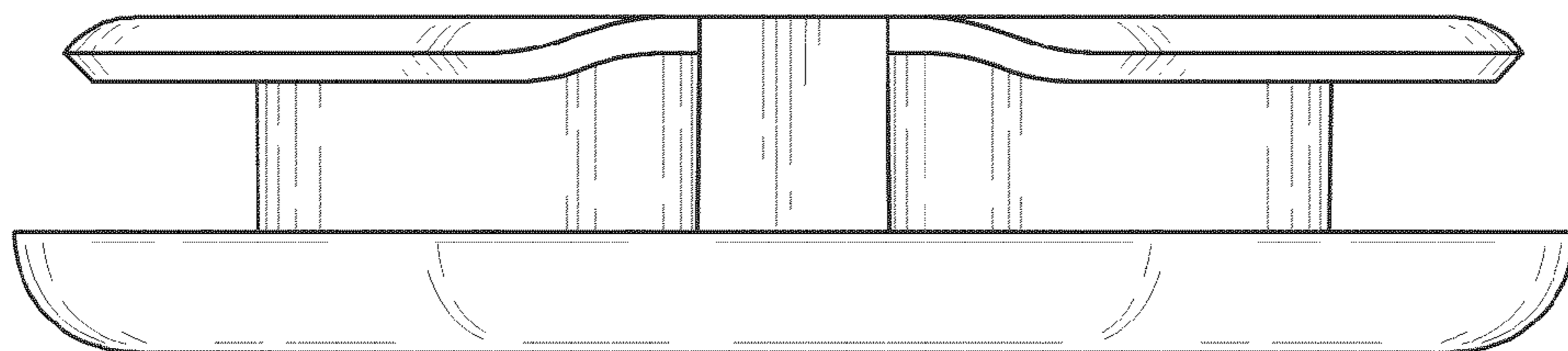

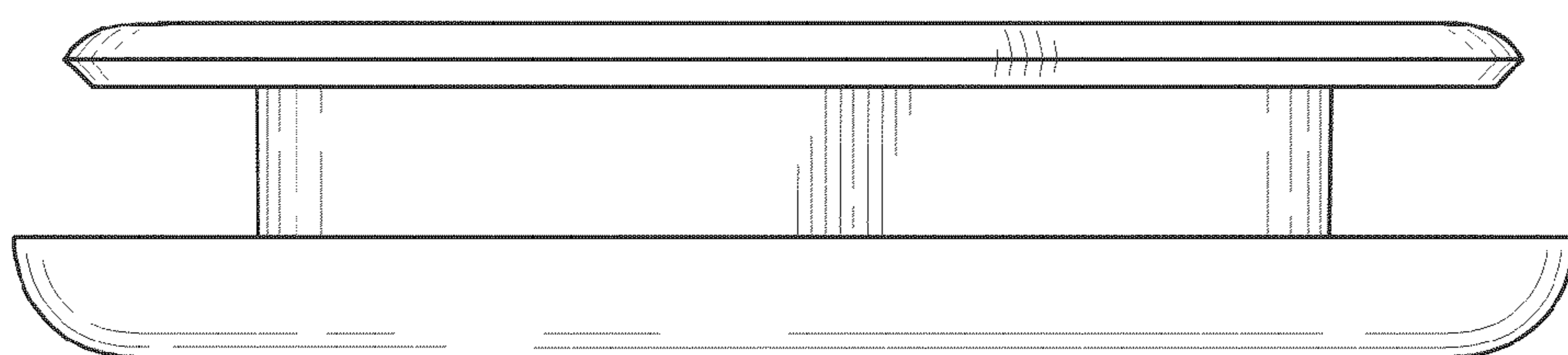

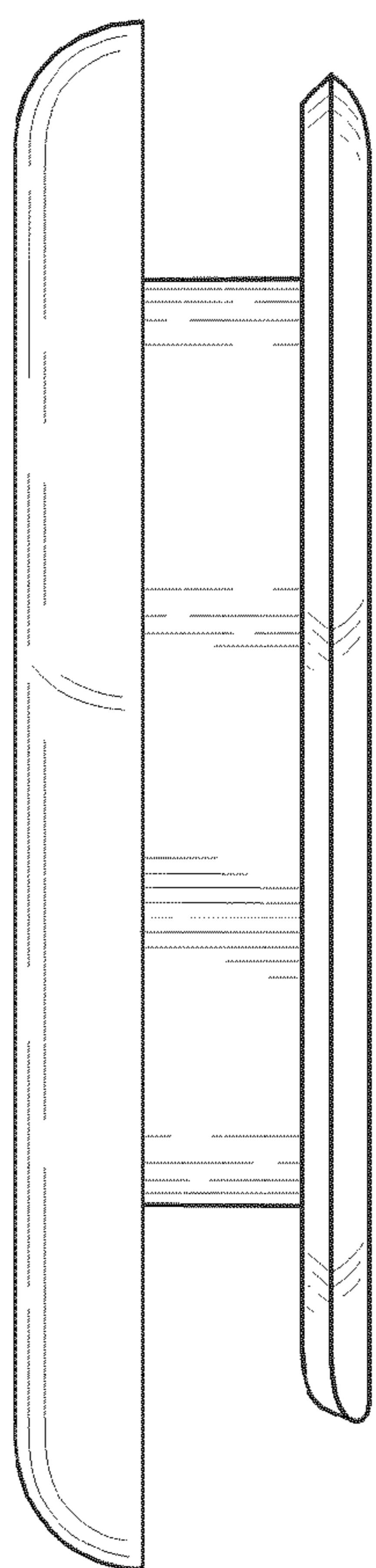

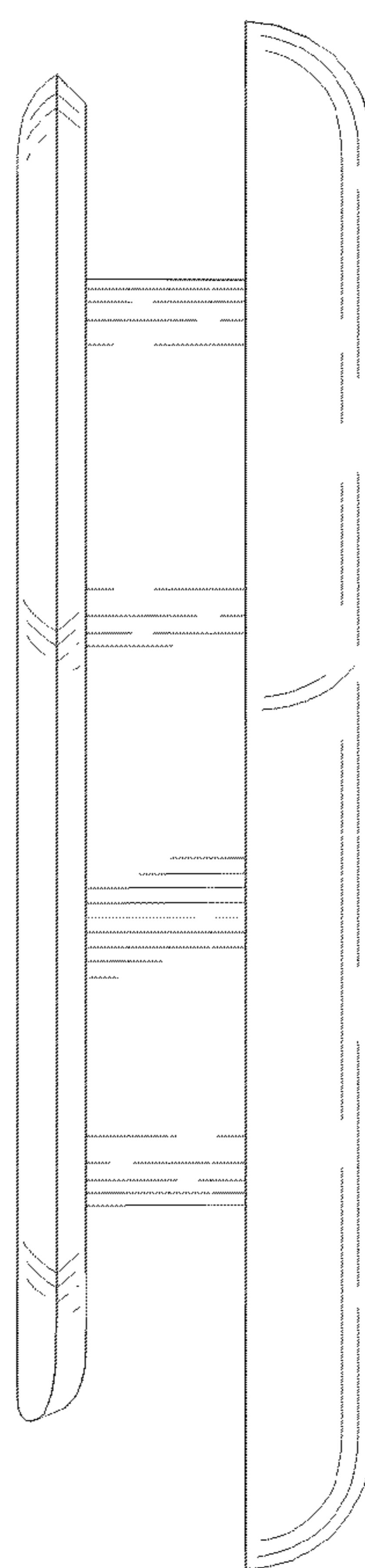

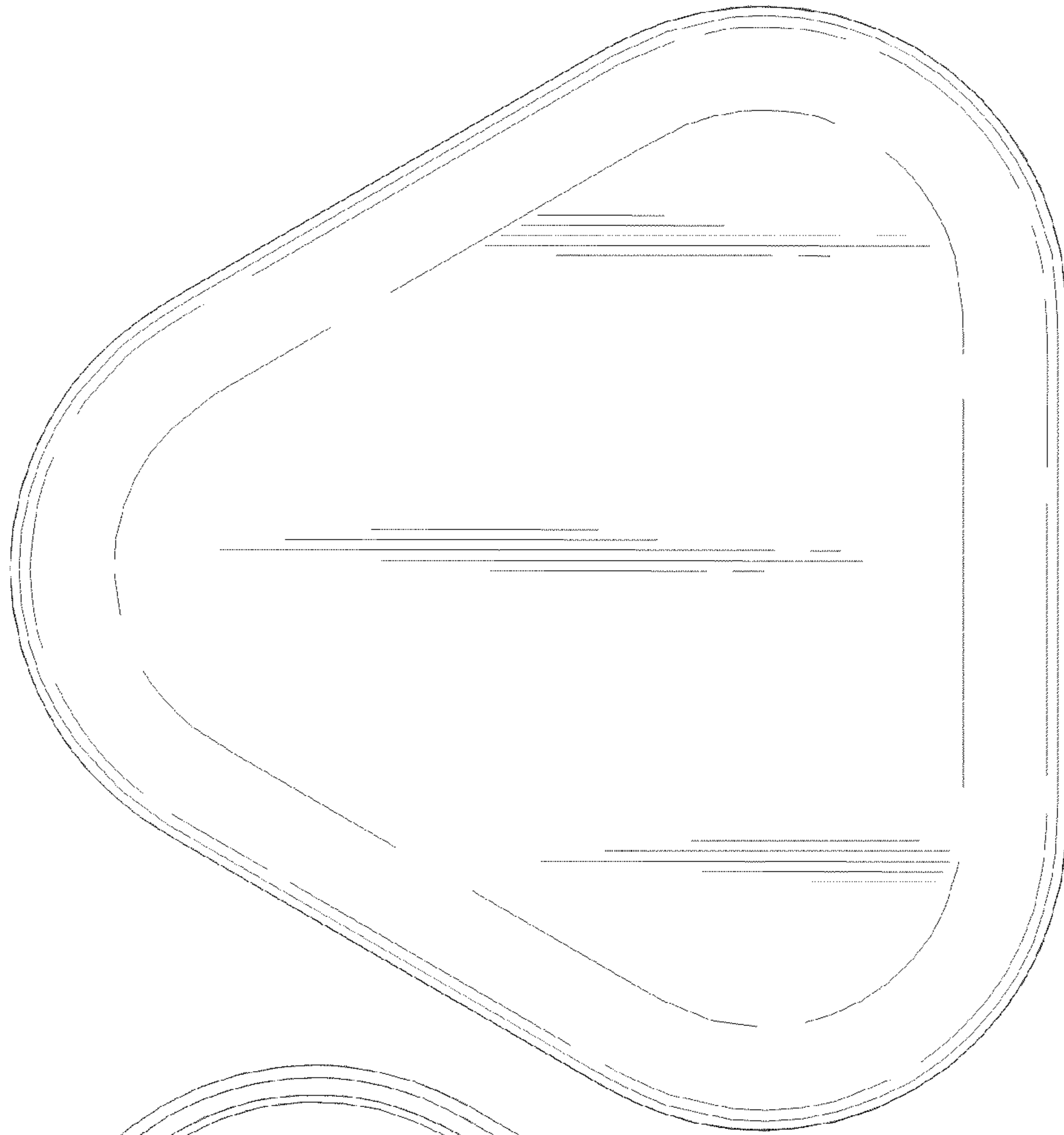

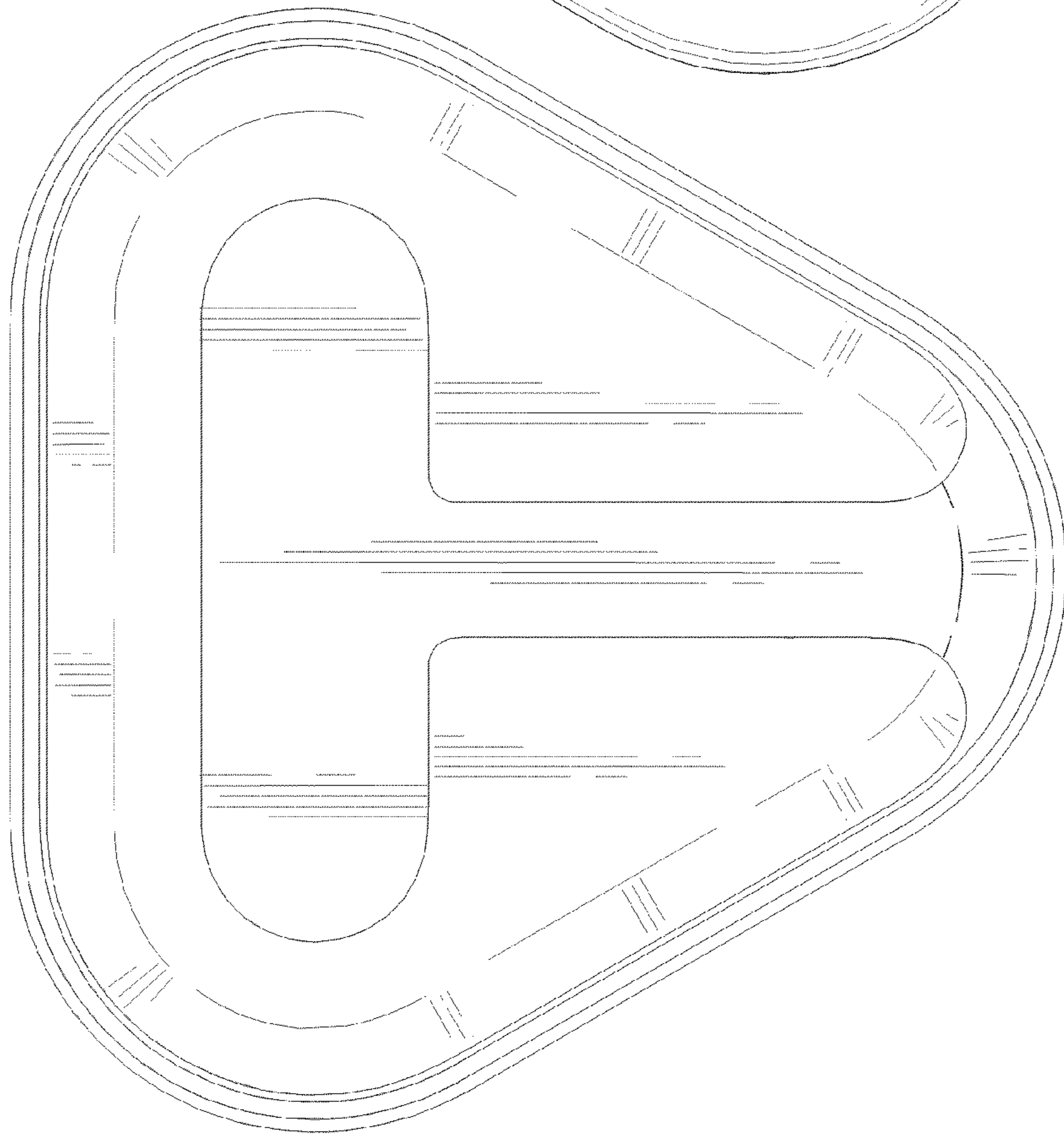

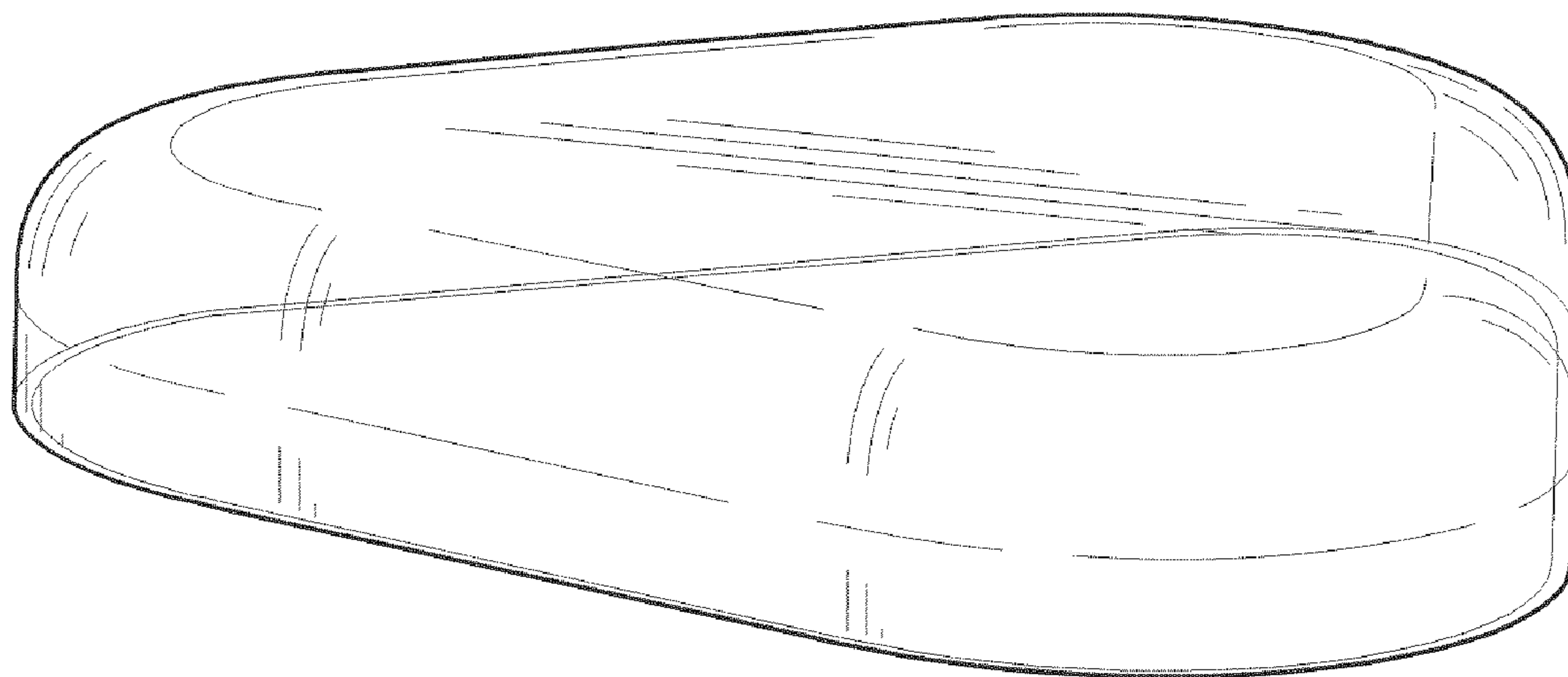

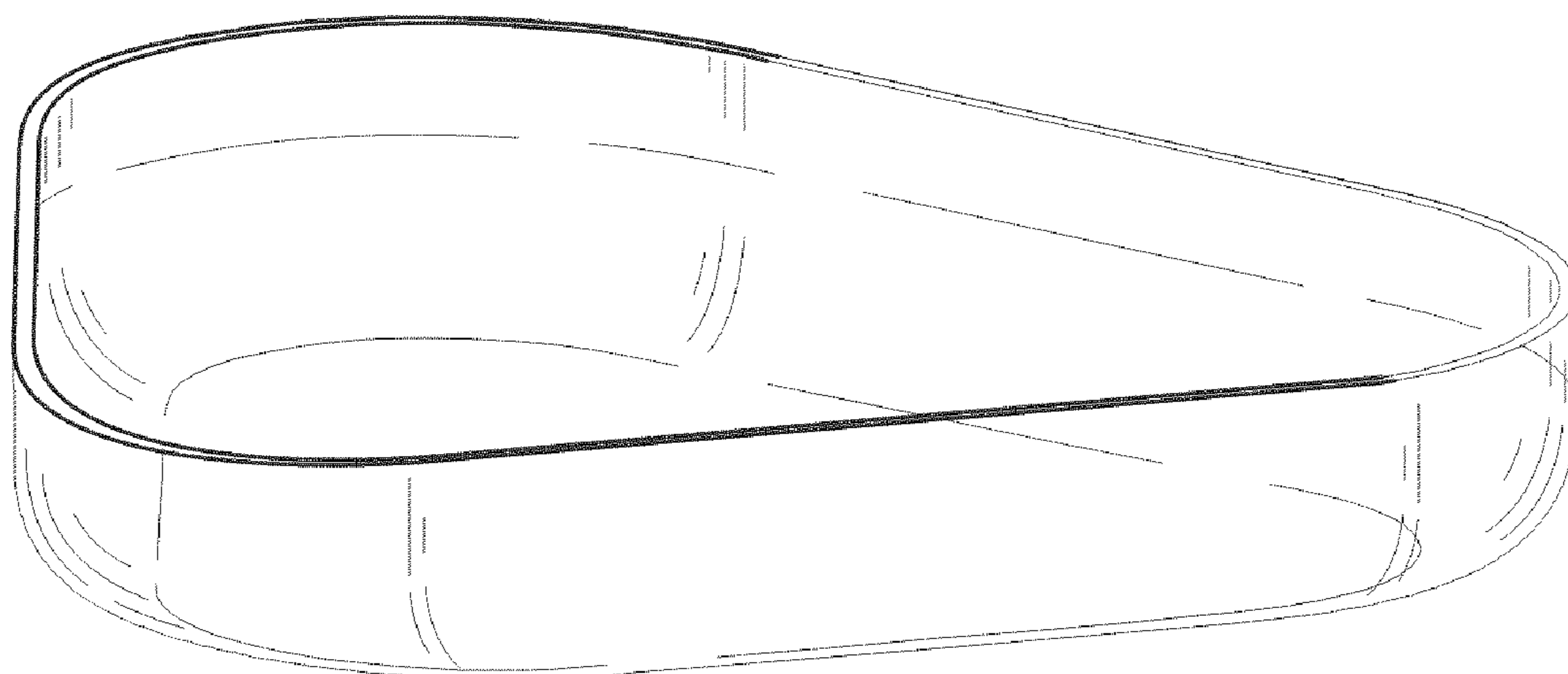

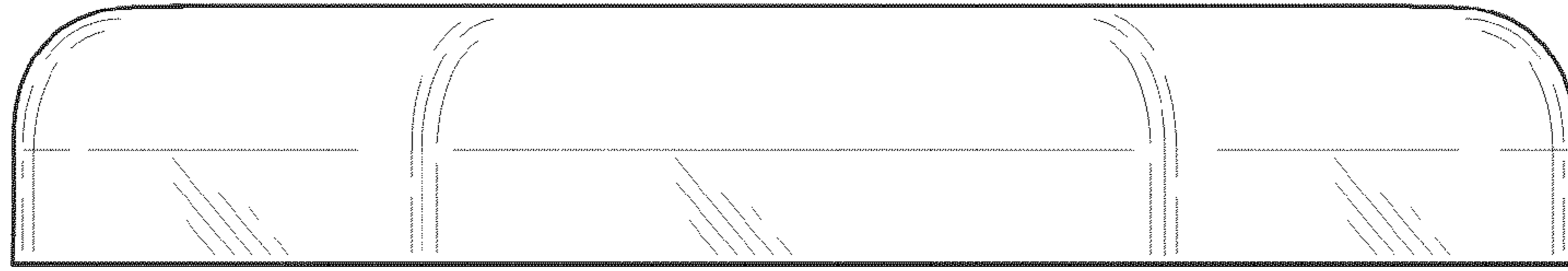

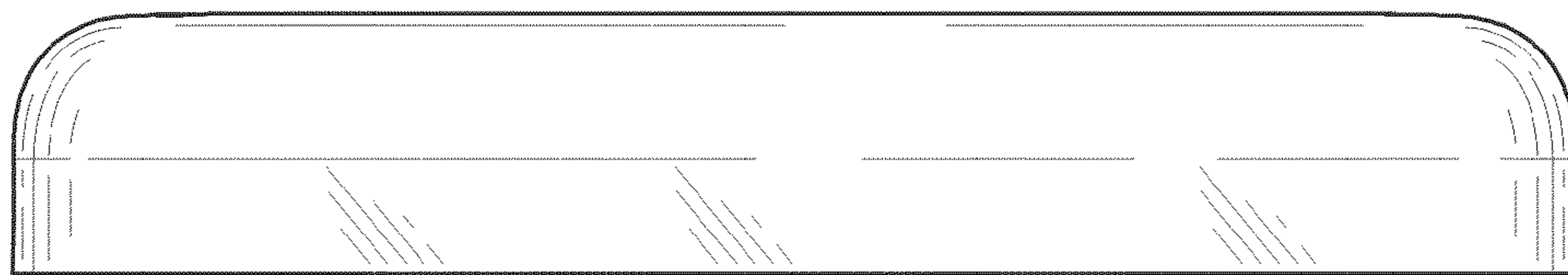

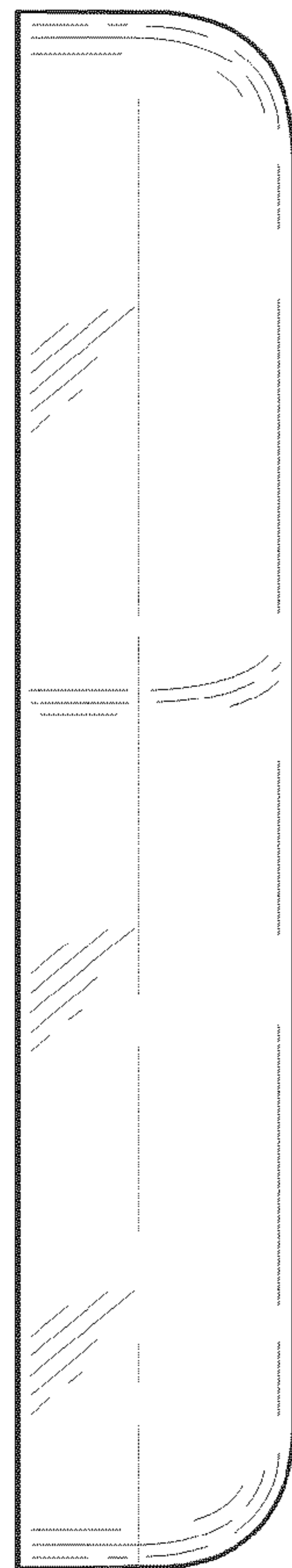

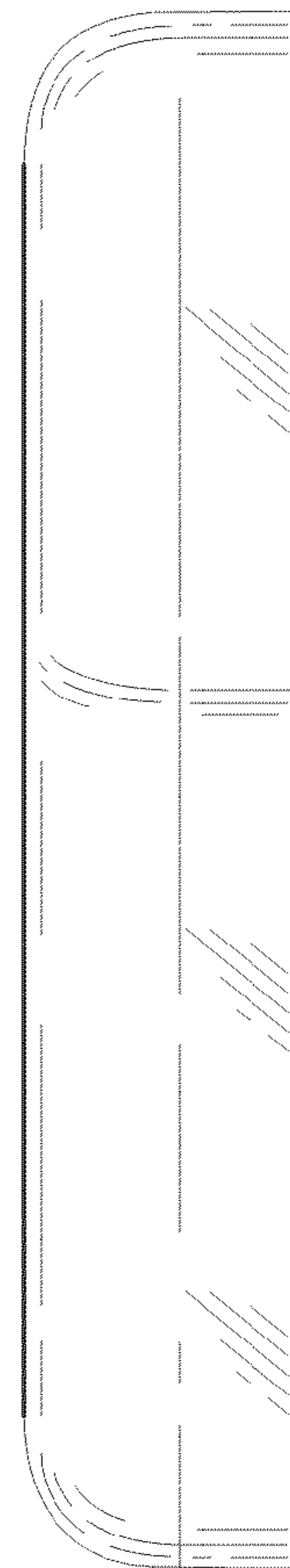

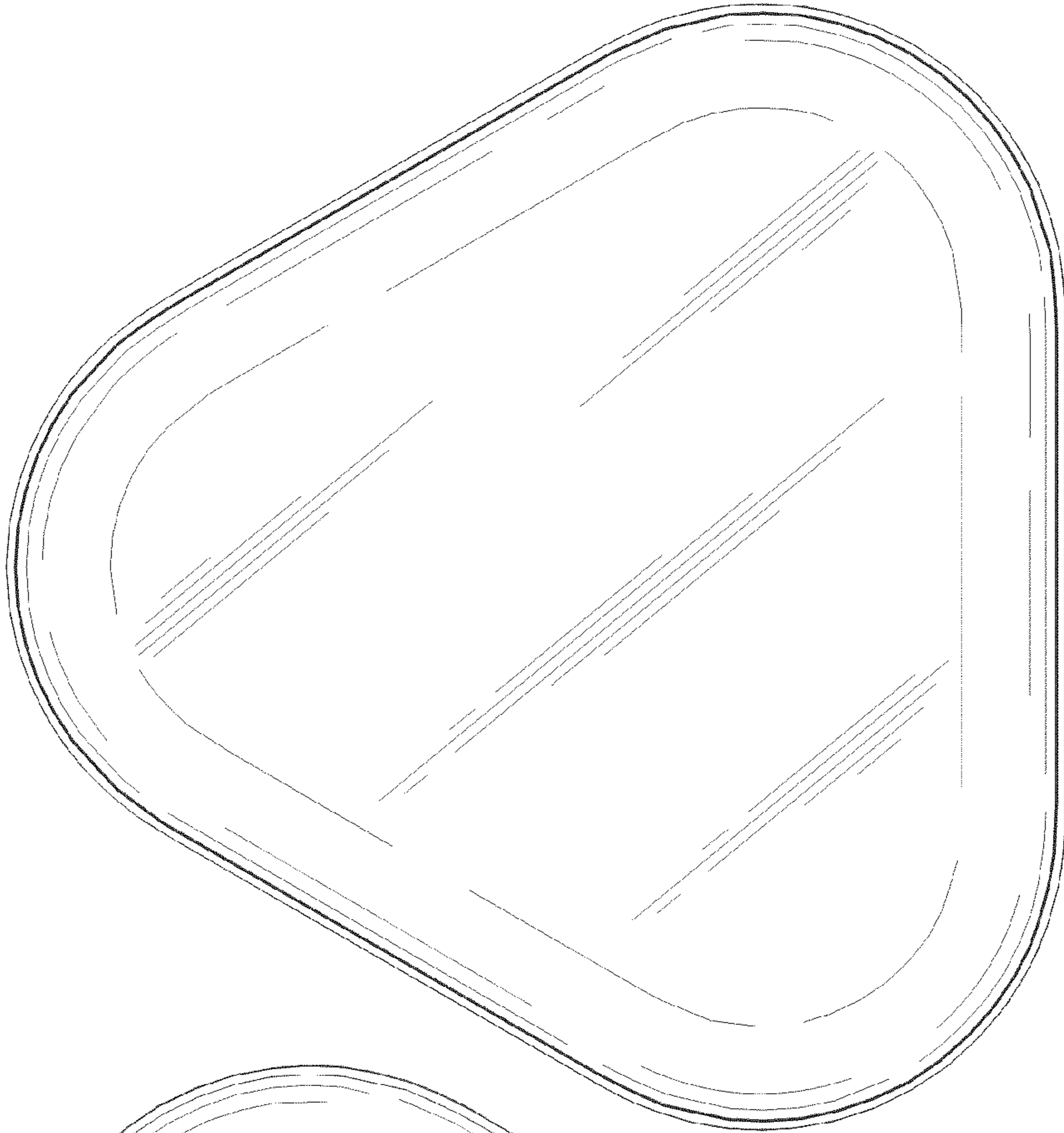

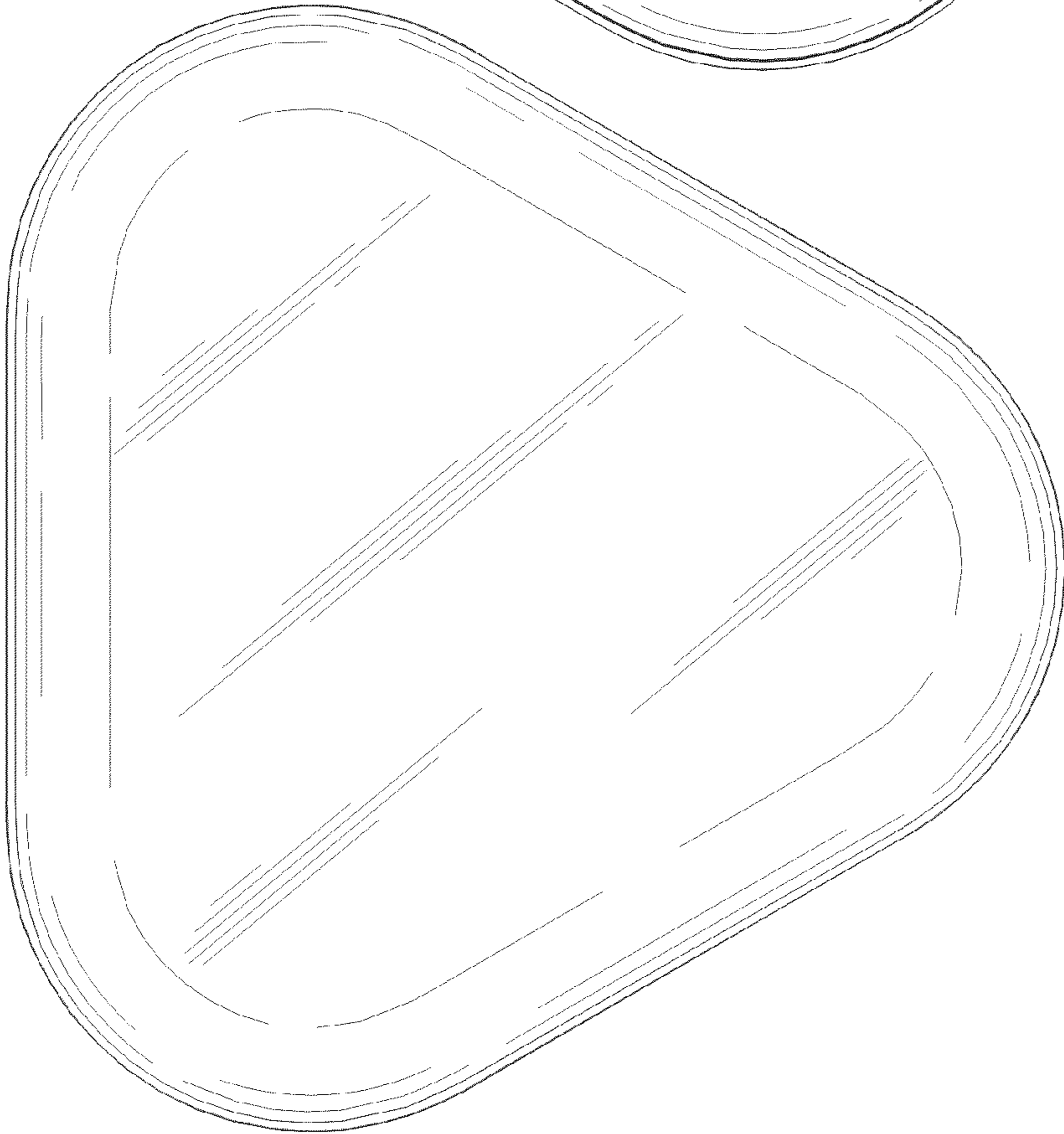
