The ornamental design for a knot ring, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective of a knot ring illustrating the new design;

FIG. 2 is a top view of the knot ring illustrated in FIG. 1;

FIG. 3 is a bottom perspective view of the knot ring illustrated in FIG. 1;

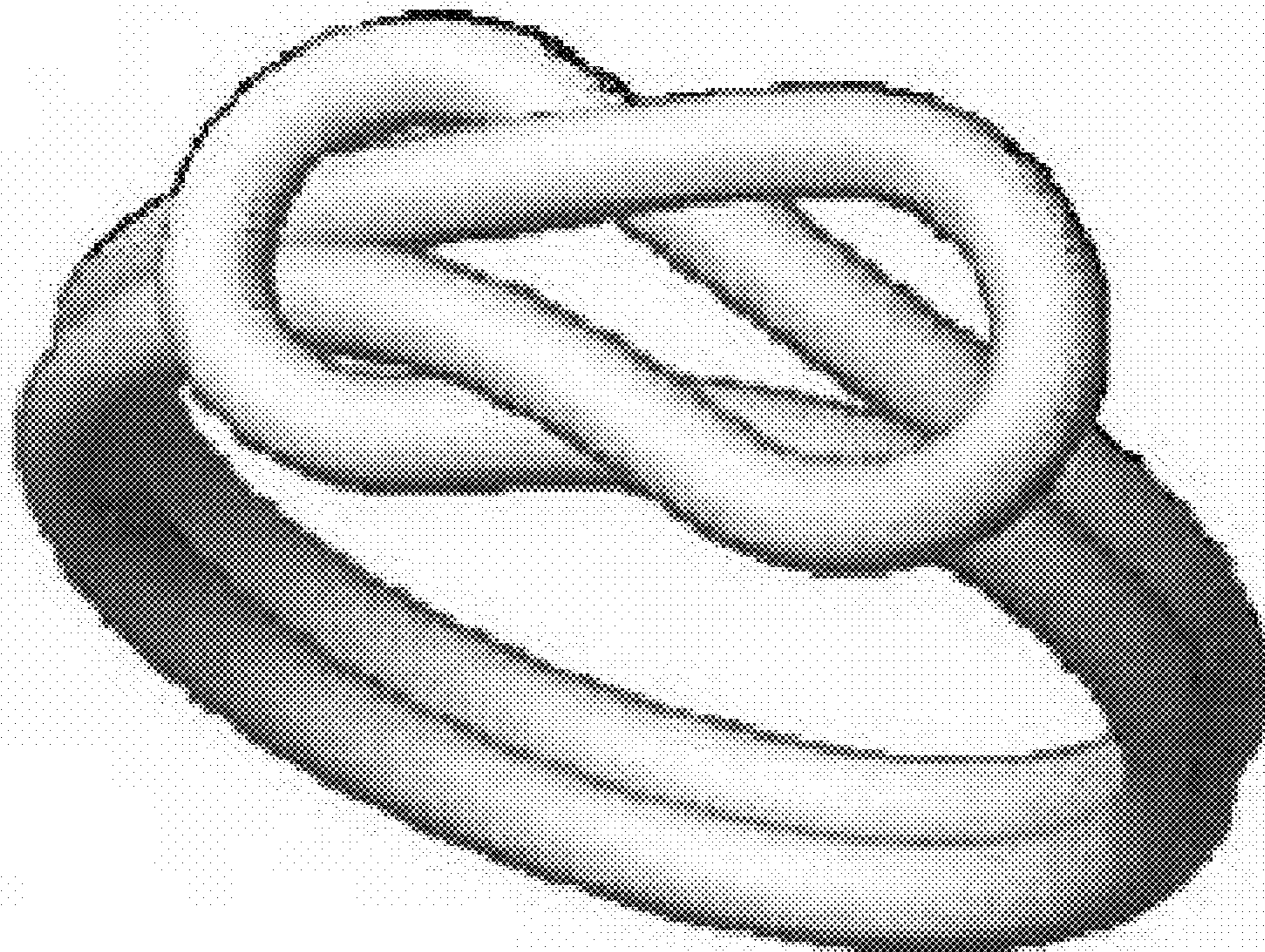
FIG. 4 is a left front perspective view of the knot ring illustrated in FIG. 1;

FIG. 5 is a front elevational view of the knot ring shown in FIG. 1 (the rear elevational view is a mirror image of FIG. 5);

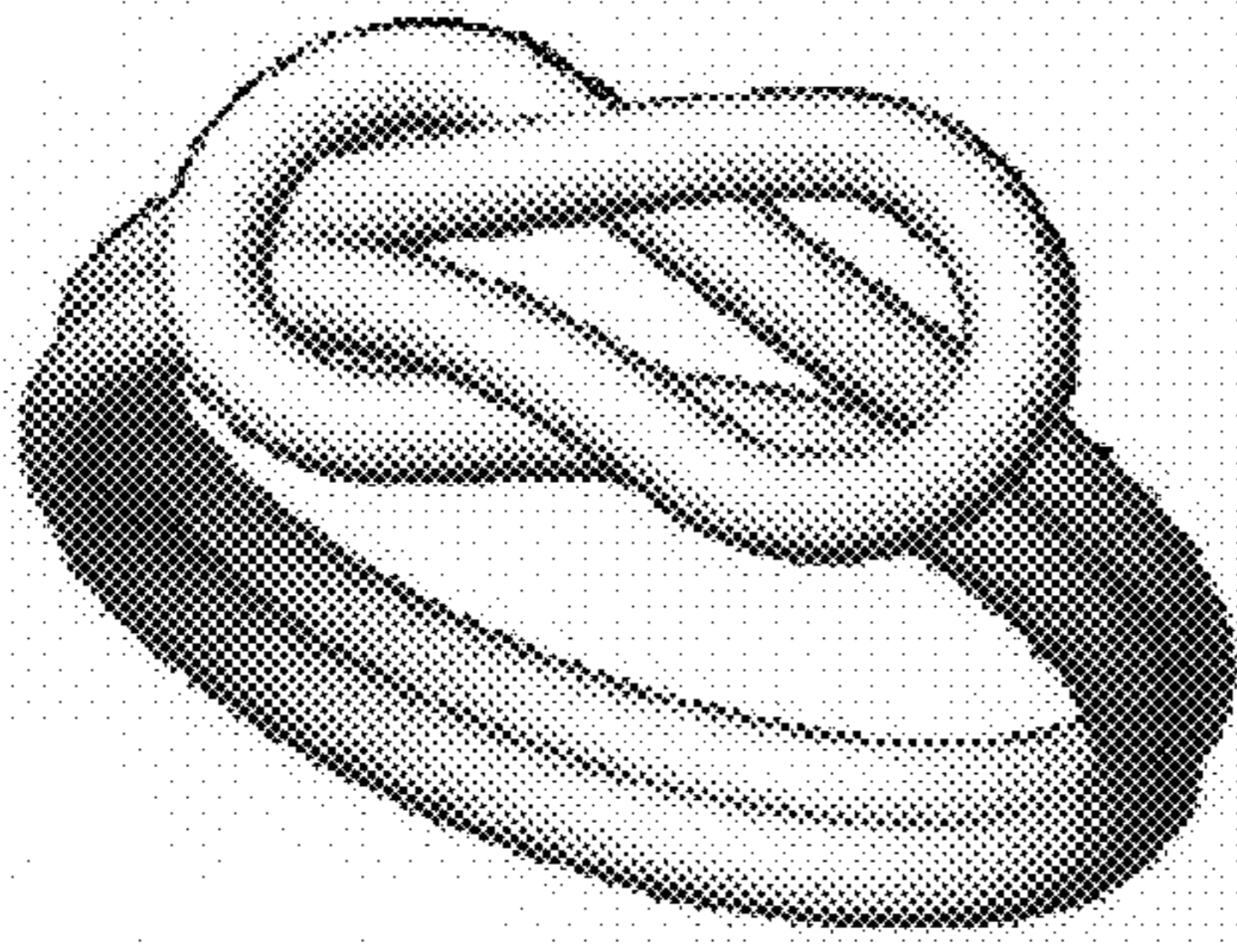

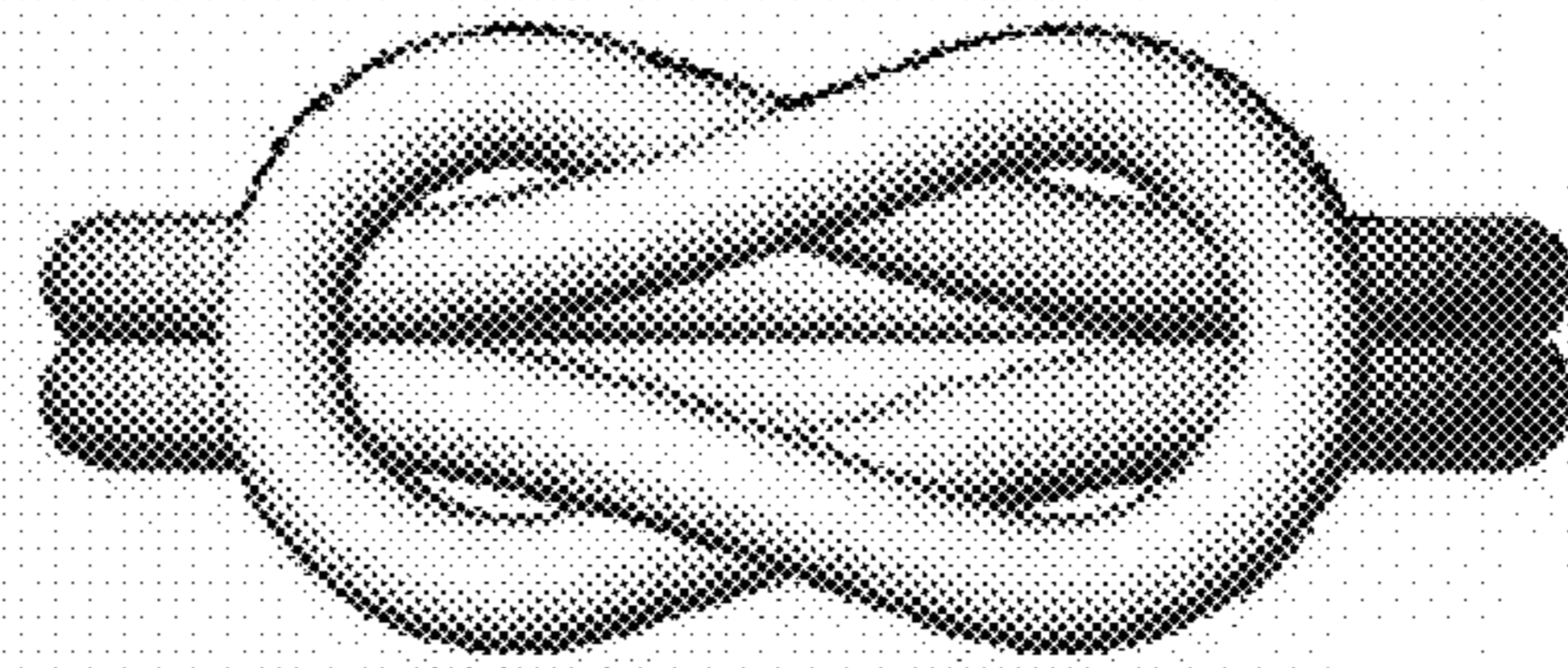

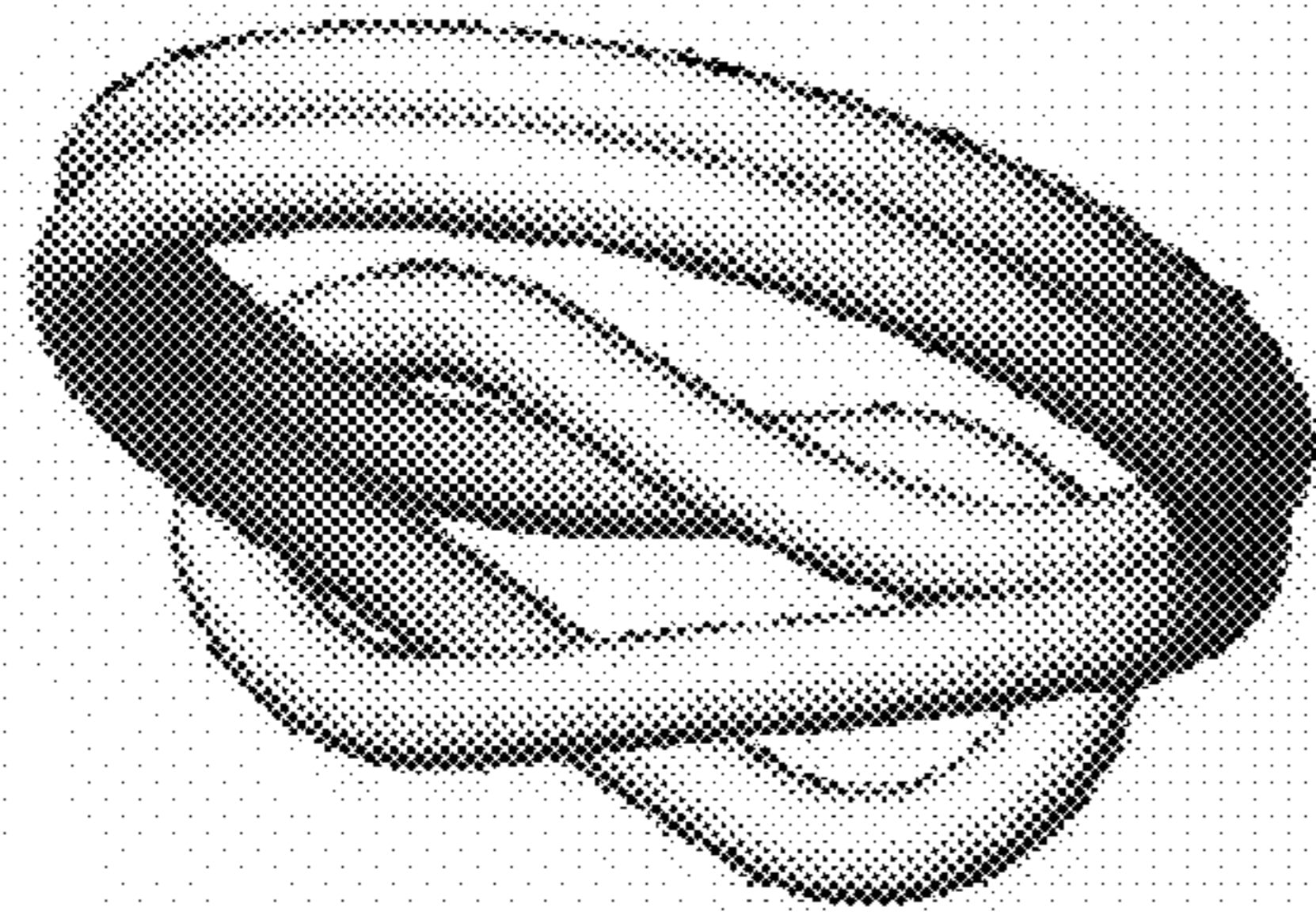

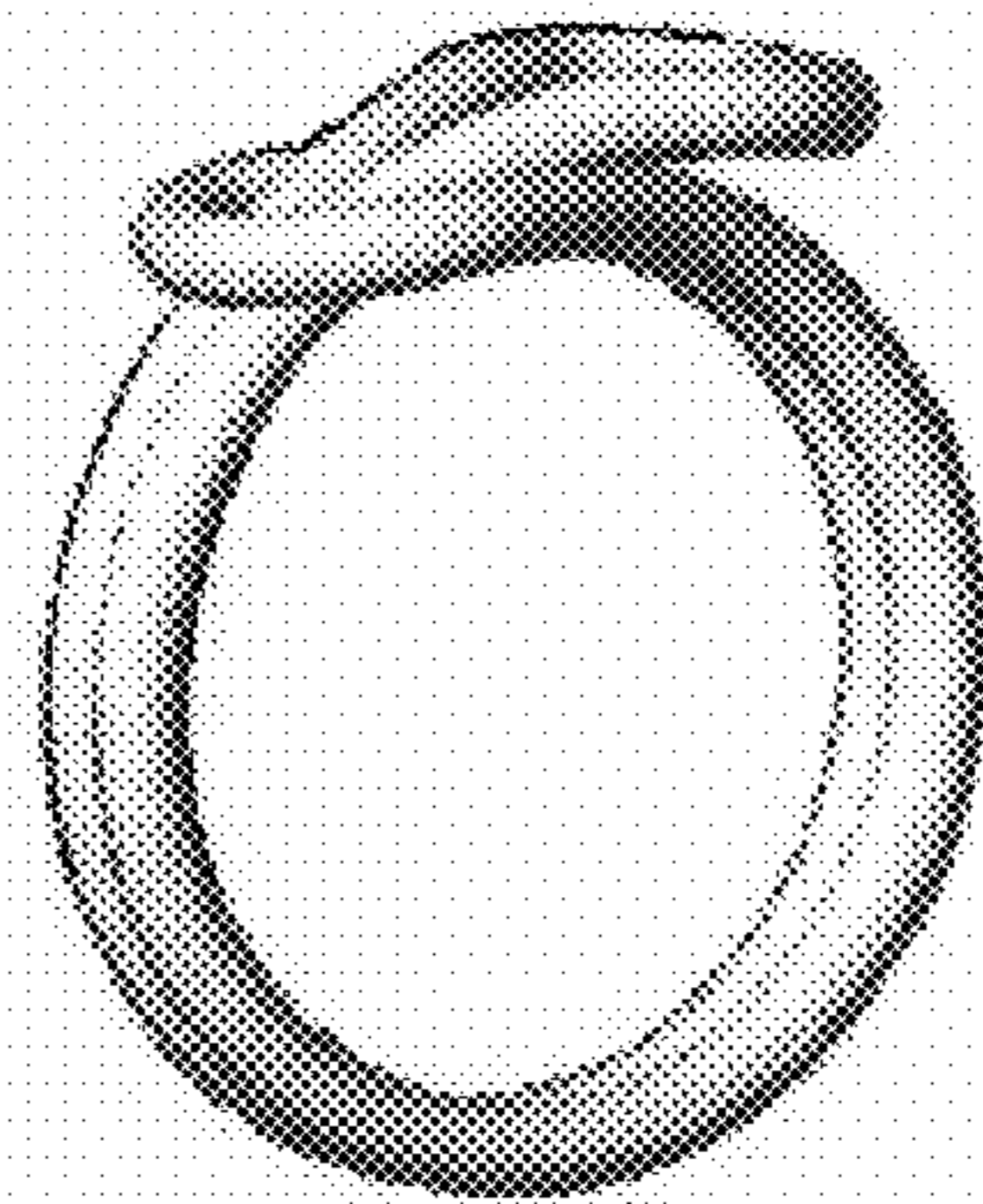

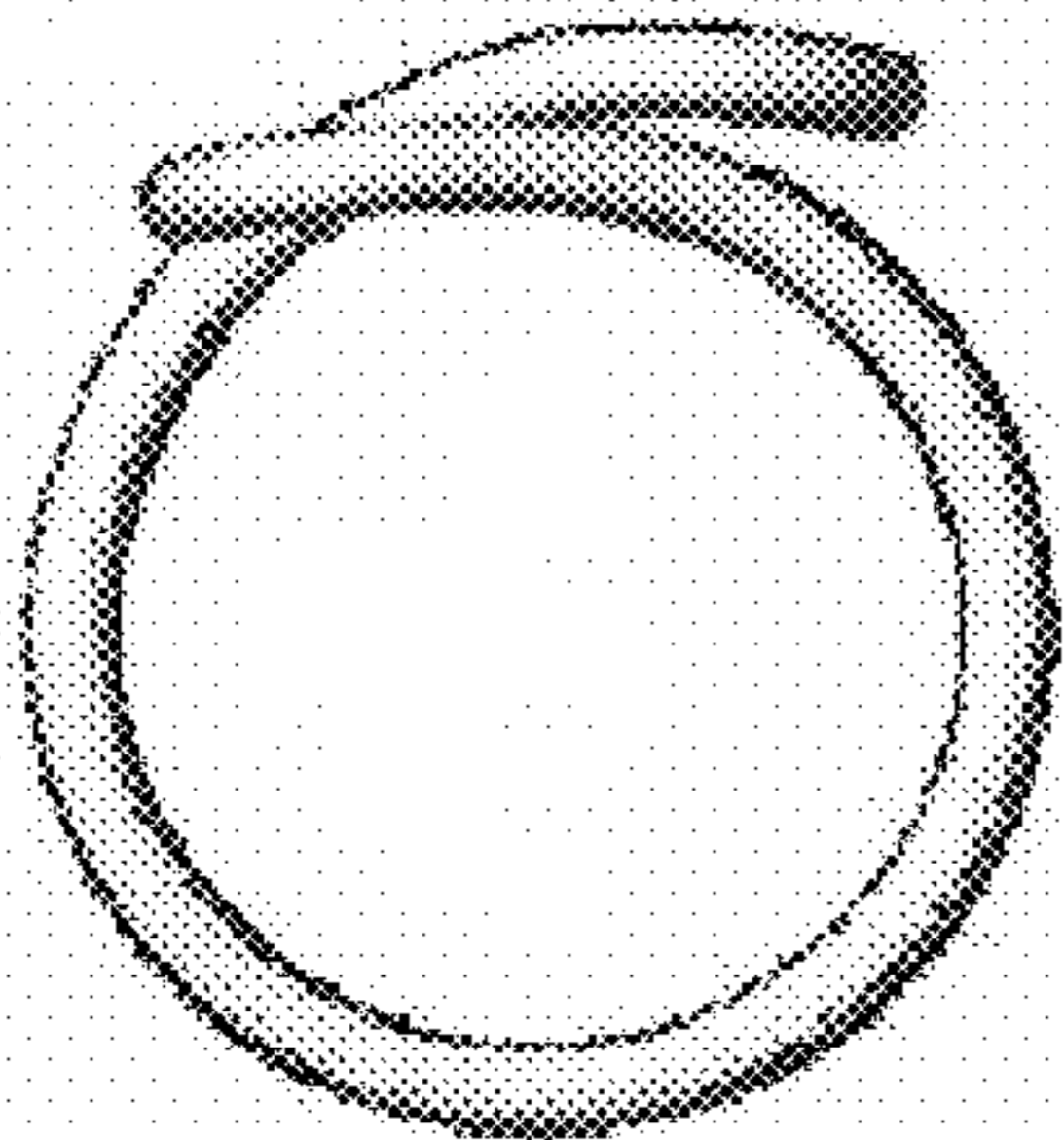

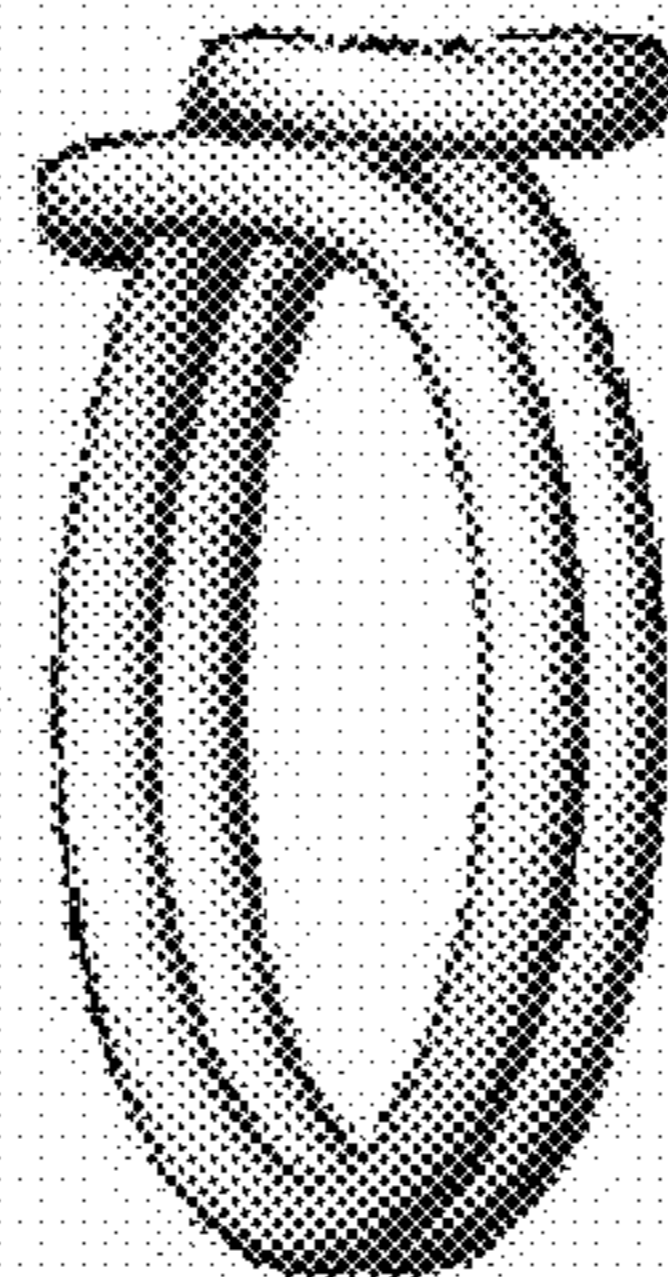

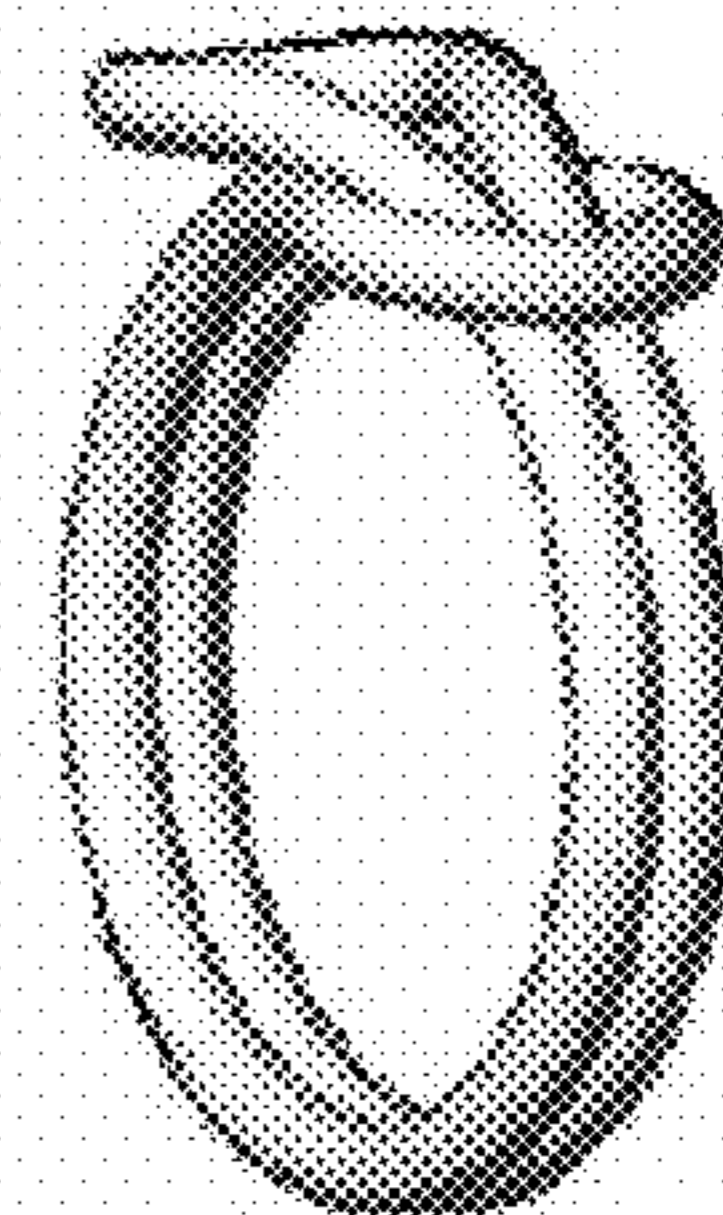
