(57) **CLAIM**

The ornamental design for a global coordinate jewelry component, as shown.

**DESCRIPTION**

FIG. 1 is a front elevational view of a global coordinate jewelry component configured in accordance with an embodiment of the present invention;

FIG. 2 is a left side elevational view of the jewelry component of FIG. 1;

FIG. 3 is a right side elevational view of the jewelry component of FIG. 1;

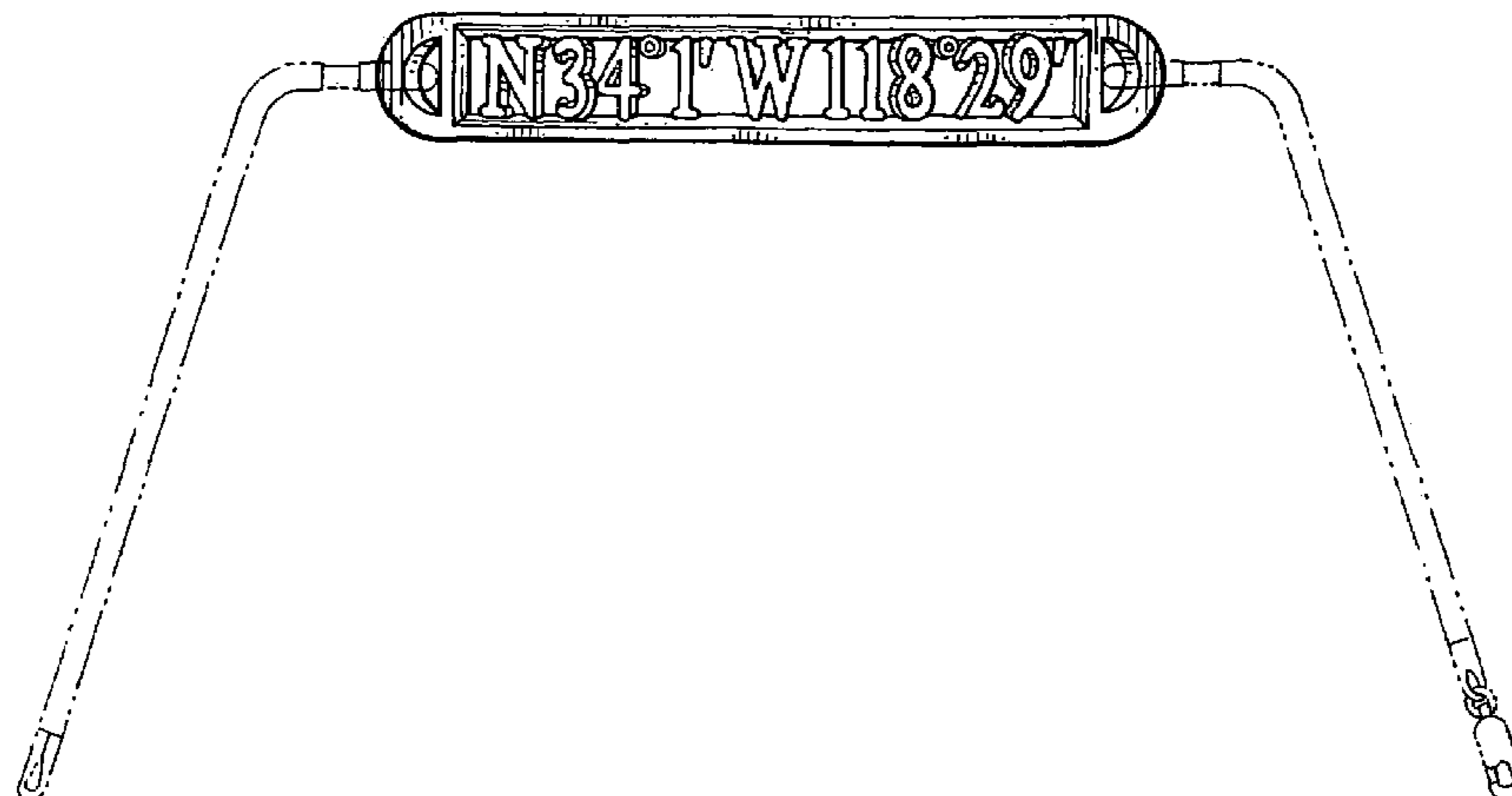
FIG. 4 is a rear elevational view of the jewelry component of FIG. 1;

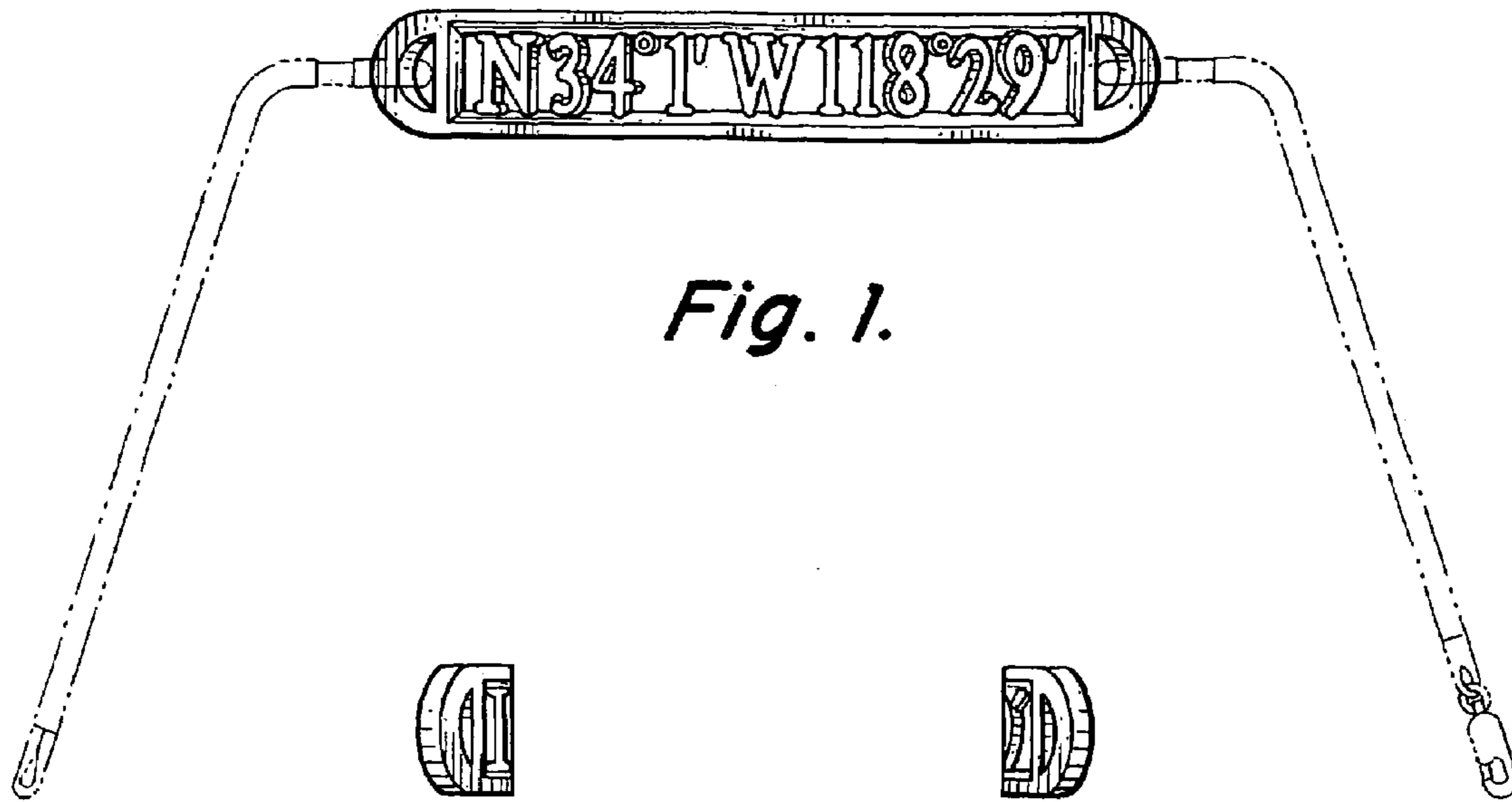
FIG. 5 is a top plan view of the jewelry component of FIG. 1; and,

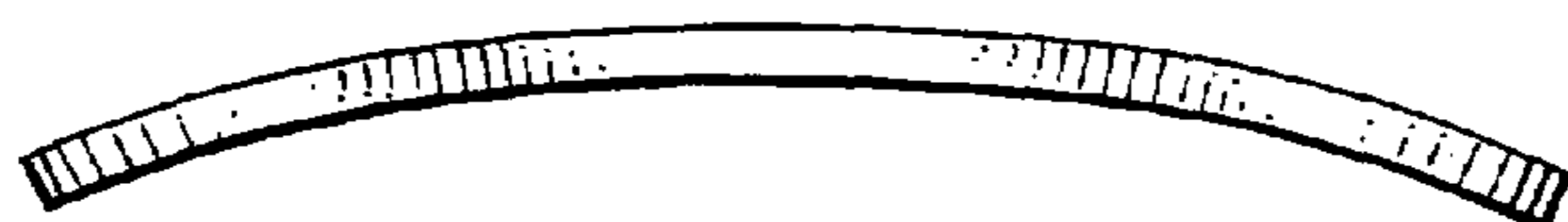
