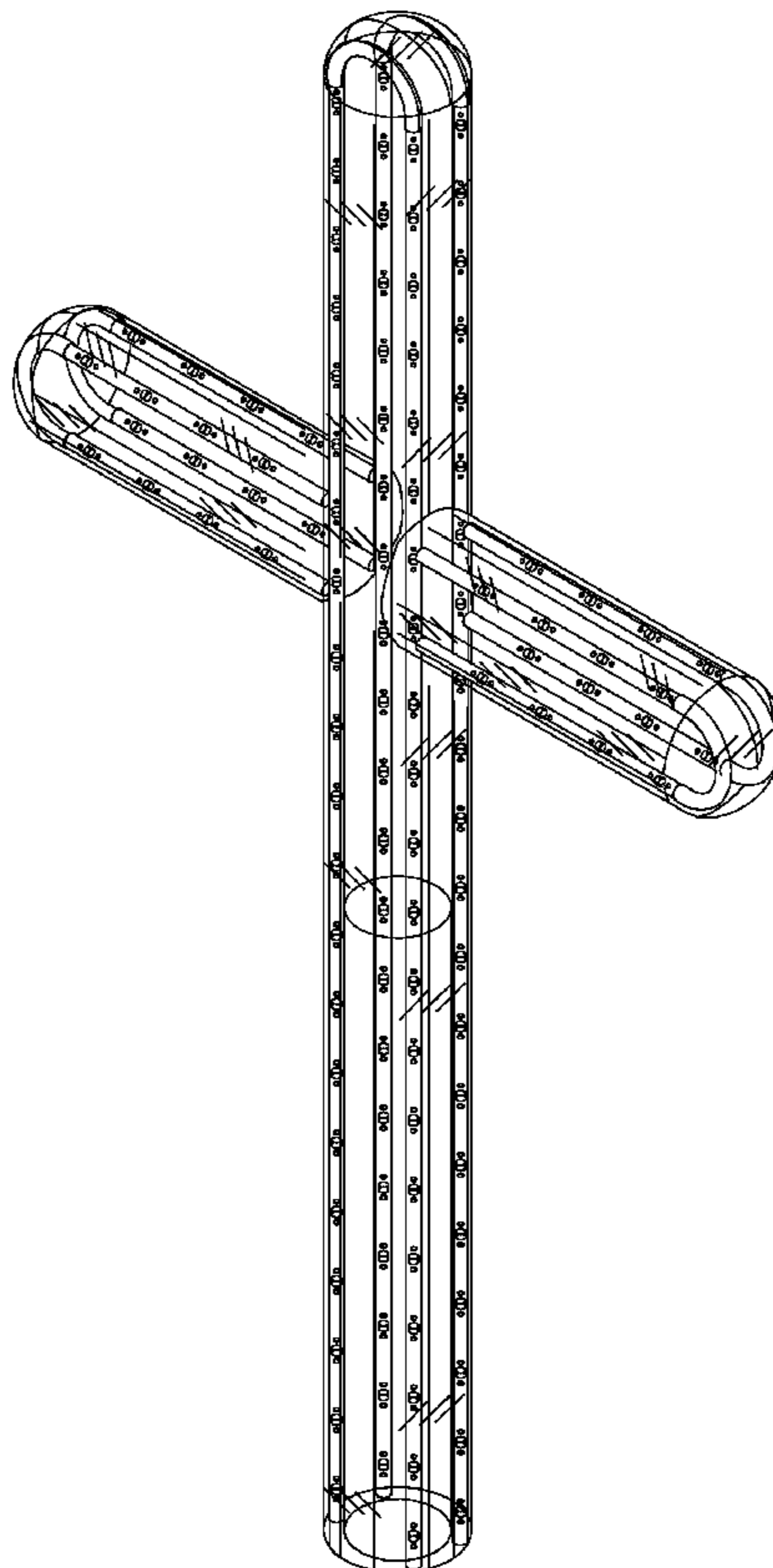
(57) **CLAIM**

I claim the ornamental design for a cross Christmas tree topper ornament, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a cross Christmas tree topper ornament showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a top planar view thereof; and,
FIG. 7 is a bottom planar view thereof.

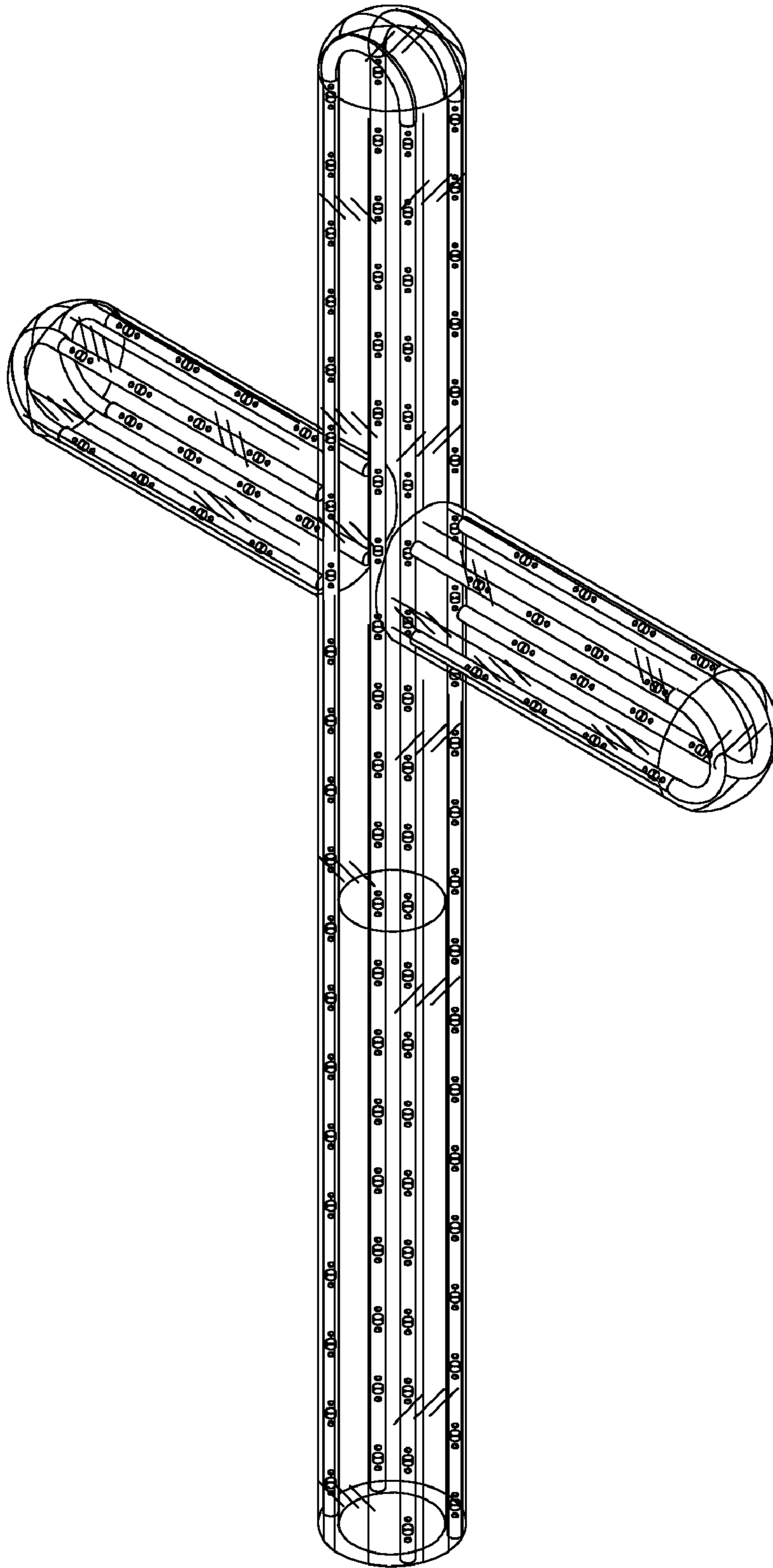

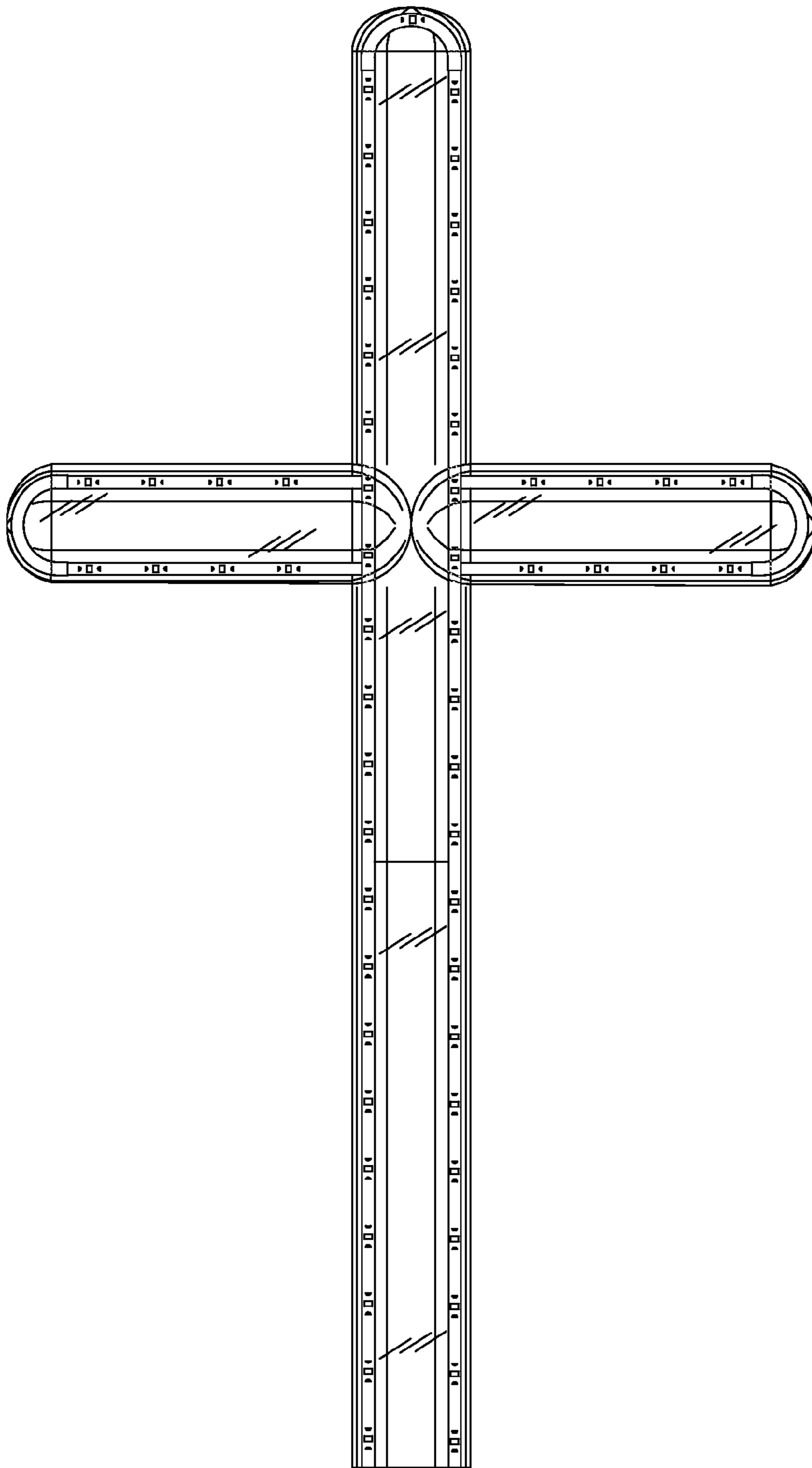

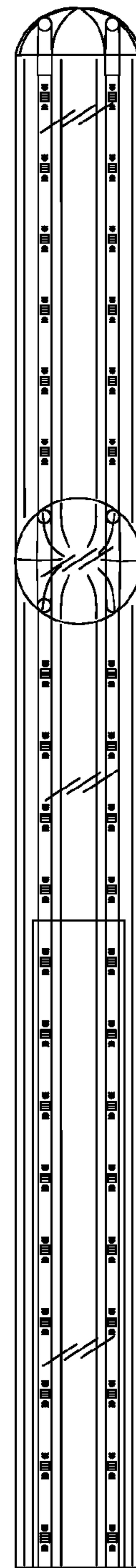

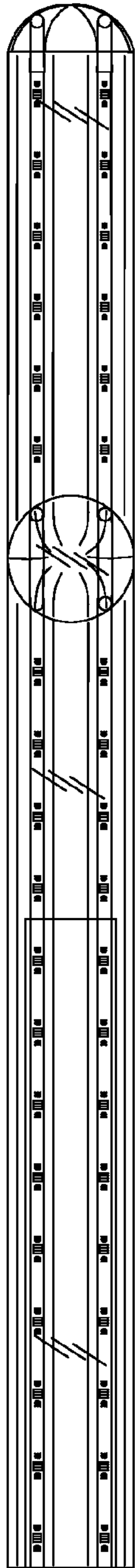

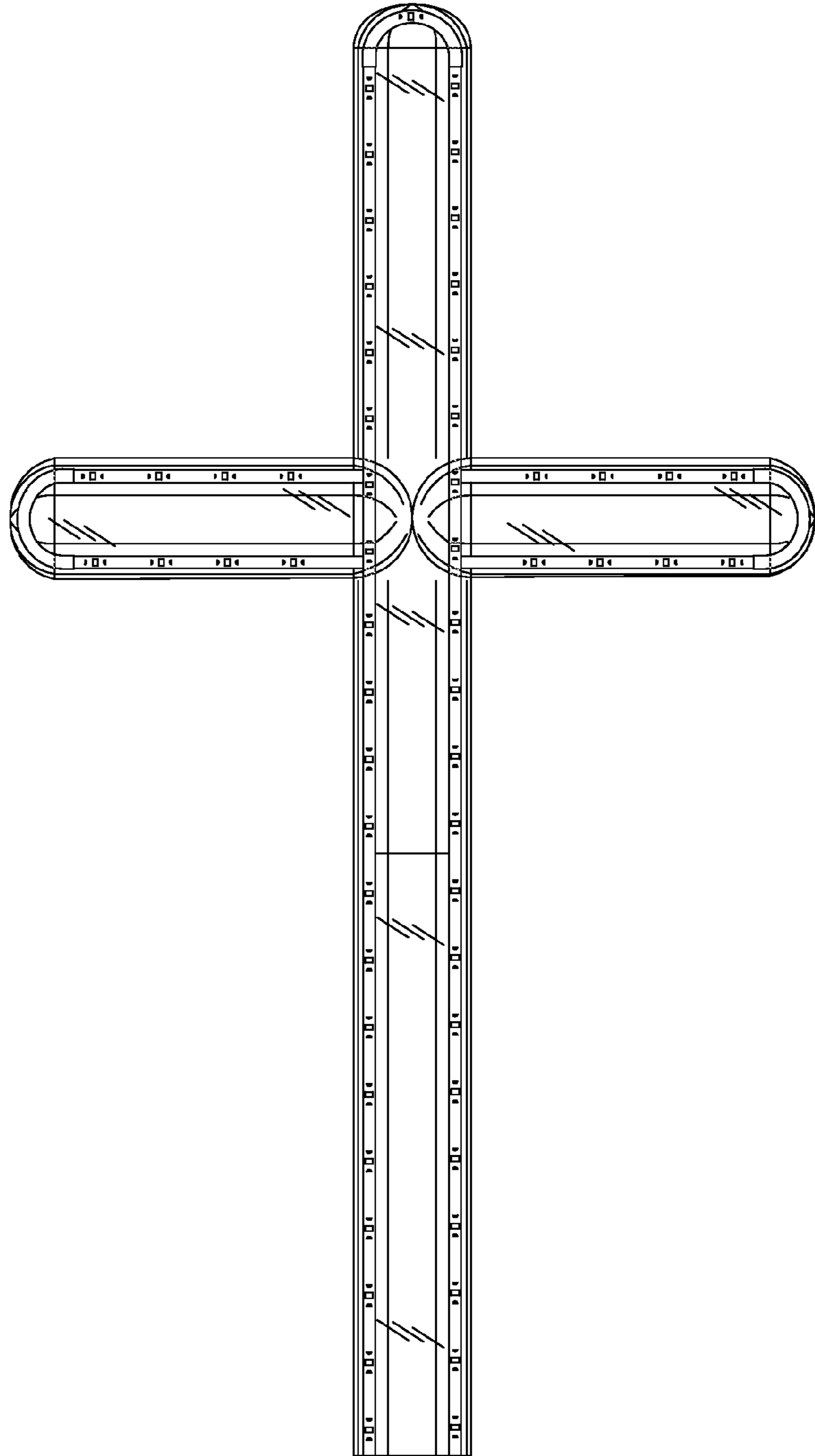

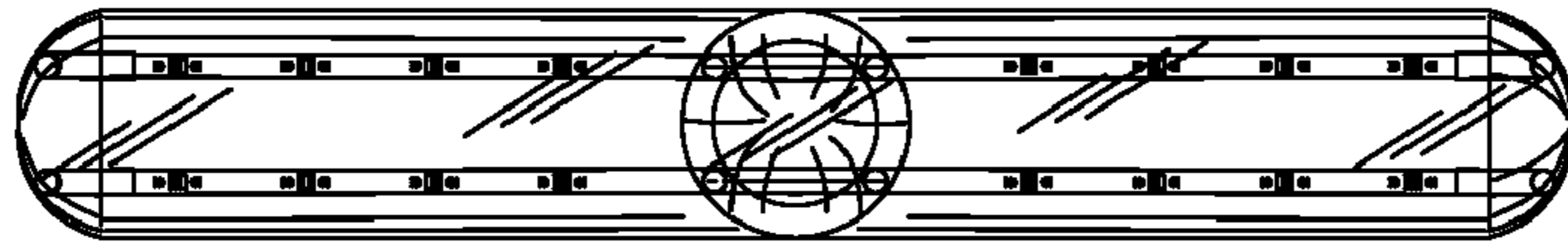

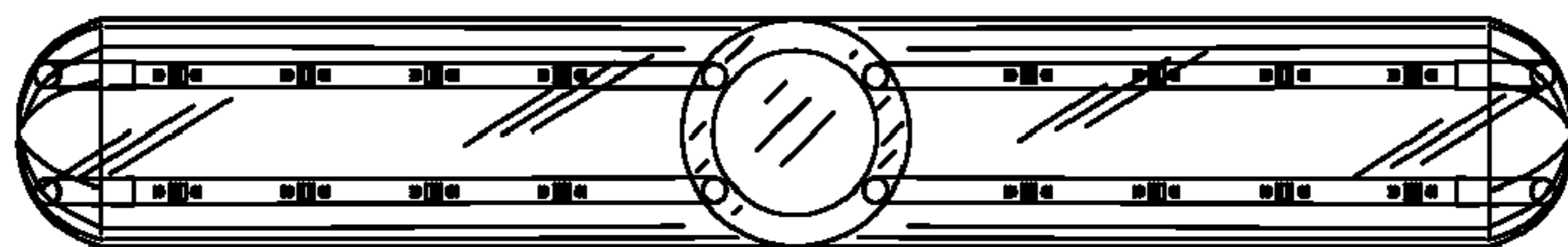
