The ornamental design for an automobile tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view thereof;

FIG. 2 is a rear view thereof;

FIG. 4 is a right-side view thereof;

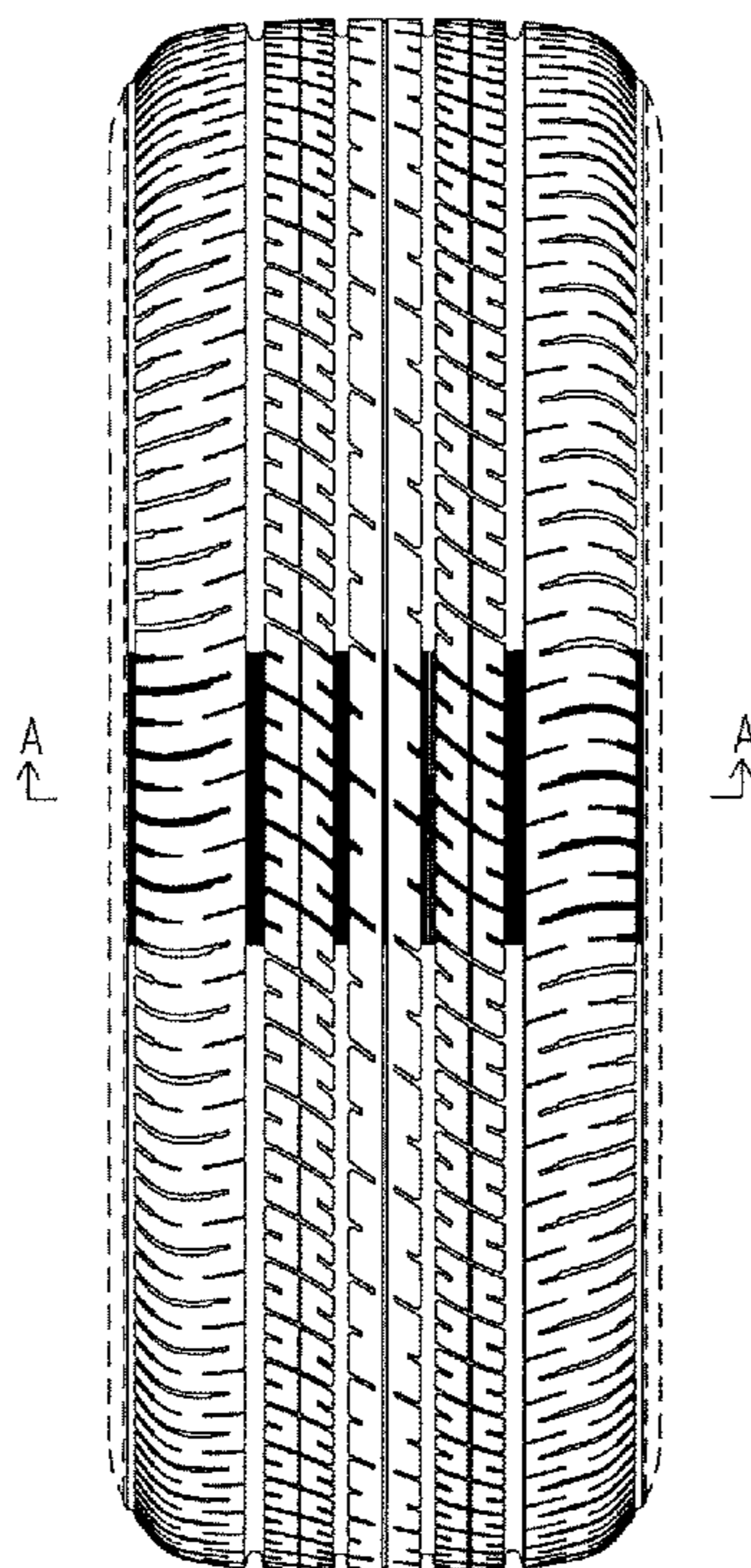
FIG. 5 is a perspective view thereof;

FIG. 6 is a reference front view, a part of its tread painted black; and,

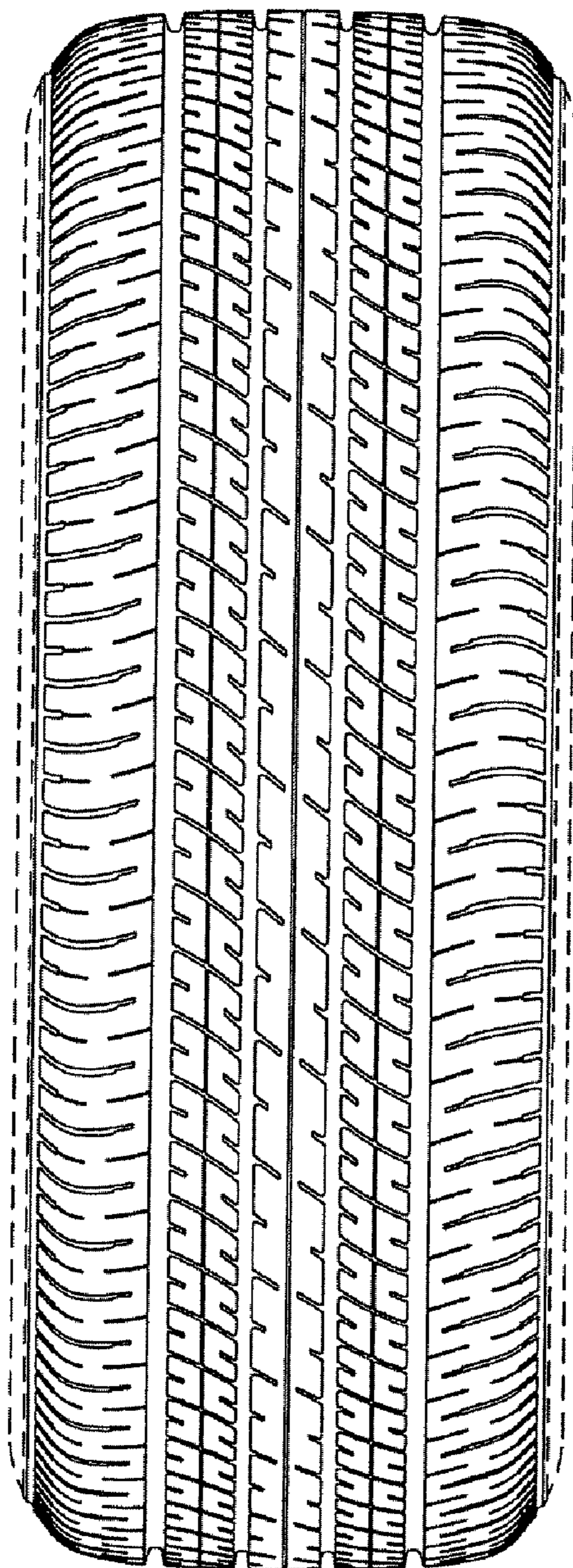

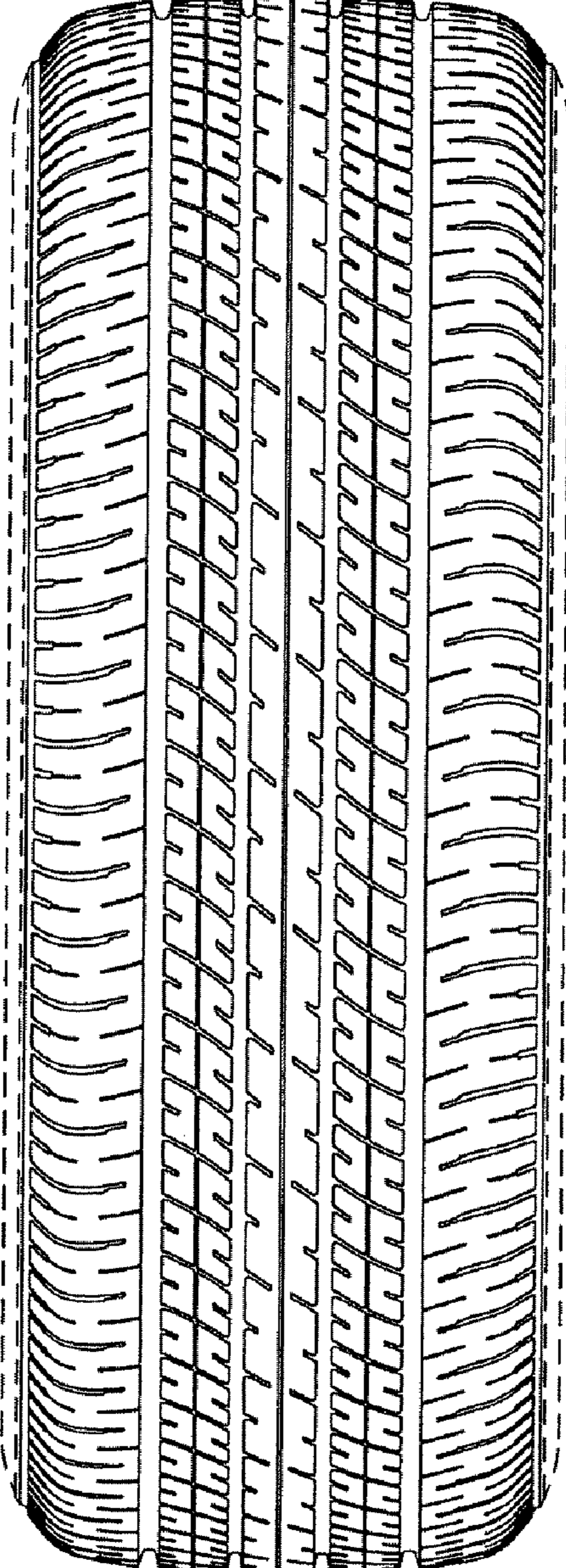

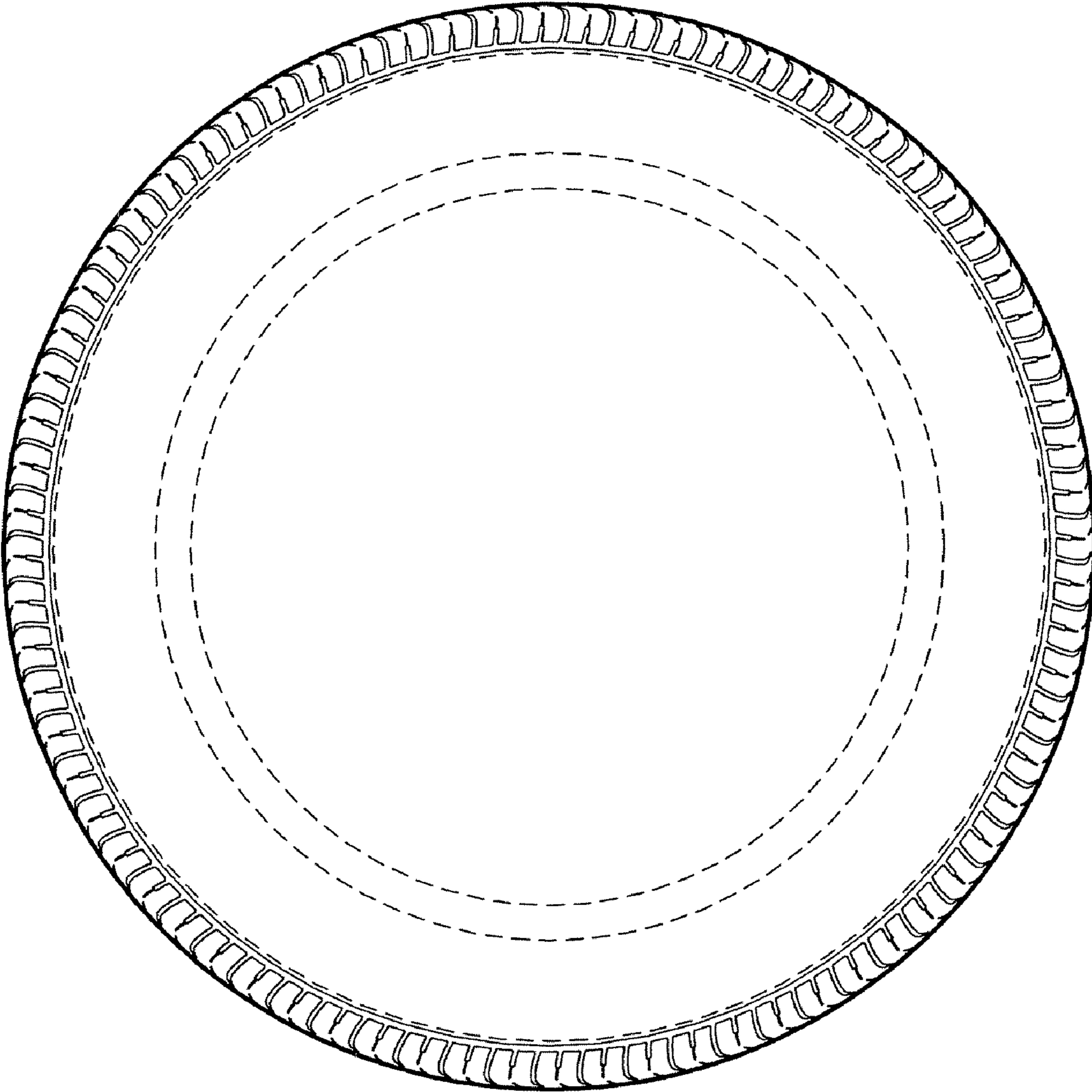

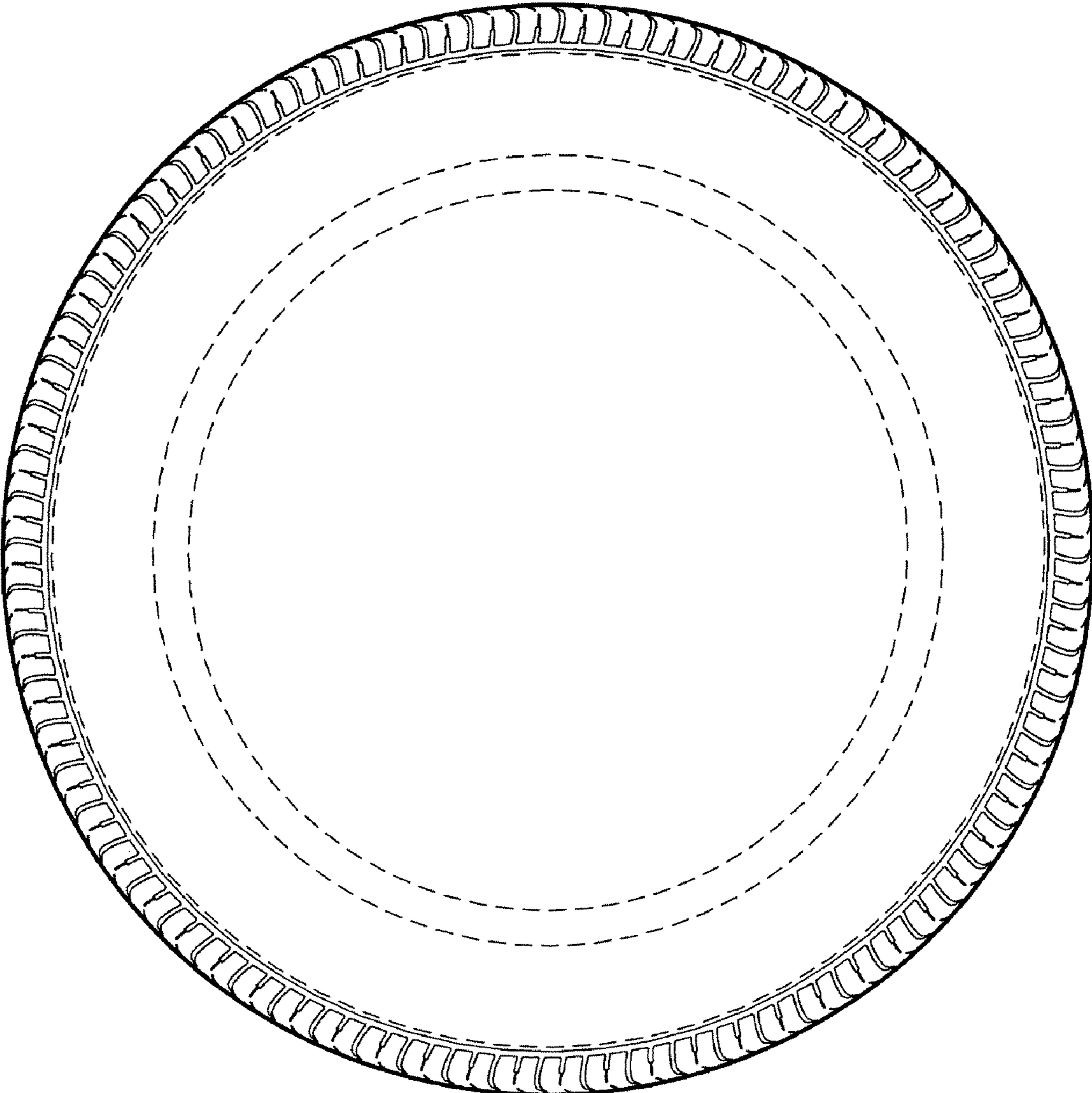

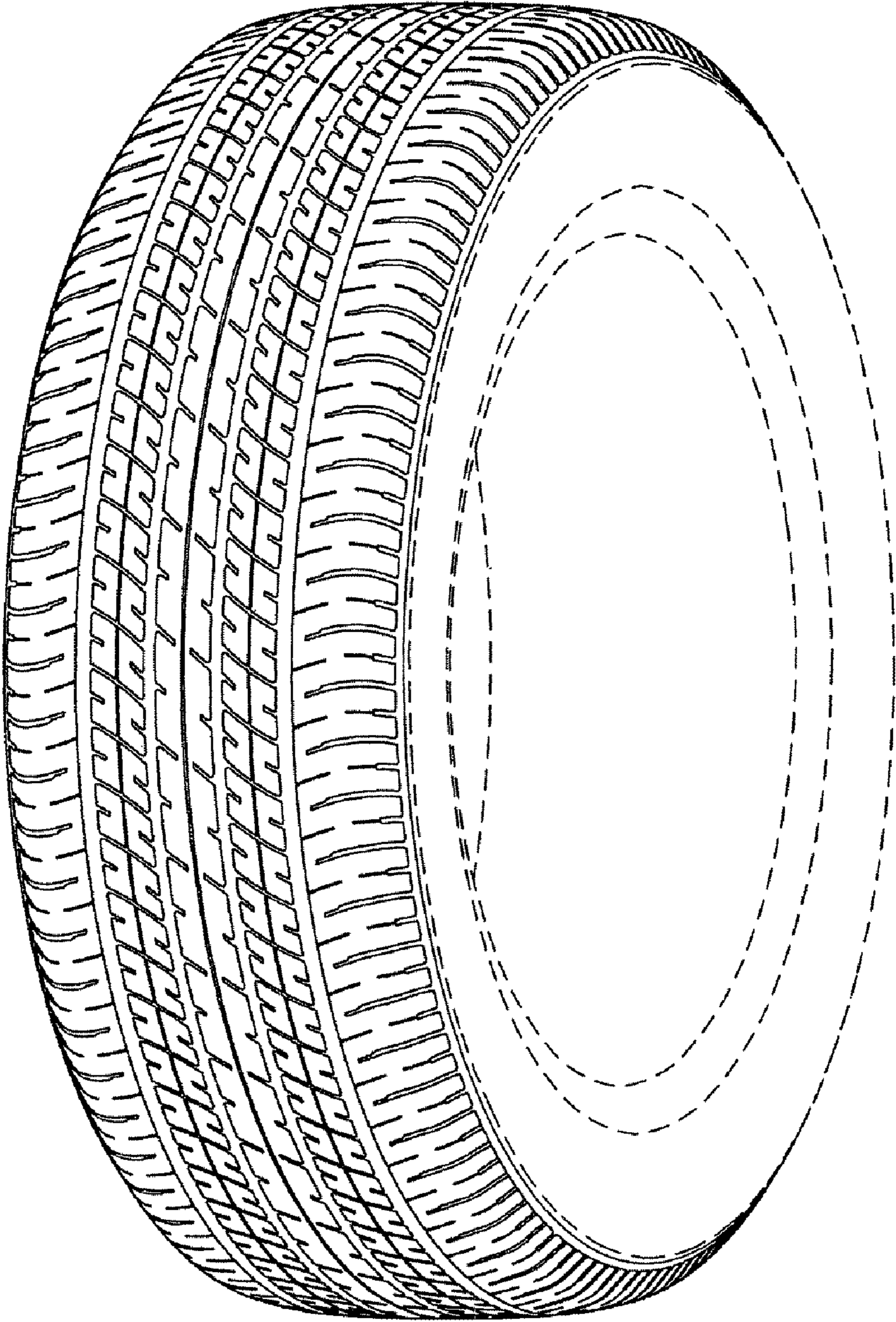

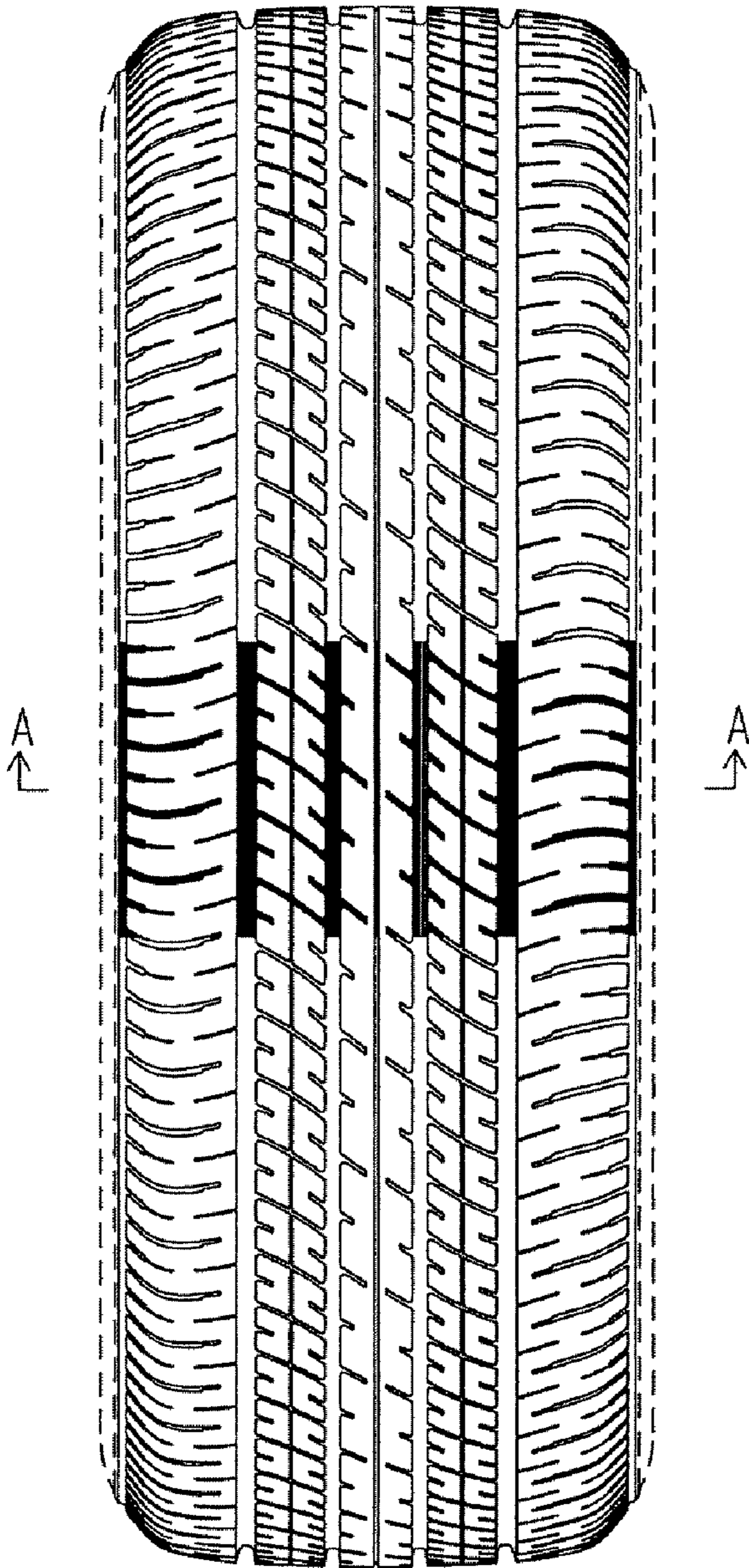

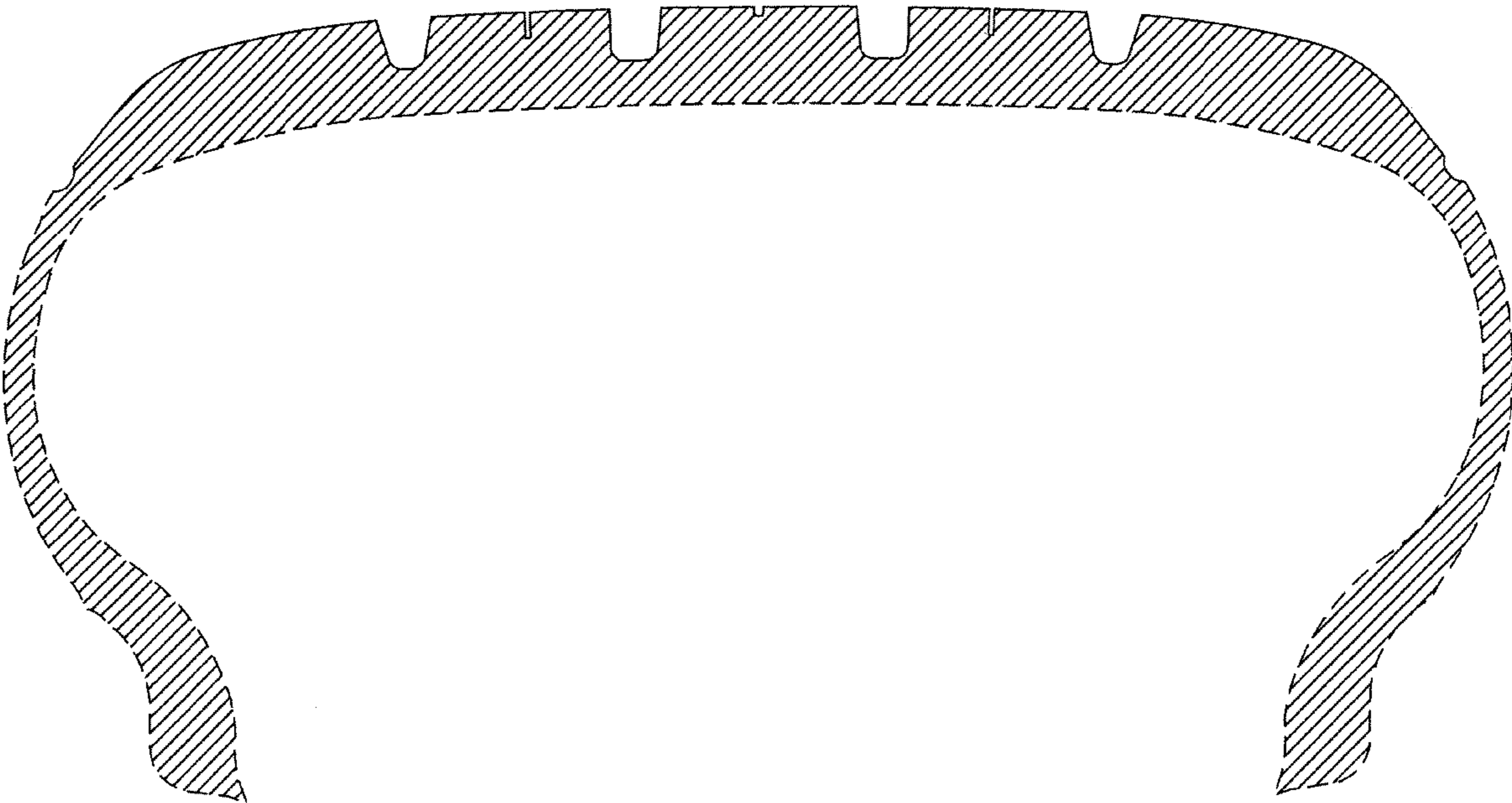
