(57) **CLAIM**

The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone;

FIG. 2 is a front view of the mobile phone of FIG. 1;

FIG. 3 is a rear view of the mobile phone of FIG. 1;

FIG. 4 is a left-side view of the mobile phone of FIG. 1;

FIG. 5 is a right-side view of the mobile phone of FIG. 1;

FIG. 6 is a top plan view of the mobile phone of FIG. 1;

FIG. 7 is a bottom plan view of the mobile phone of FIG. 1; and,

FIG. 8 is a rear perspective view of the mobile phone of FIG. 1 showing the rear panel in an alternate position.

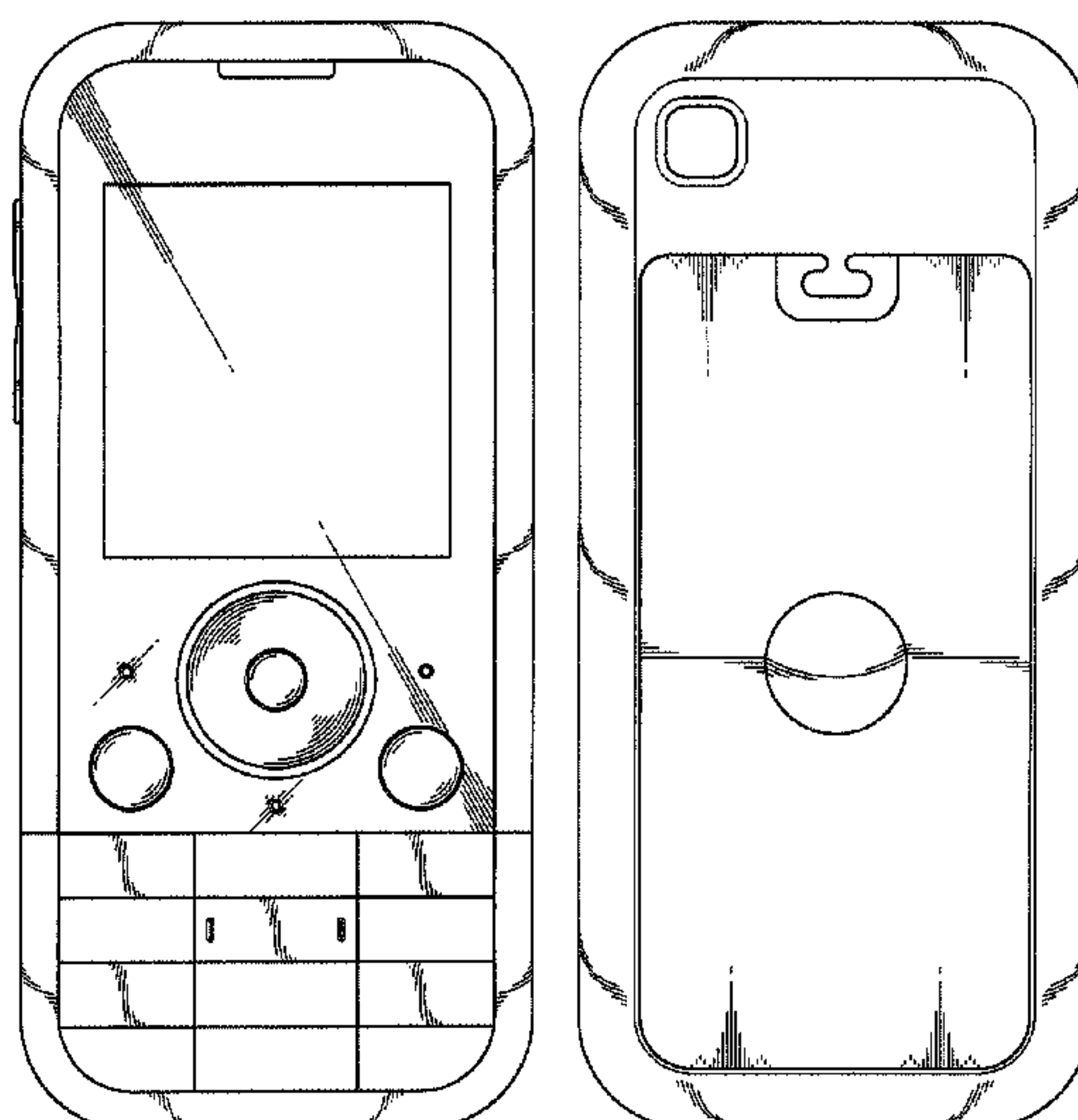

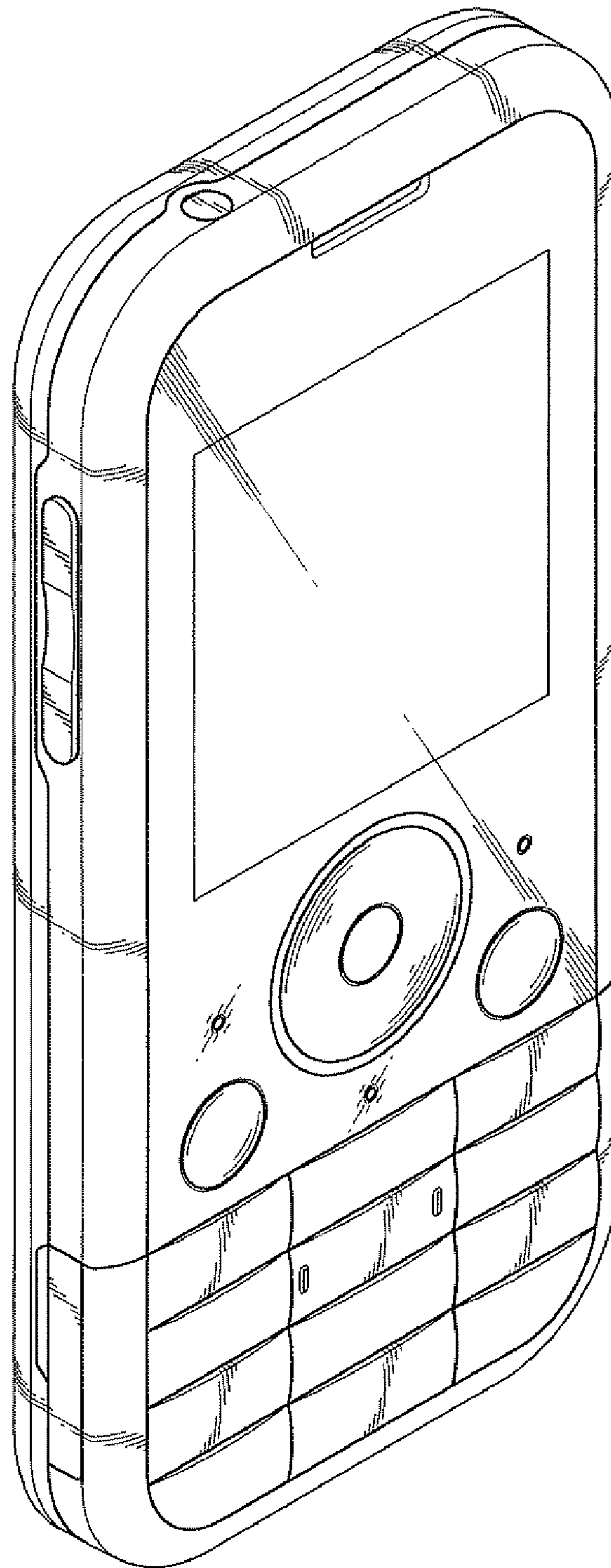

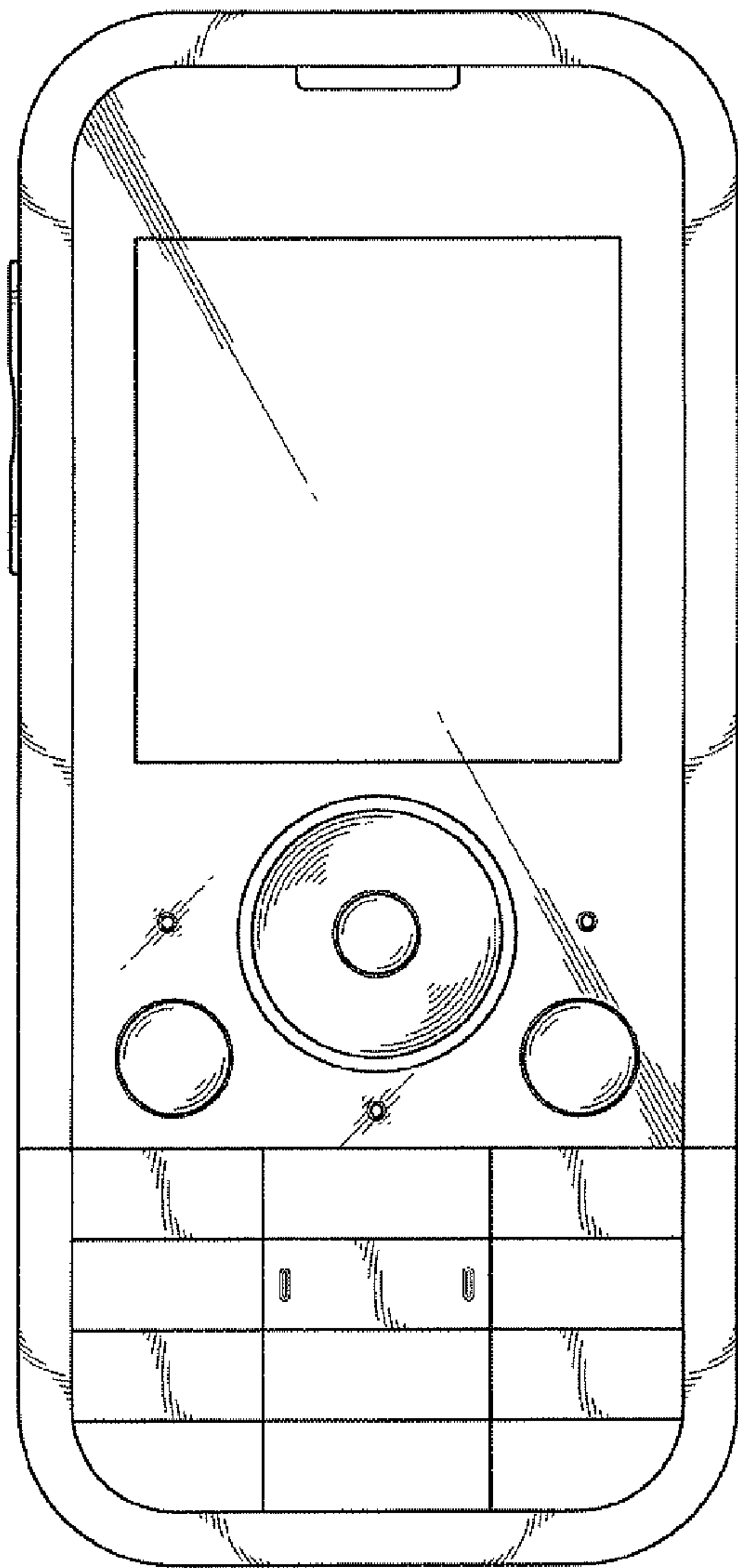

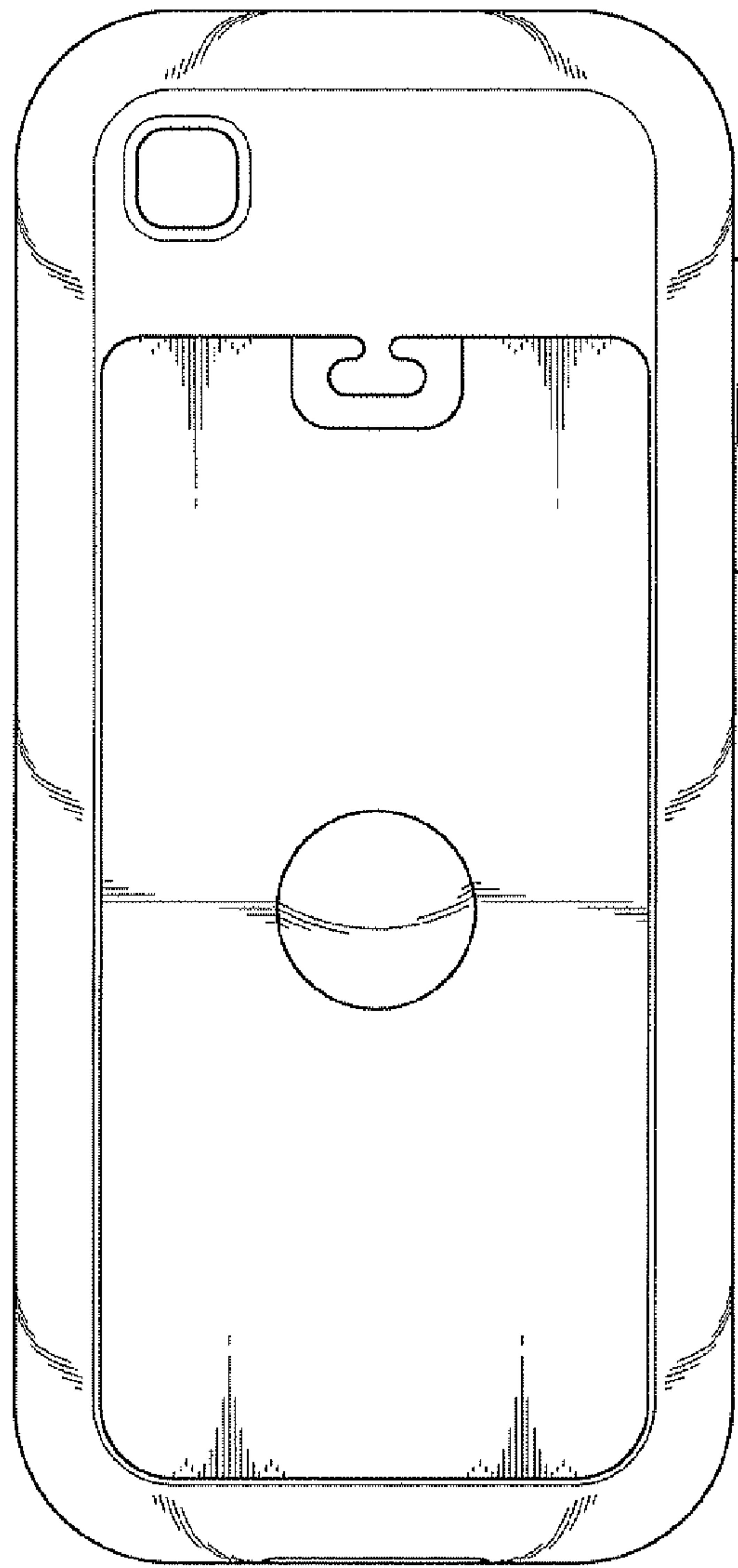

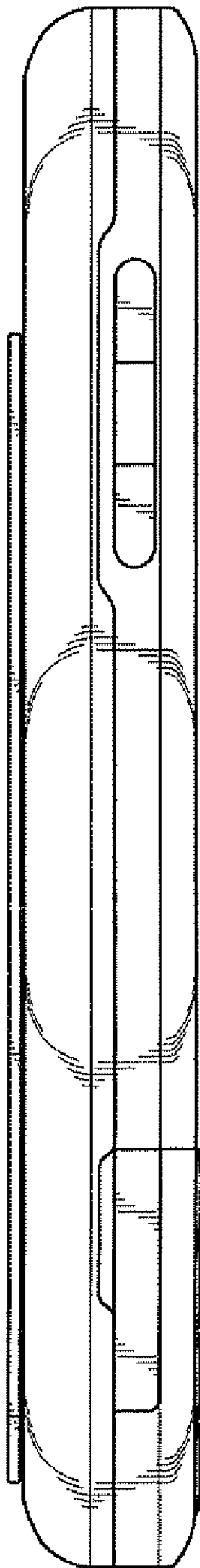

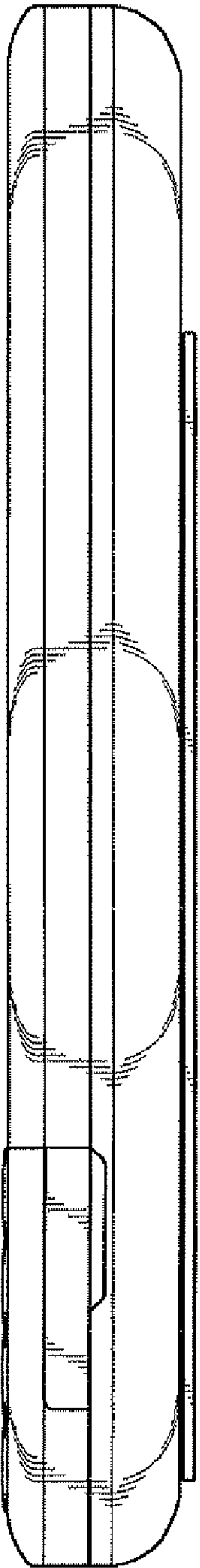

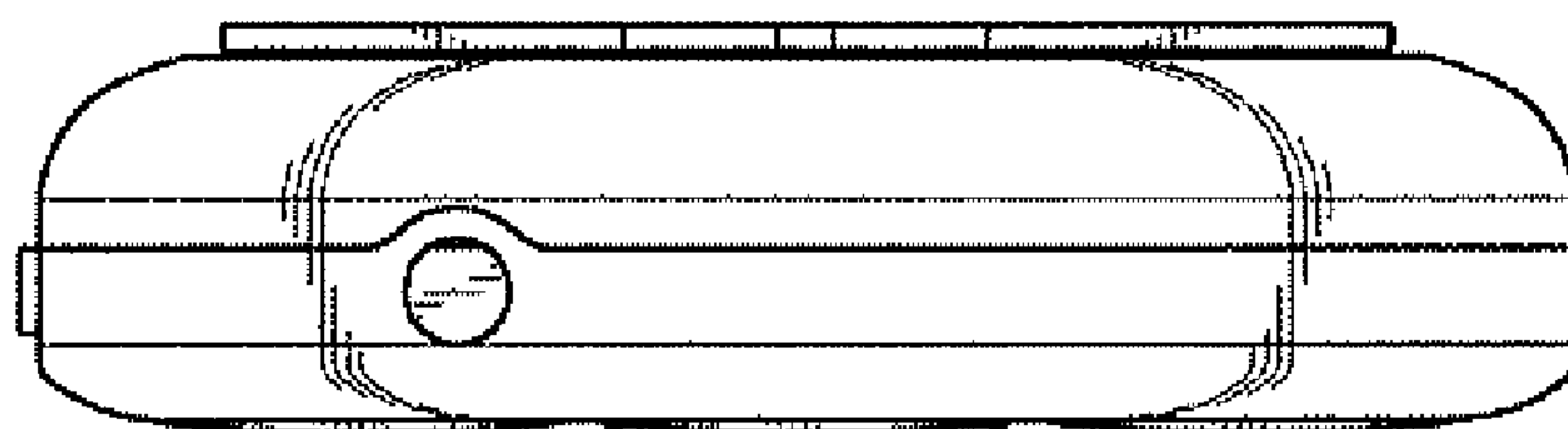

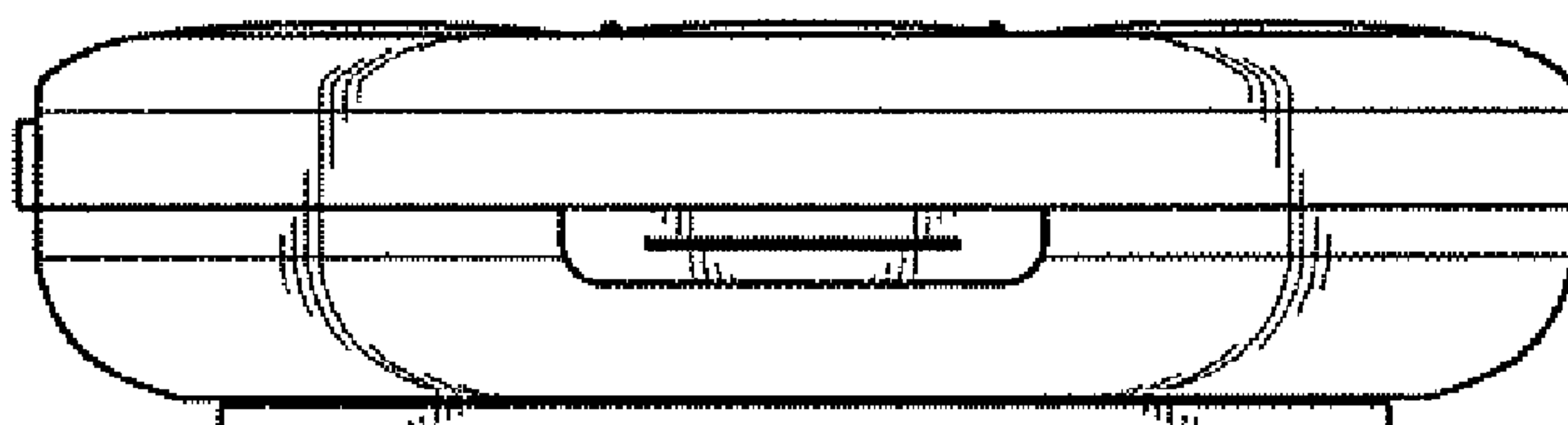
