The ornamental design for a mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a mobile phone;

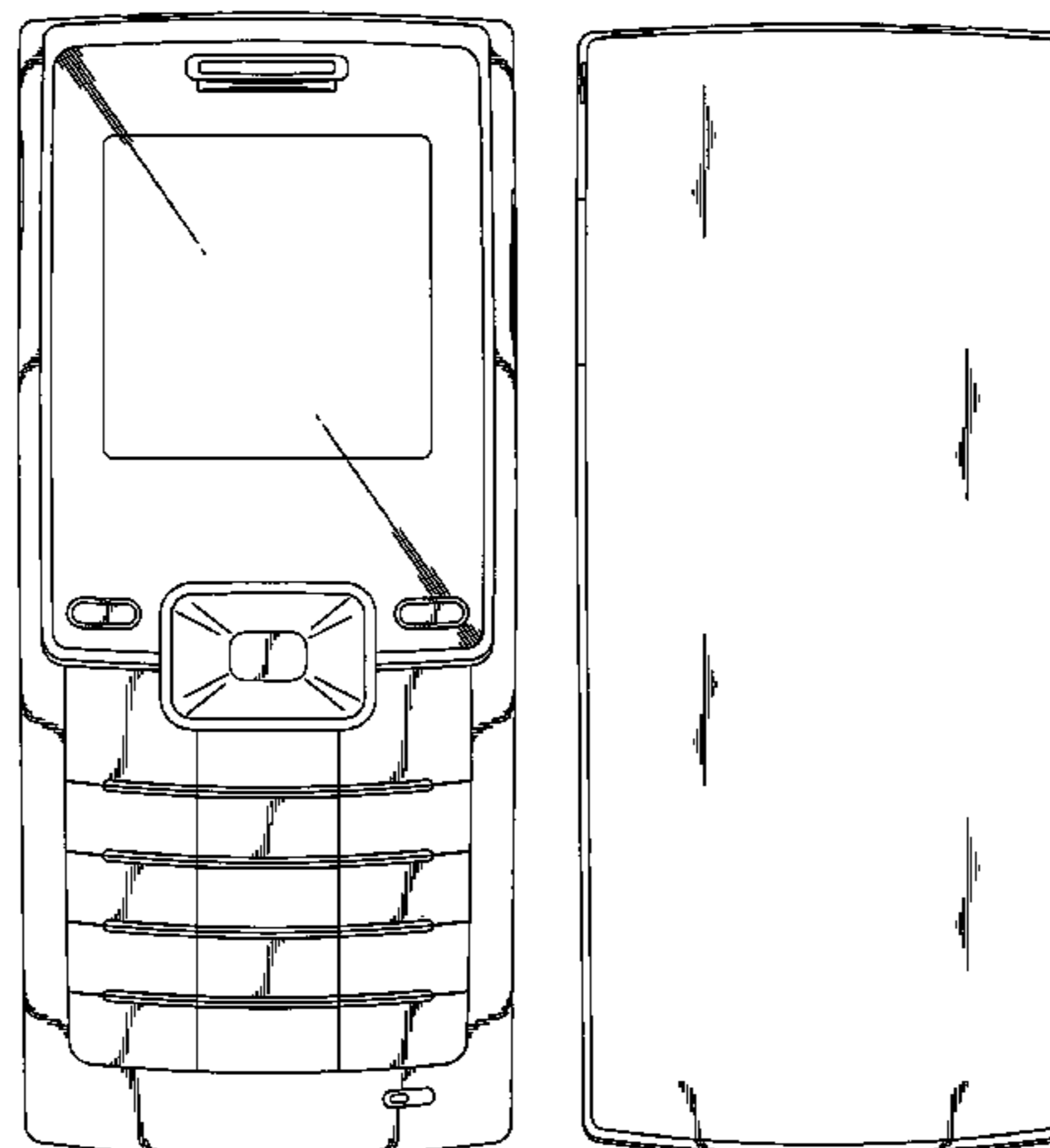

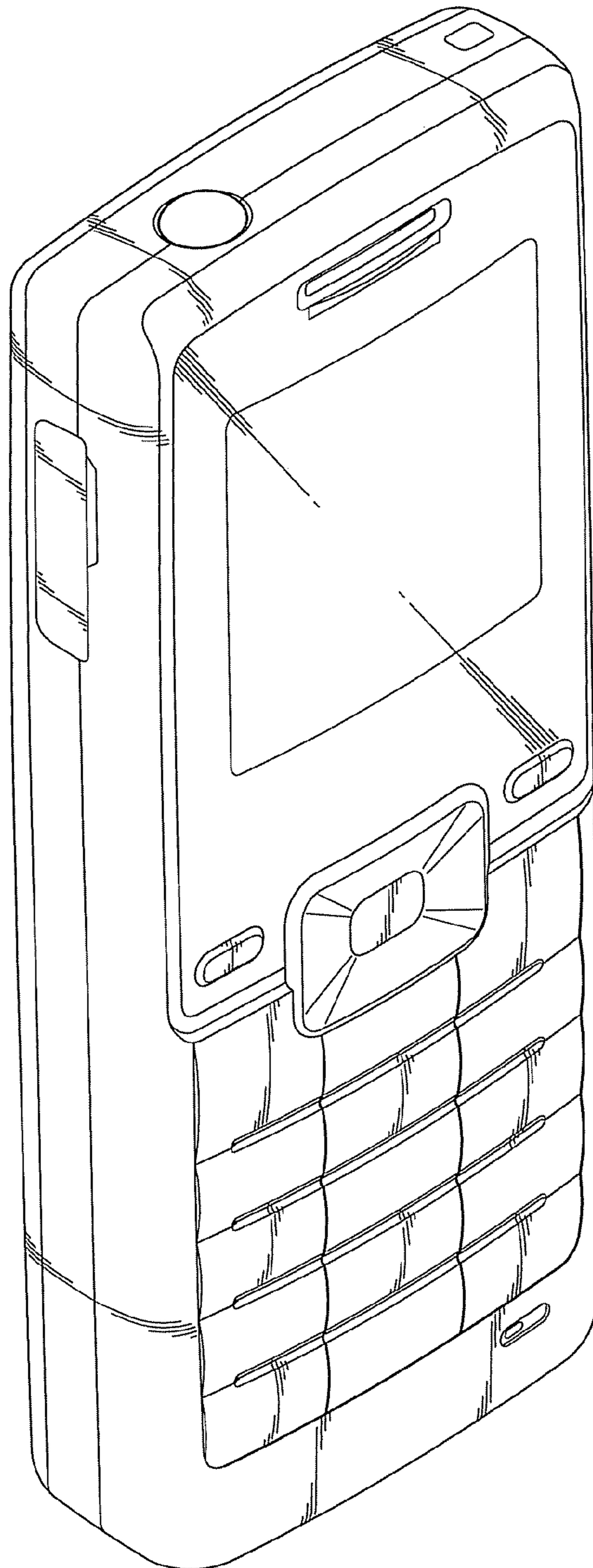

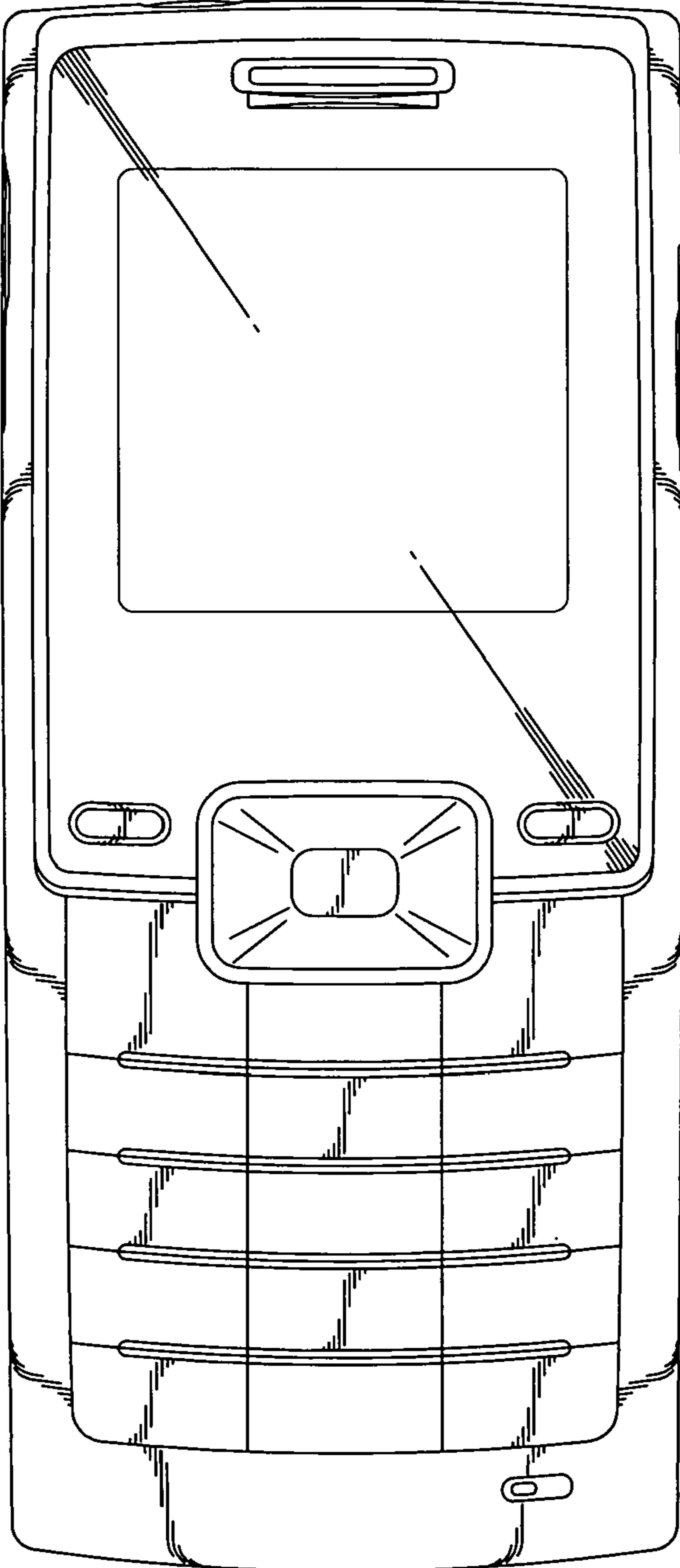

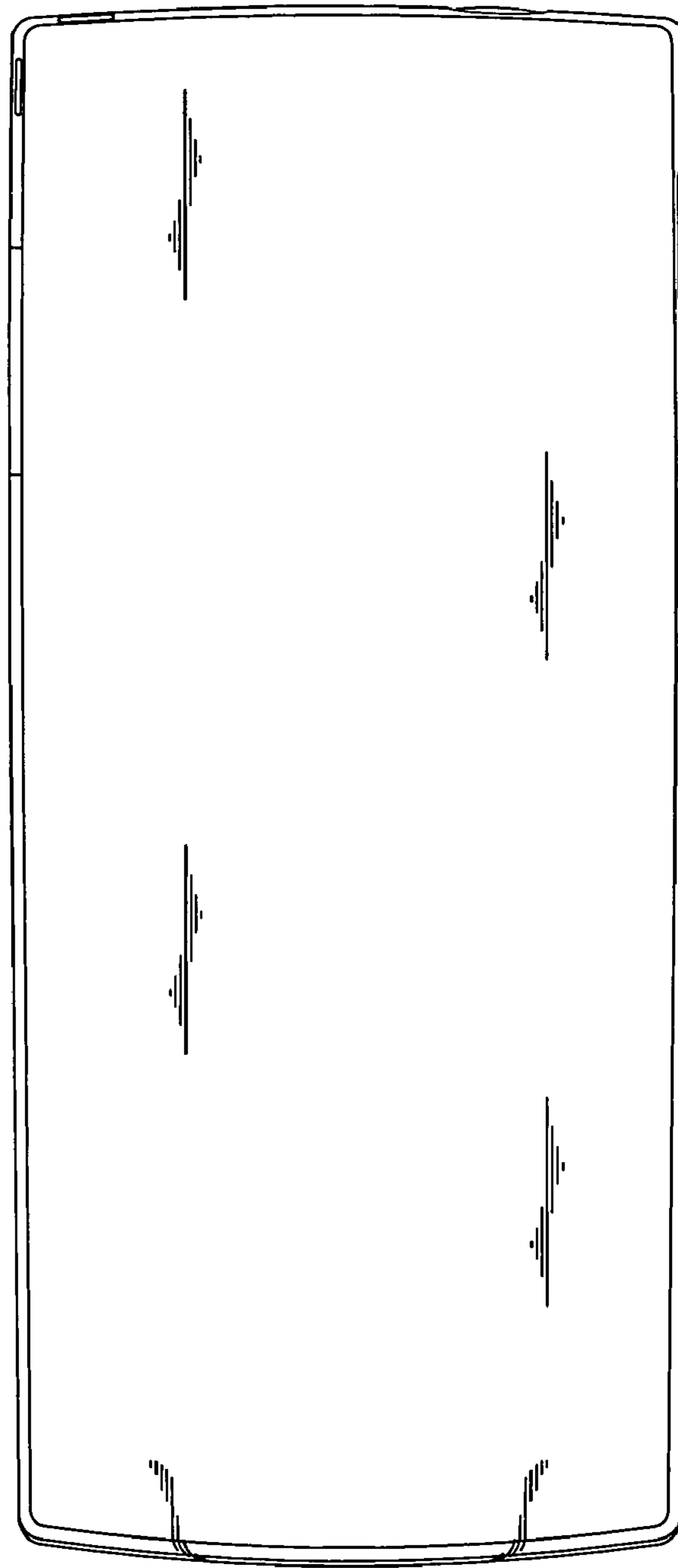

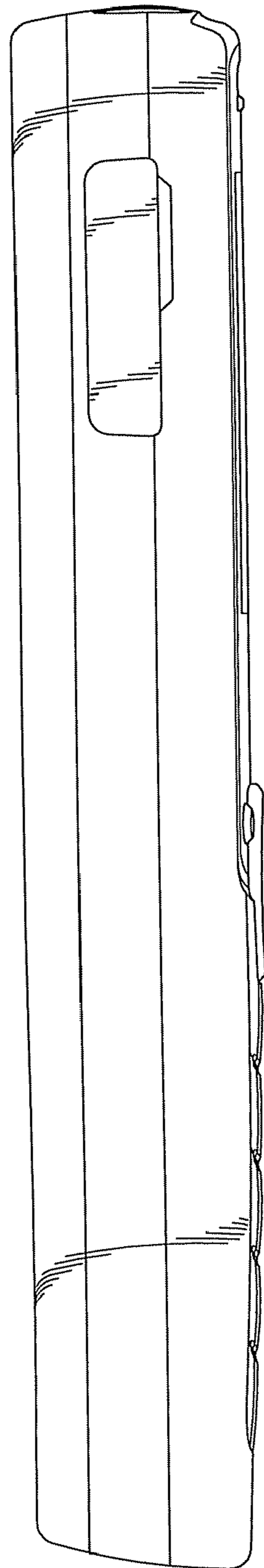

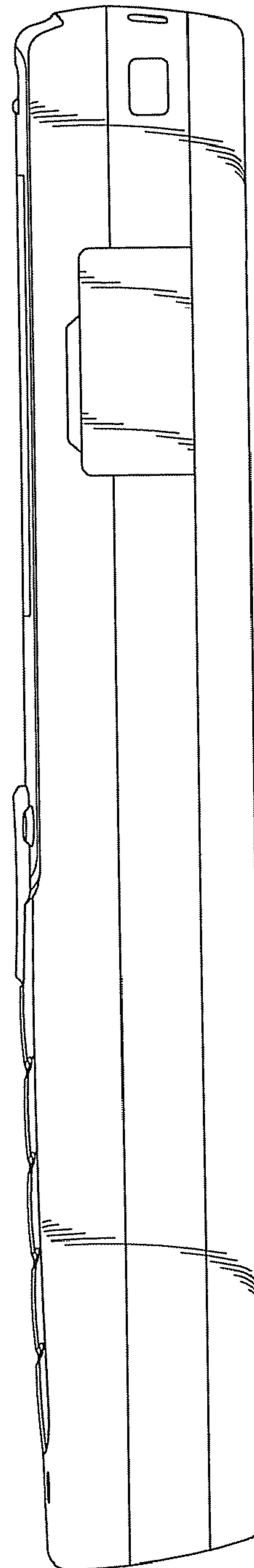

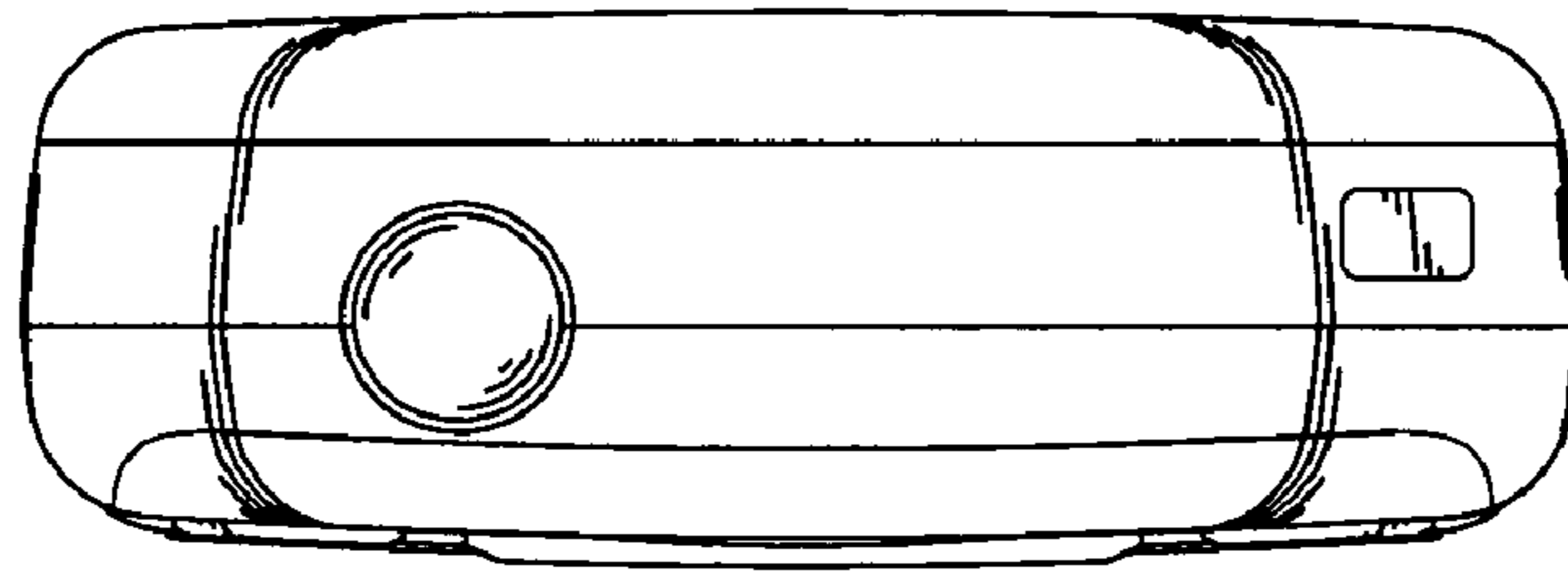
