DESCRIPTION

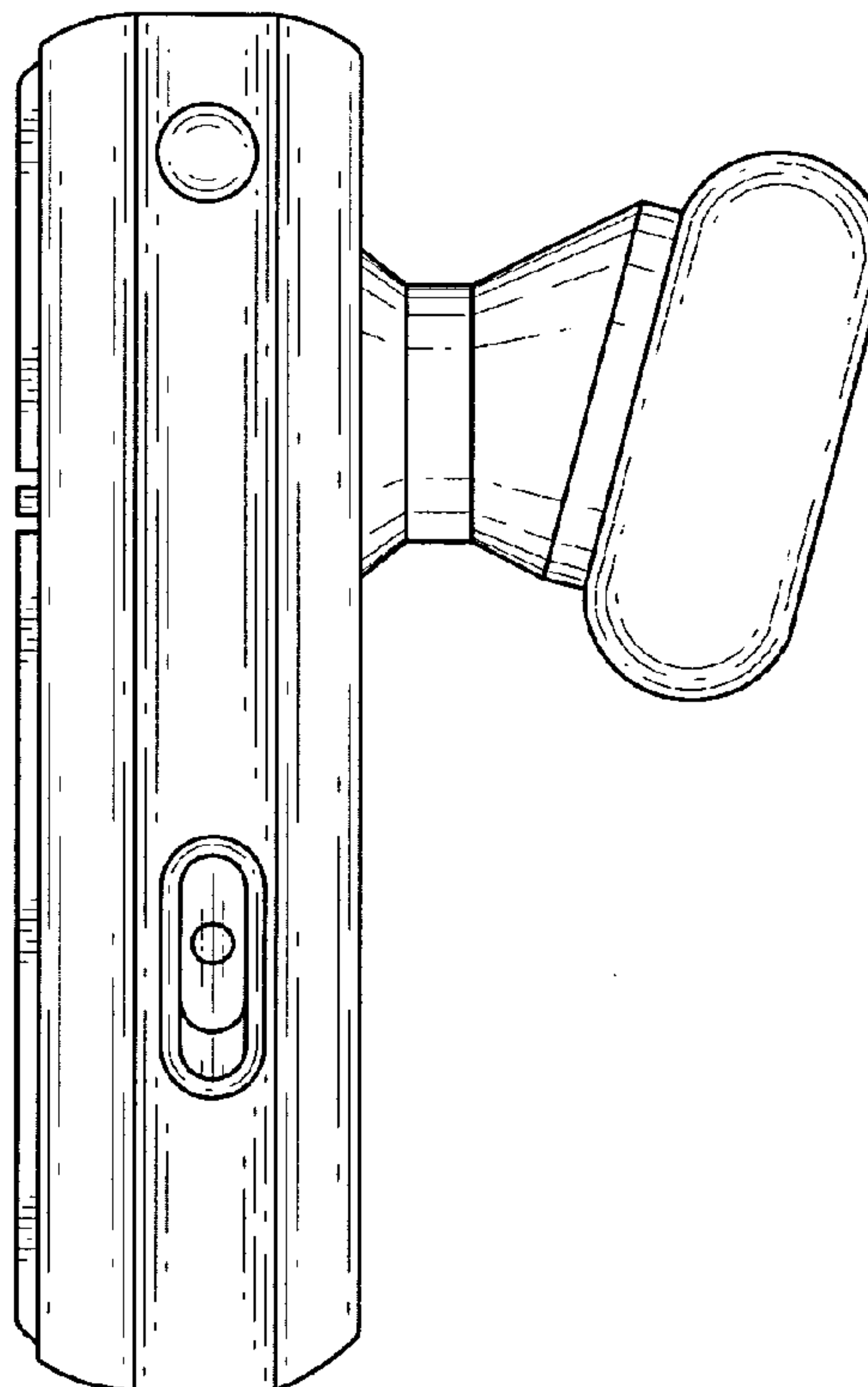
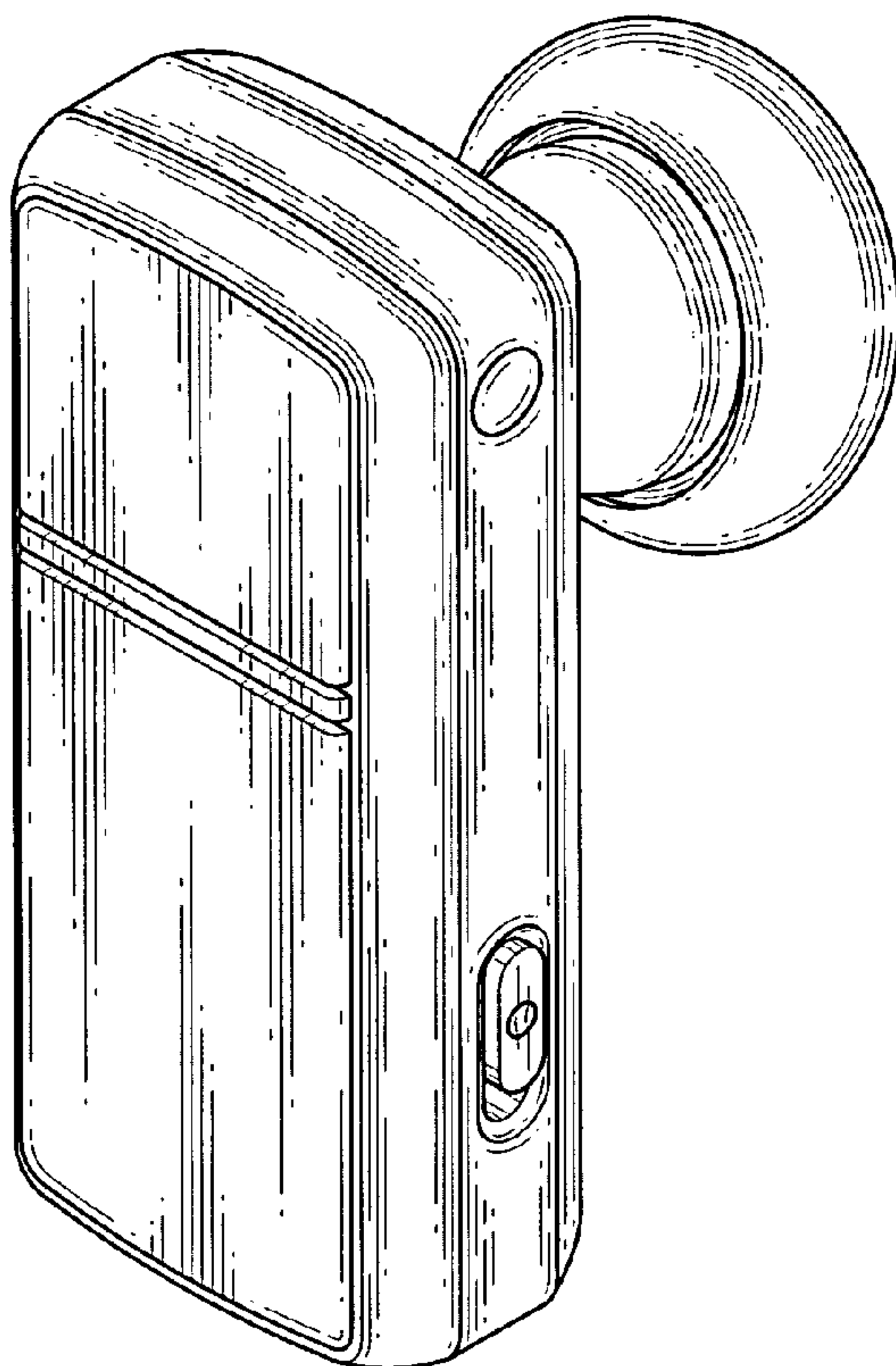

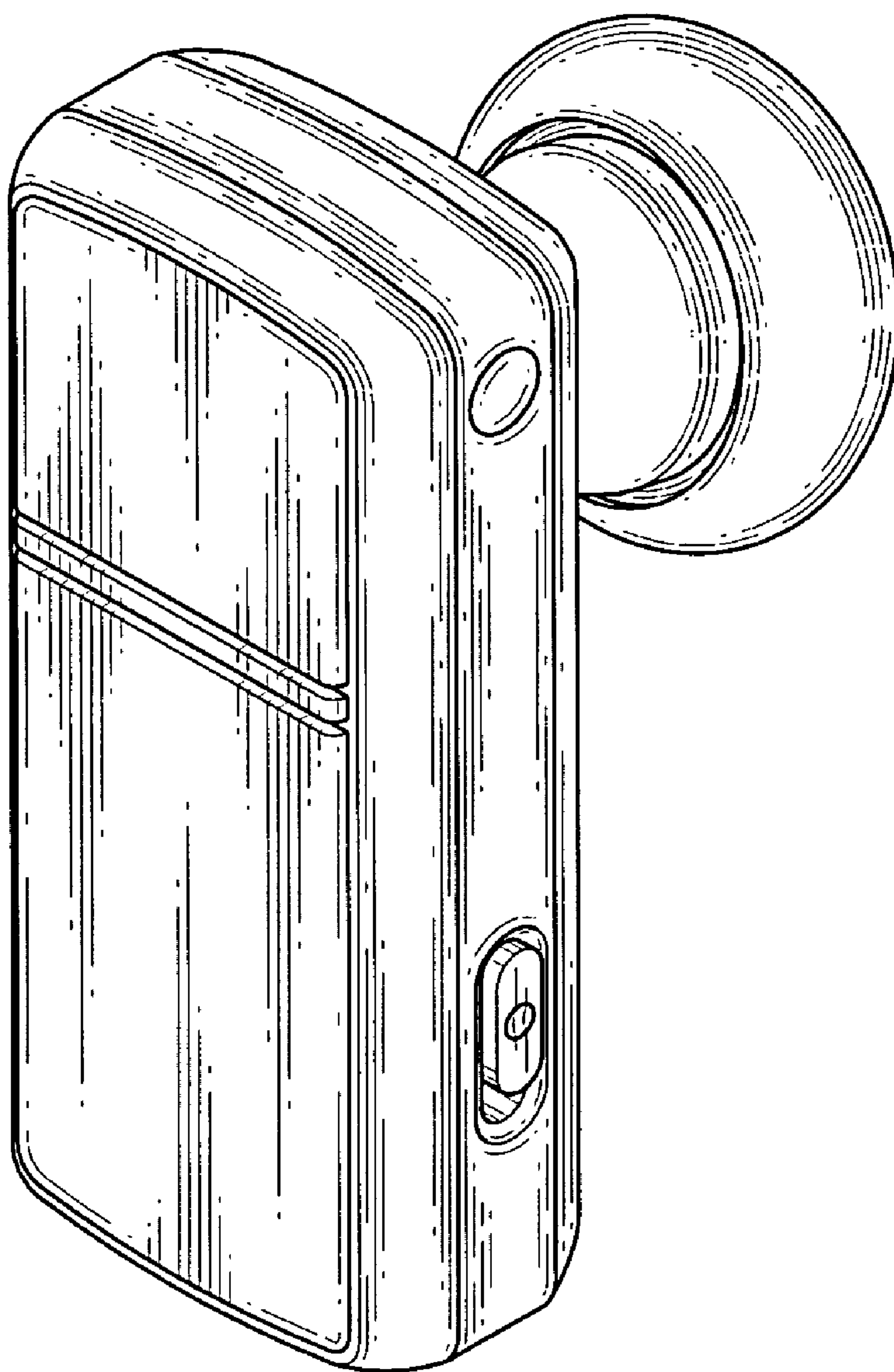

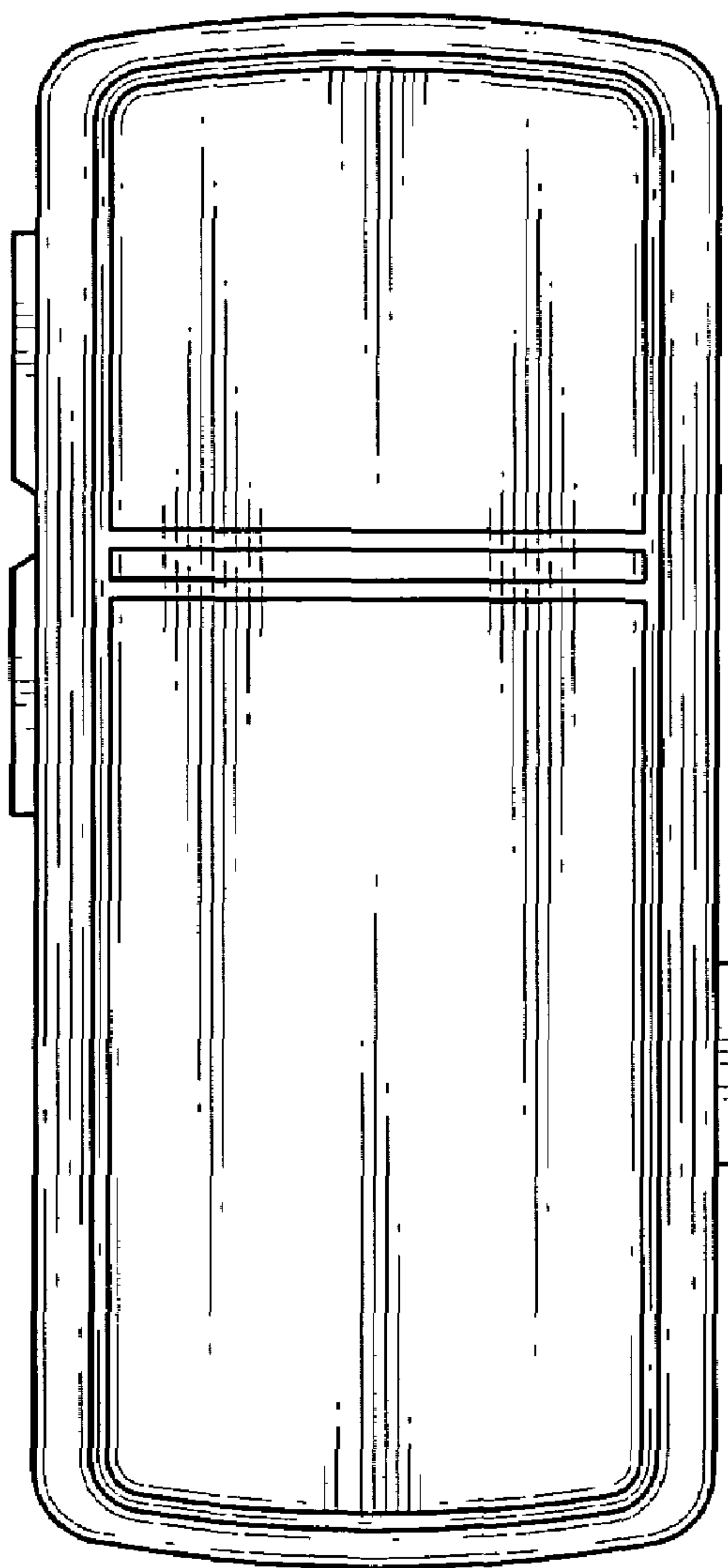

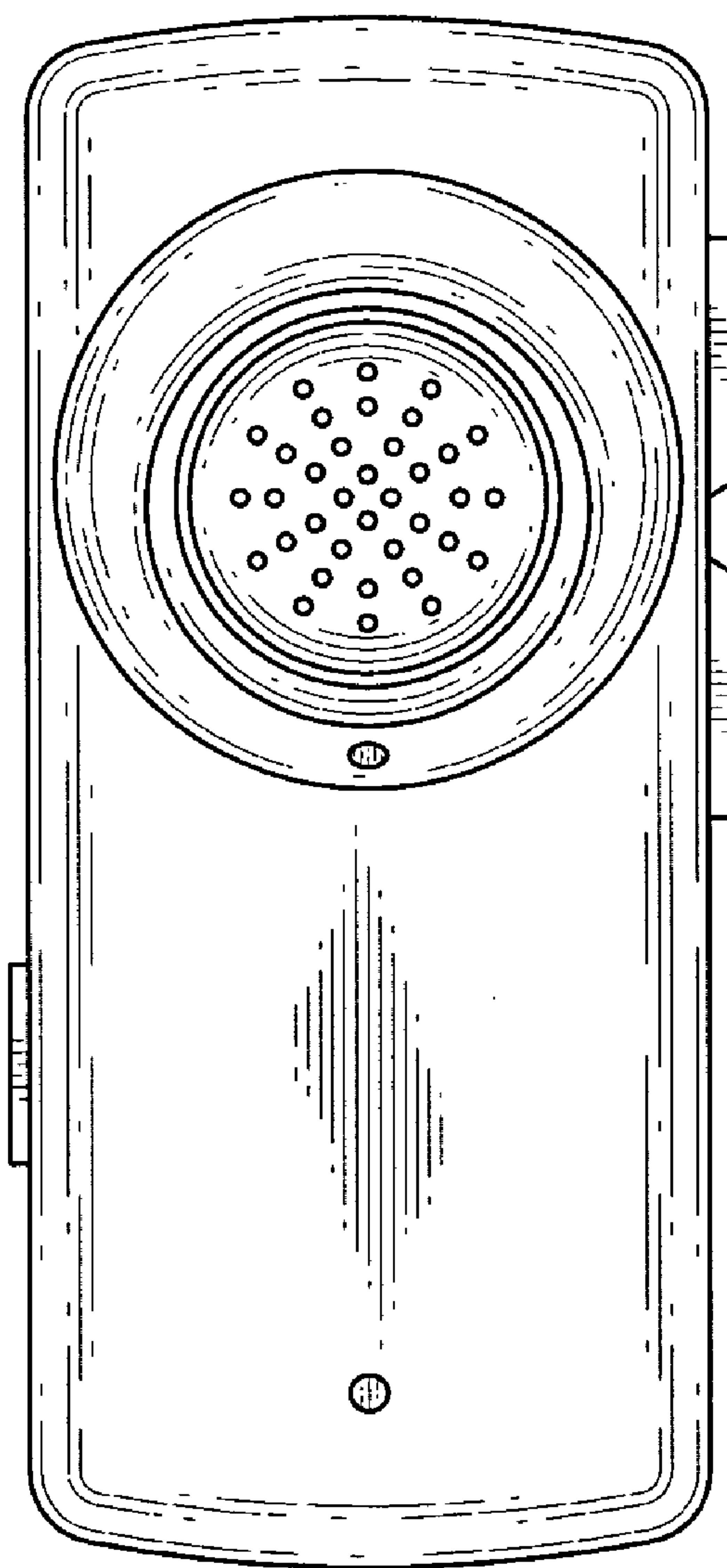

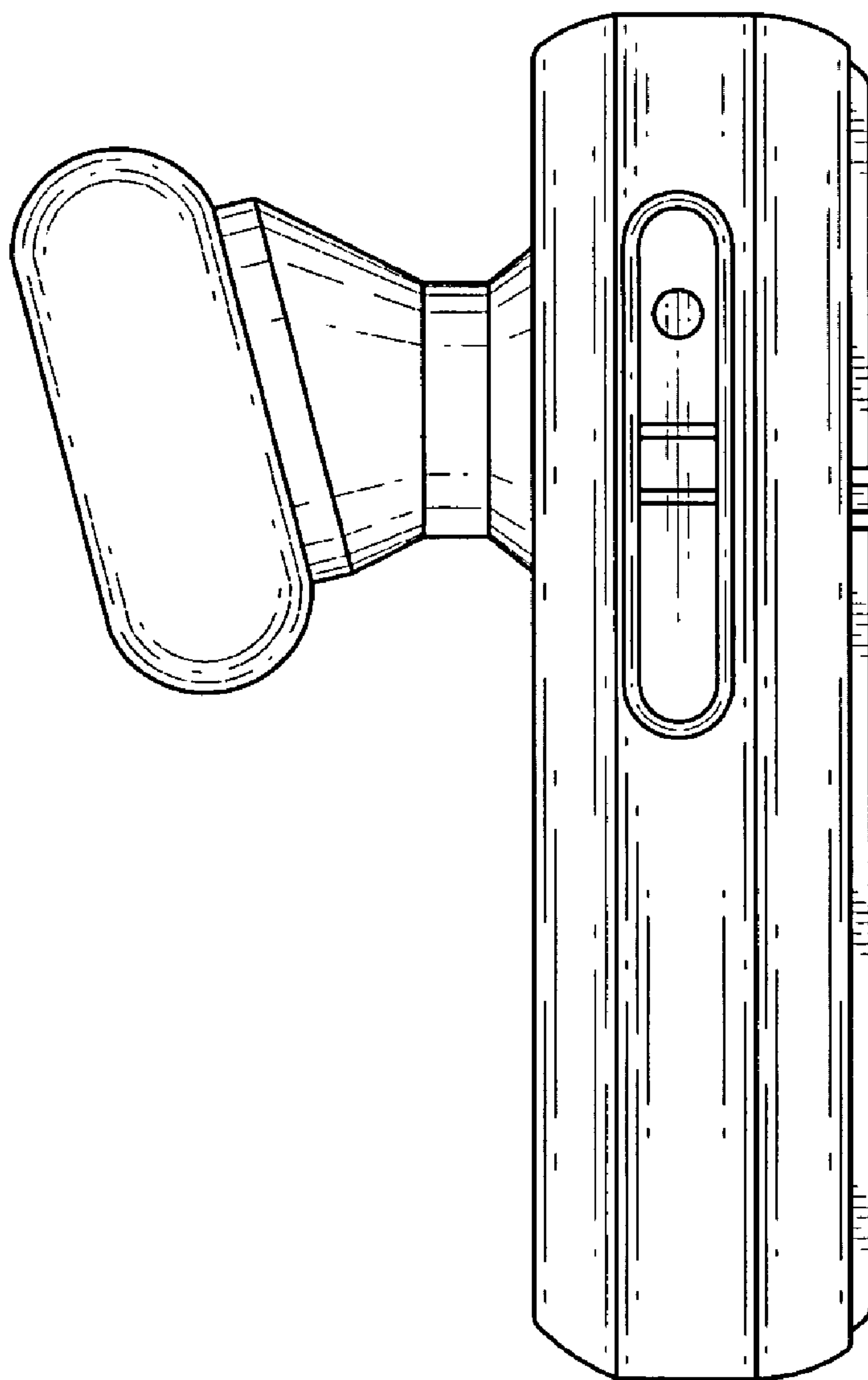

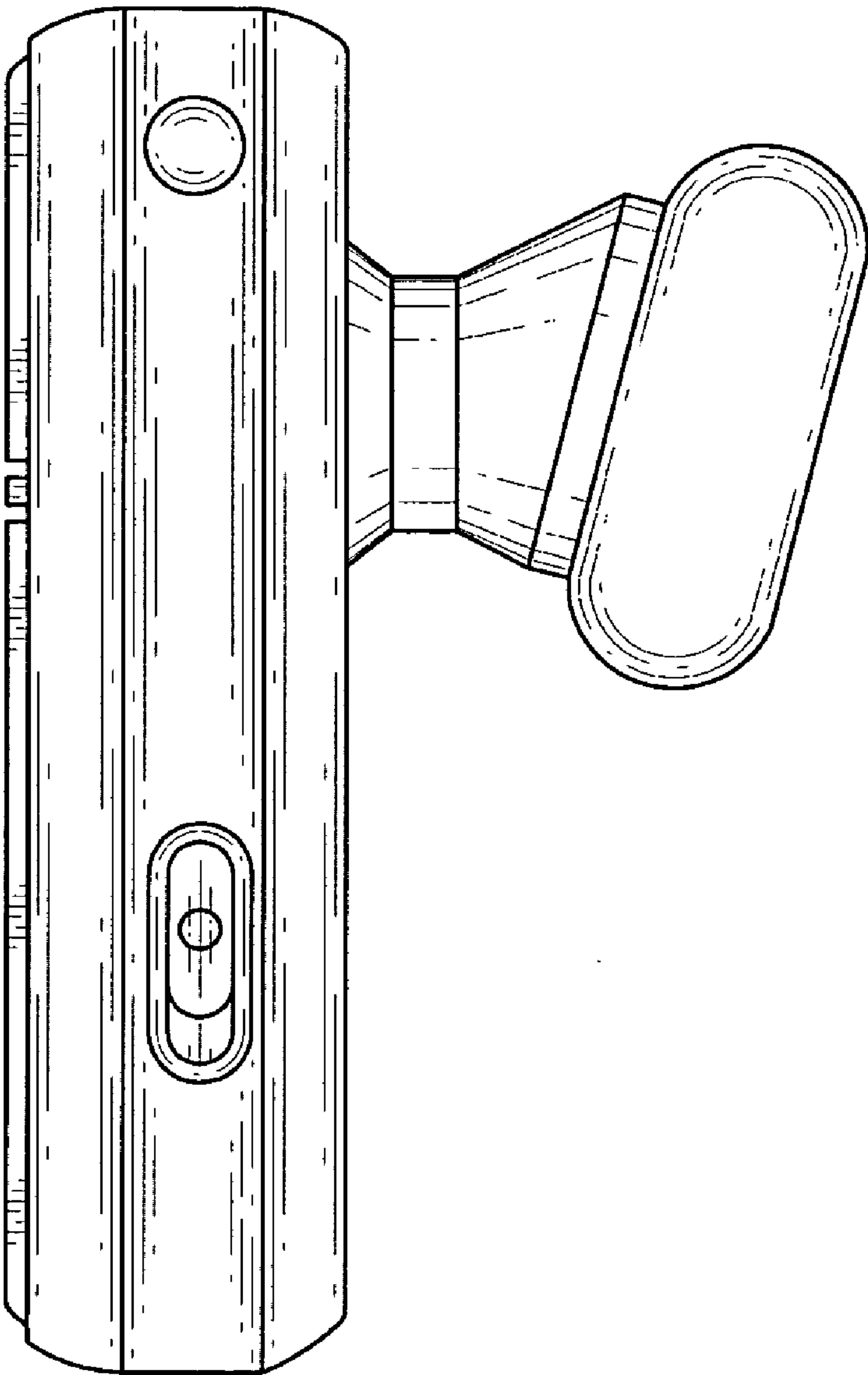

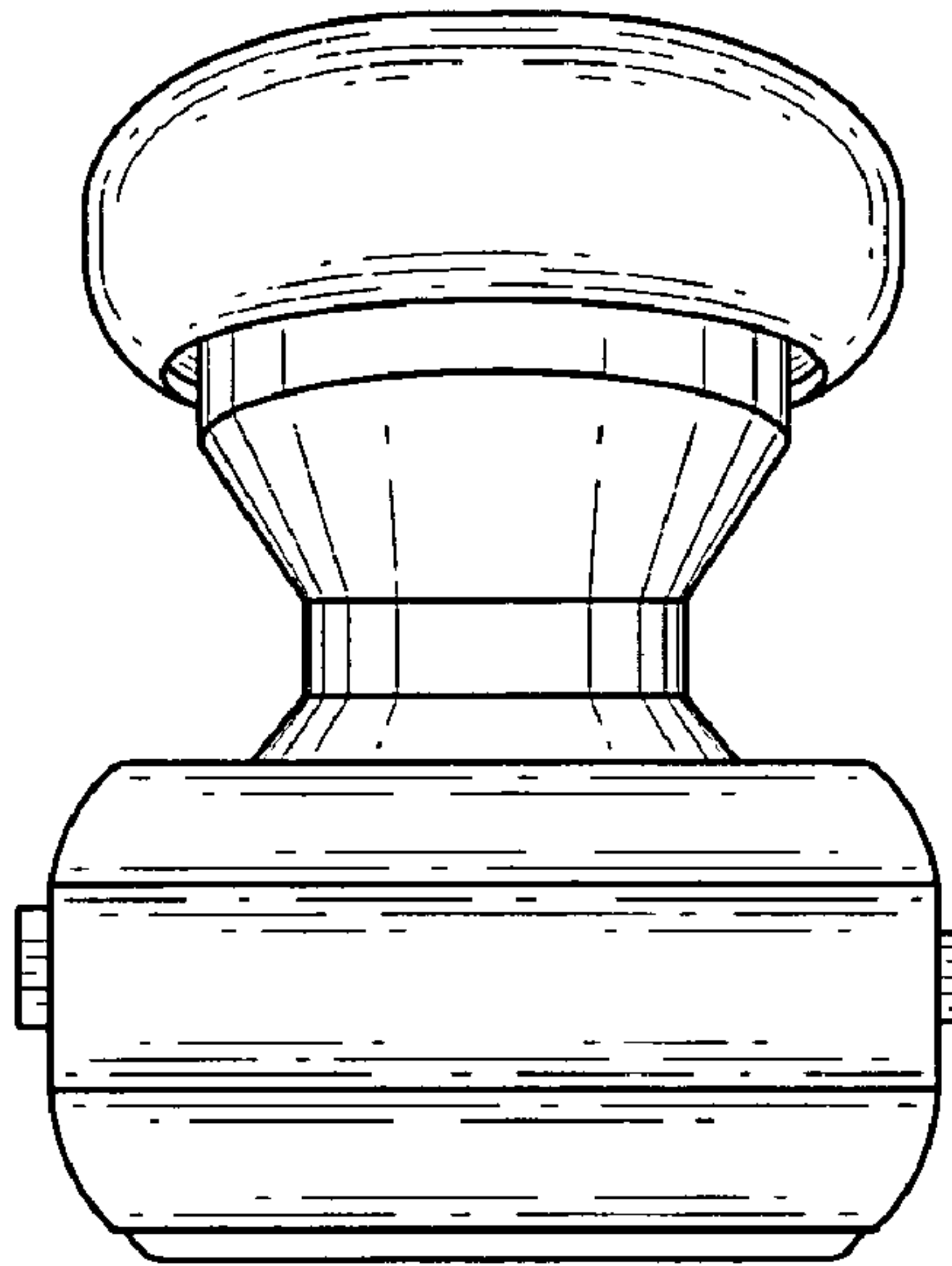
