(57) **CLAIM**

The ornamental design of a hub for an electromagnetic coupling for motor vehicles, as shown.

DESCRIPTION

FIG. 1 is a top view of a hub for an electromagnetic coupling for motor vehicles.

FIG. 2 is an enlarged top view of the hub illustrated in FIG. 1; and,

FIG. 3 is a perspective view of the first embodiment illustrated in FIG. 1.

The broken lines in the drawings show the environment of the invention and form no part of the claimed design.

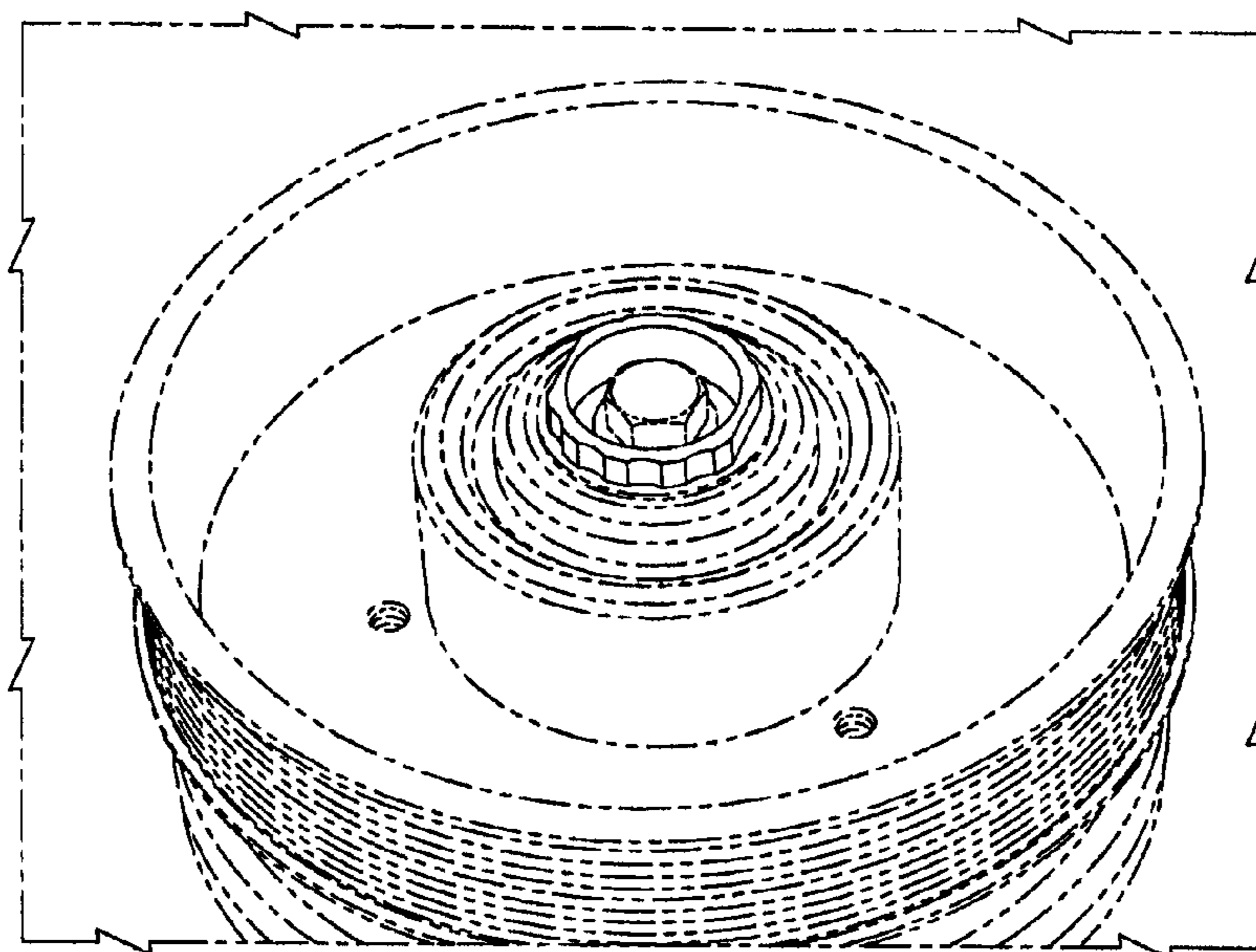

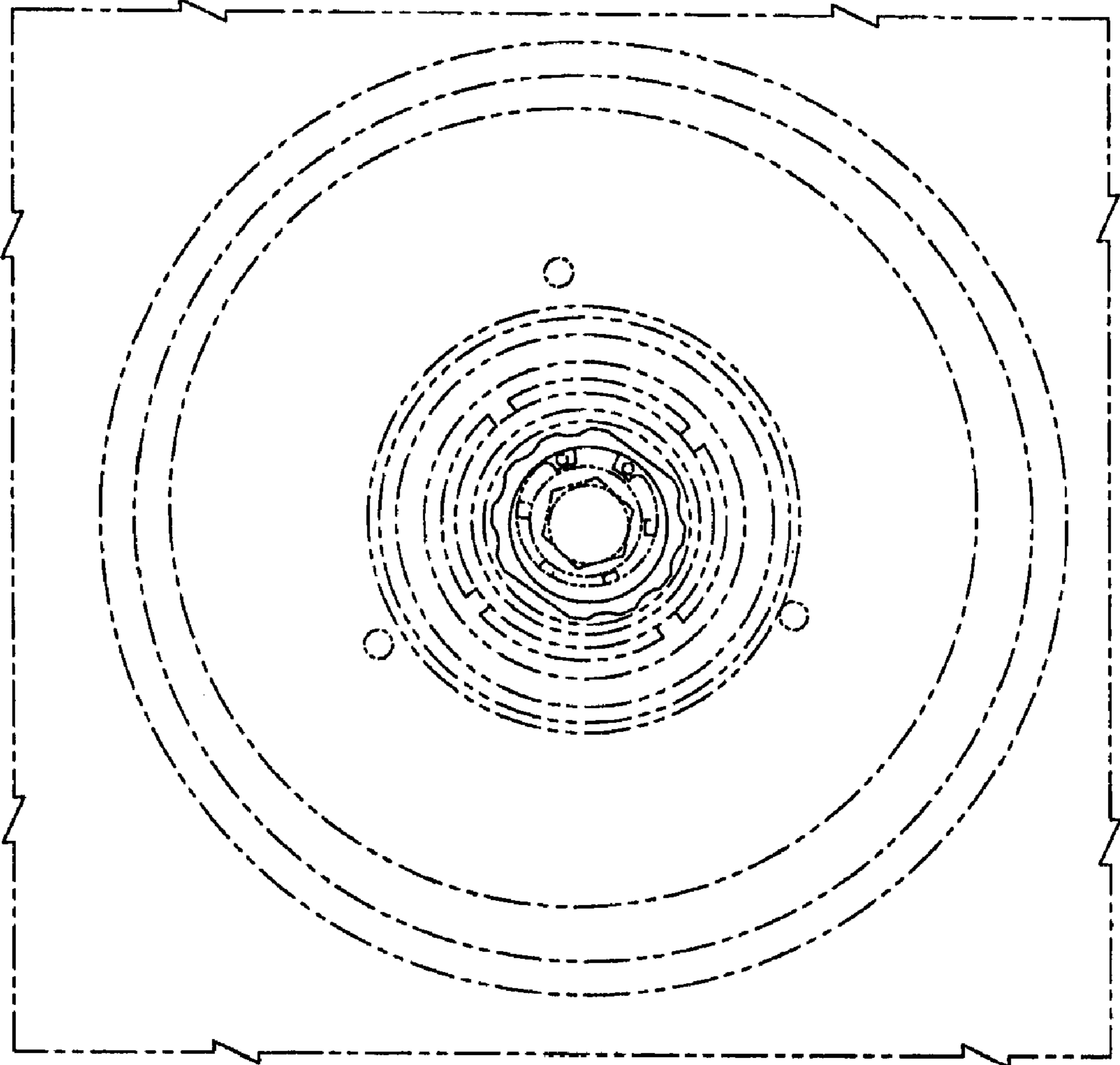

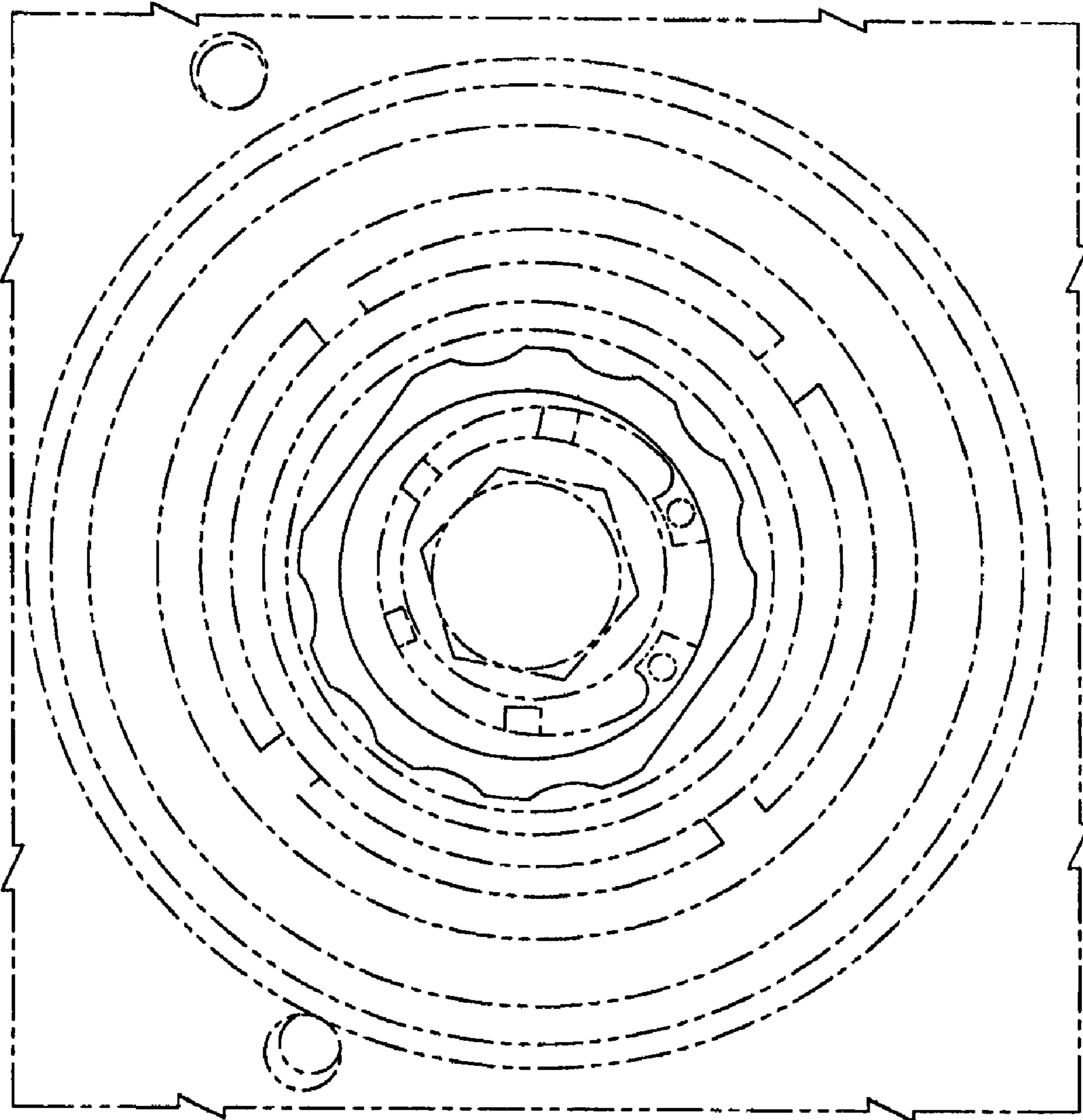
