The ornamental design for a tractor, as shown and described.

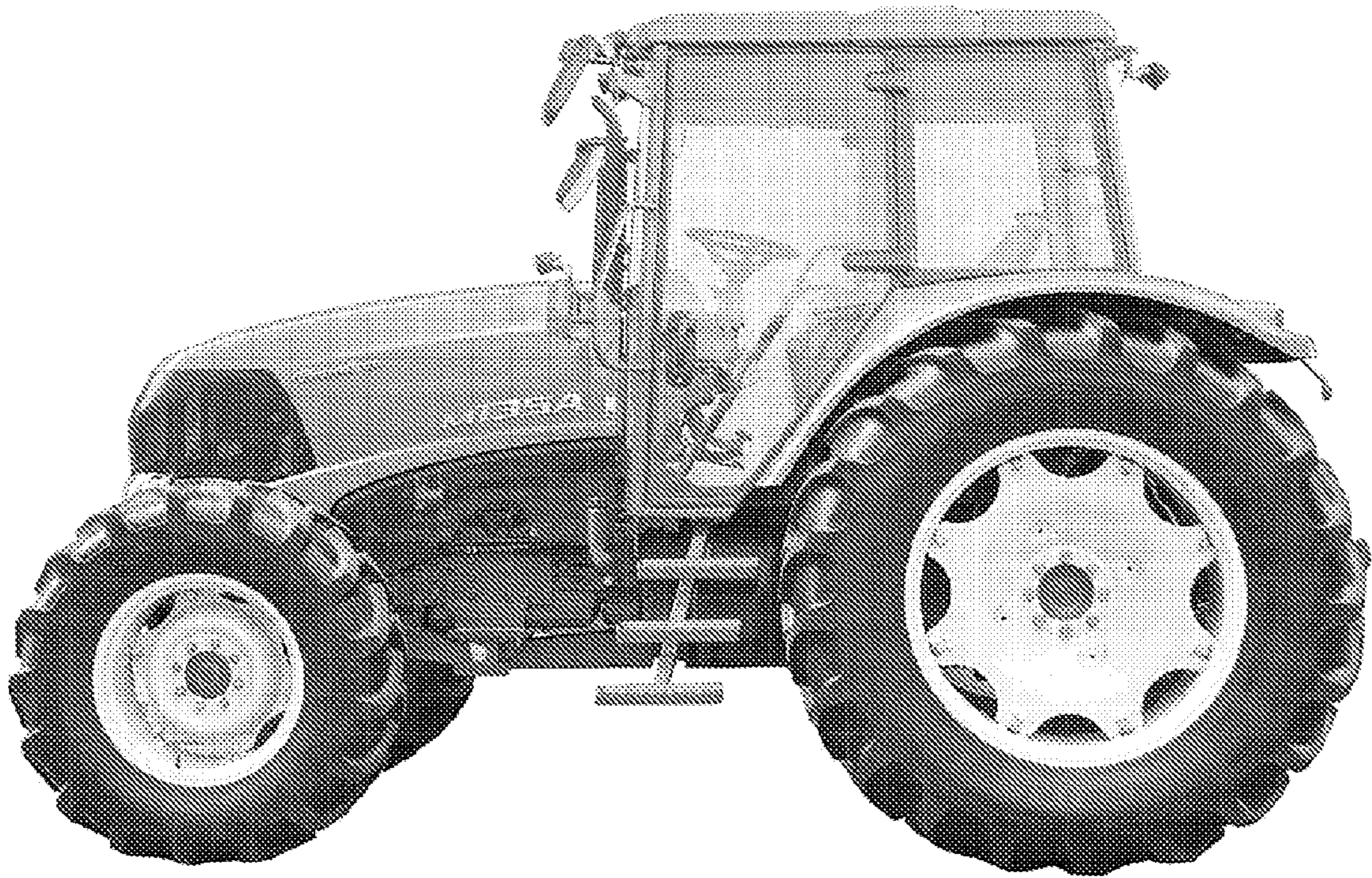
DESCRIPTION

FIG. 8 is a left rear perspective view thereof.

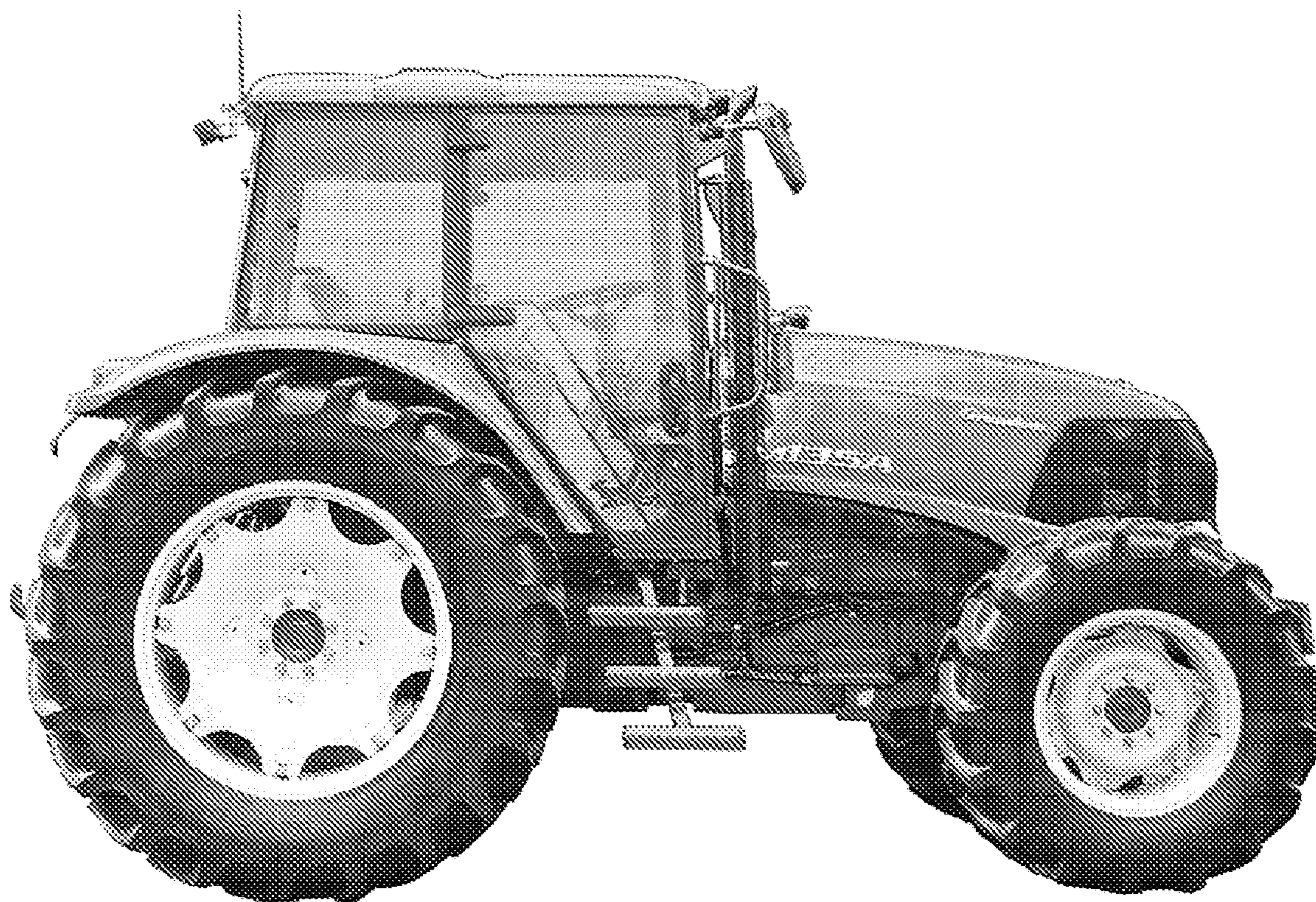

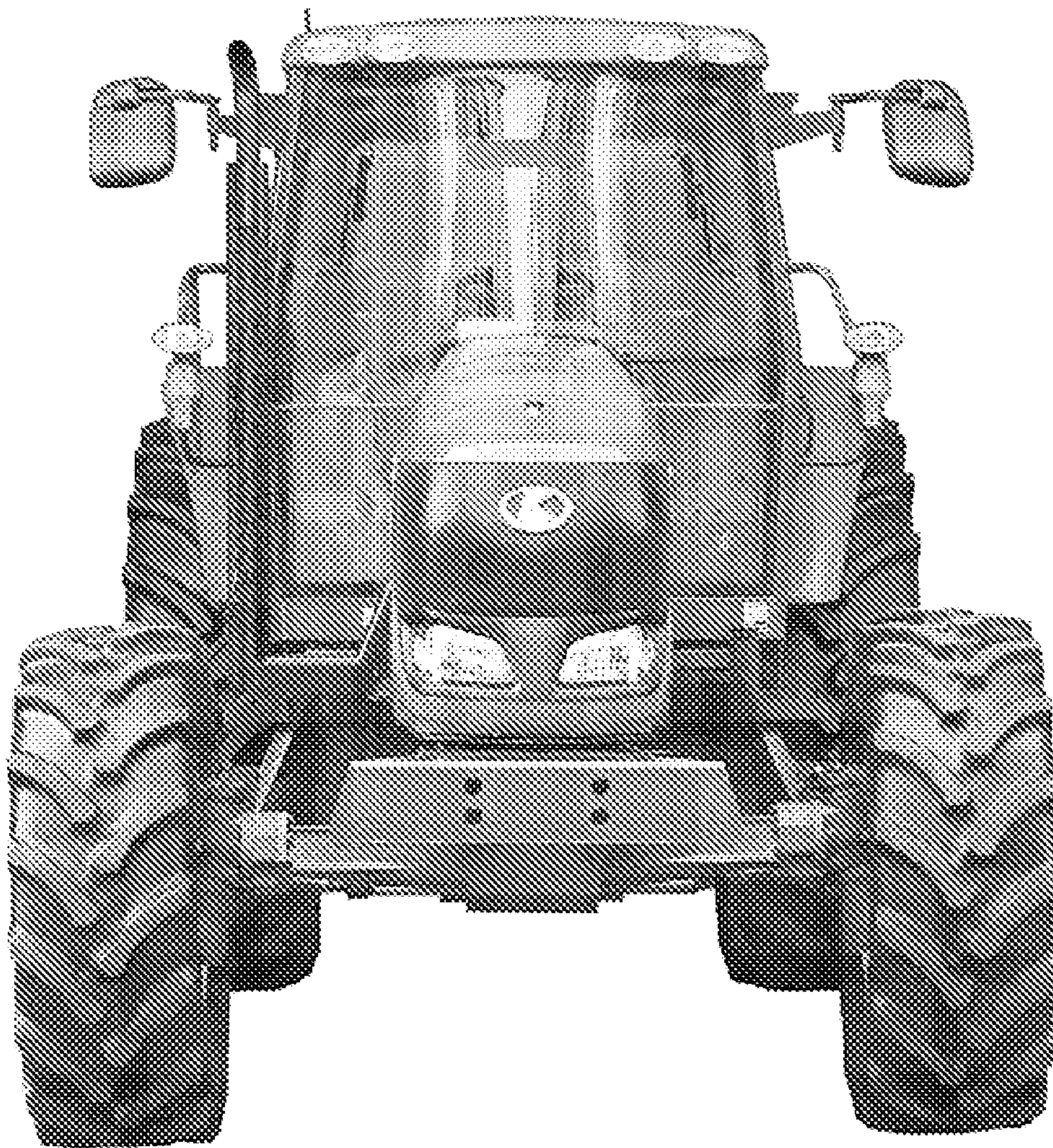
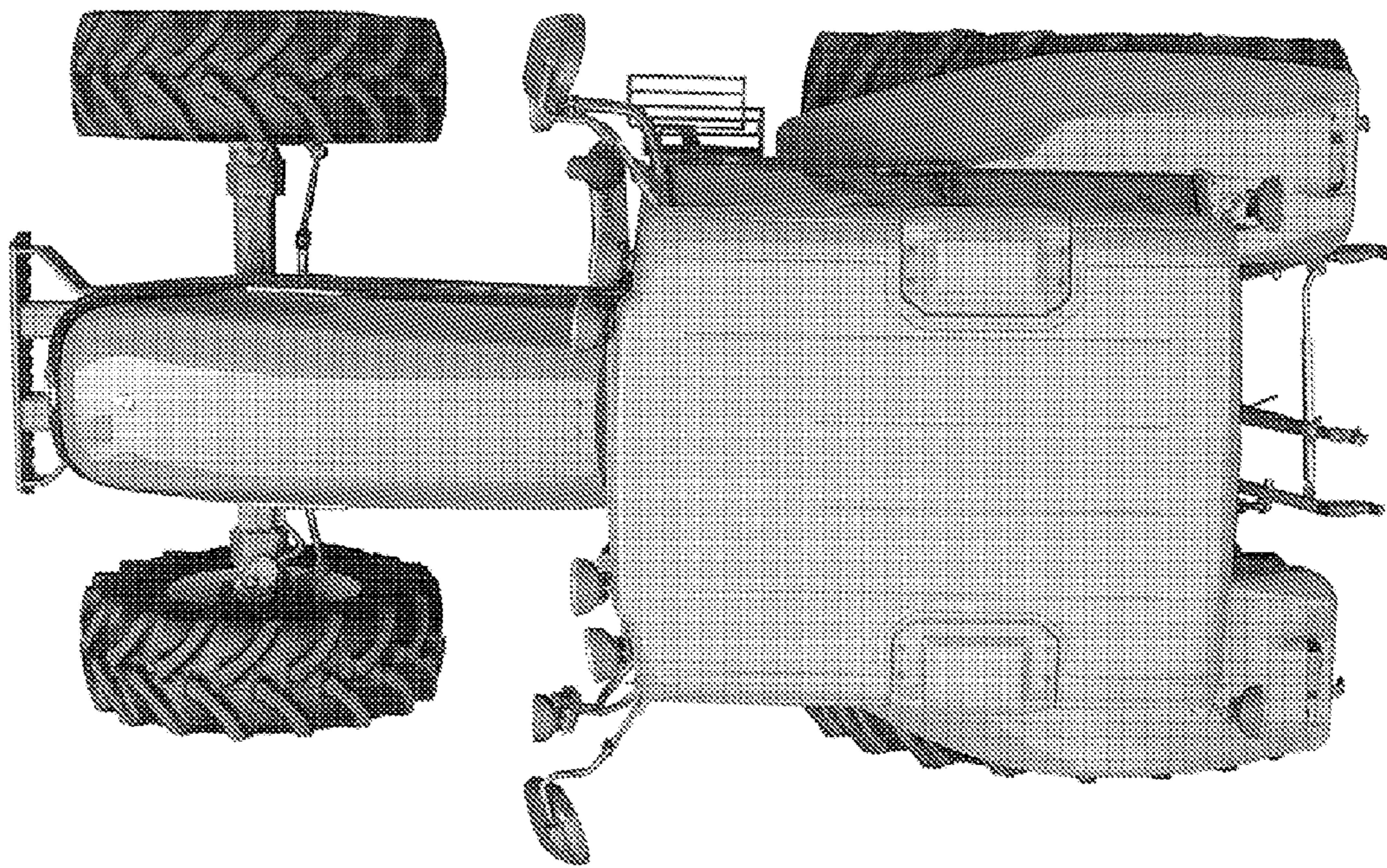
