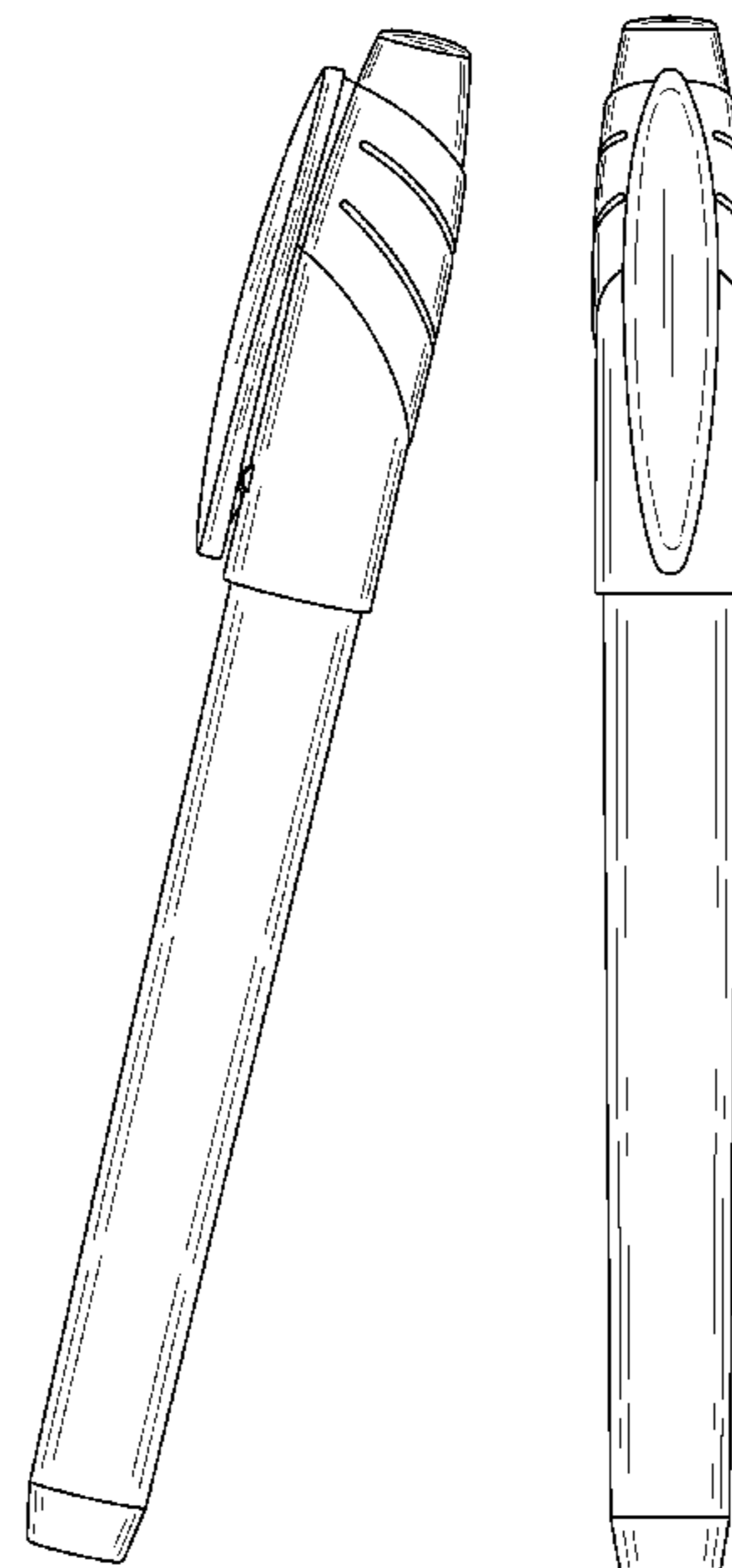

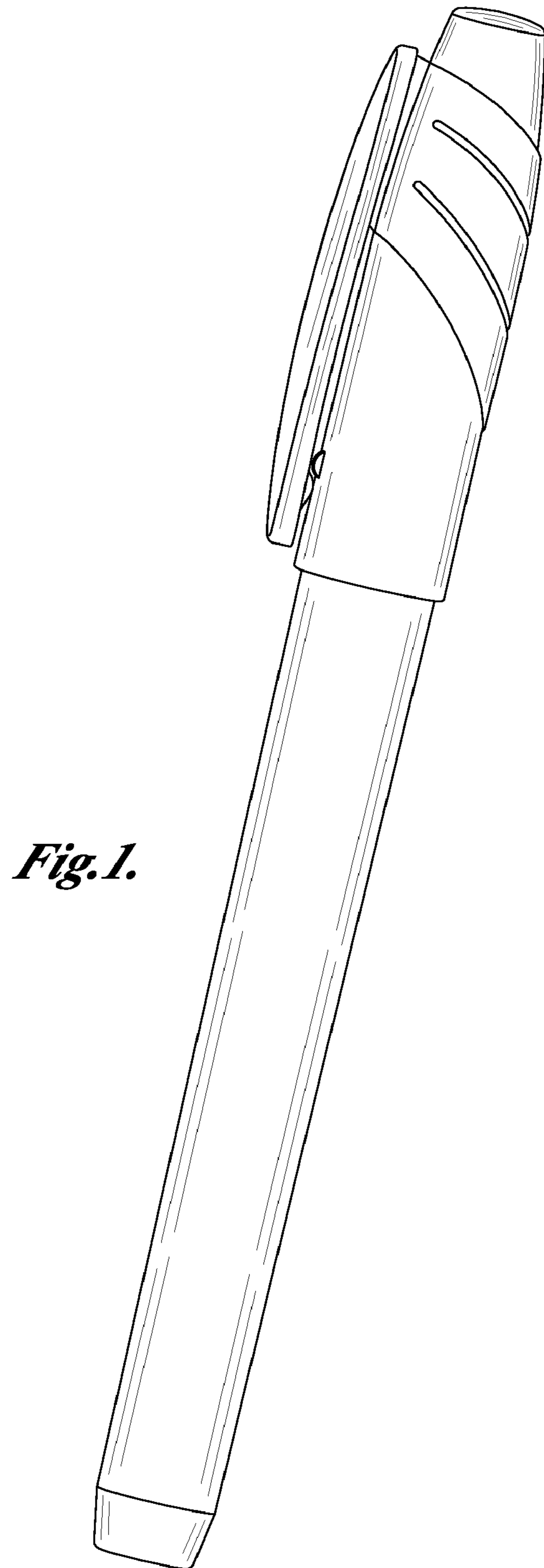
The ornamental design for a pen, as shown and described.

**DESCRIPTION**

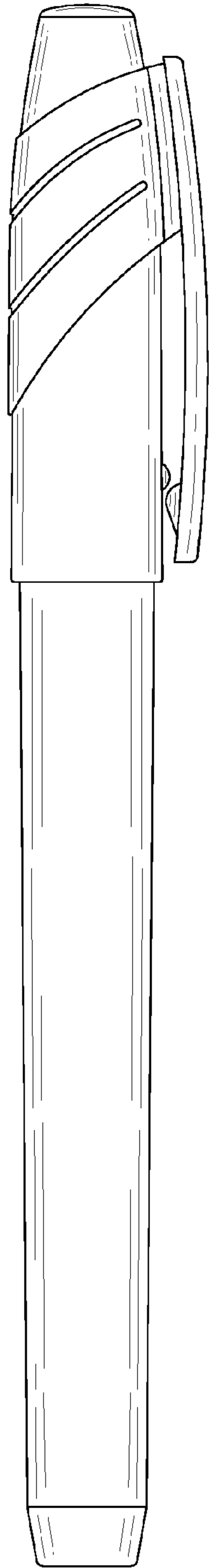
FIG. 1 is an upper right perspective view of a pen showing my new design;

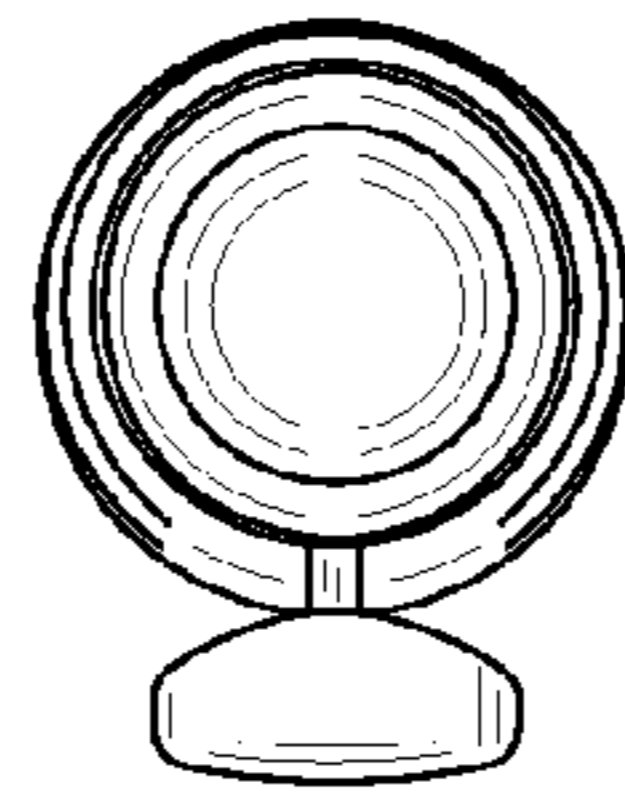




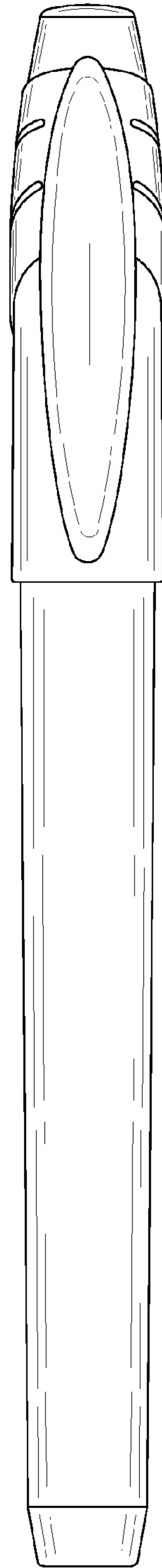

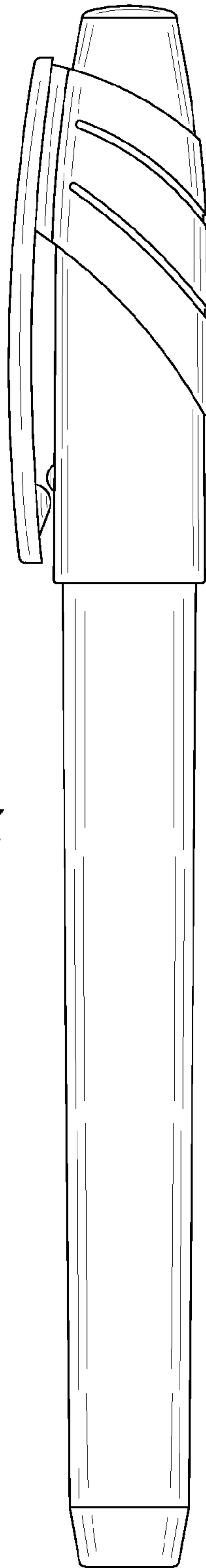

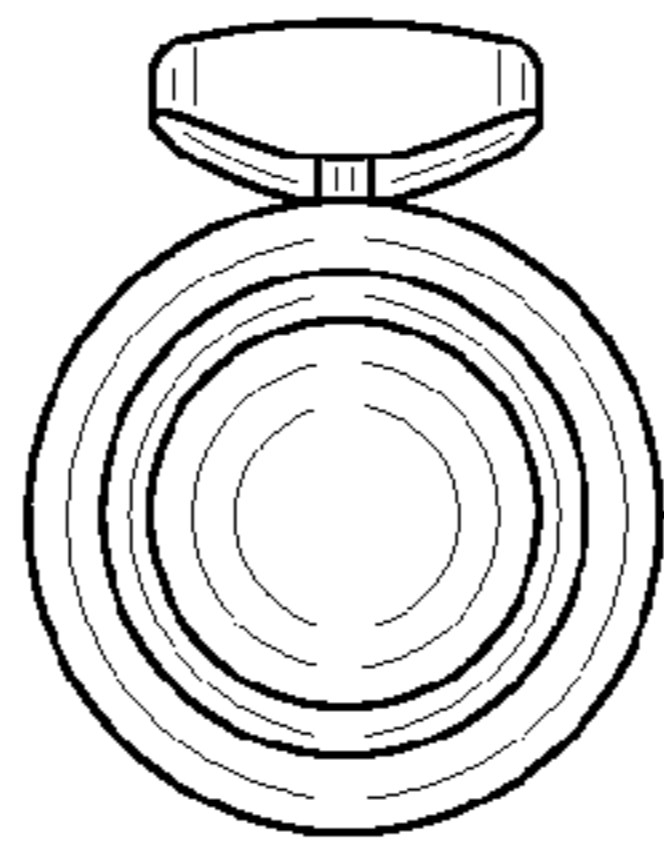

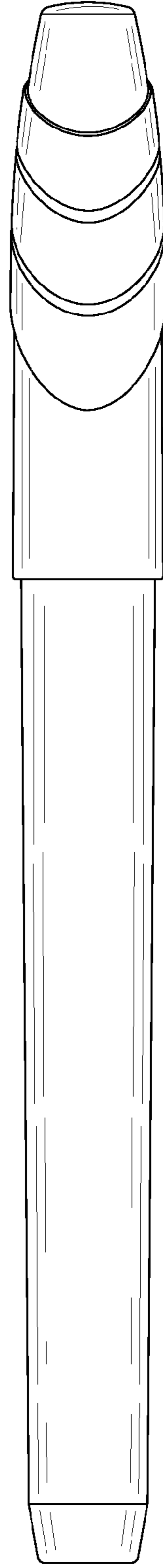
