The ornamental design for a hand held game controller, as shown and described.

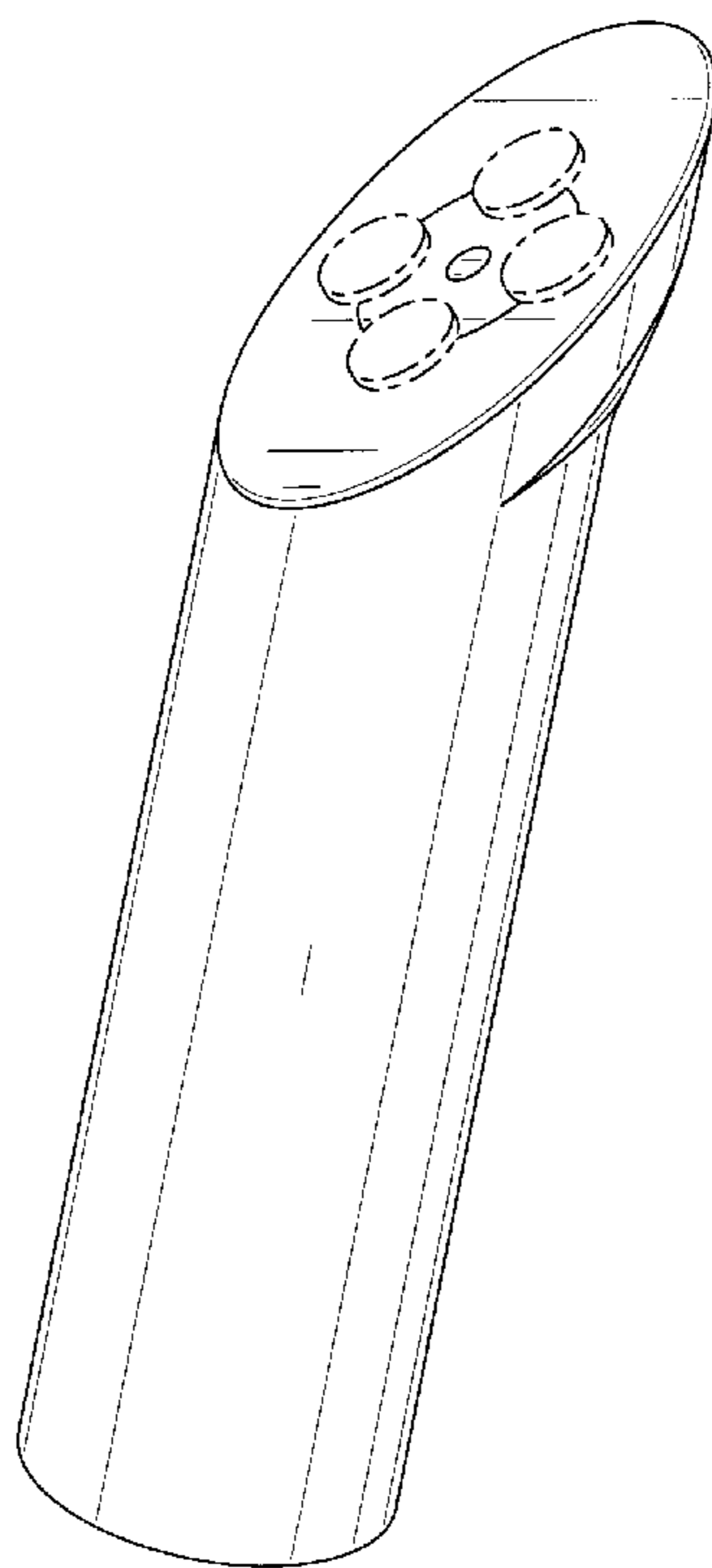
**DESCRIPTION**

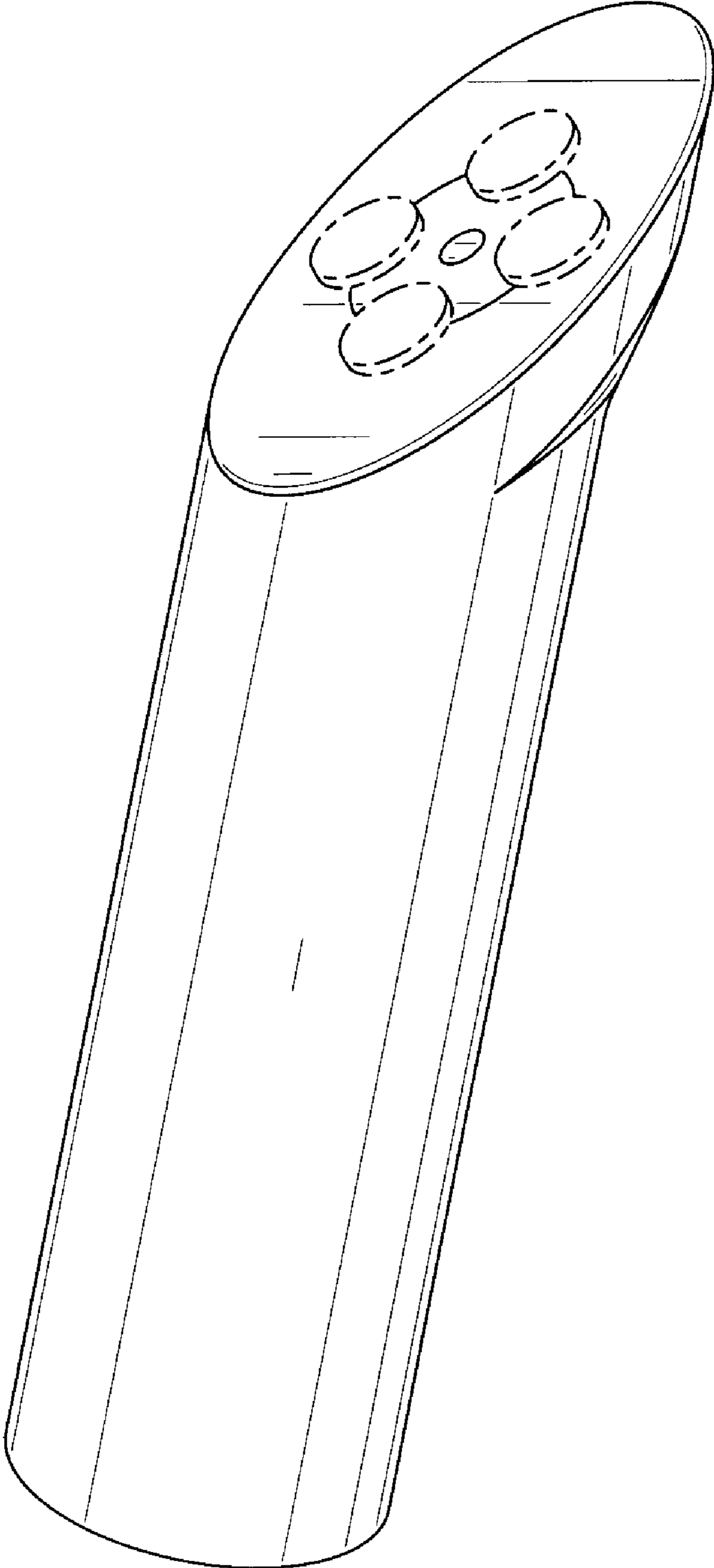

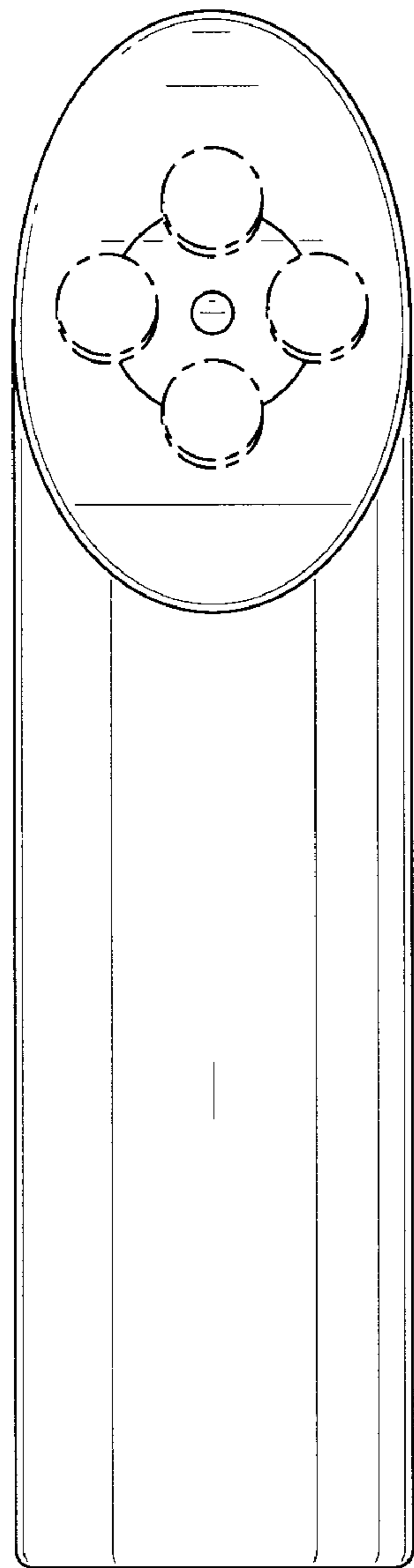

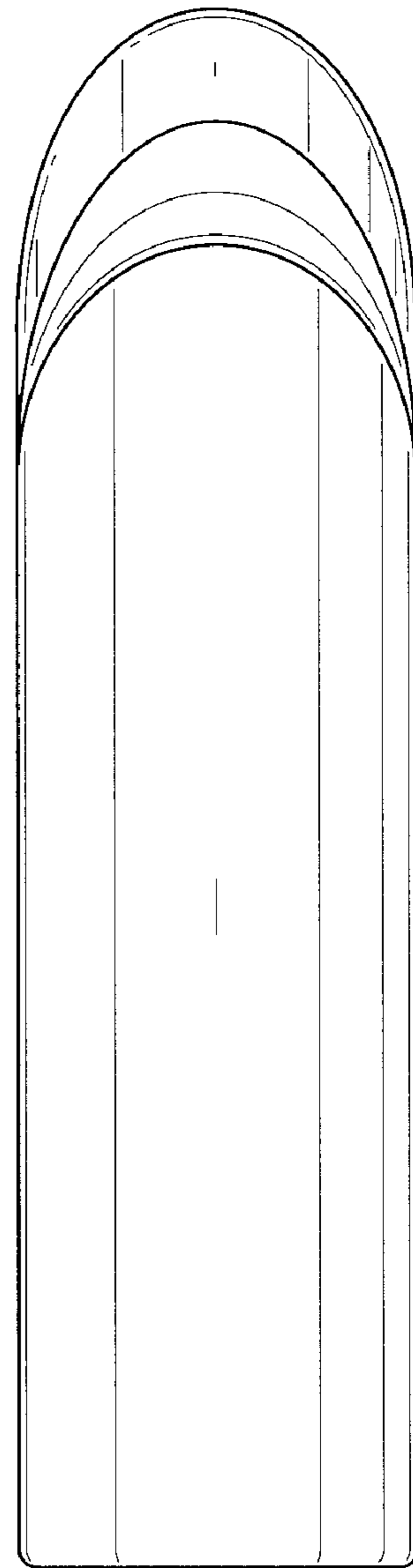

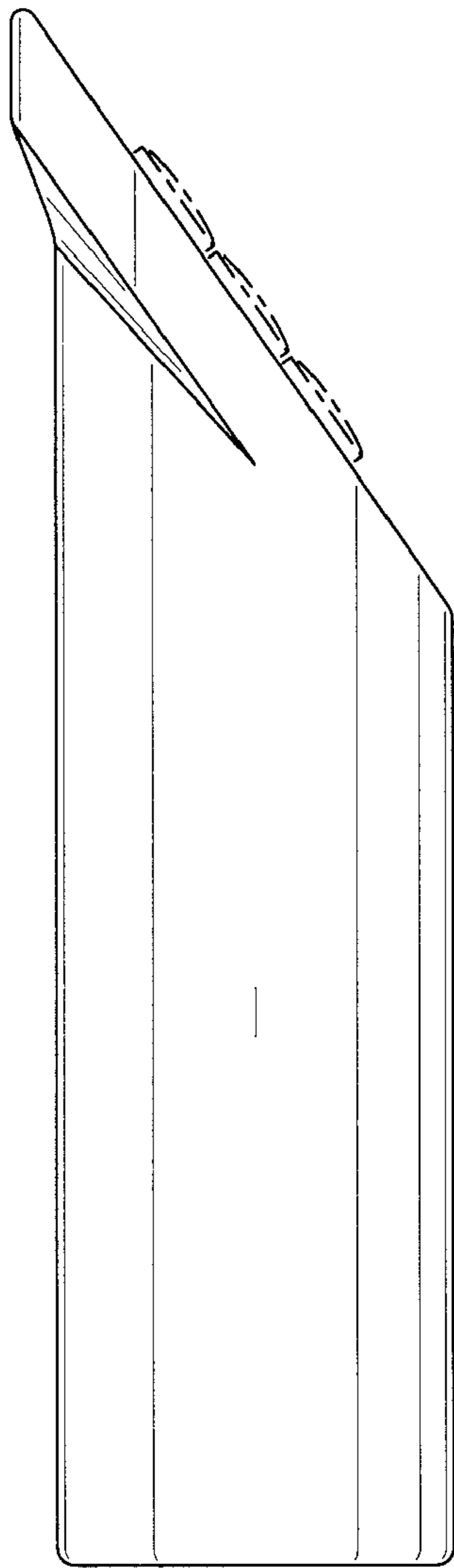

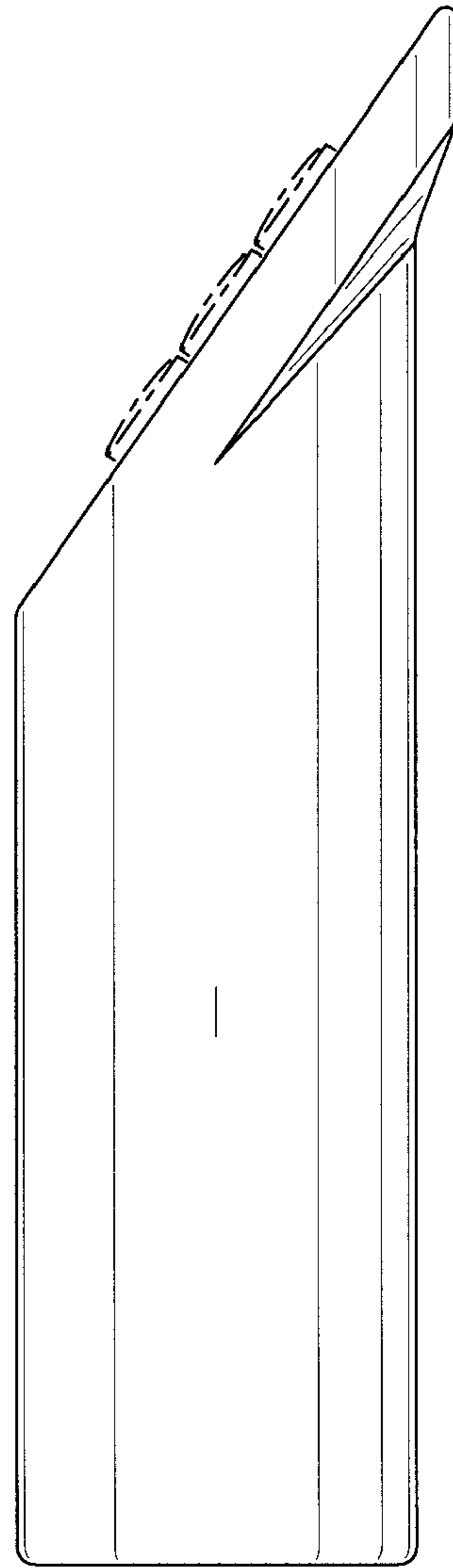

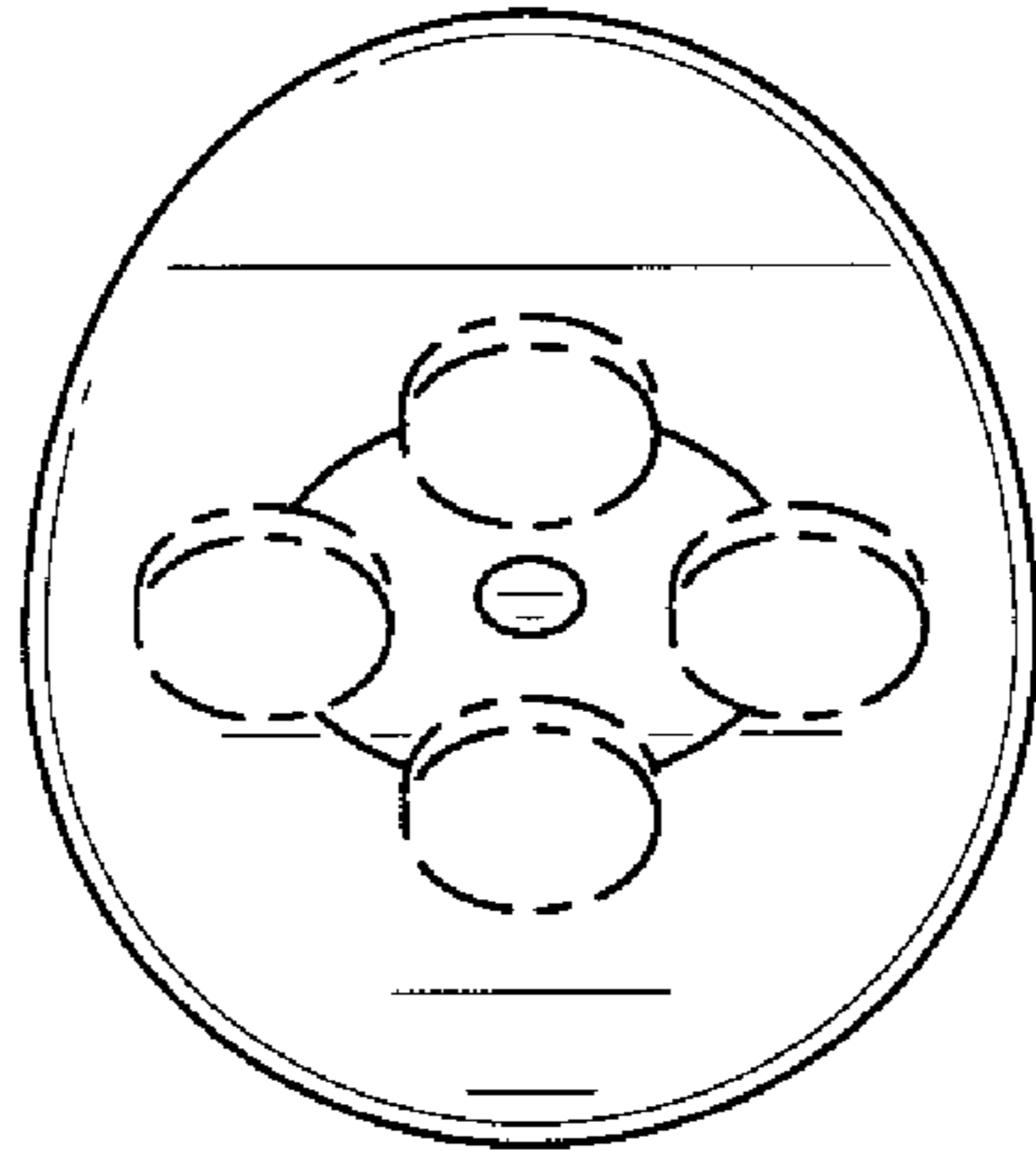

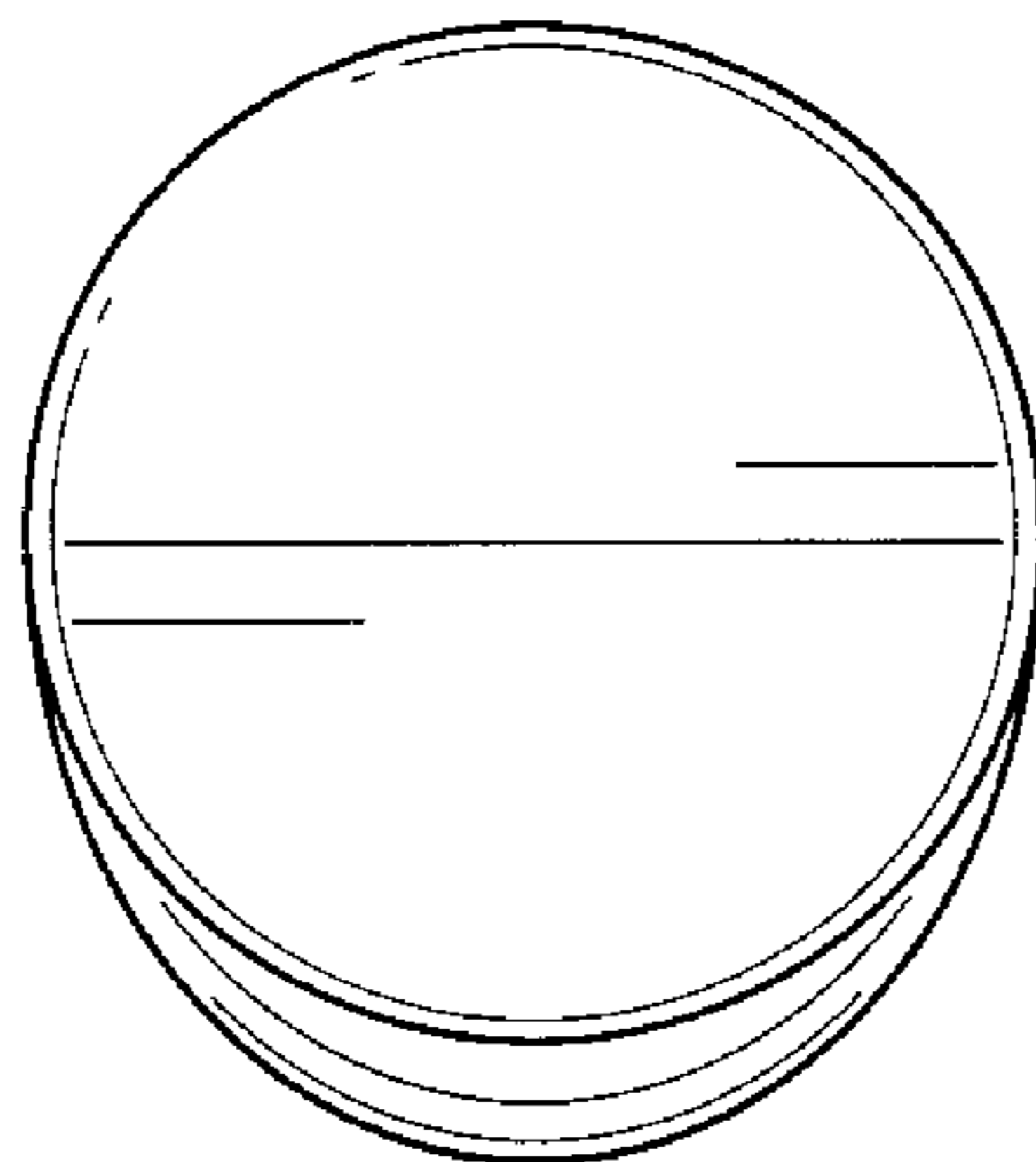

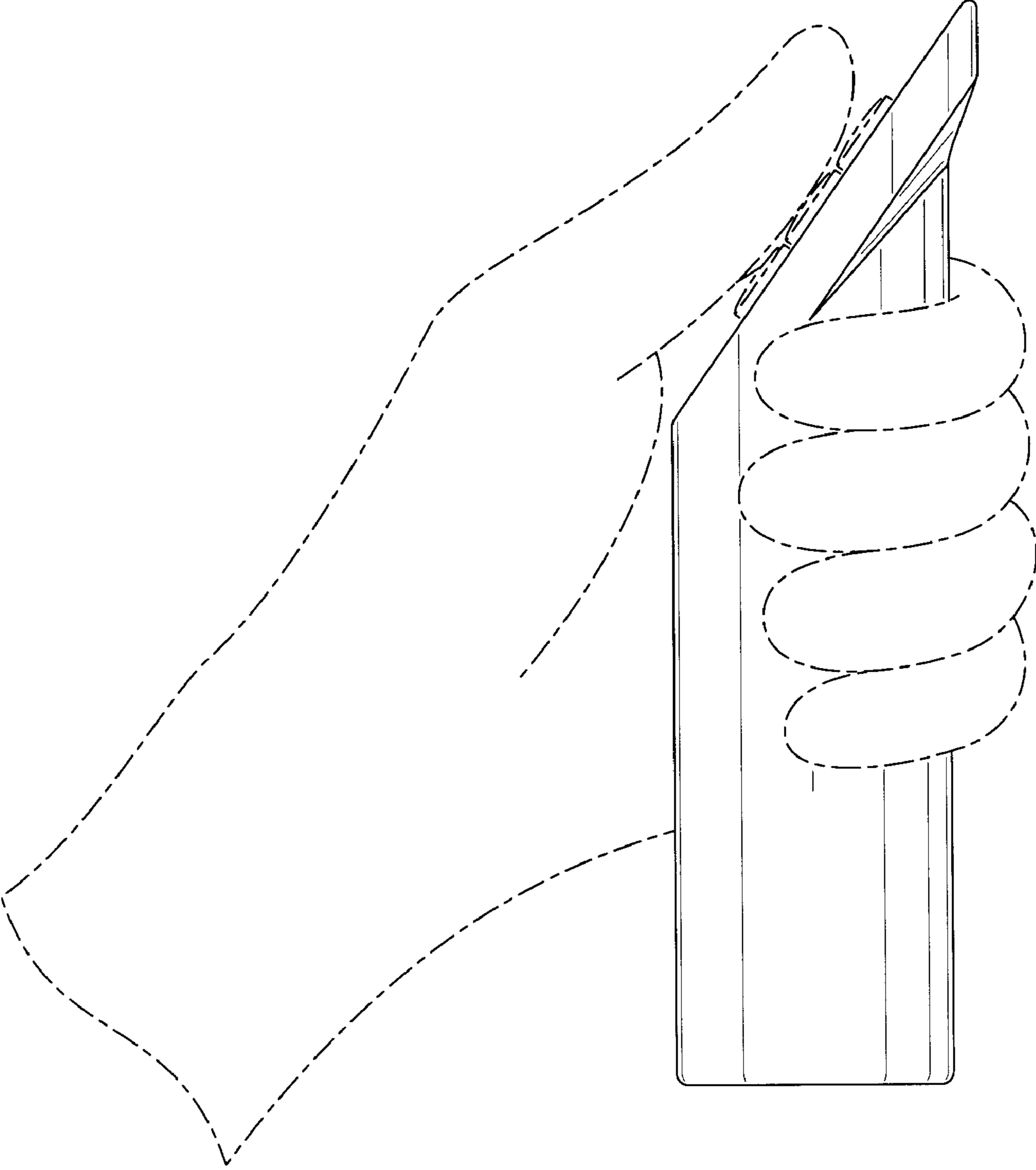
