The ornamental design of a sprayer tank with holster for tools or accessories, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective, elevational view taken from the top, right side of a sprayer tank with holster for tools or accessories showing my design;

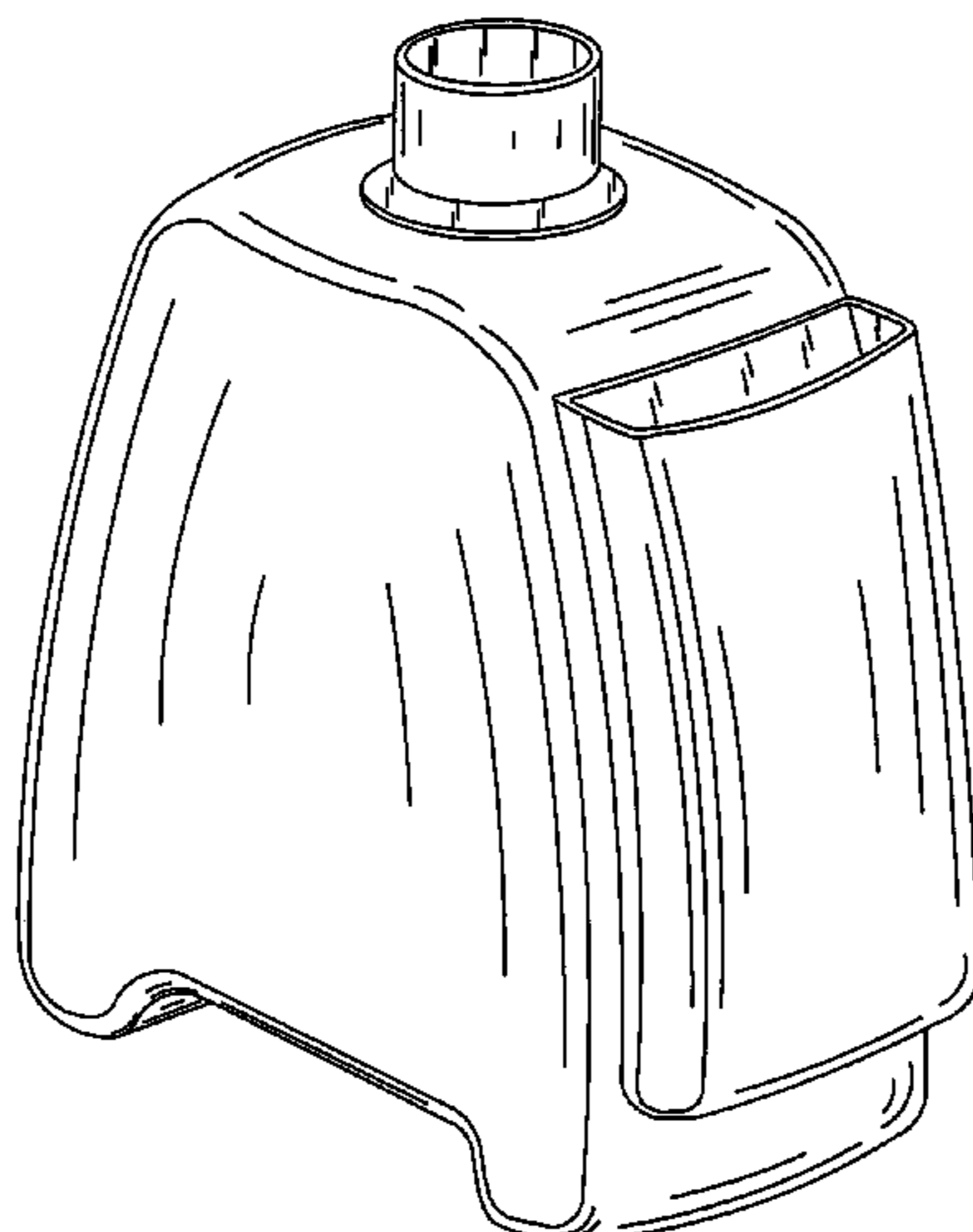
FIG. 2 is a front elevational view thereof, the rear elevational view being the same;

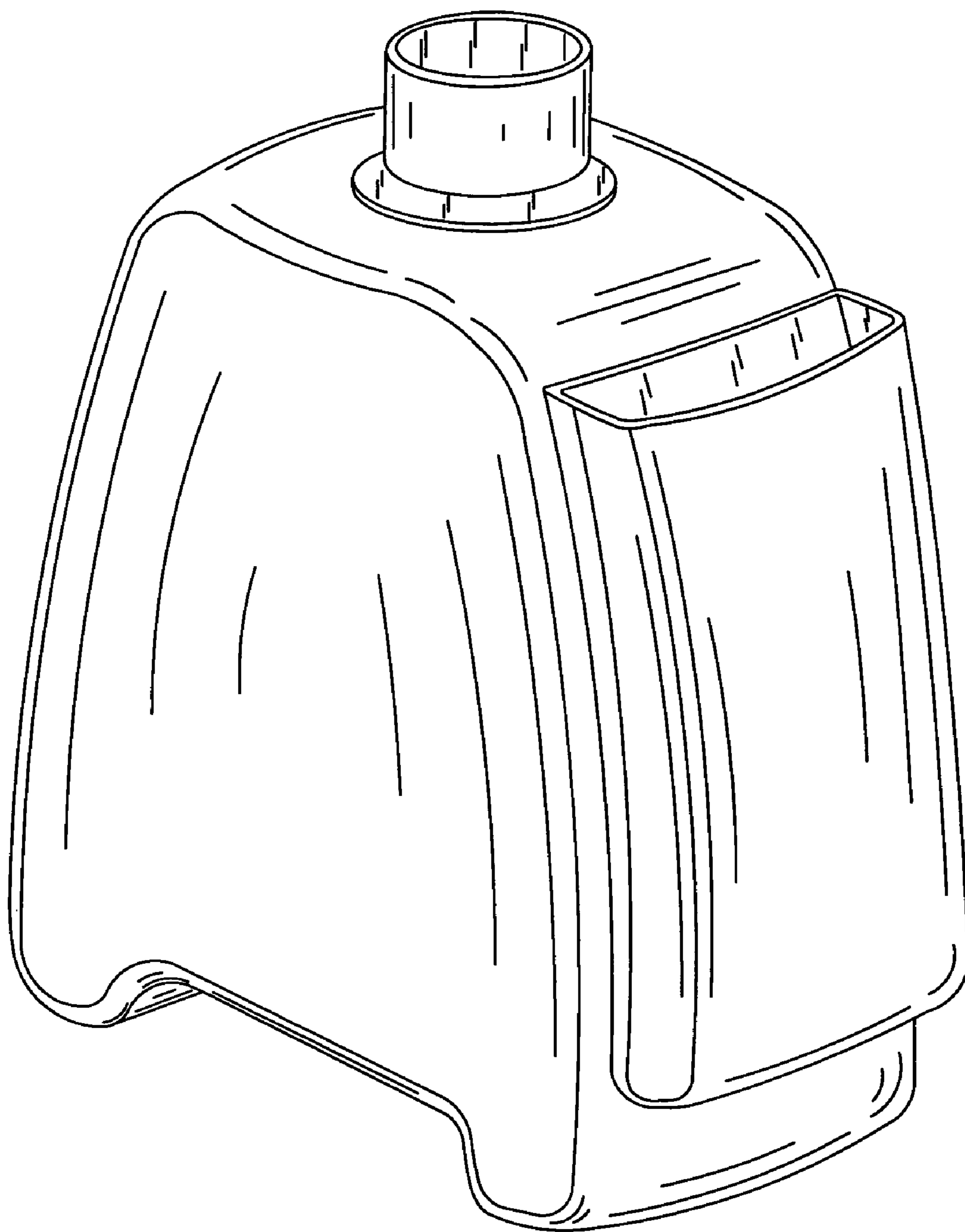

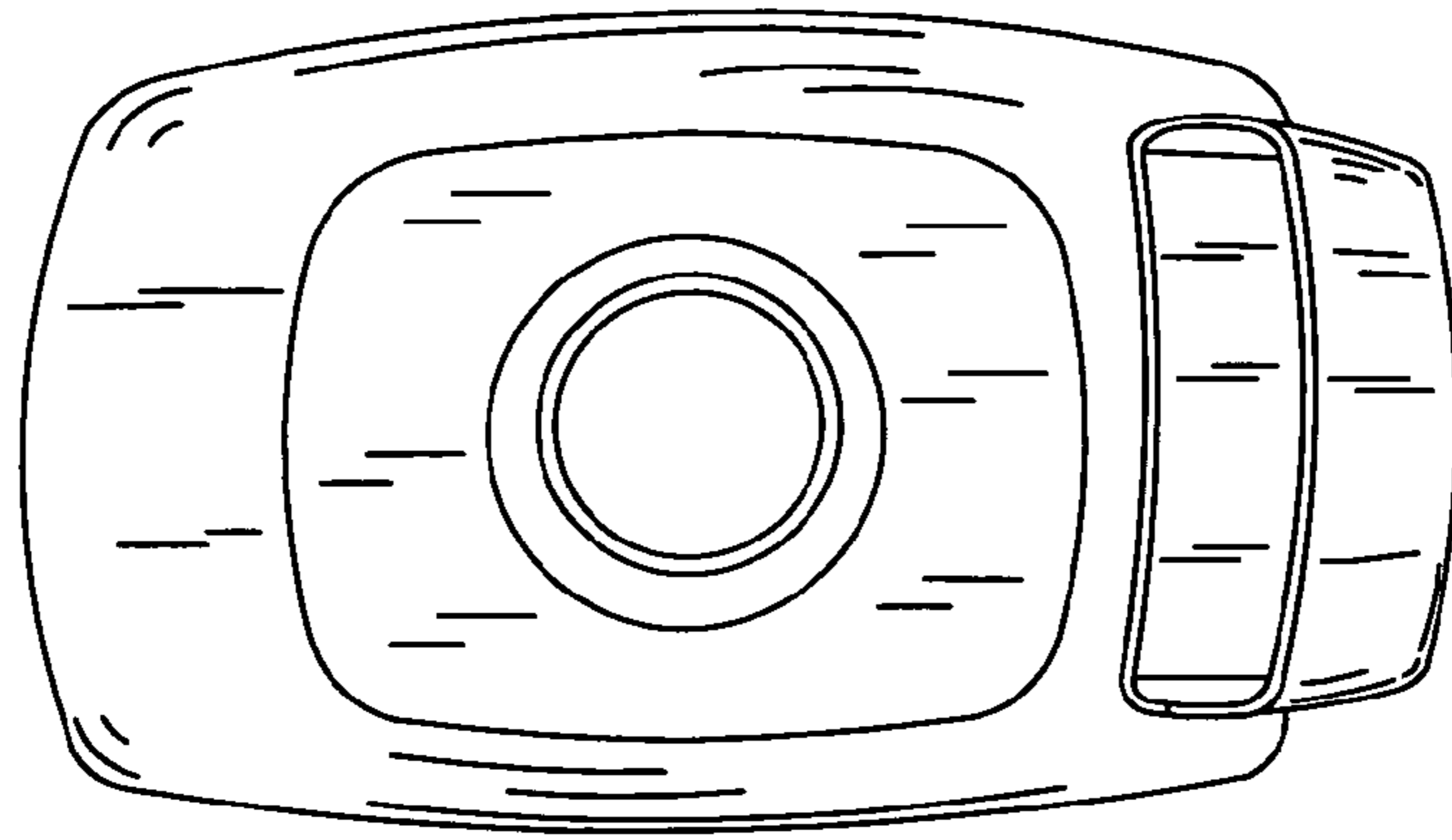

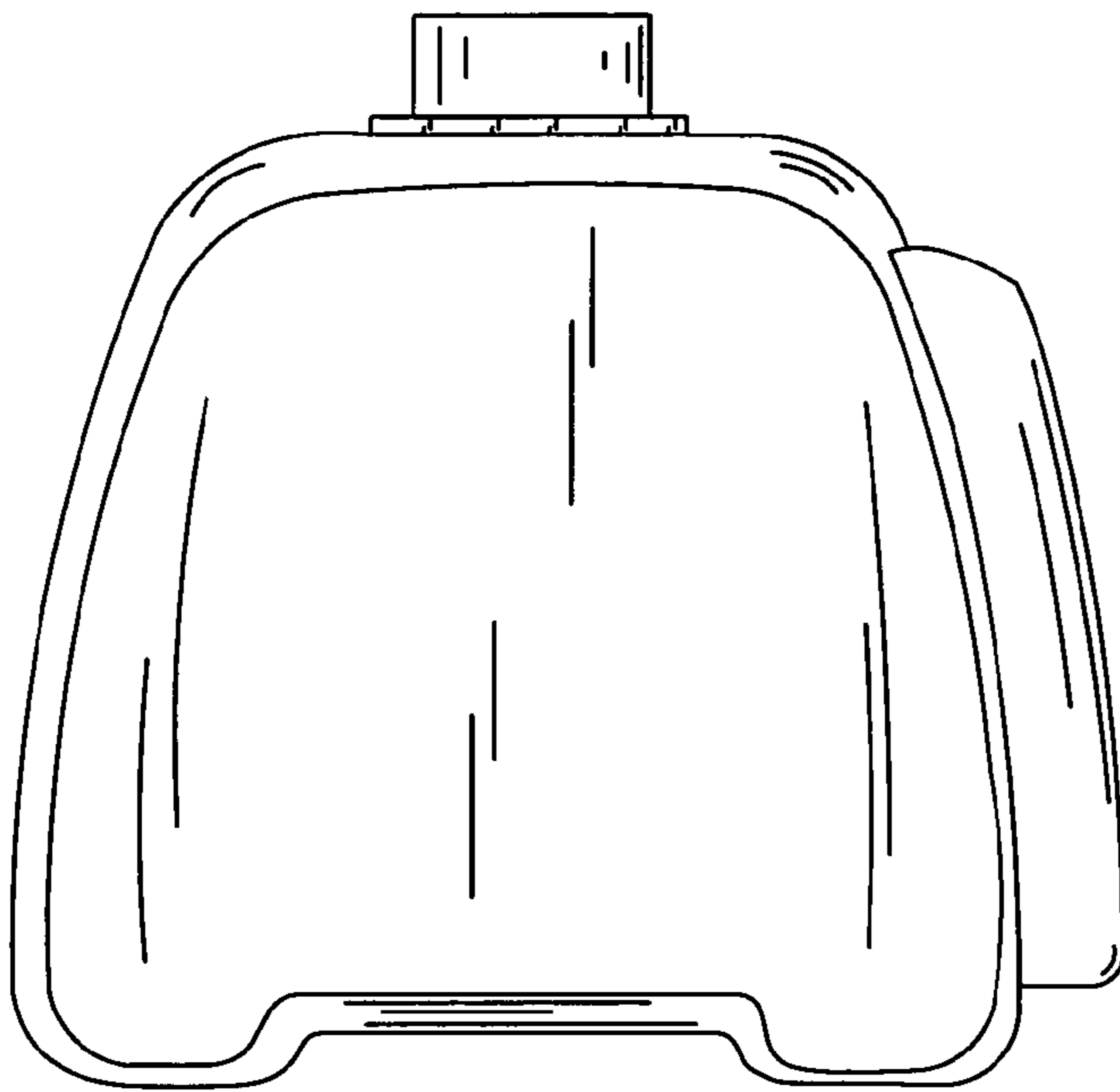

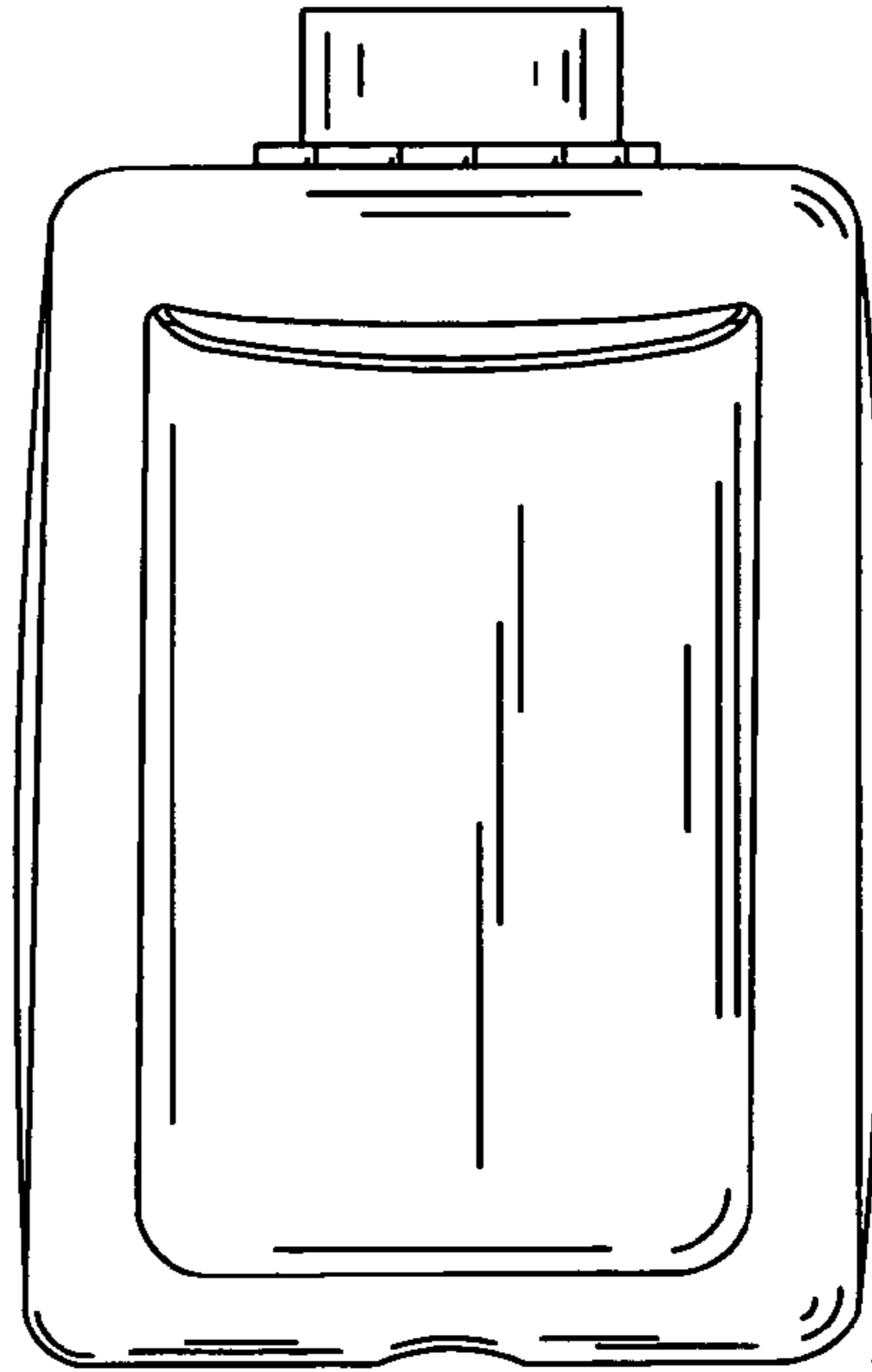

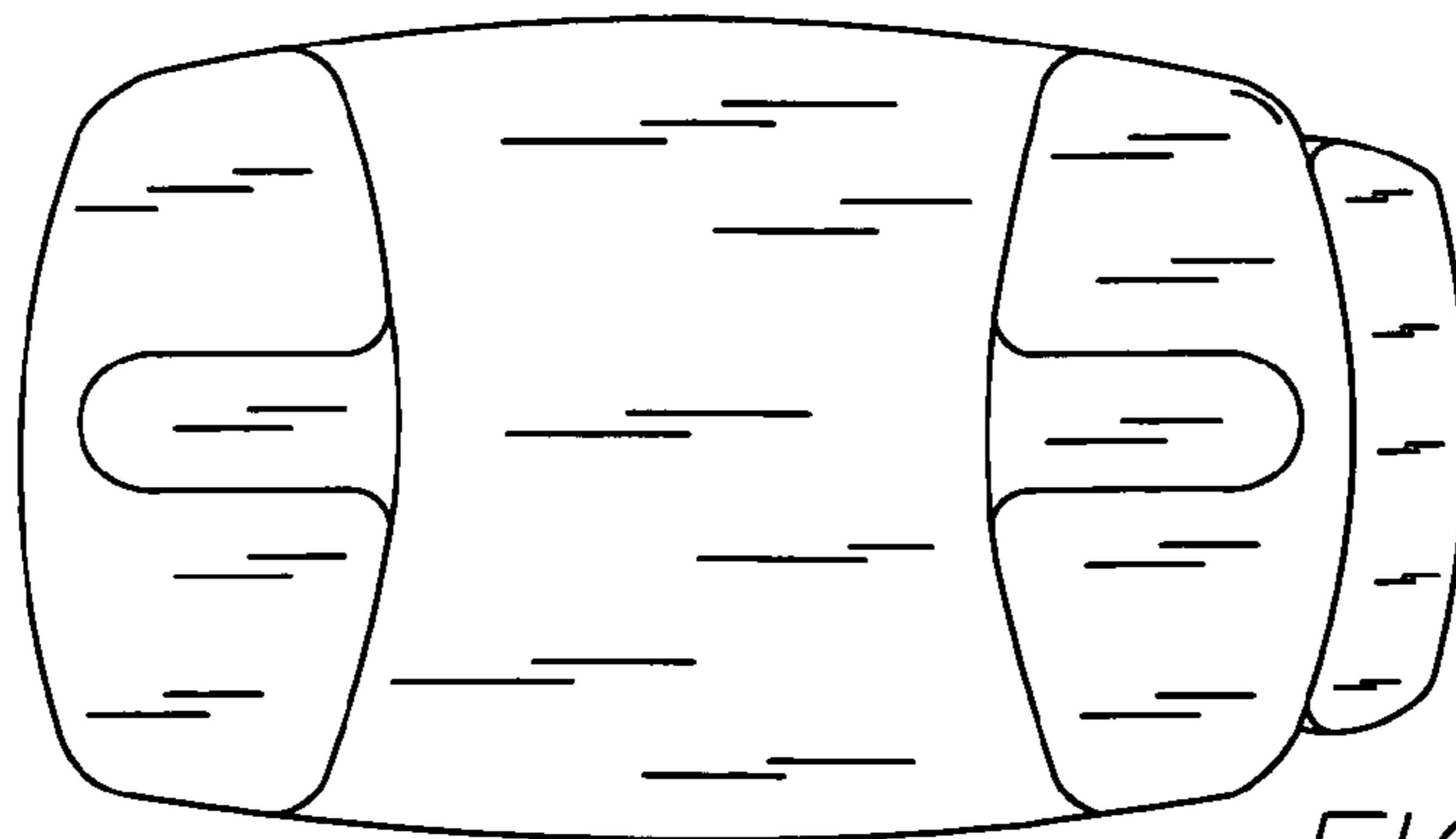
