The ornamental design for a sillcock handle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the sillcock handle of the invention;

FIG. 2 is a top plan view;

FIG. 3 is a front elevation view, which is the same as the rear elevation view;

FIG. 4 is a bottom perspective view;

FIG. 5 is the bottom plan view; and,

FIG. 6 is a left side elevation view, which is the same as the right side elevation view.

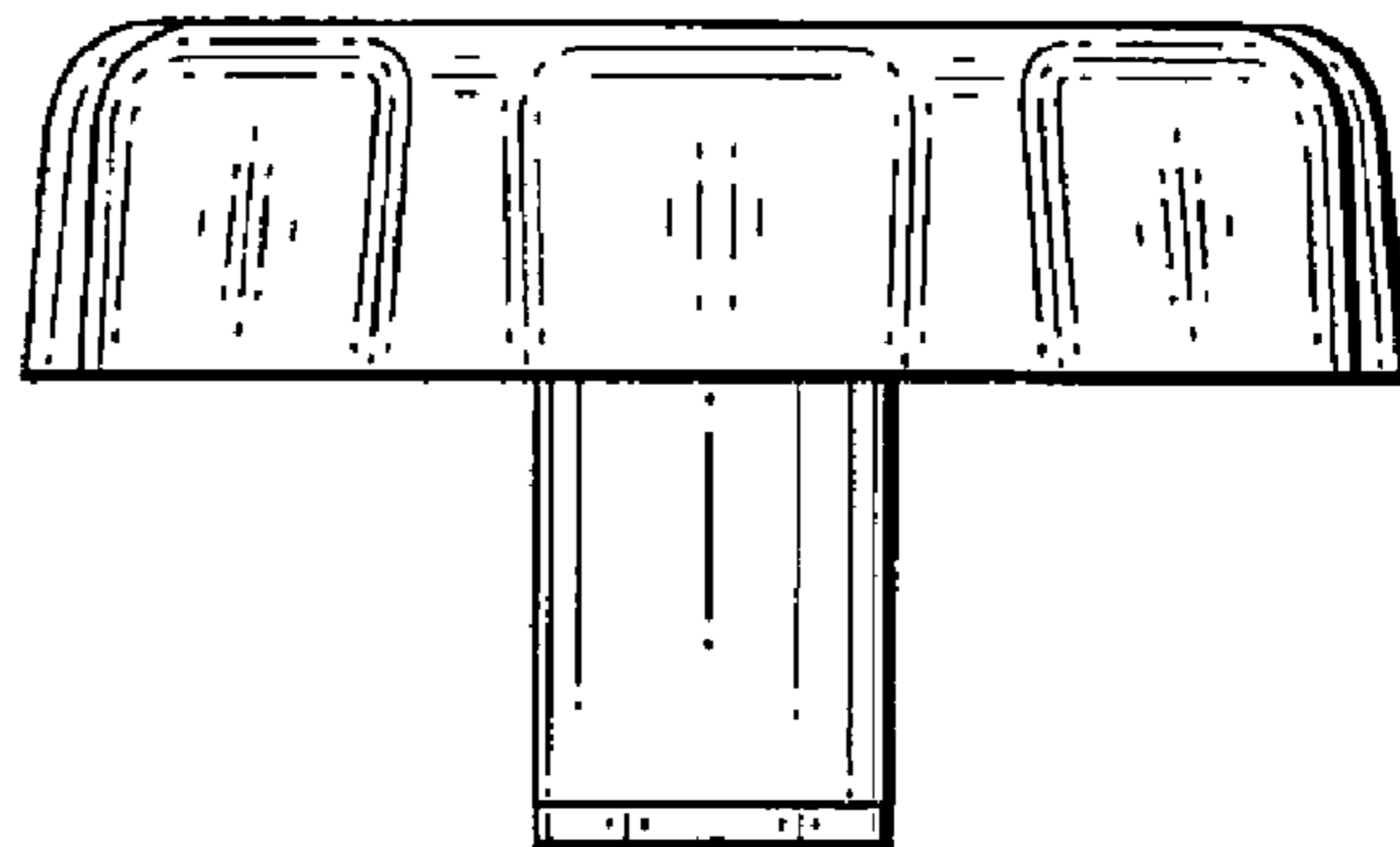
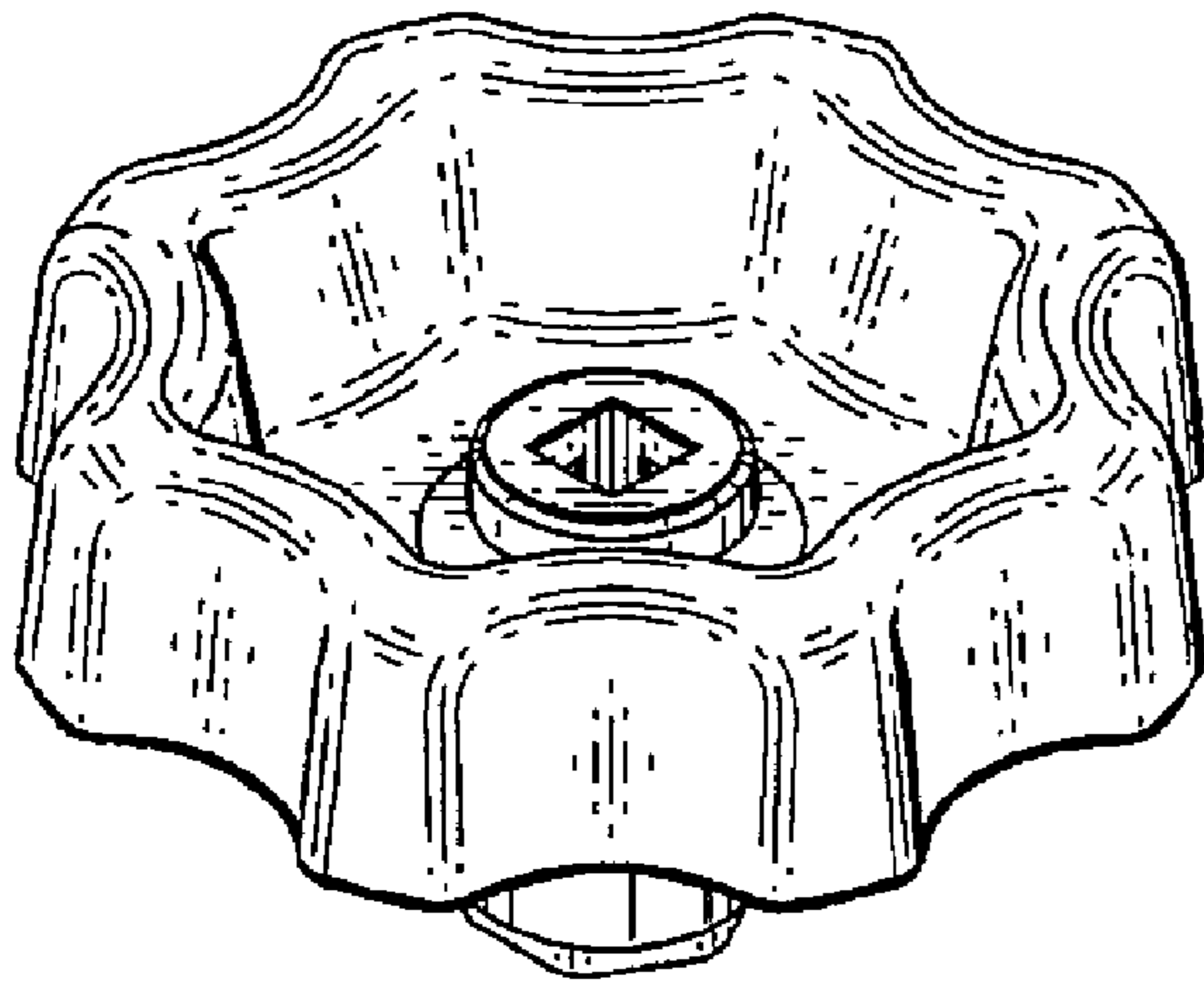

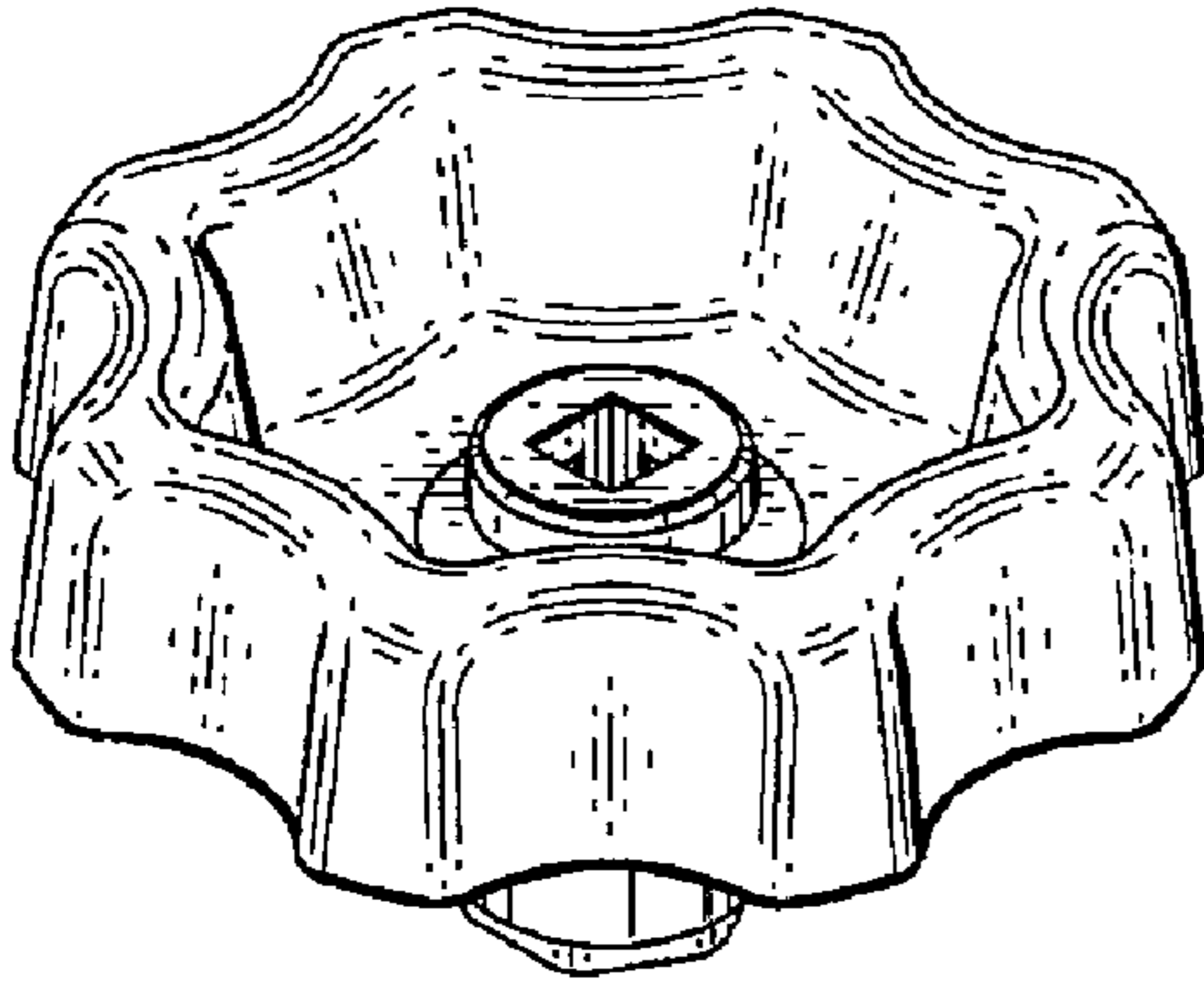

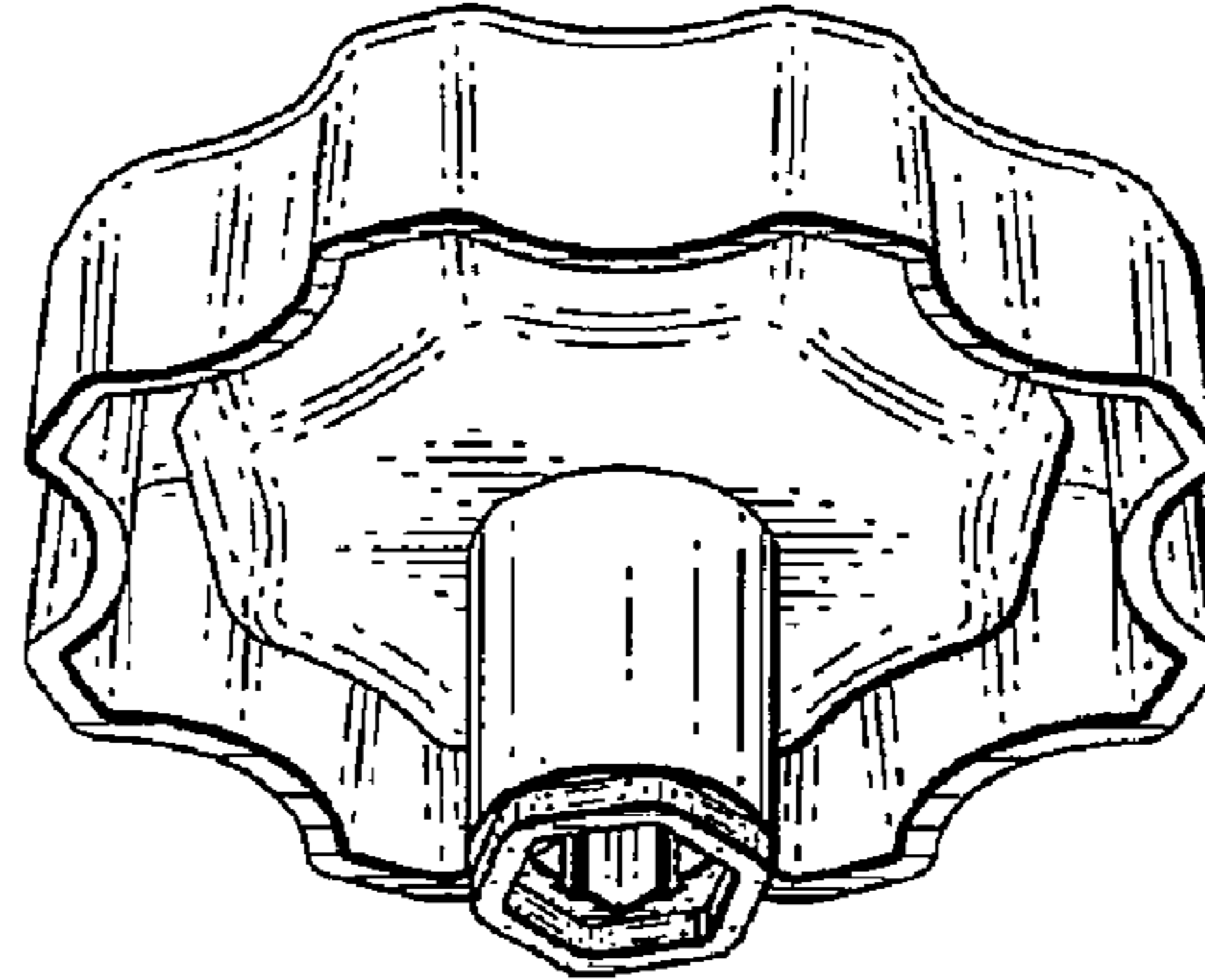

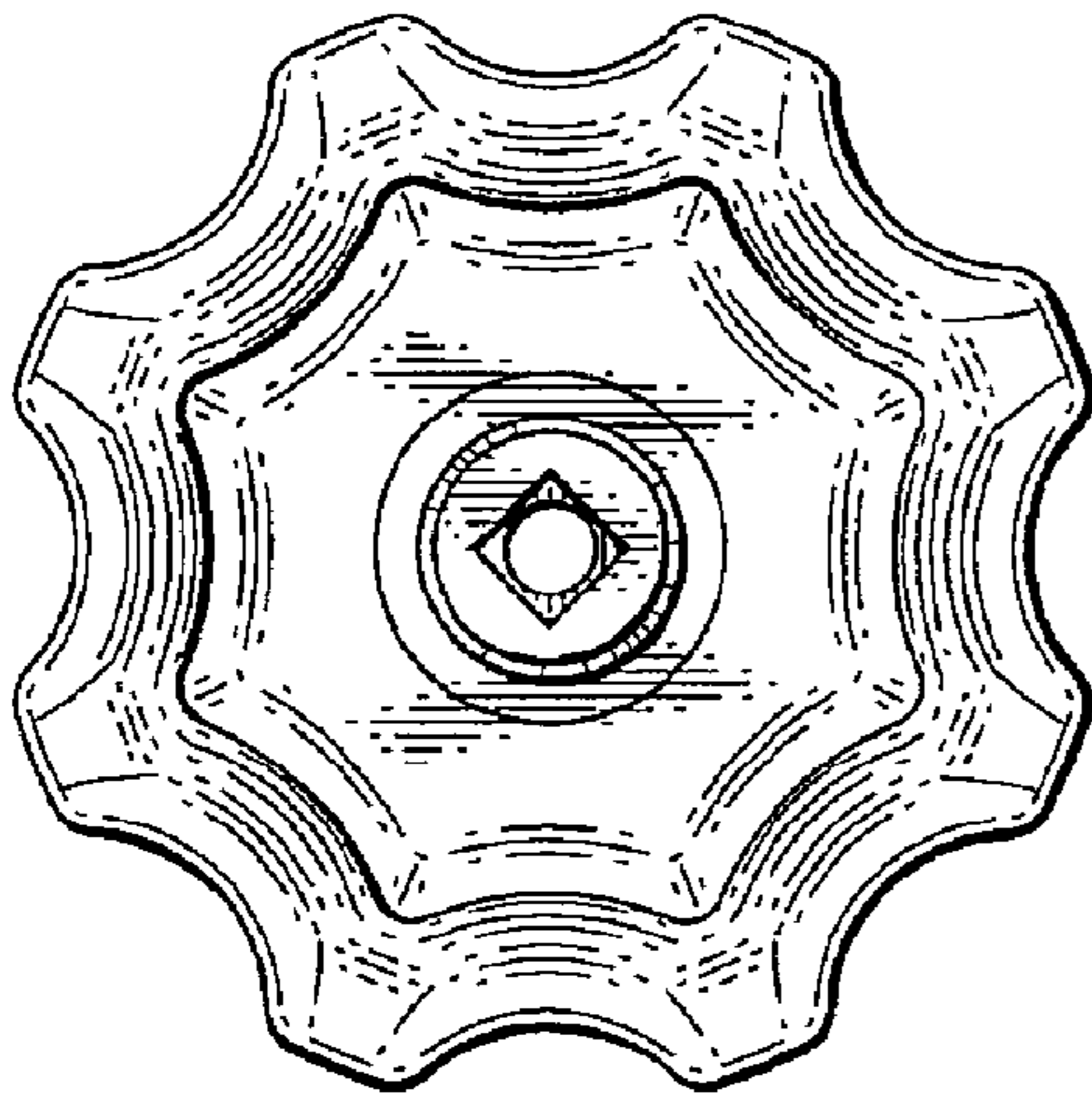

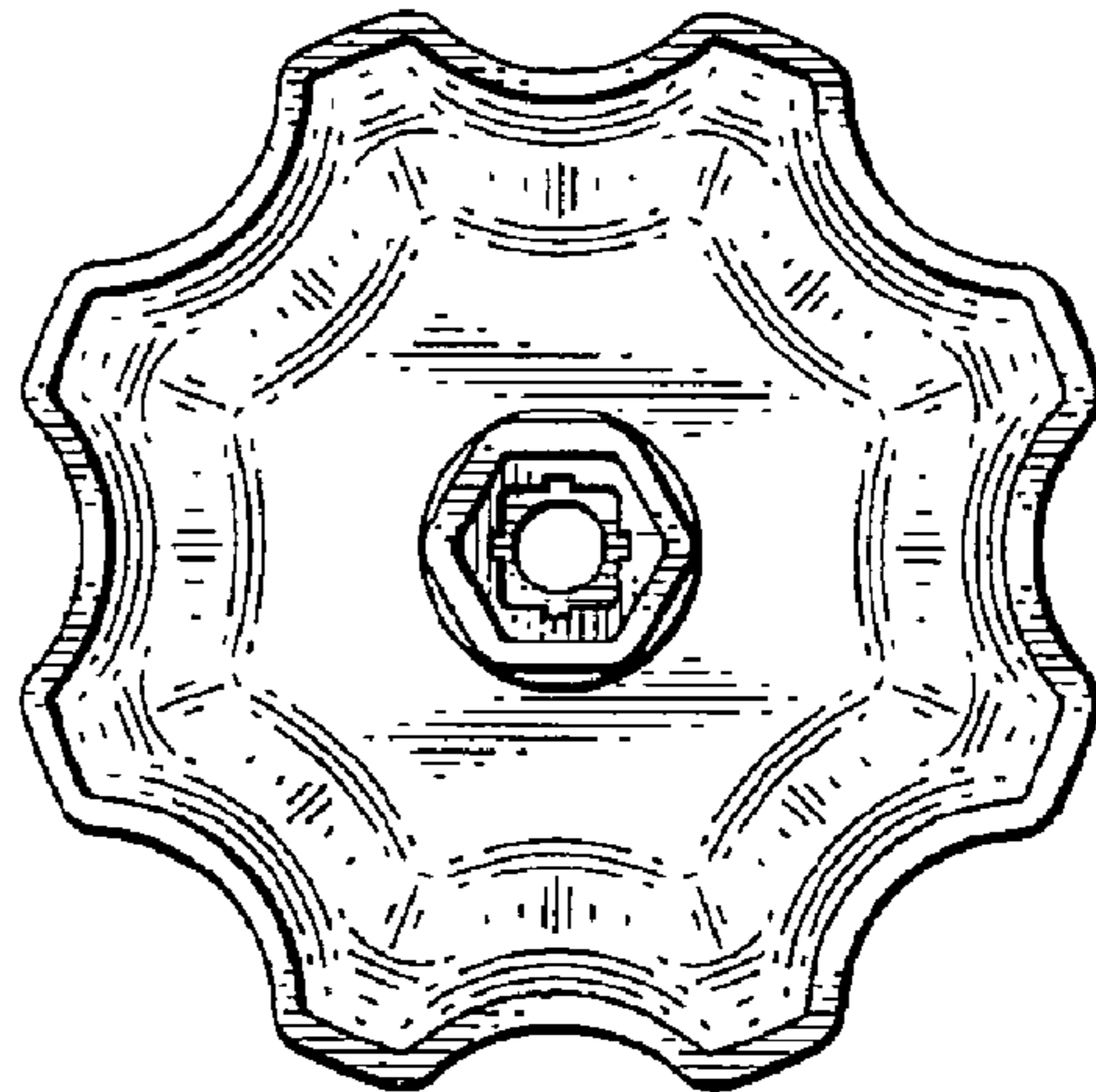

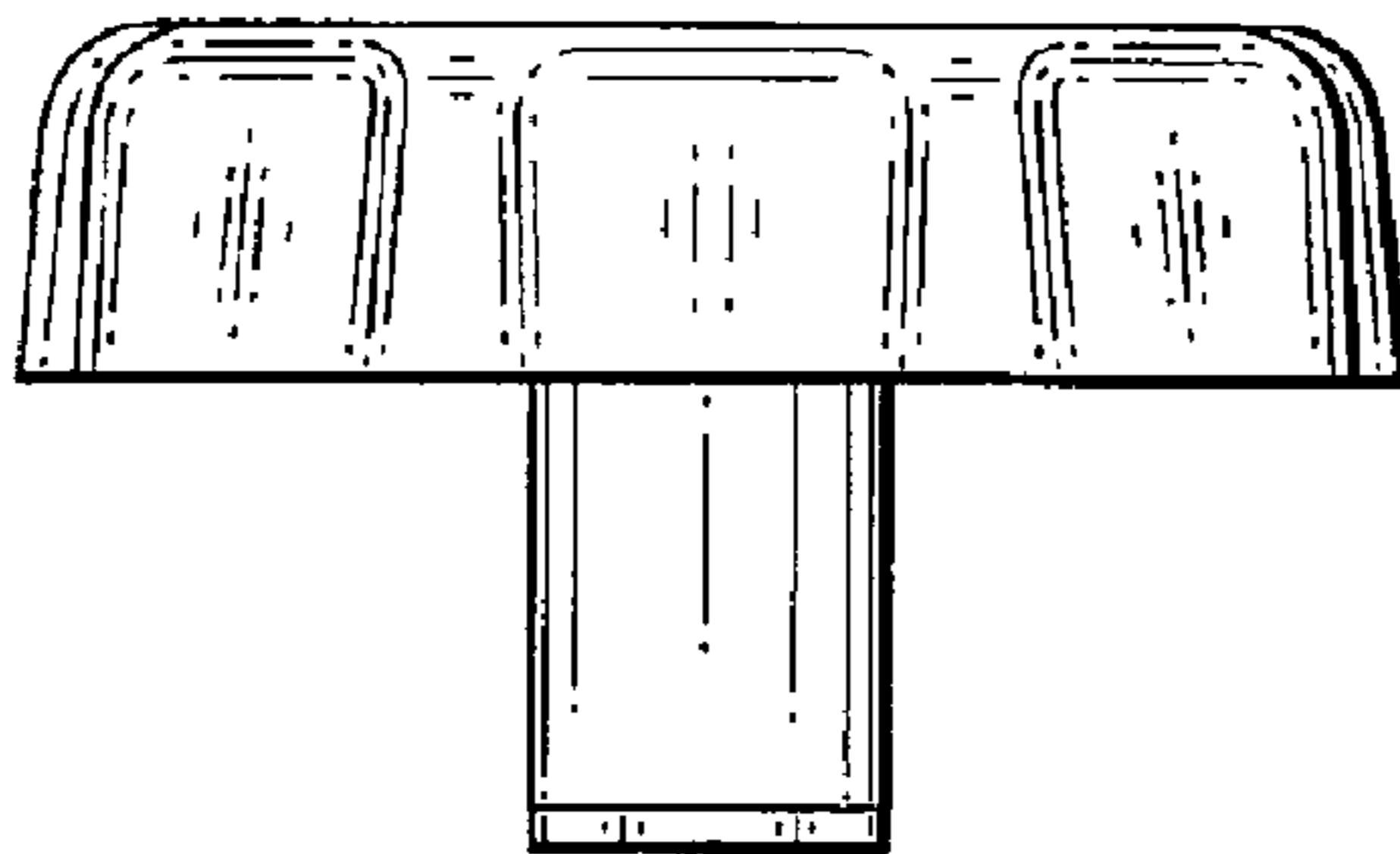
