The ornamental design for a disposable urinal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view looking from the right, rear side of my disposable urinal

FIG. 4 is a right side view thereof

FIG. 6 is a rear view thereof

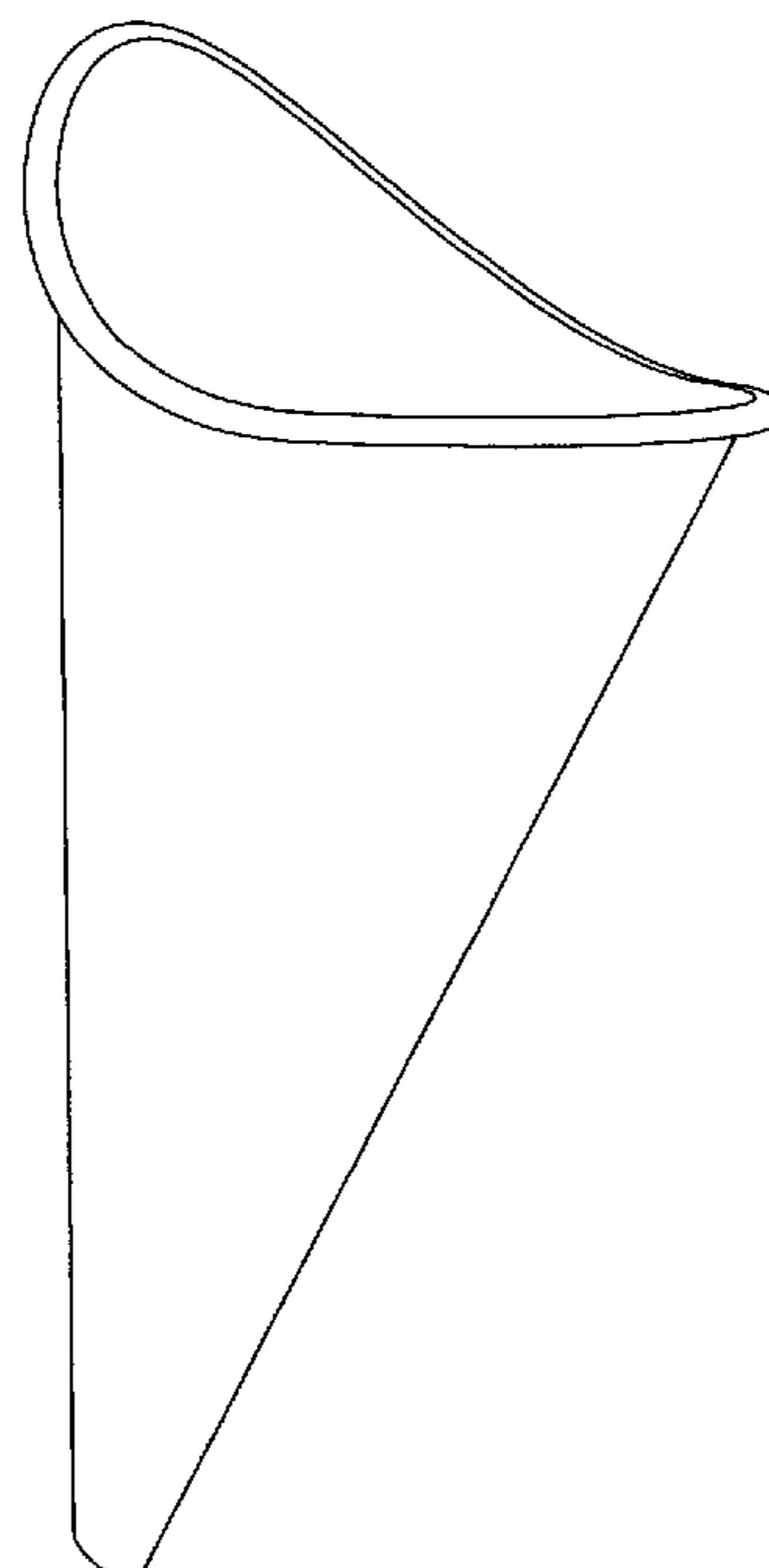
FIG. 7 is a left side view thereof; and,

My disposable urinal is characterized by its sculpture ornamentation that features smooth walls sloping downward at an angle with a lip formed along the top edges.

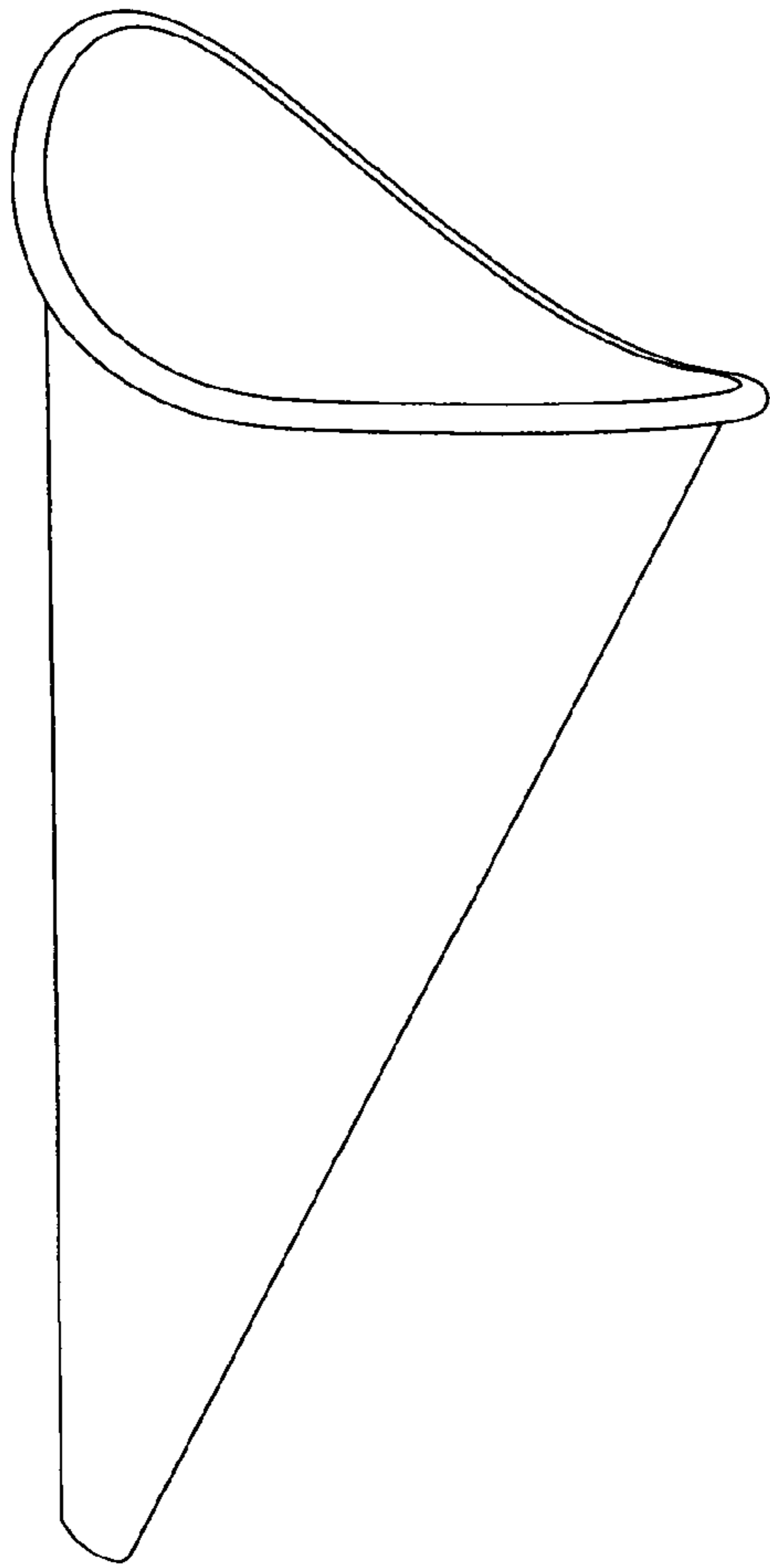

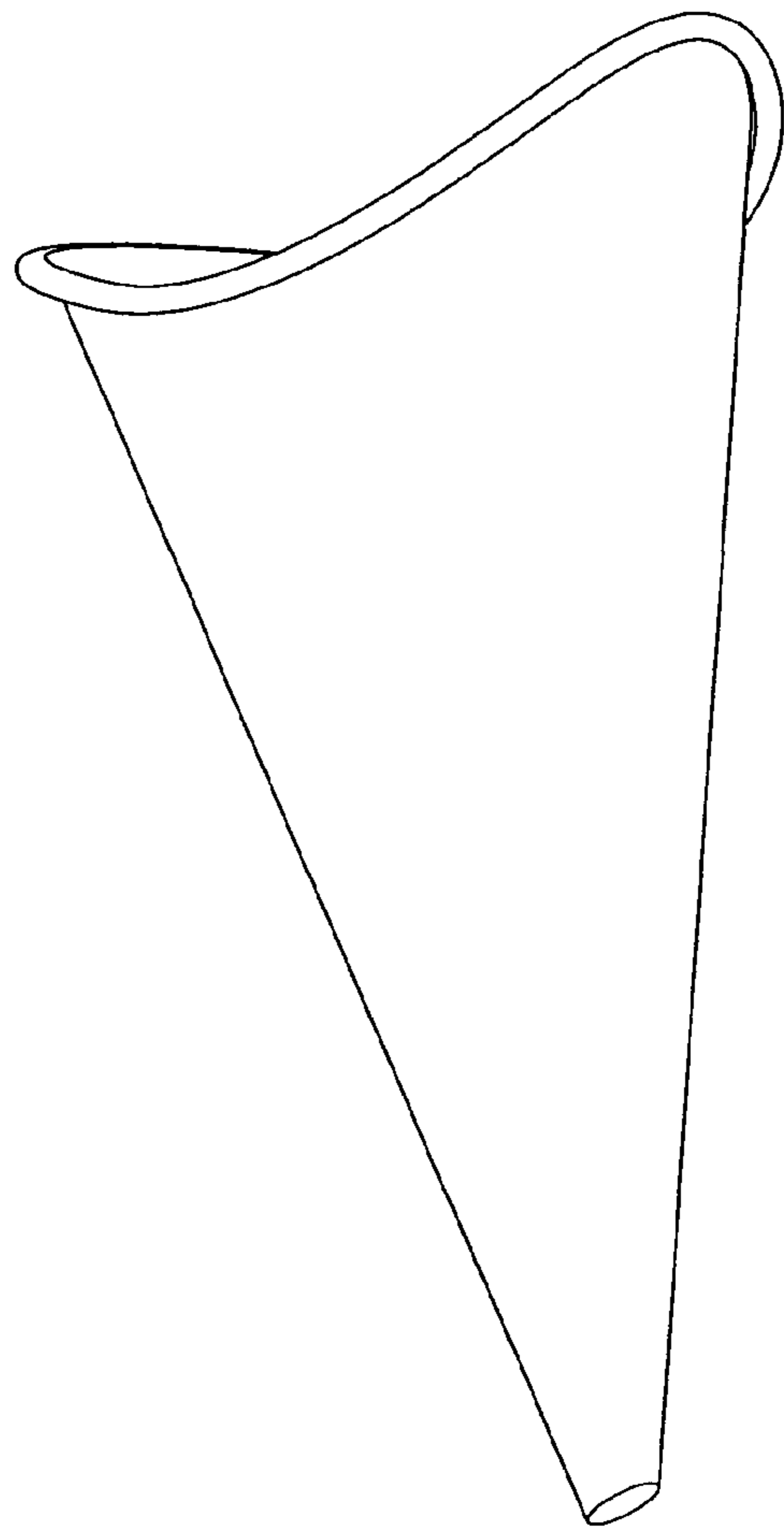

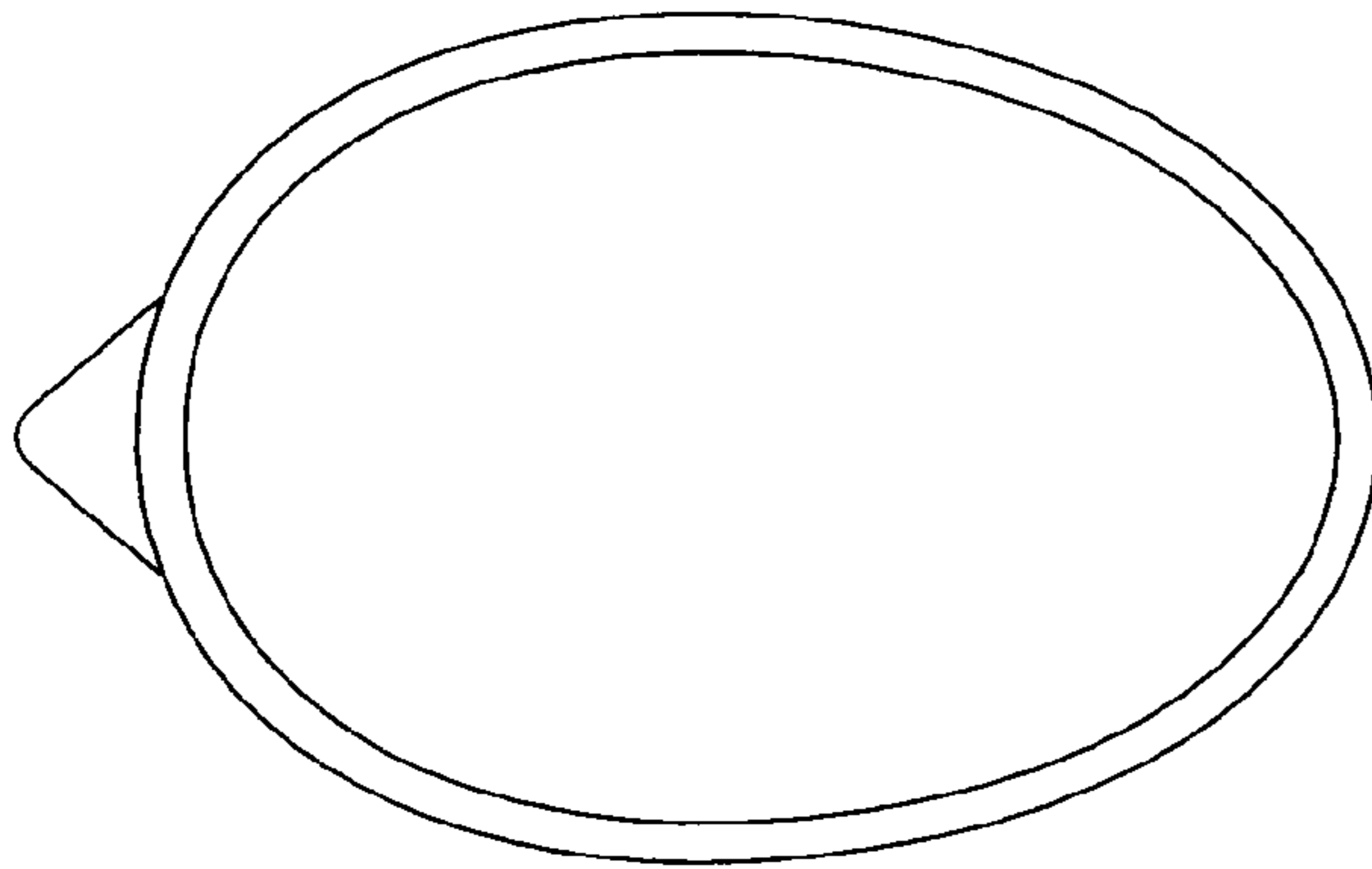

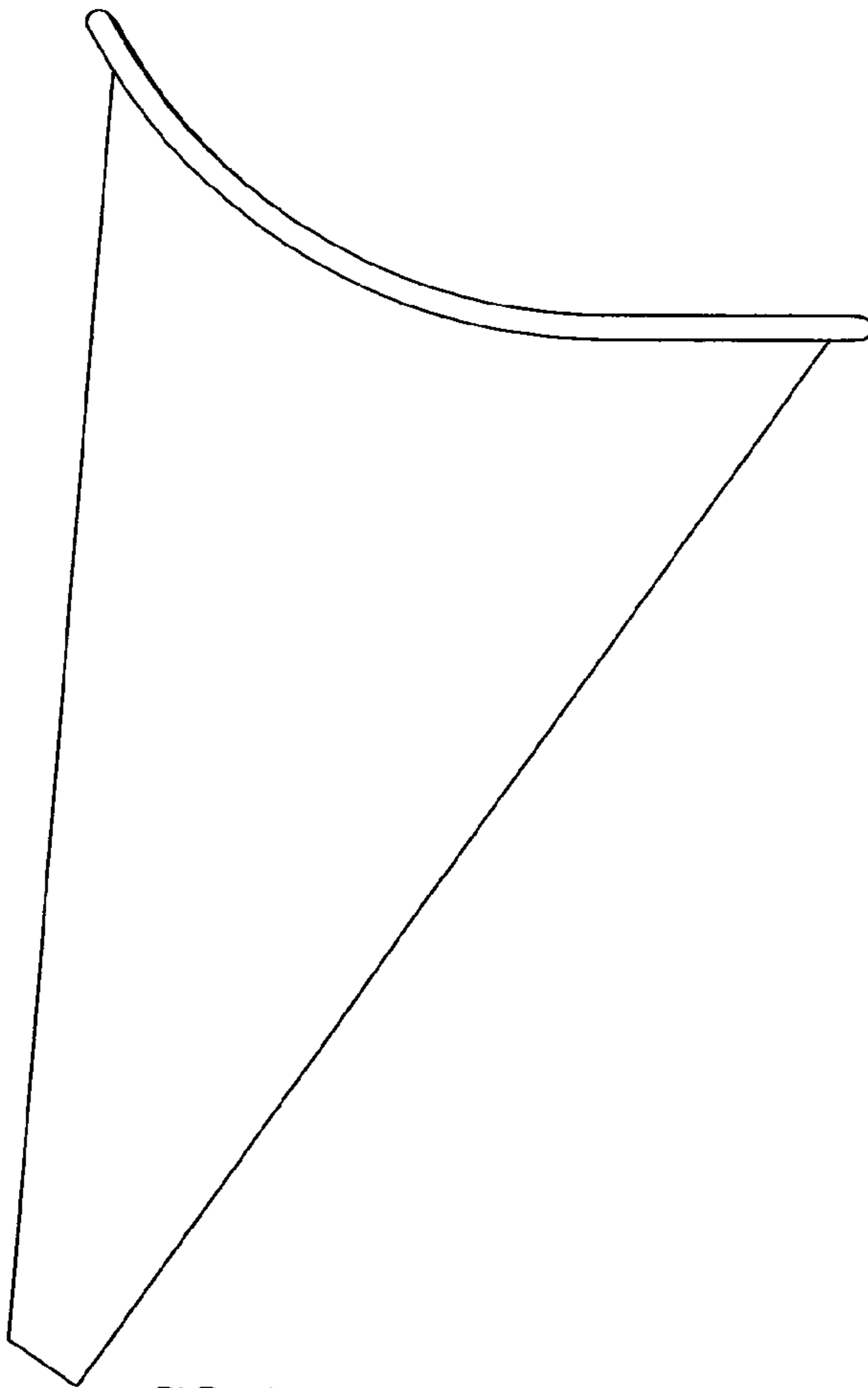

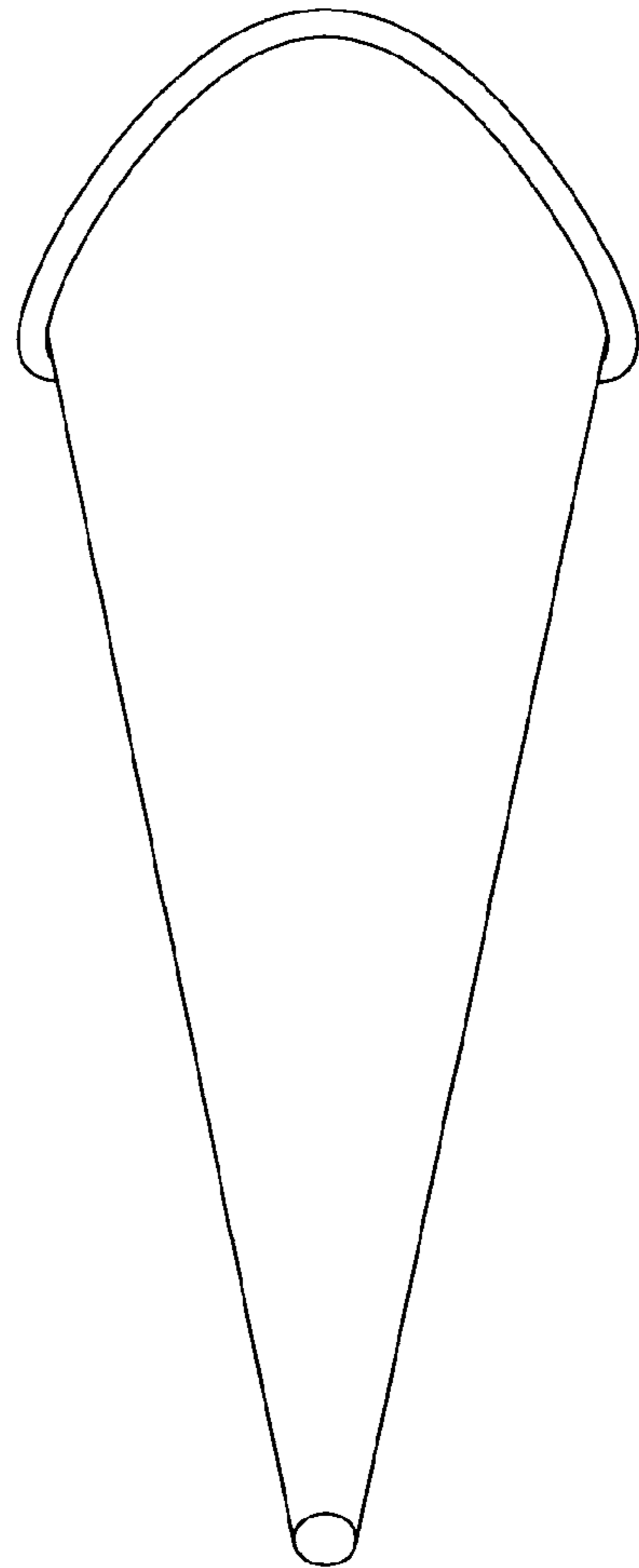

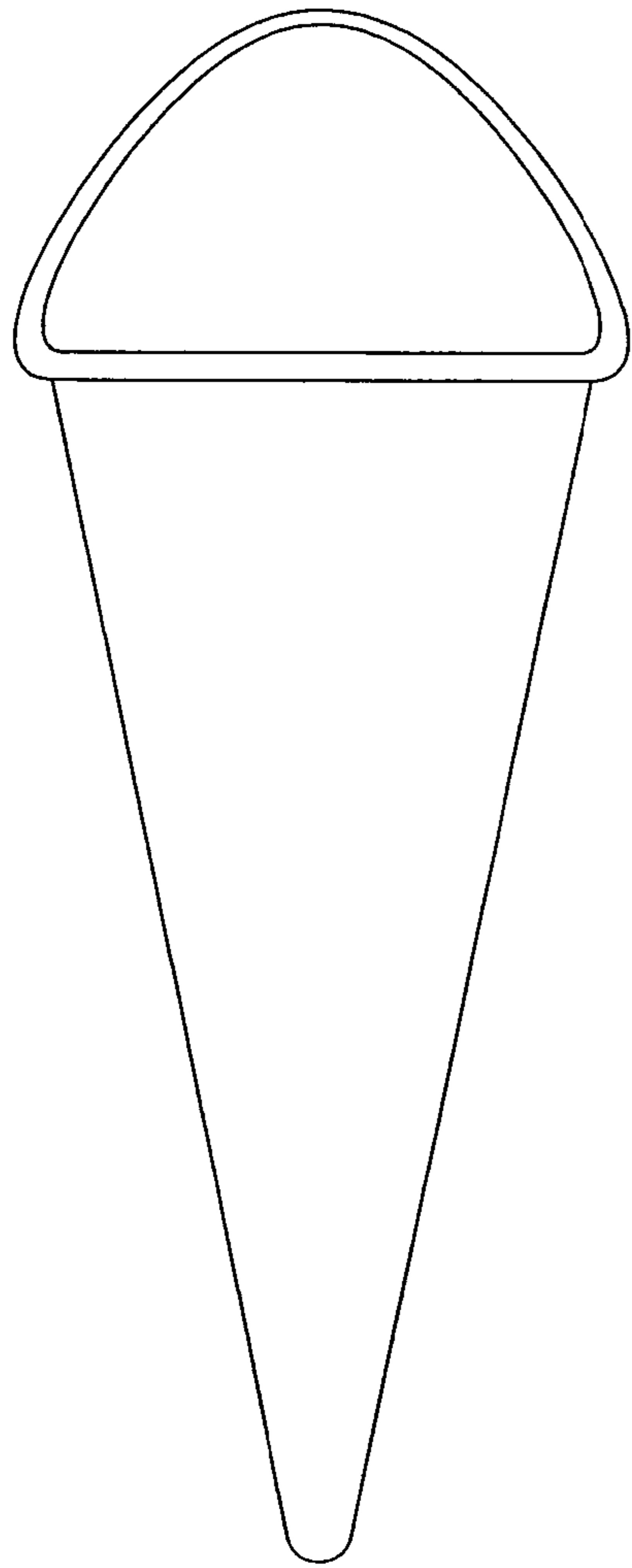

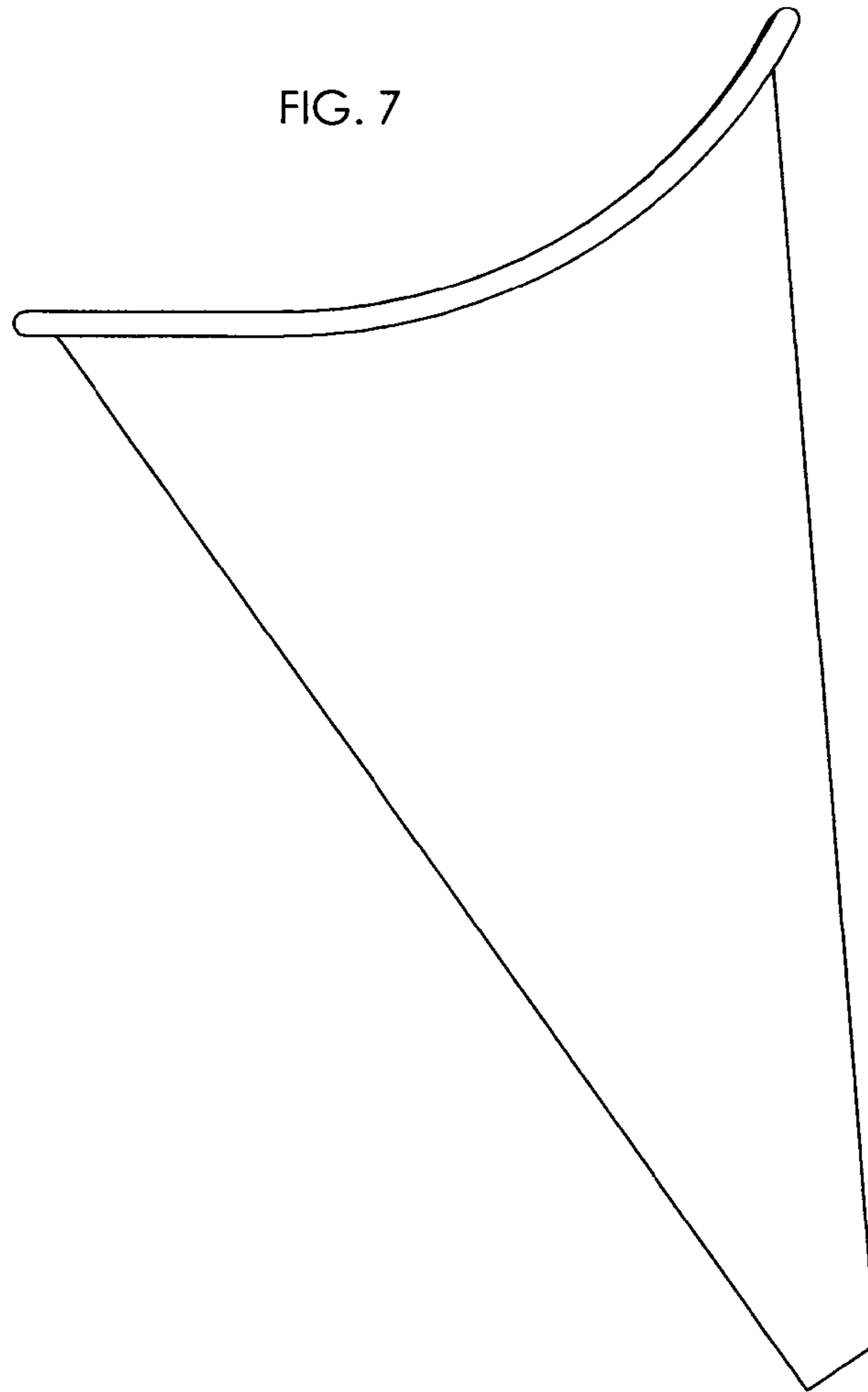

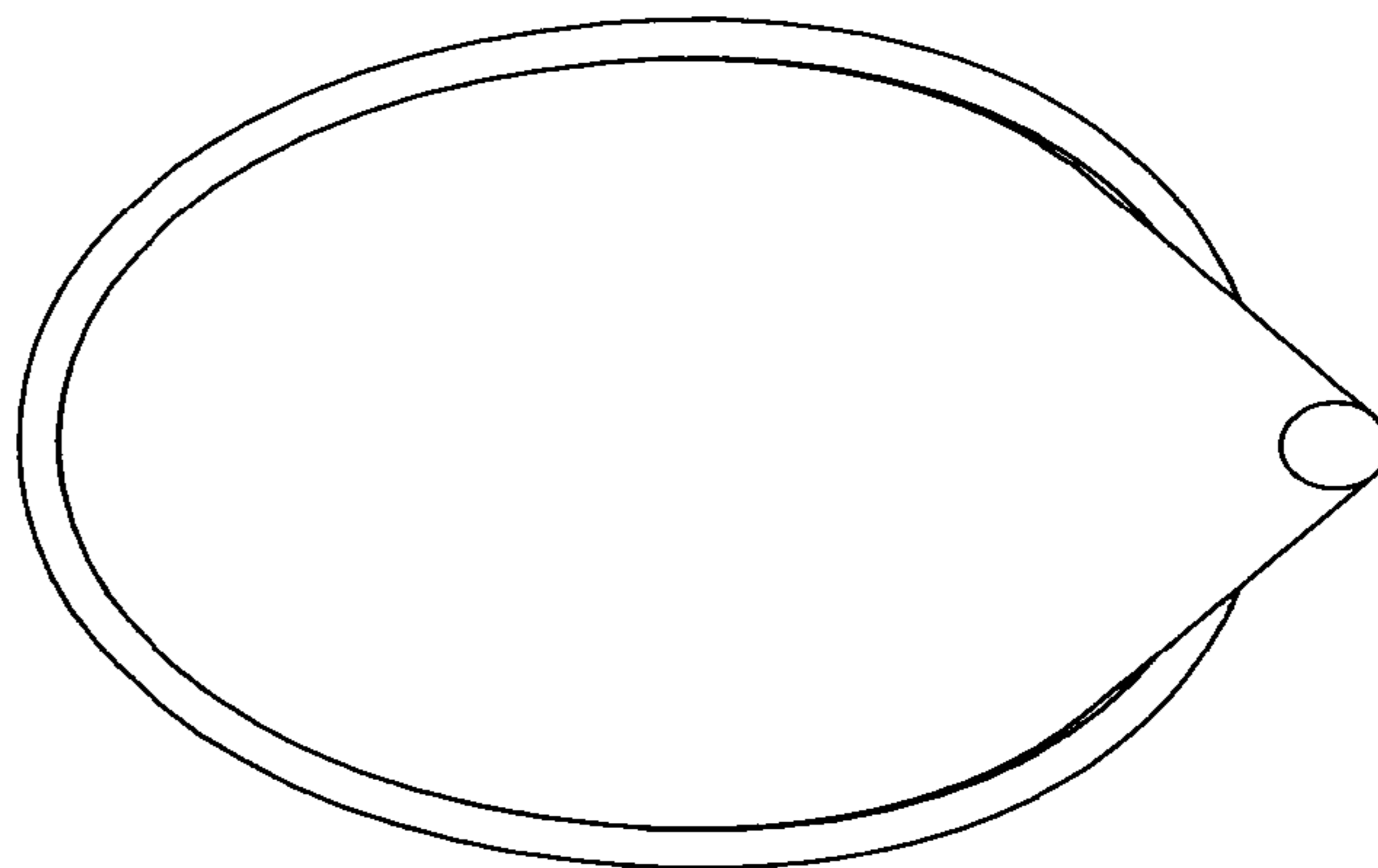
