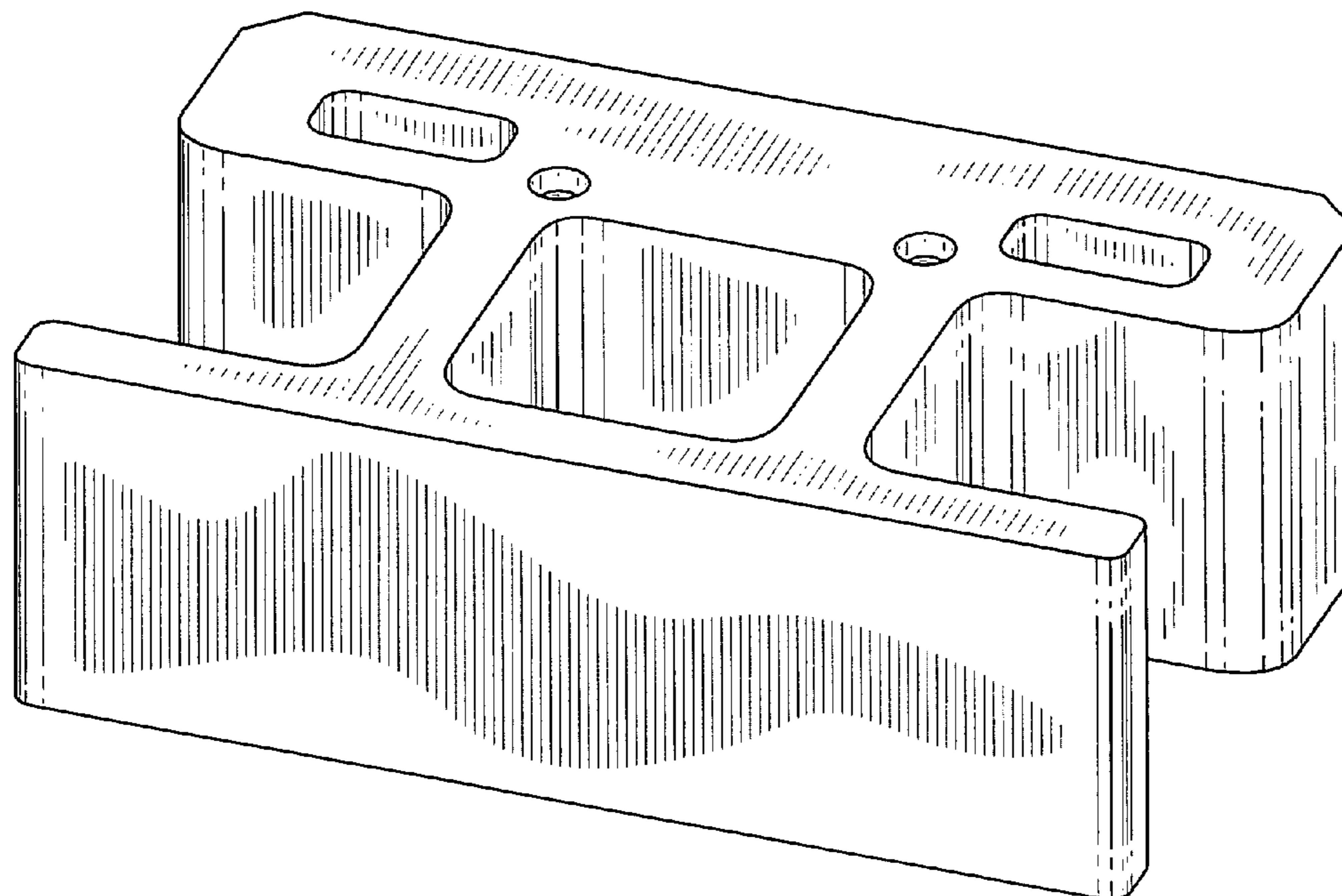
(57) **CLAIM**

The ornamental design for a concrete block, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present concrete block; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; and, FIG. 5 is a right side elevation view thereof (the left side view being symmetrical).

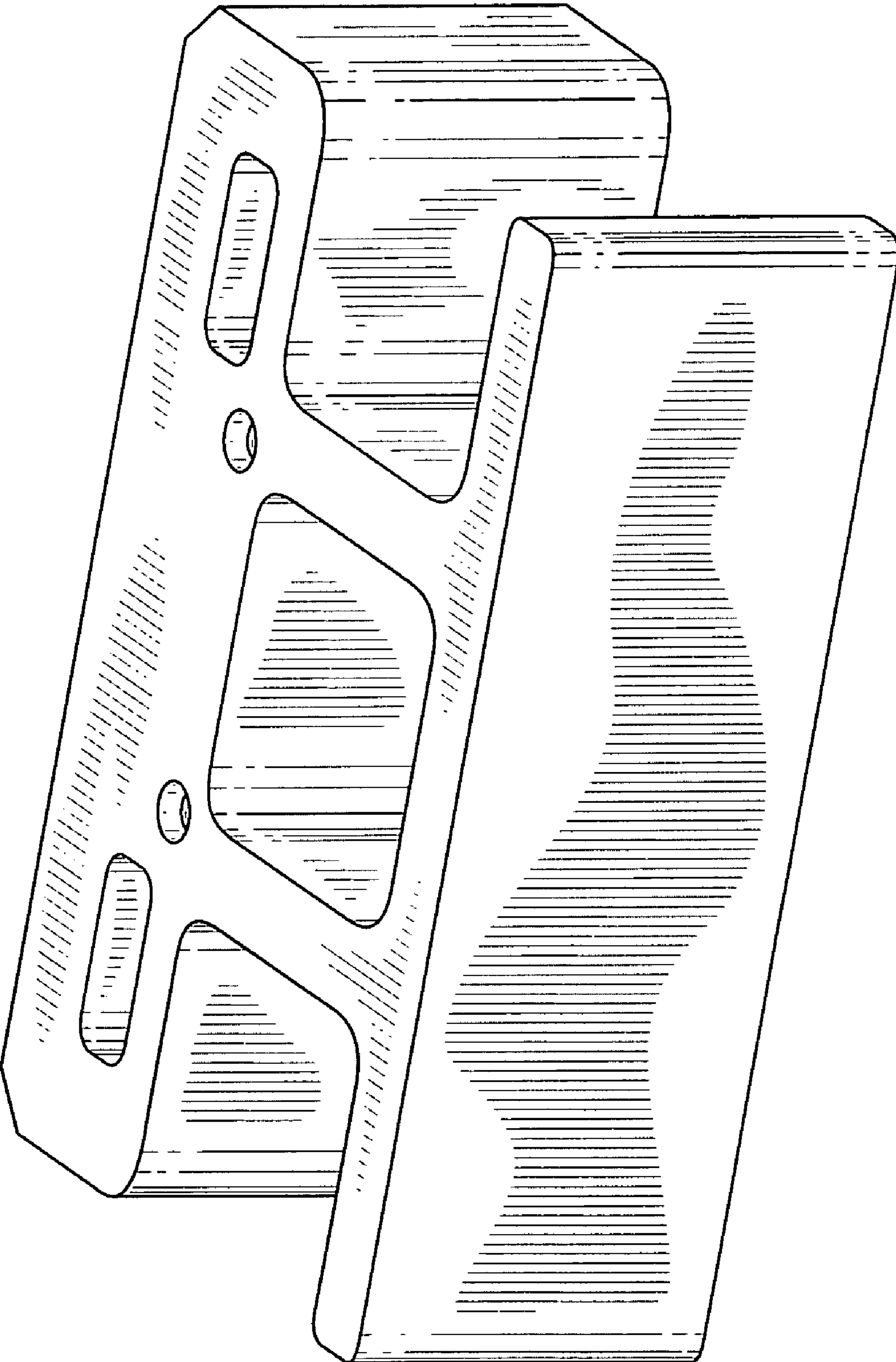

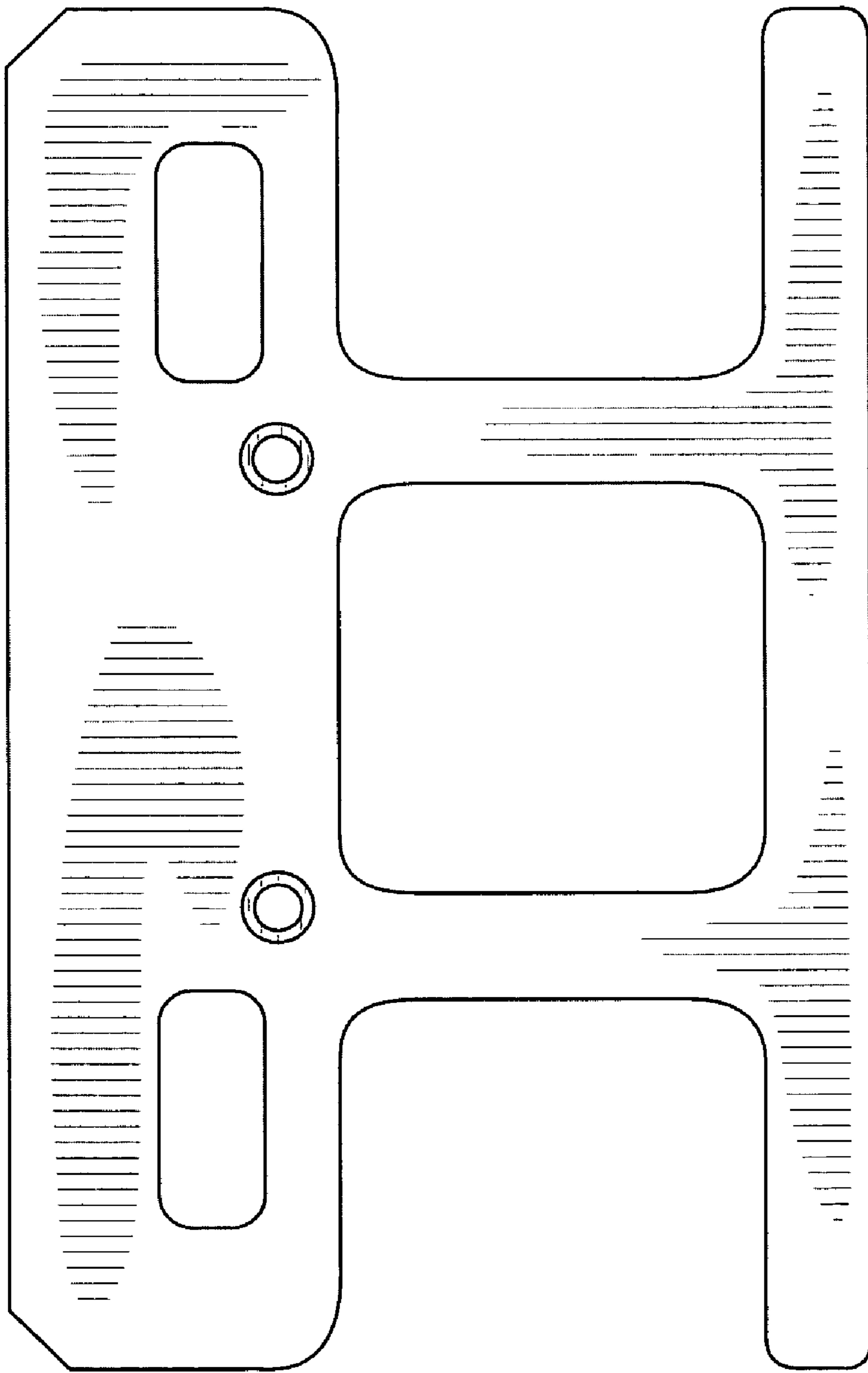

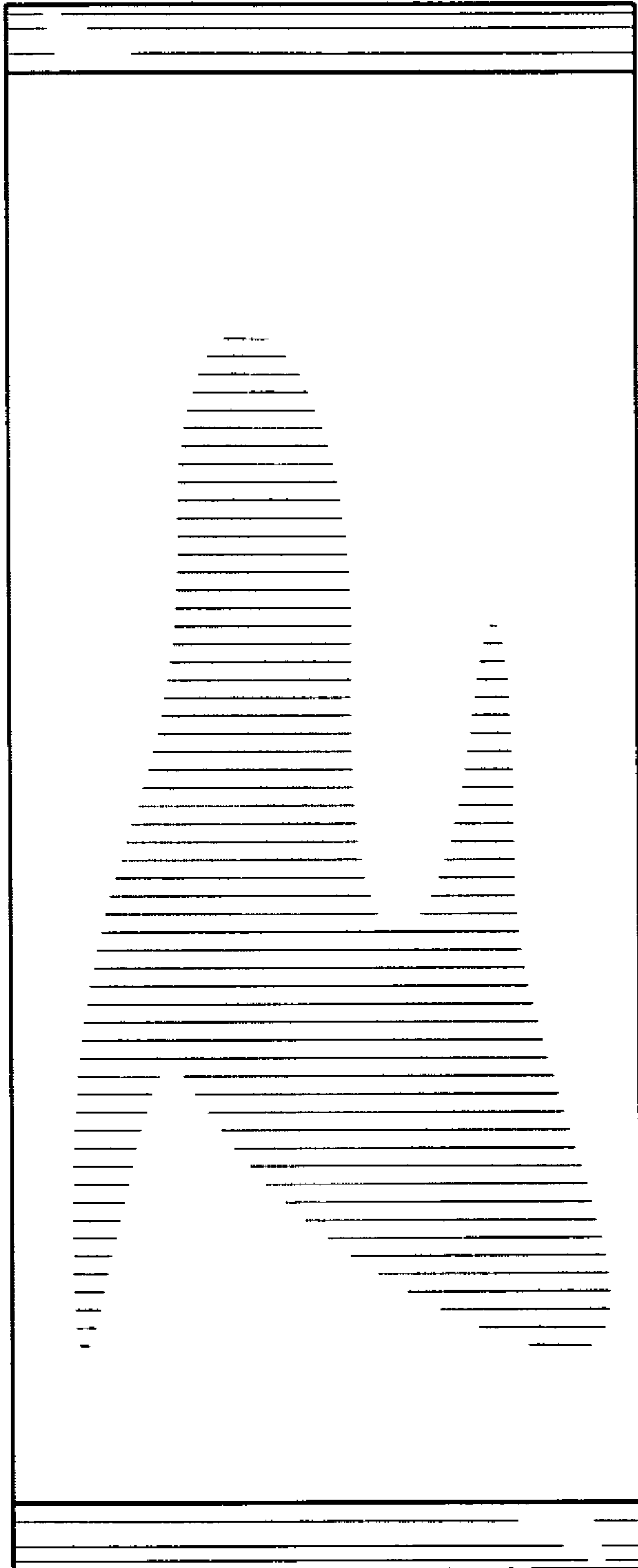

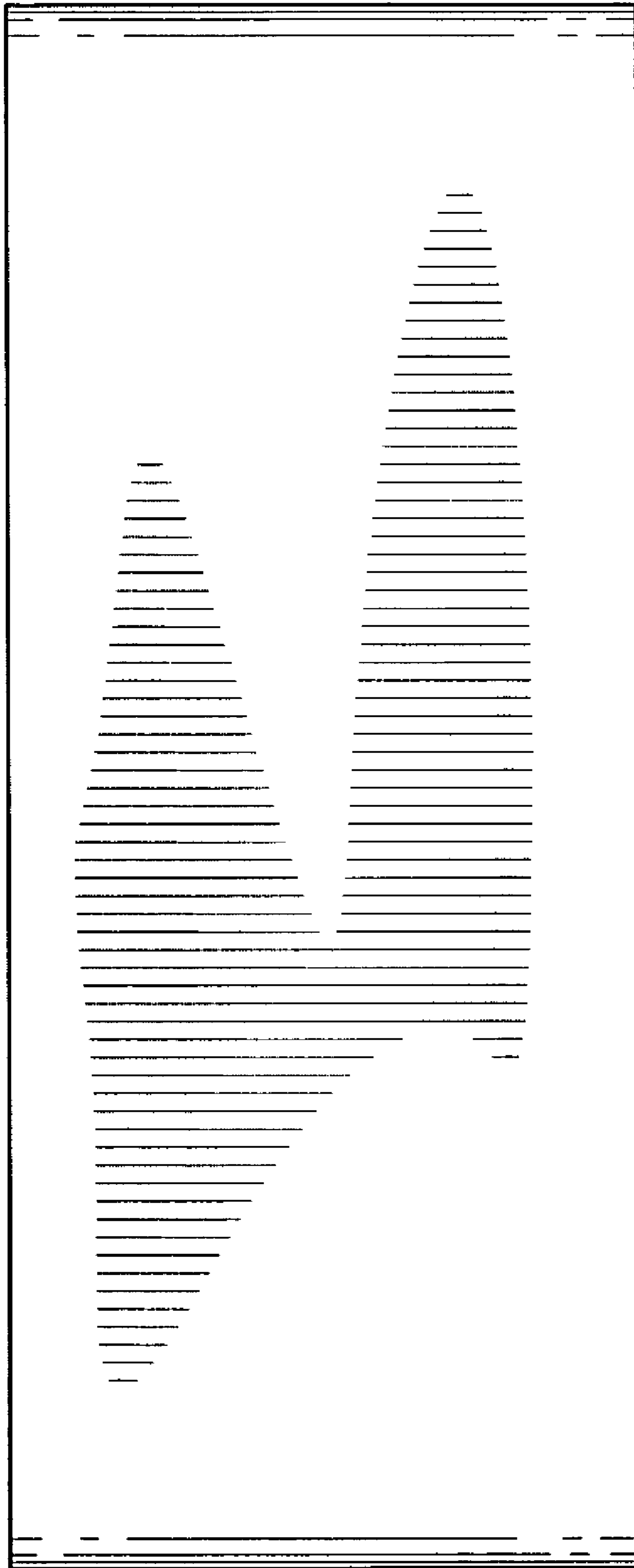

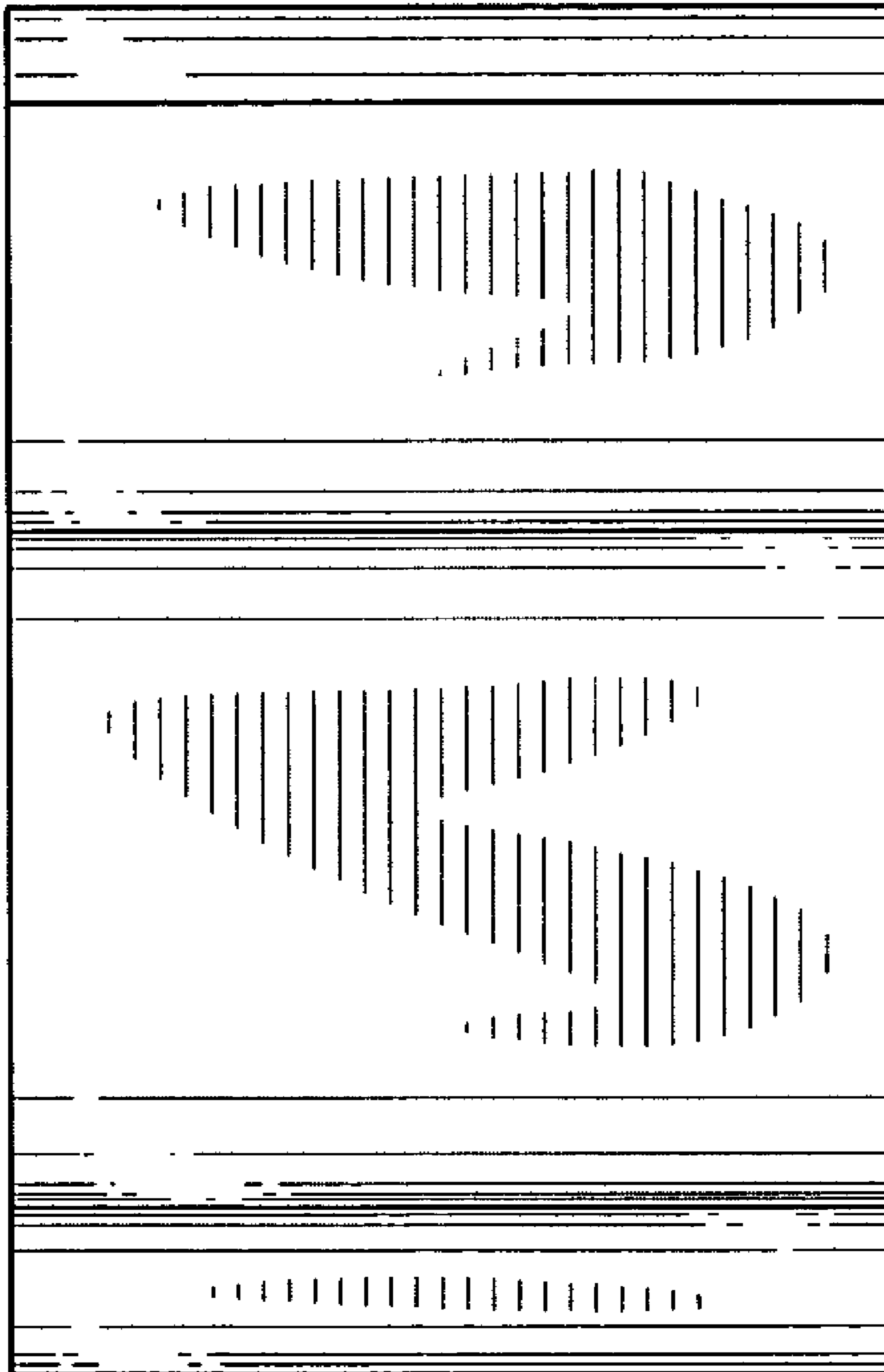
