FIG. 5 is a rear view of the lamp for aquariums shown in FIG. 1.

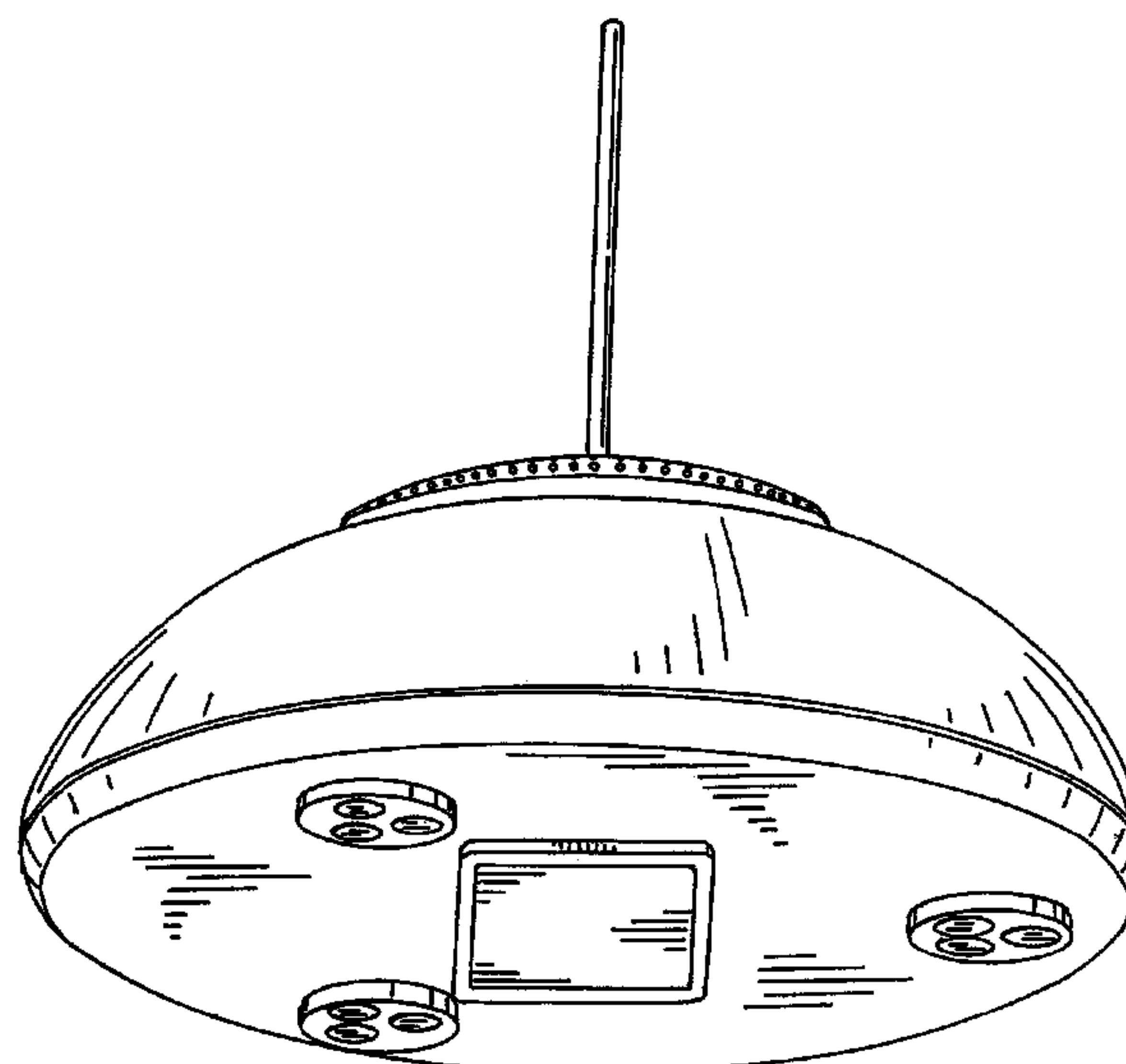
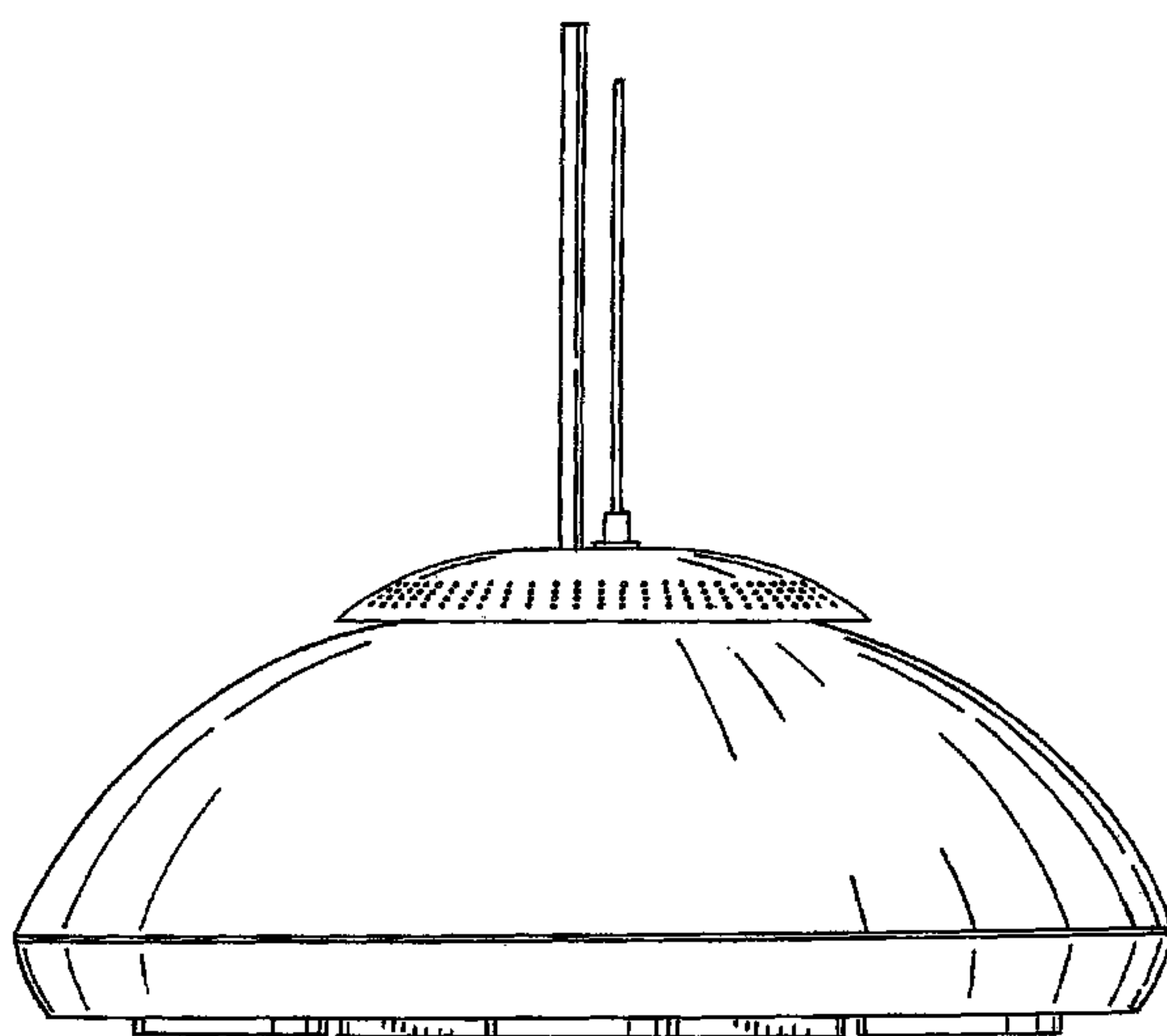
FIG. 6 is a left side view of the lamp for aquariums shown in FIG. 1.

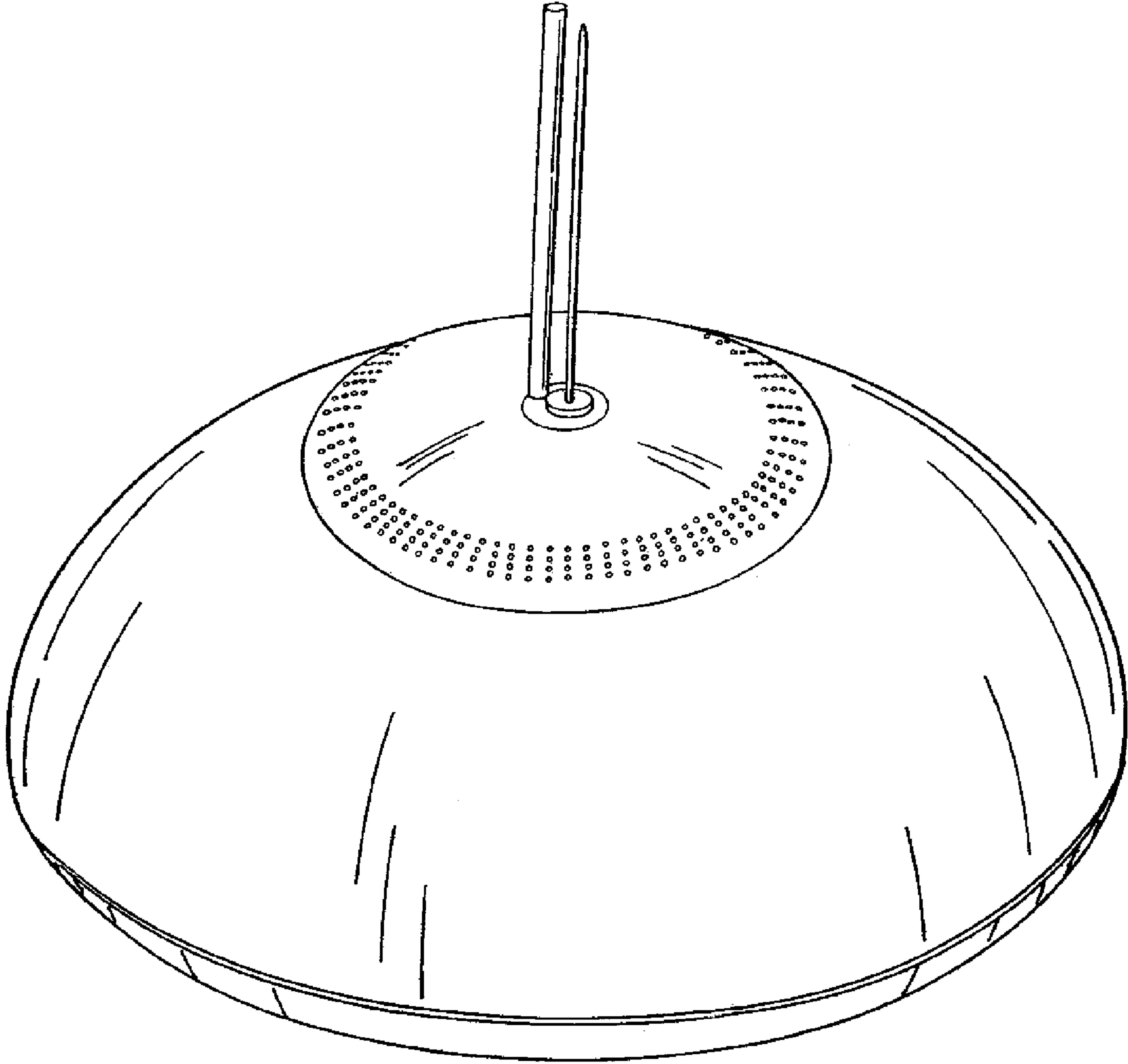

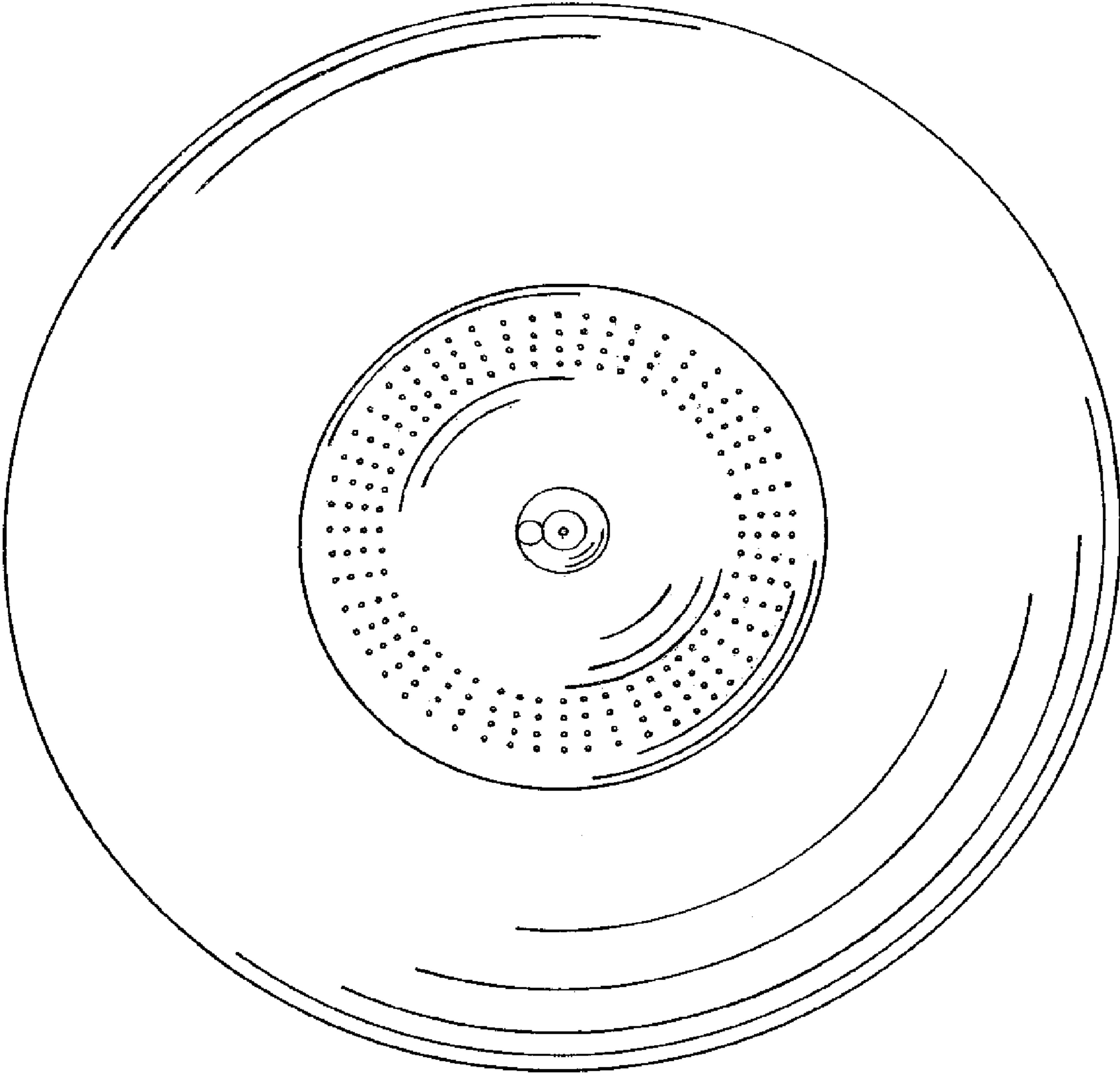

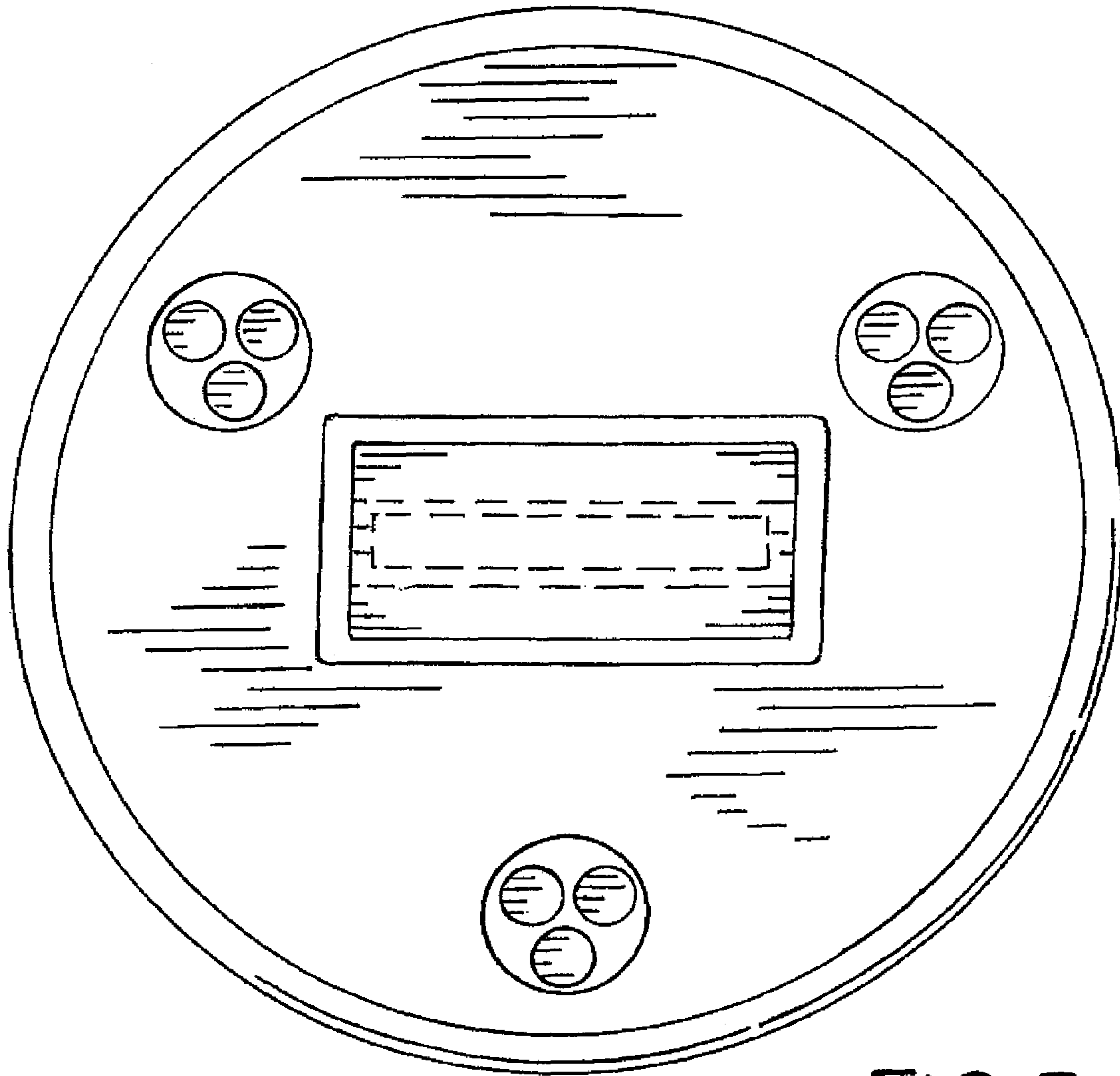

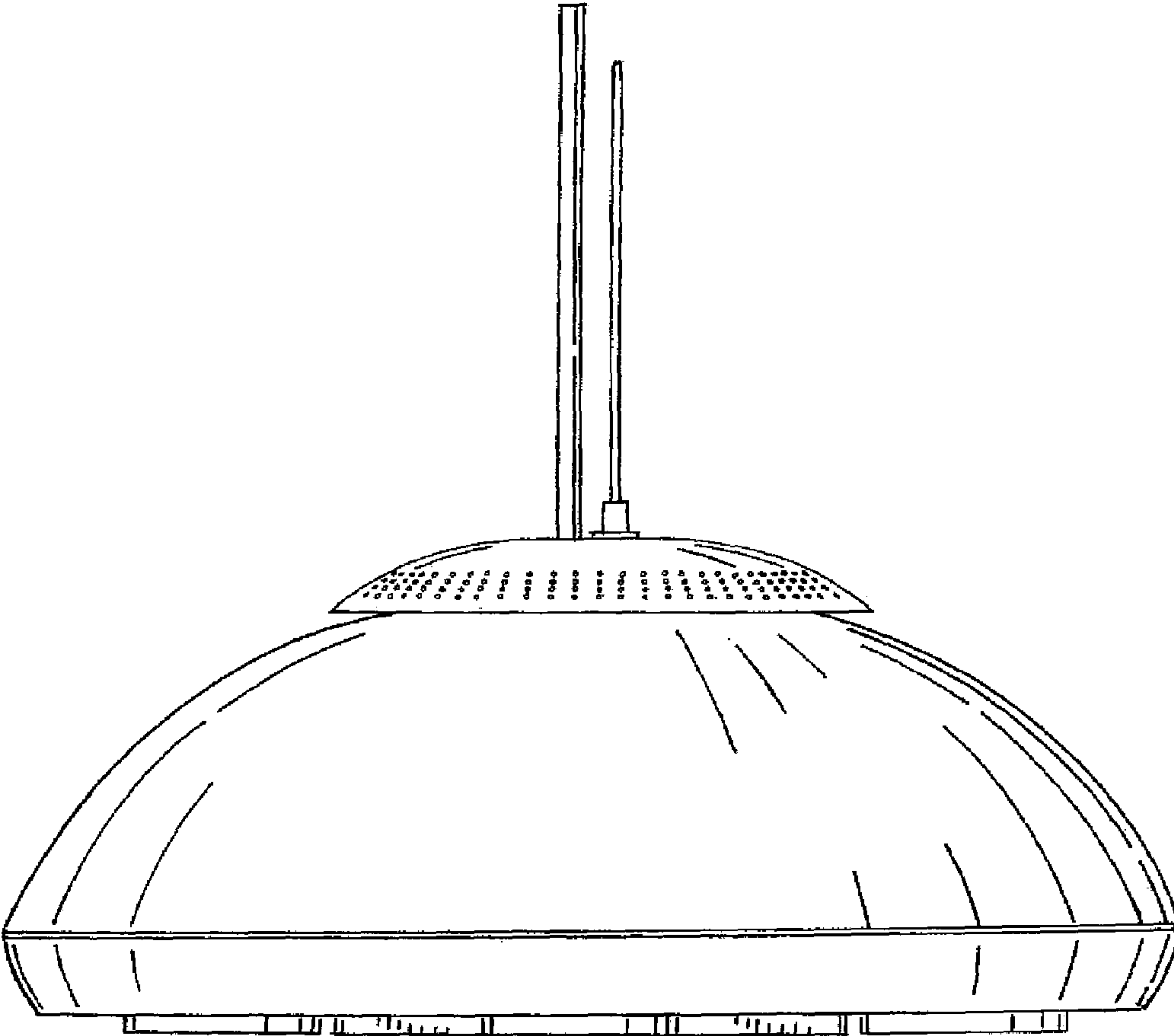

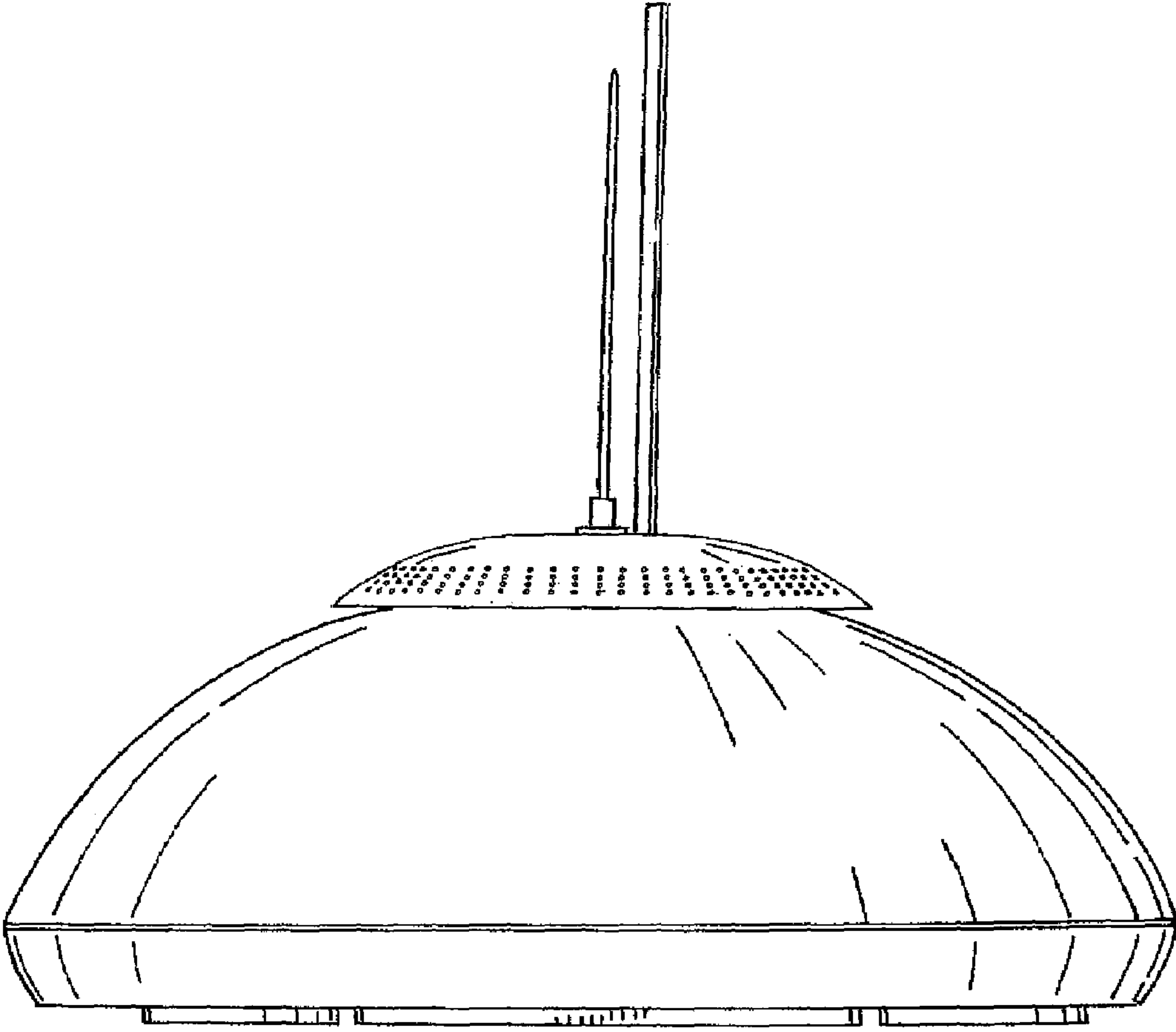

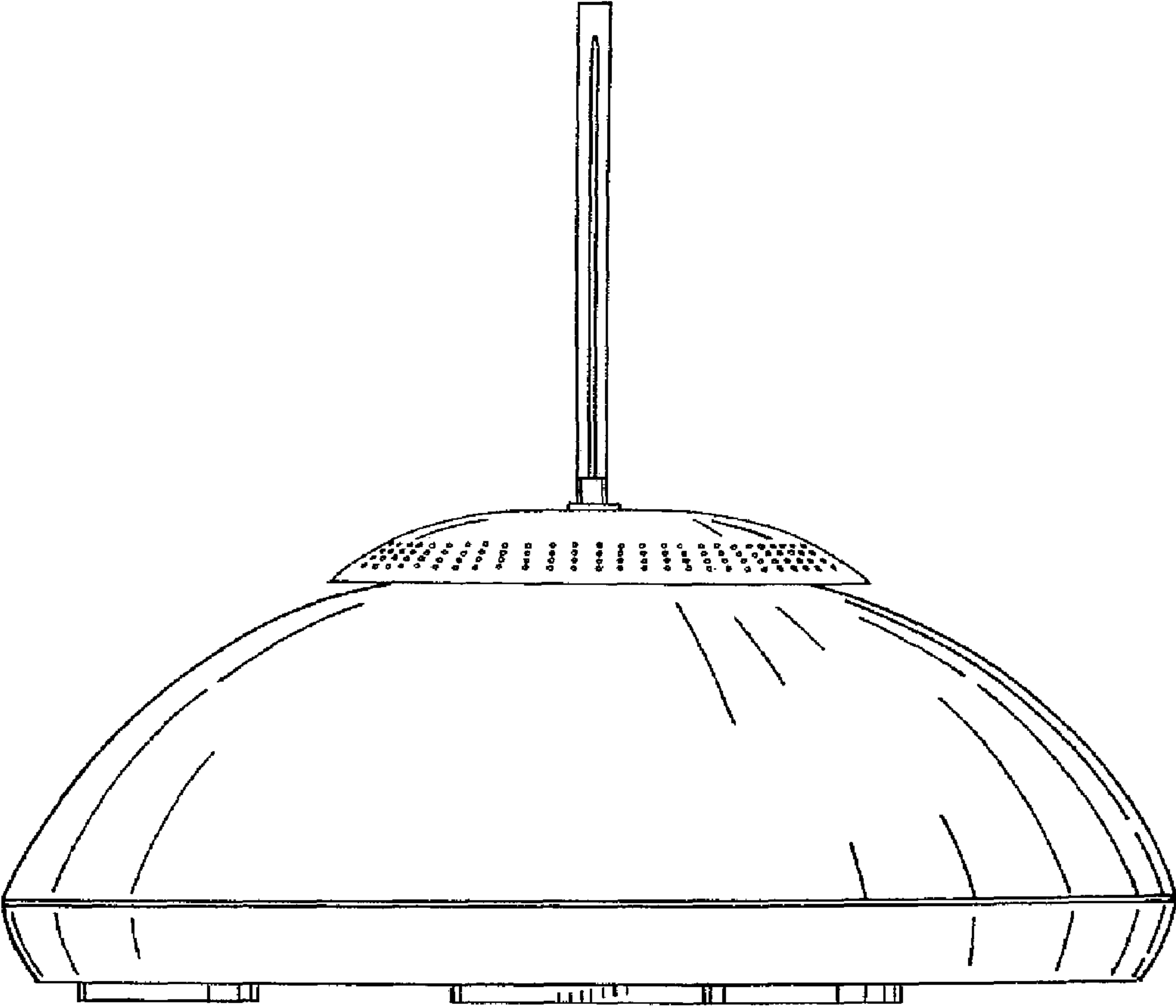

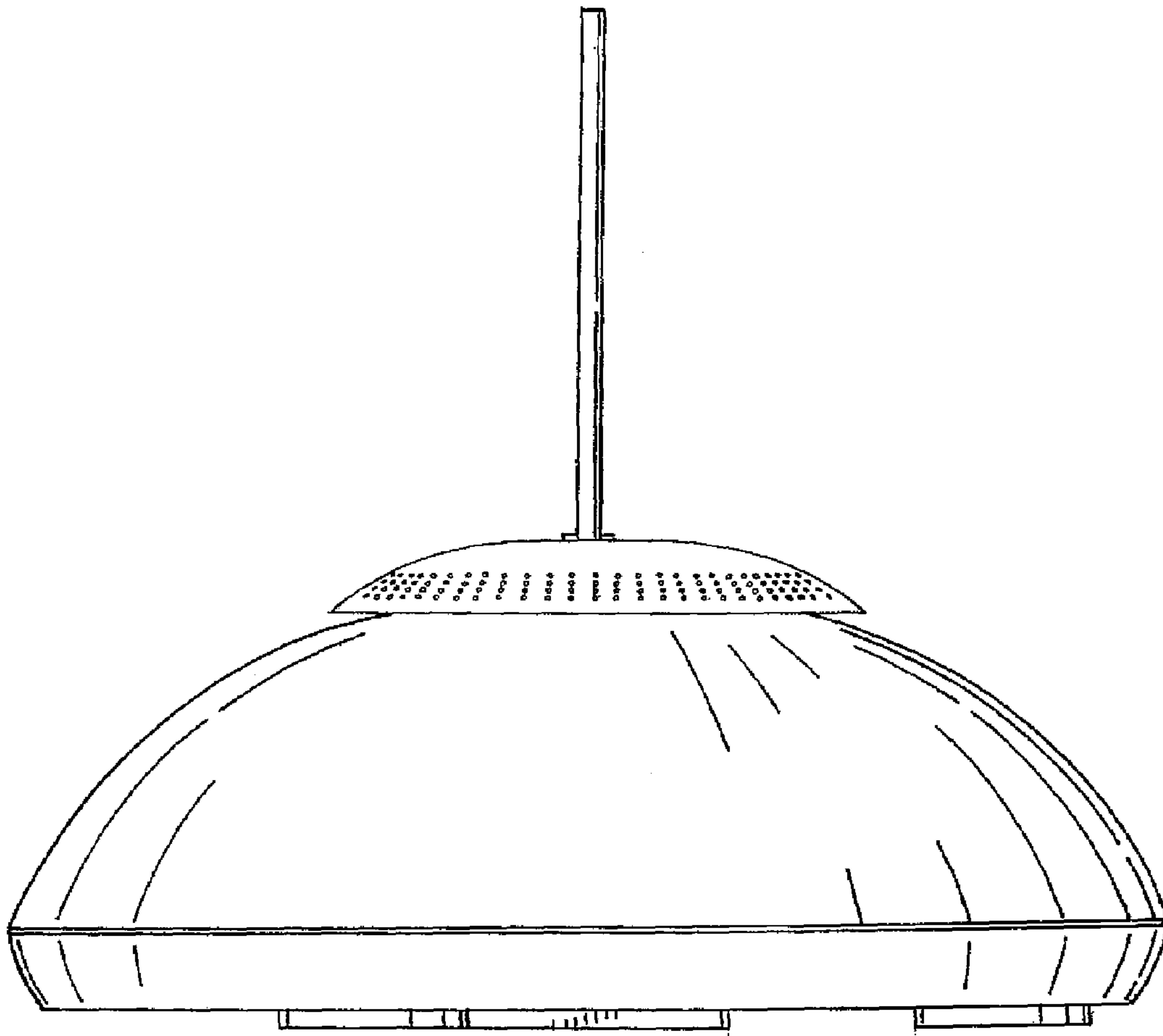

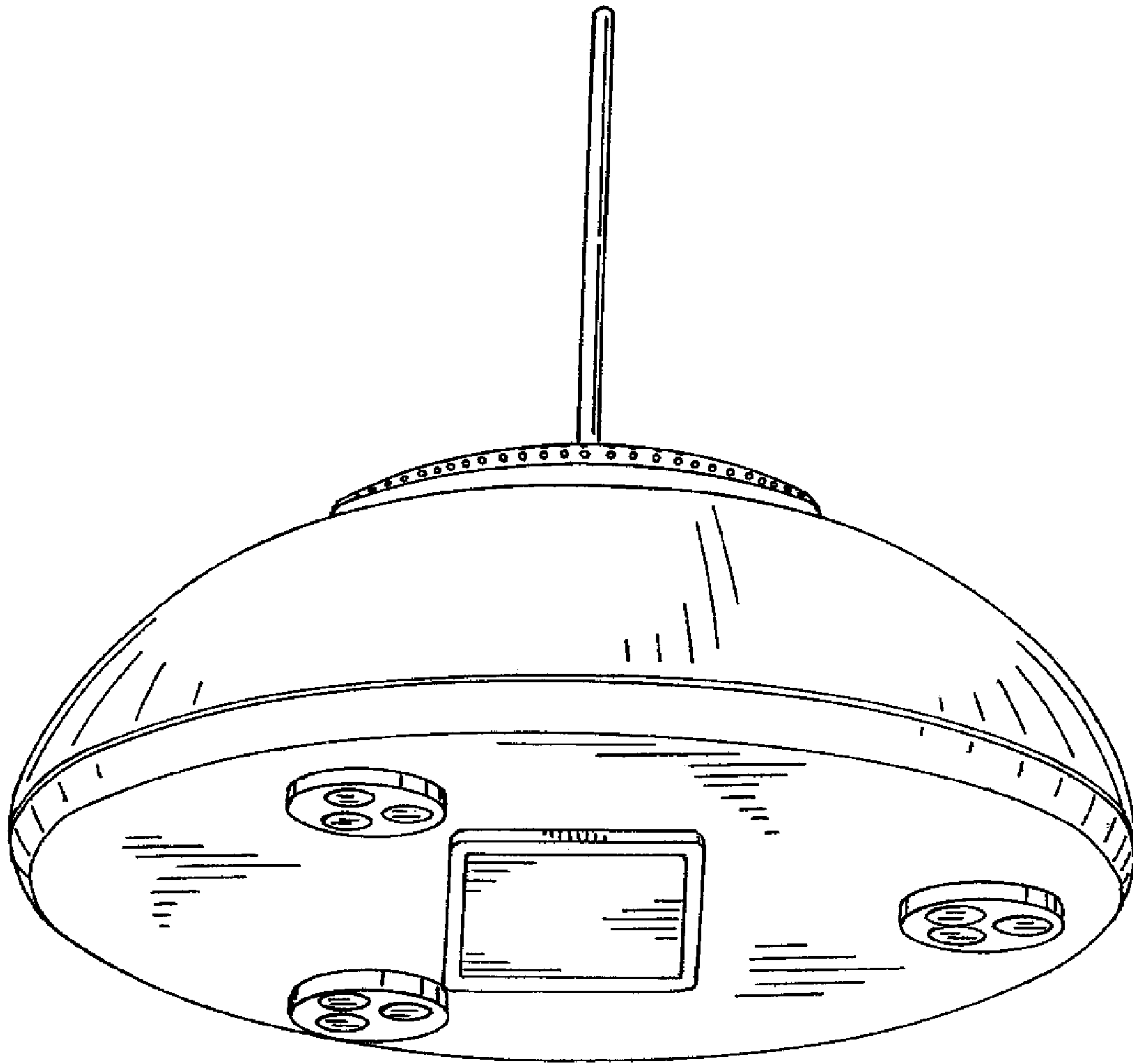
