FIG. 1 is a front perspective view of a sports shoe showing my new design.

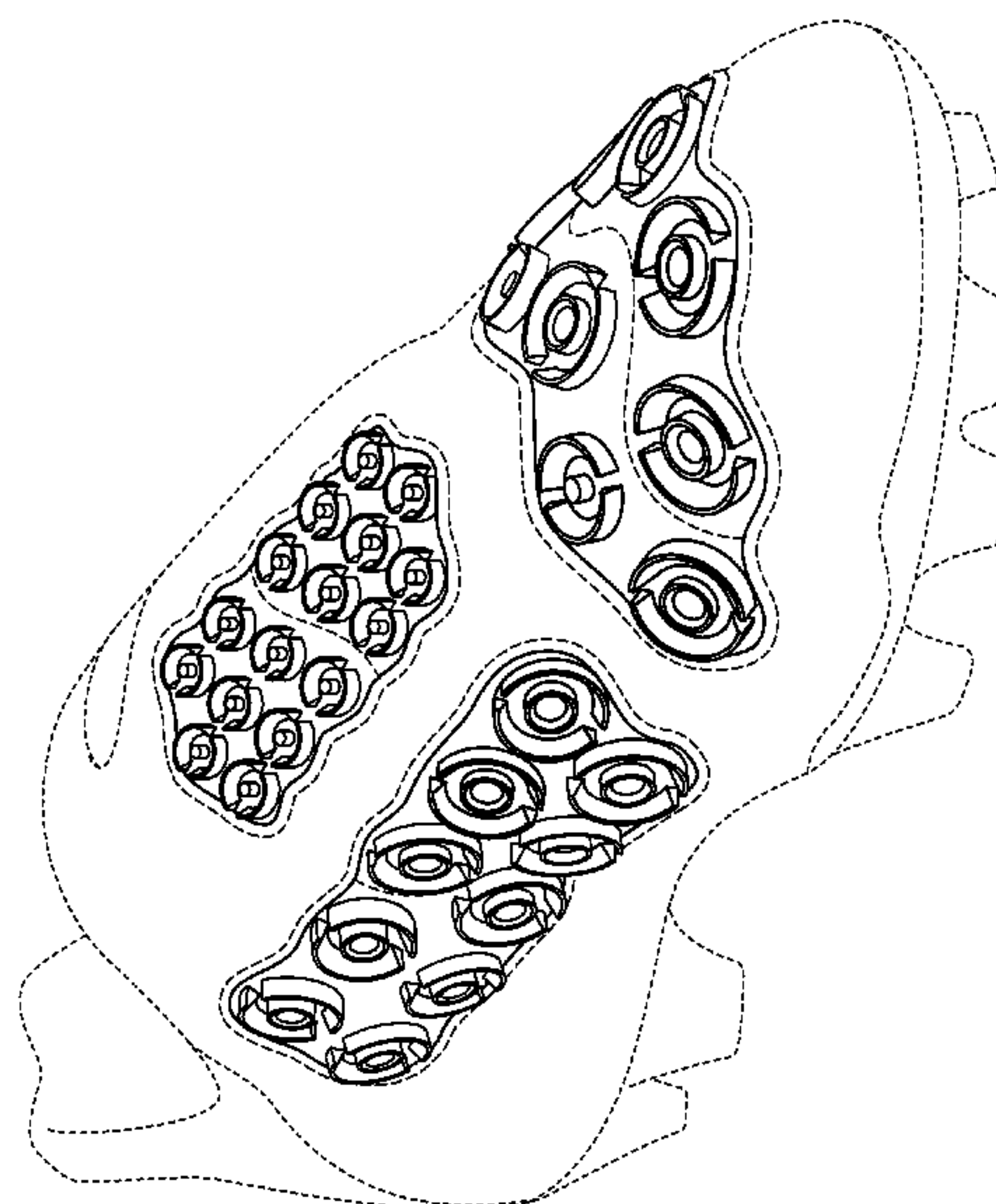
FIG. 2 is a front view of the sports shoe of FIG. 1.

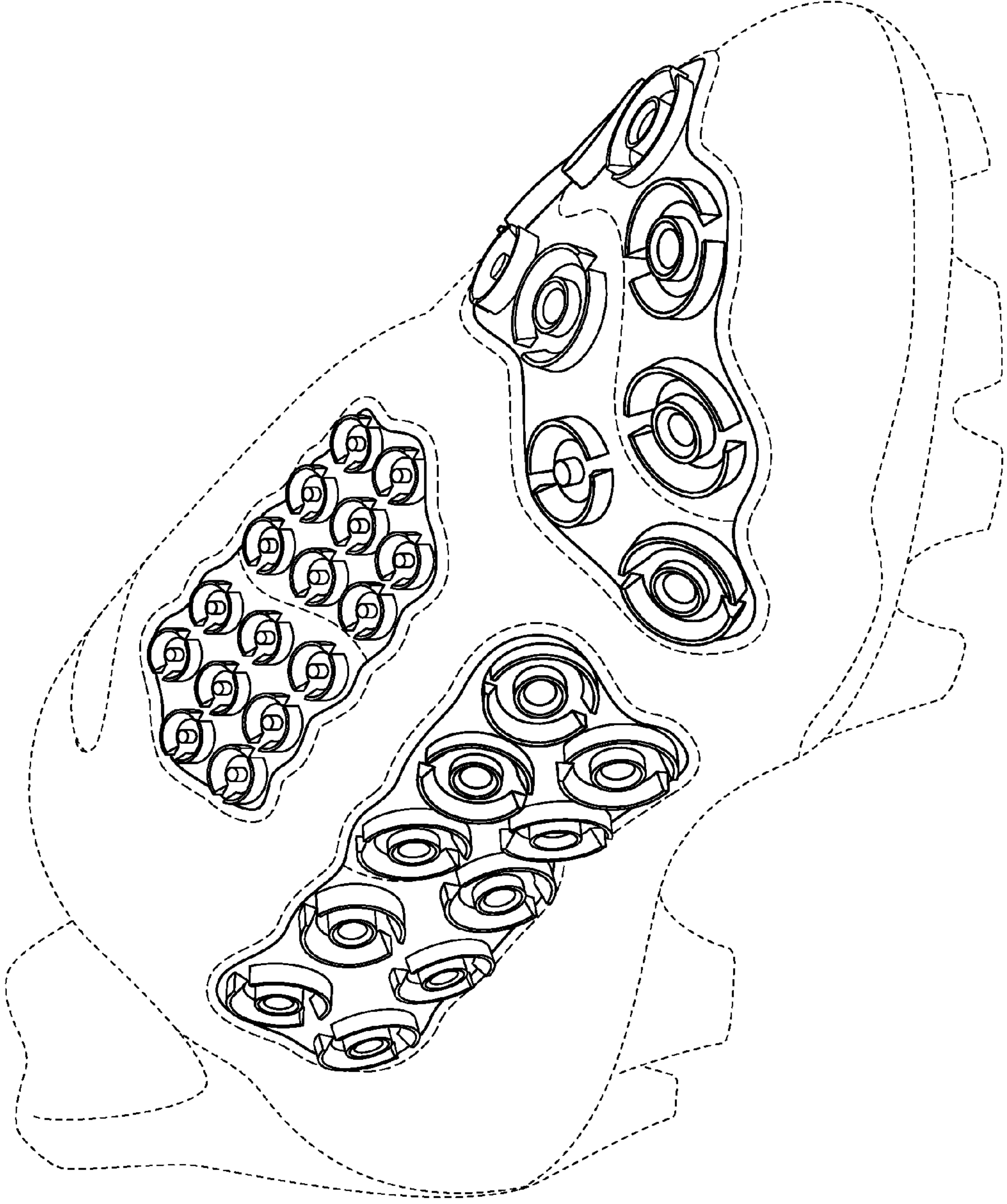

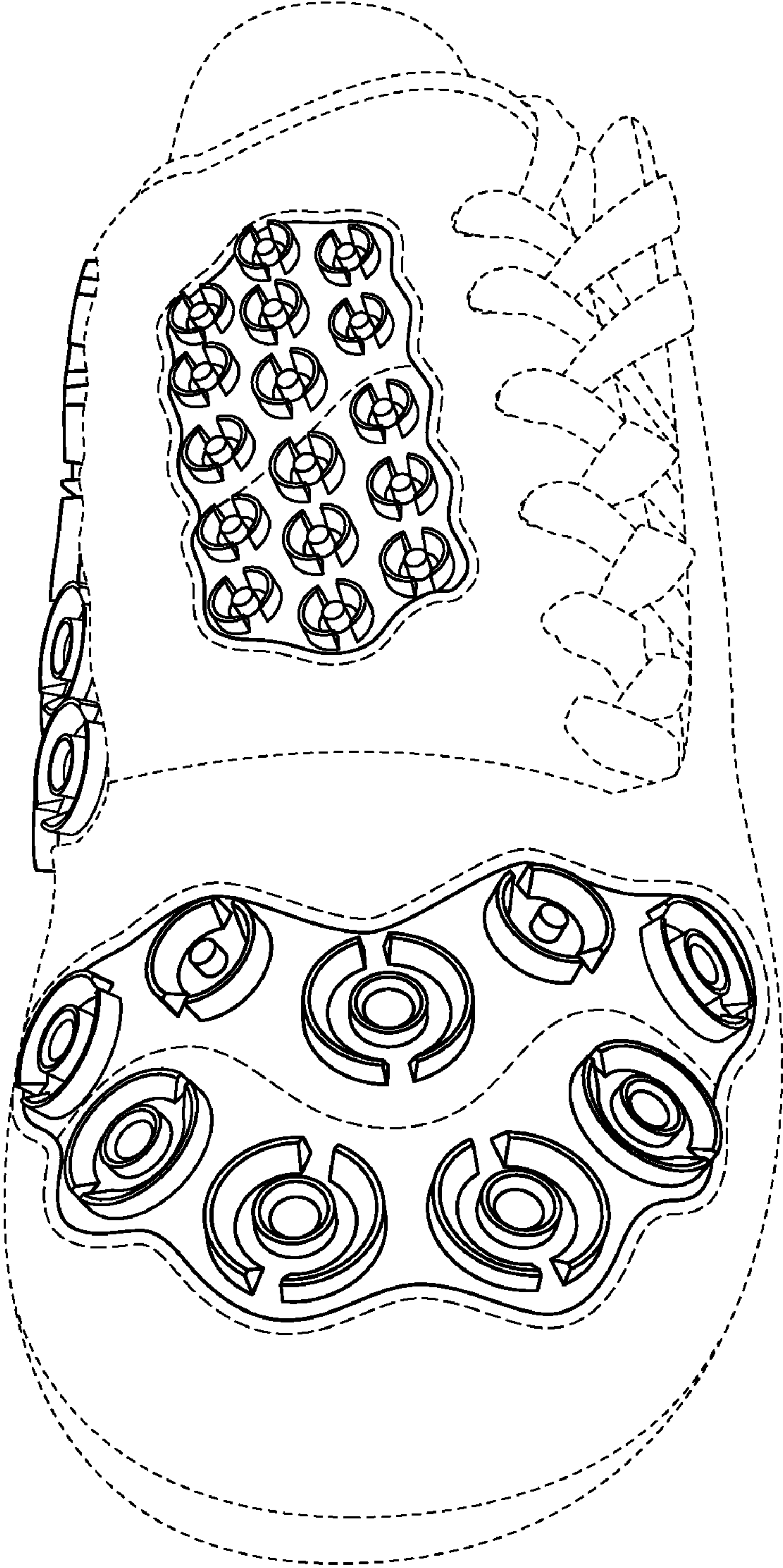

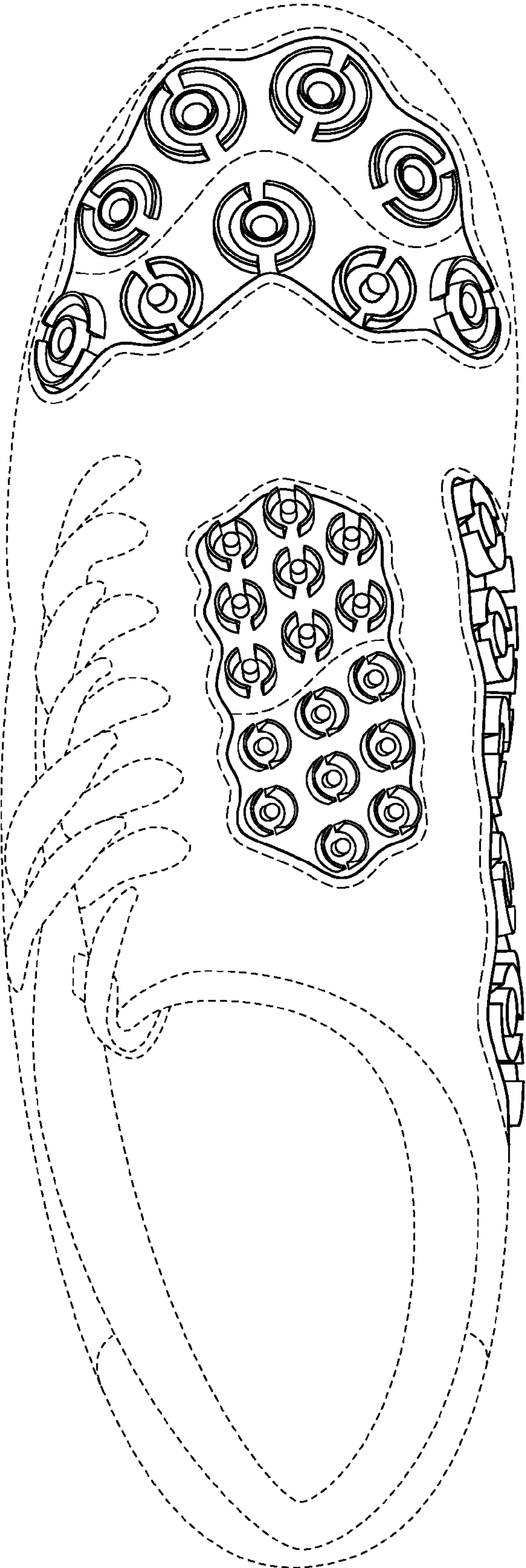

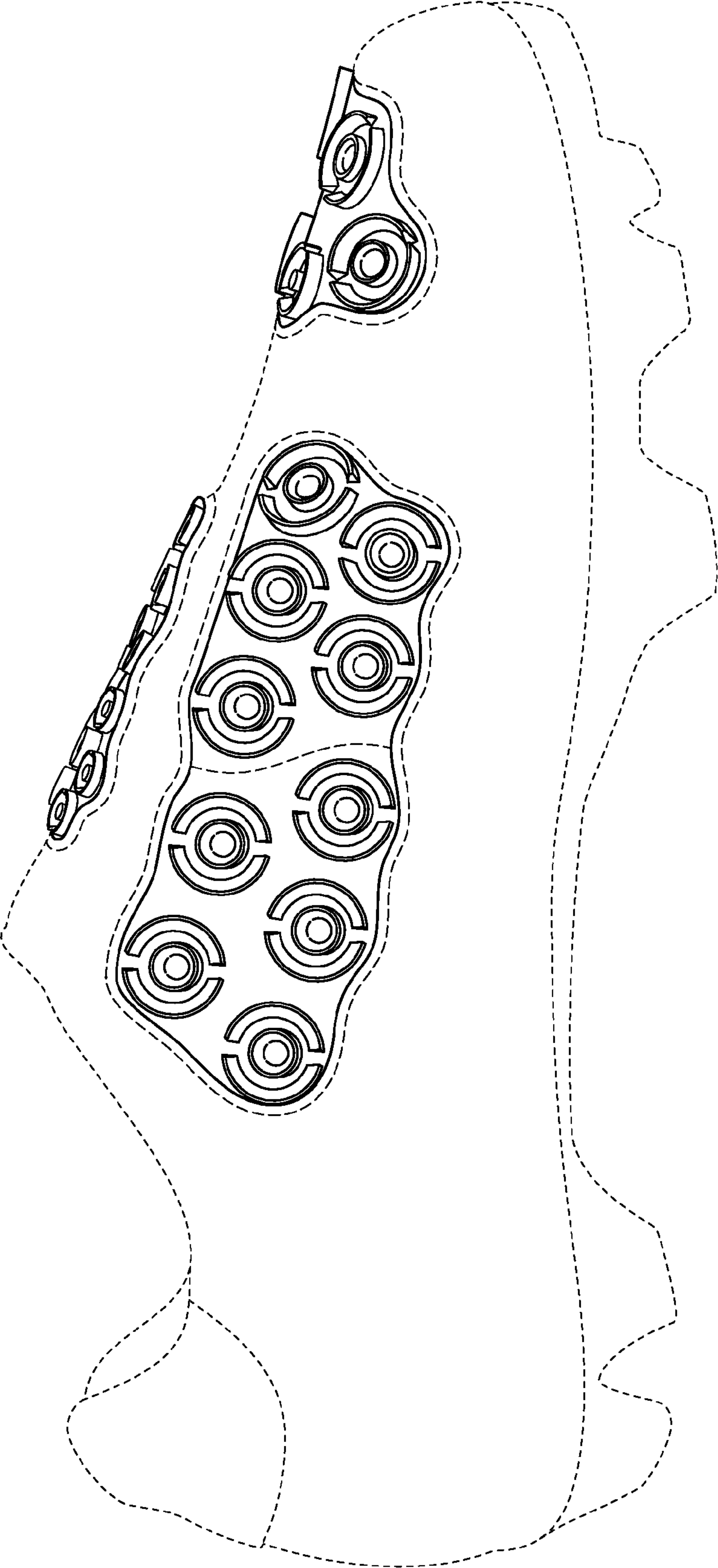

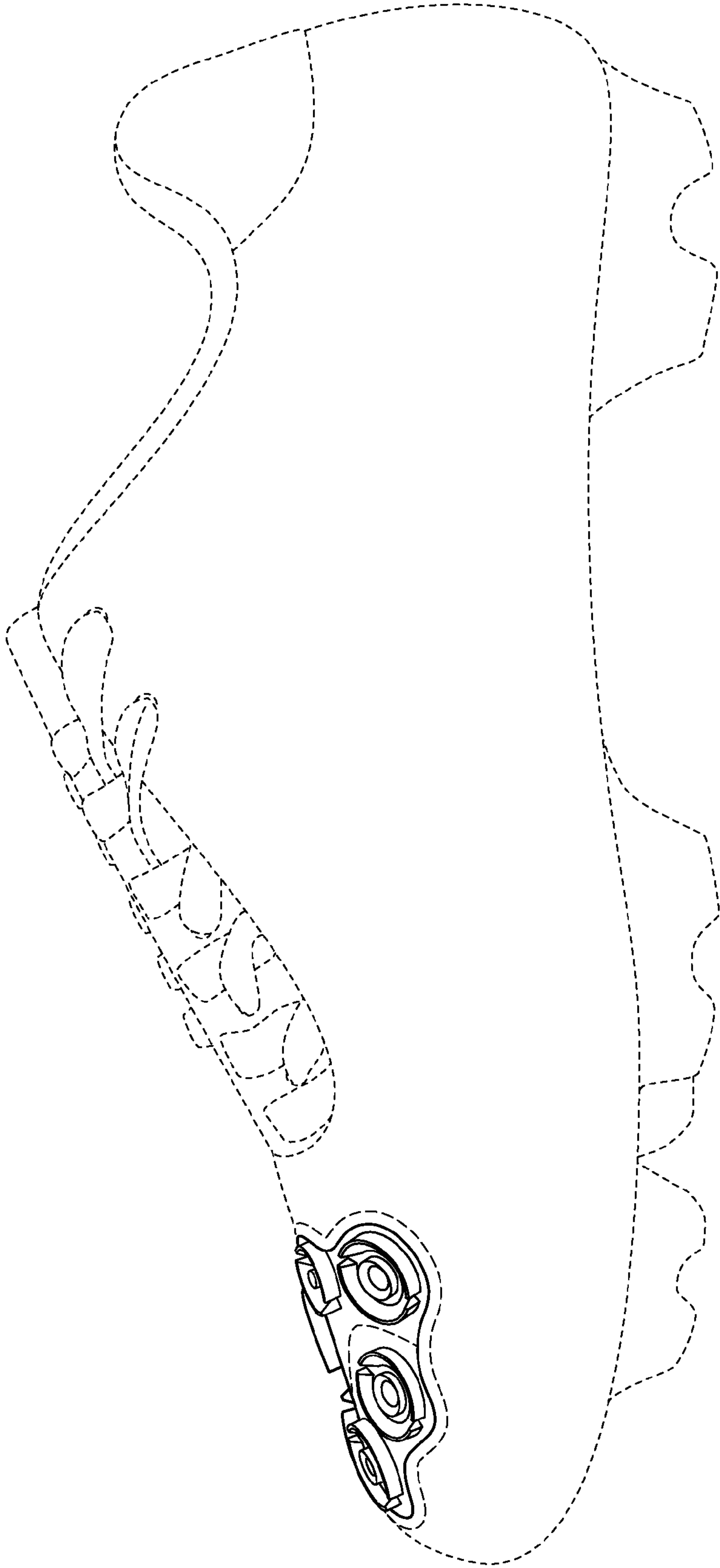
