The ornamental design for a razor storage case, as shown and described.

DESCRIPTION

FIG. 1 is a top right perspective view of a razor storage case showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left side elevational view thereof; and,

FIG. 6 is a front elevational view thereof.

Broken lines in the figures are illustrative of environment and form no part of the claimed design.

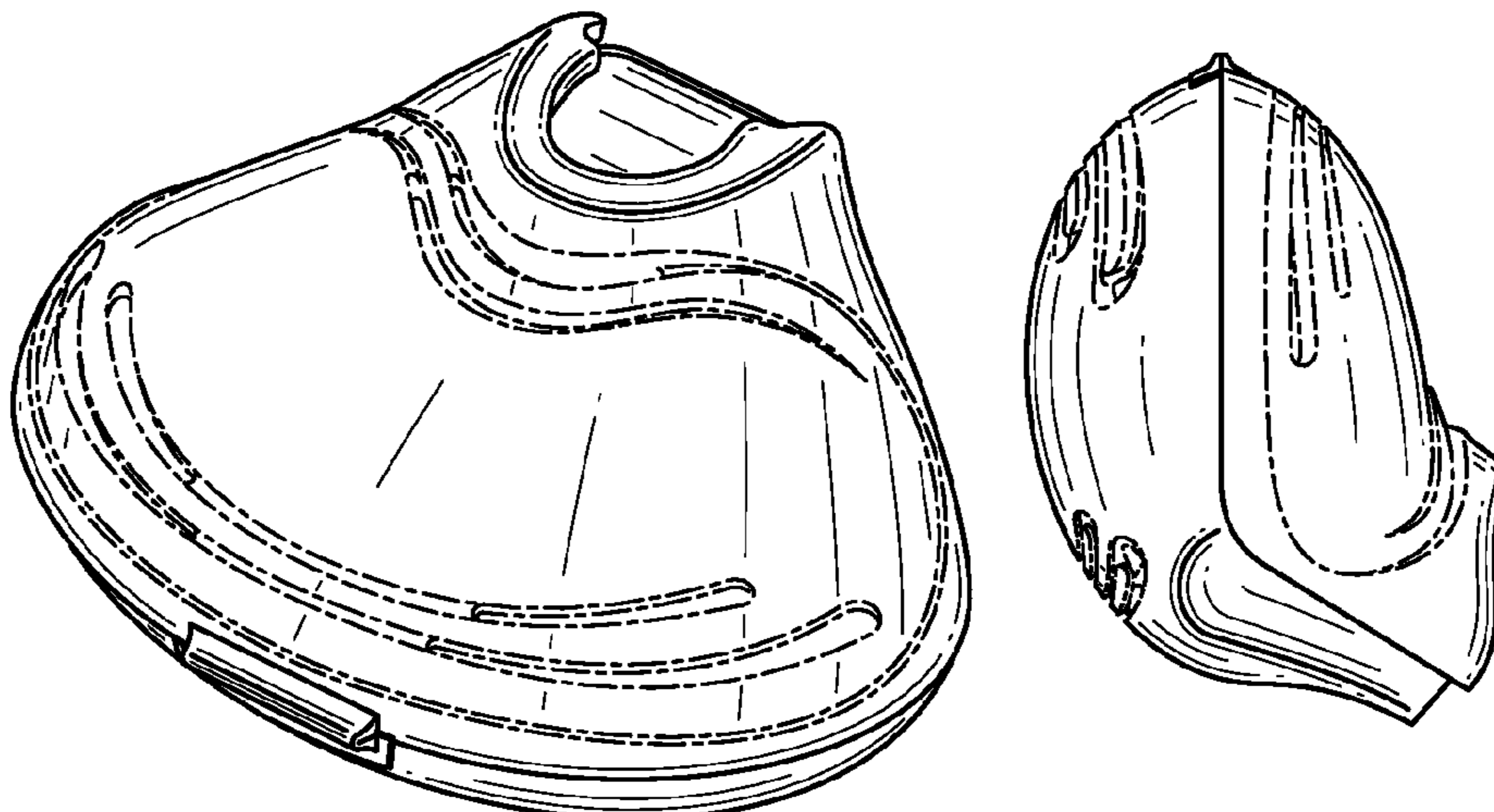

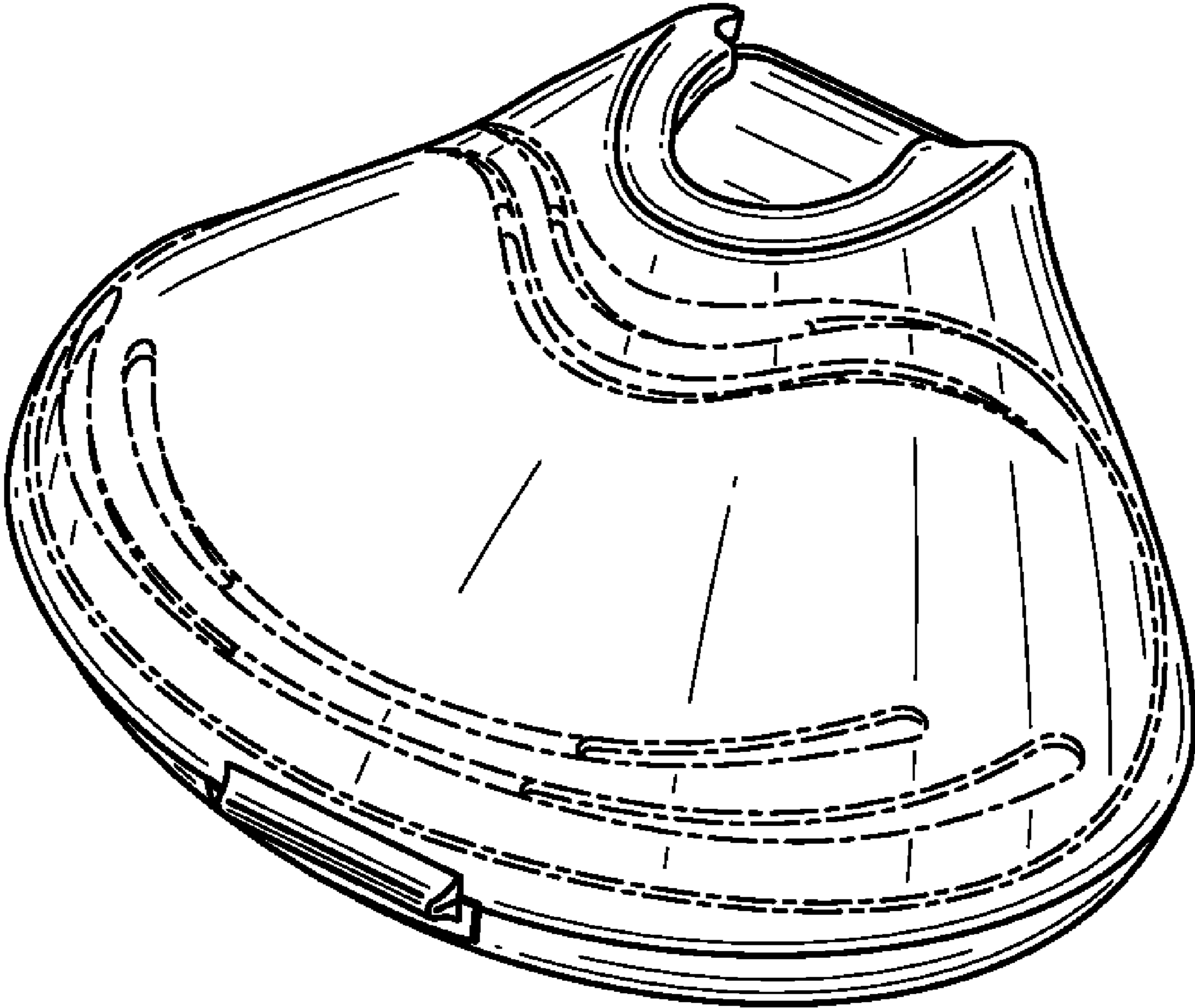

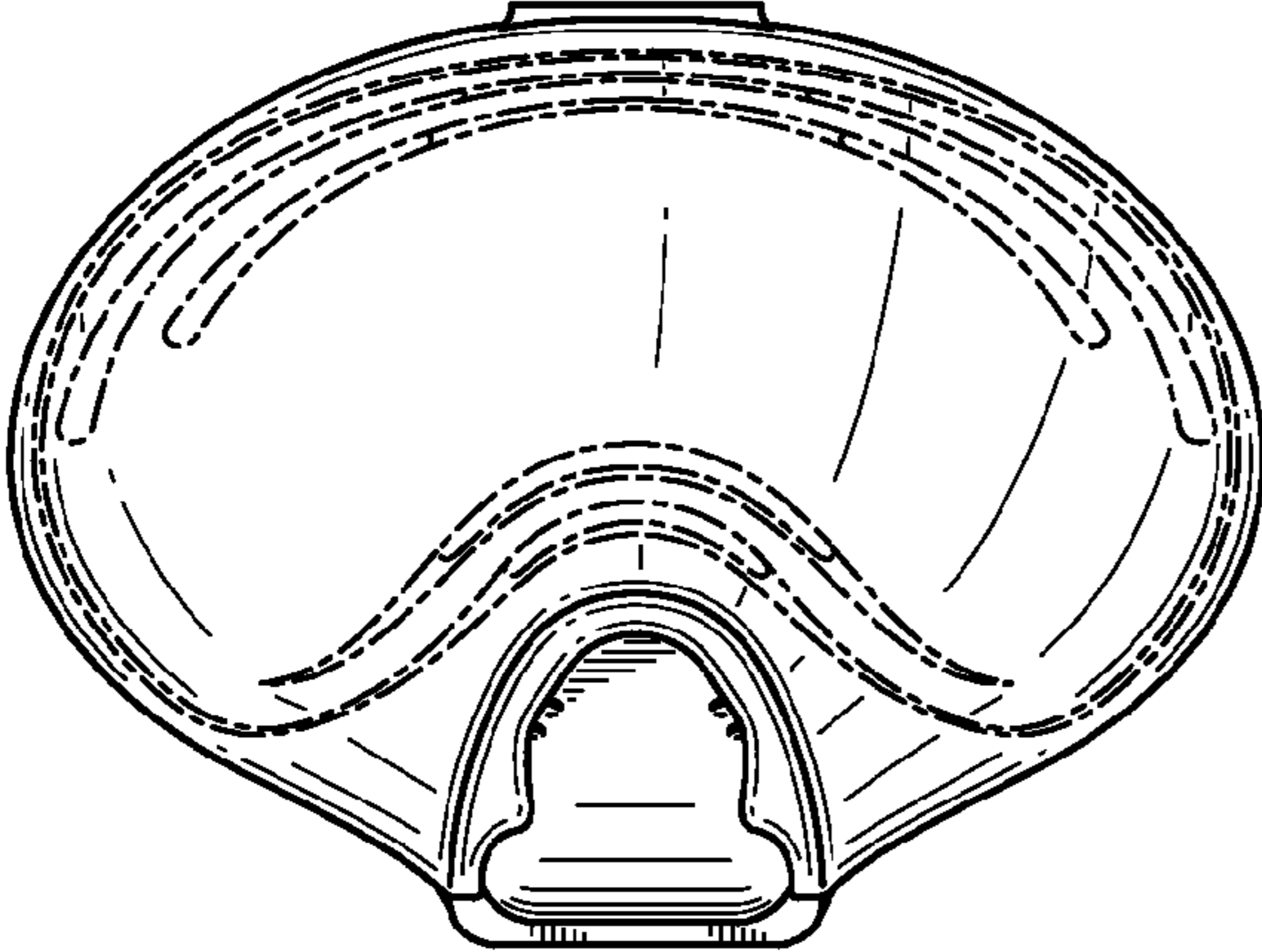

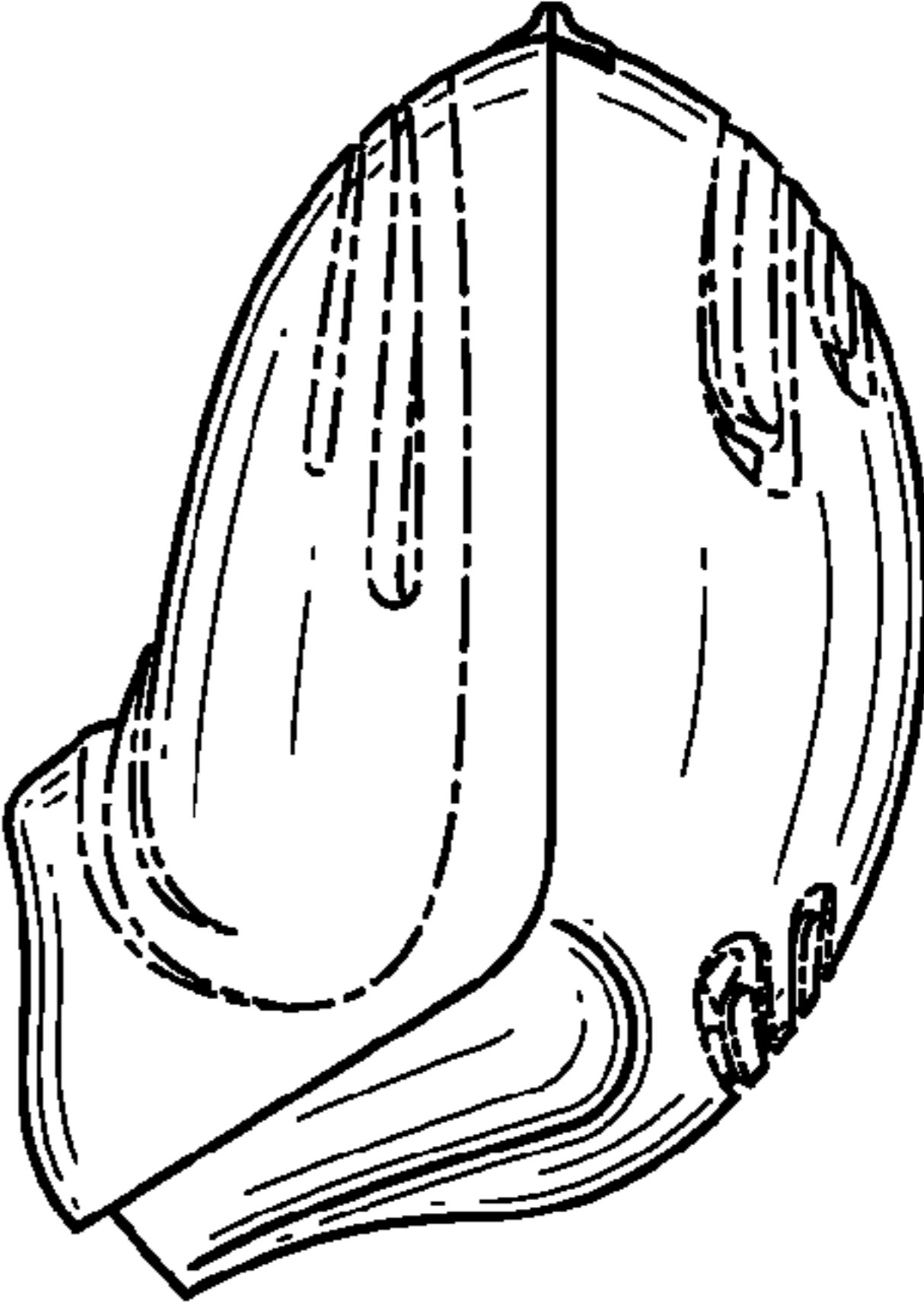

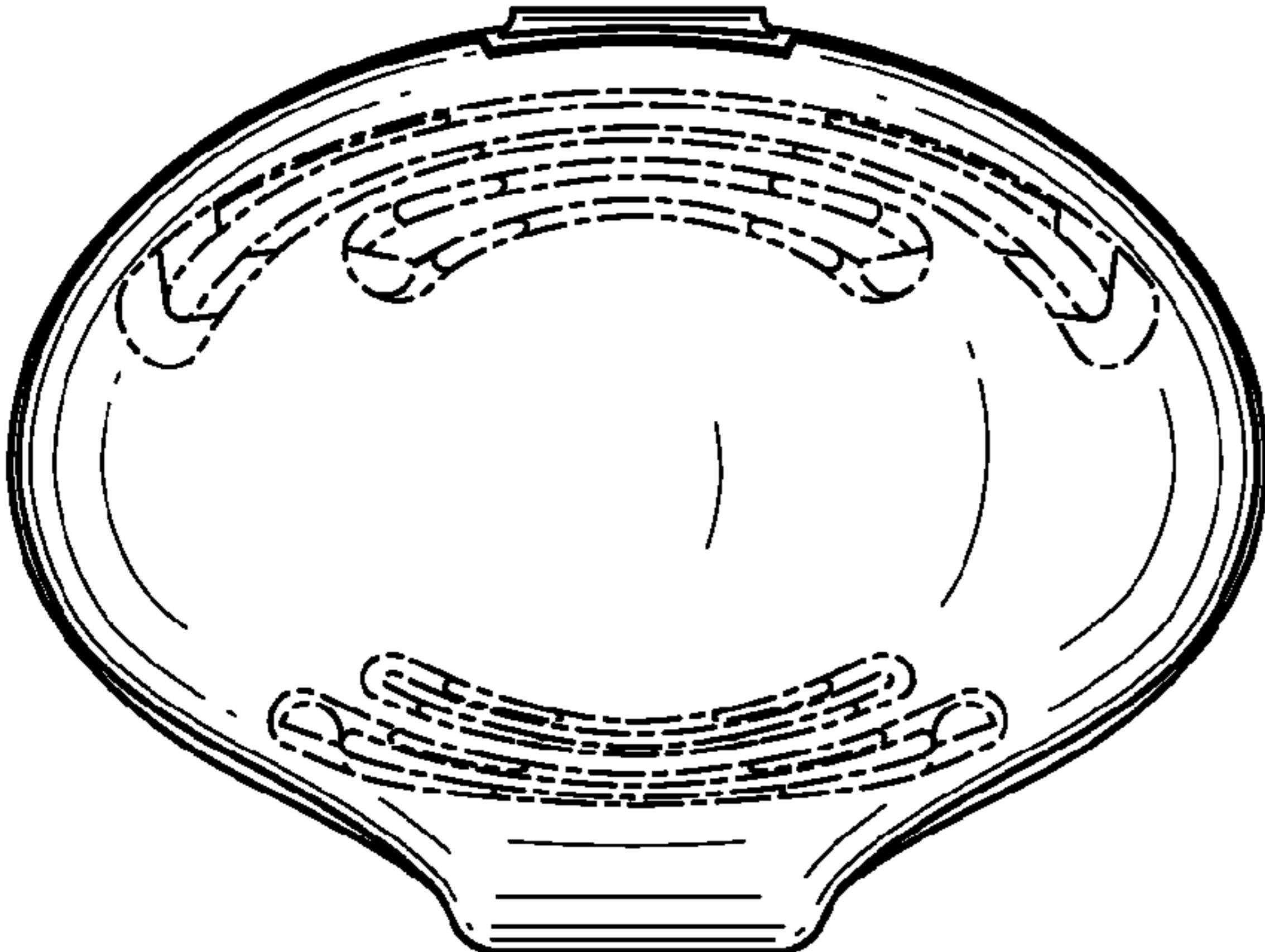

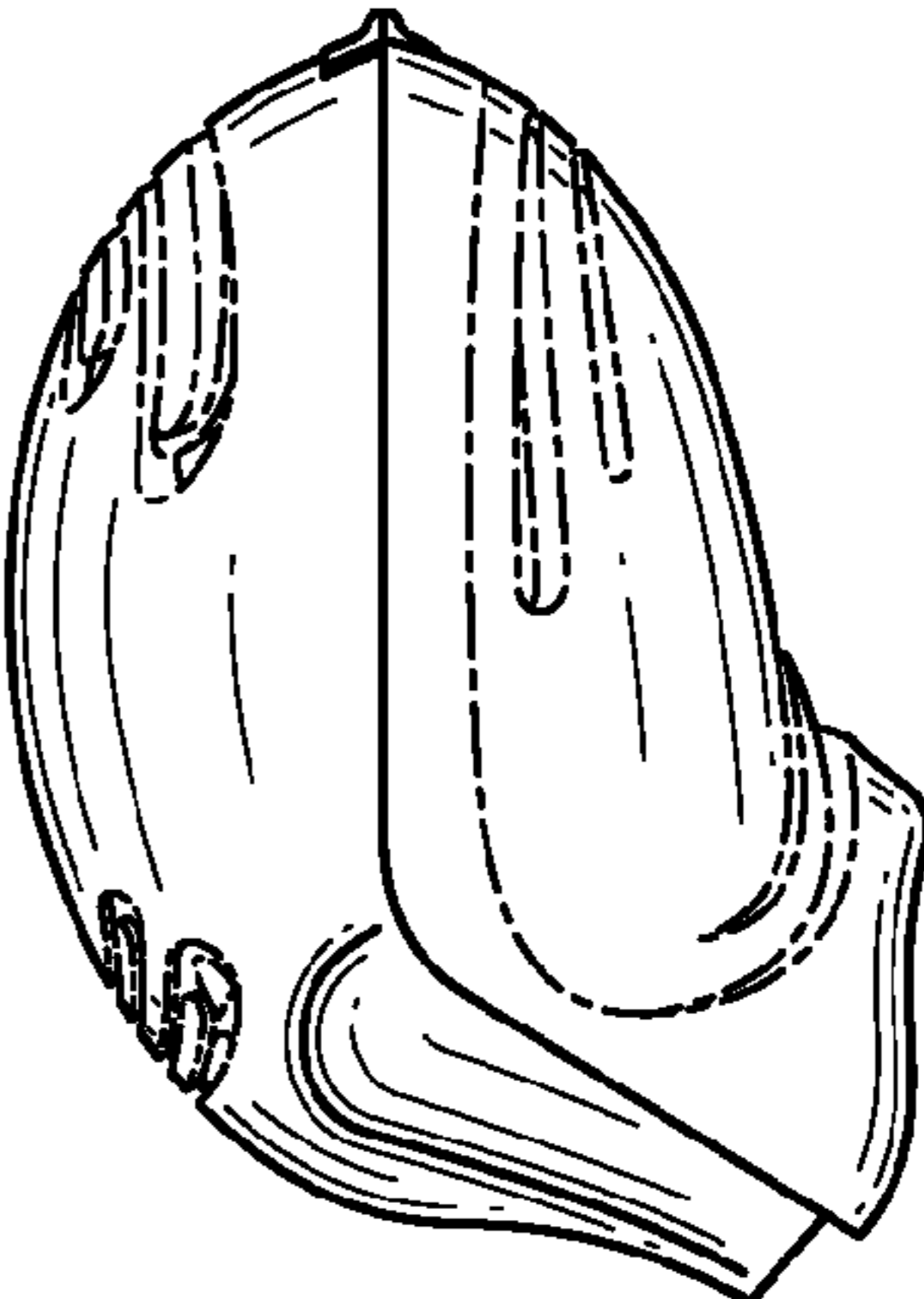
