FIG. 16 is a front view of the indicia for fabric treatment product of FIG. 15.

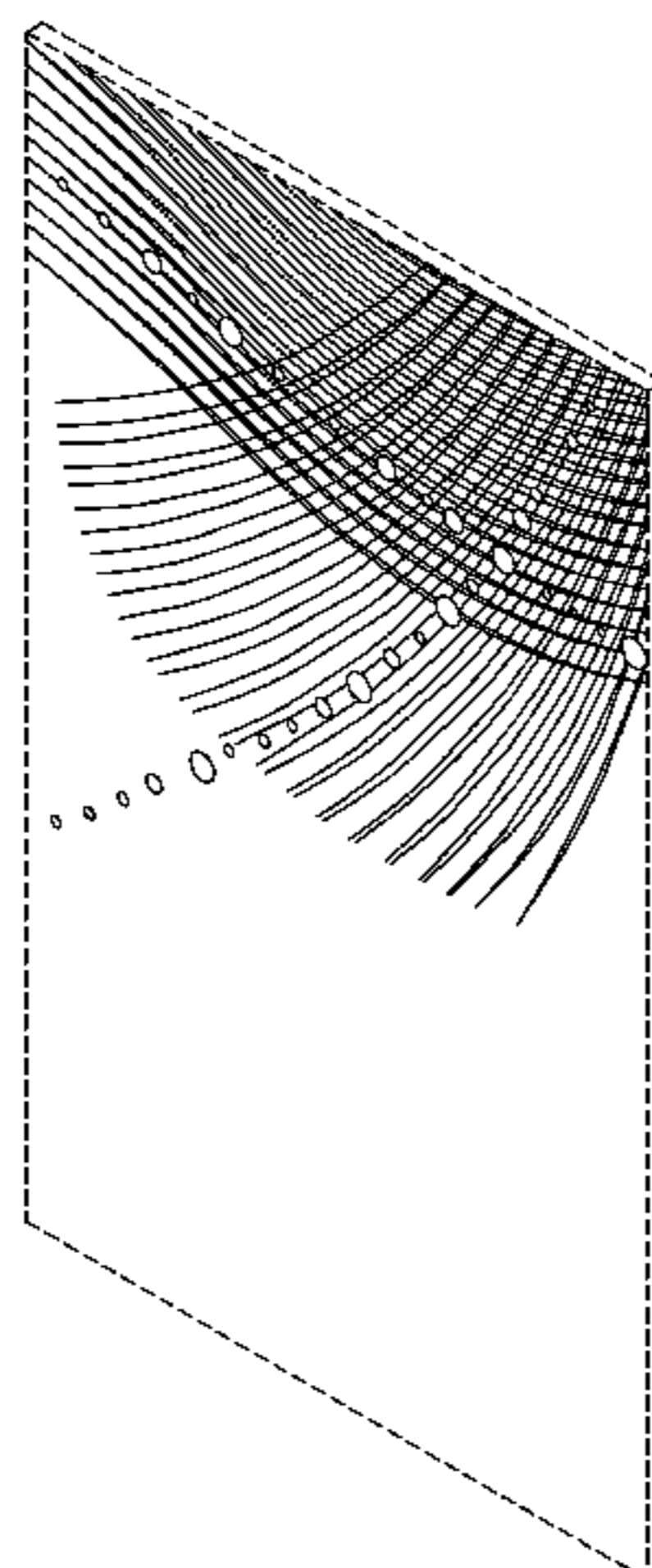


FIG. 17 is a left side view of the indicia for fabric treatment product of FIG. 15.

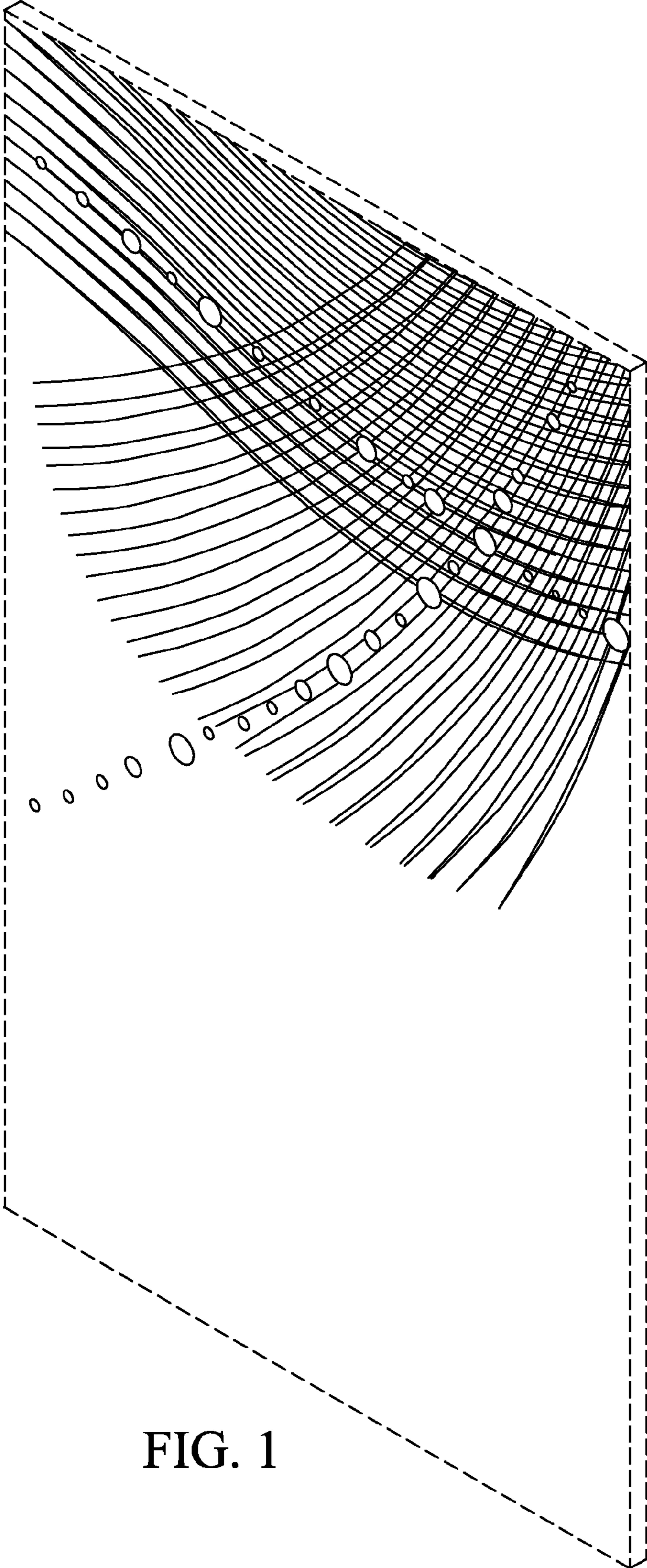

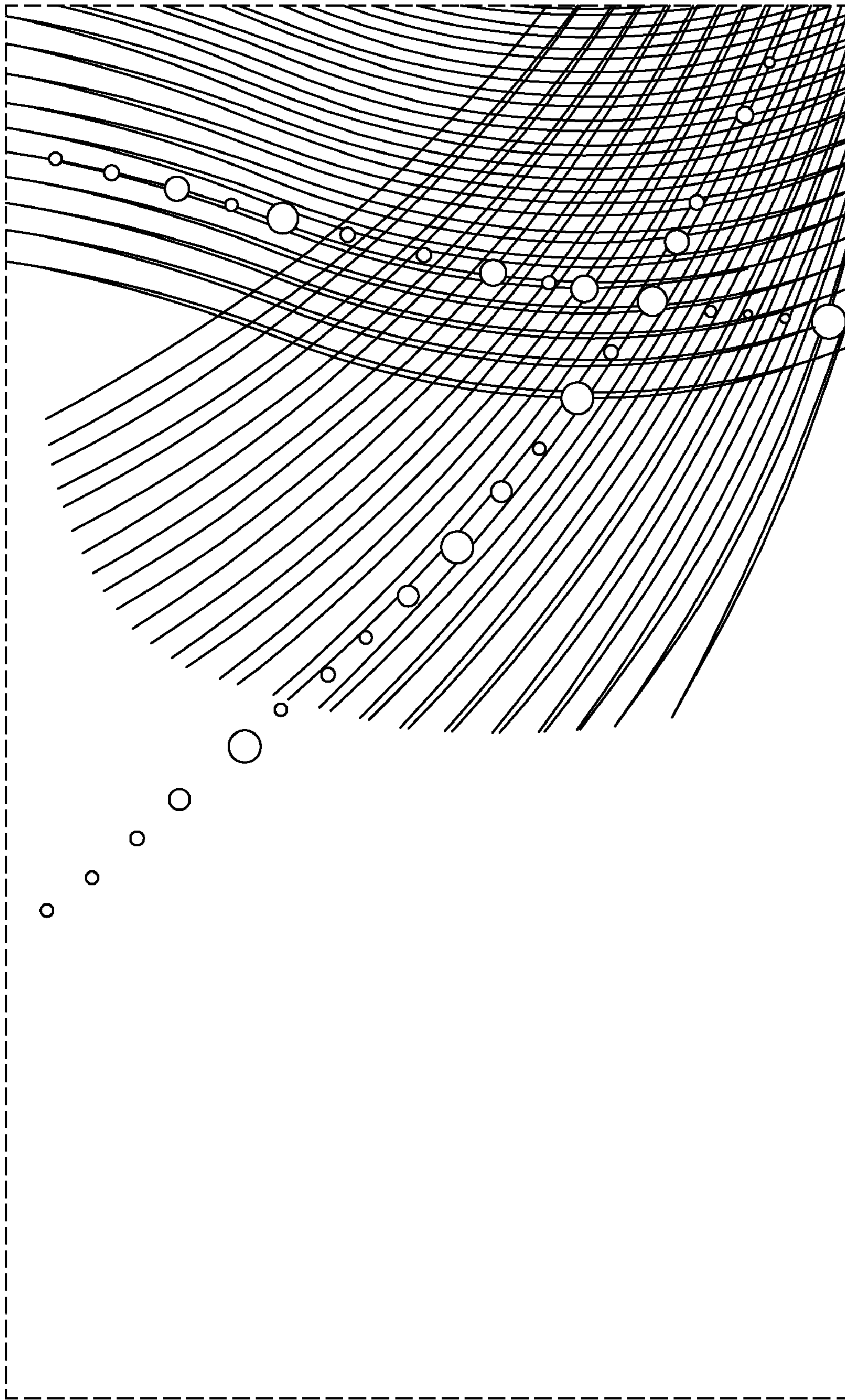

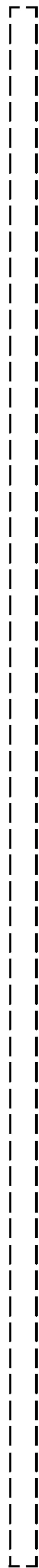

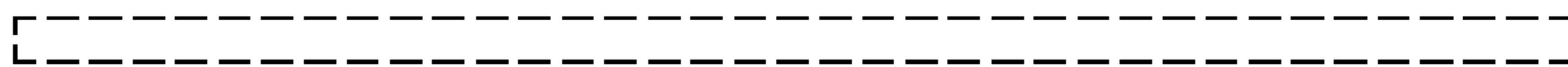

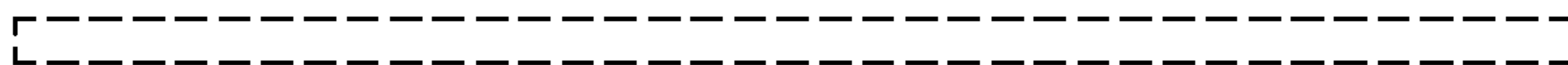

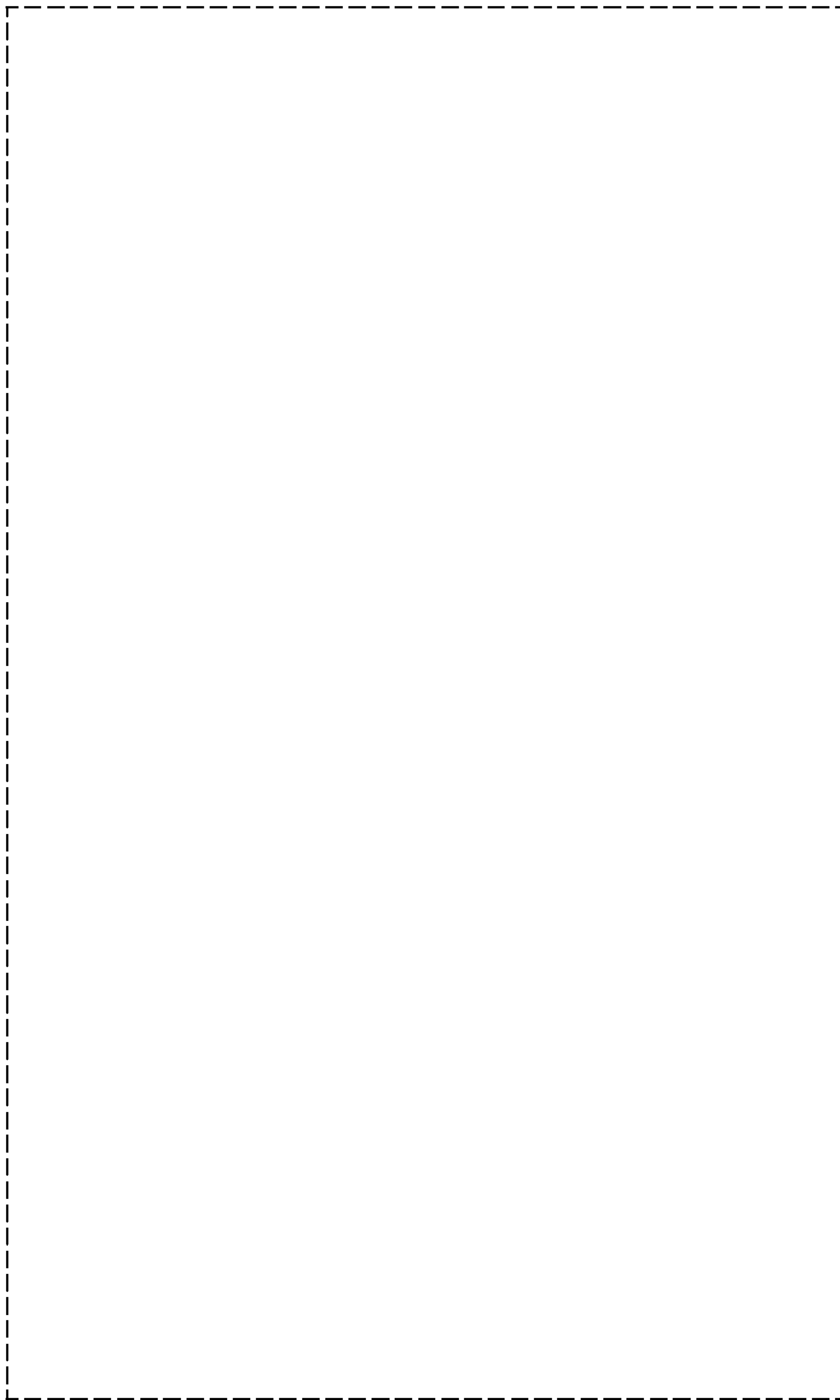

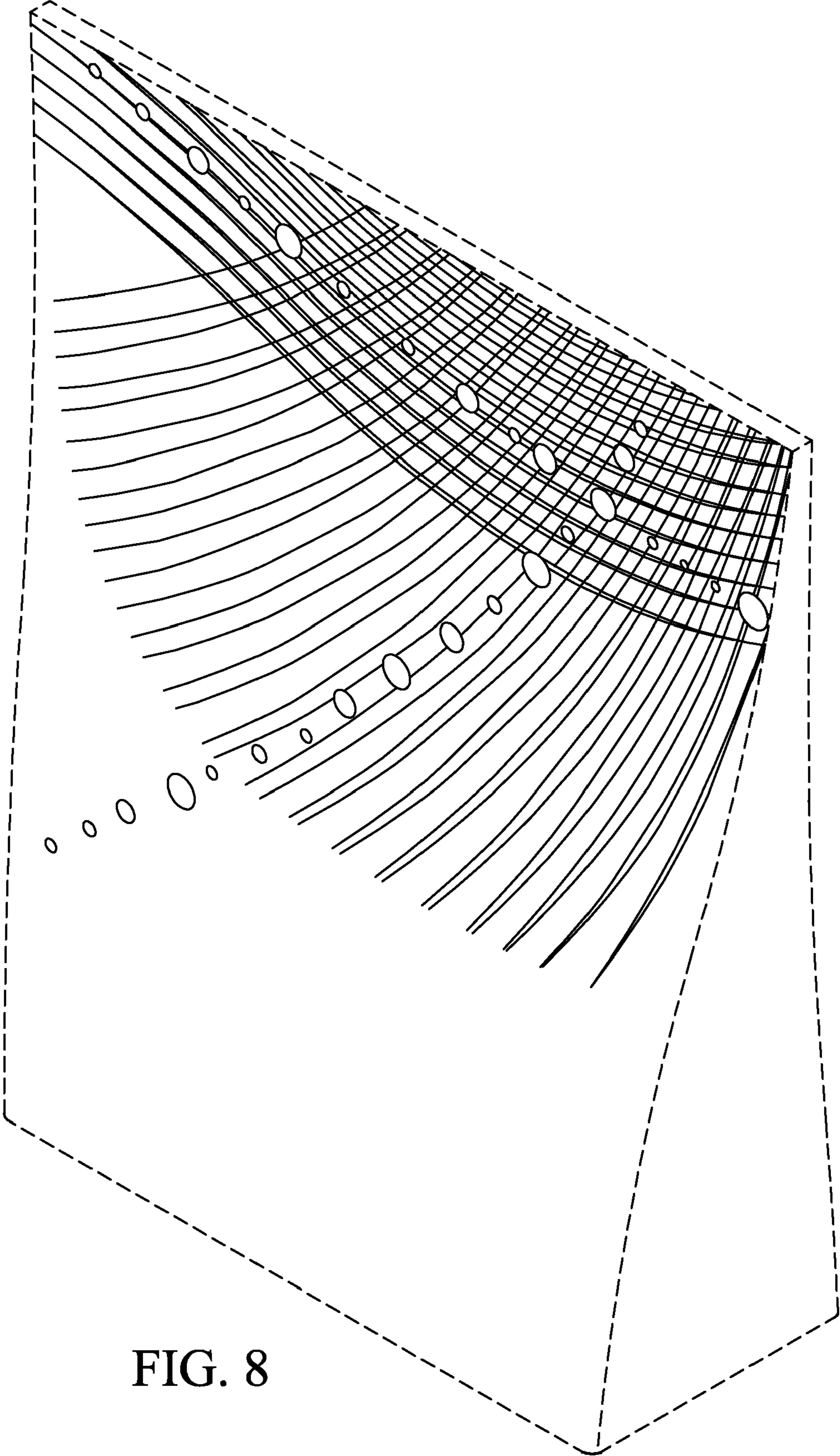

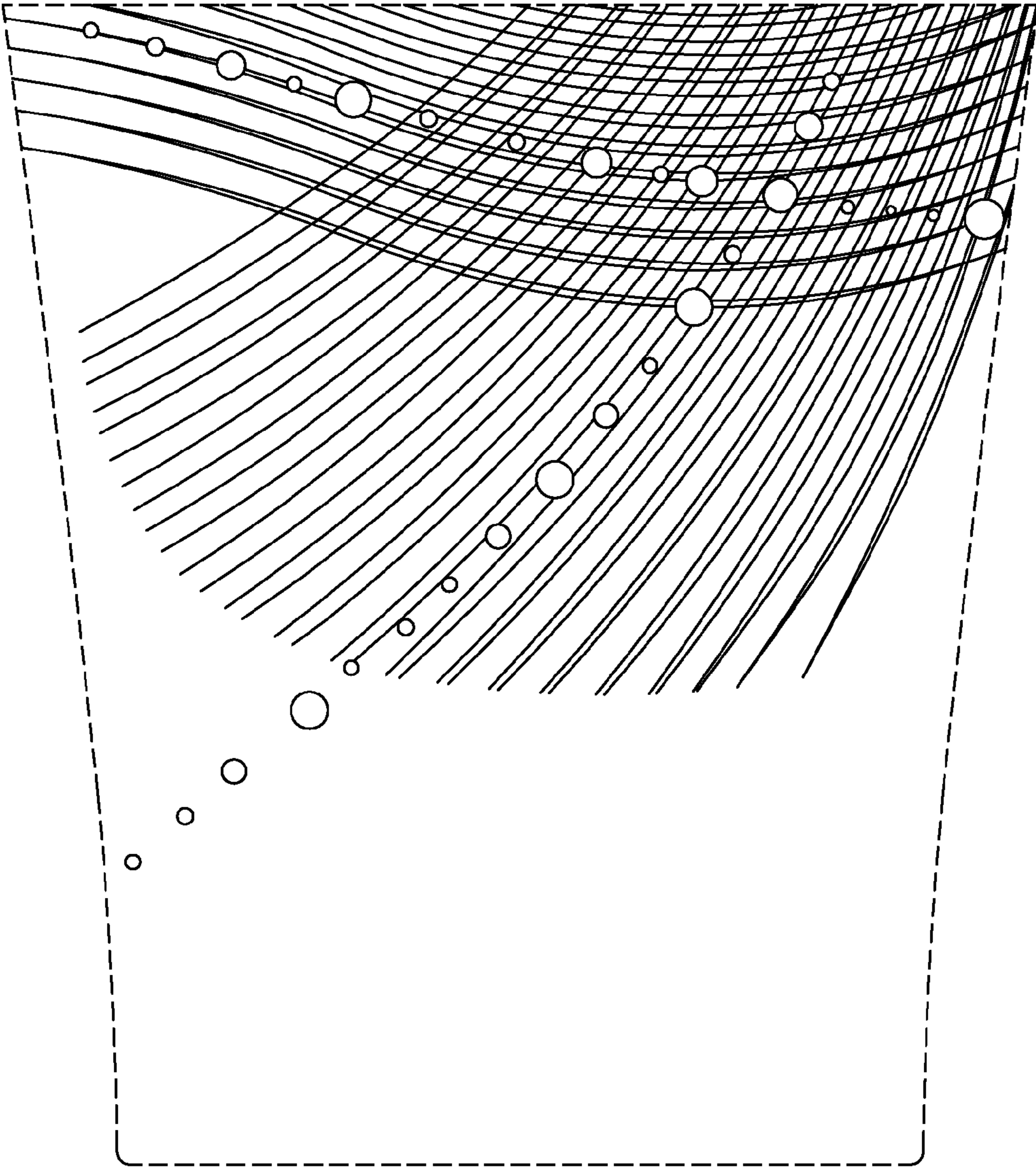

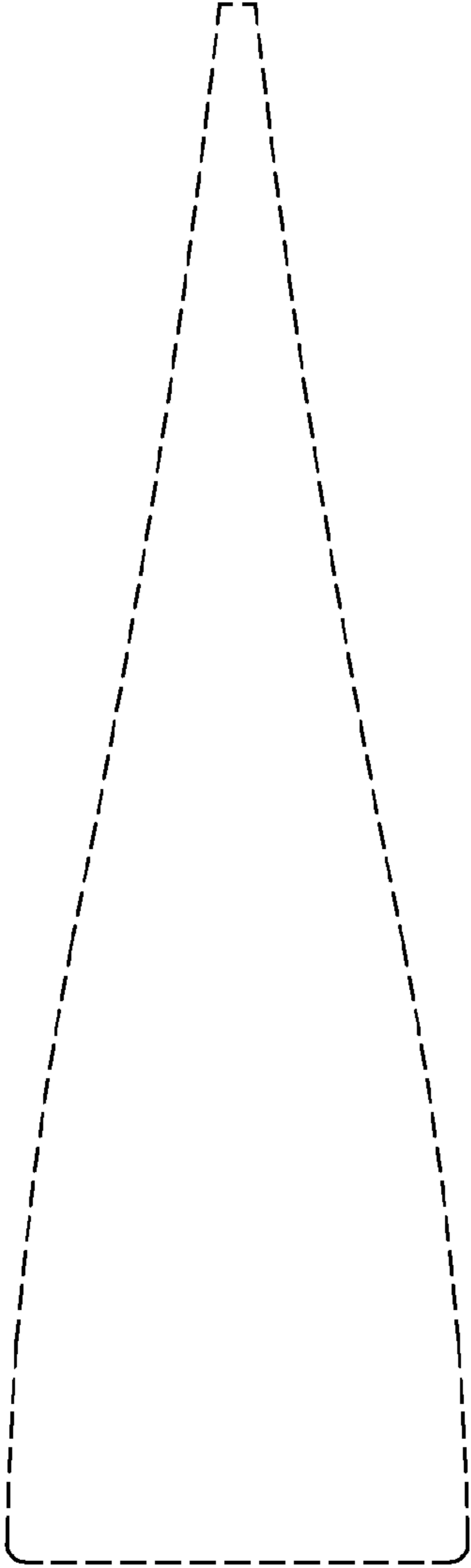

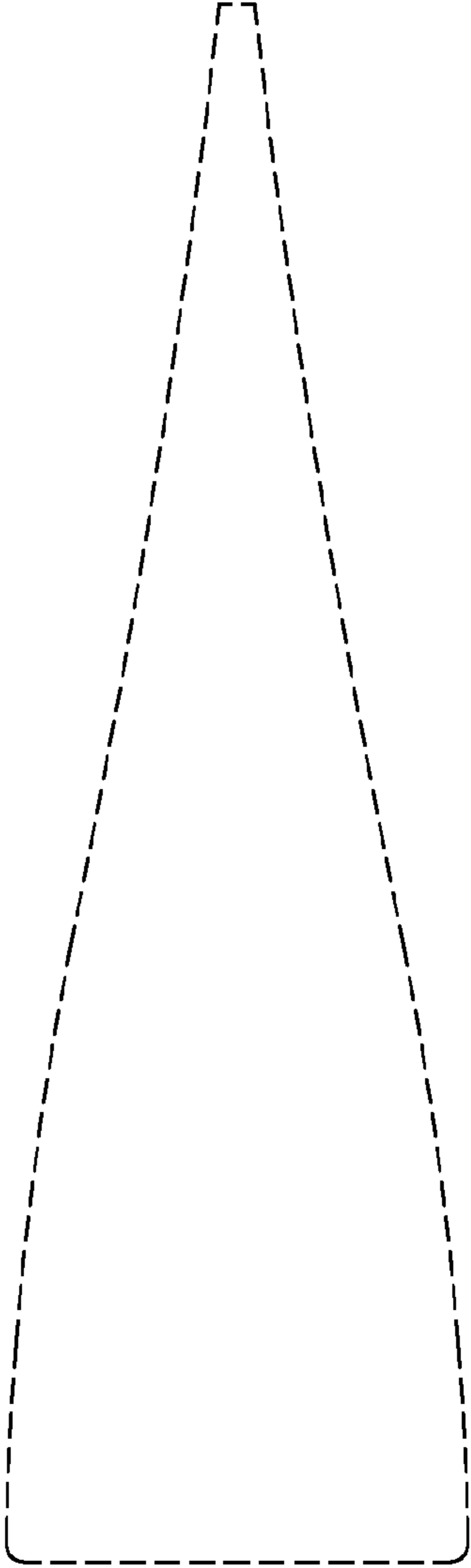

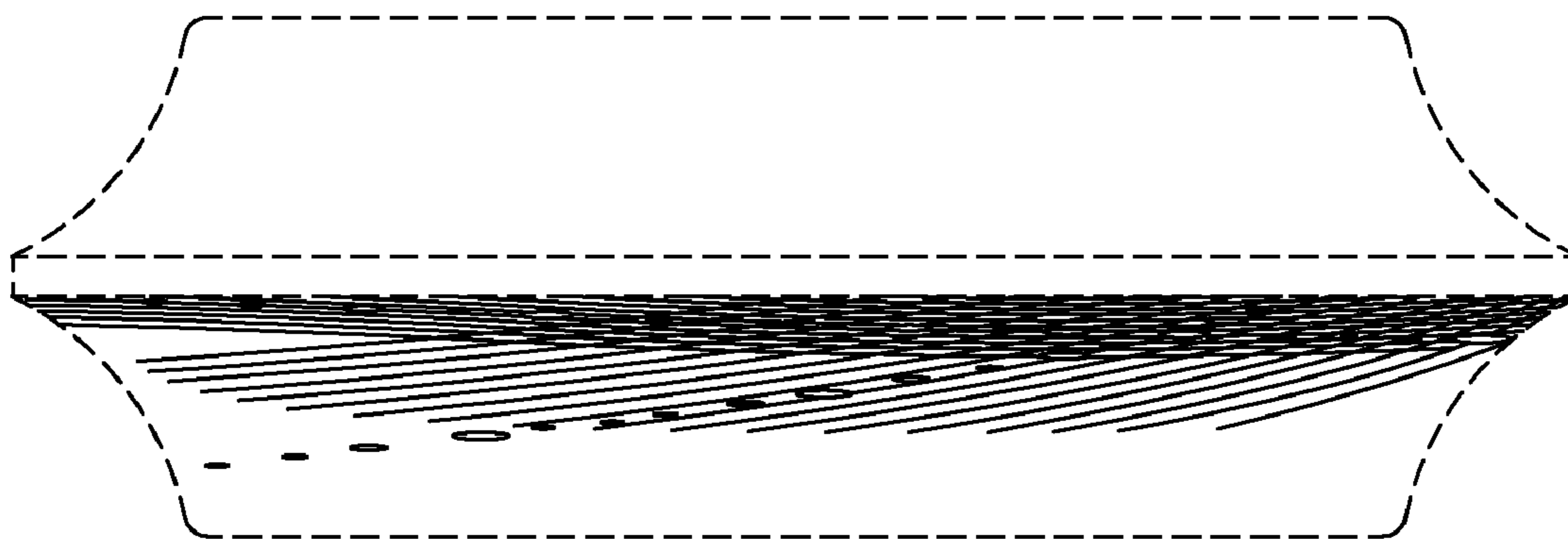

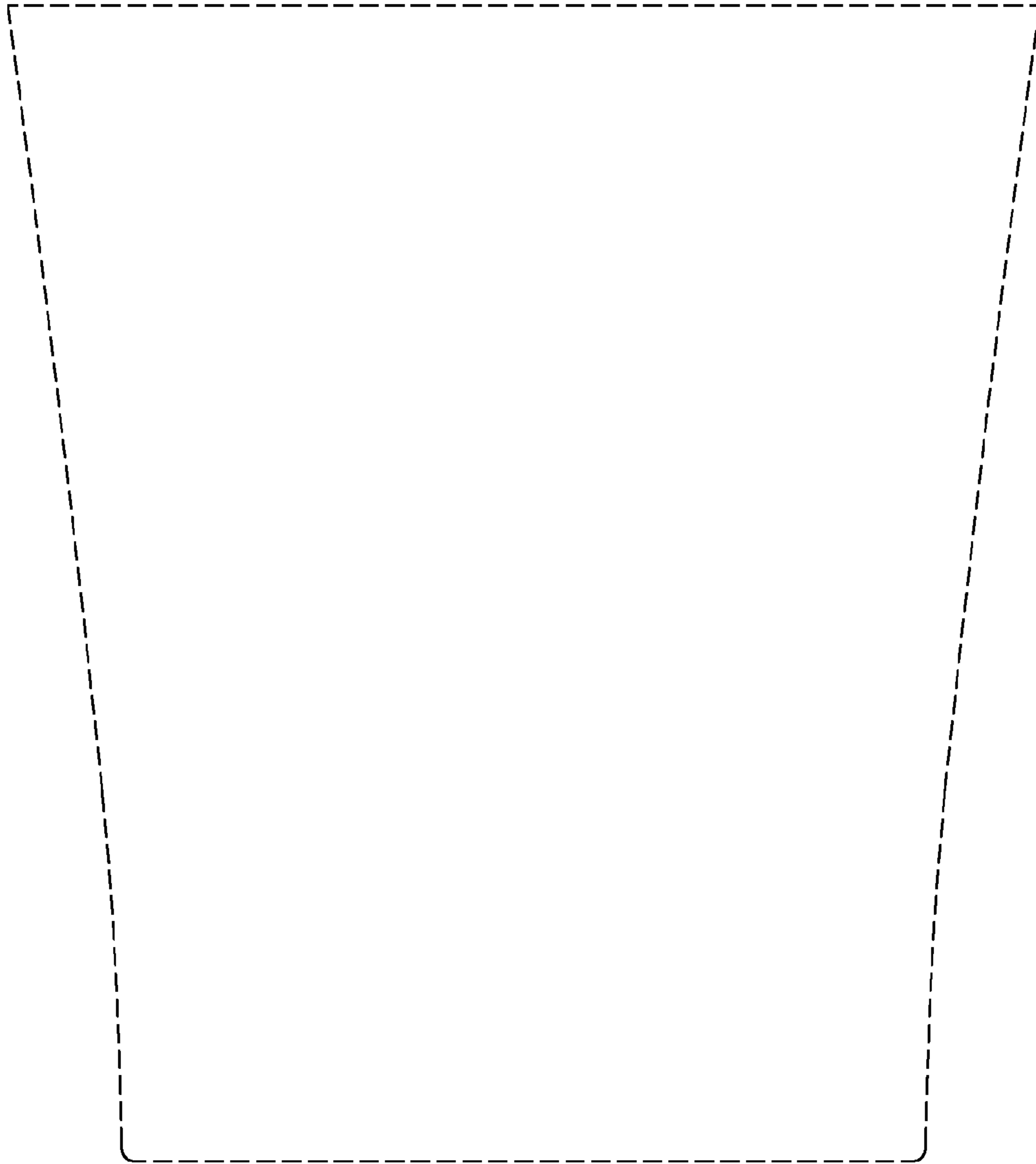

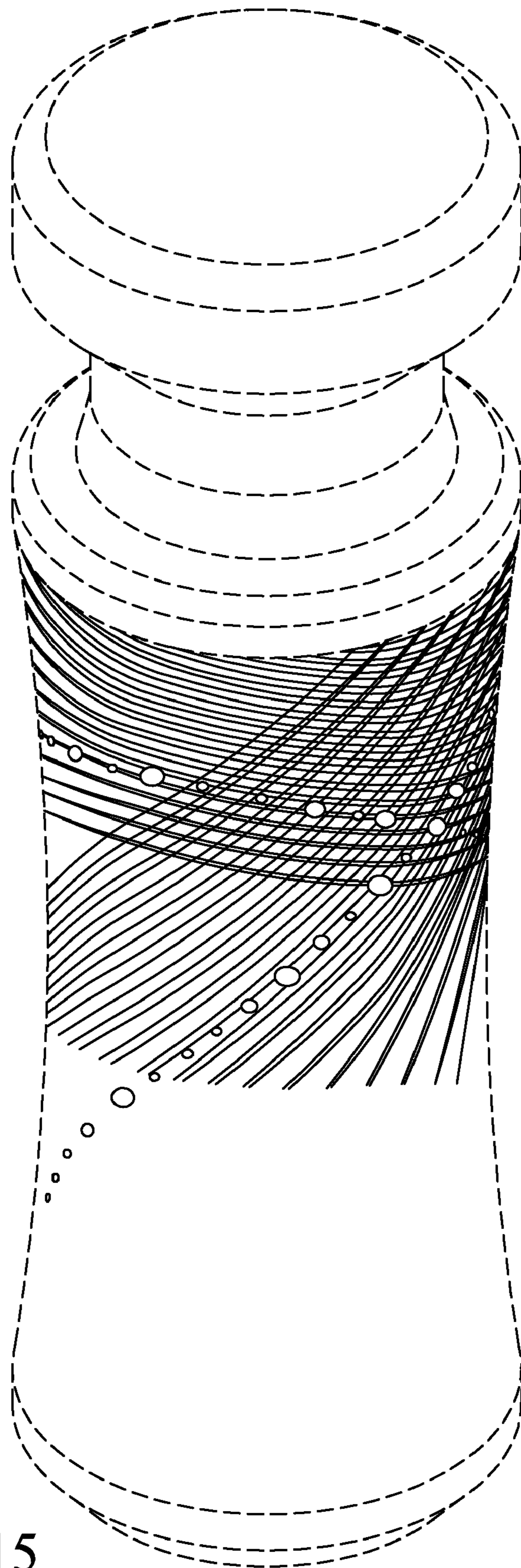

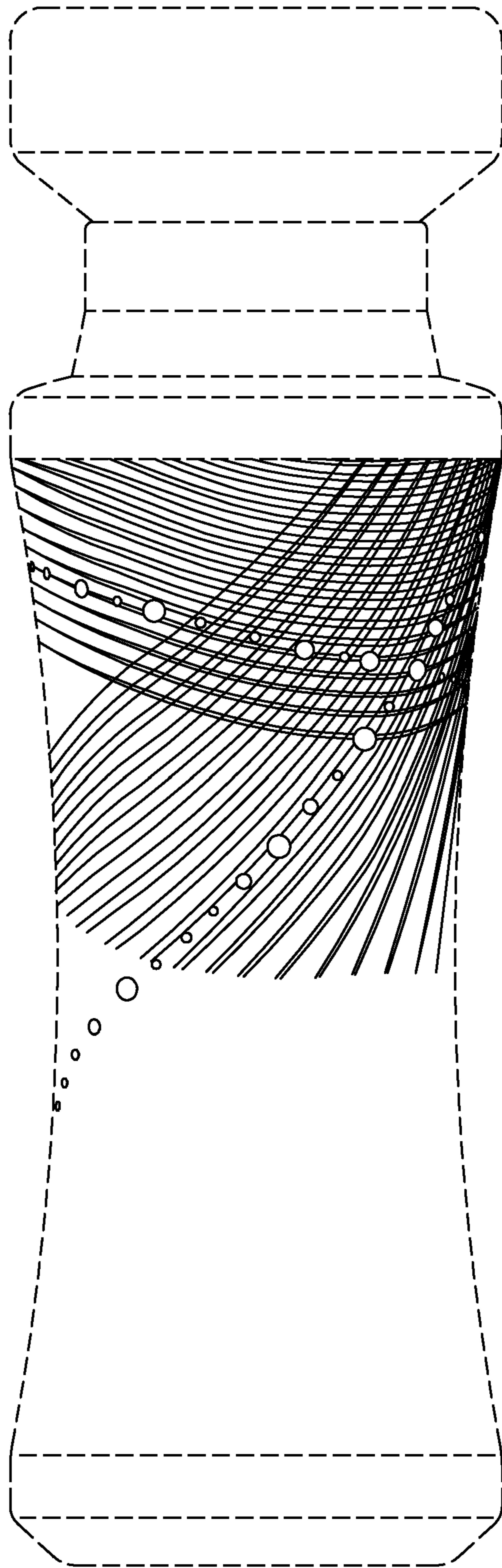

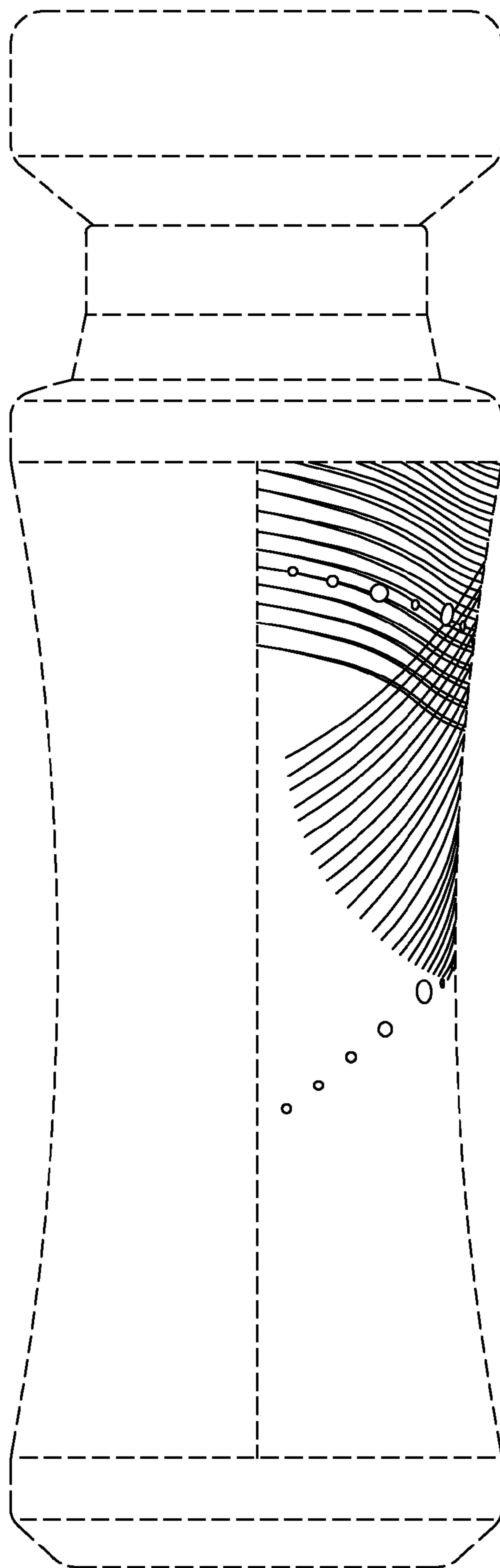

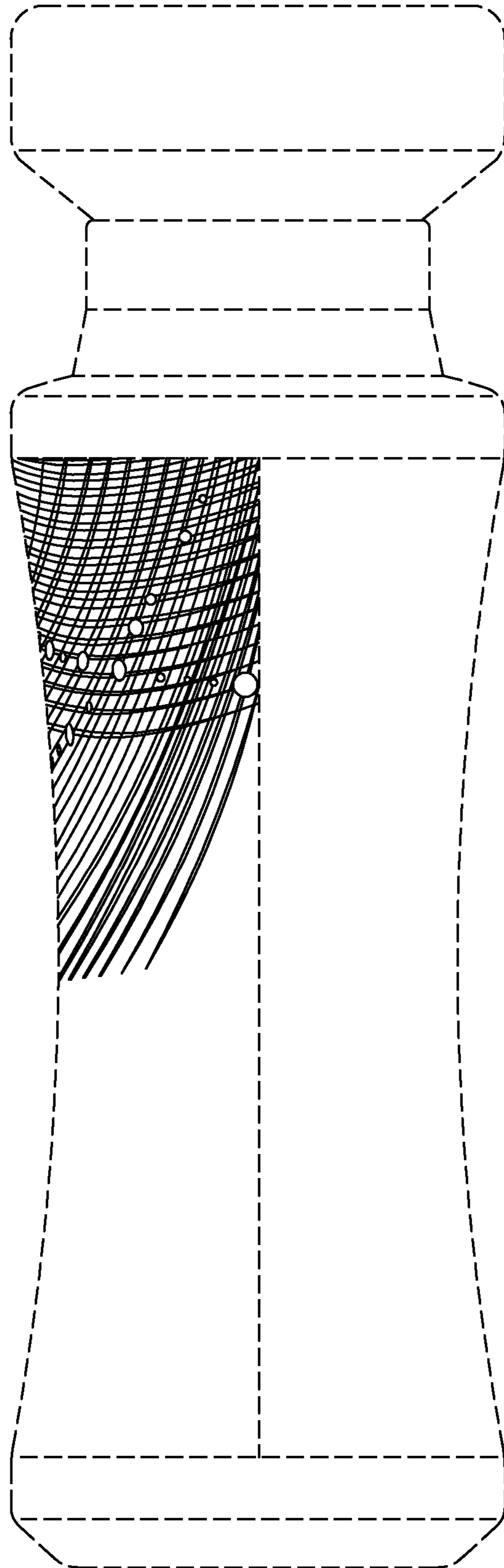

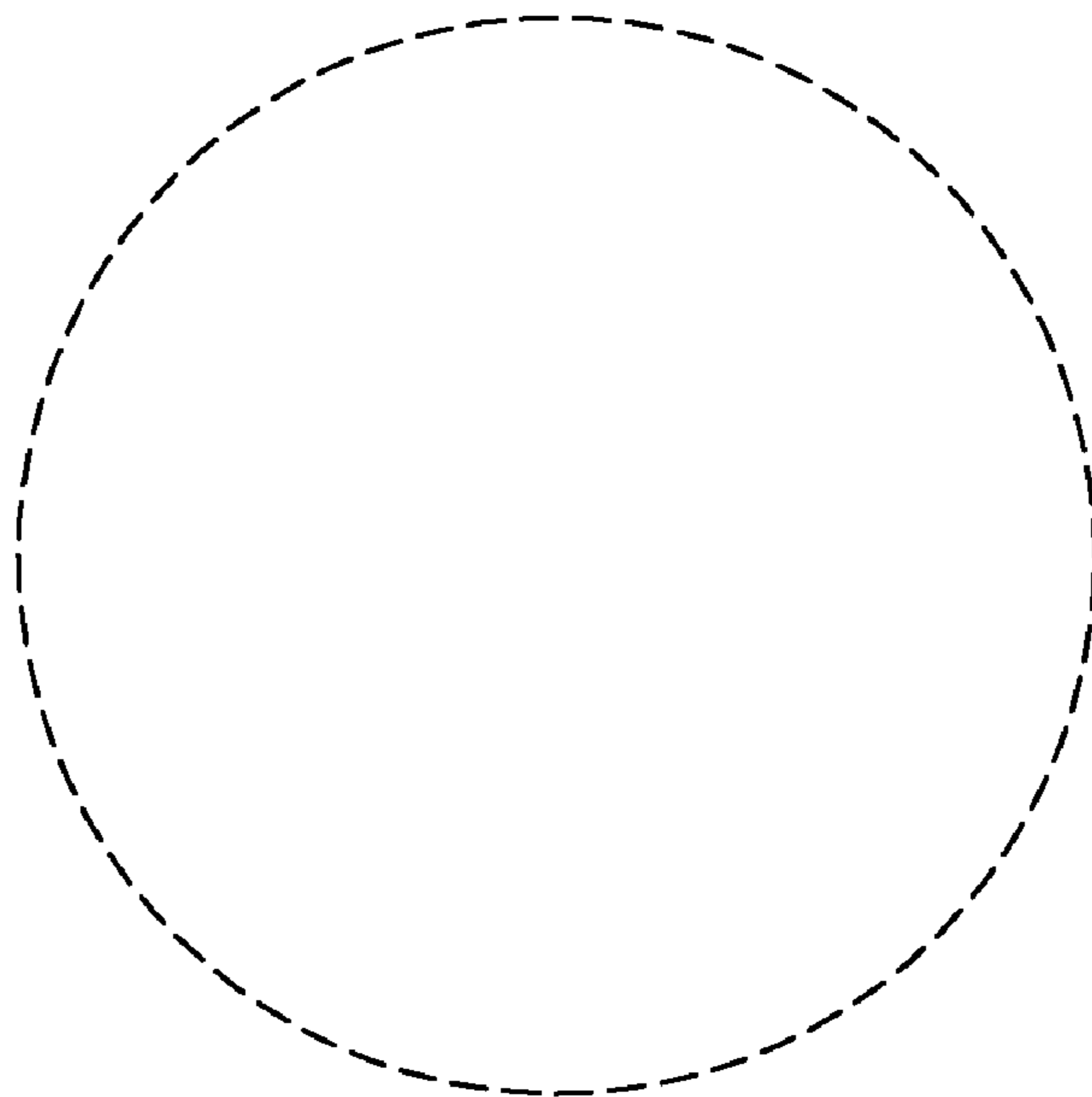

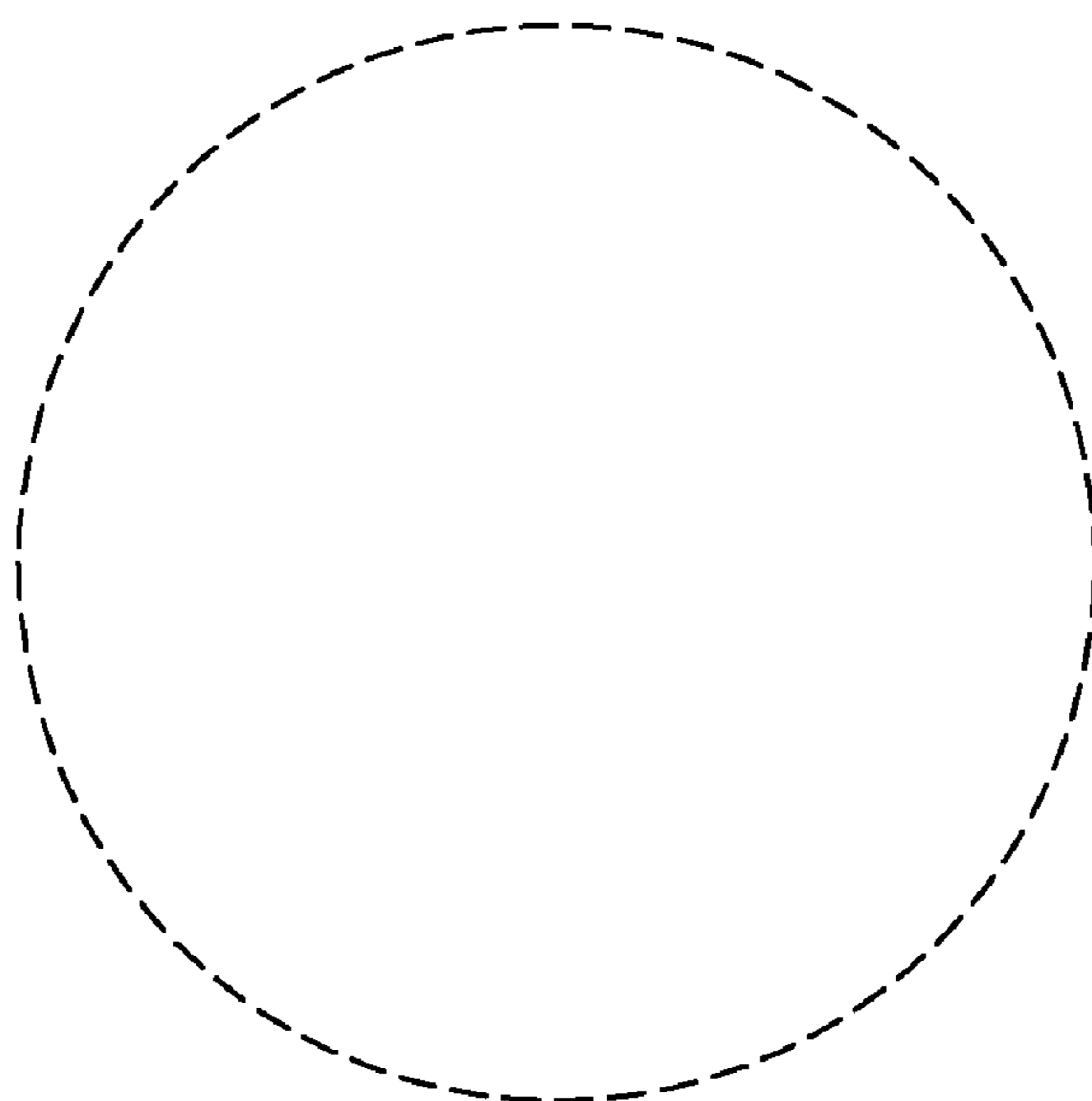

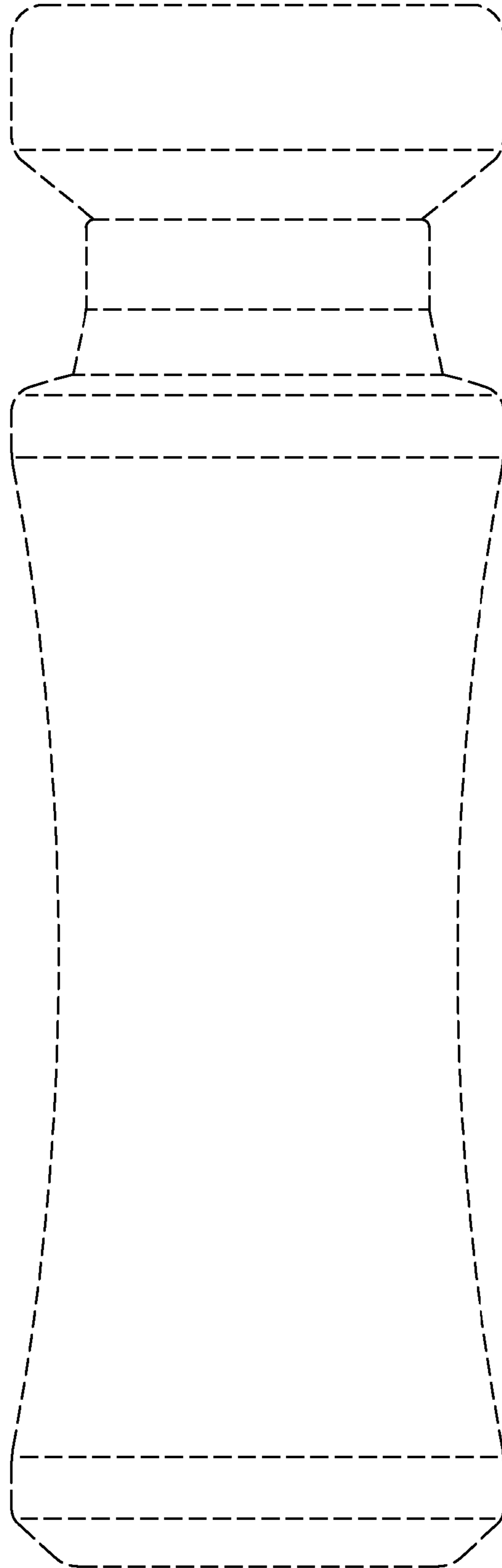

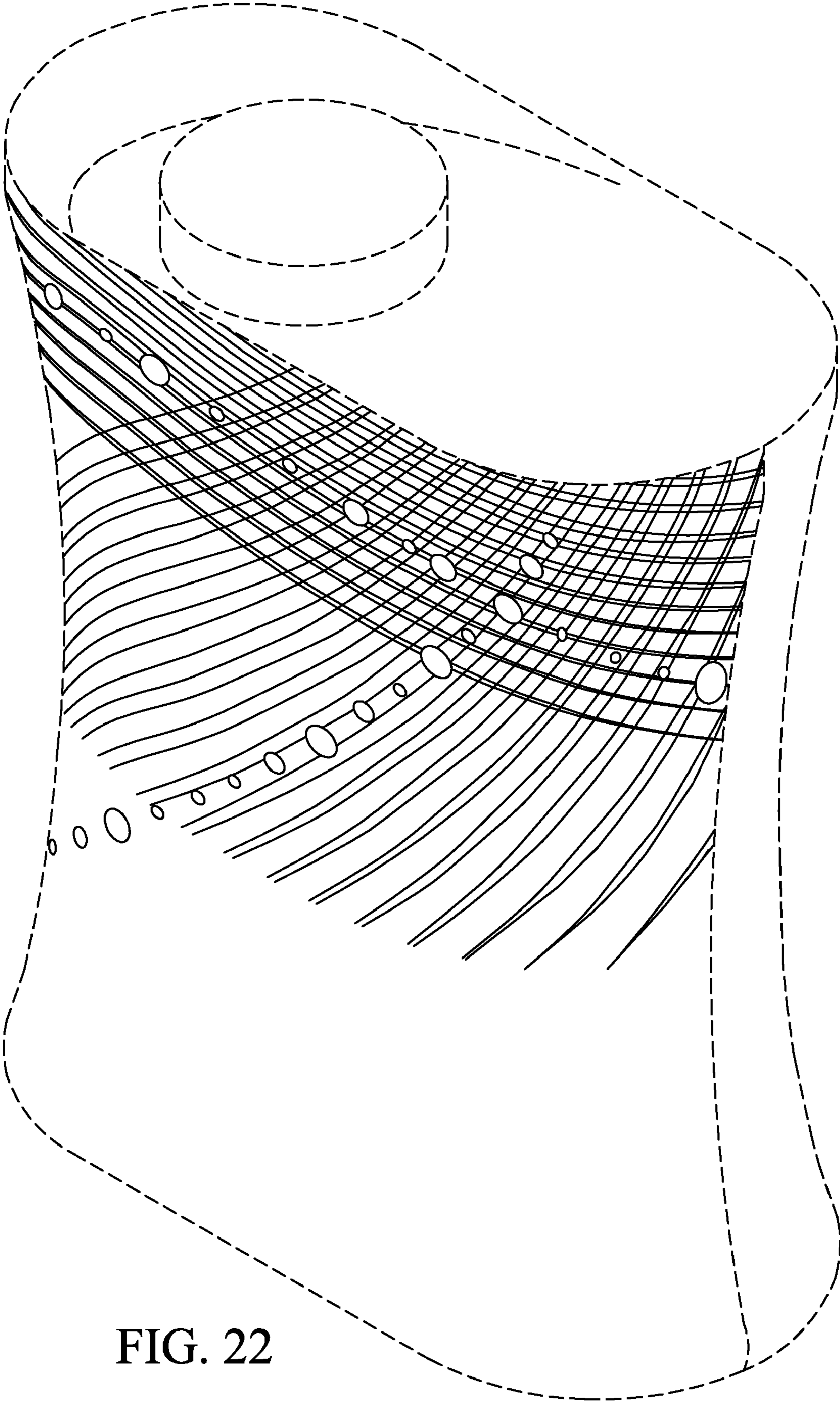

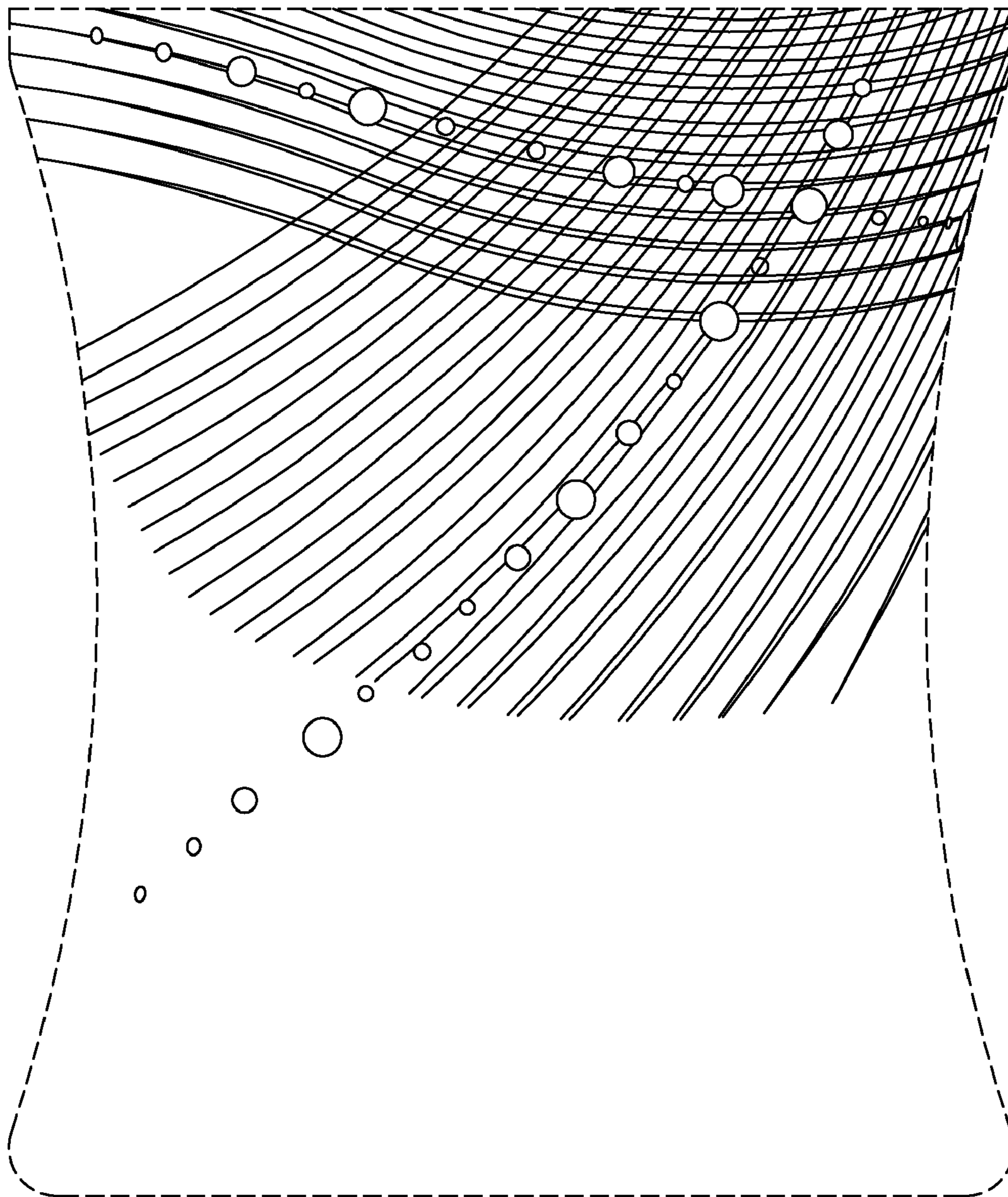

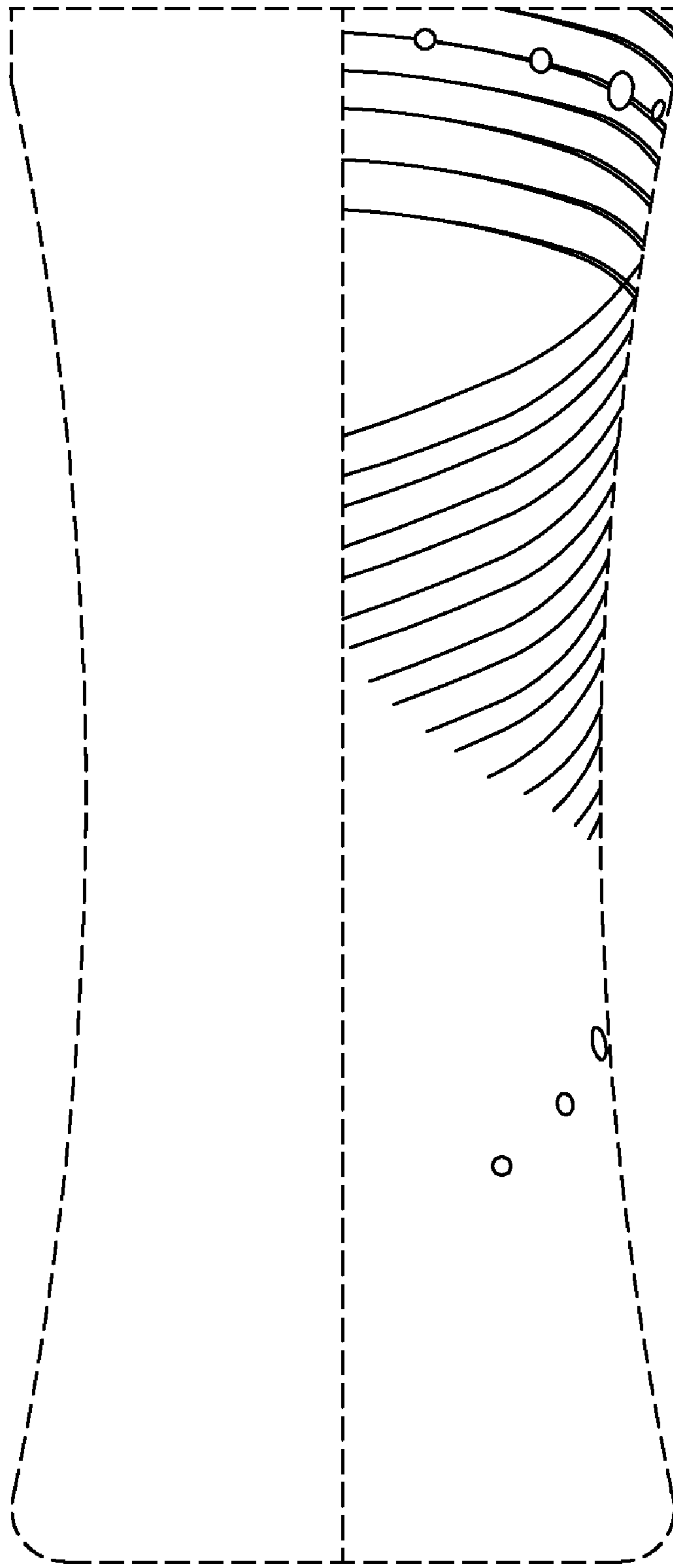

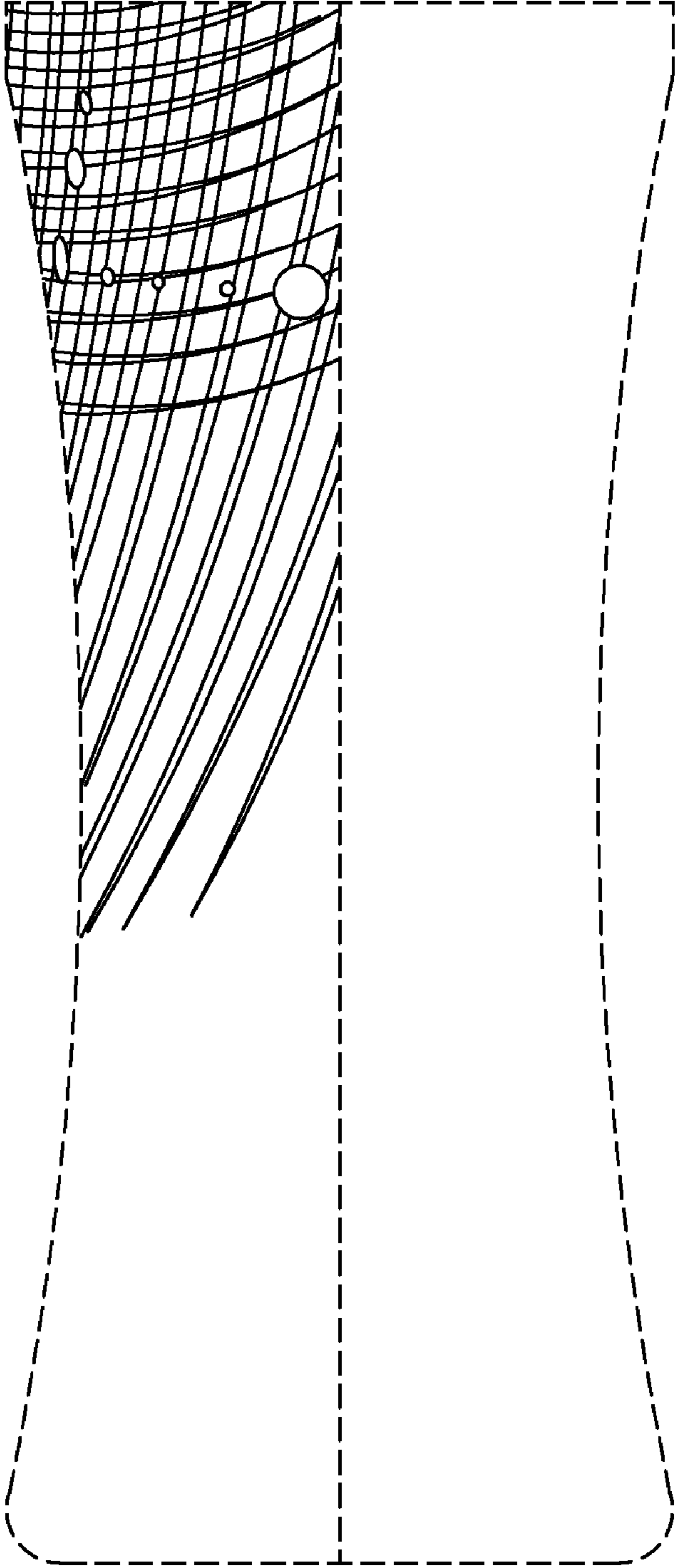

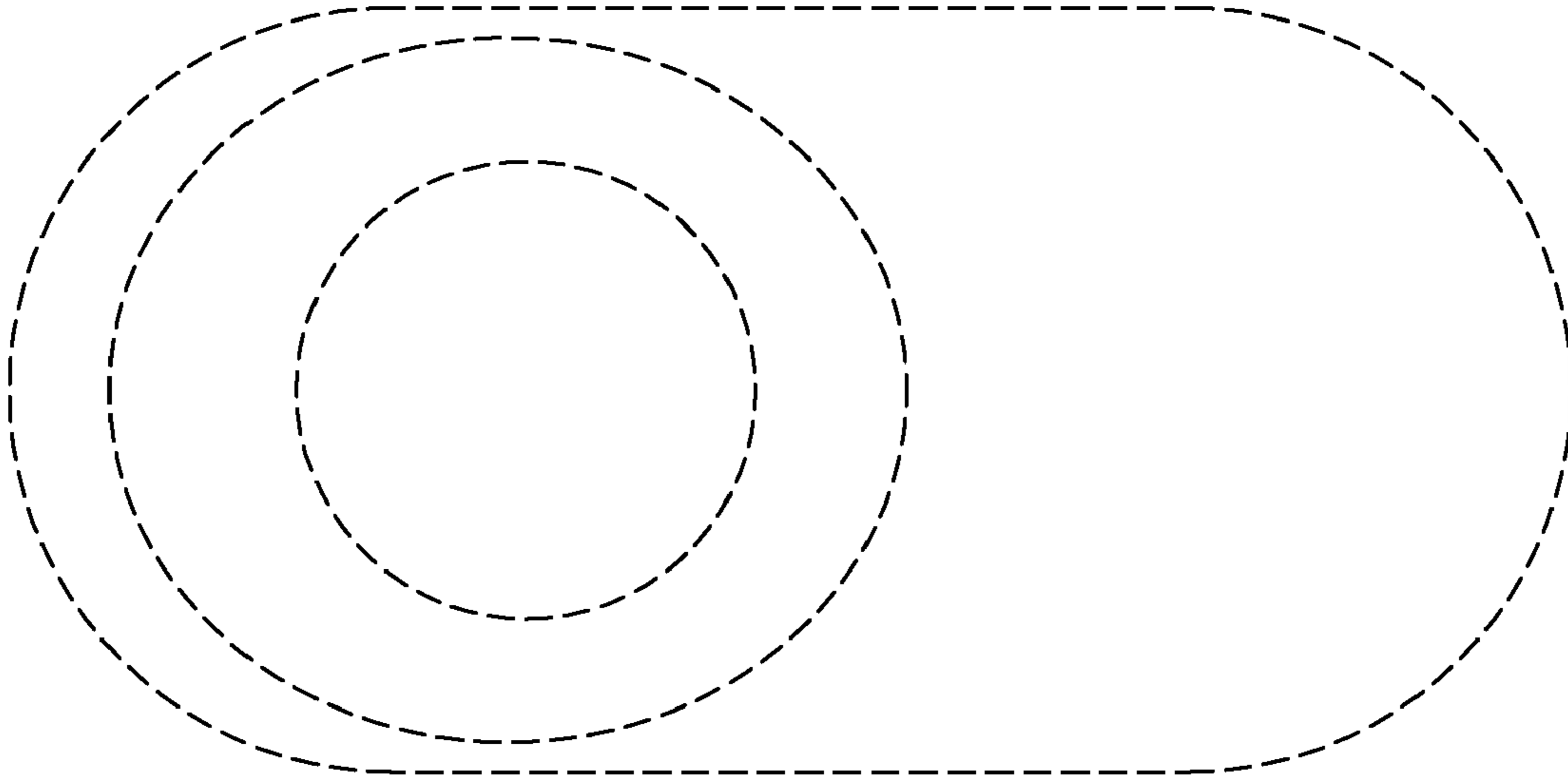

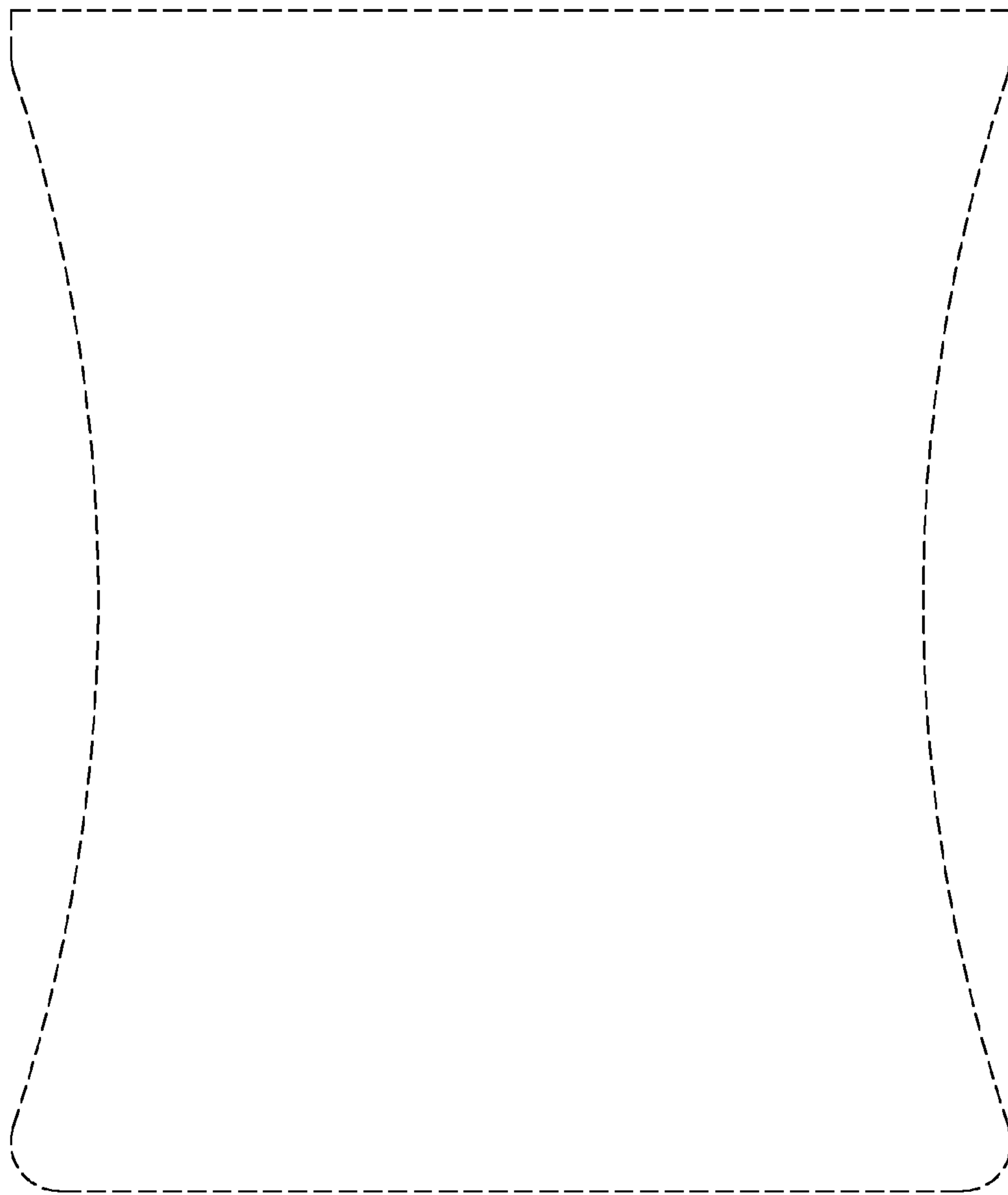
