DESCRIPTION

serving bowl with the inner circular area displaying, the
smallest base configuration, which embodies my design;

ond largest base configuration;

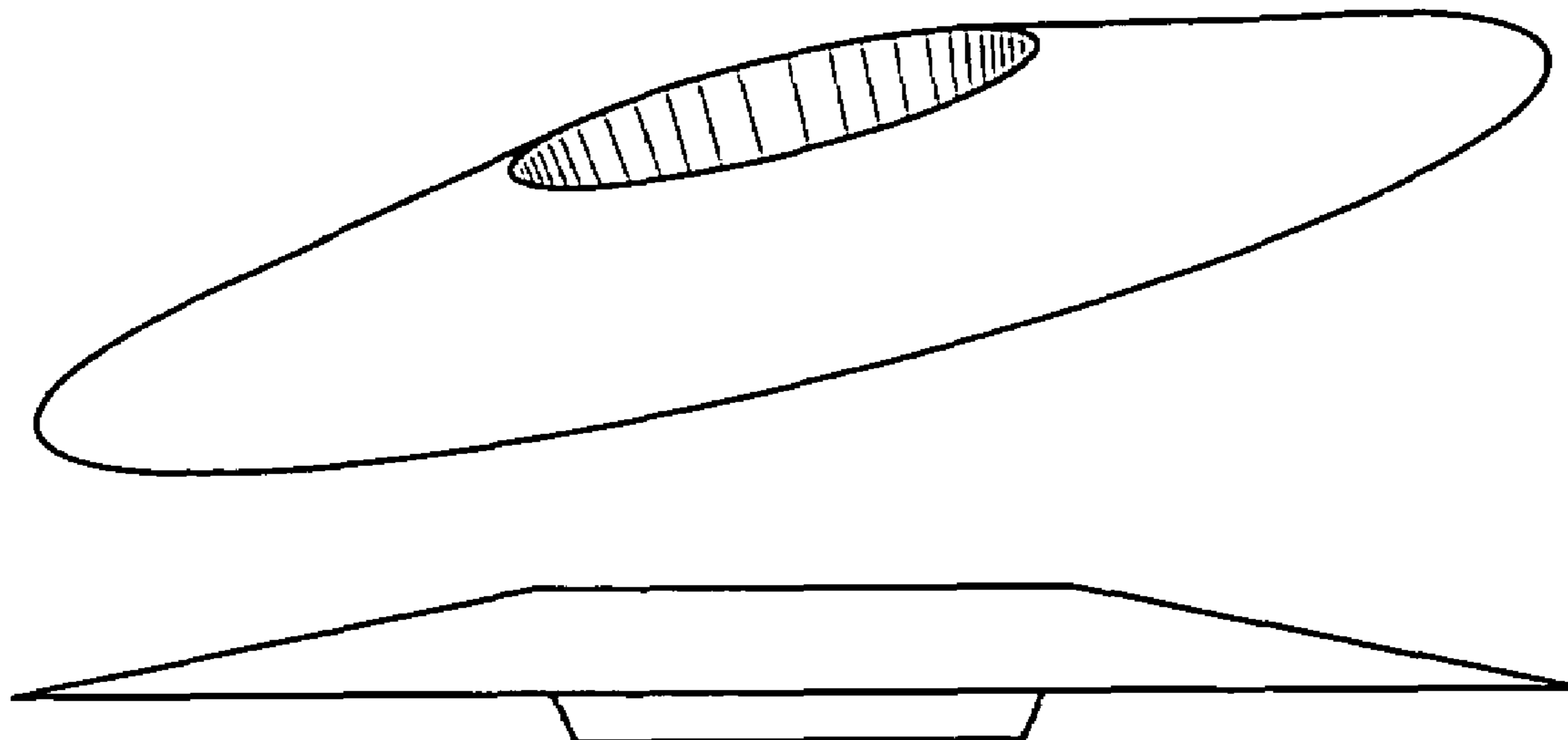
FIG. 9 is a top plan view of the third embodiment of the

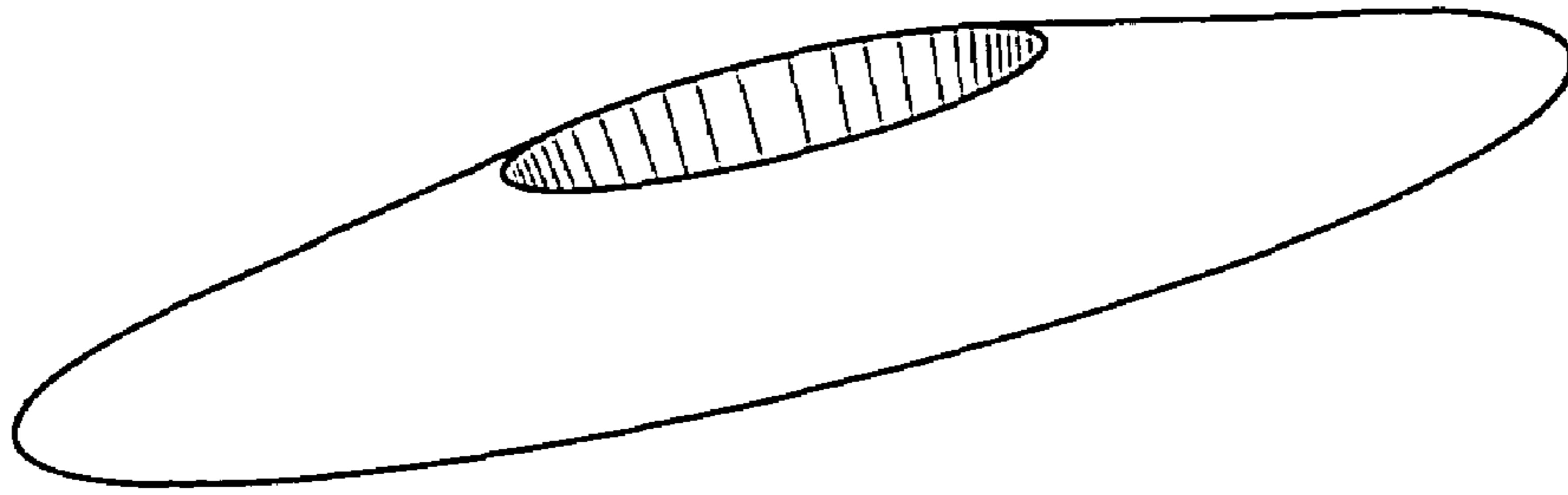

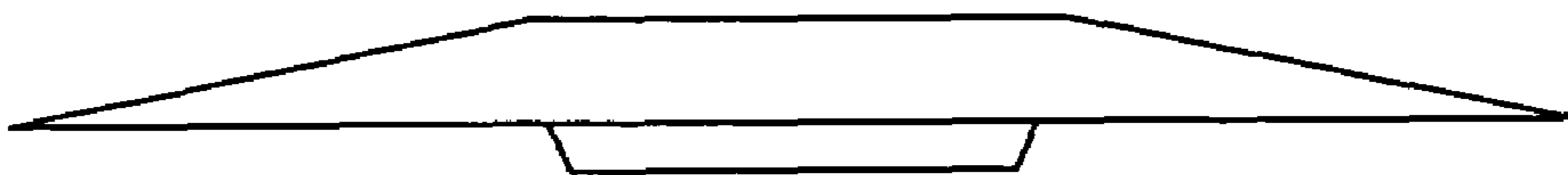

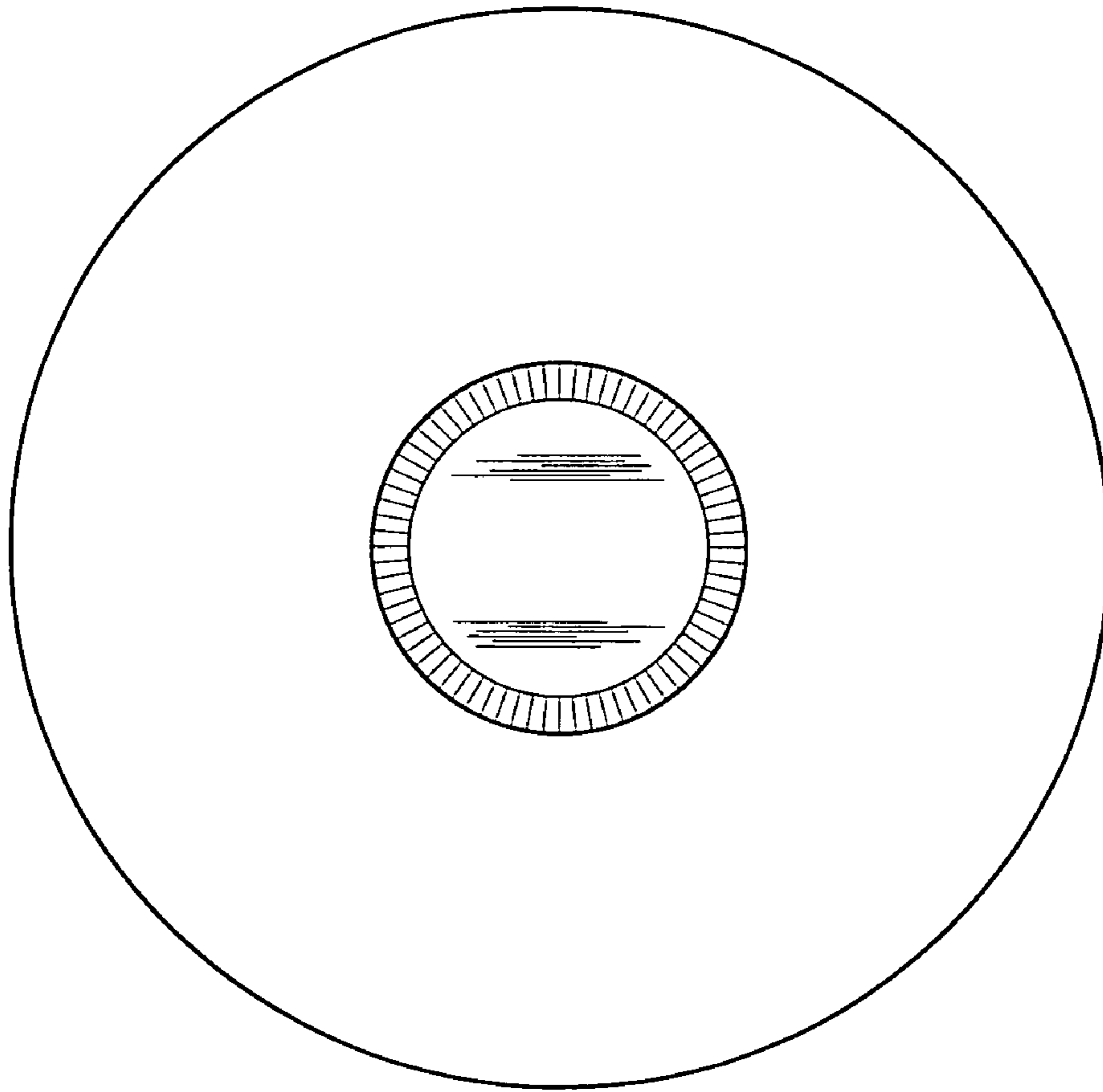

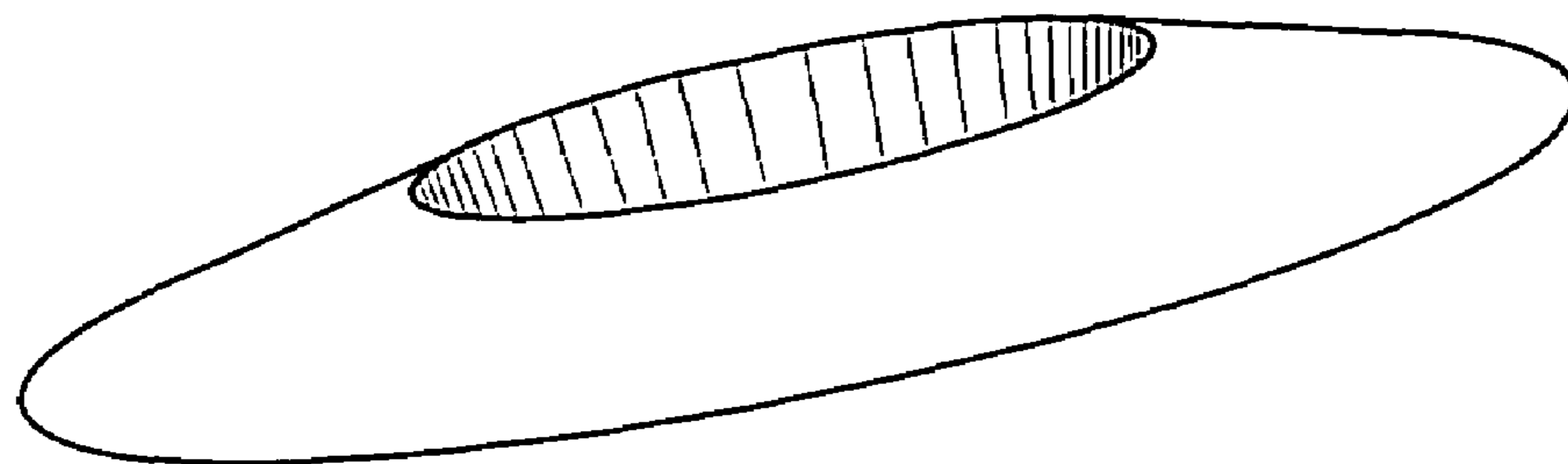

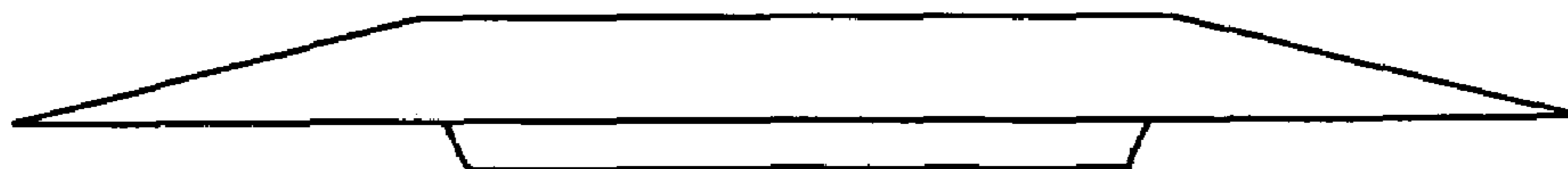

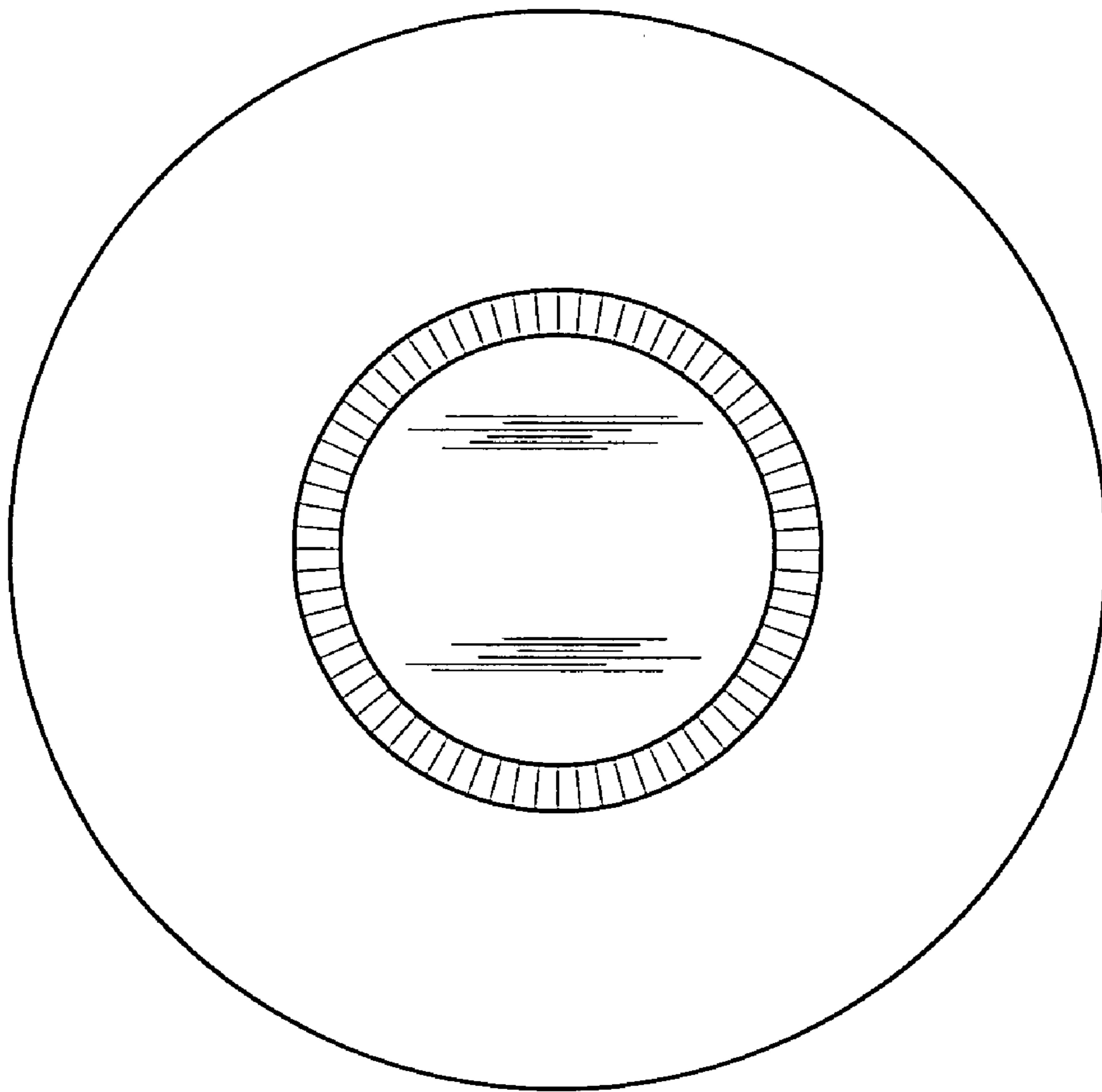

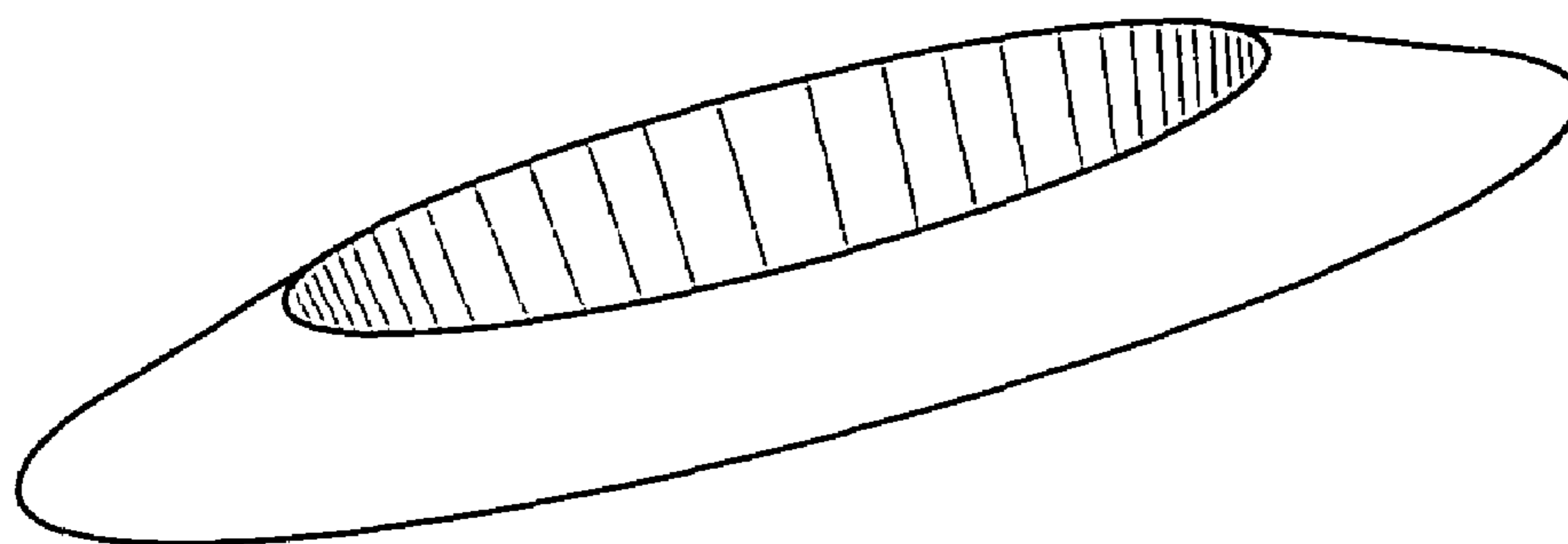

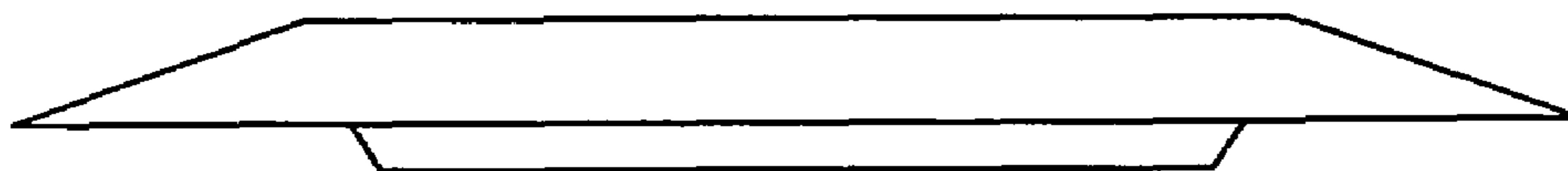

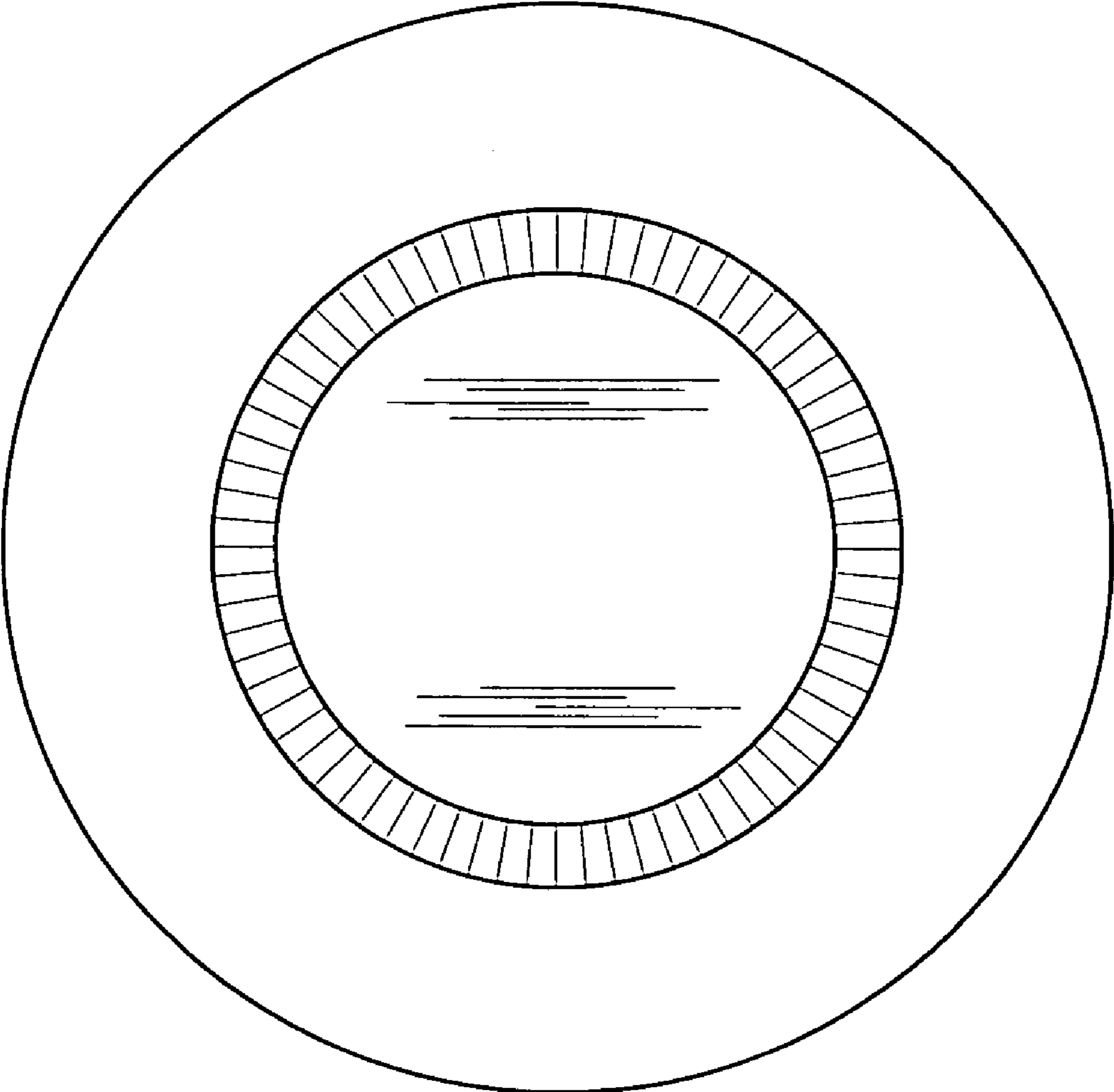

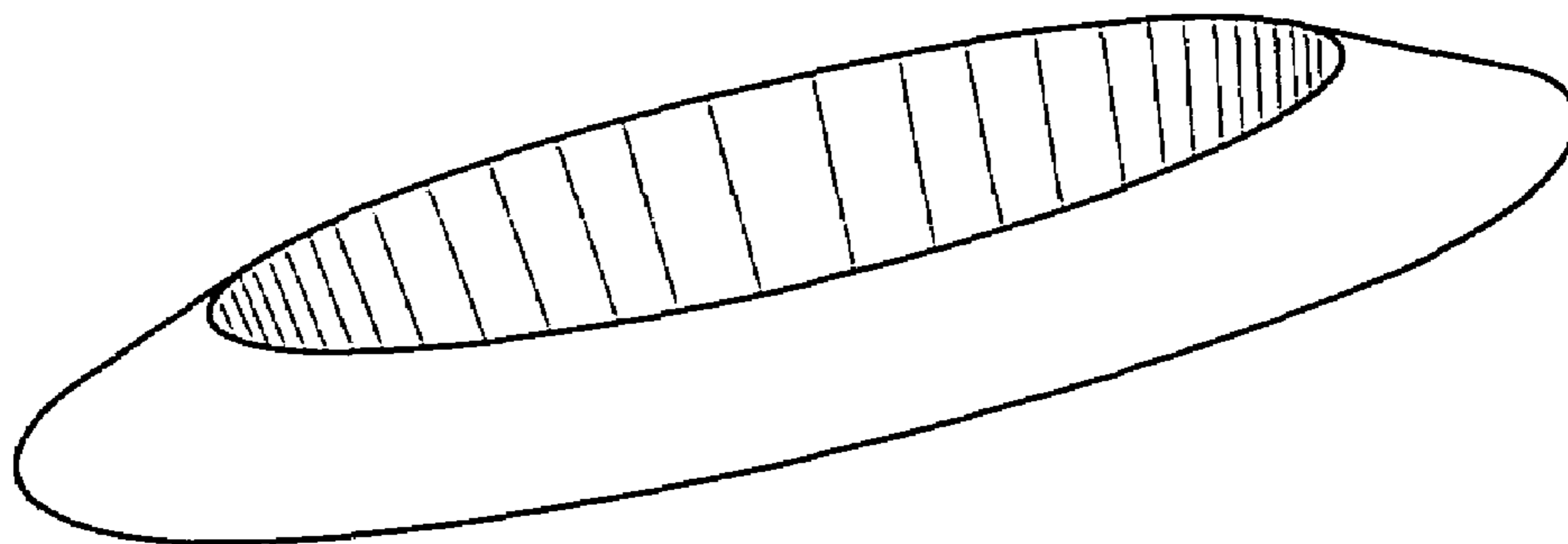

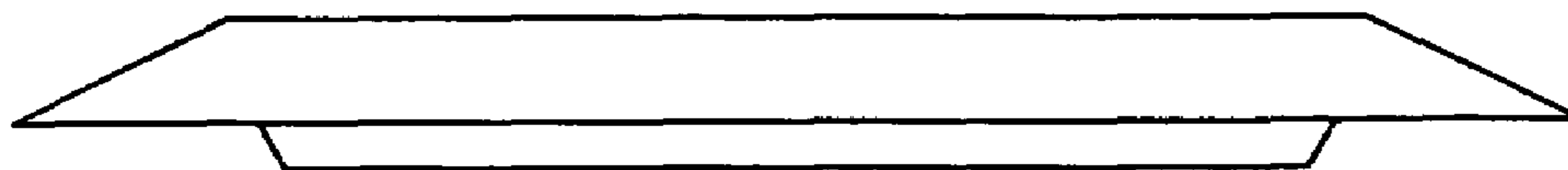

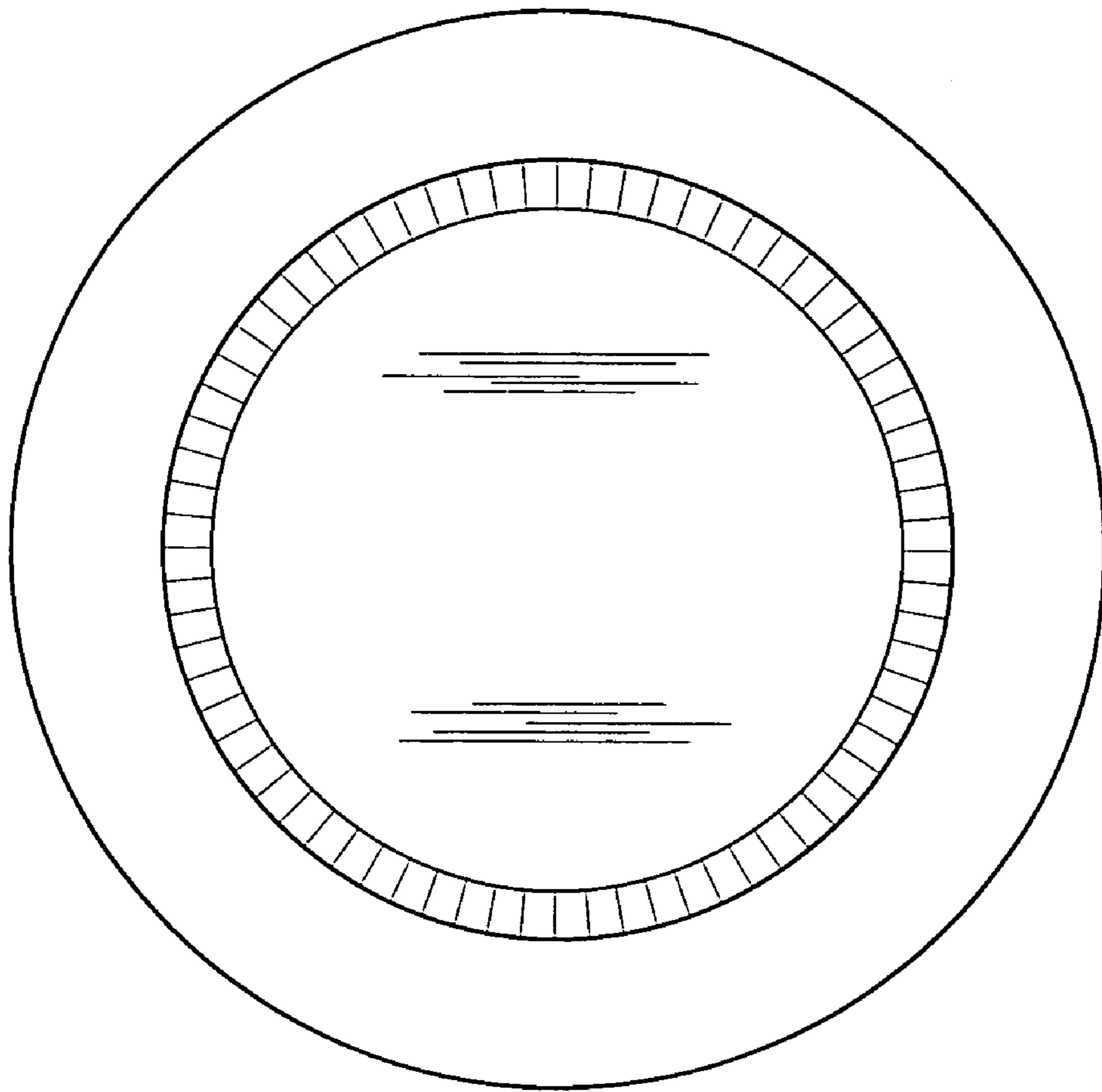
