(57) **CLAIM**

The ornamental design for a wire stripper/utility knife, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left perspective view of the wire stripper/utility knife according to the present invention;

FIG. 2 is a bottom right perspective view of the wire stripper/utility knife of FIG. 1;

FIG. 3 is a left side elevational view of the wire stripper/utility knife of FIG. 1;

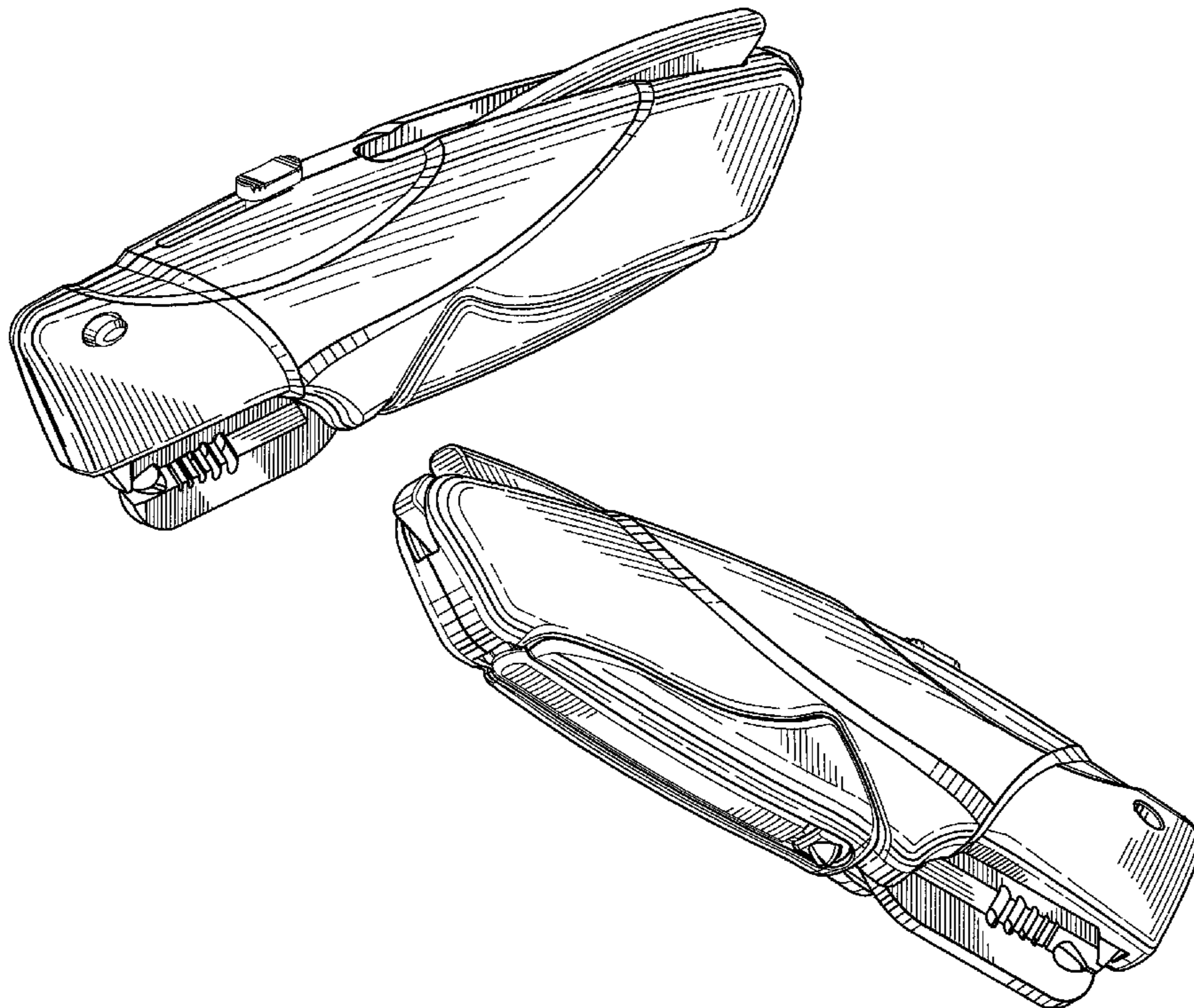
FIG. 4 is a right side elevational view of the wire stripper/utility knife of FIG. 1;

FIG. 5 is a top right perspective view of the wire stripper/utility knife of FIG. 1, with the wire stripper/utility knife in an open configuration; and,

FIG. 6 is a left side elevational view of the wire stripper/utility knife of FIG. 5.

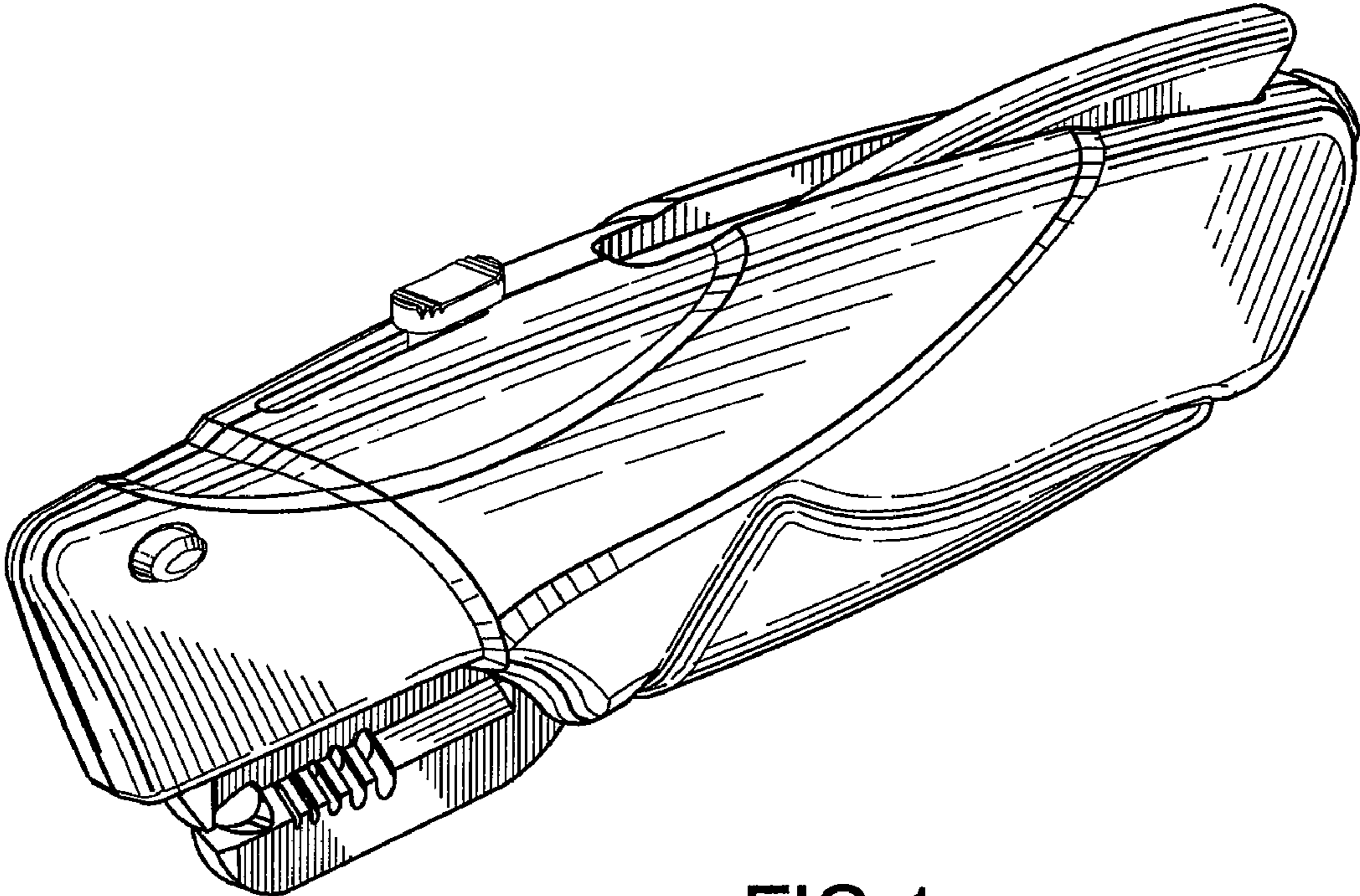

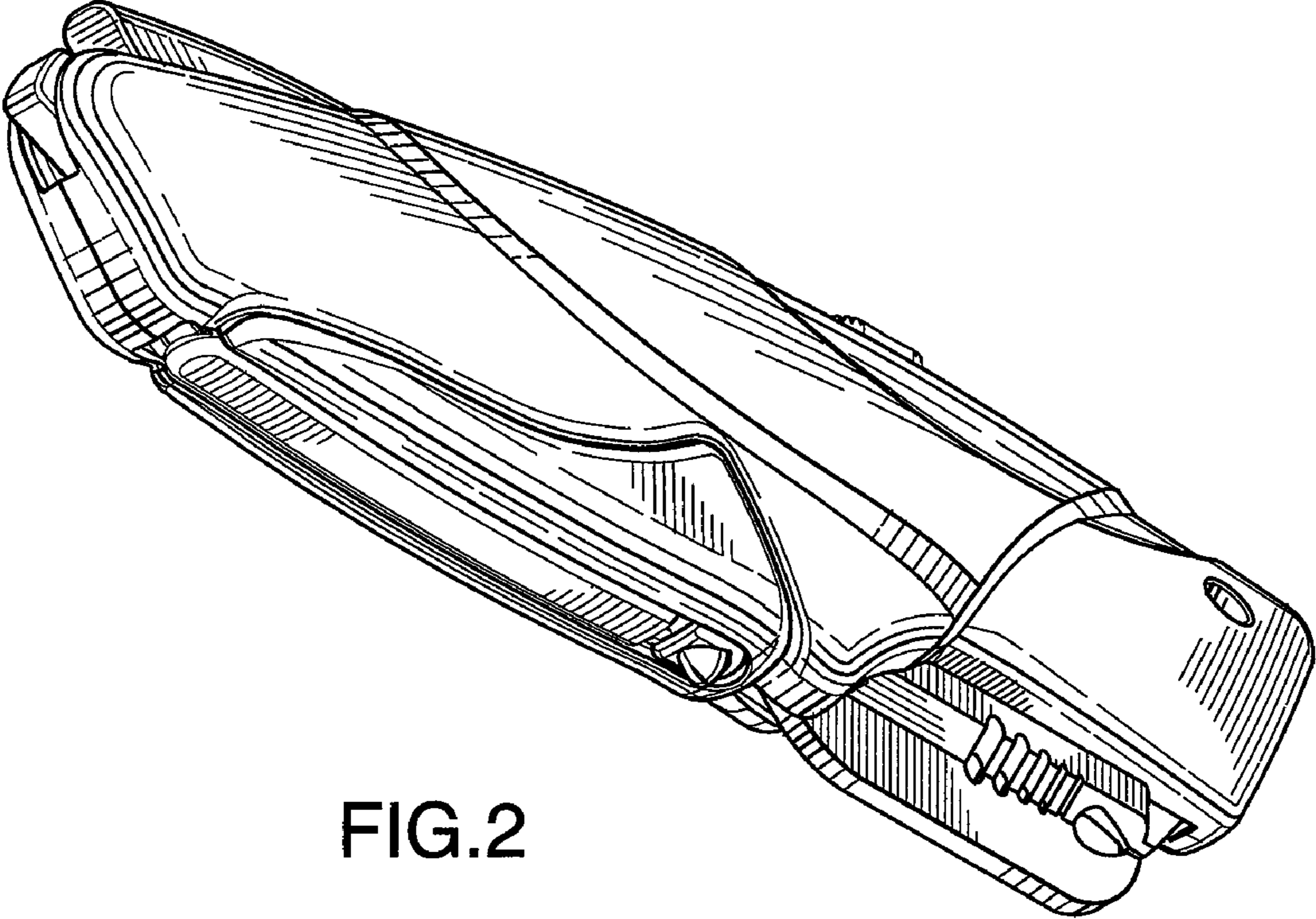

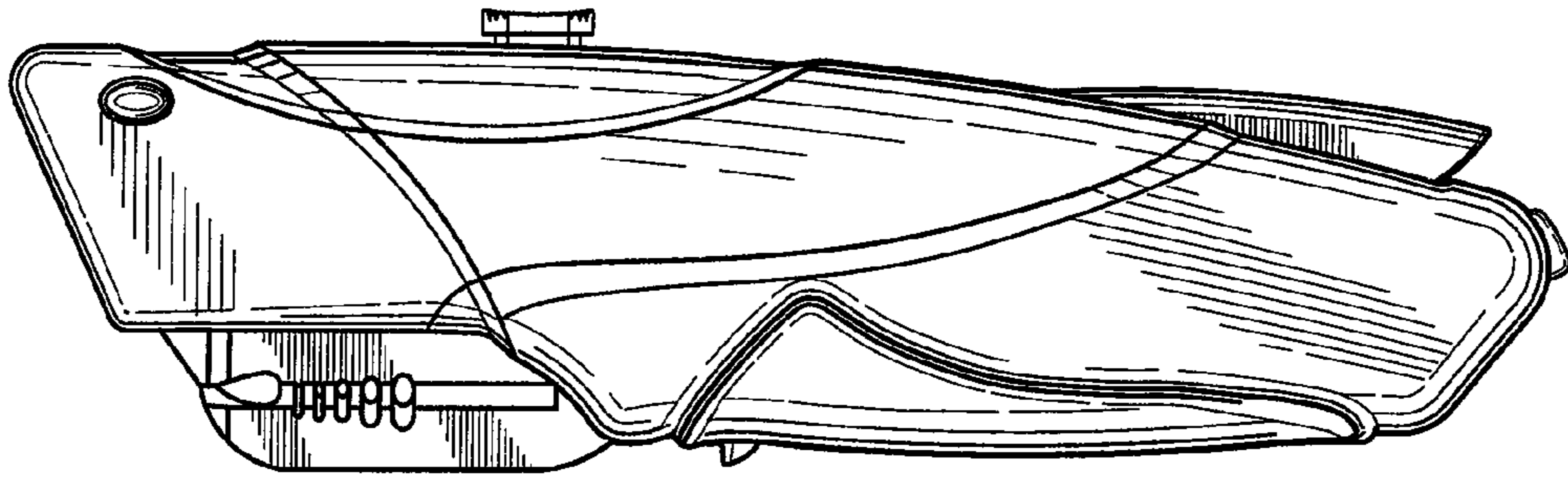

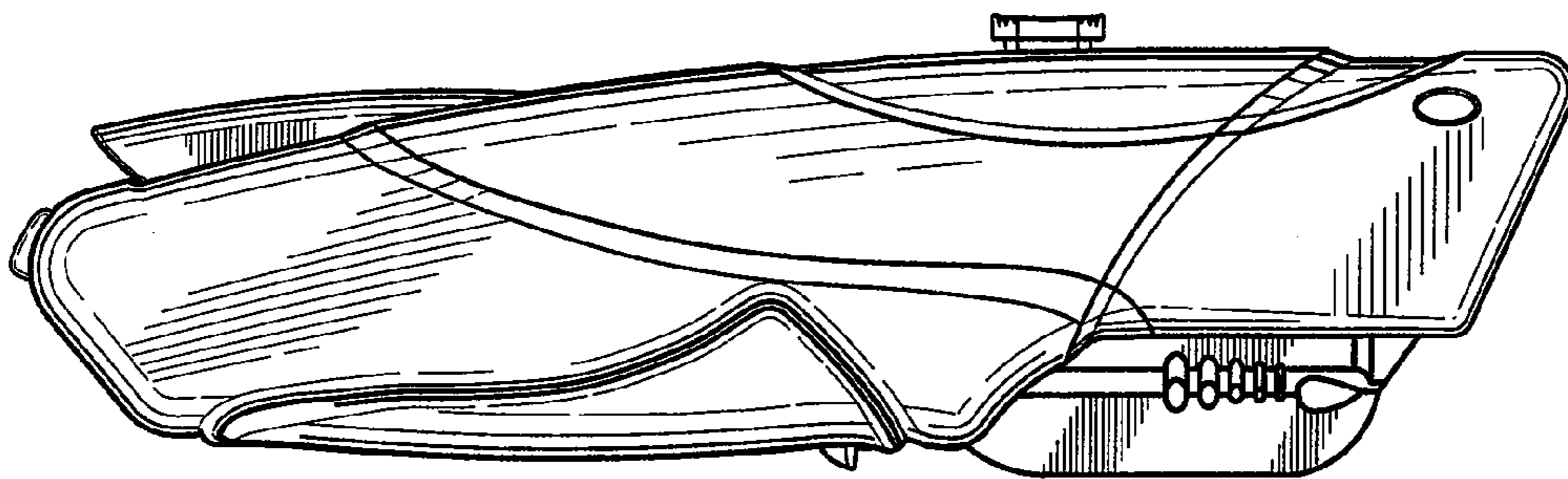

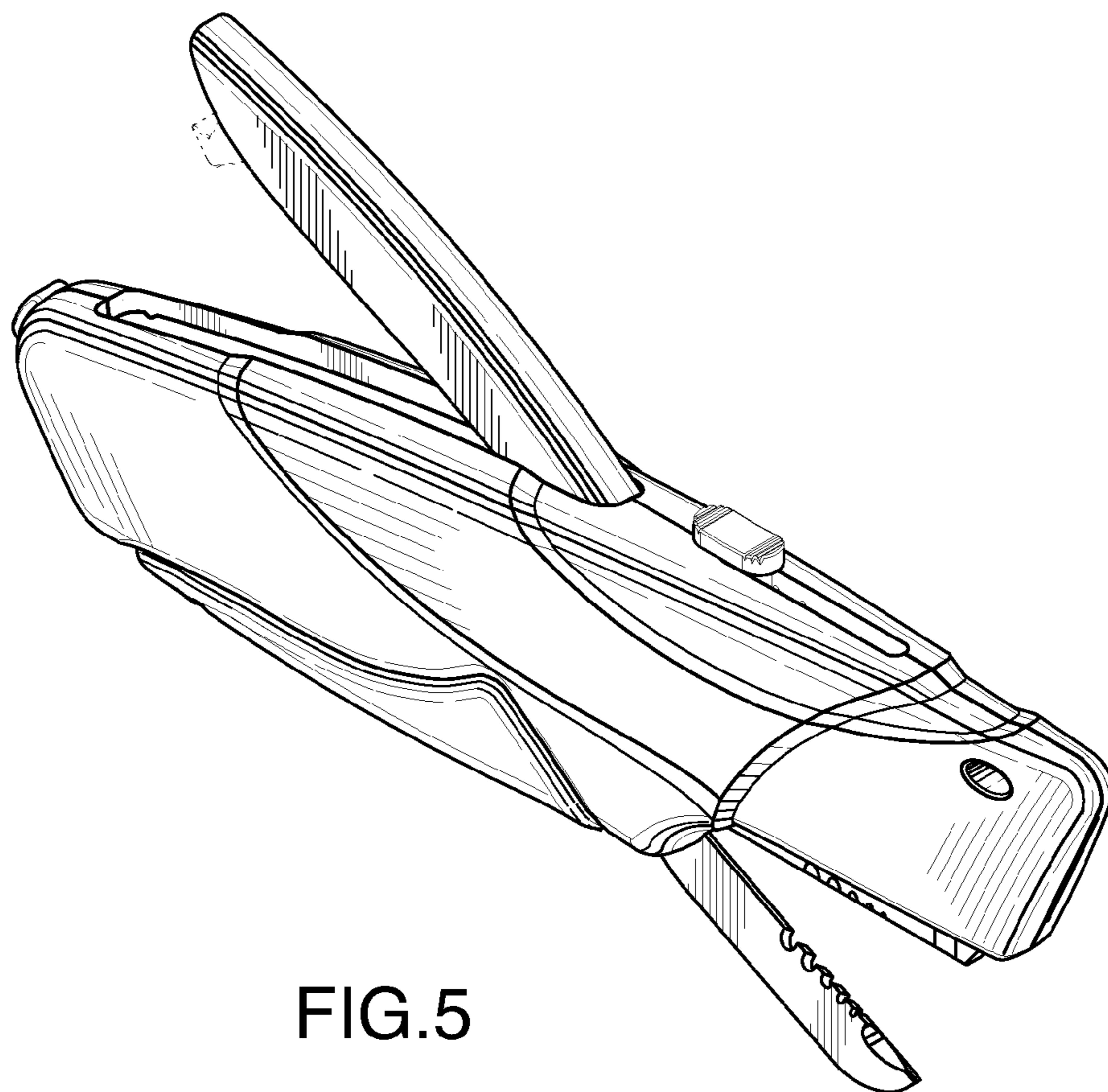

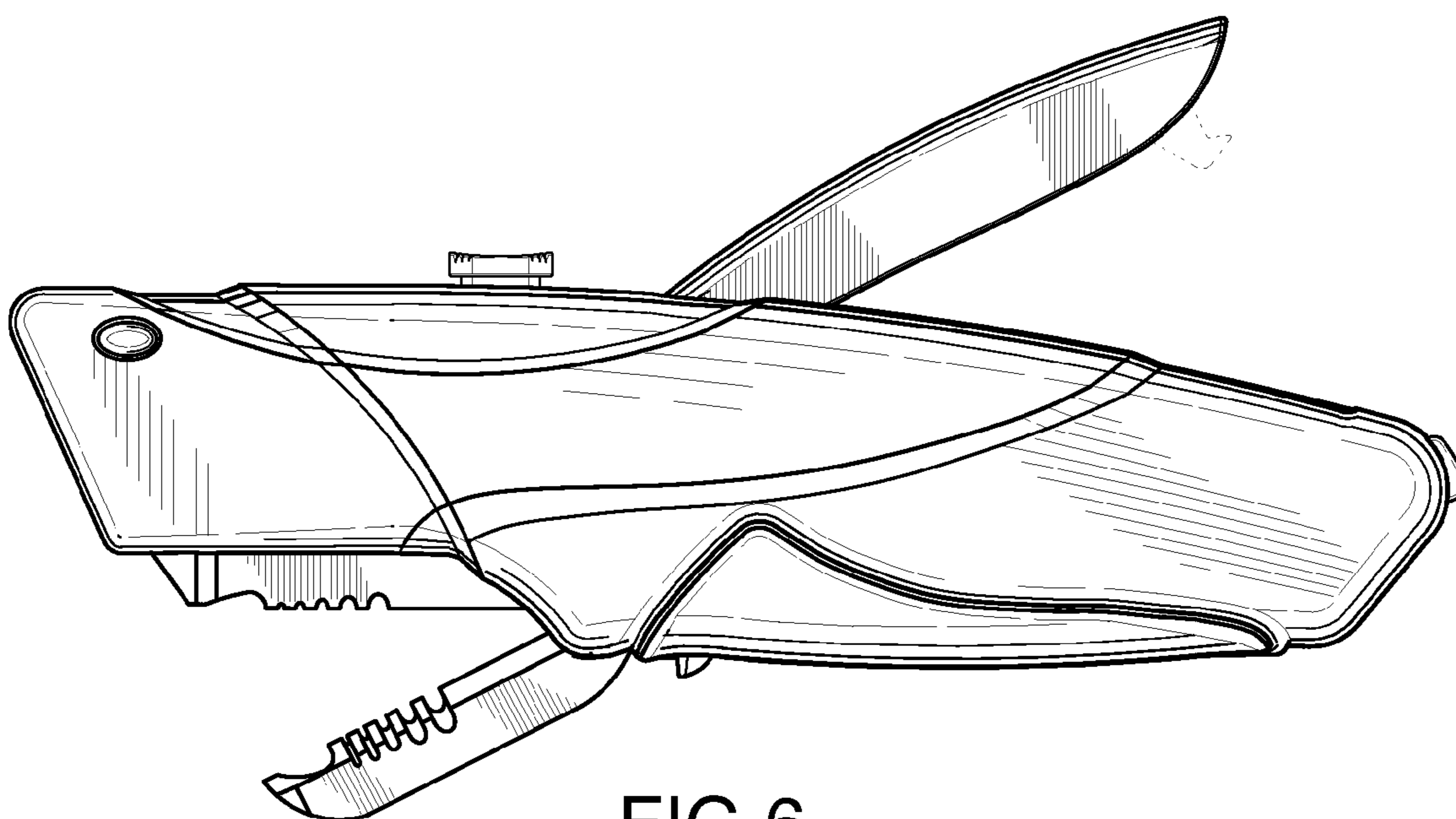
