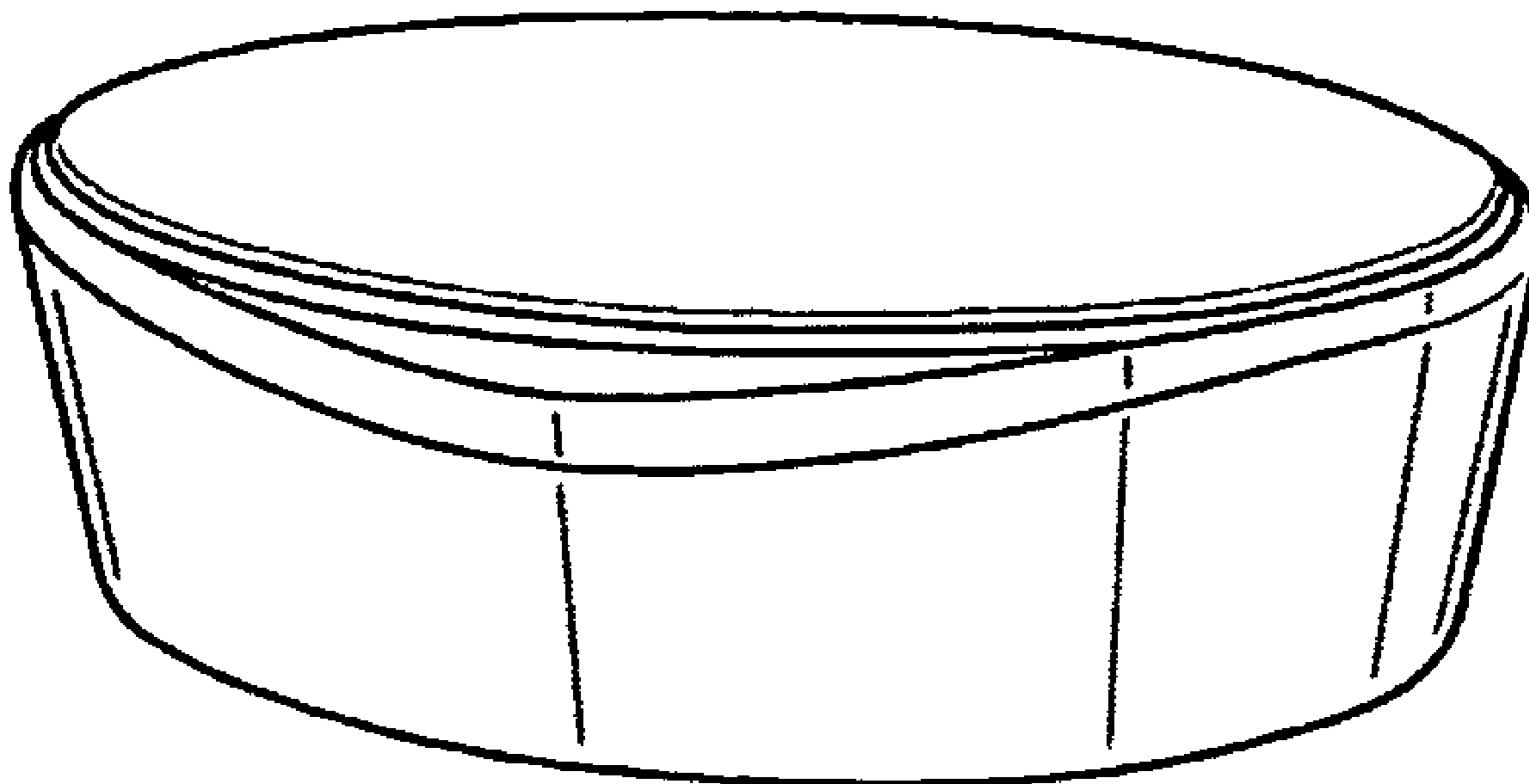
The ornamental design for a lid, as shown and described.

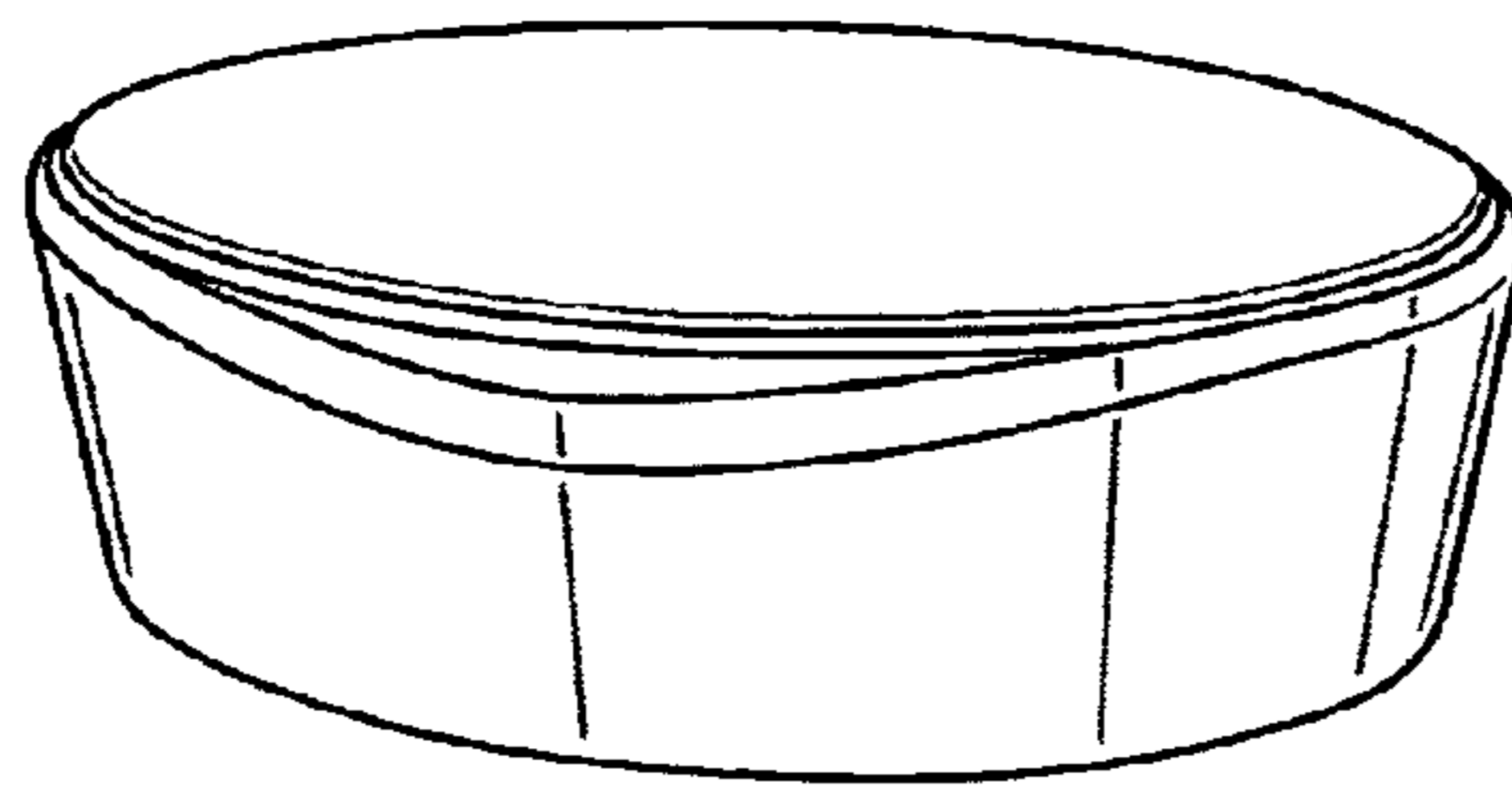

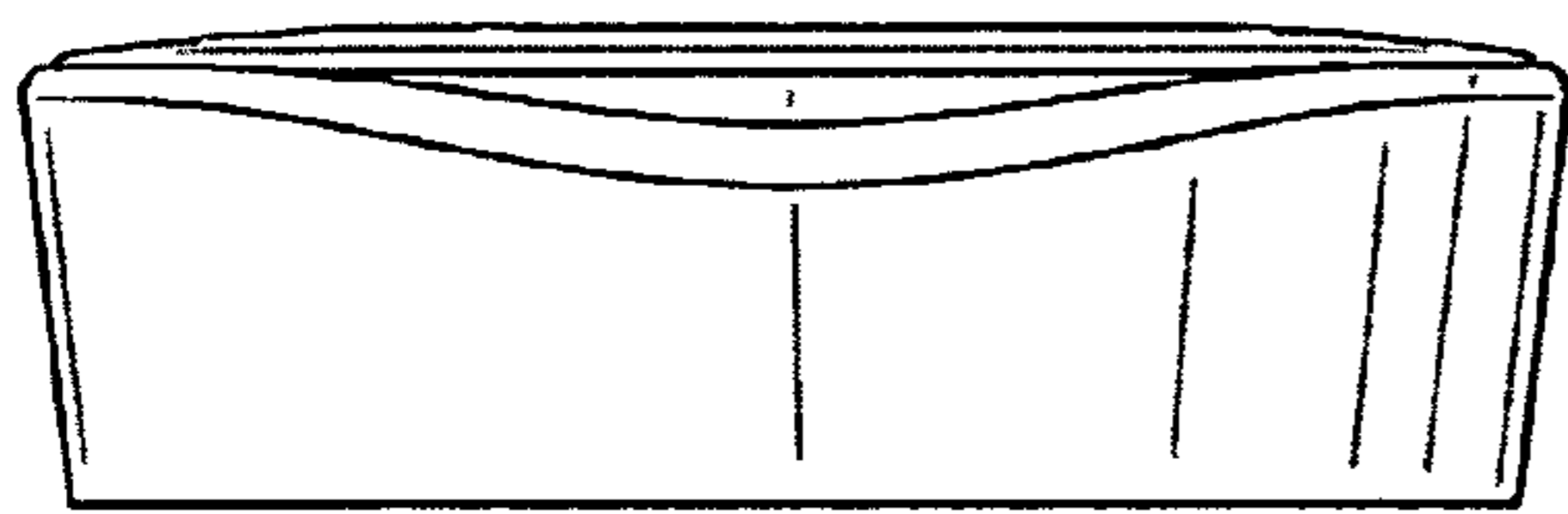

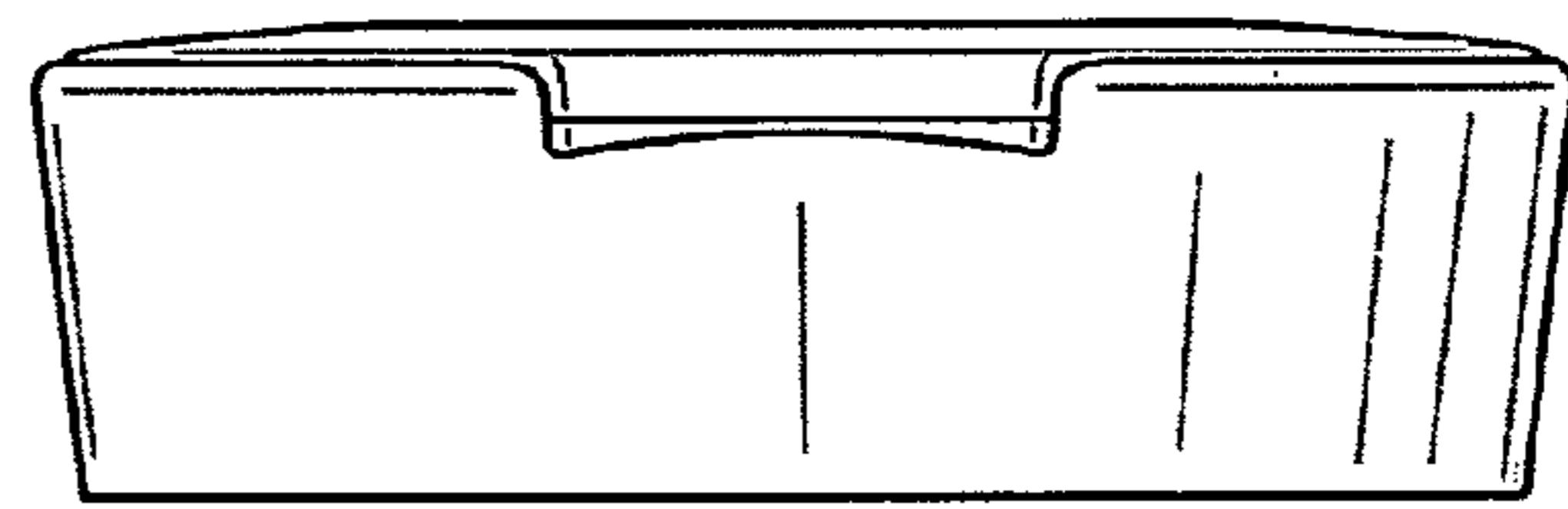

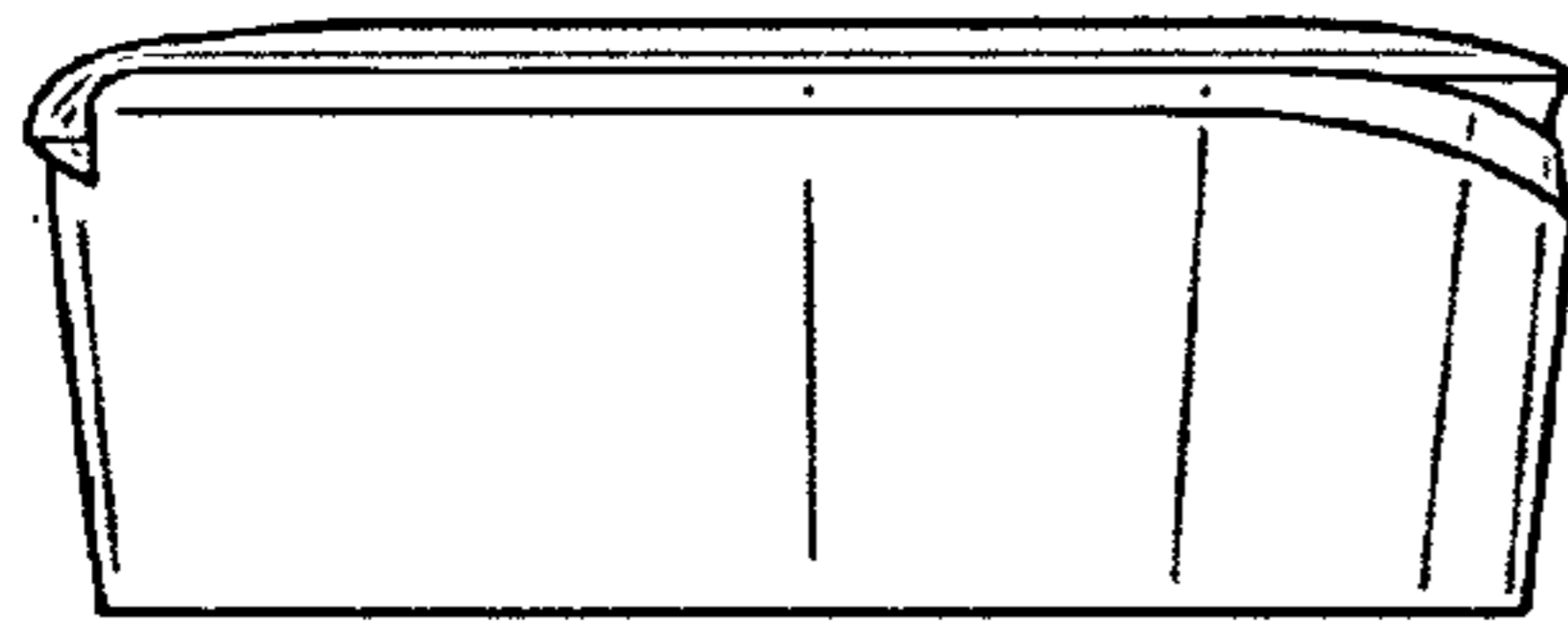

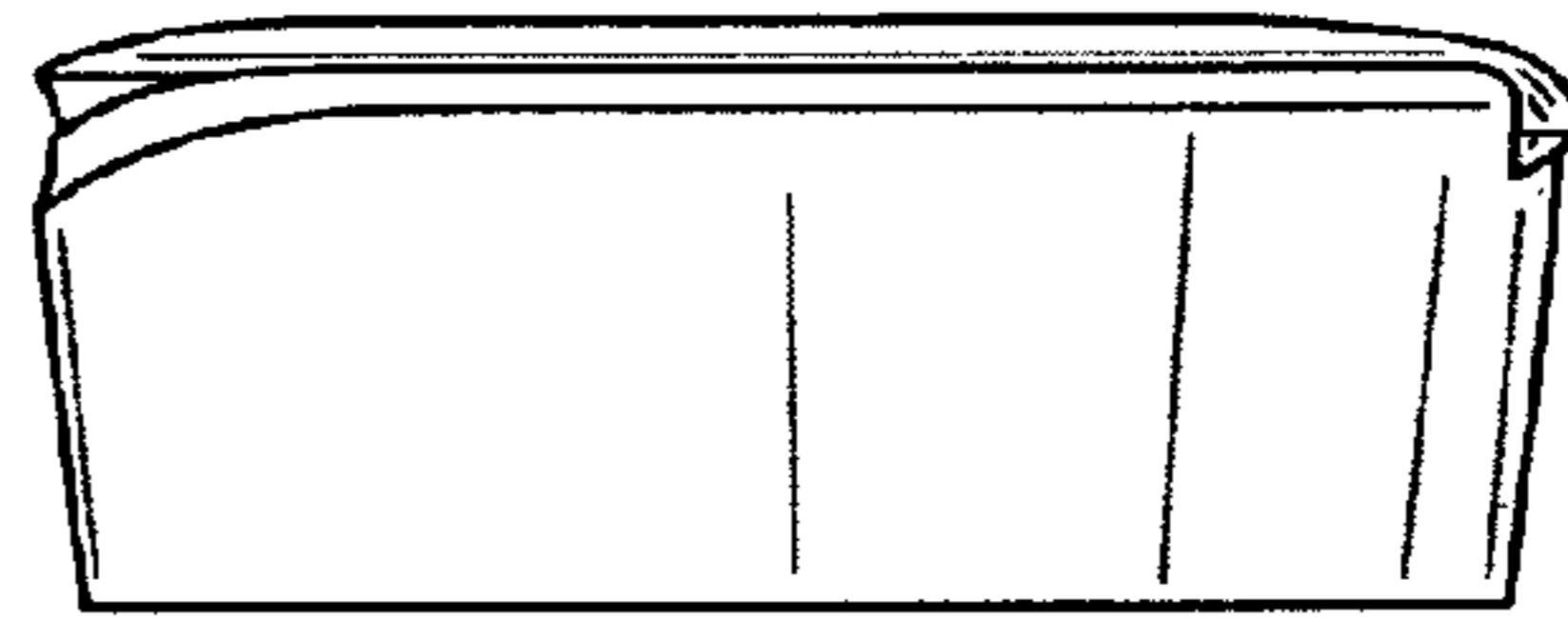

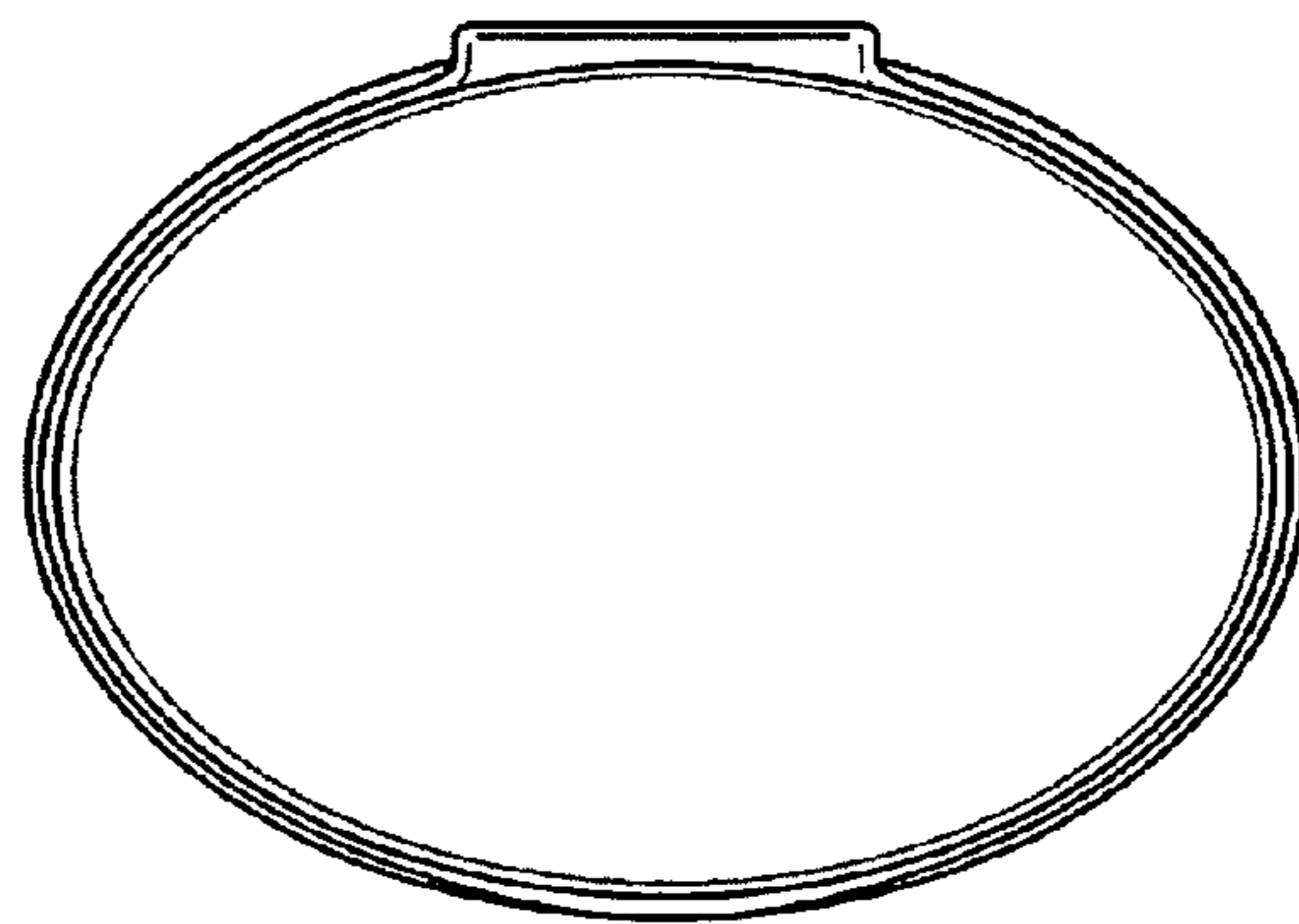
