DESCRIPTION

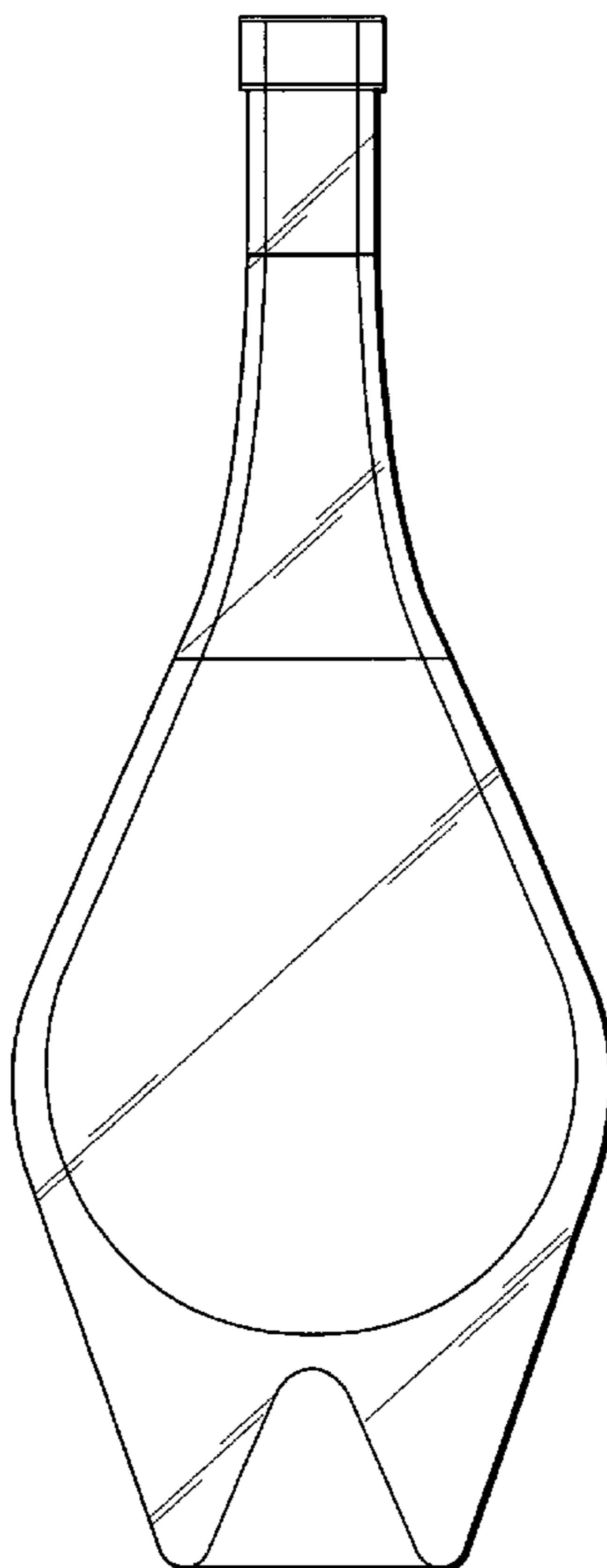
FIG. 1 is a front perspective view of a first embodiment of a bottle showing my new design;

FIG. 2 is a front elevation view of a second embodiment of my design, showing the bottle of FIG. 1 in transparent form, the left side, right side and rear elevation views being identical;

FIG. 3 is a top plan view of the bottle of FIG. 1; and,

FIG. 4 is a bottom plan view thereof, shown at an enlarged scale.

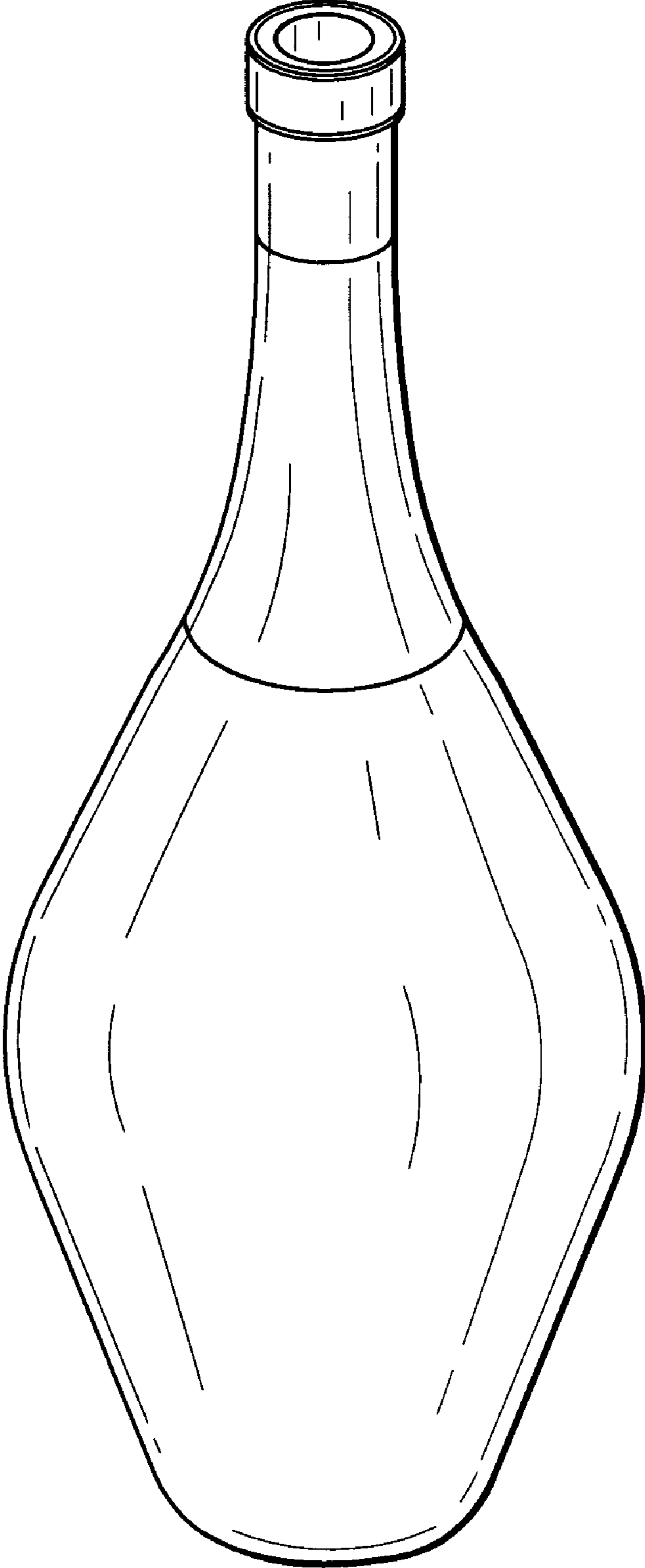

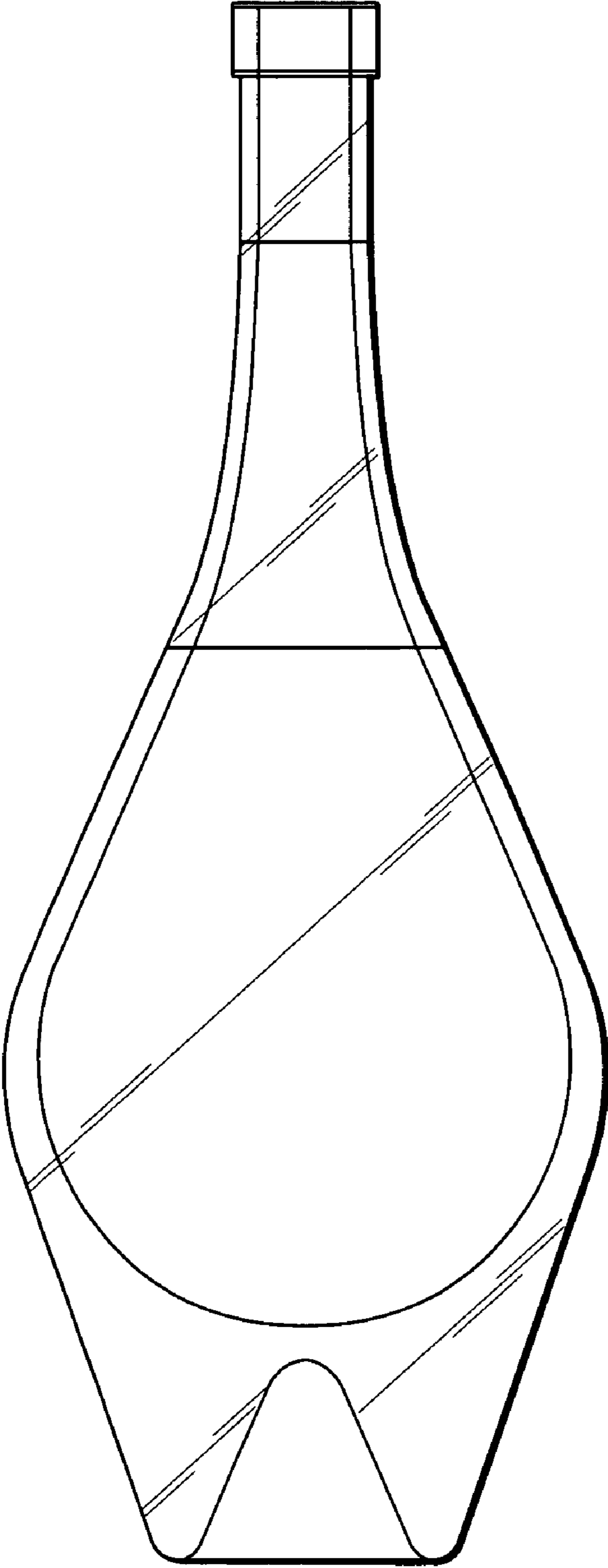

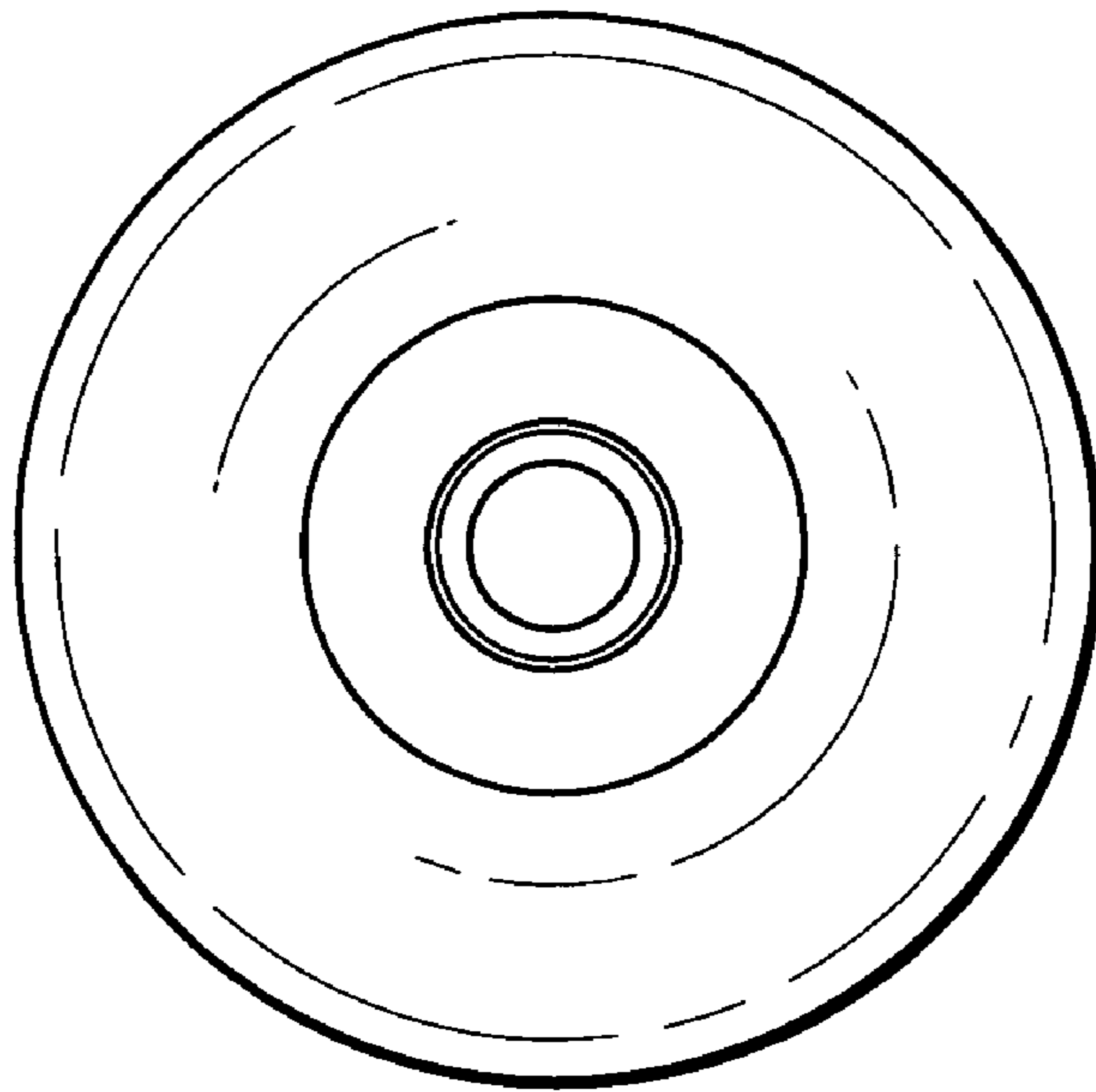

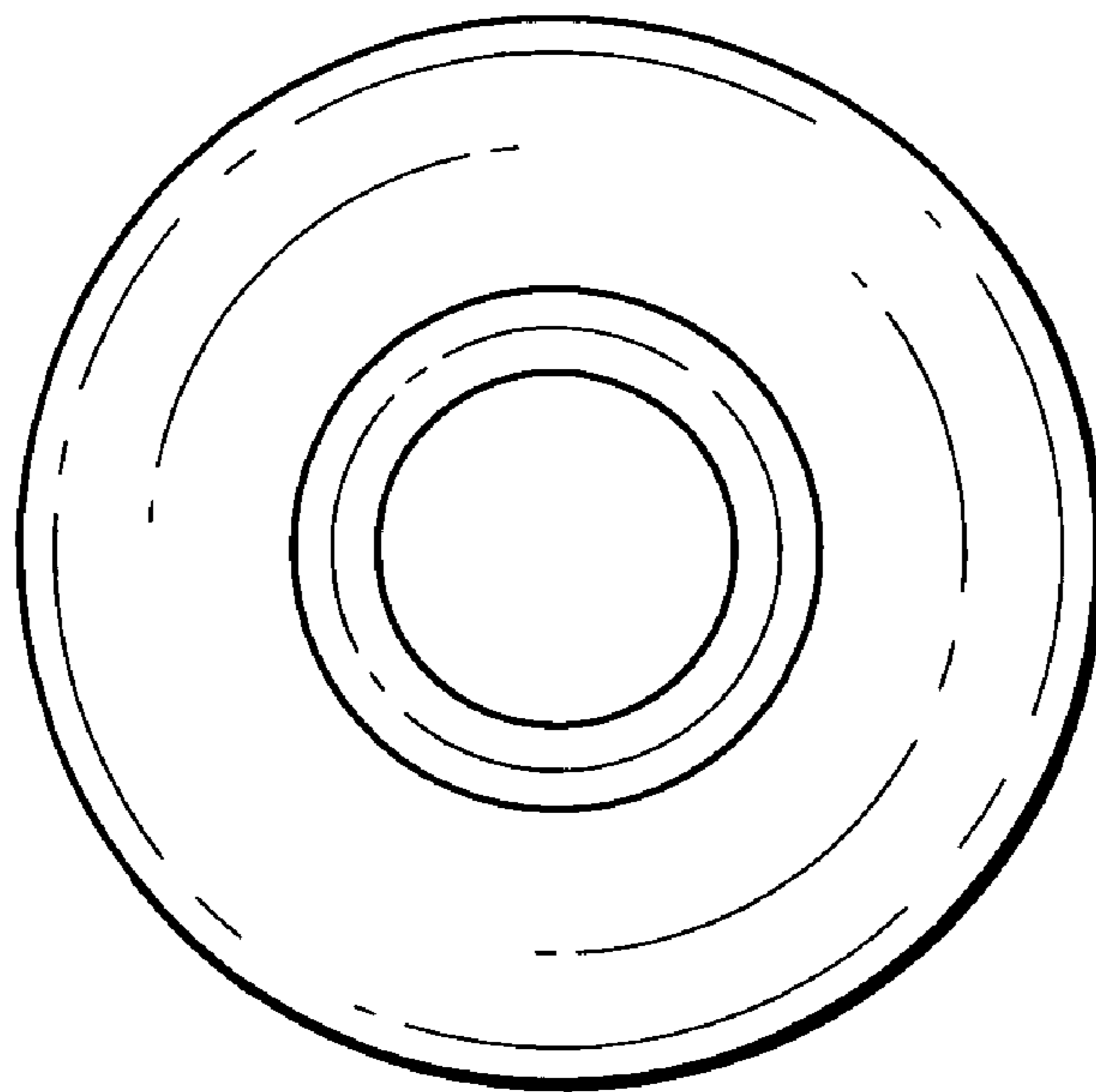
