FIG. 6 is a side view thereof;

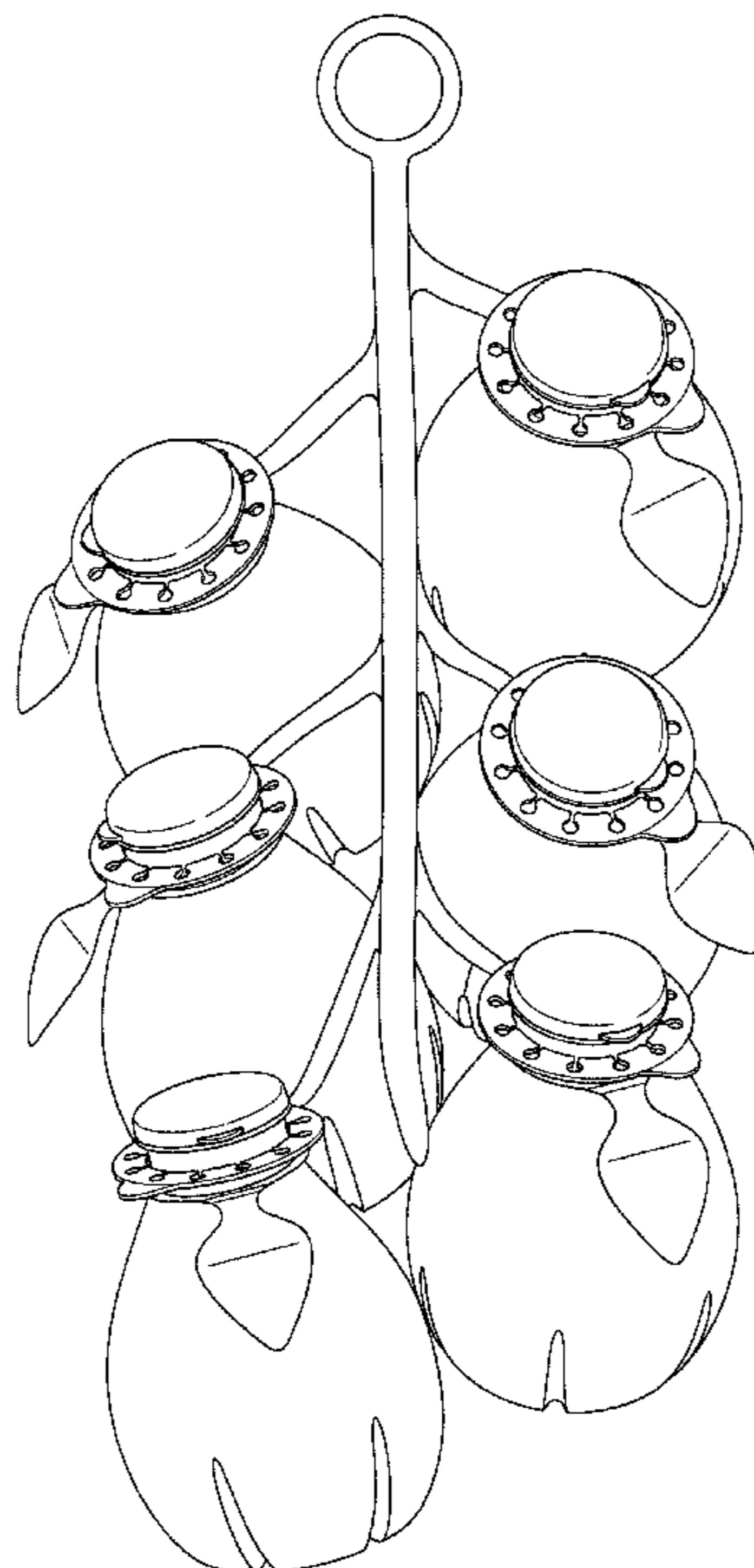
FIG. 7 is an opposite side view of the stand.

FIG. 8 is an upper end view of the stand.

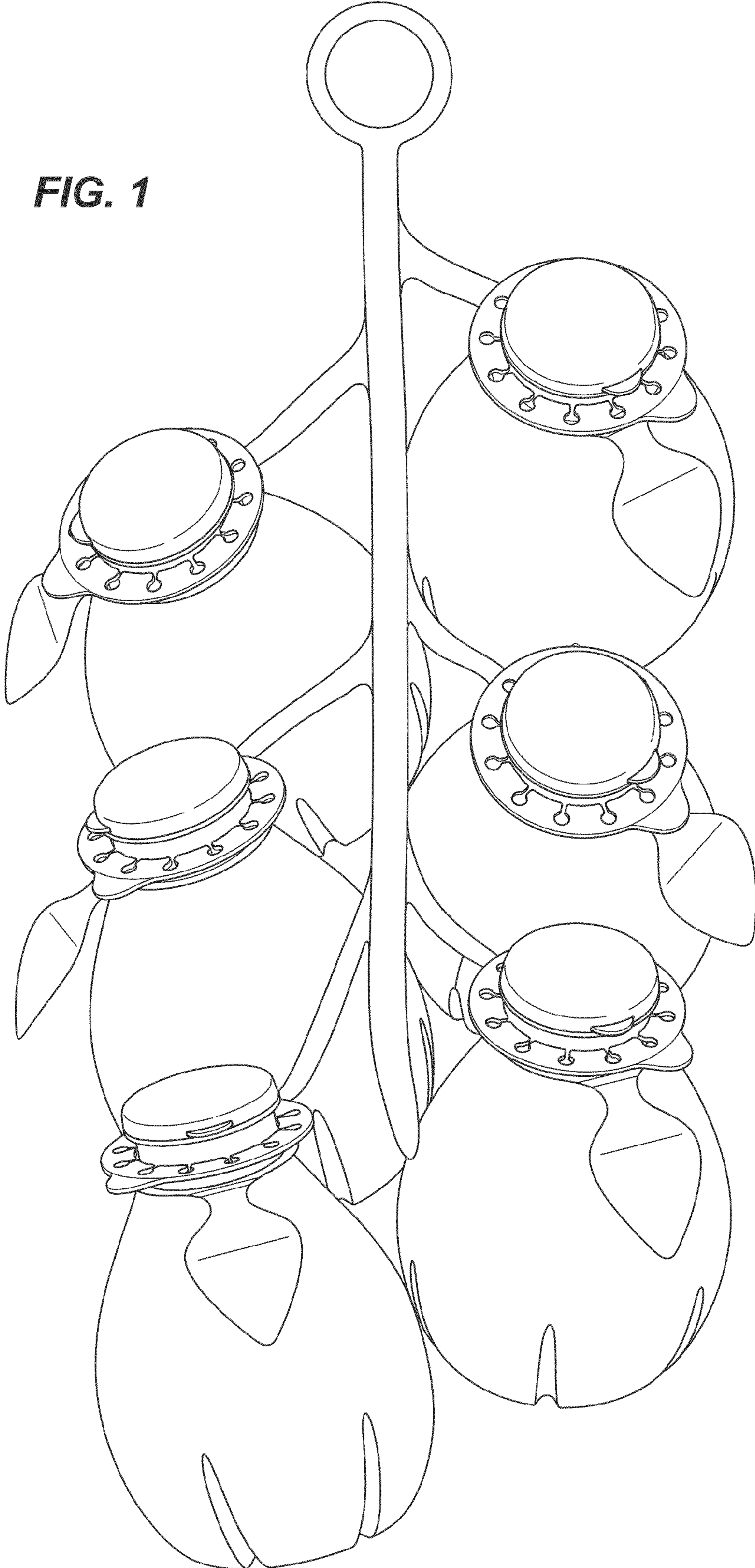
FIG. 9 is a lower end view of the stand; and,

FIG. 10 is a rear view of the stand.

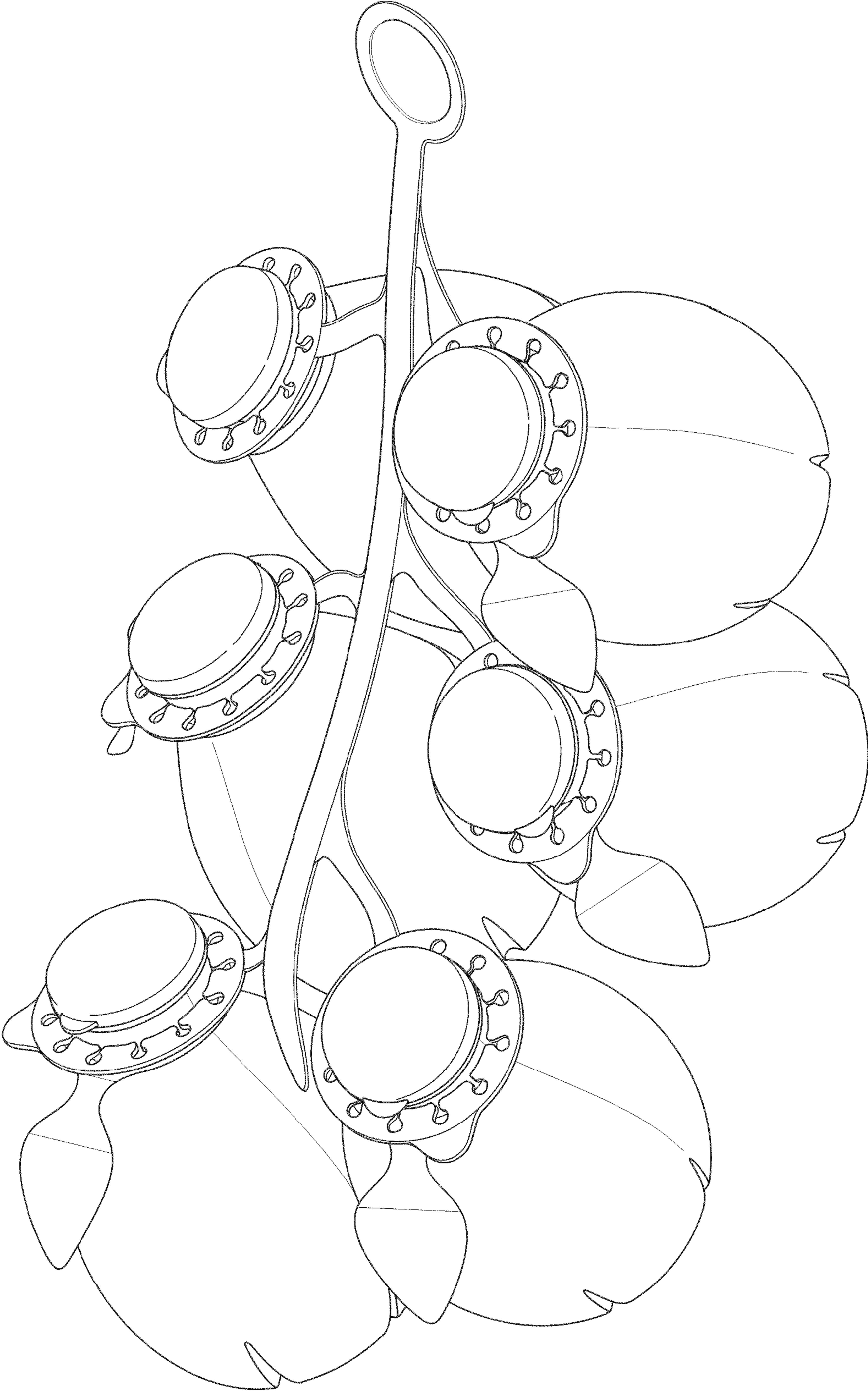

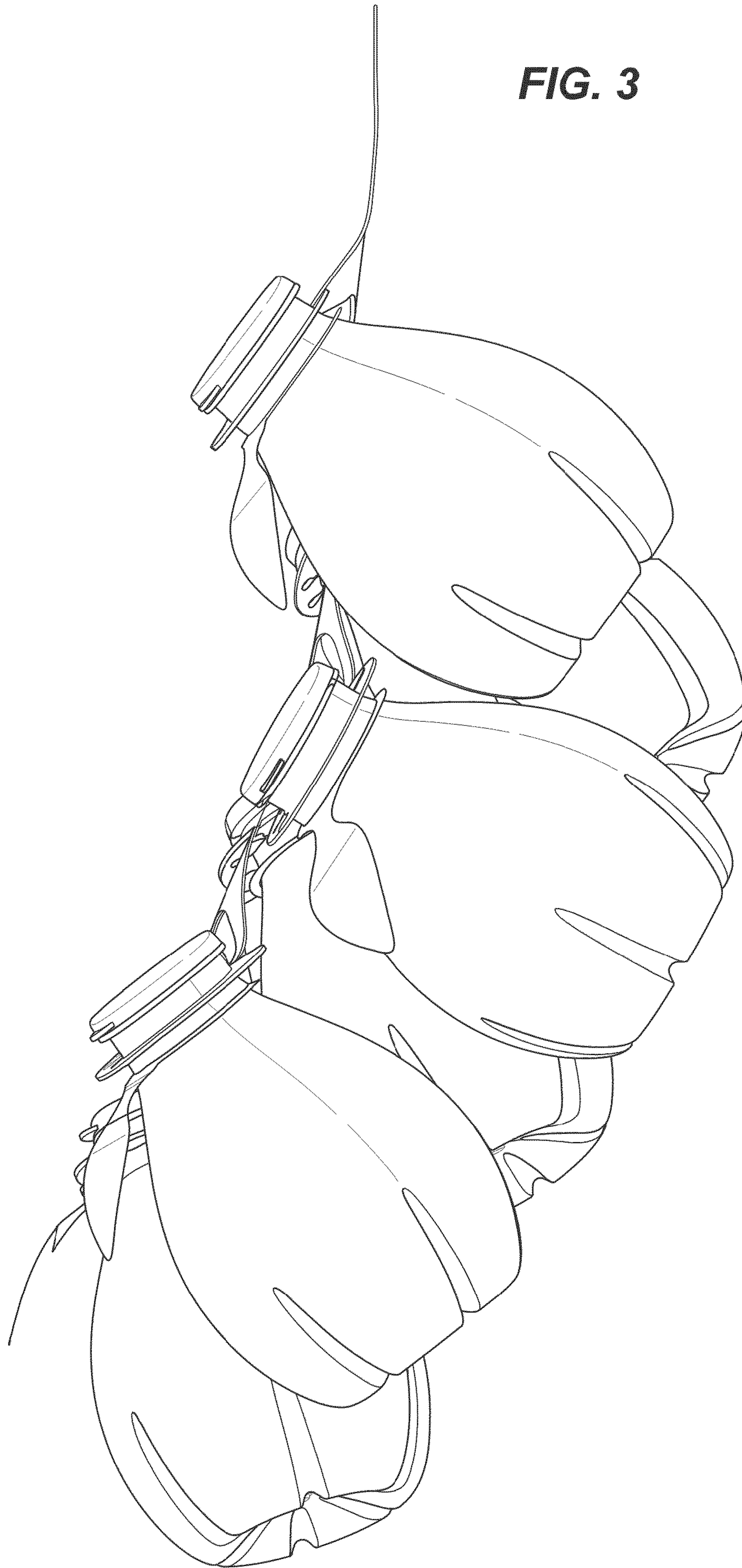

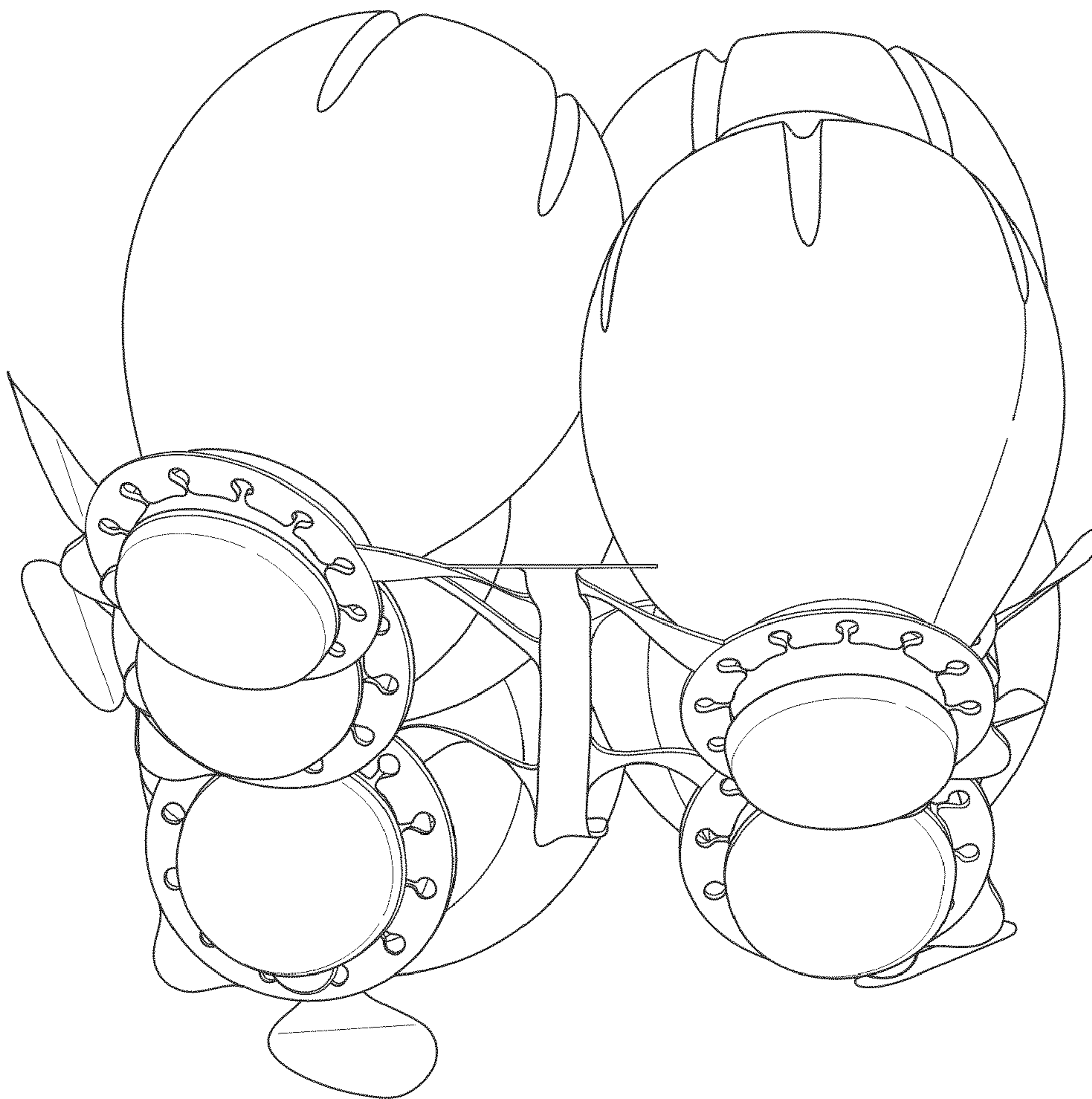




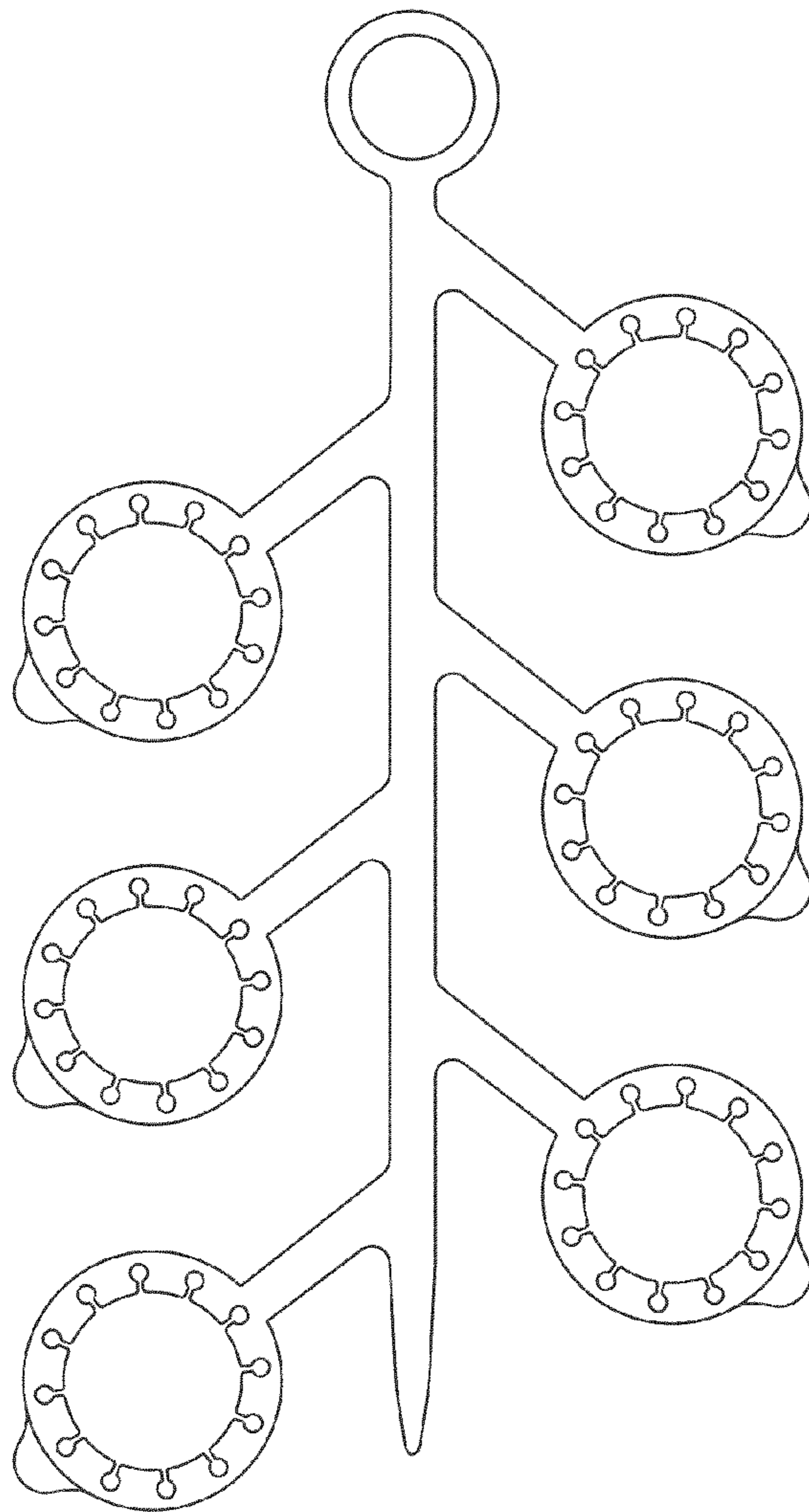

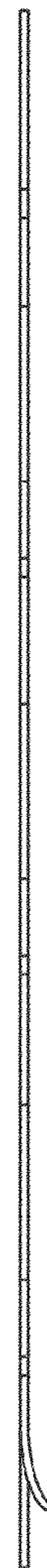
