FIG. 1 is a front elevational view of the spray bottle with replaceable cartridge insert showing my new design;

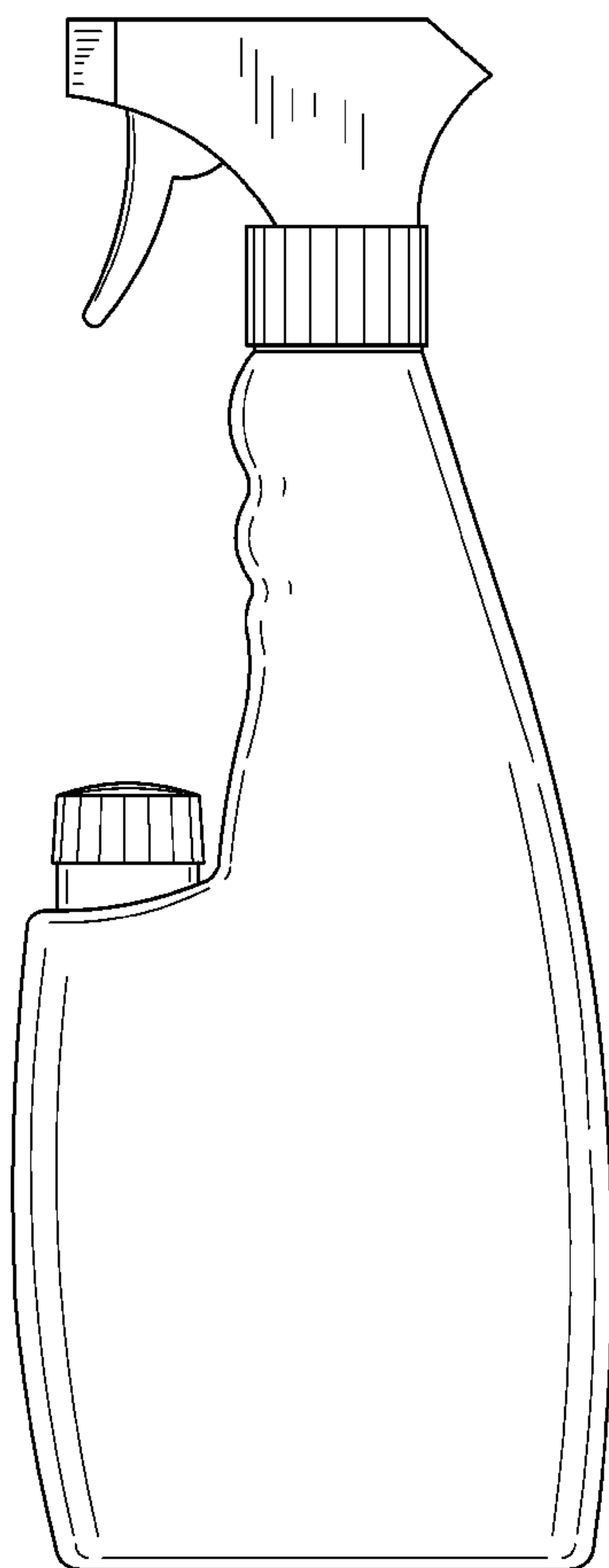
FIG. 2 is a left-side elevational view thereof;

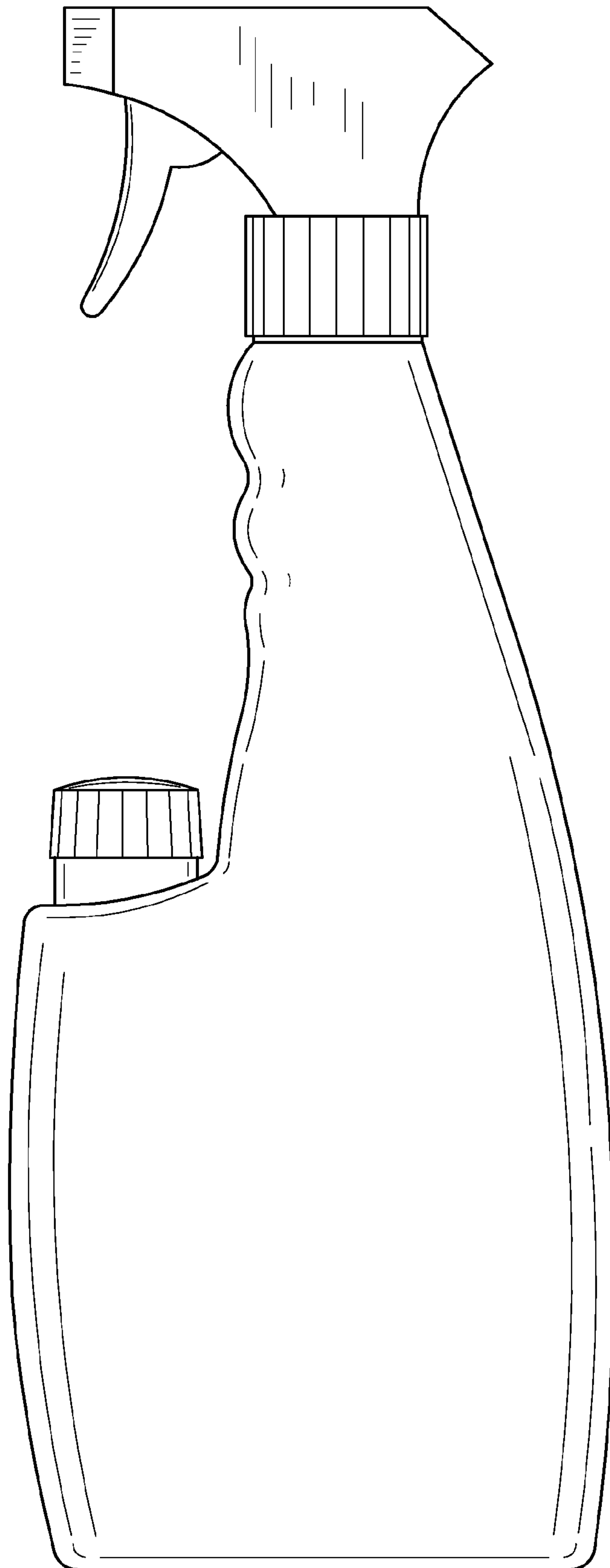

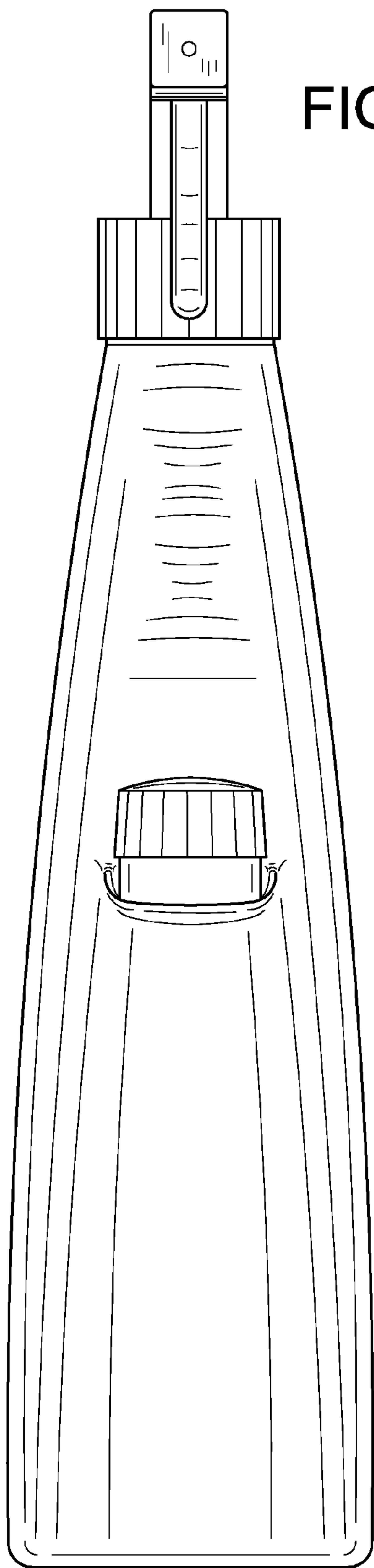

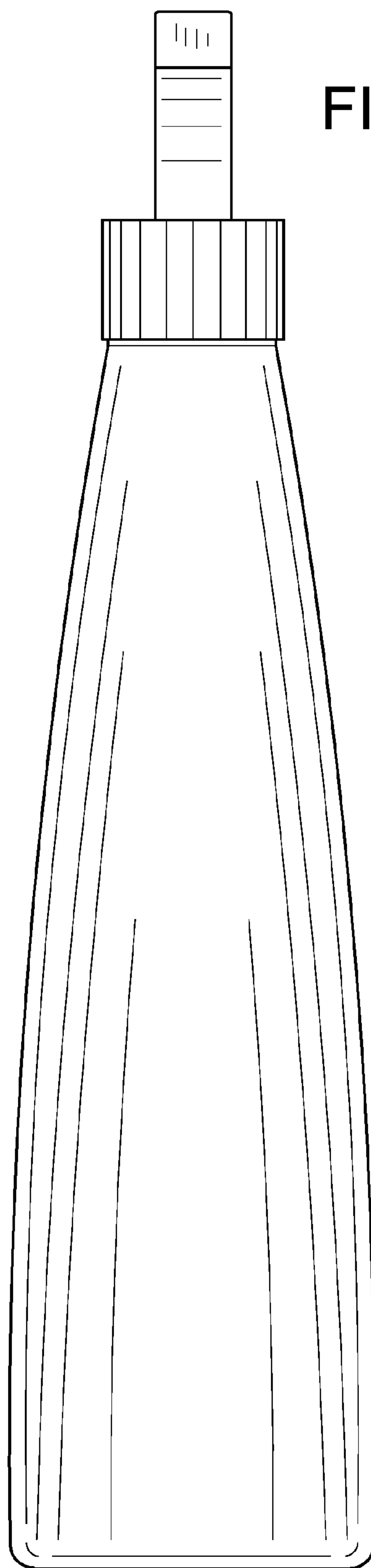

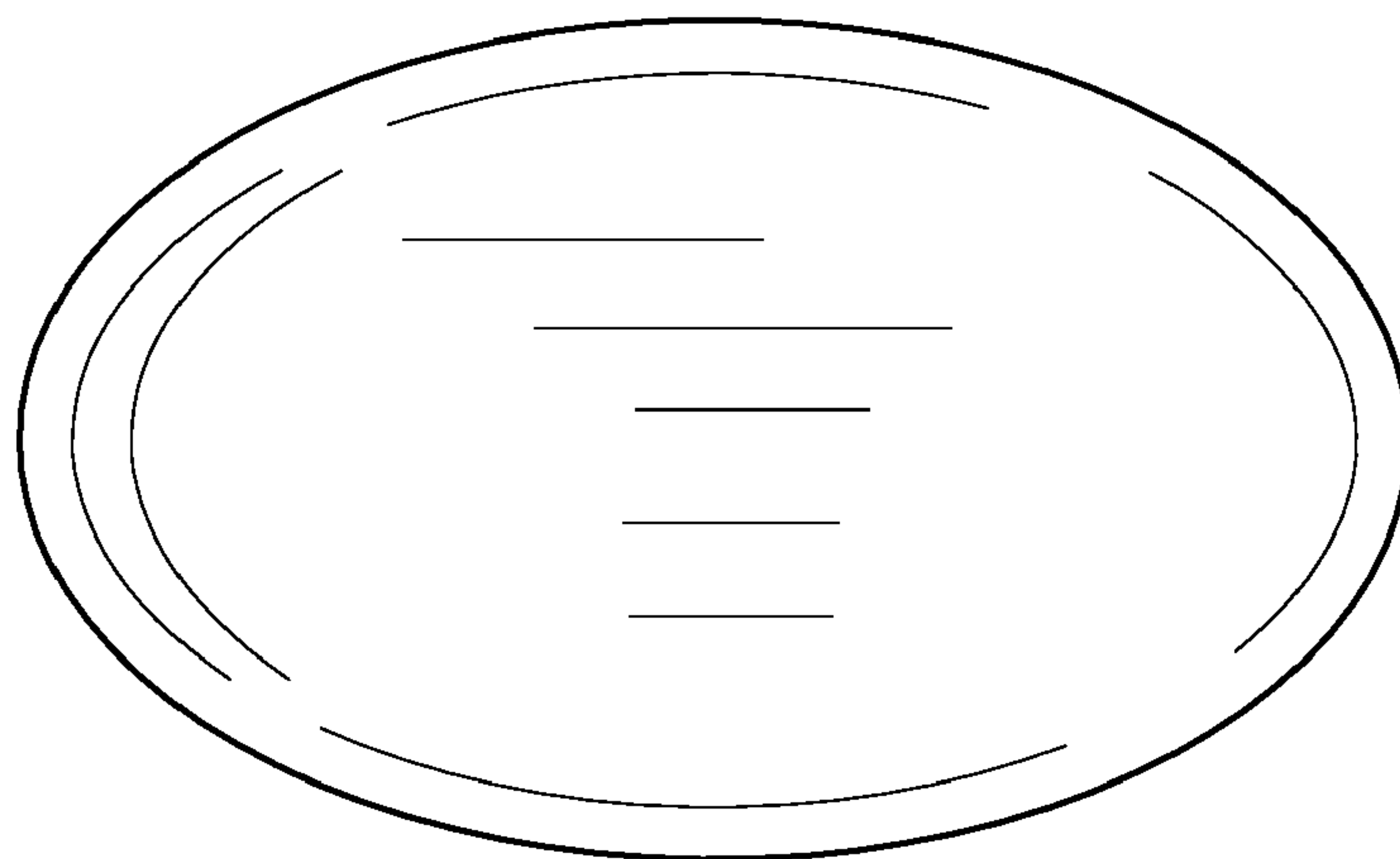
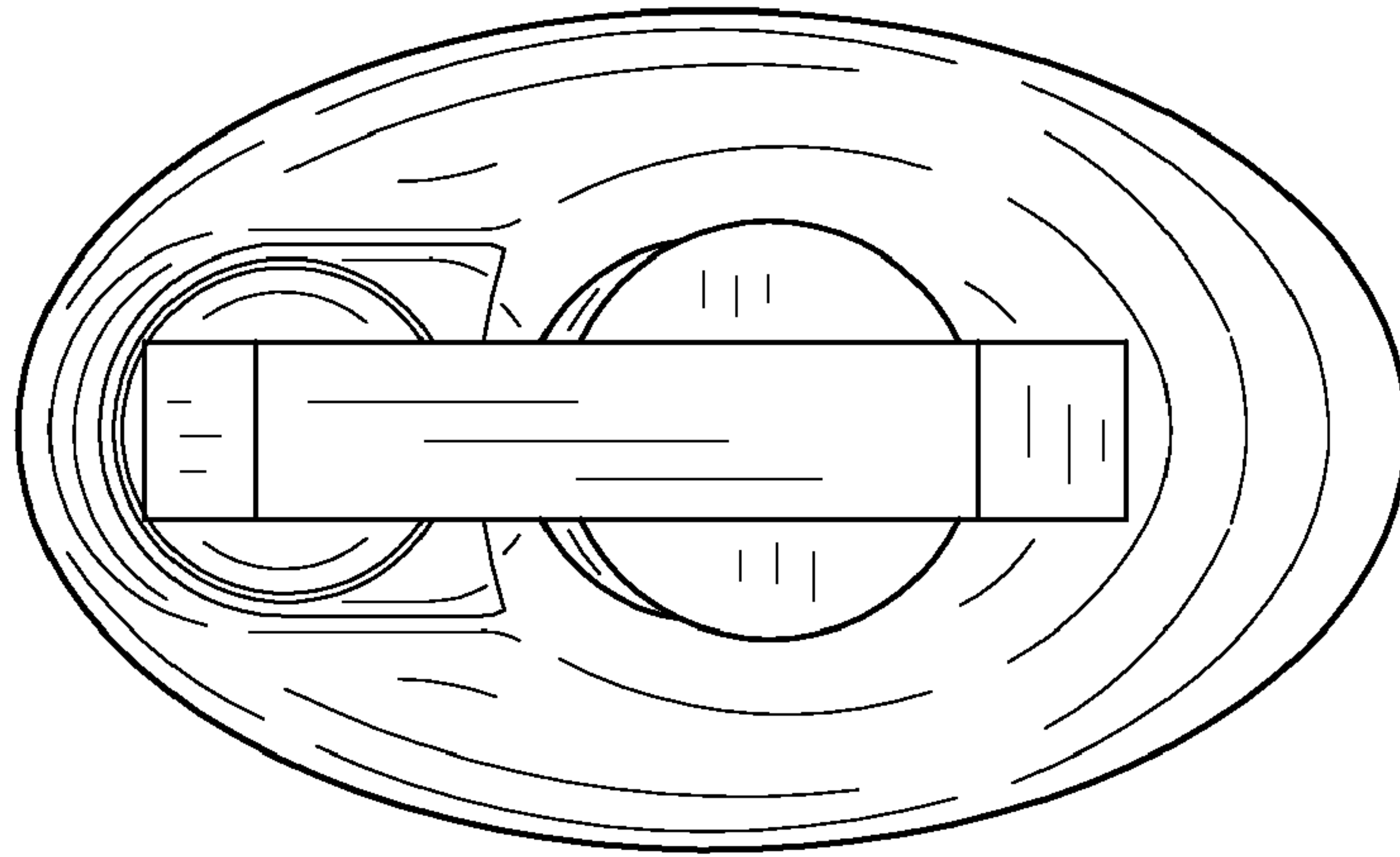
