FIG. 4 is a right side view of the tall vase of FIG. 1;

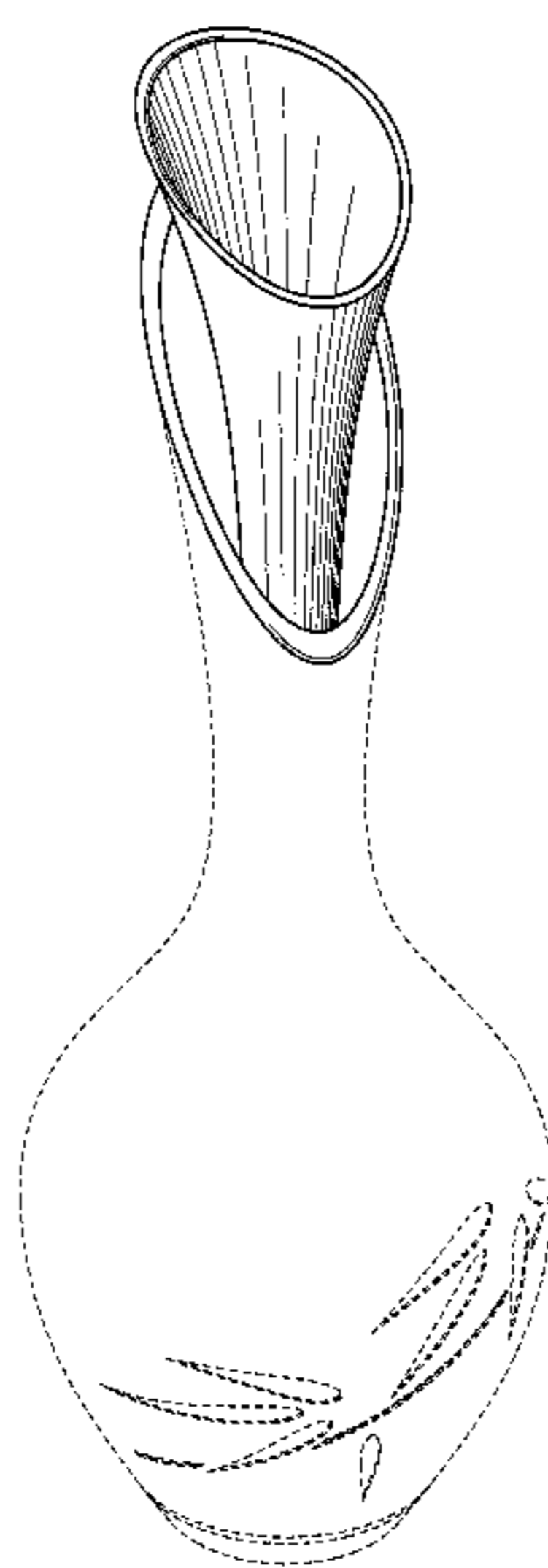
FIG. 5 is left side view of the tall vase of FIG. 1;

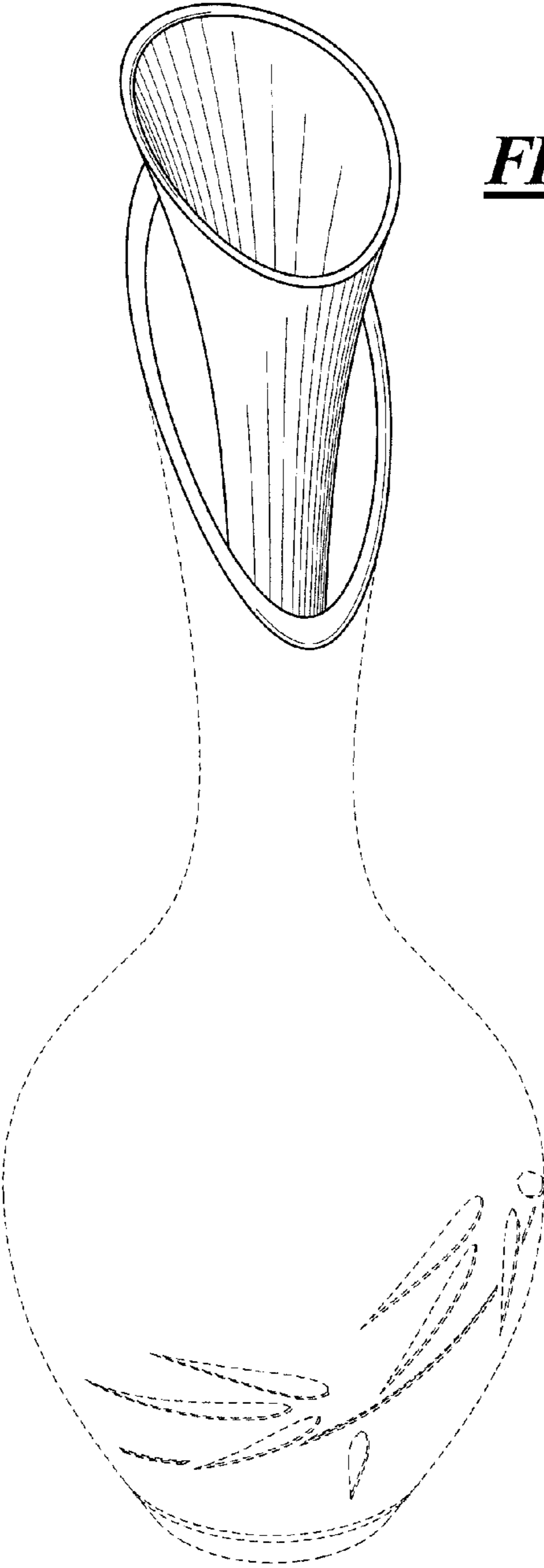

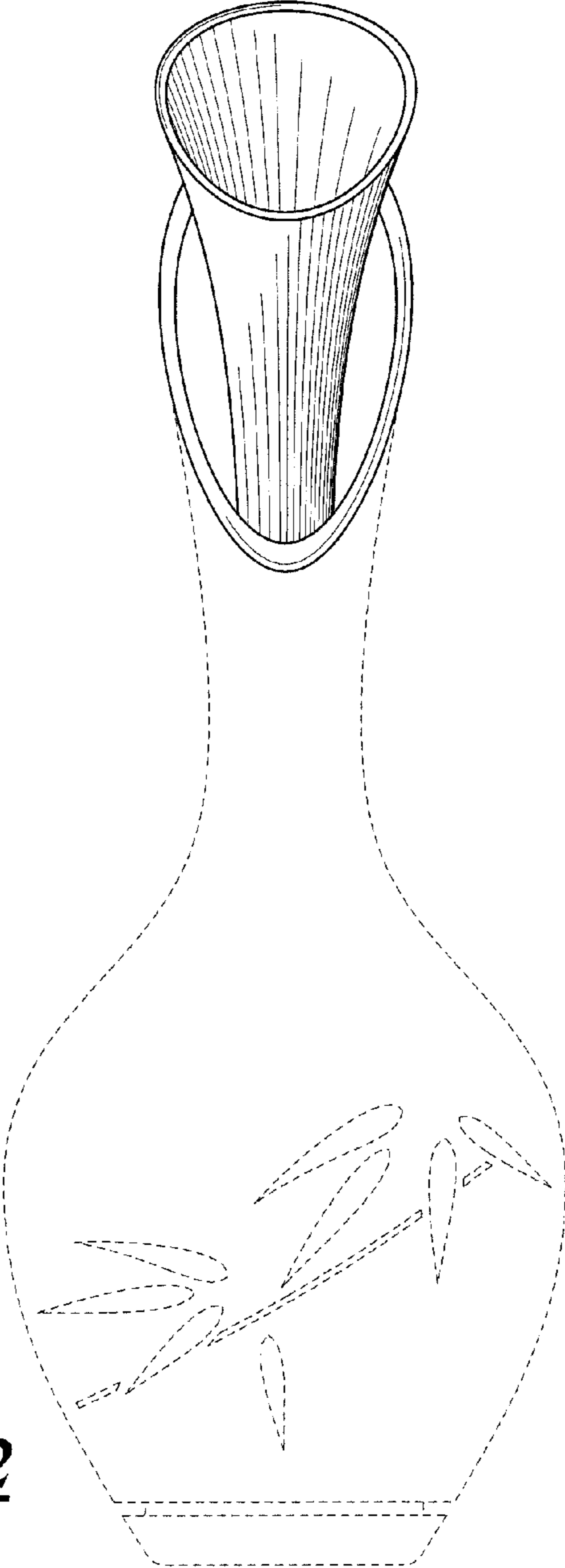

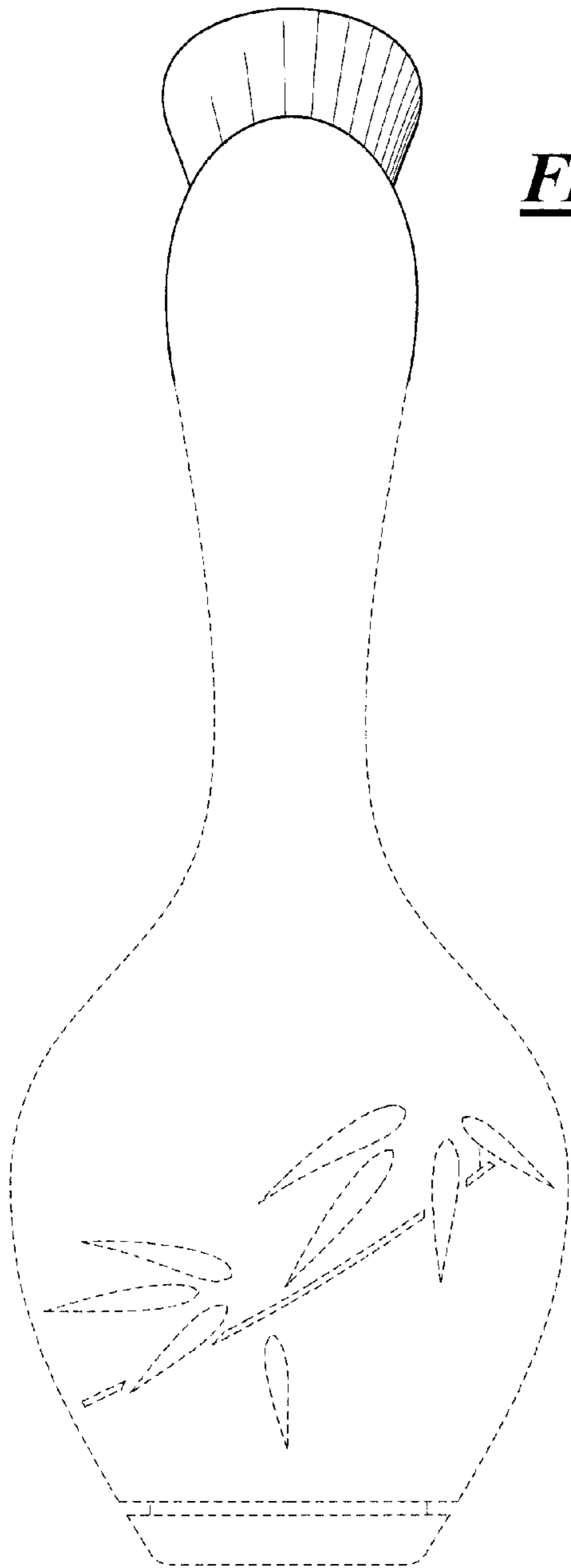

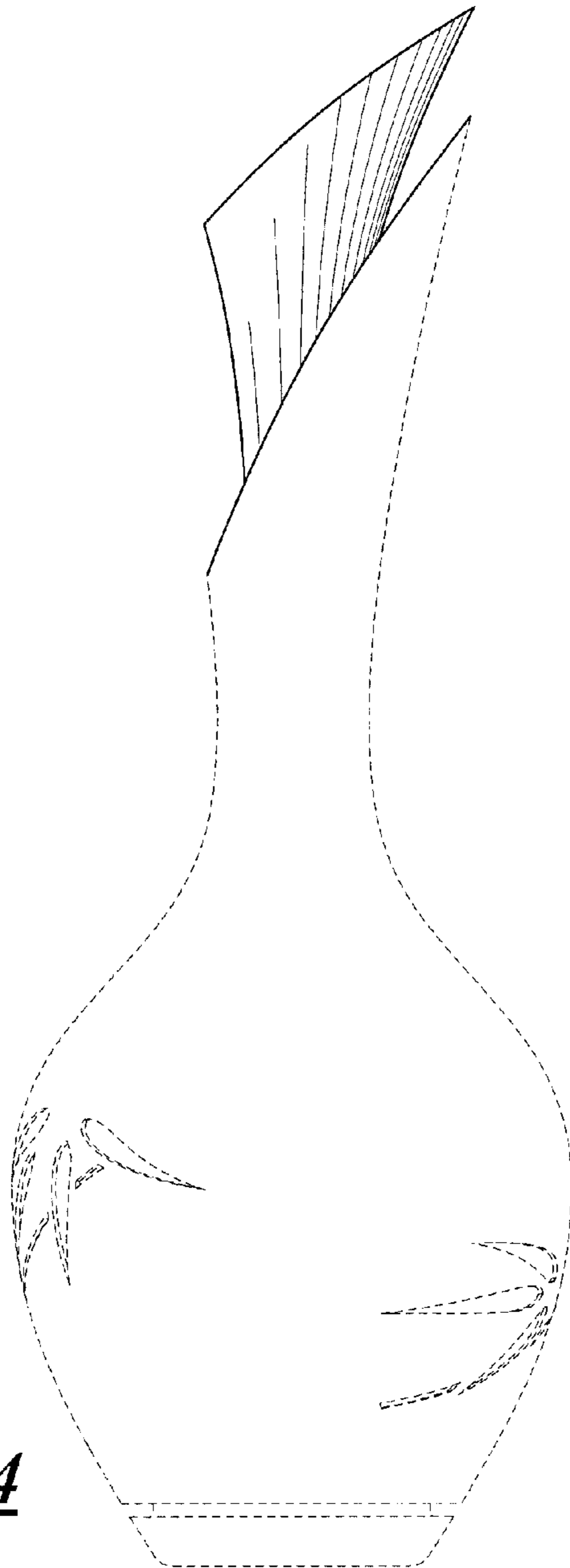

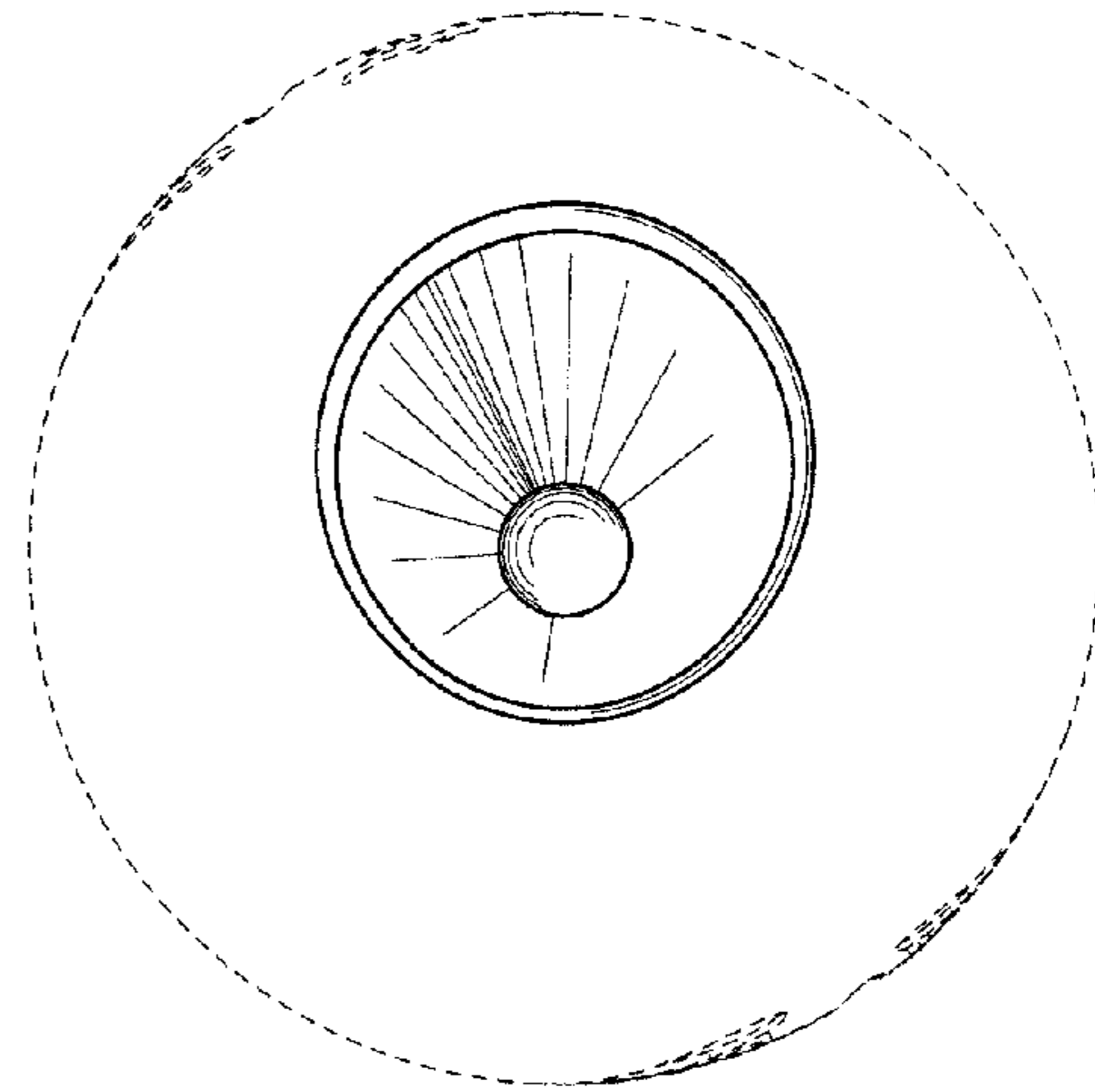
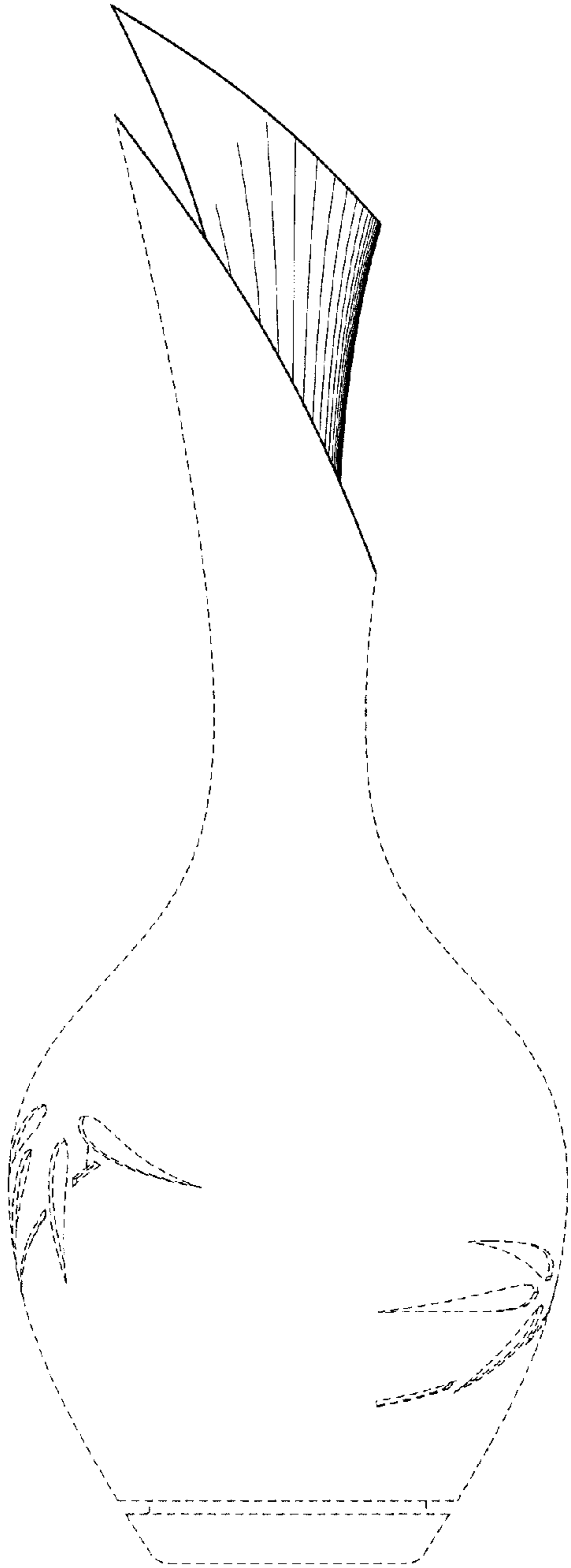

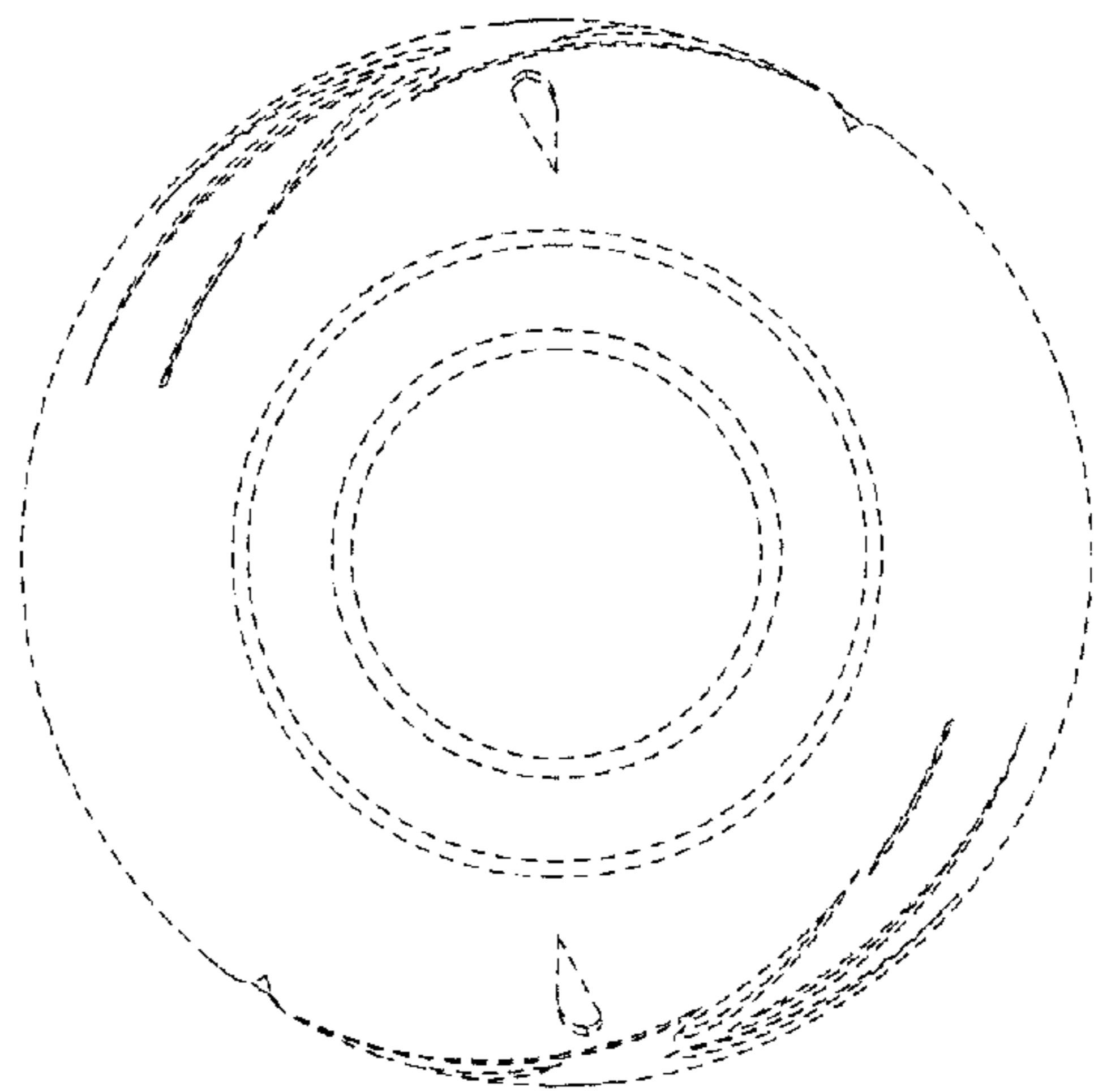
