FIG. 1 is a top plan view of a writing instrument with nail file,
showing our new design.

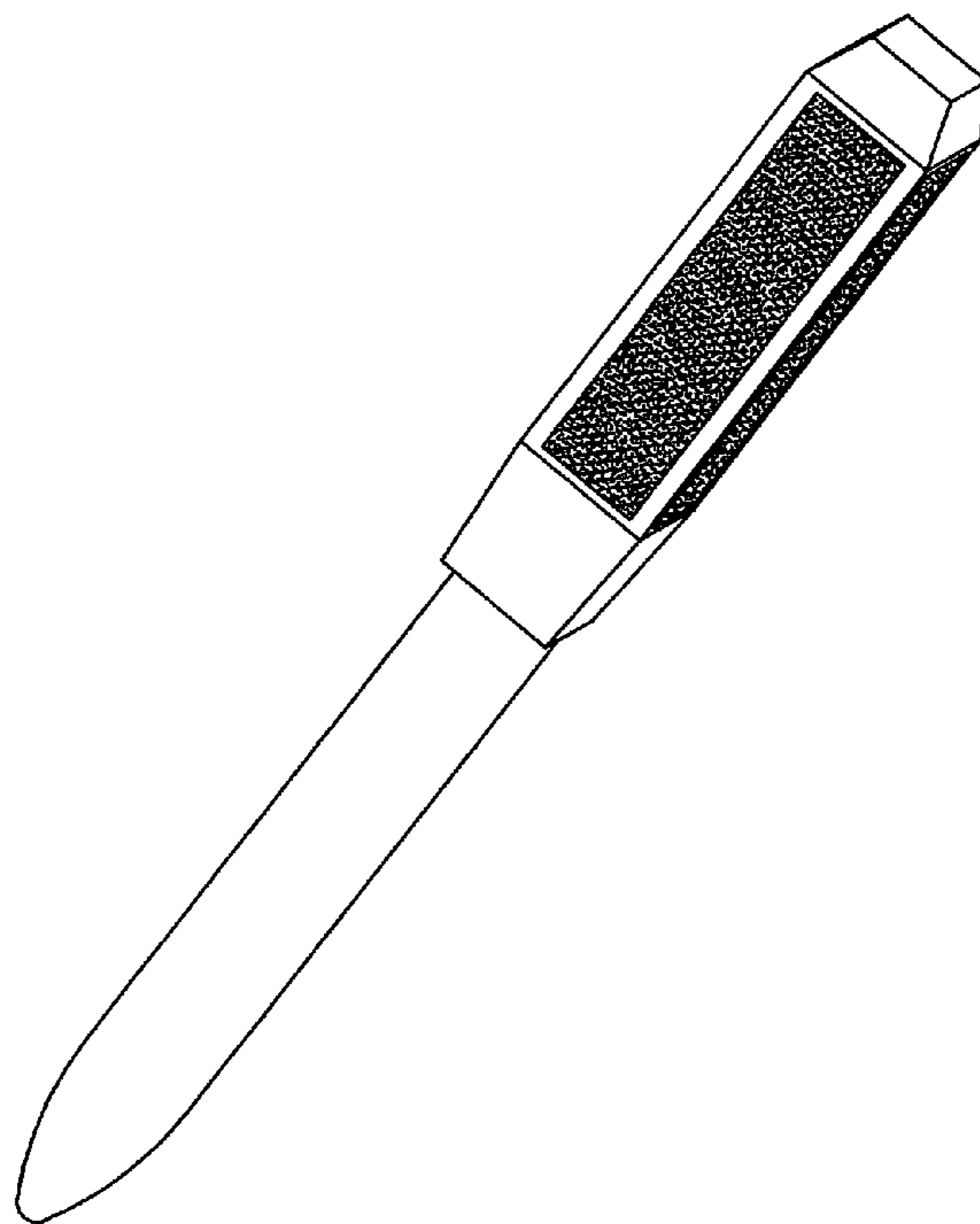
FIG. 2 is a side elevation view thereof;

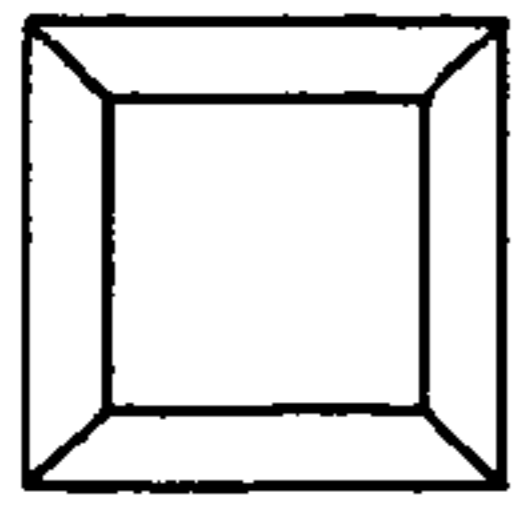

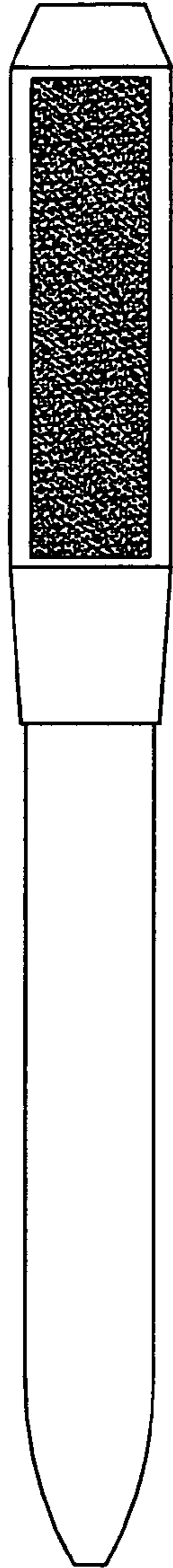

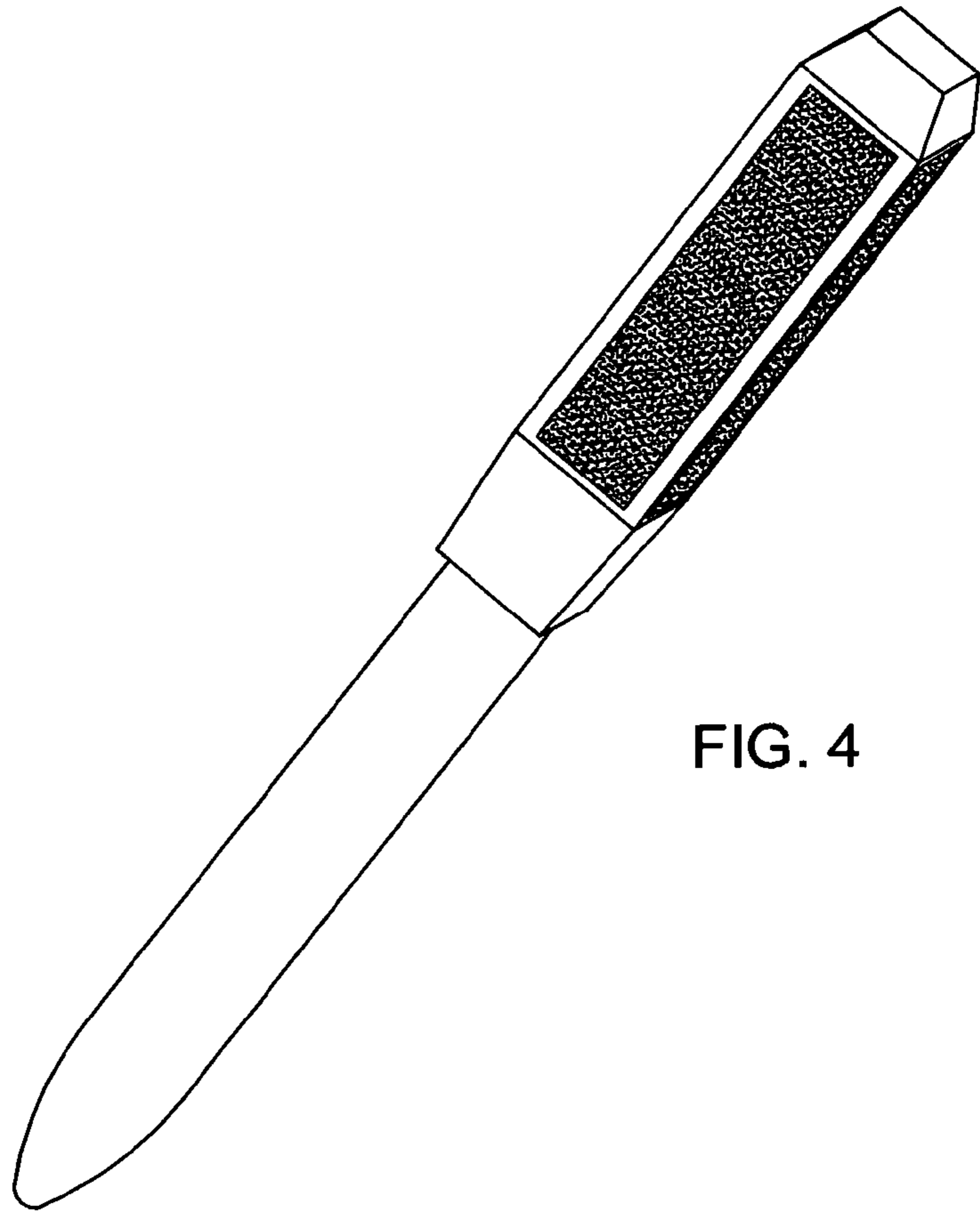

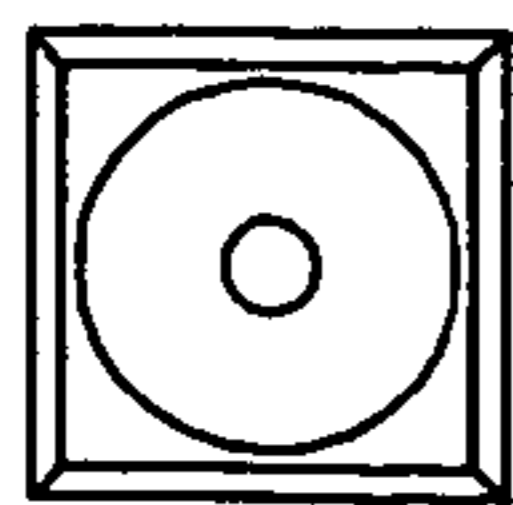
