FIG. 1 is a front perspective view of a paintball loader body having the design of the present invention;

FIG. 2 is a top plan view of the paintball loader shown in FIG. 1;

FIG. 3 is a bottom view of the paintball loader shown in FIG. 1;

FIG. 4 is a rear elevational view of the paintball loader shown in FIG. 1;

FIG. 5 is a front elevational view of the paintball loader shown in FIG. 1; and,

FIG. 6 is a left side elevational view of the paintball loader body shown in FIG. 1, the right side elevational view being a mirror image thereof.

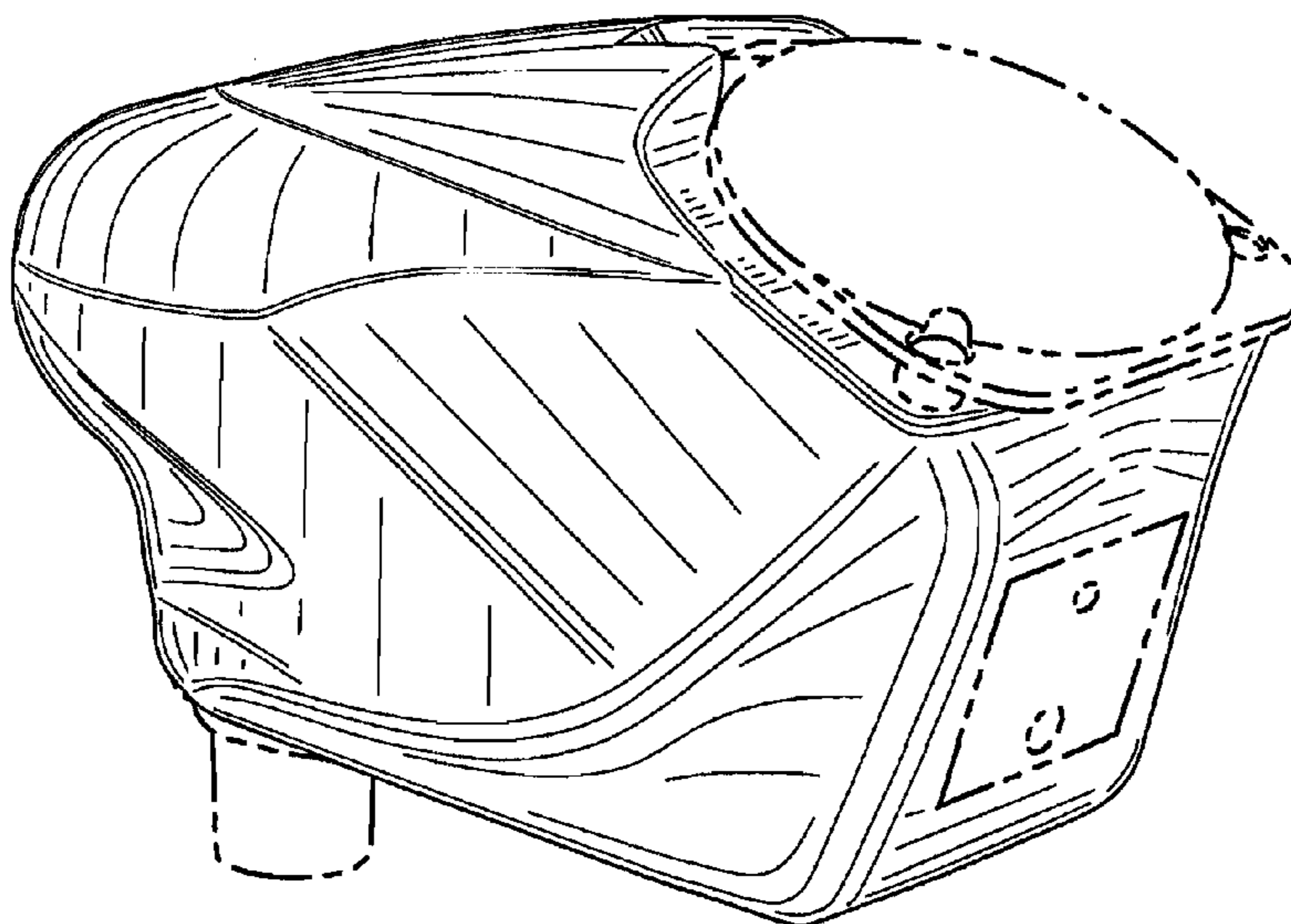

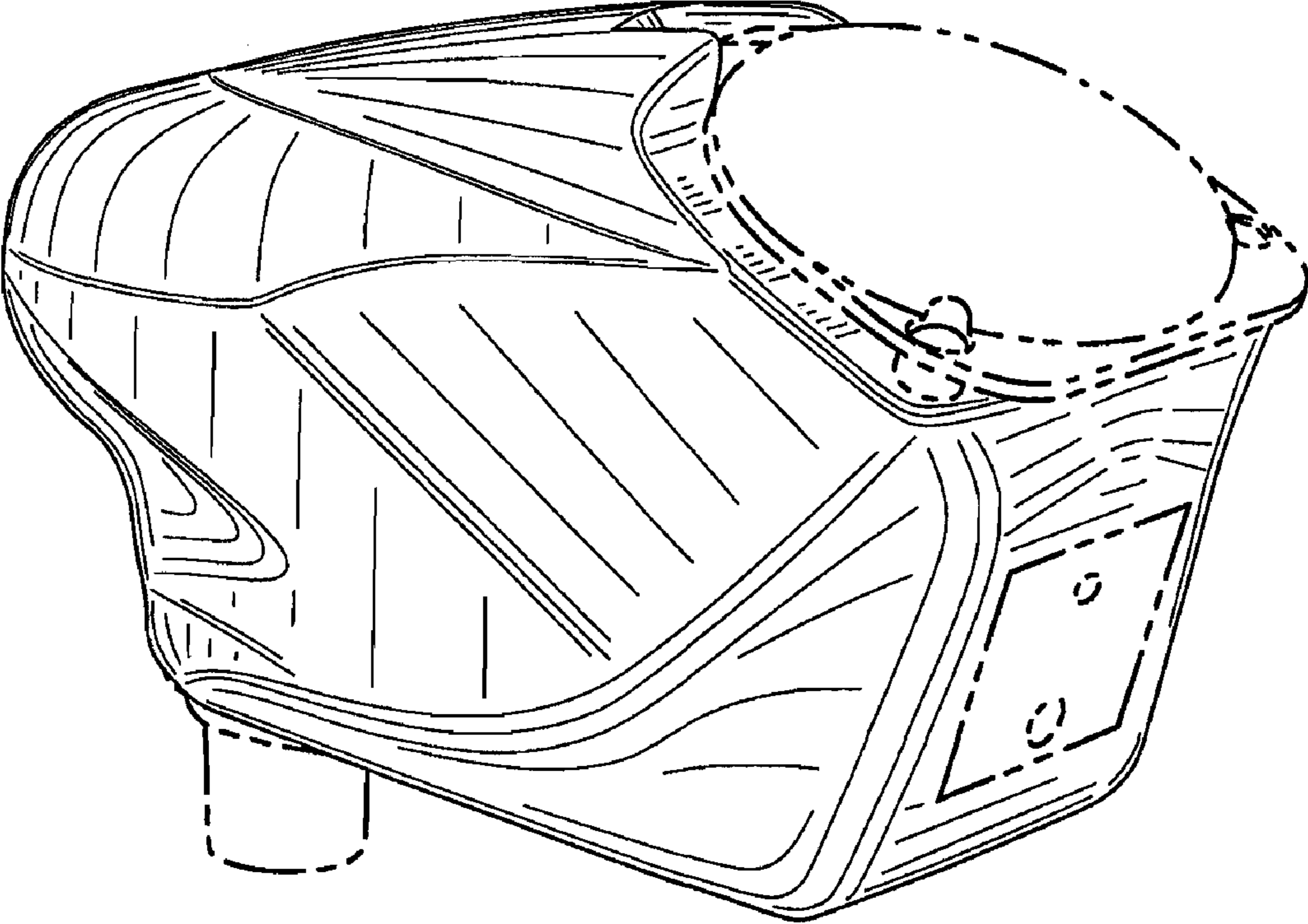

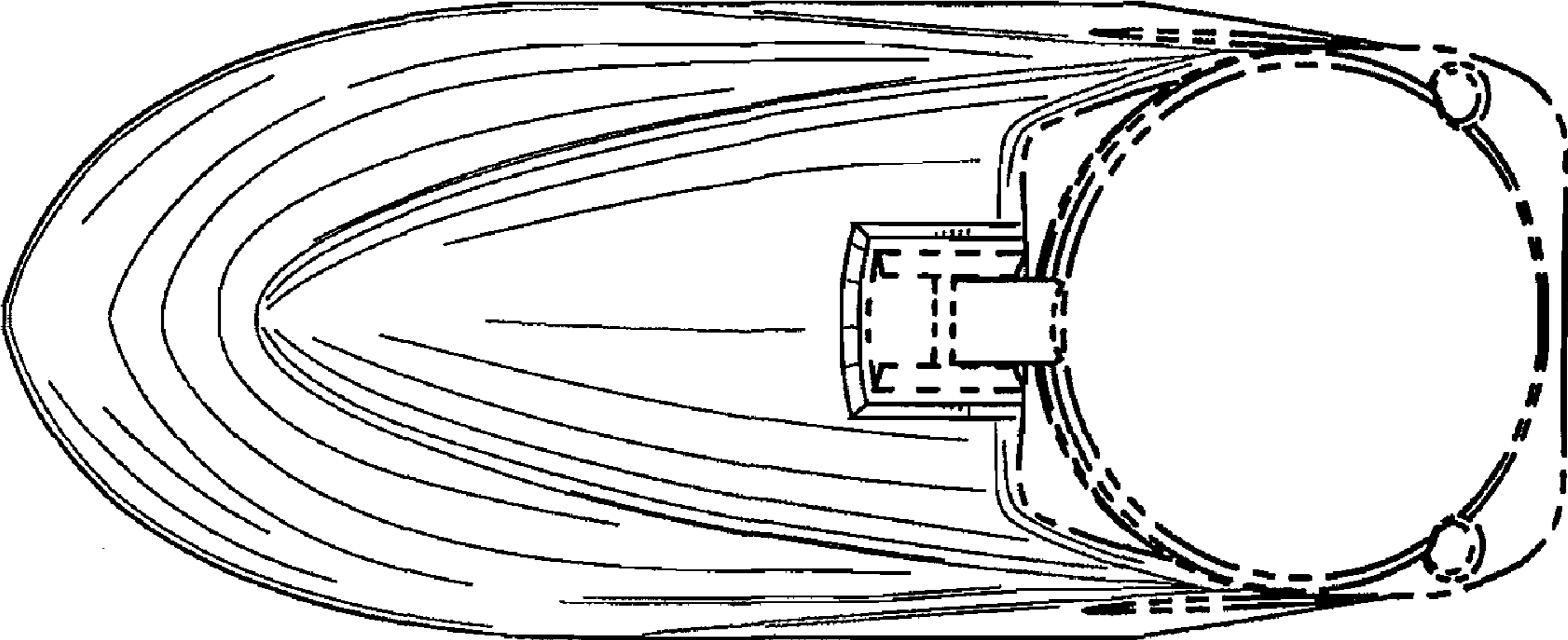

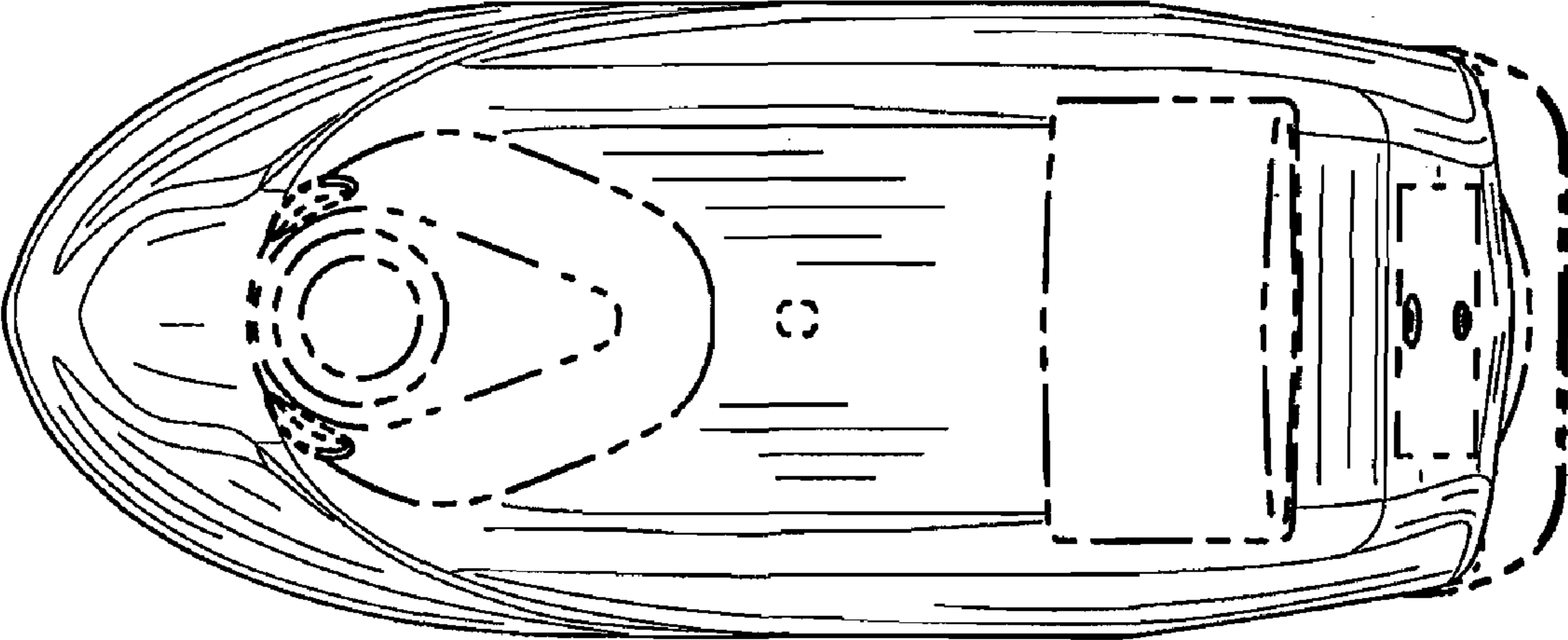

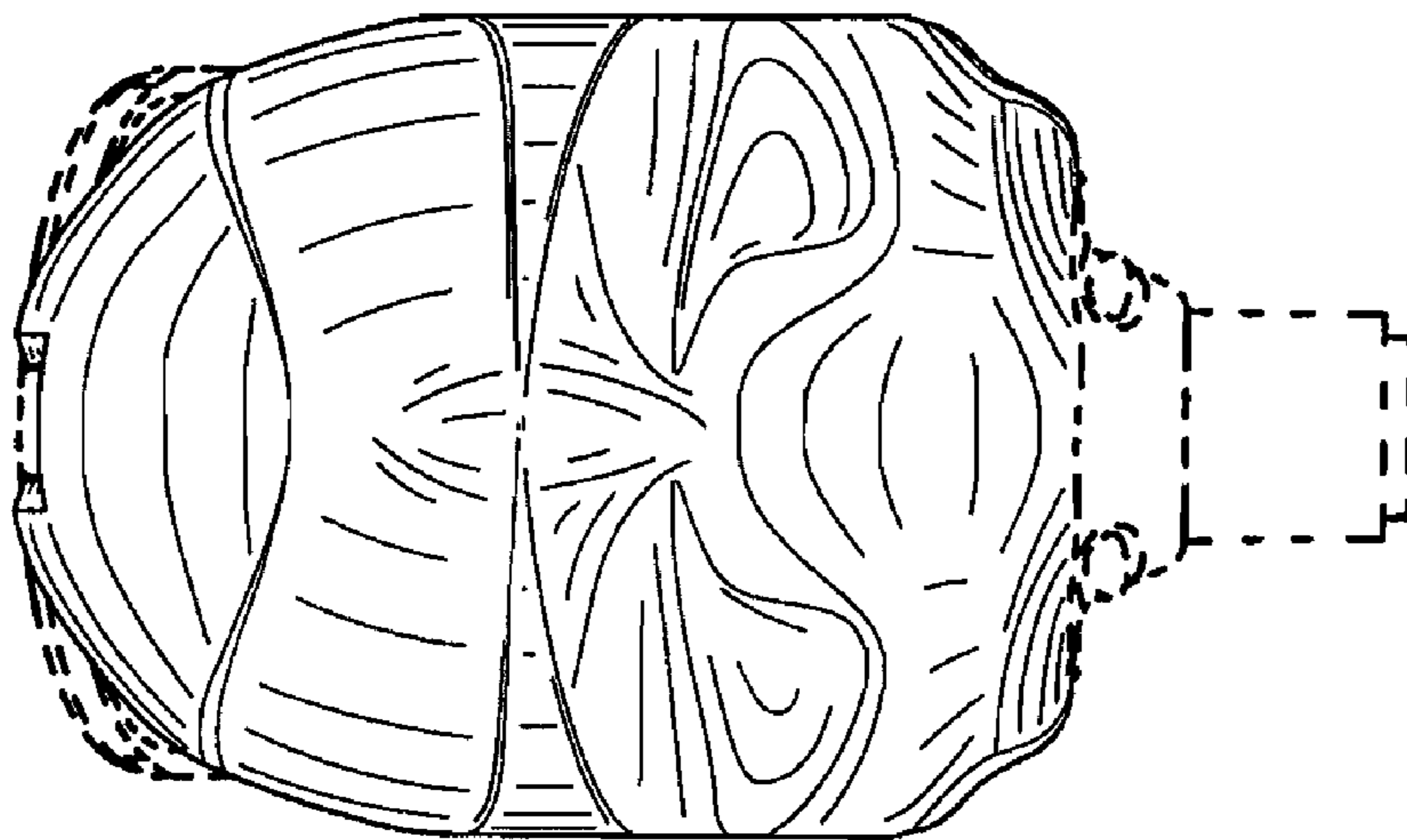

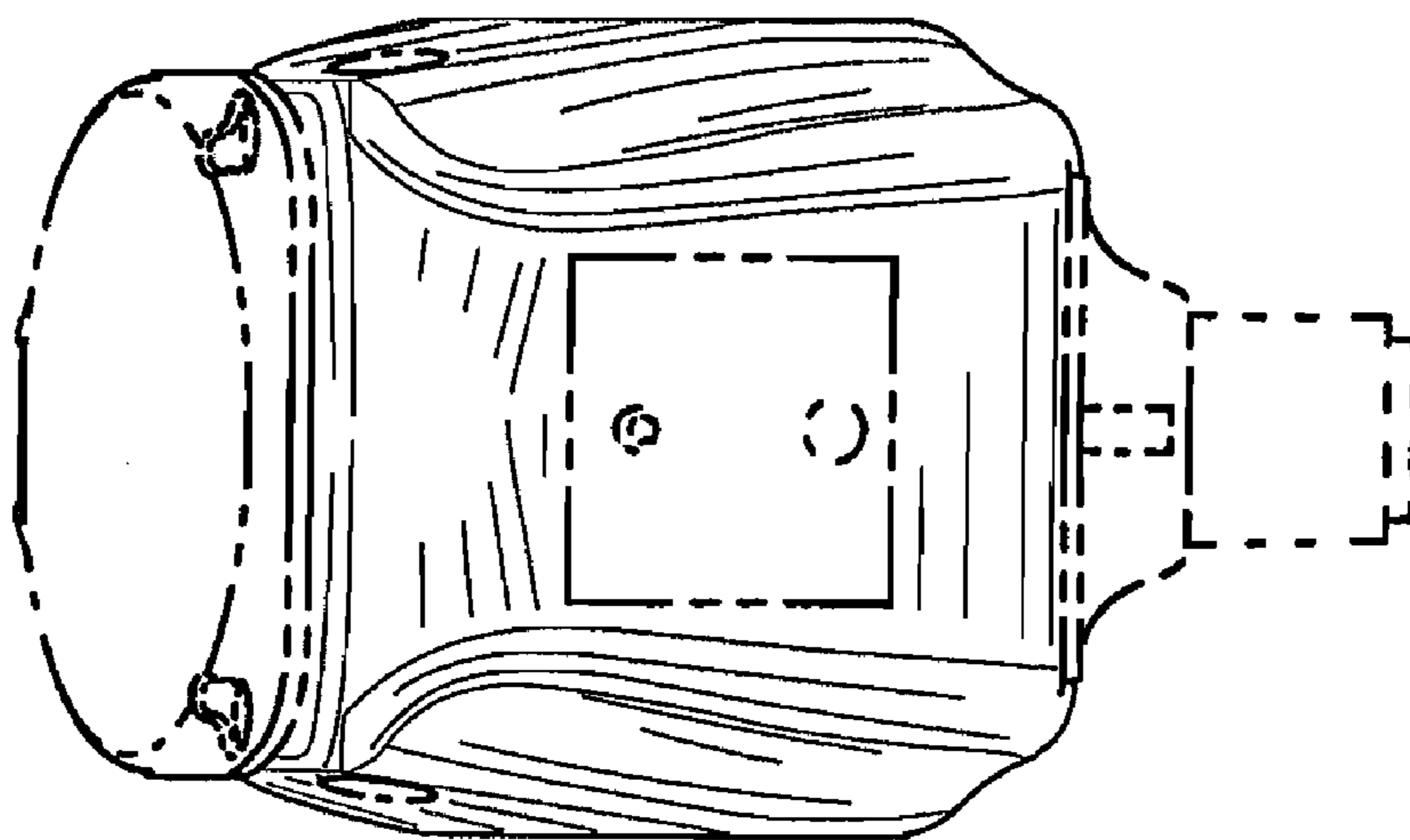

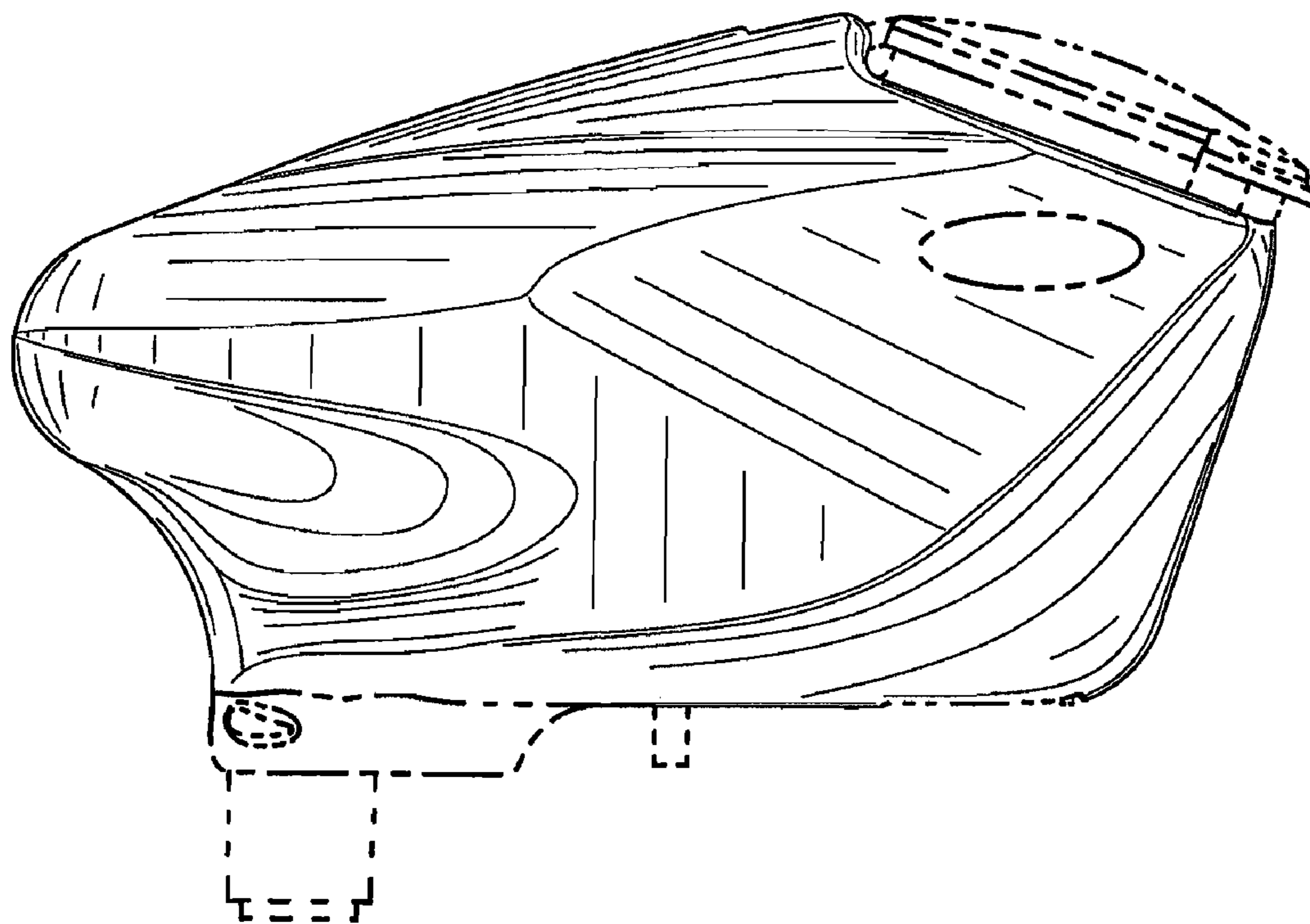
