The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf club head showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a heel end view thereof;

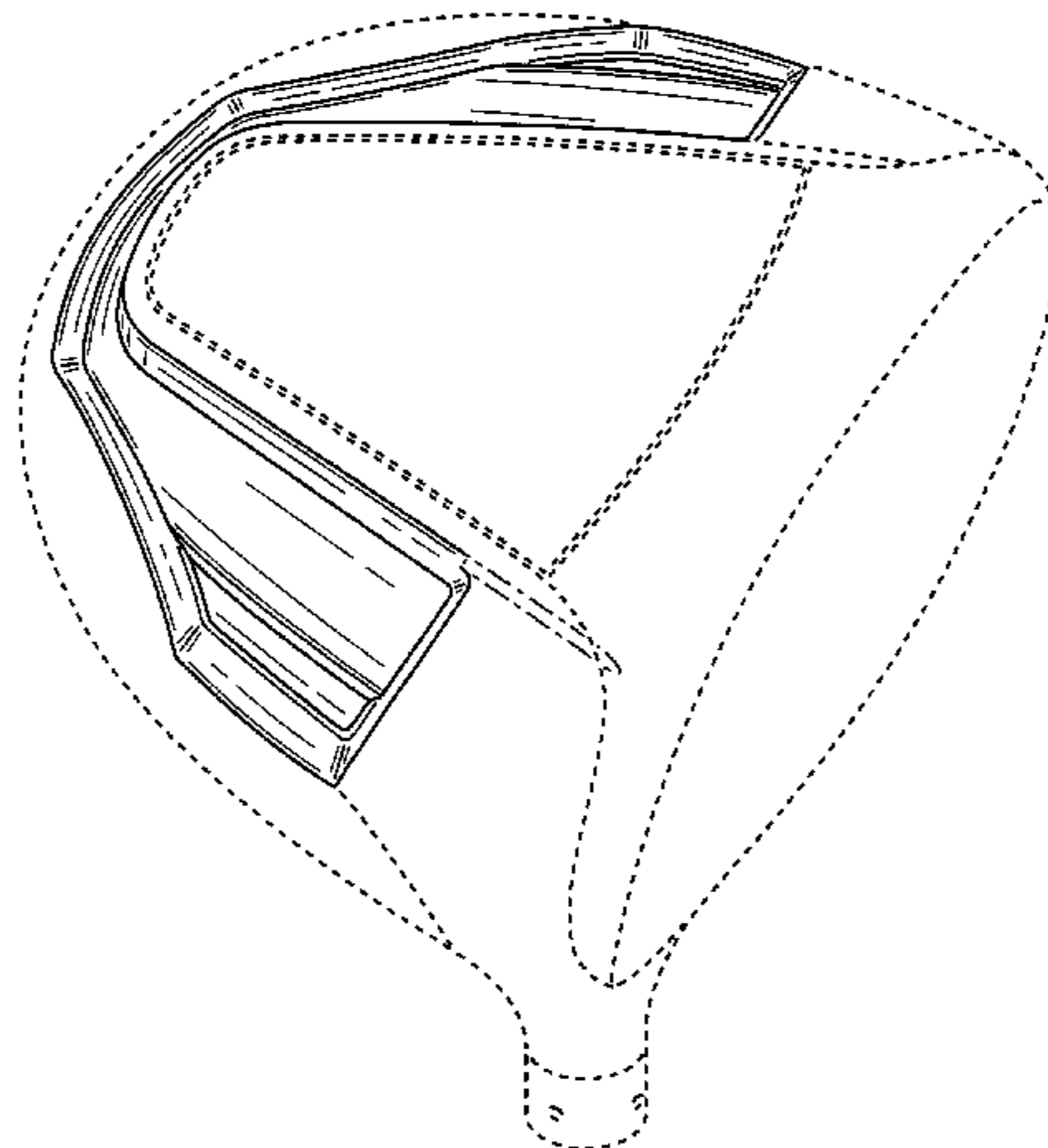
FIG. 5 is a toe end view thereof;

FIG. 6 is a front view thereof; and,

FIG. 7 is a top view thereof.

The broken line segments at the distal inner-front corners of the shaded region forms an unclaimed boundary of the design. The broken line showing of the remainder of the golf club head is for environmental purposes only and forms no part of the claimed design.

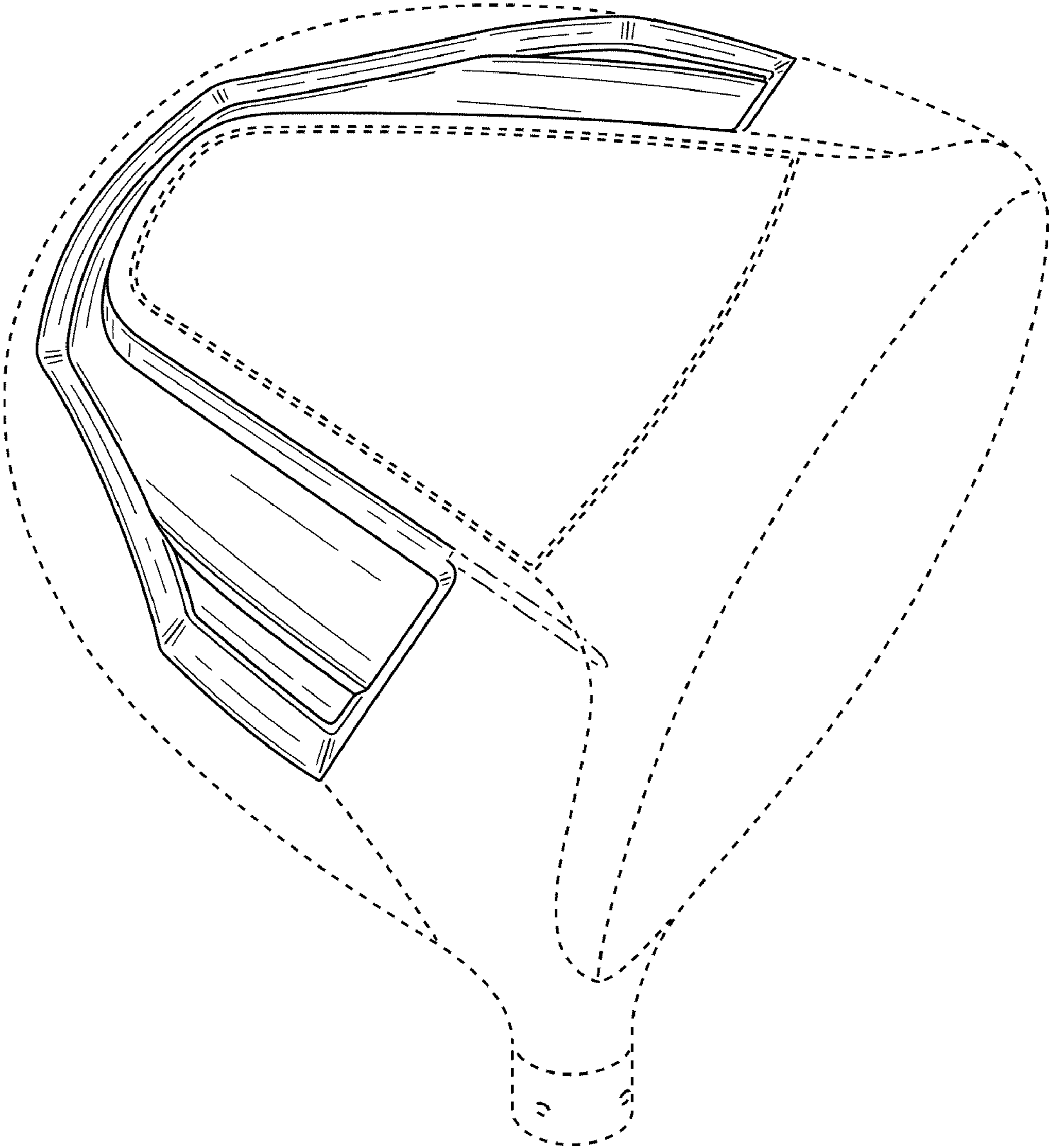

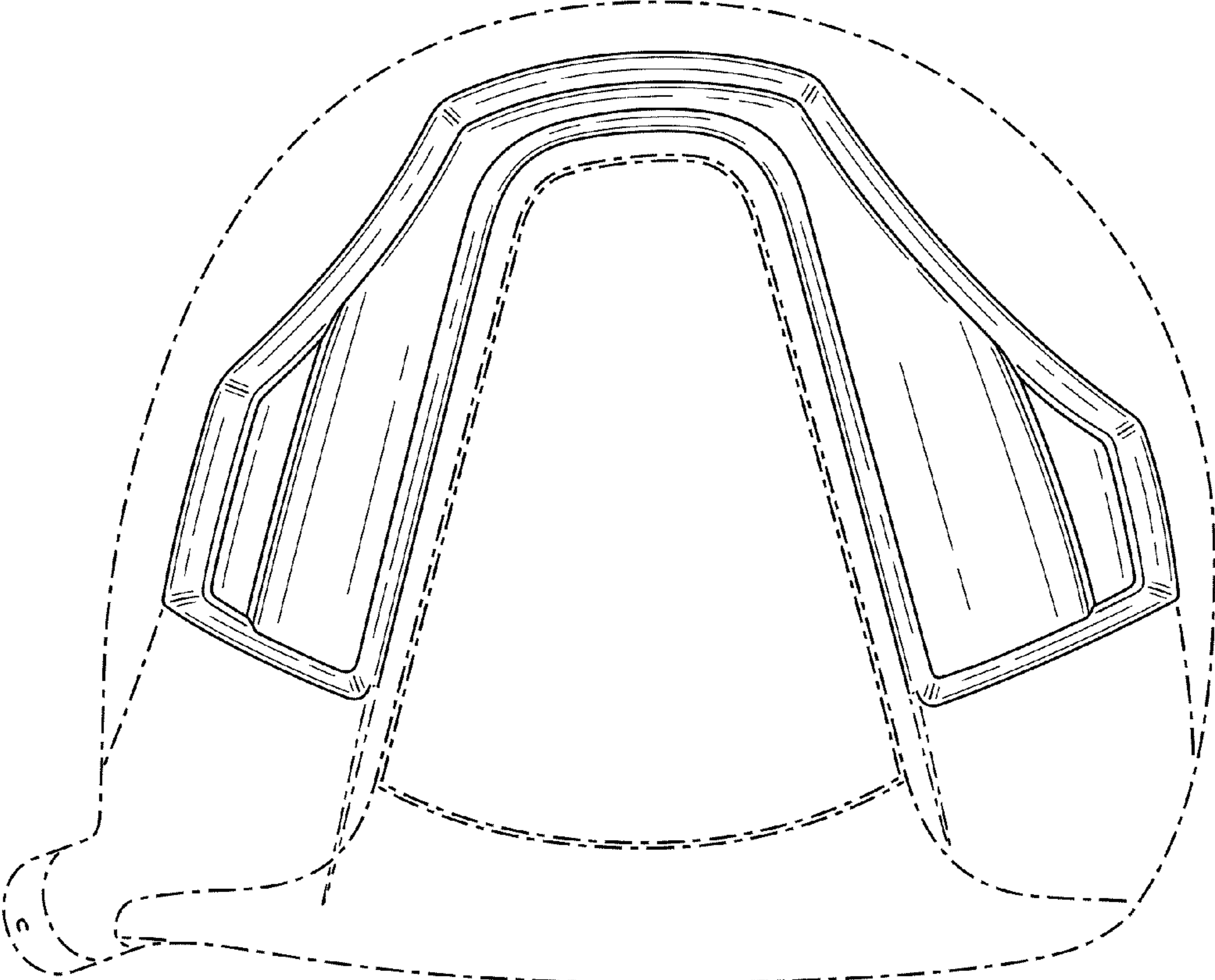

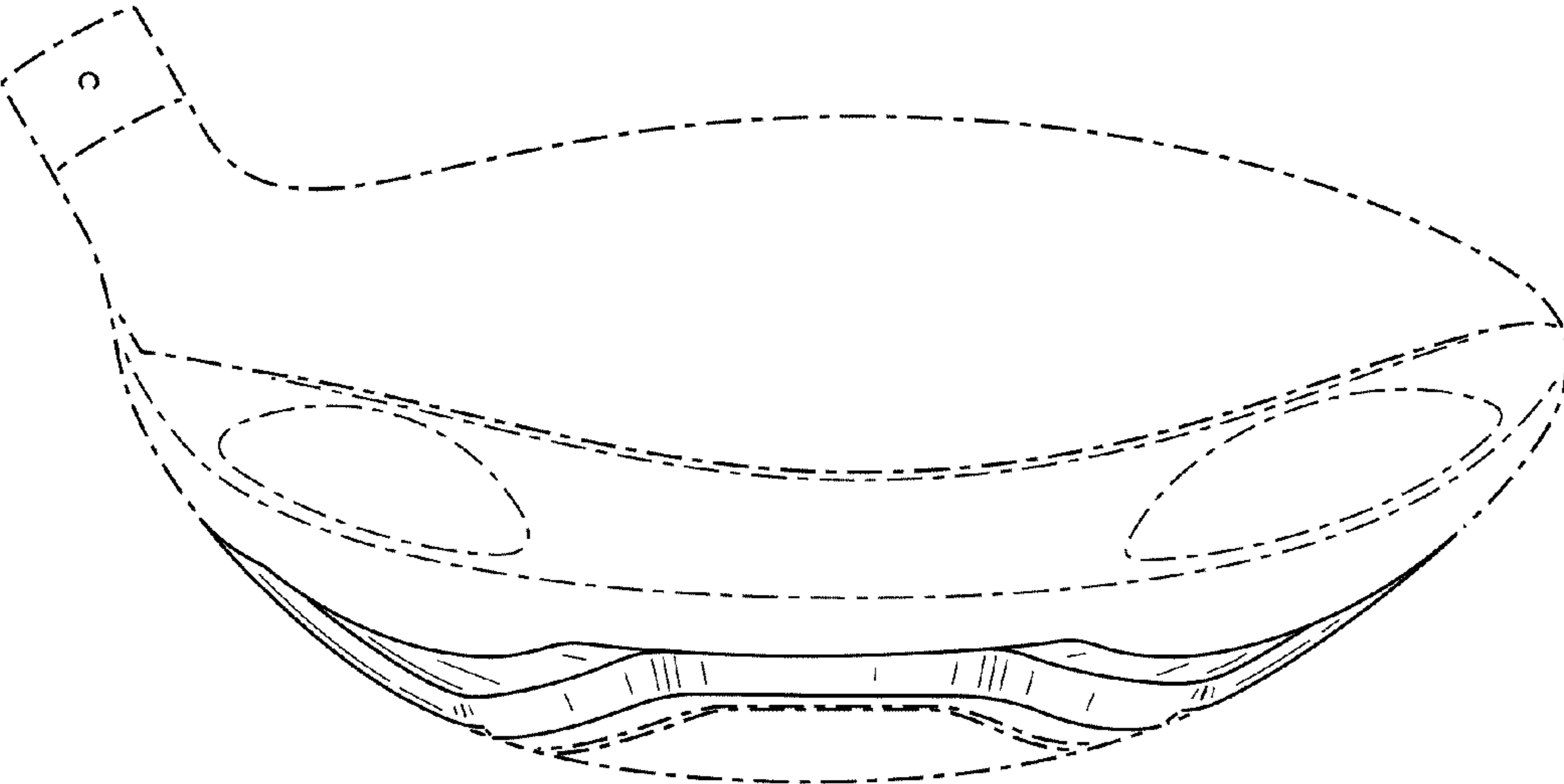

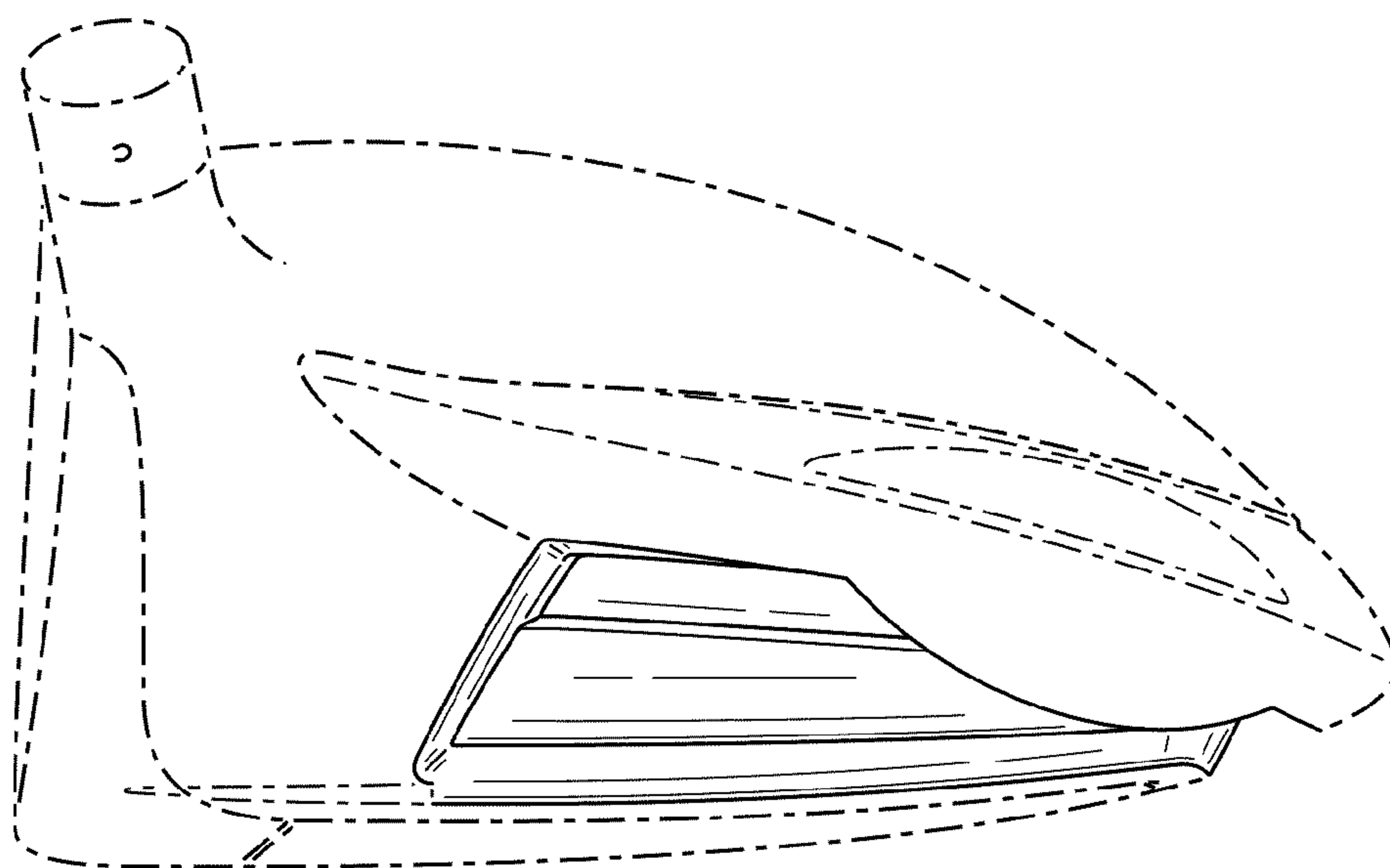

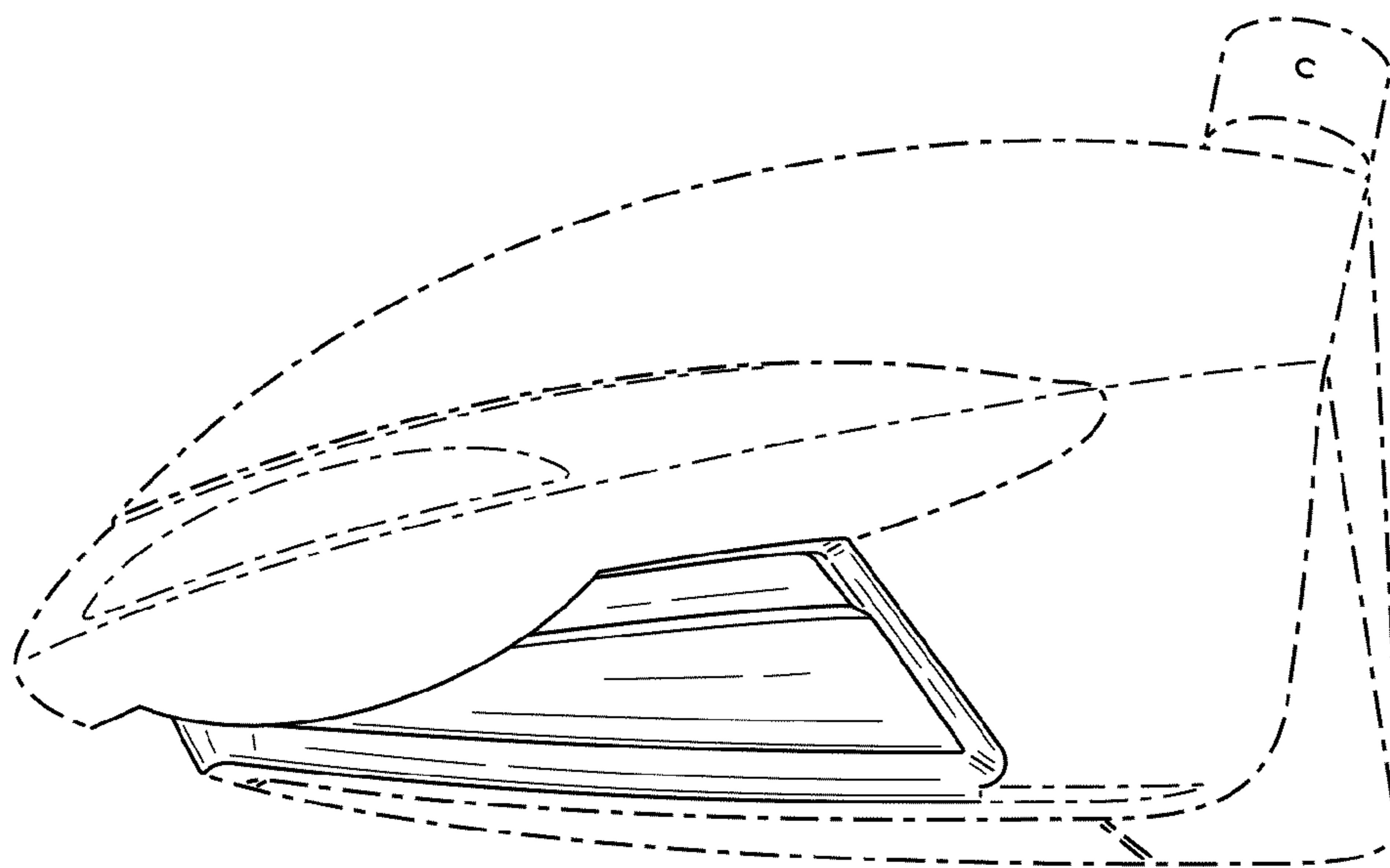

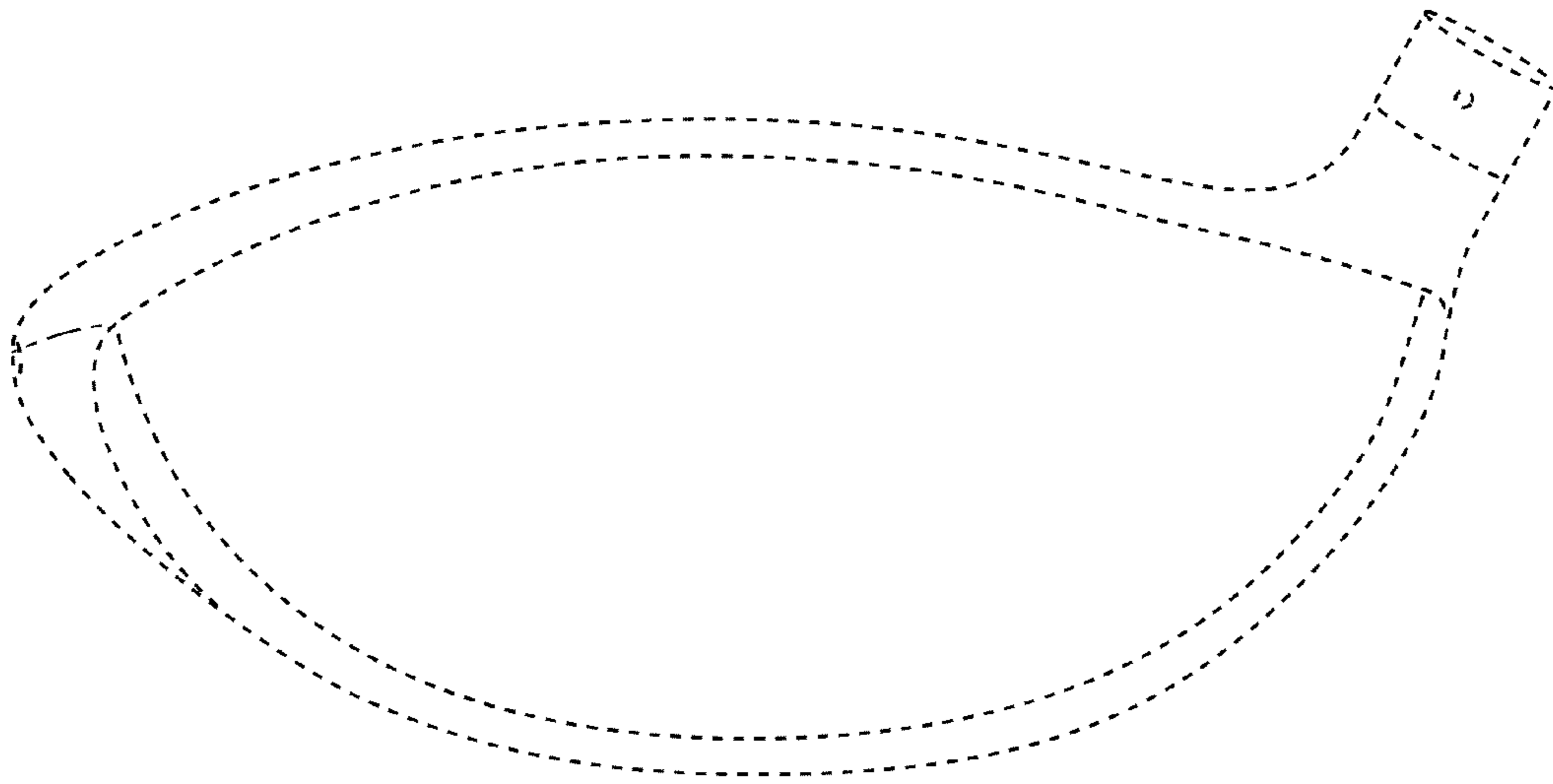

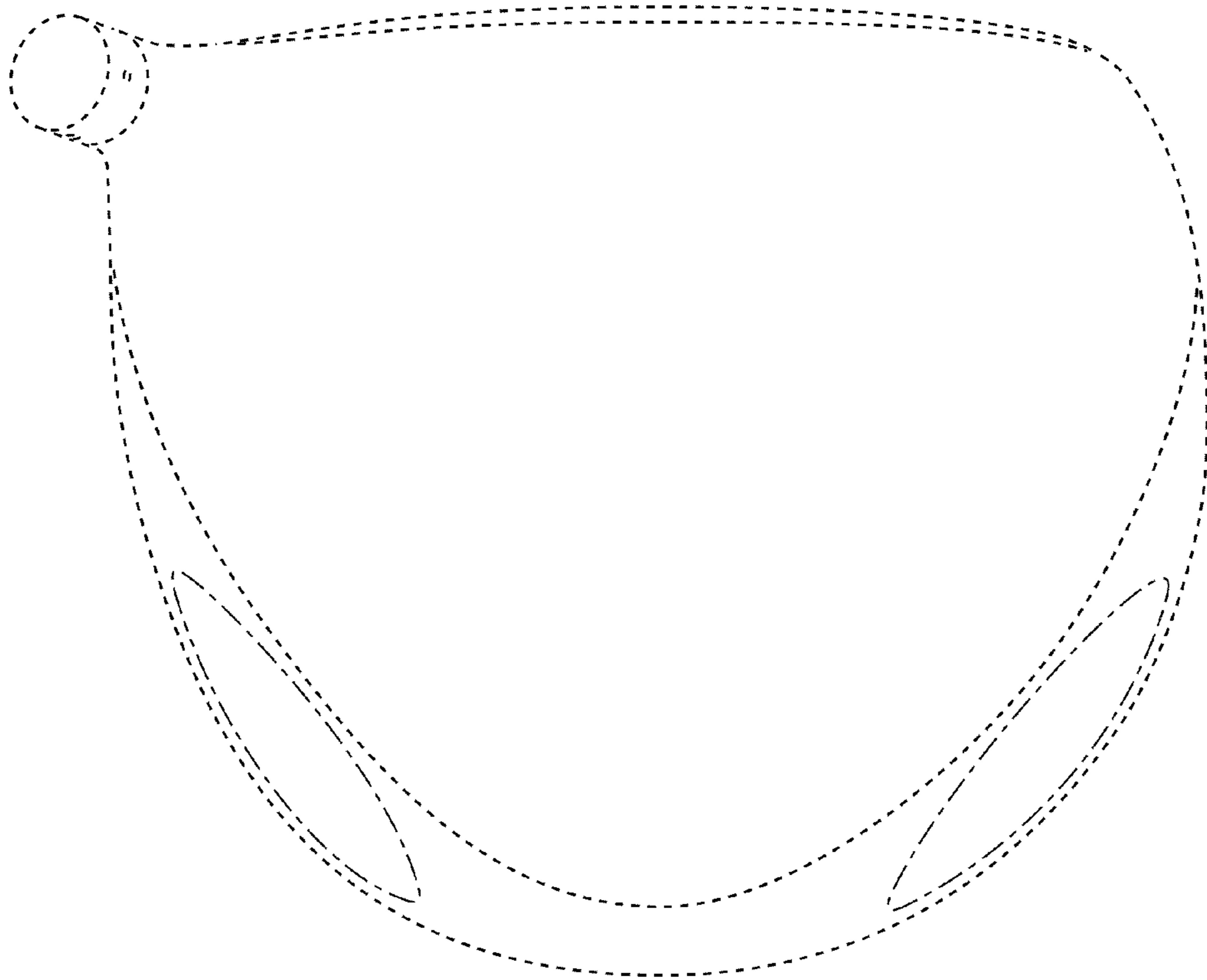
