FIG. 2 is a front elevational view;

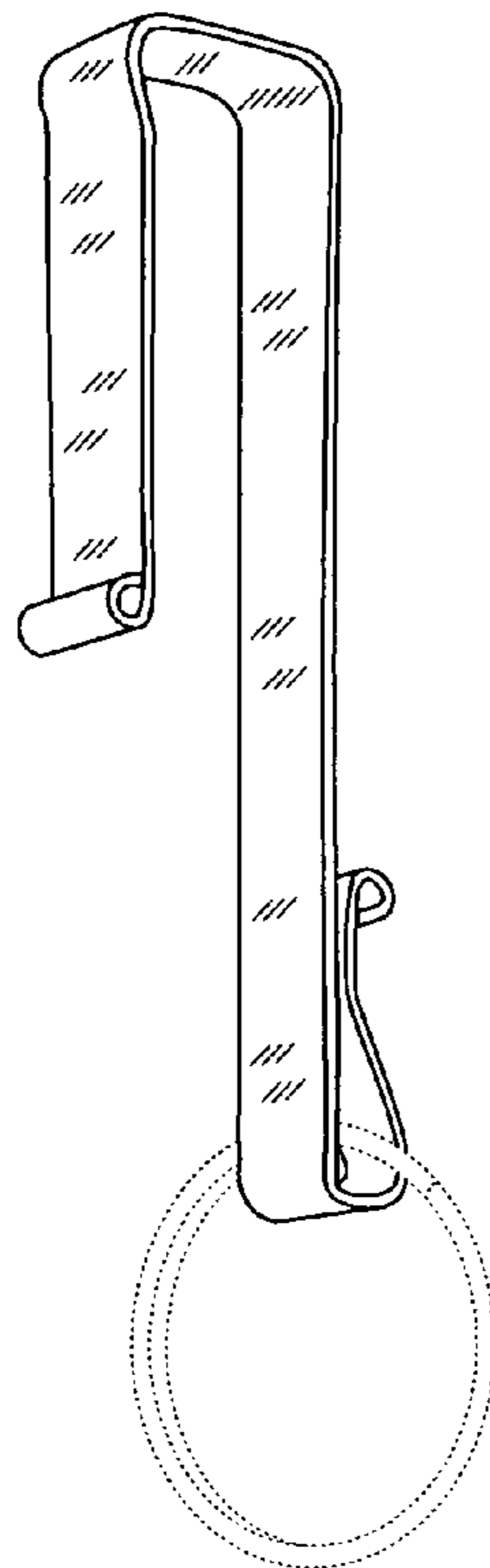
FIG. 3 is a side elevational view, the opposite side view being a mirror image thereof;

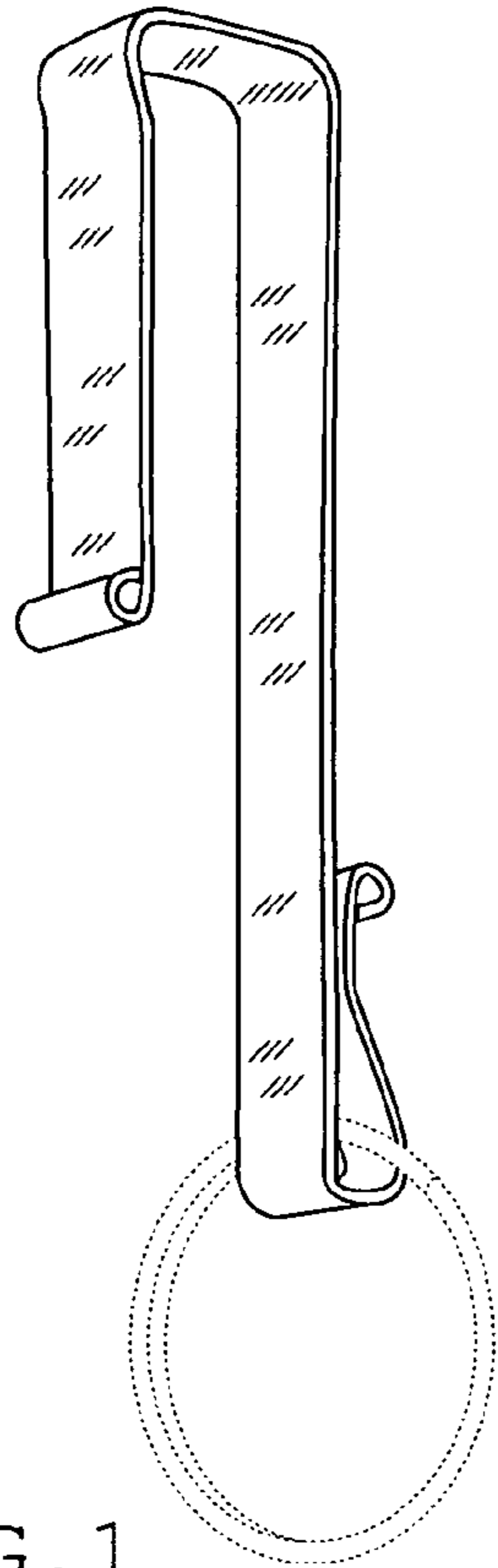

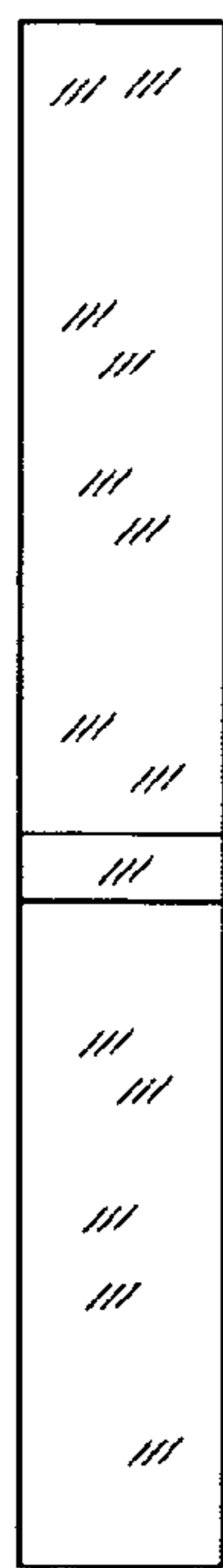

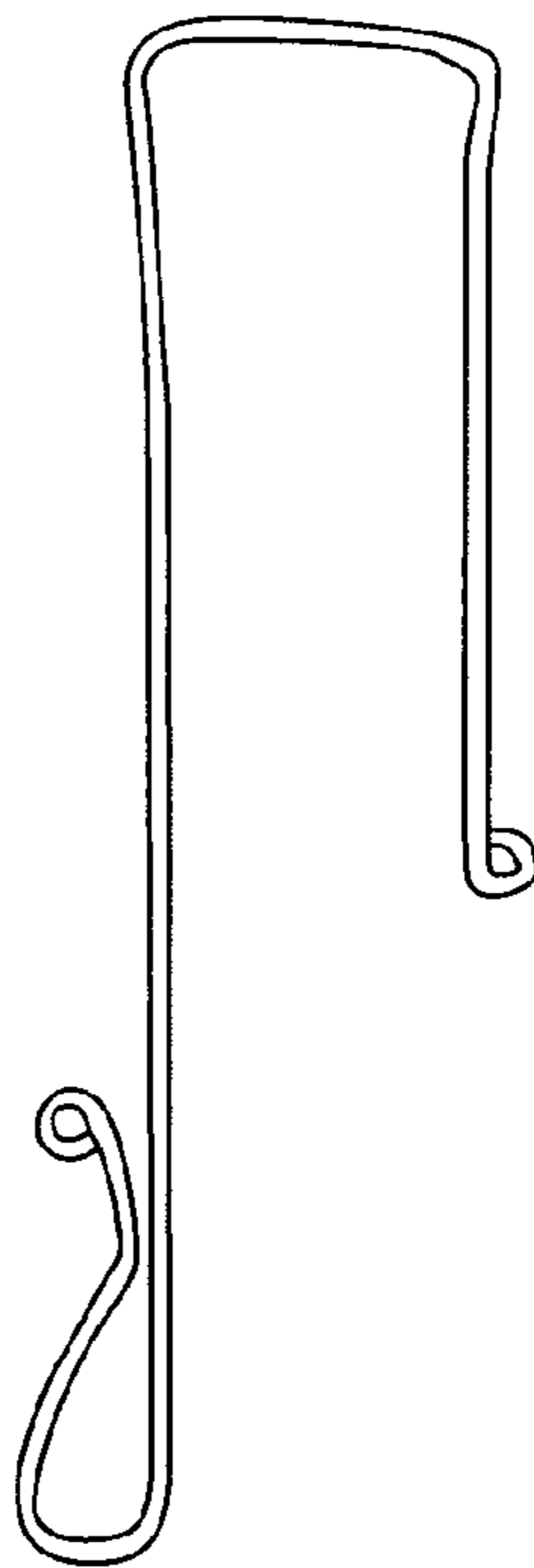

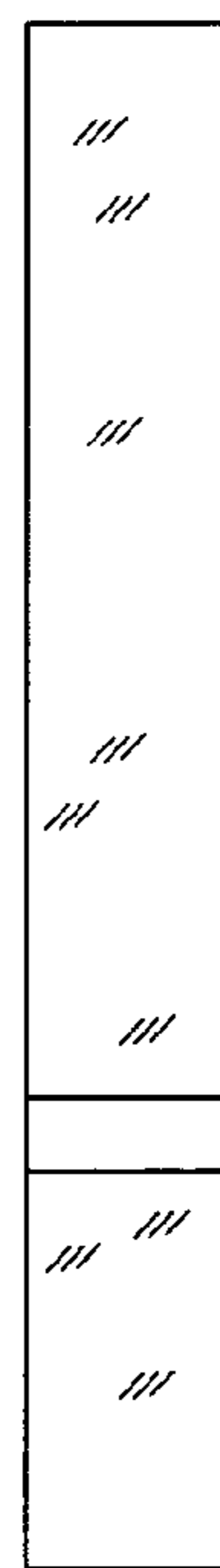
