(57) **CLAIM**

The ornamental design for a crayon and art tool caddy with handle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a crayon and art tool caddy with handle of my invention with crayons and art tools shown in phantom;

FIG. 2 is an top, plan view of a crayon and art tool caddy with handle of my invention based on FIG. 1;

FIG. 3 is a bottom, plan view of a crayon and art tool caddy with handle of my invention and a reverse view of FIG. 2;

FIG. 4 is a front plan view of a crayon and art tool caddy of my invention based on FIG. 1;

FIG. 5 is a rear, plan view of a crayon and art tool caddy with handle of my invention and a reverse view of FIG. 4;

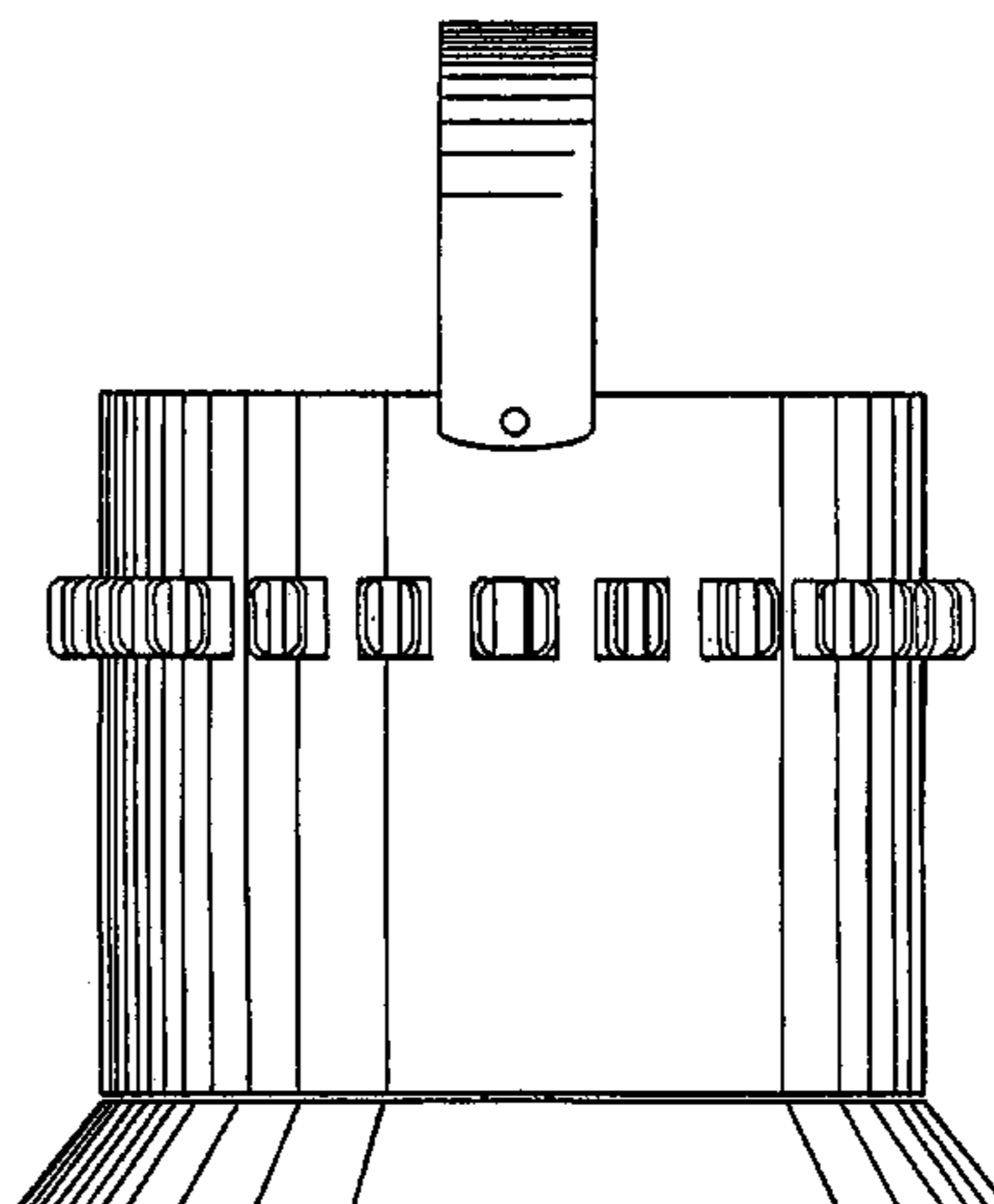
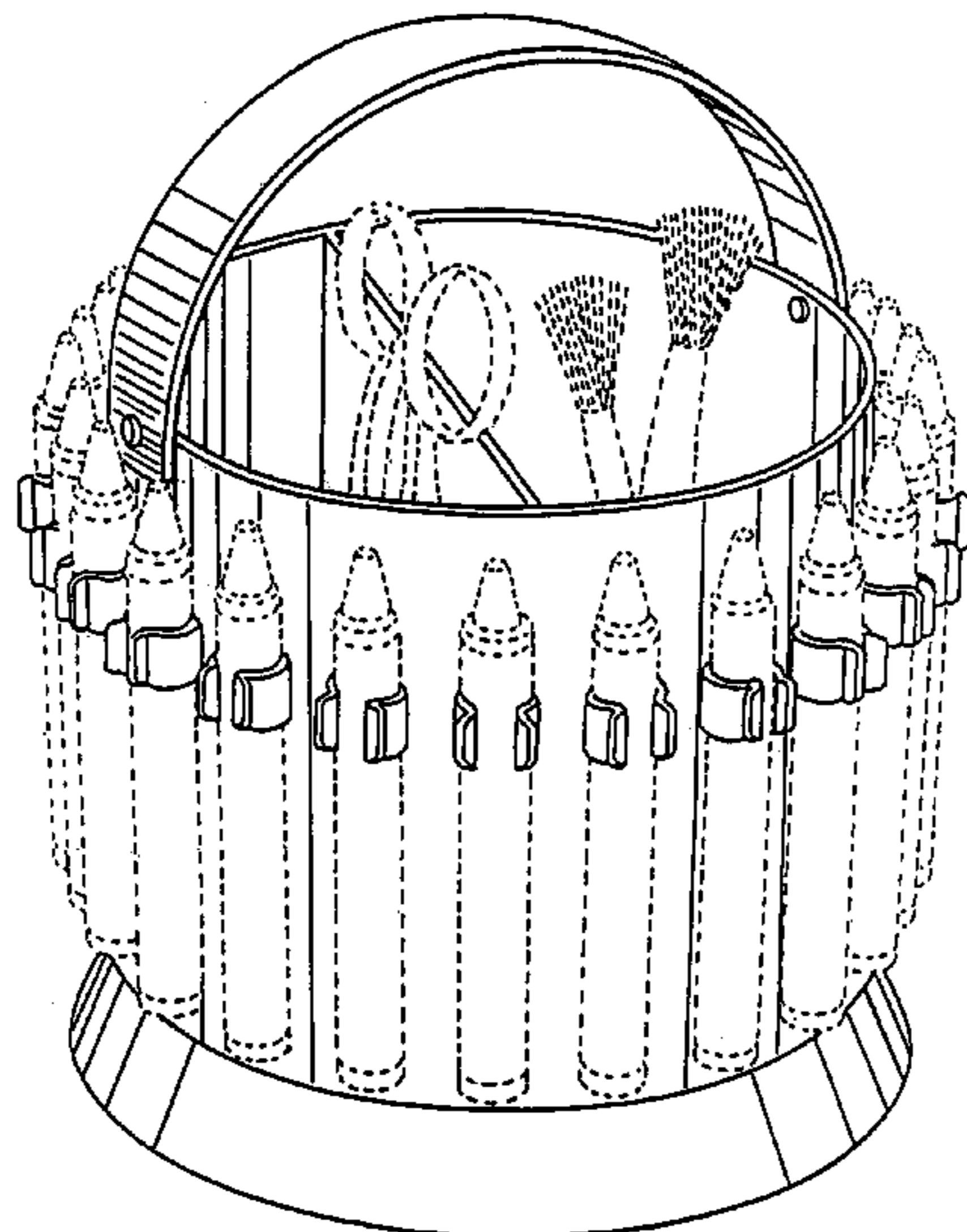
FIG. 6 is a side view of a crayon and art tool caddy with handle of my invention;

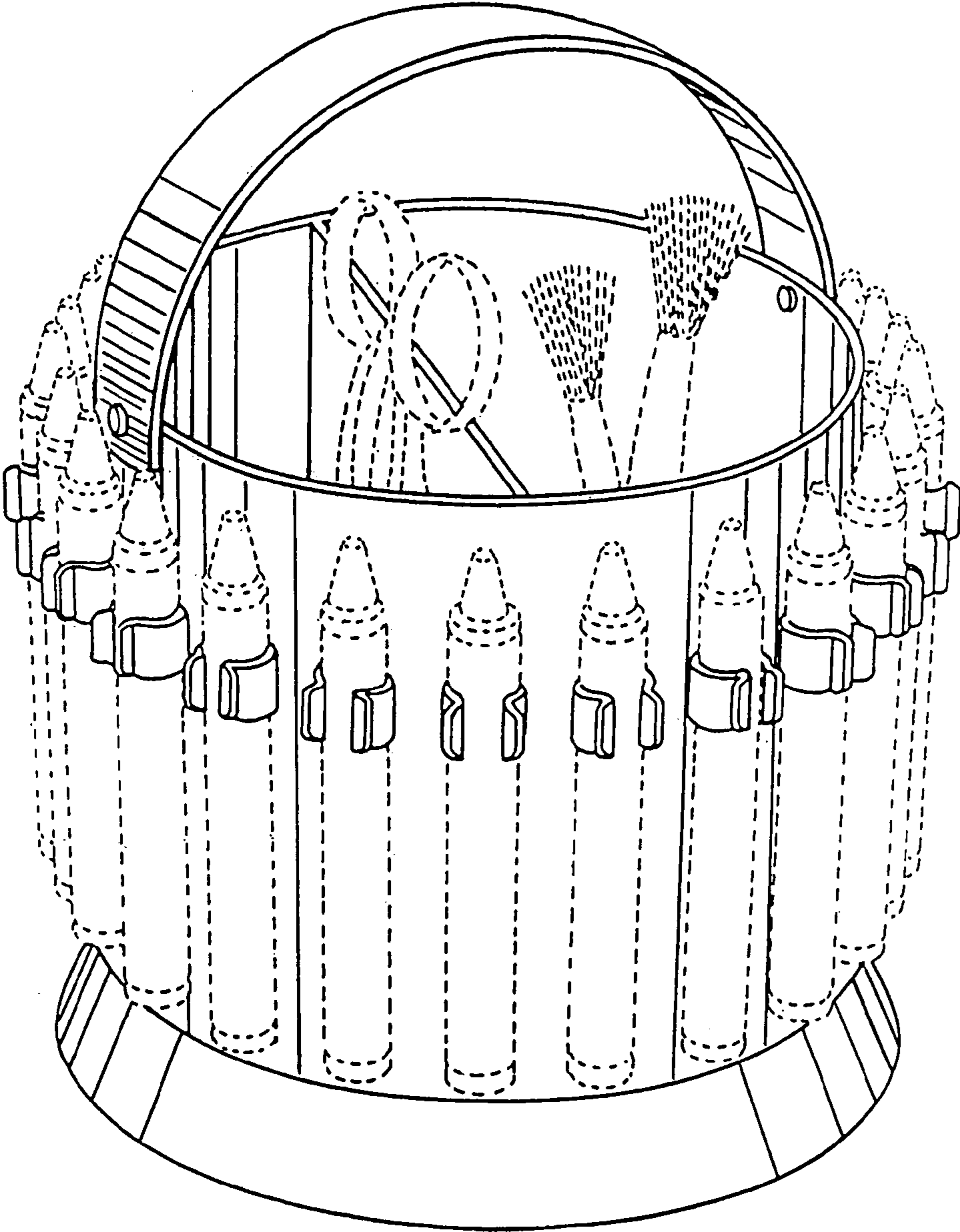

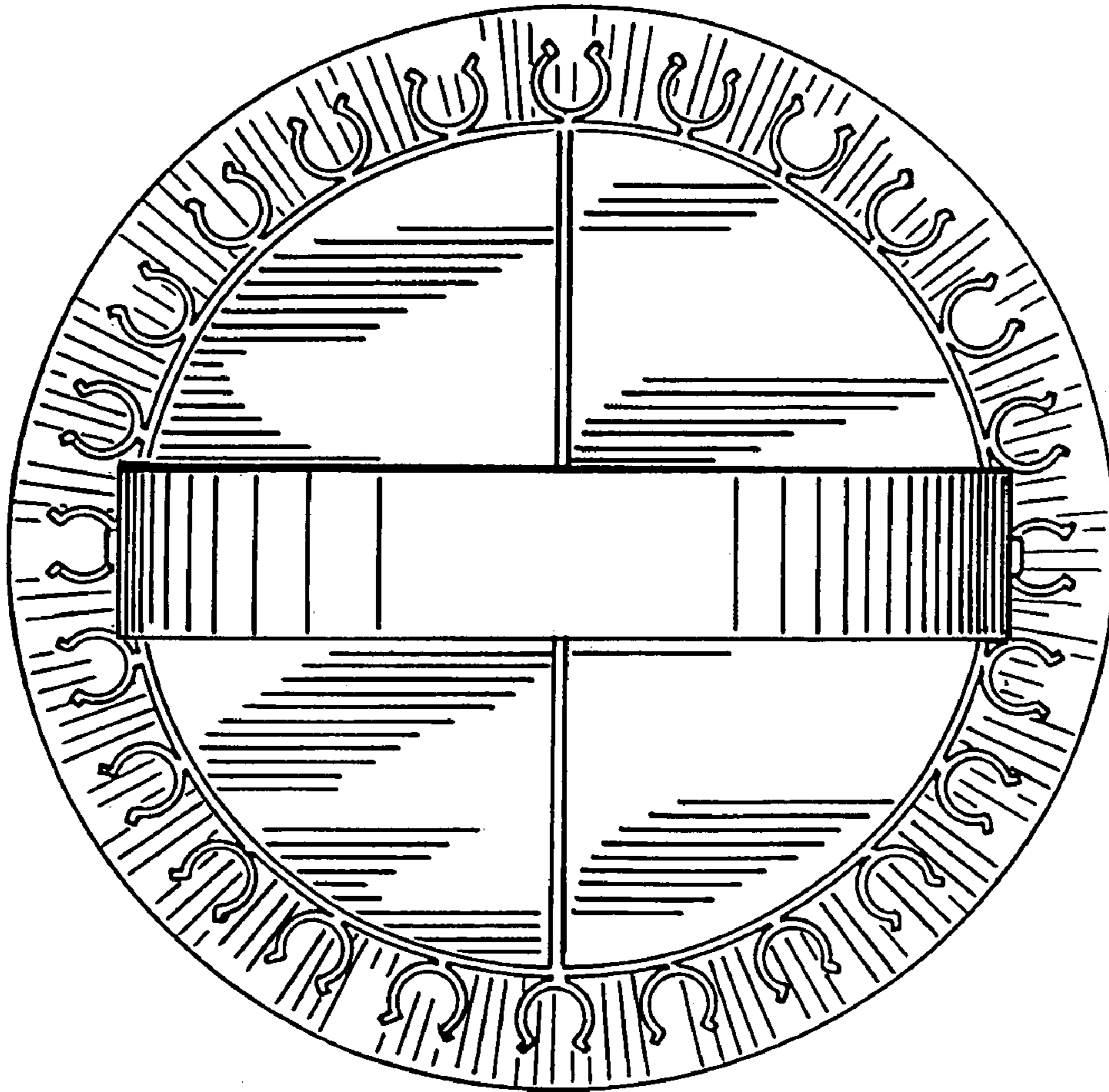

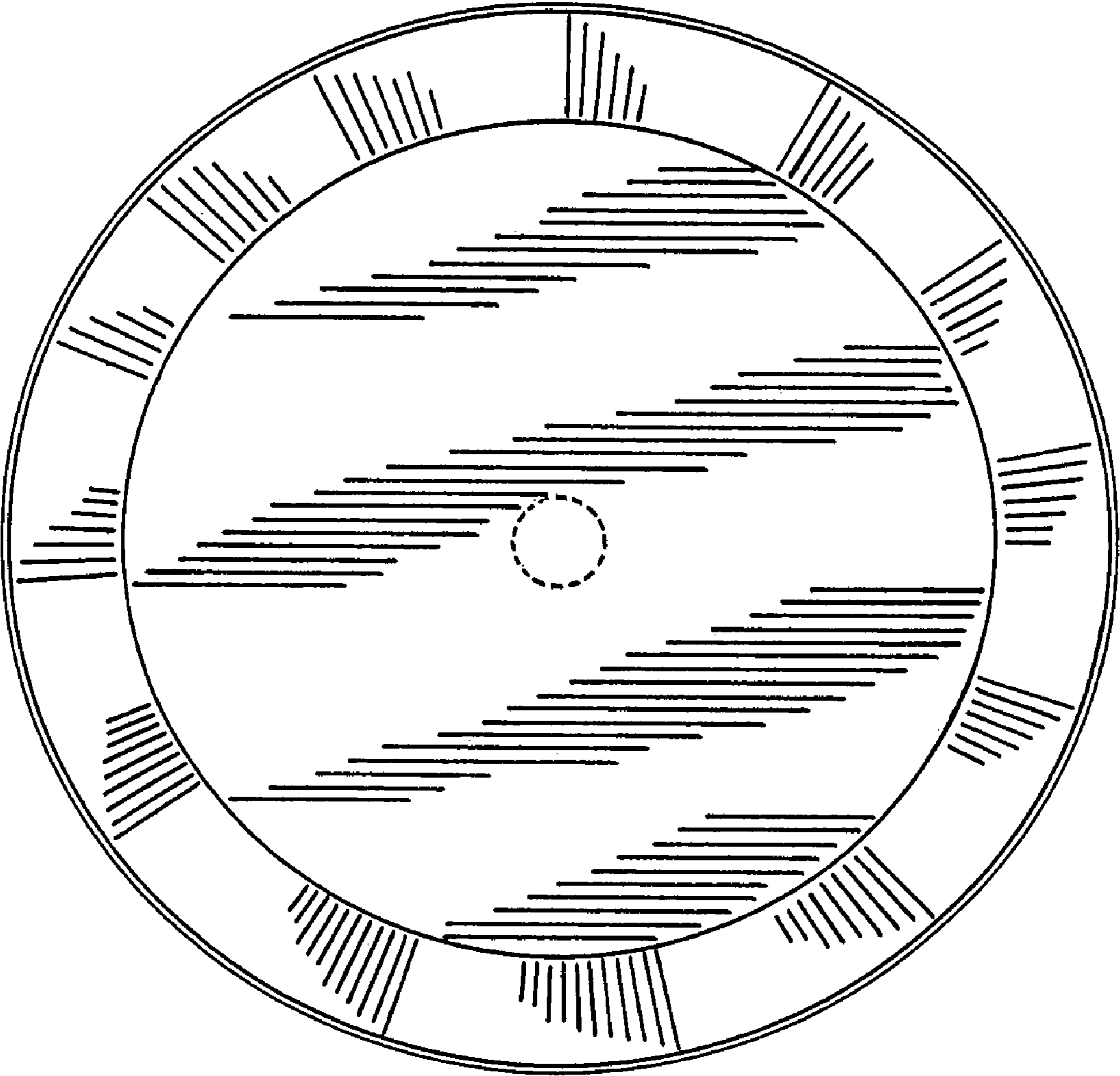

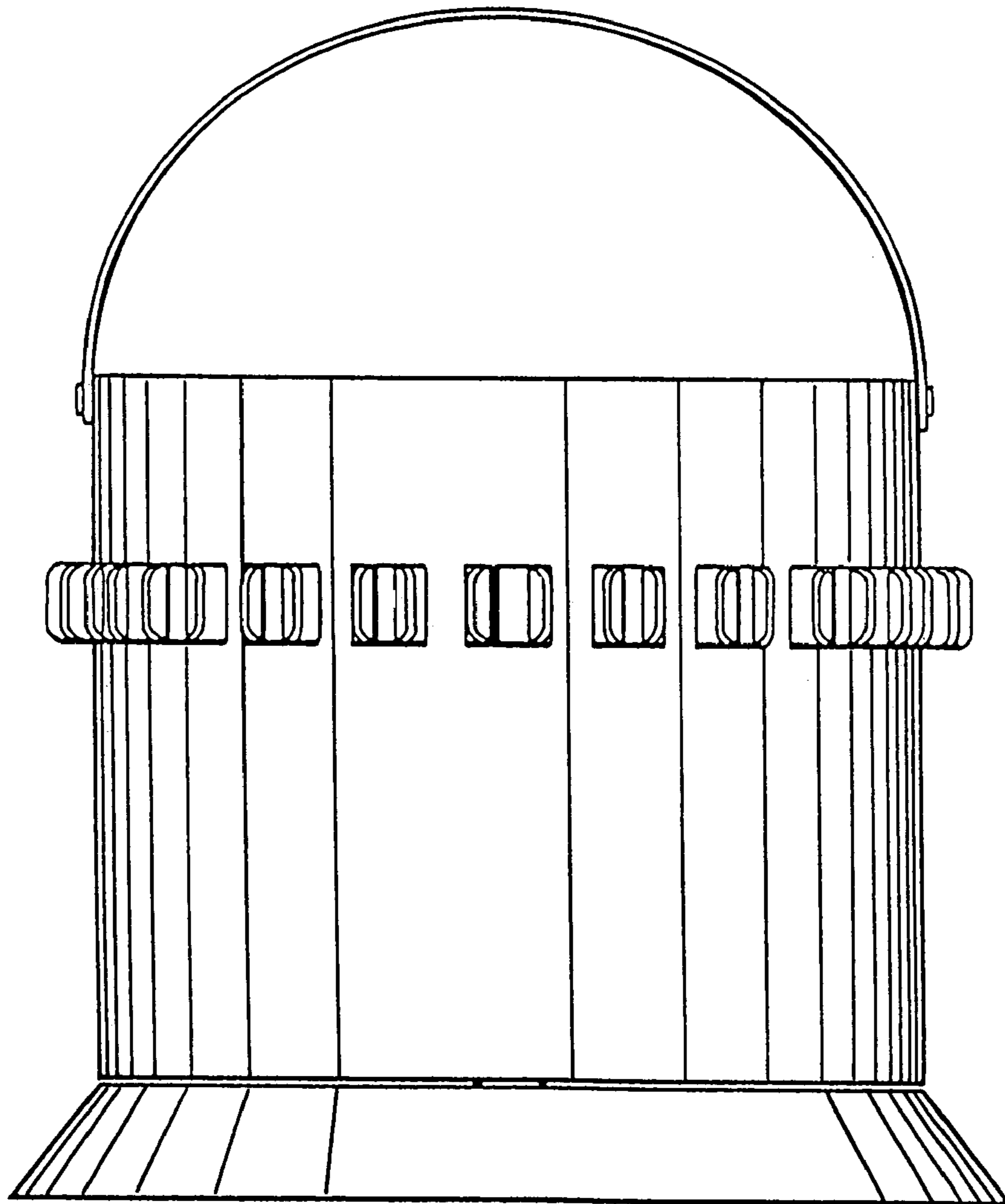

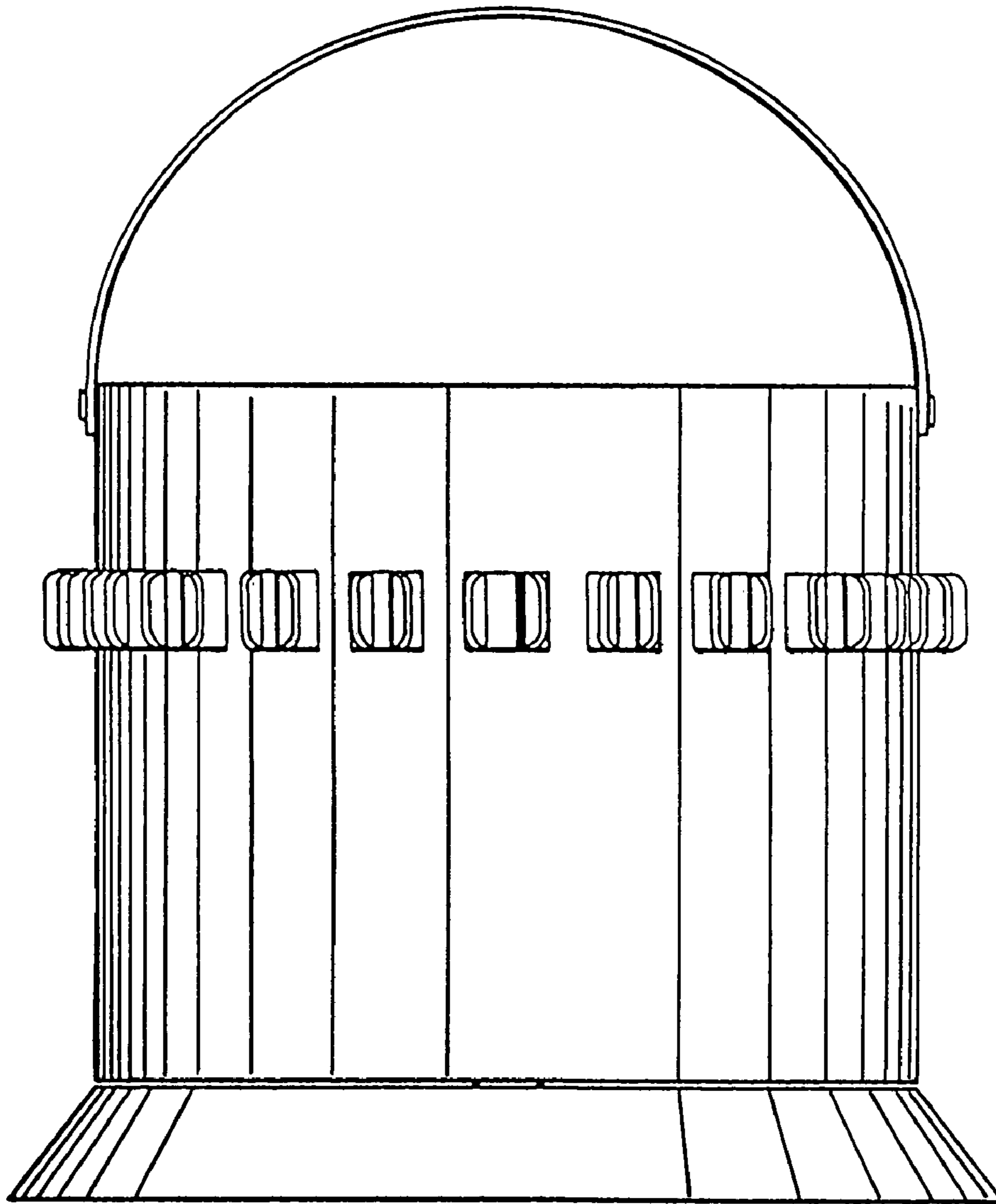

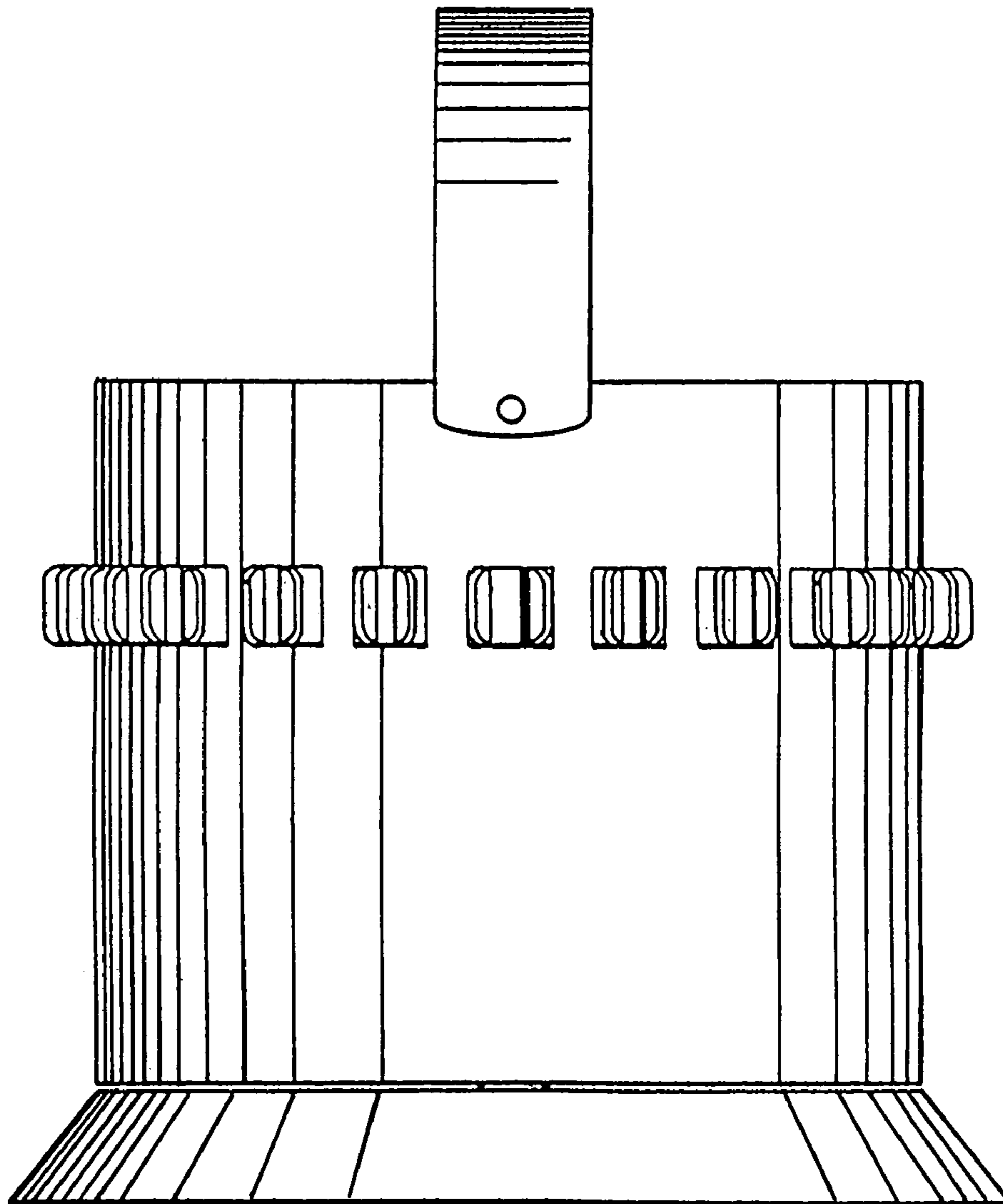

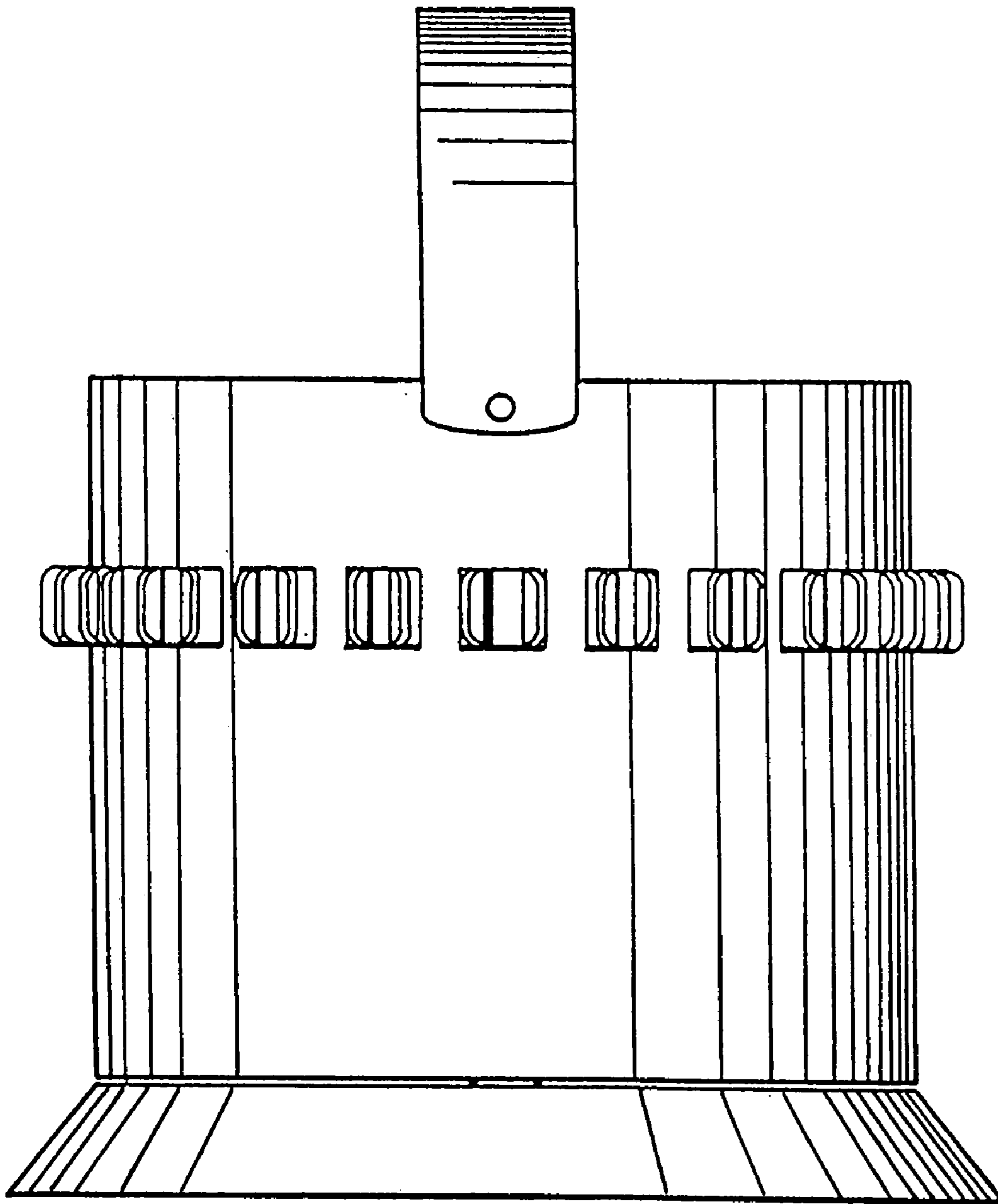

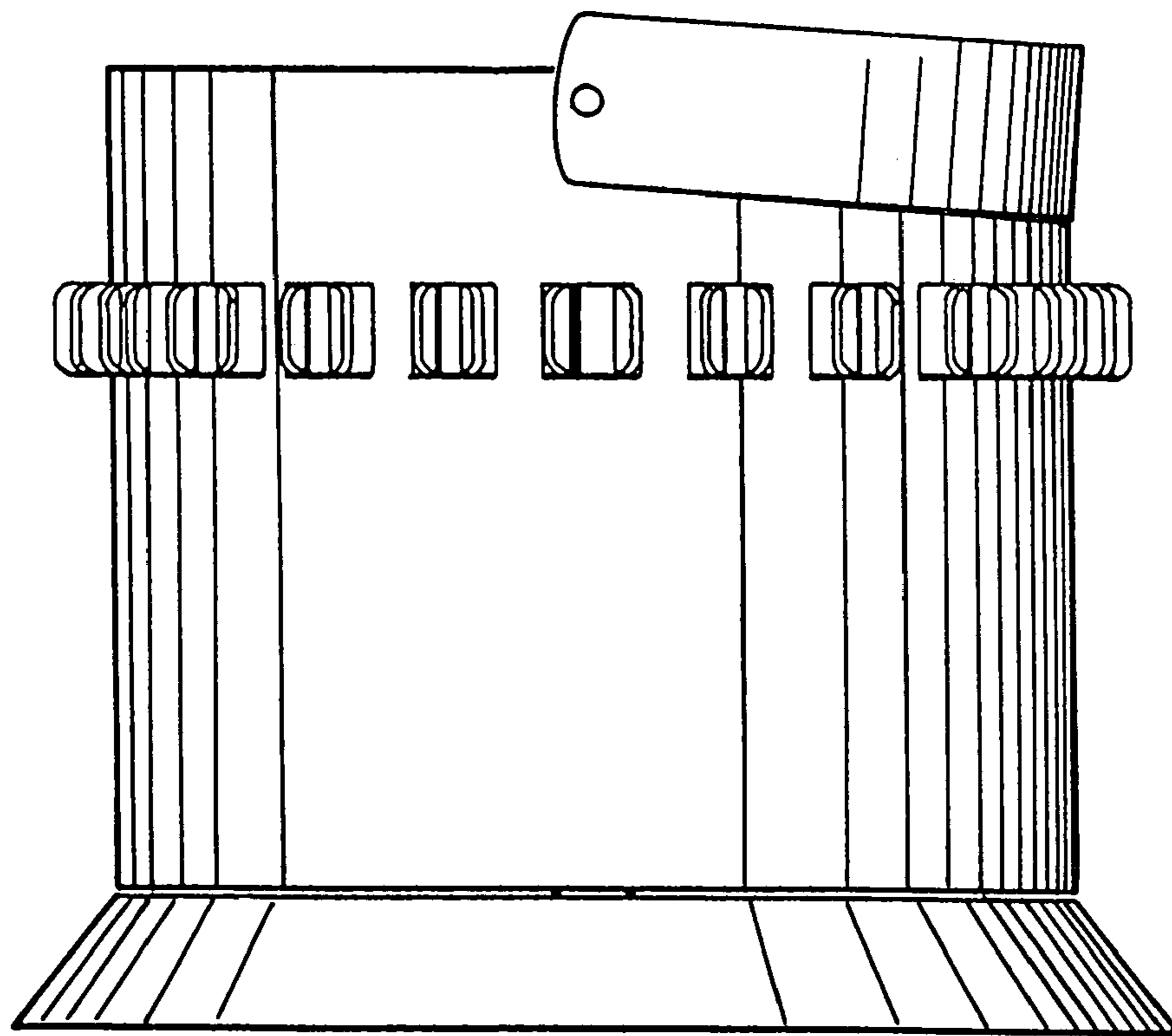
