FIG. 1 is a front view of a hammock according to the subject matter disclosed herein;

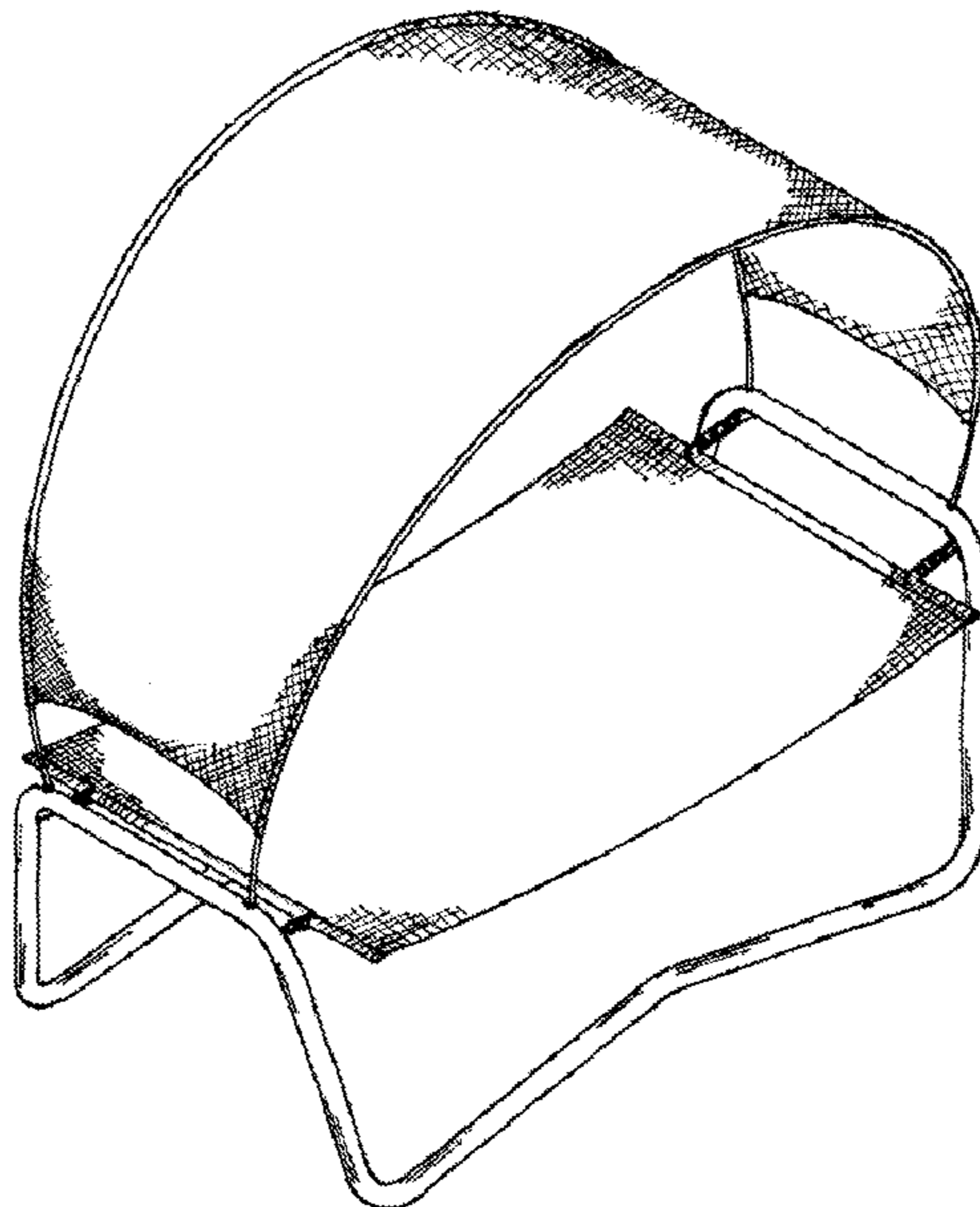
FIG. 2 is an isometric view of a hammock according to the subject matter disclosed herein;

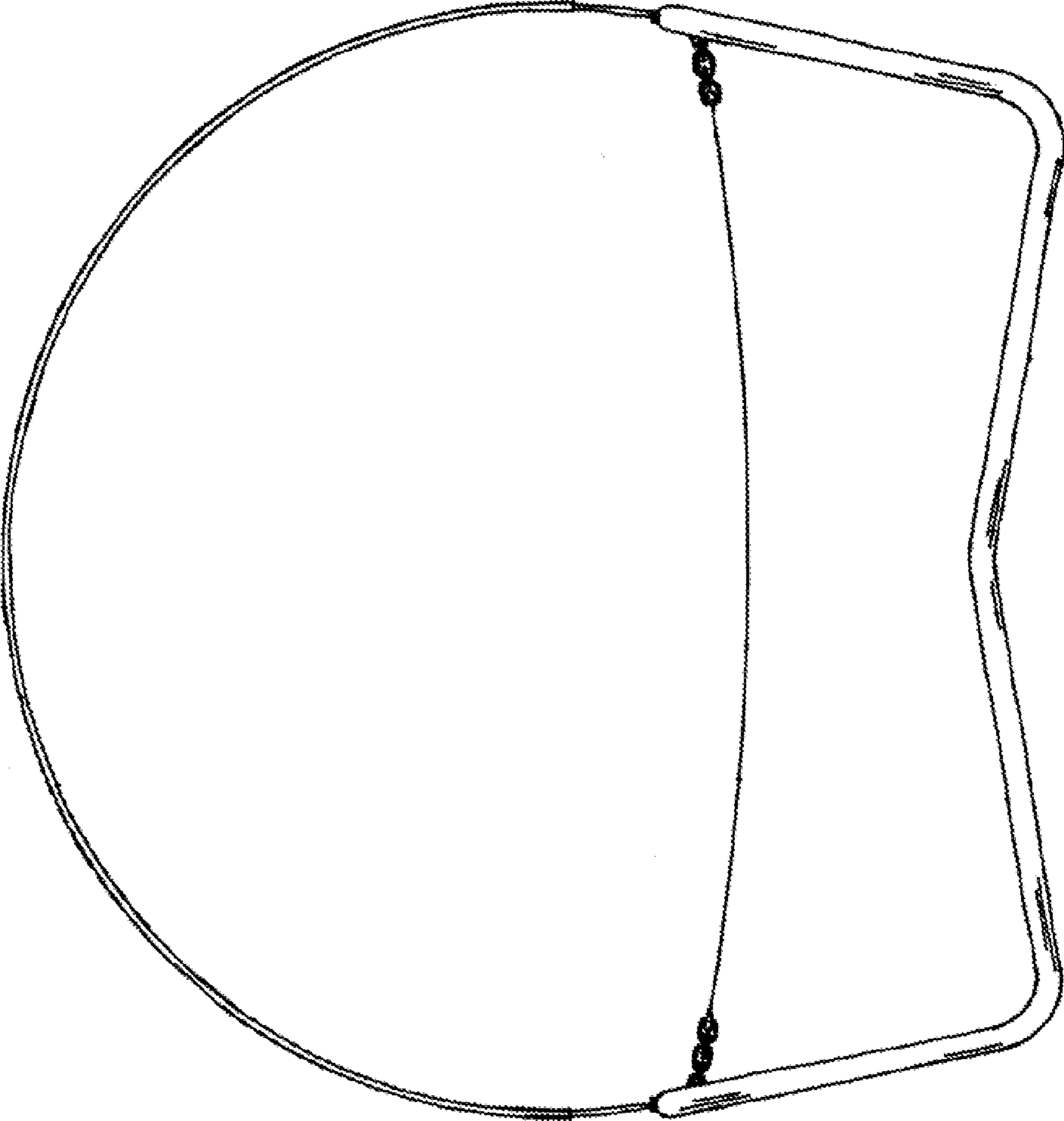

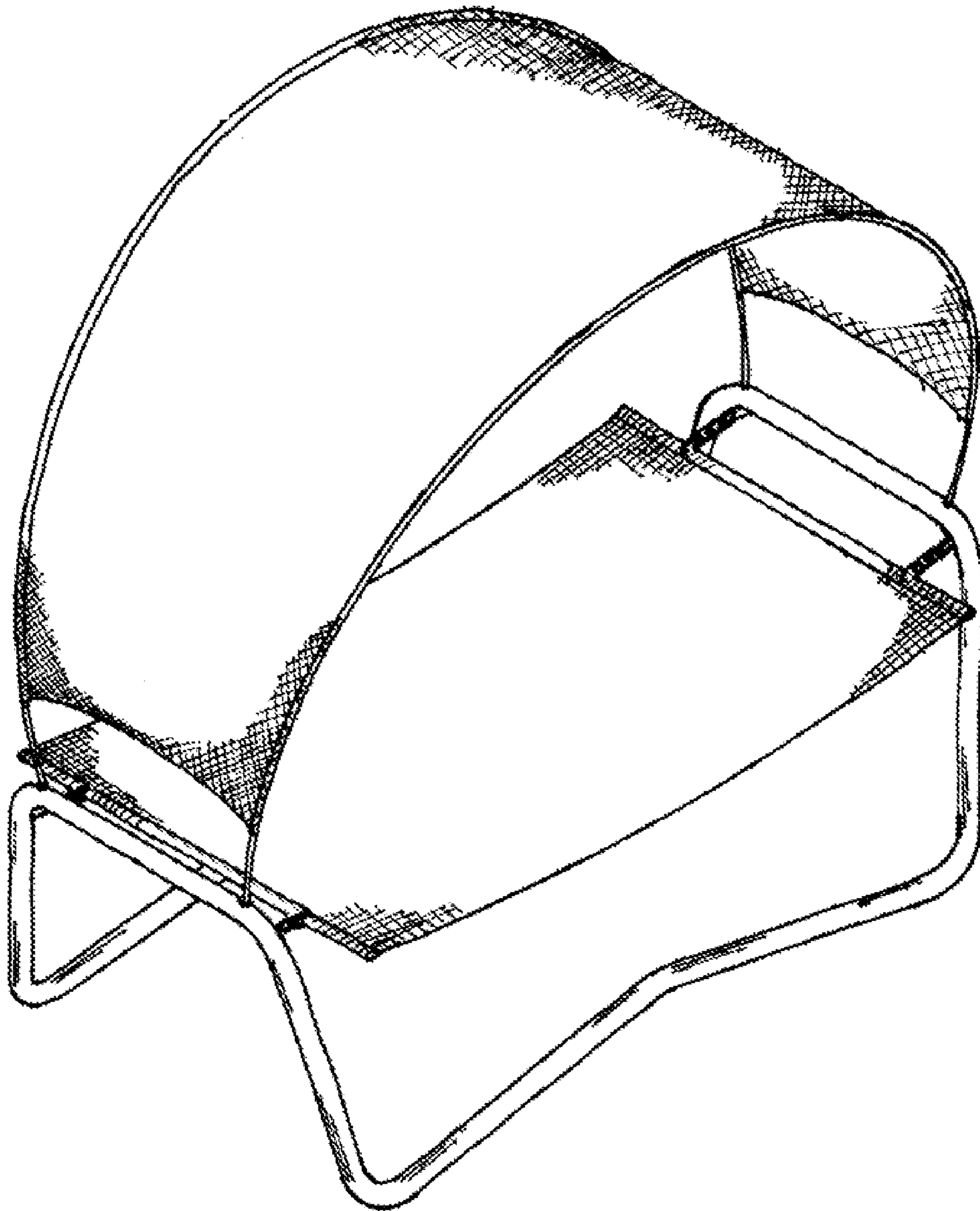

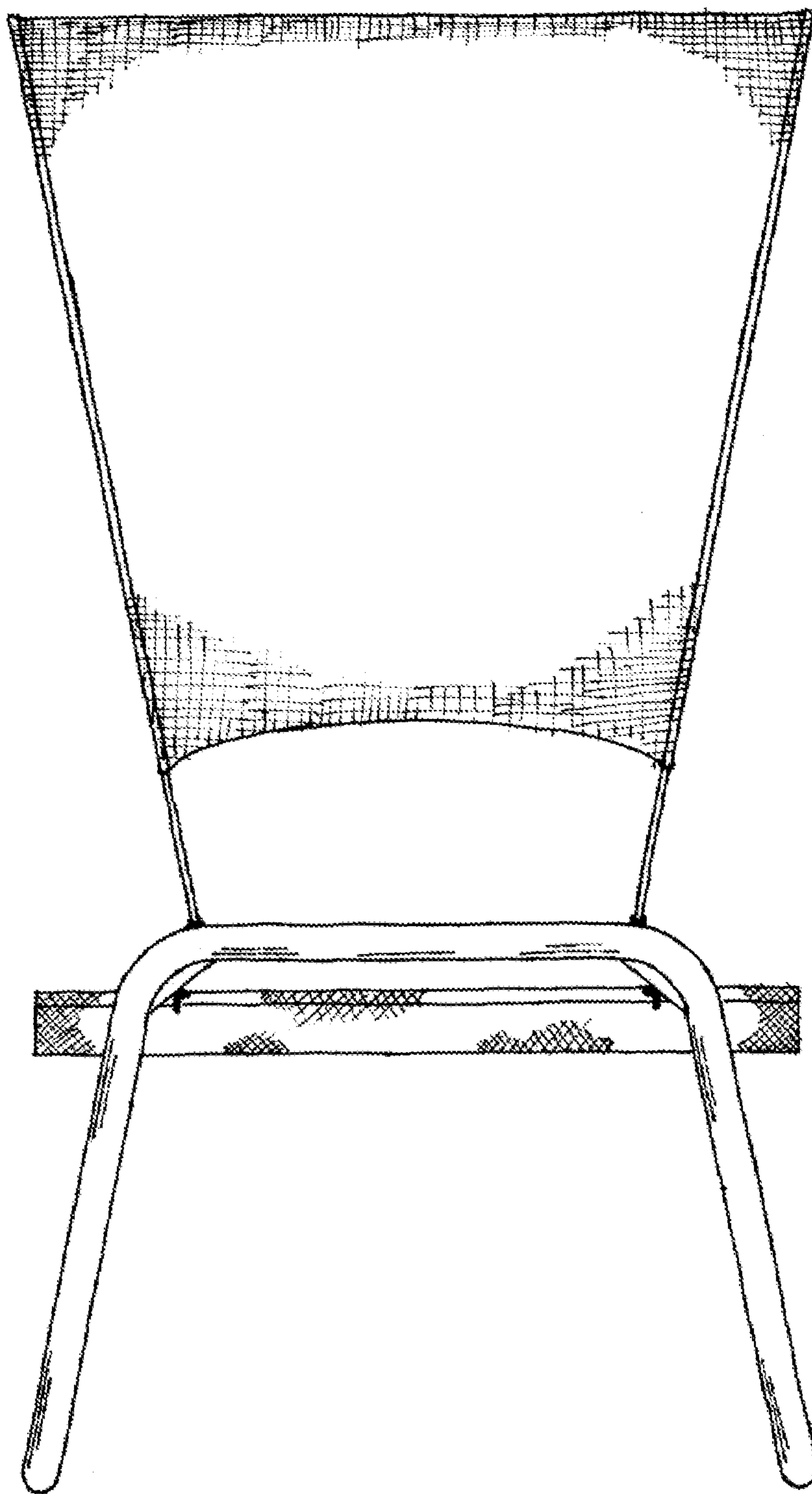

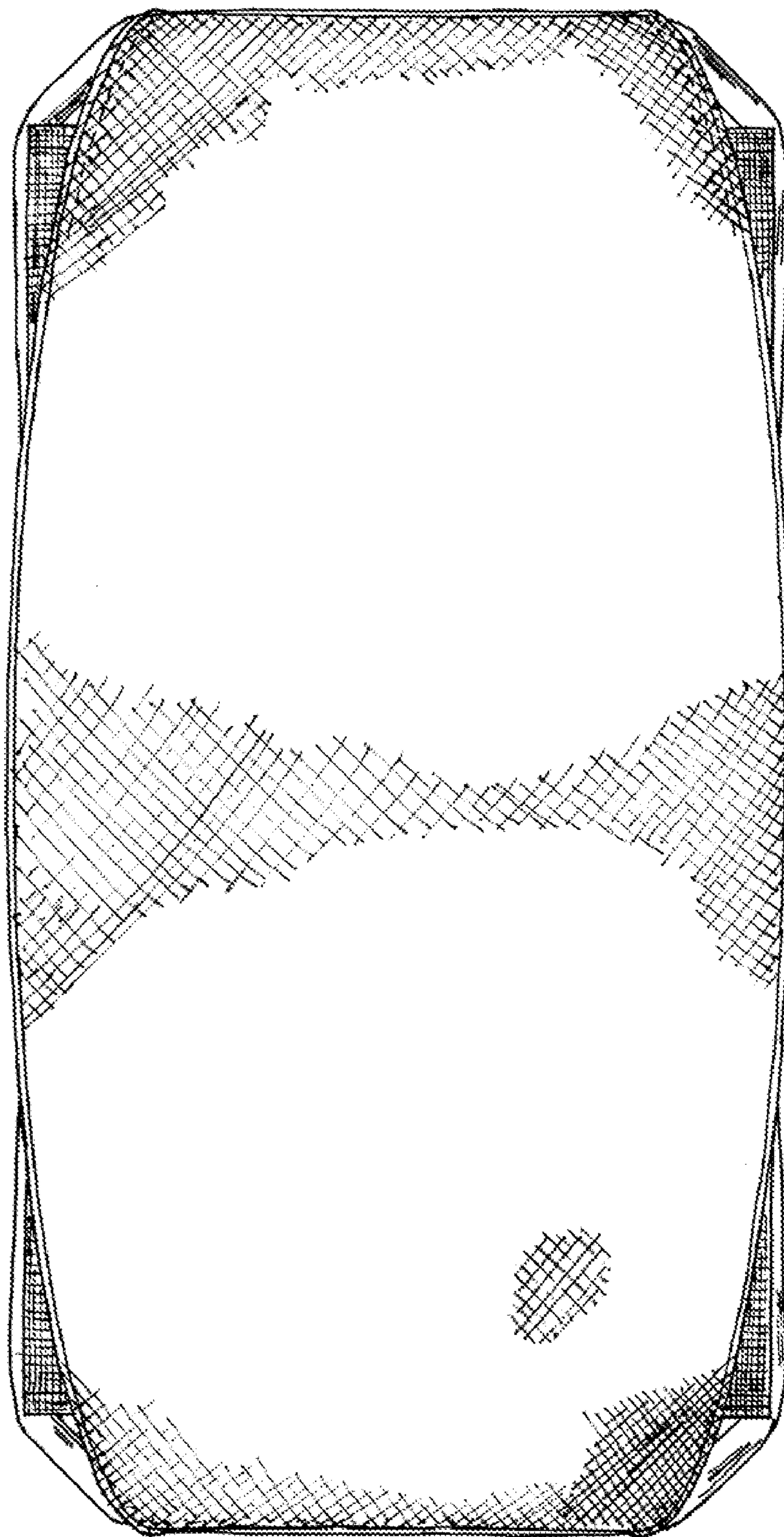
