DESCRIPTION

FIG. 10 is a left plan view thereof;

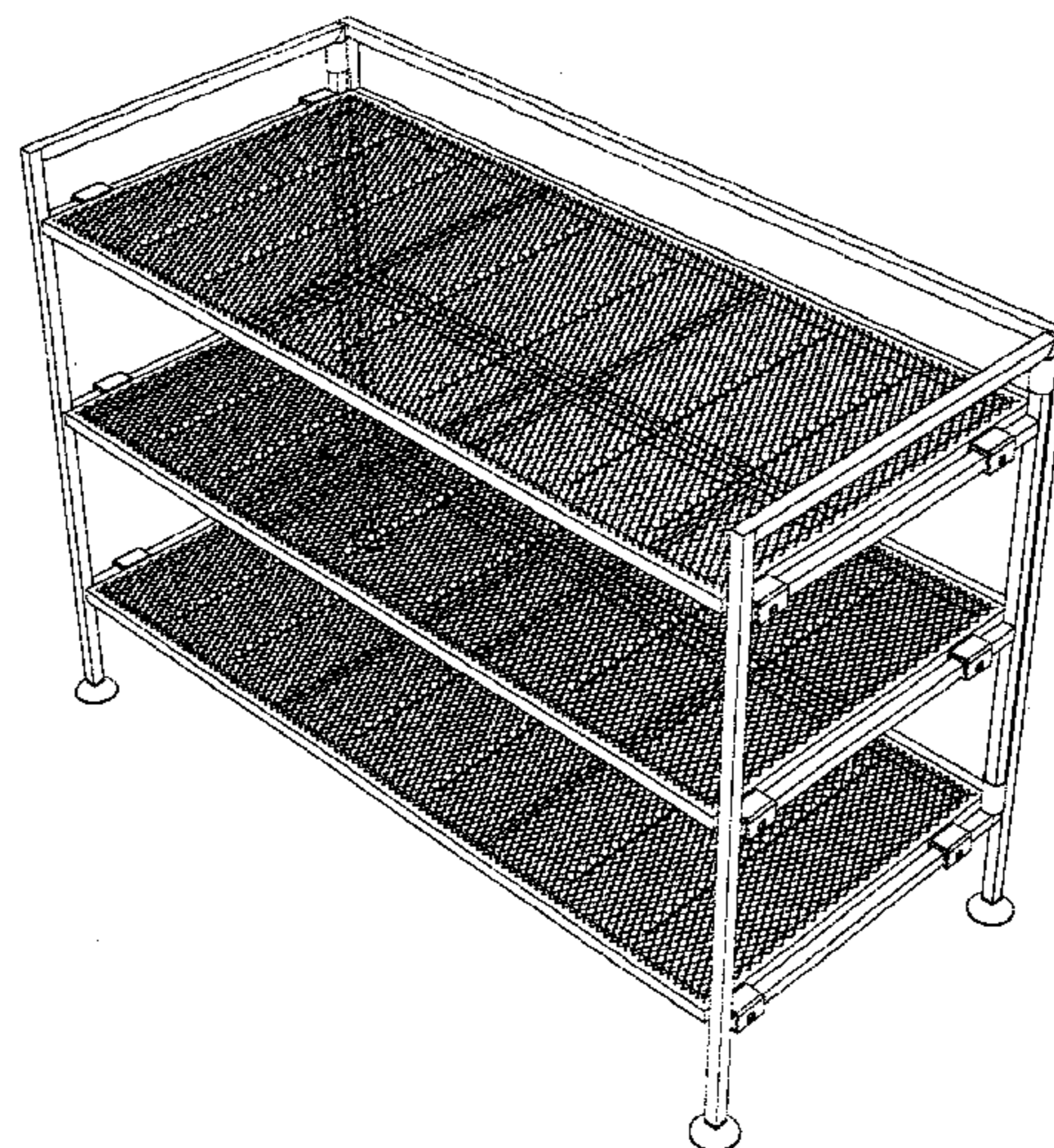
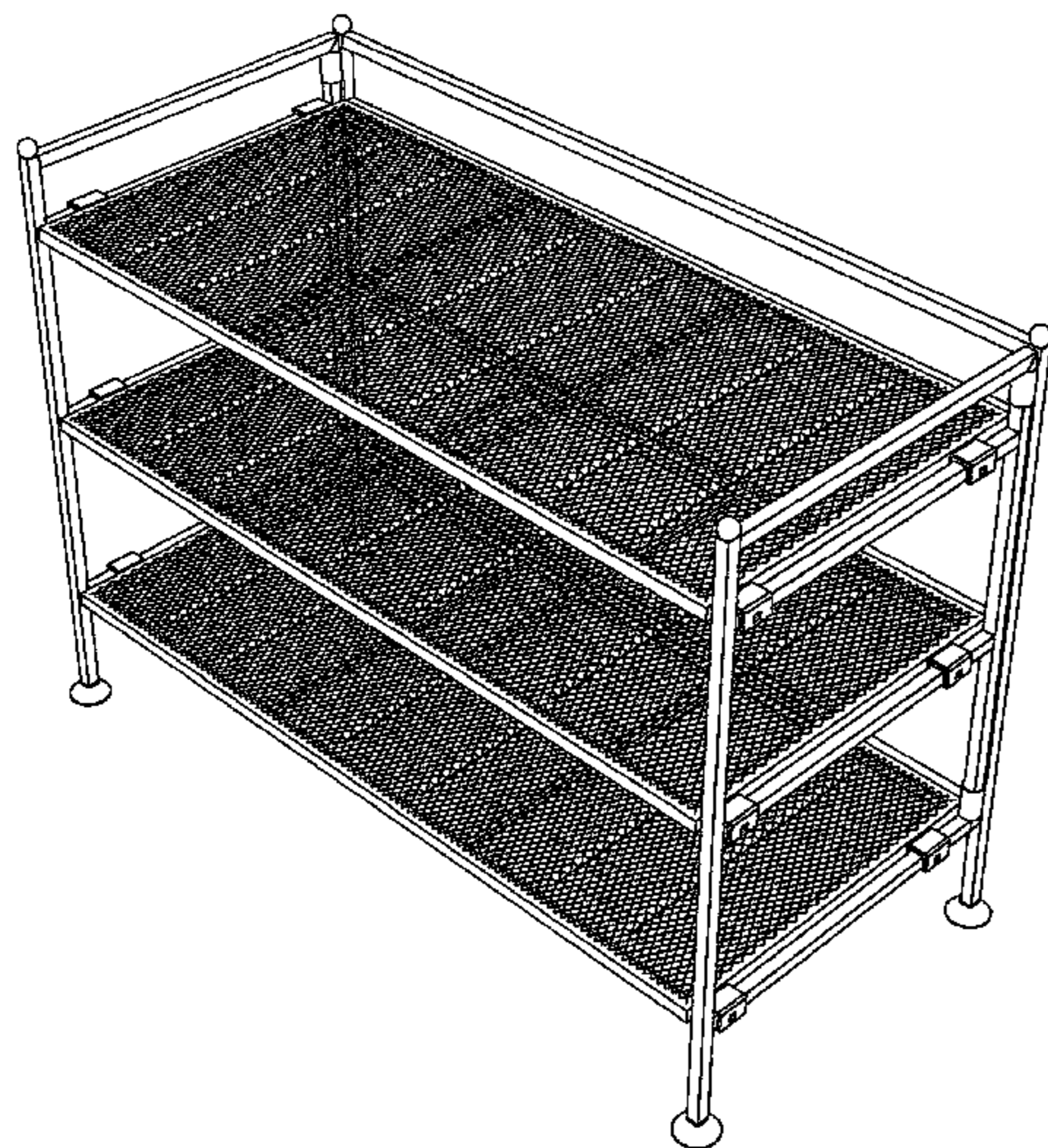
FIG. 11 is a right plan view thereof;

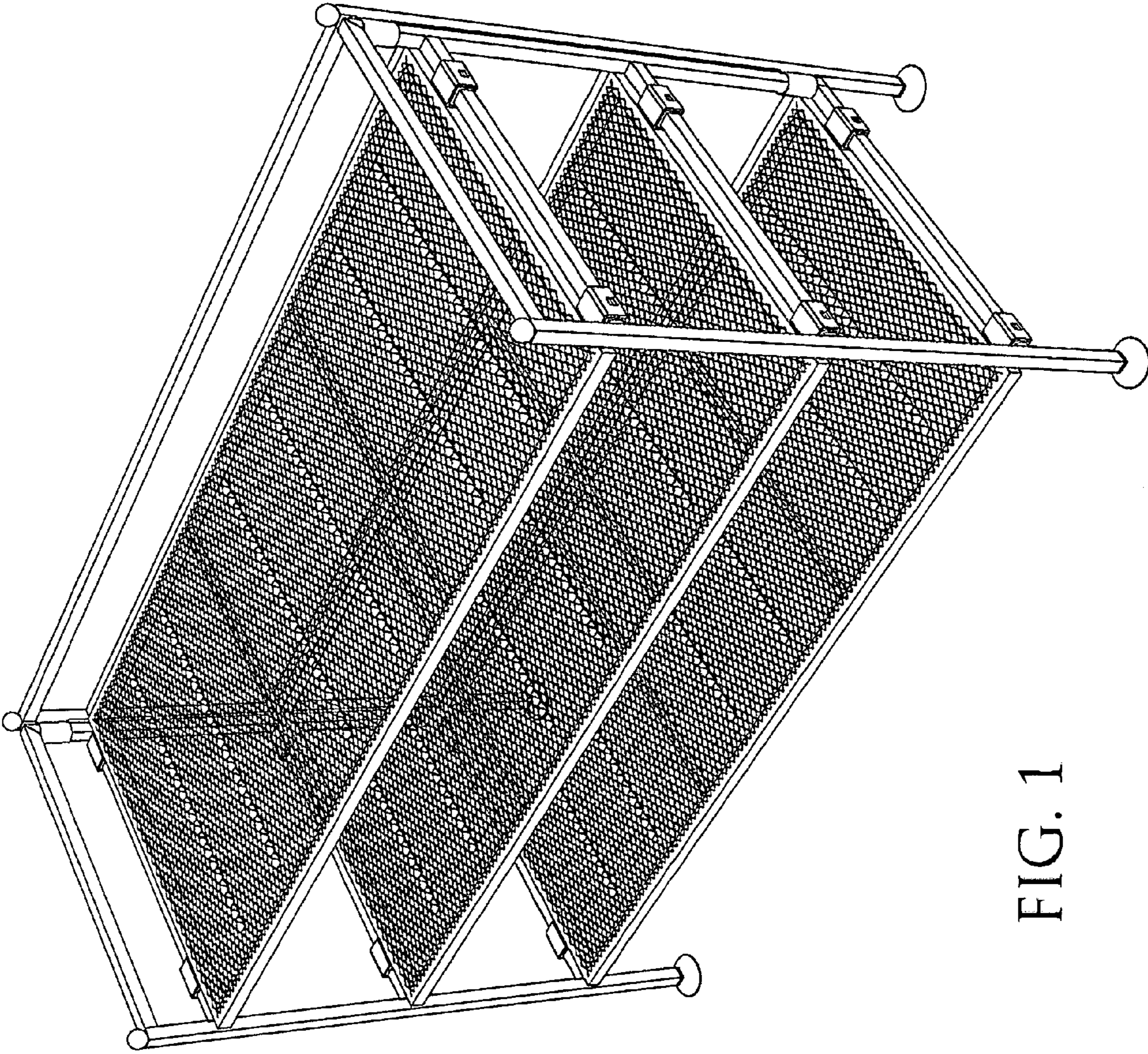

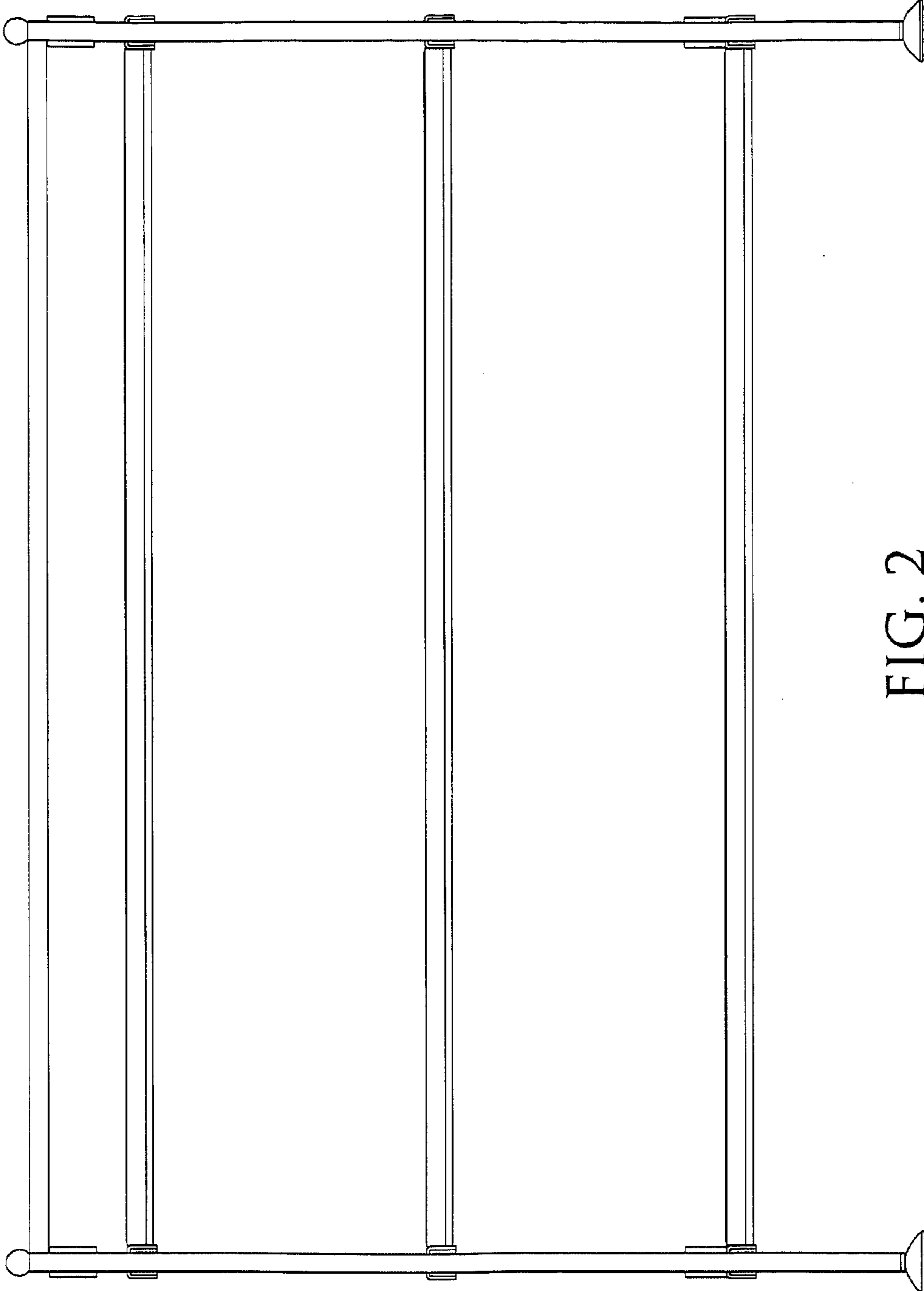

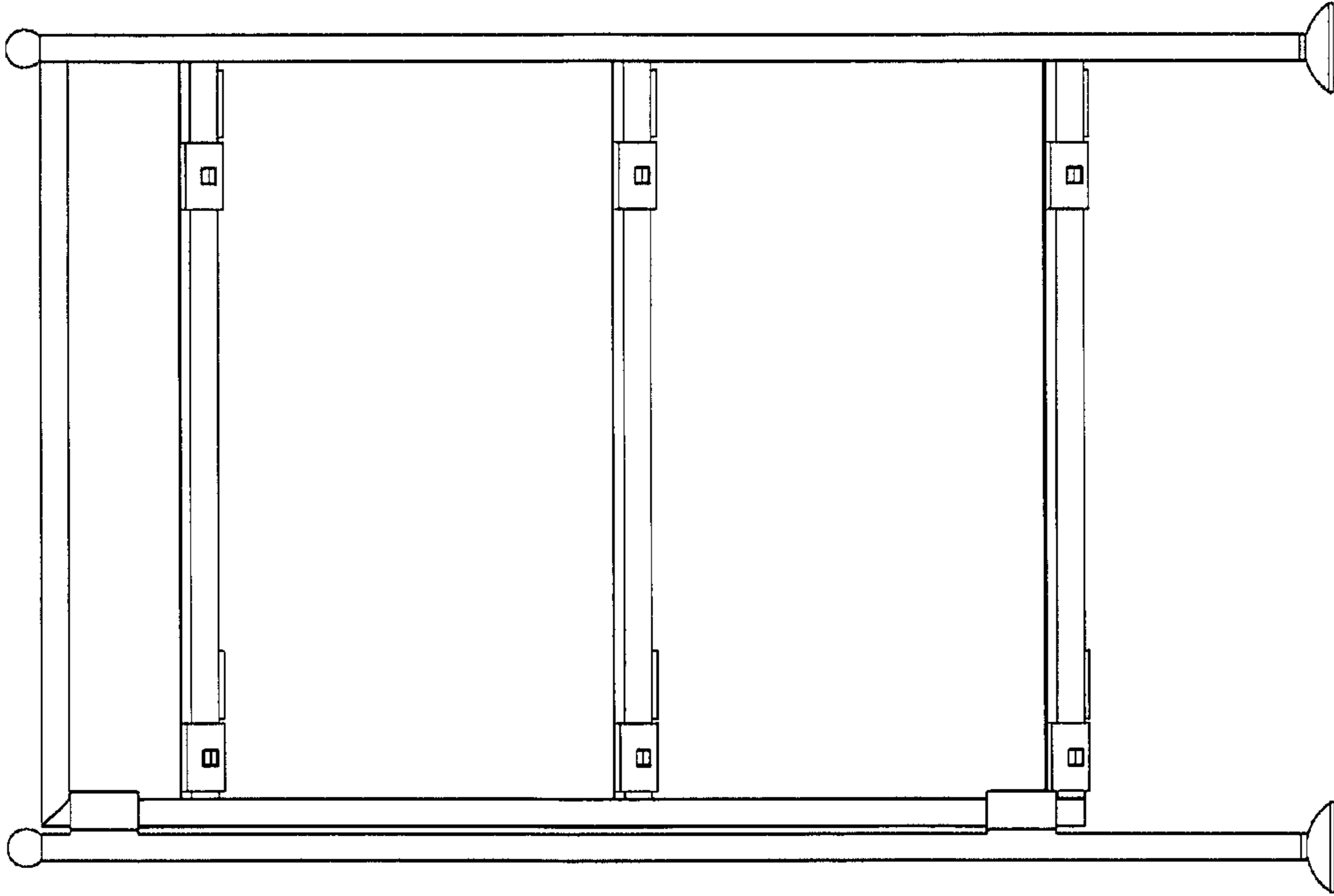

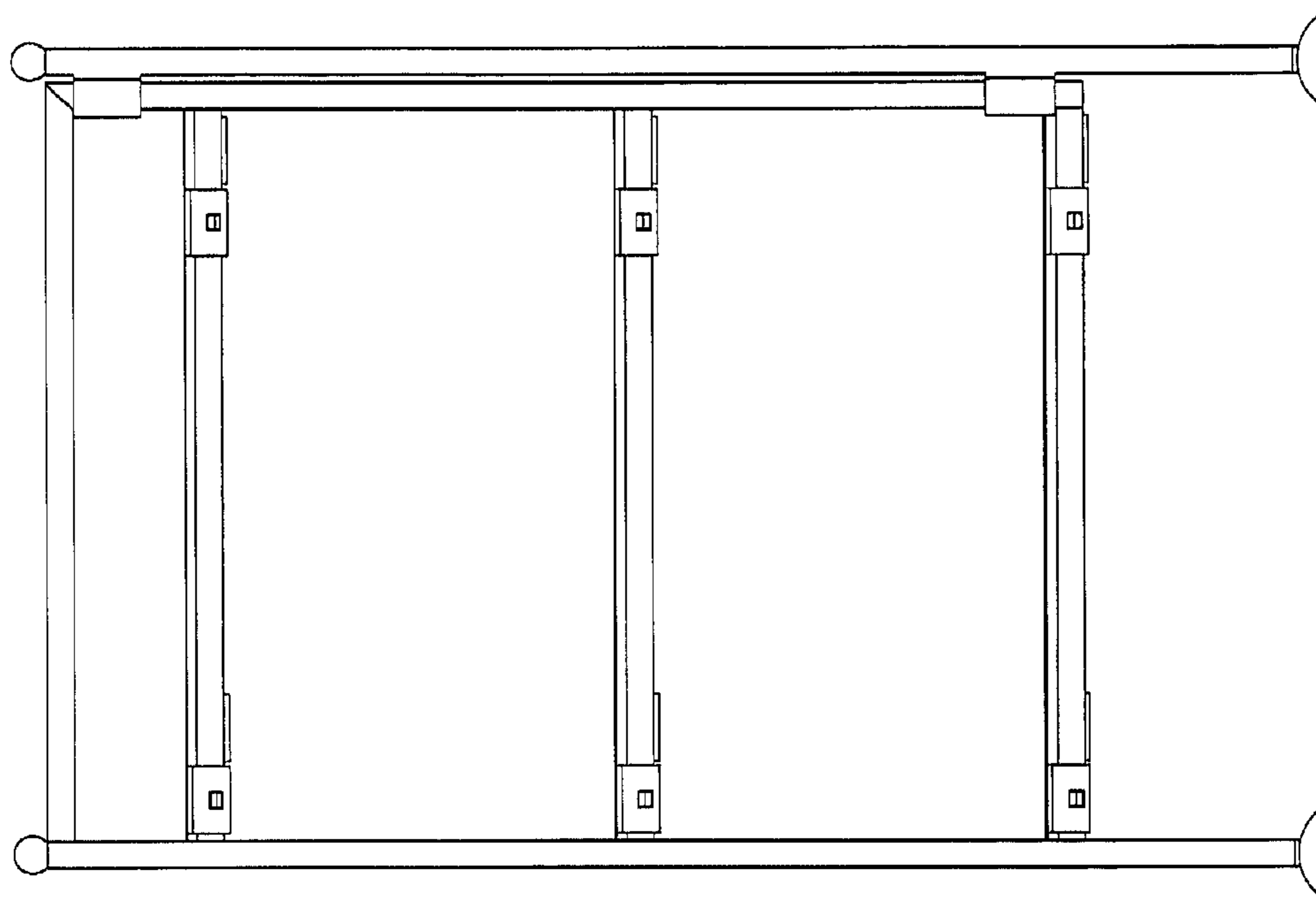

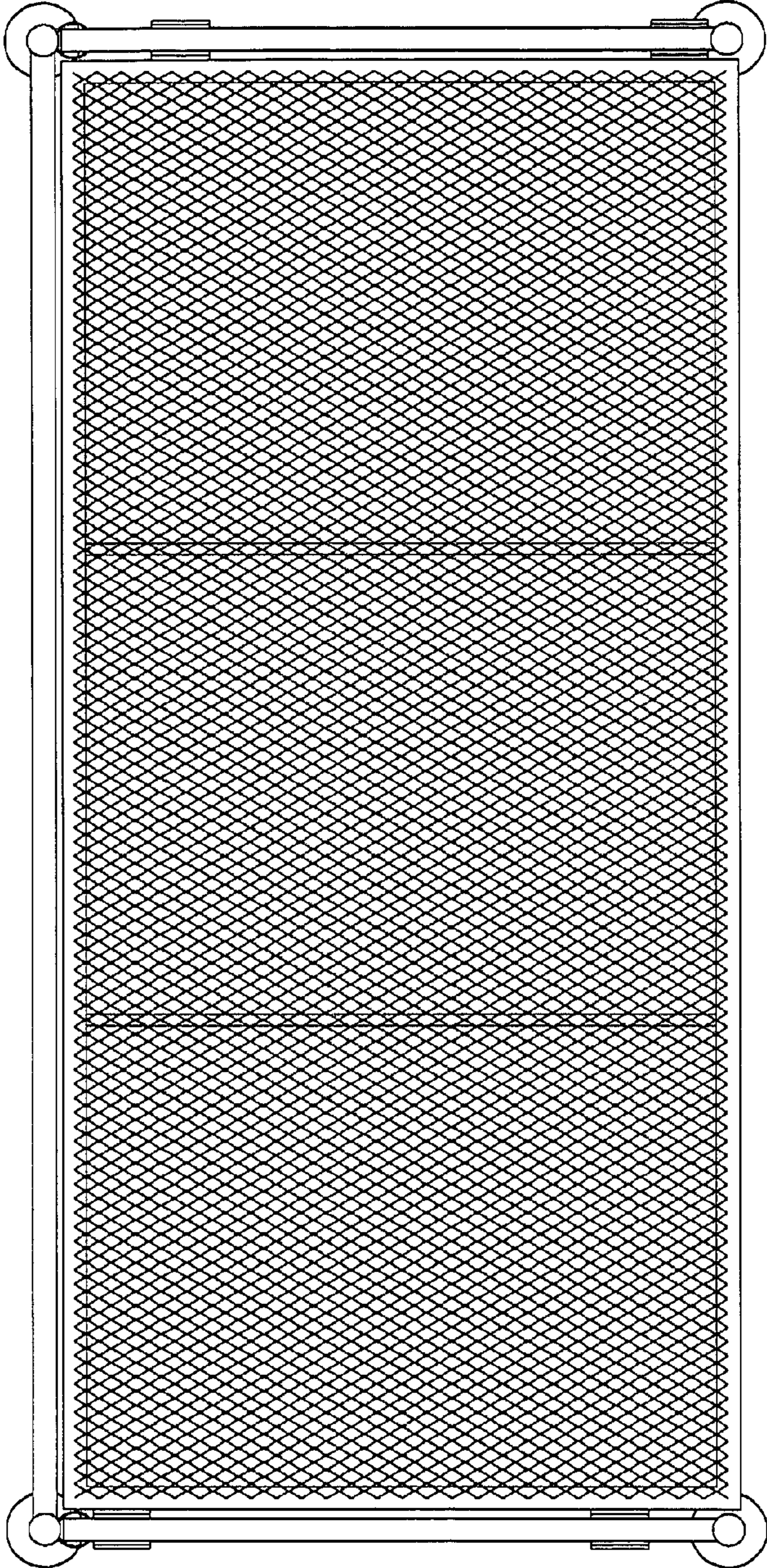

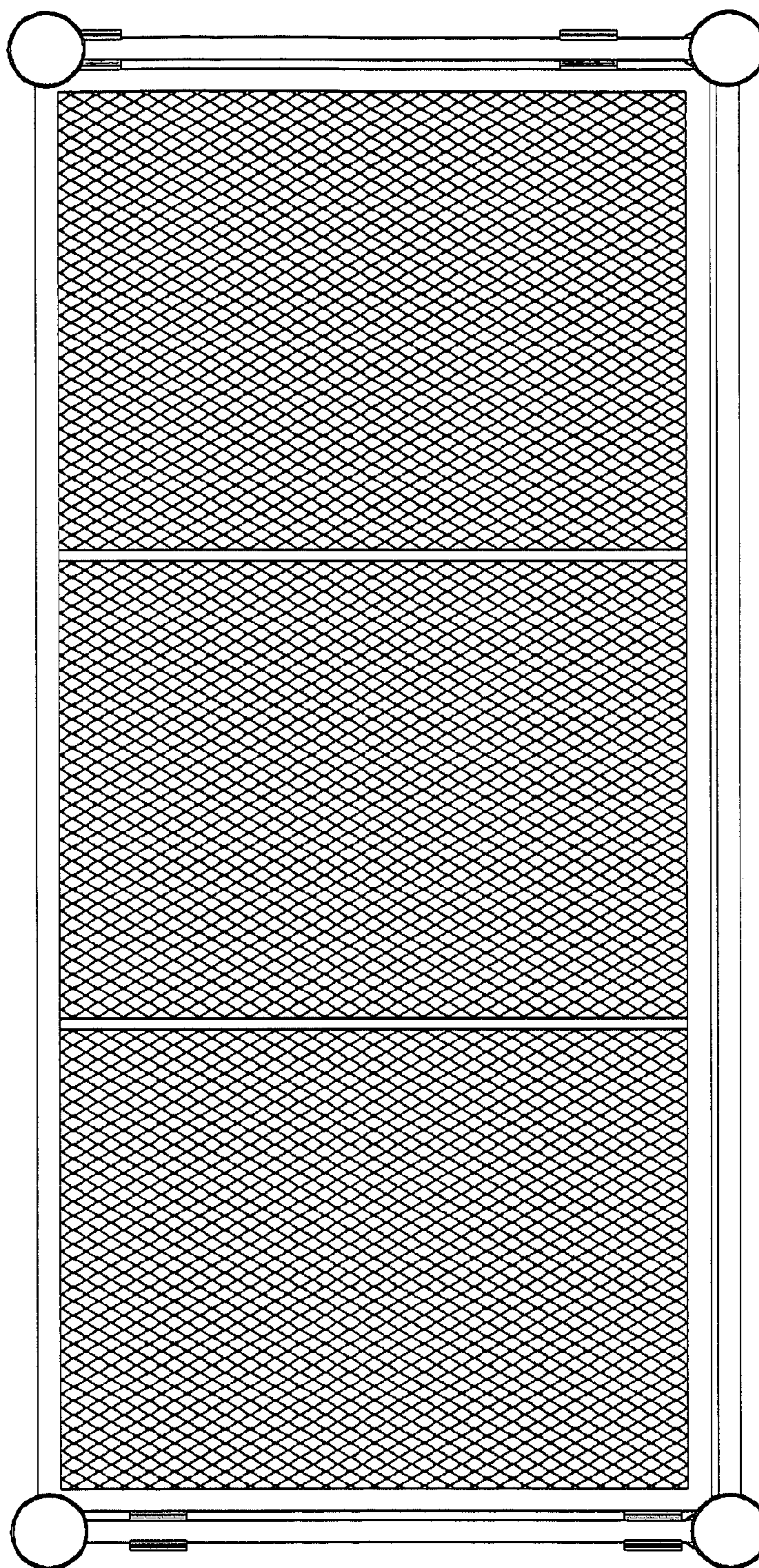

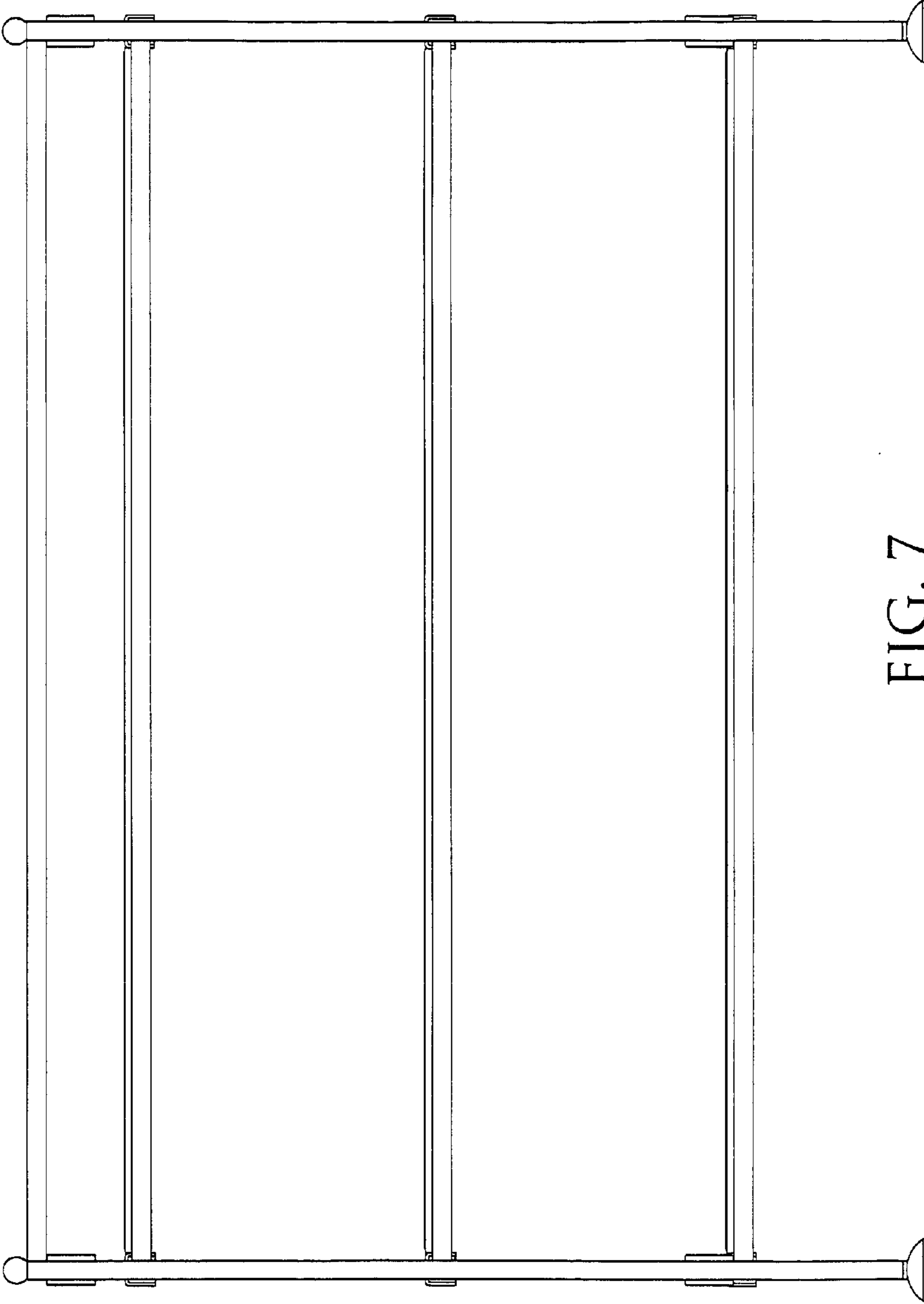

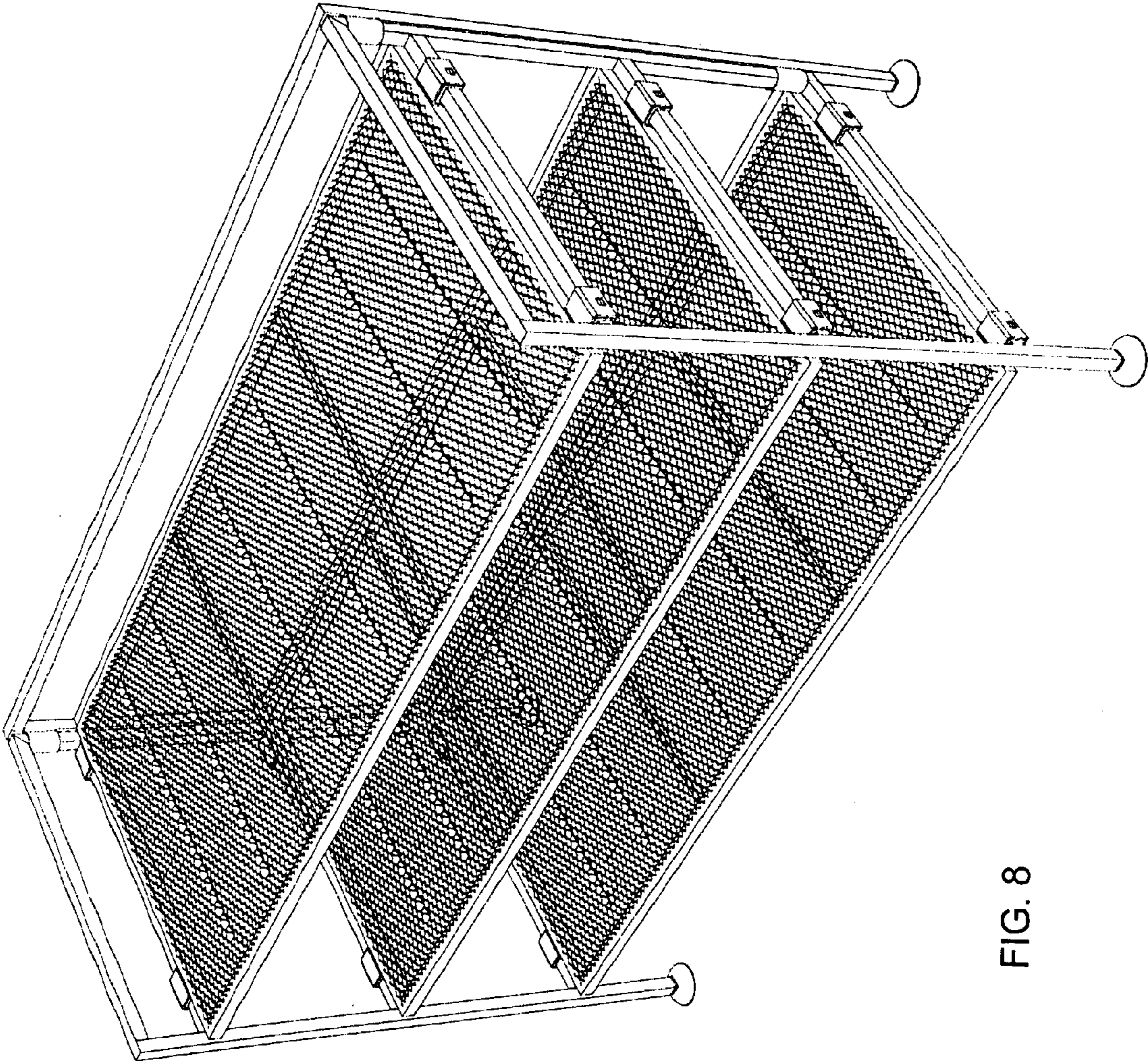

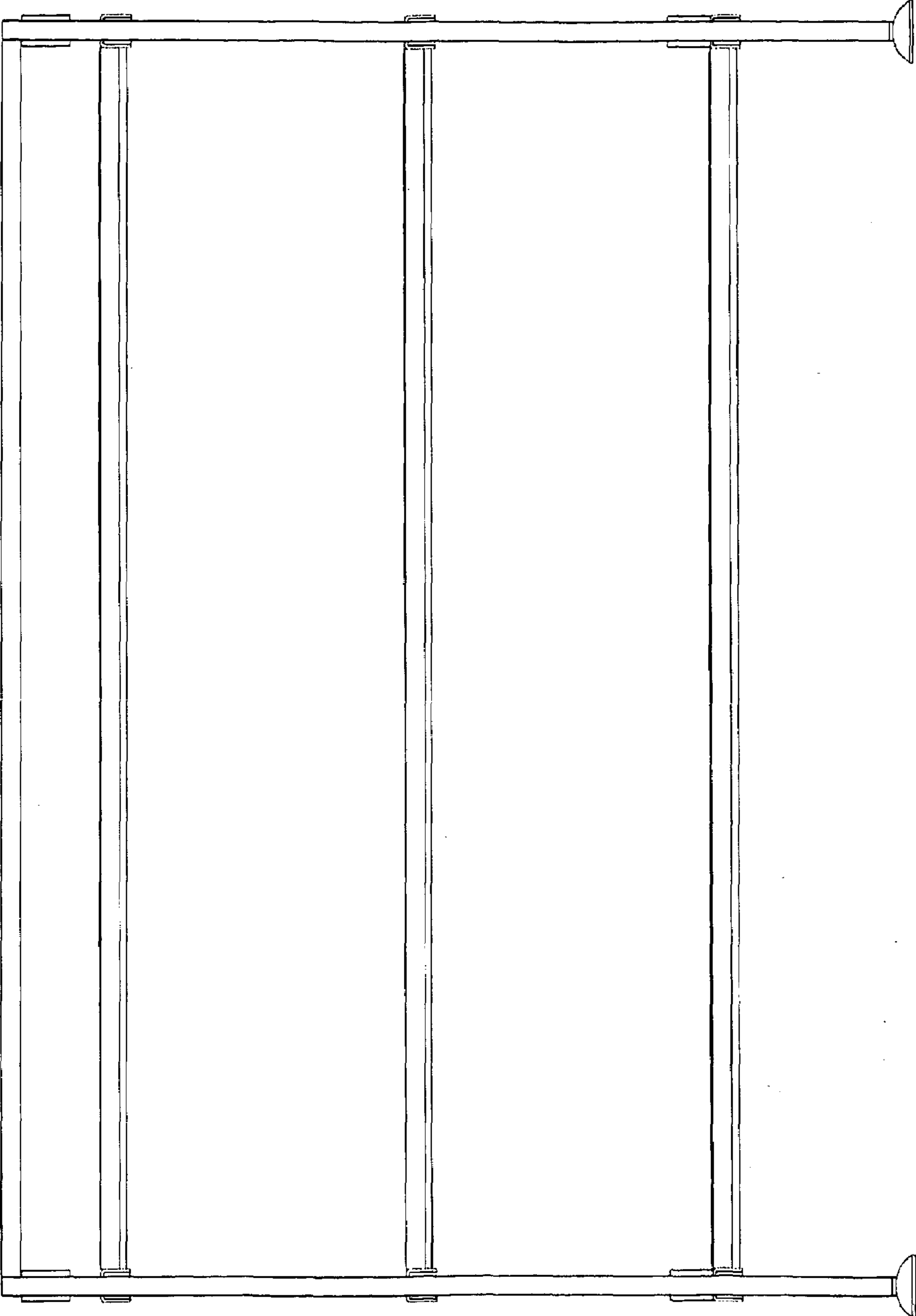

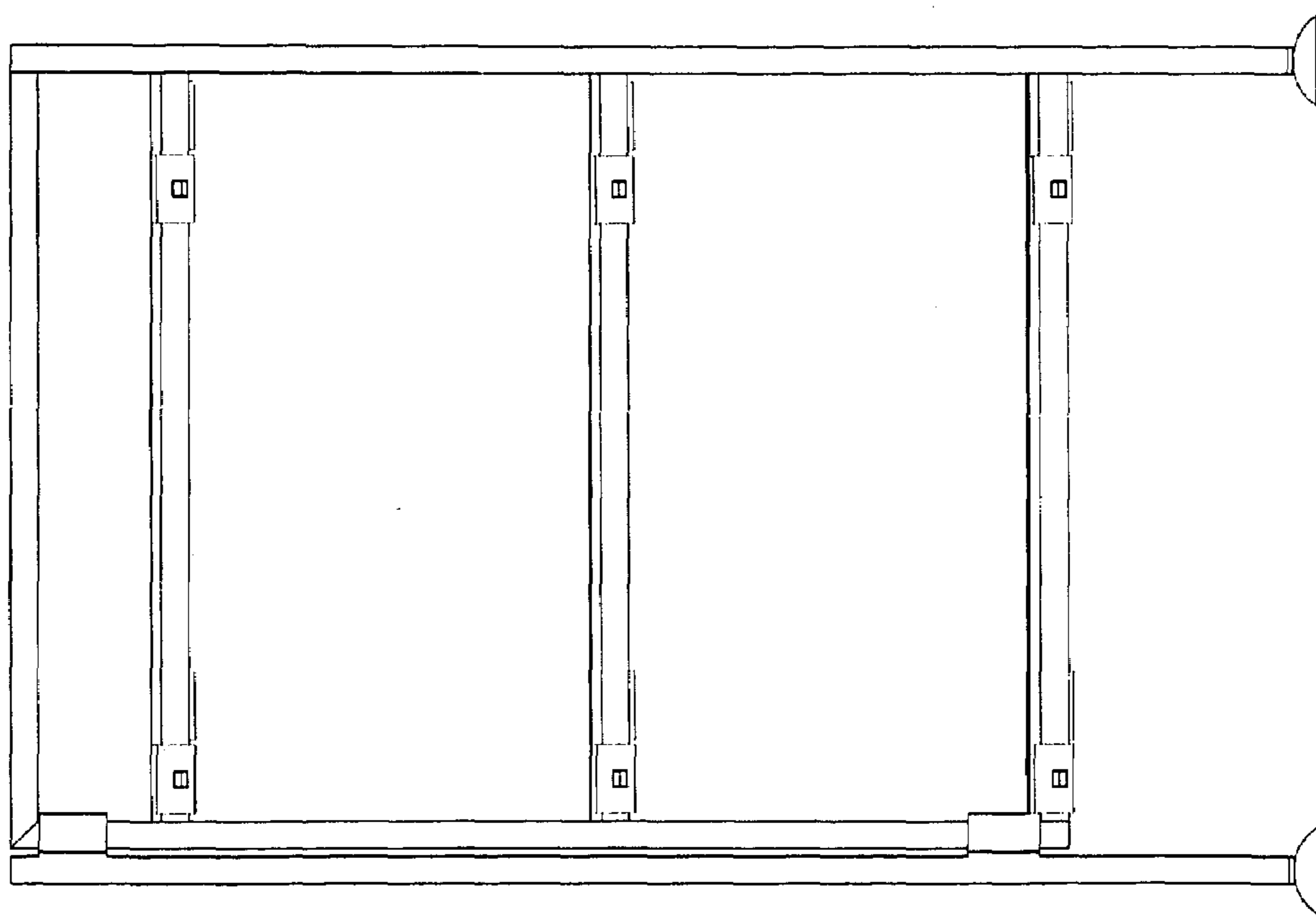

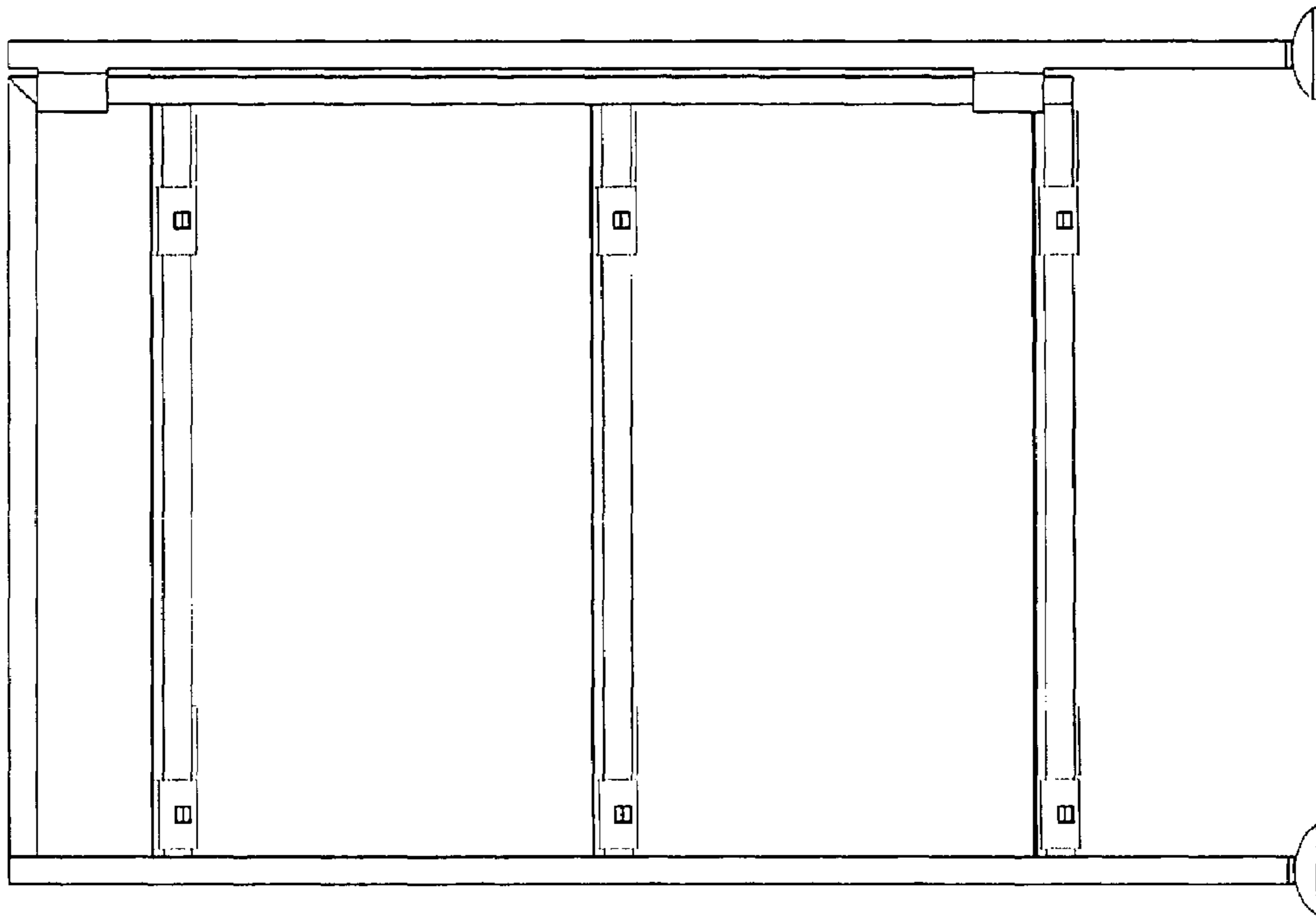

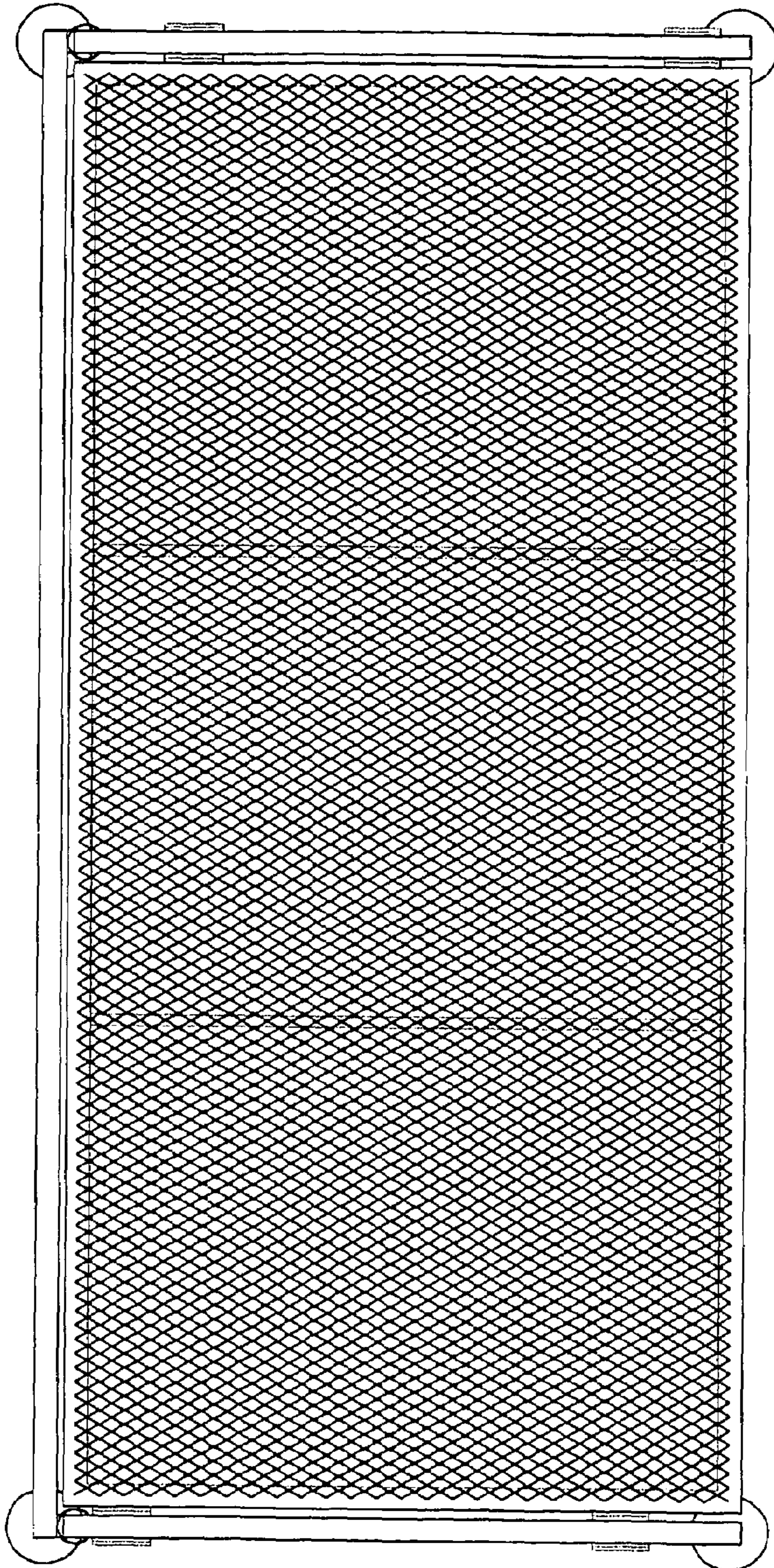

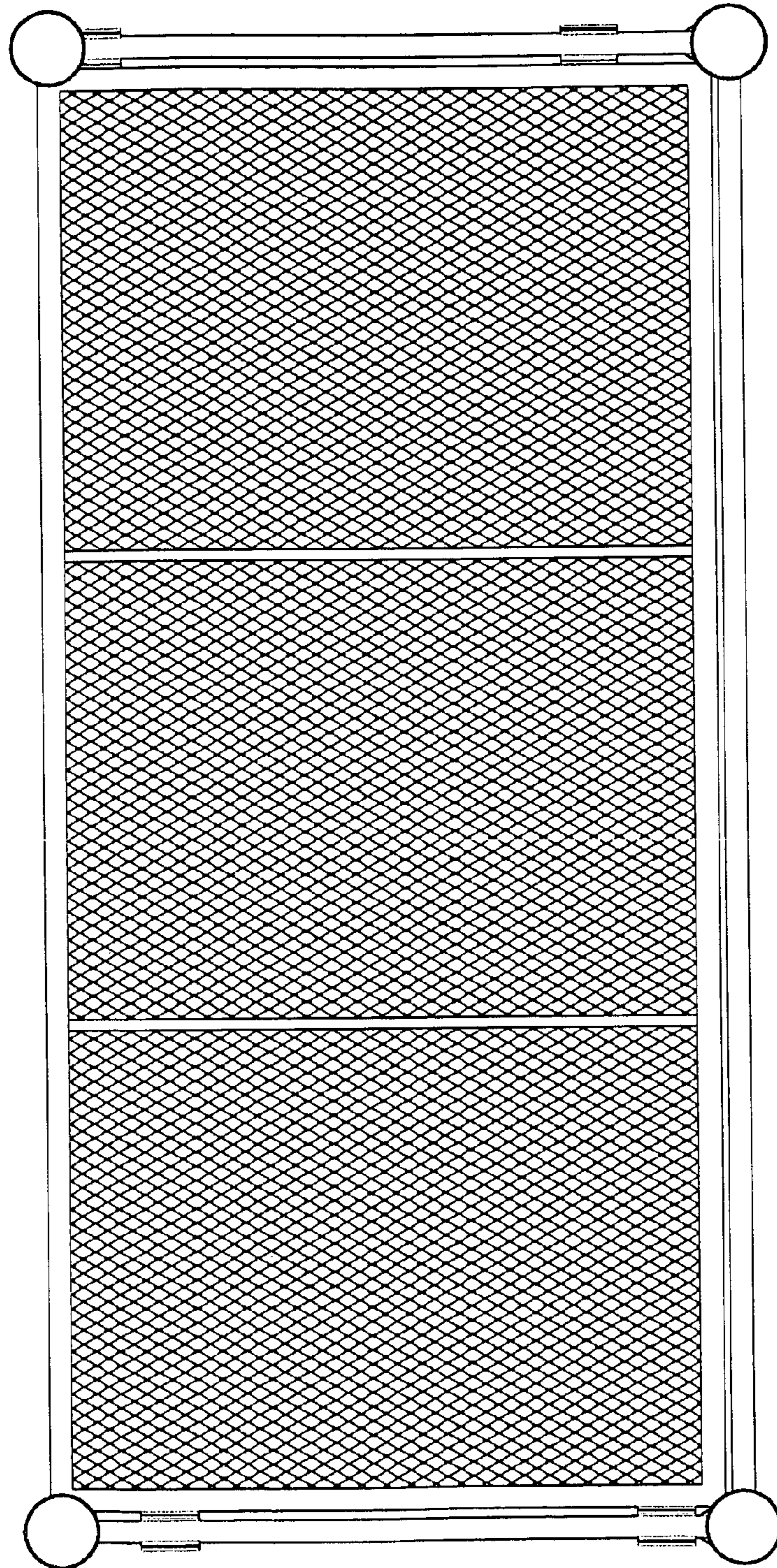
