(57) **CLAIM**

The ornamental design for a bangle bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bangle bracelet illustrating the new design;

FIG. 2 is a top view of the bangle bracelet illustrated in FIG. 1;

FIG. 3 is a bottom perspective view of the bangle bracelet illustrated in FIG. 1;

FIG. 4 is a left, front perspective view of the bangle bracelet illustrated in FIG. 1;

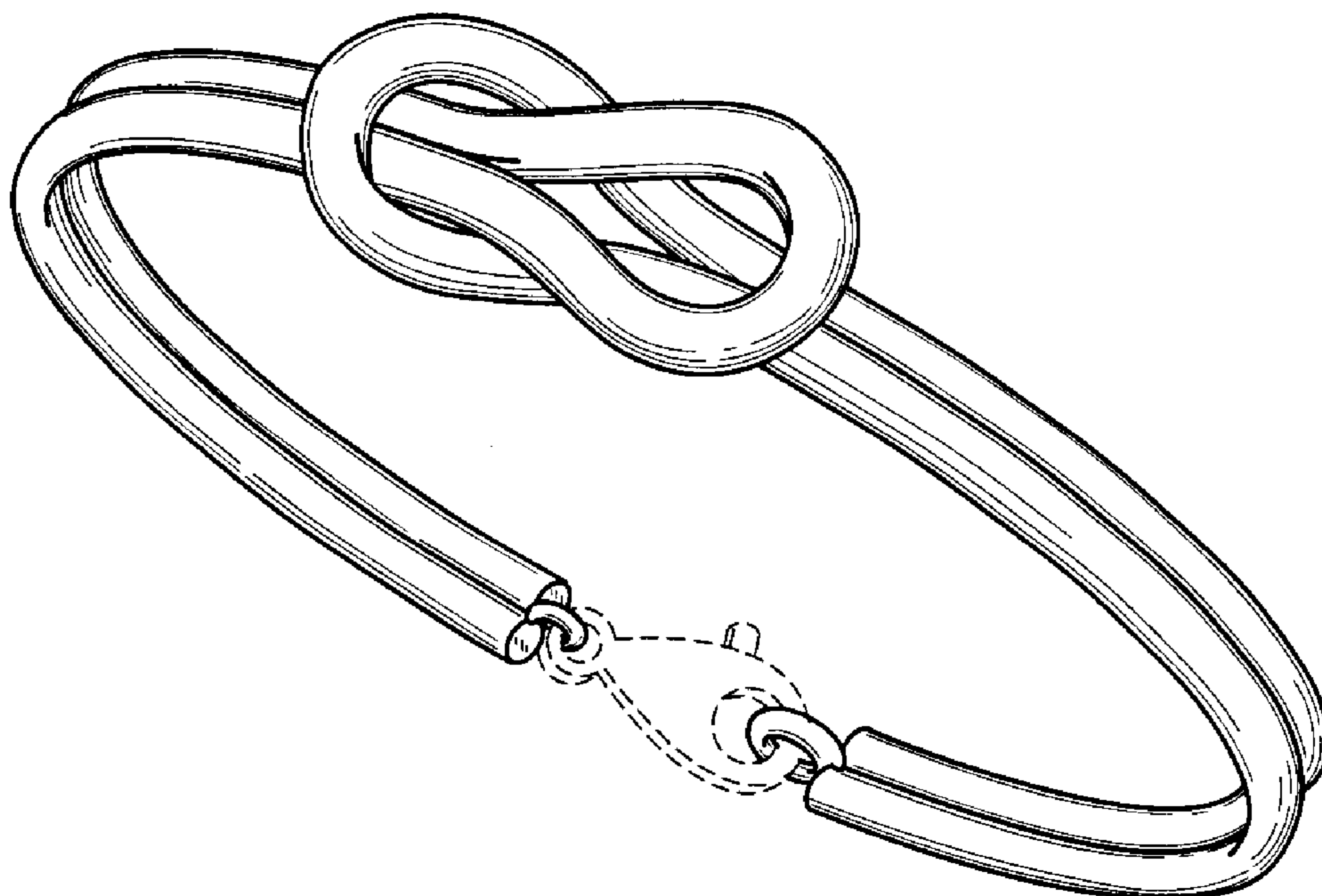
FIG. 5 is a front view of the bangle bracelet shown in FIG. 1 (the rear view is a mirror image of FIG. 5);

FIG. 6 is a right perspective view of the bangle bracelet illustrated in FIG. 1; and,

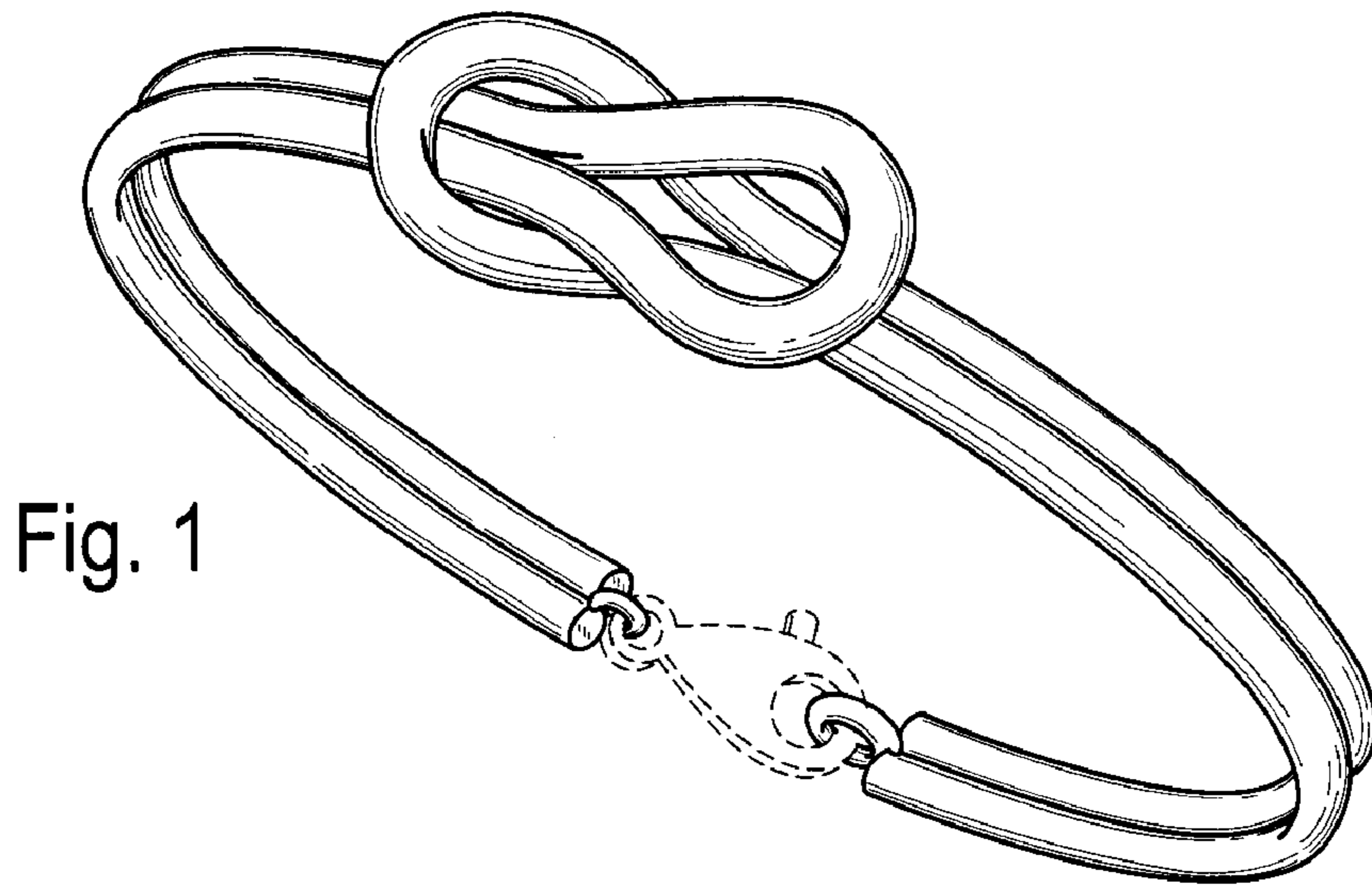

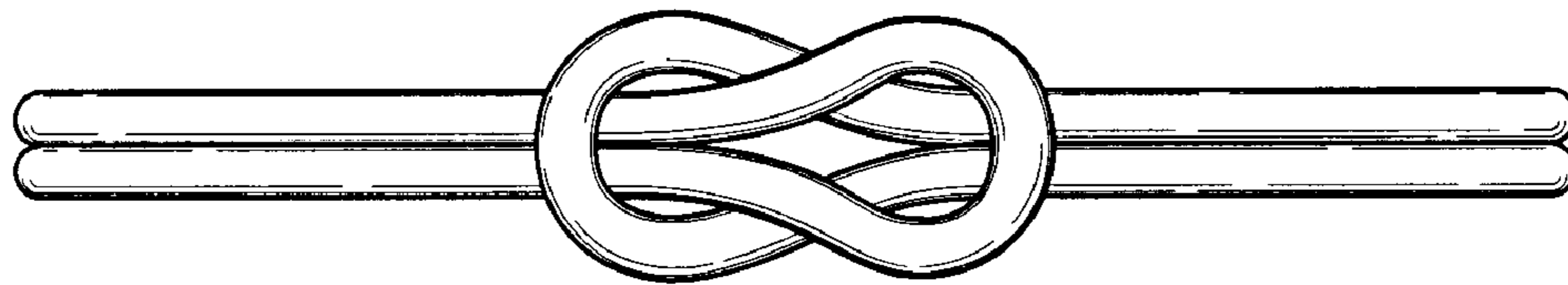

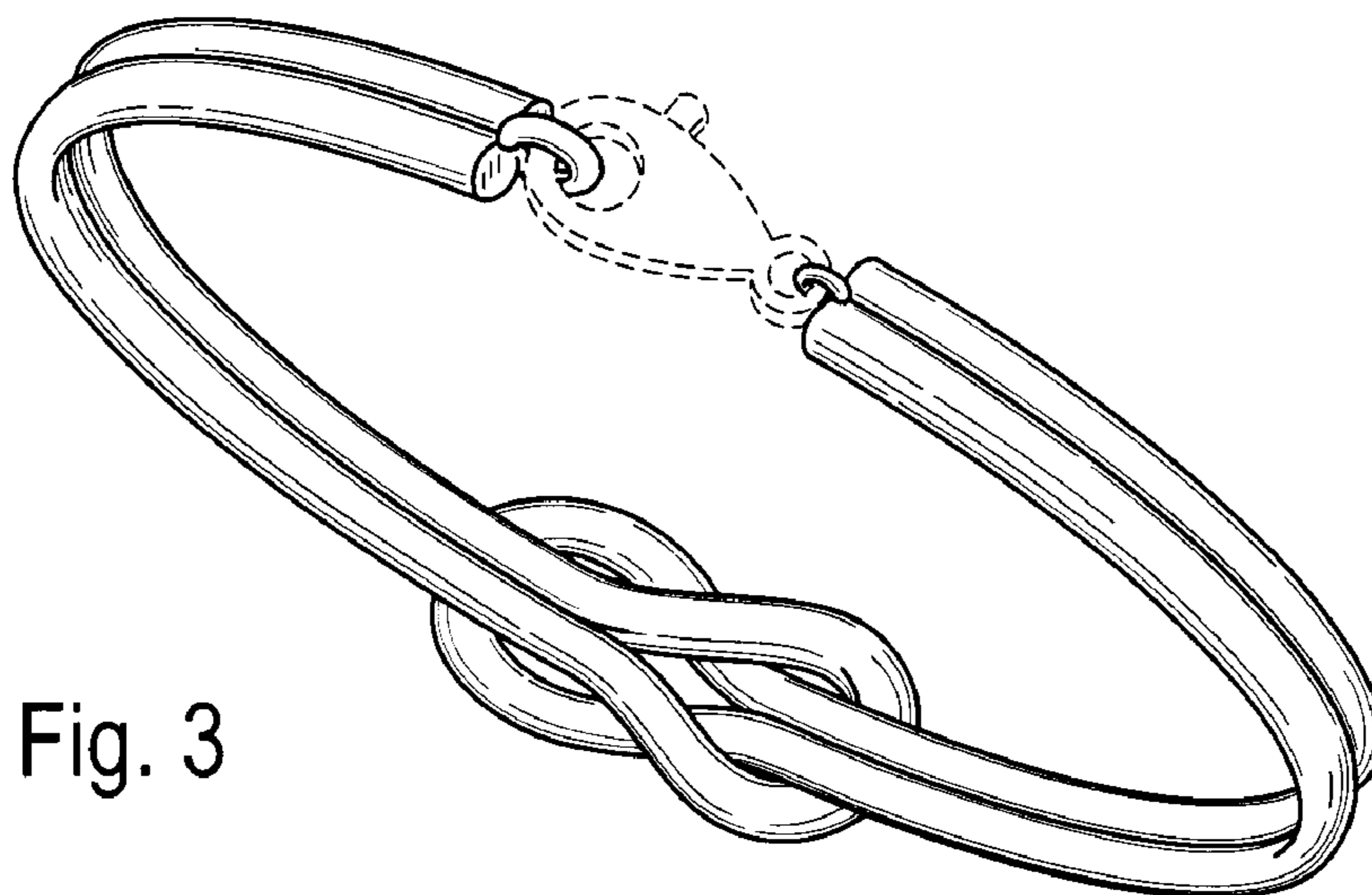

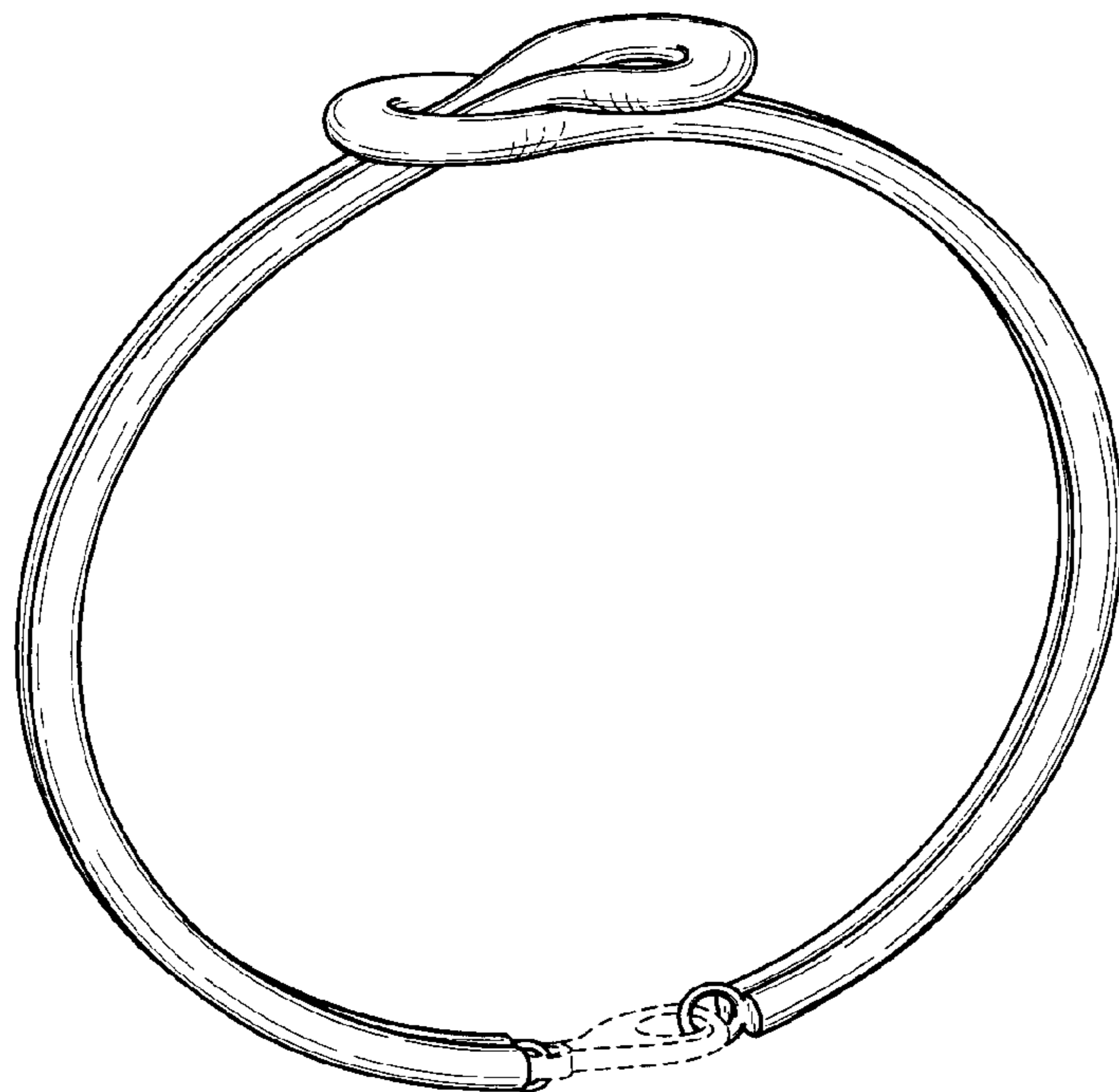

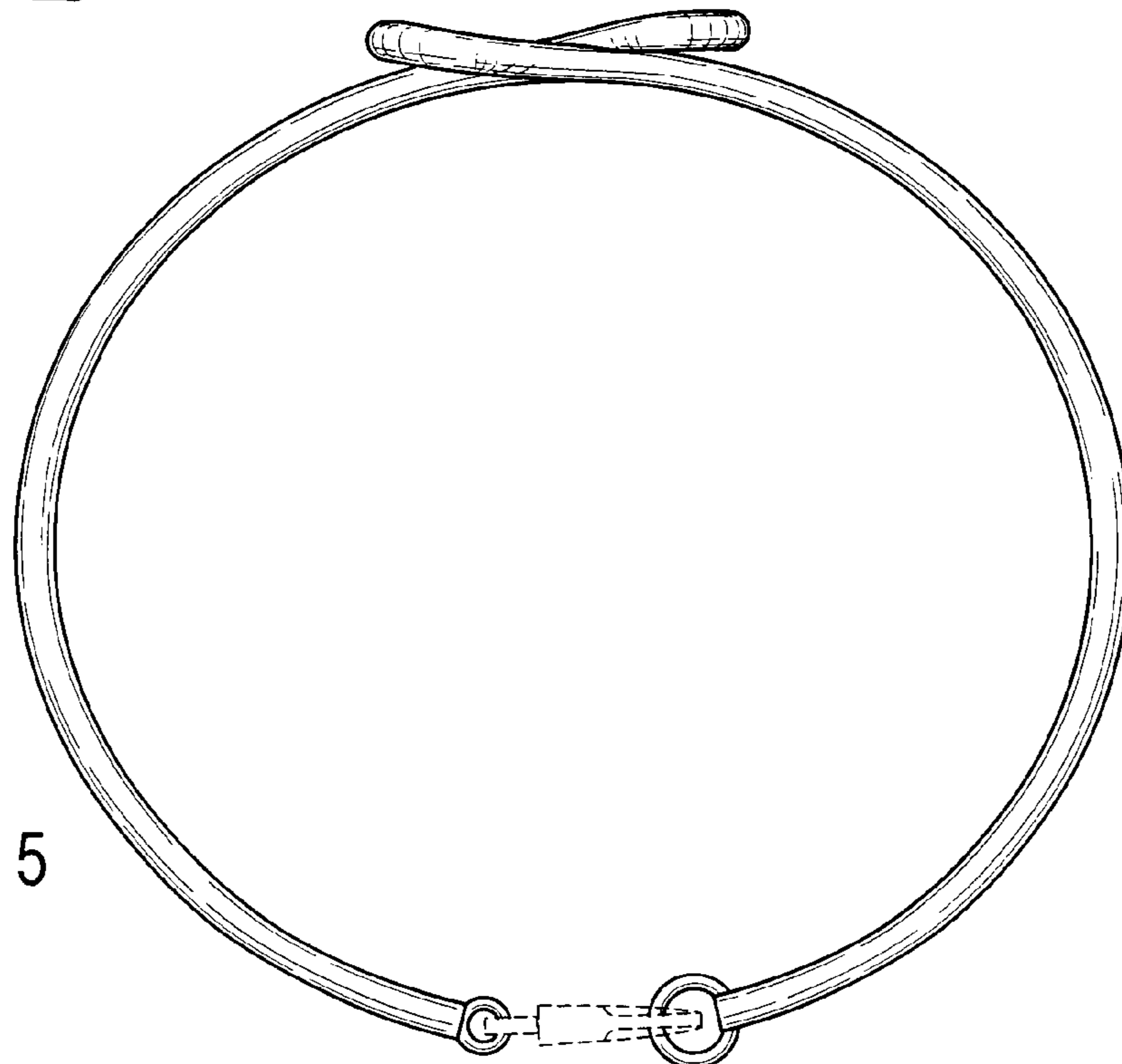

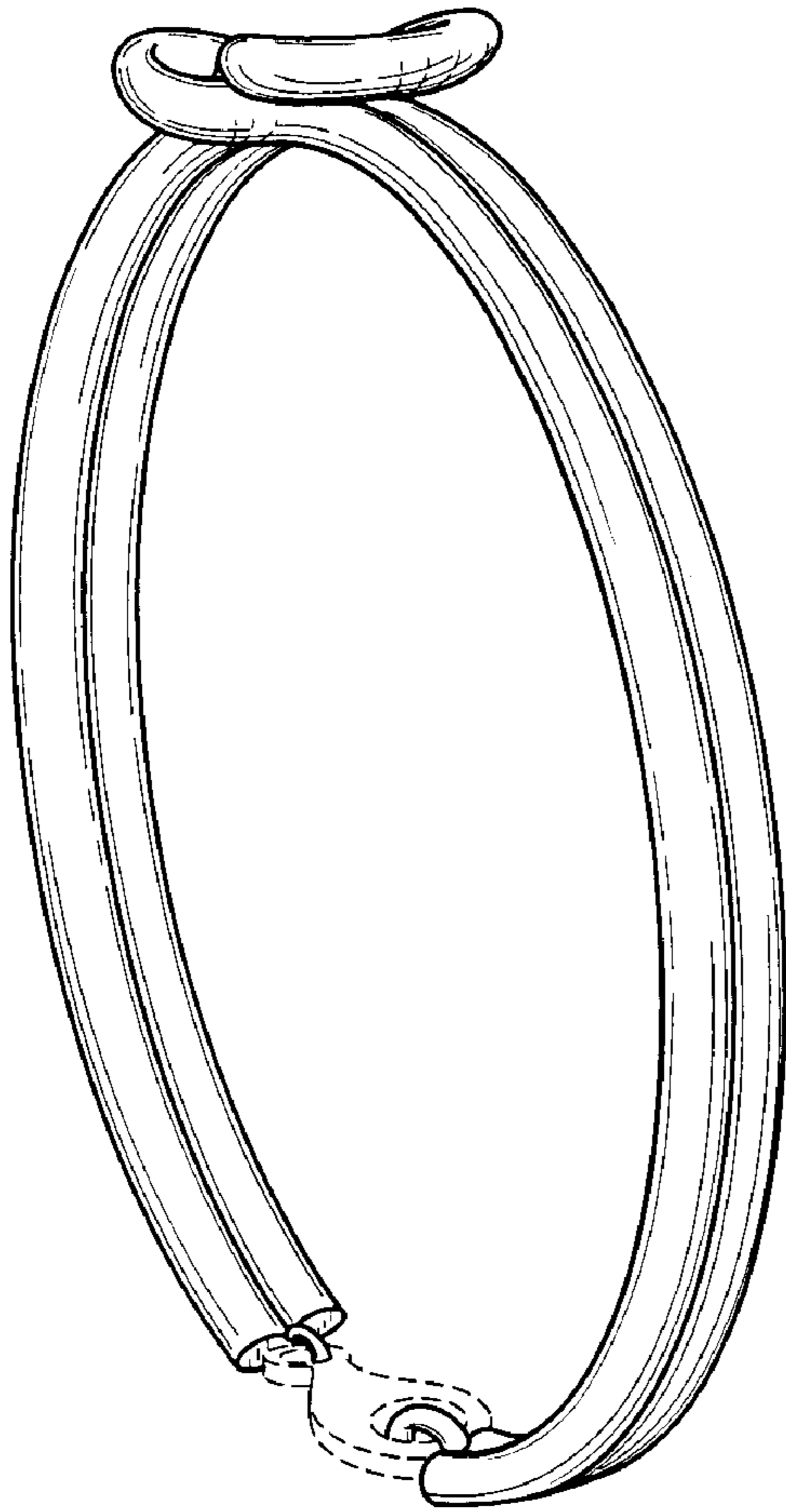

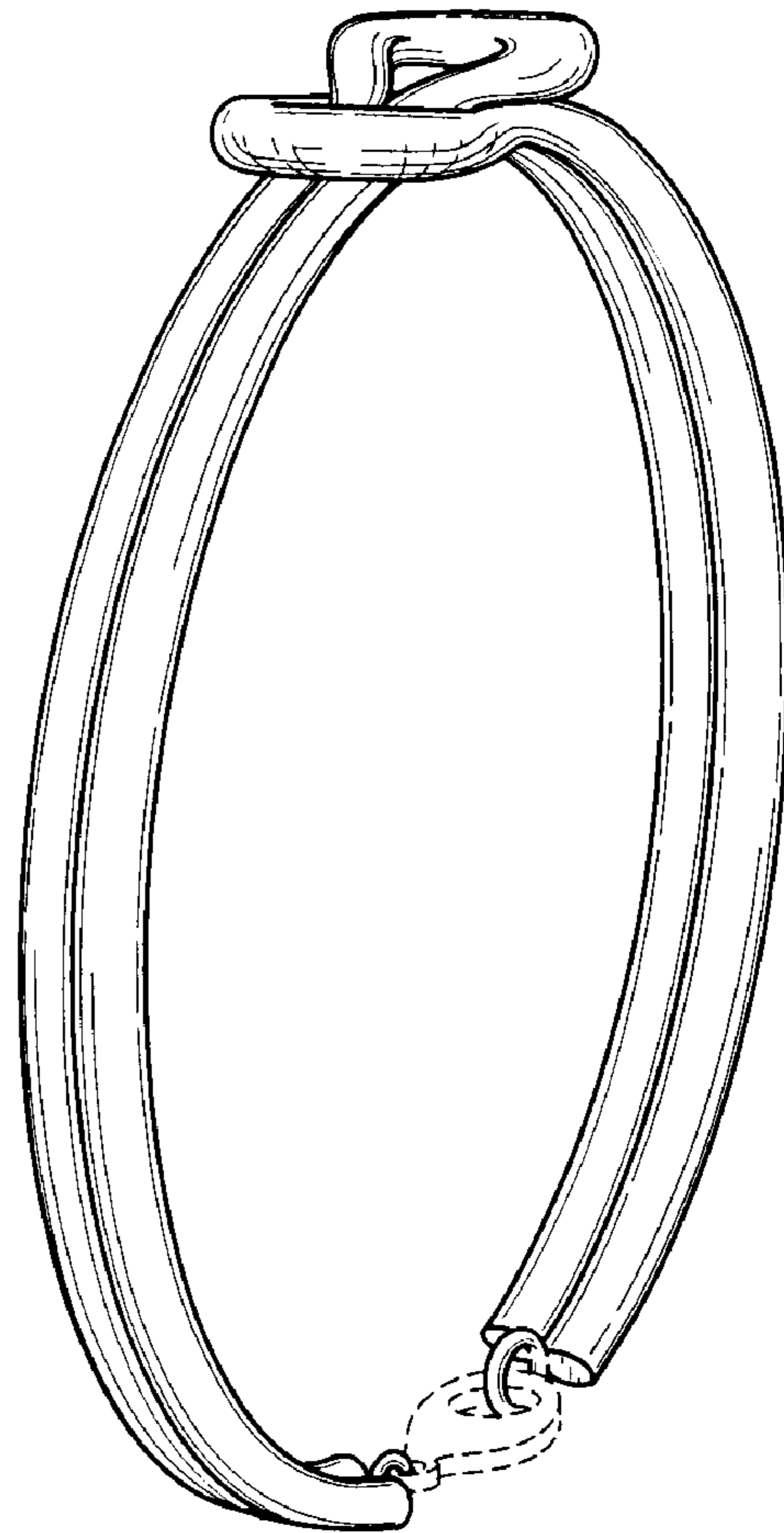
