FIG. 1 is a front perspective view of a jewelry setting illustrating the new design;

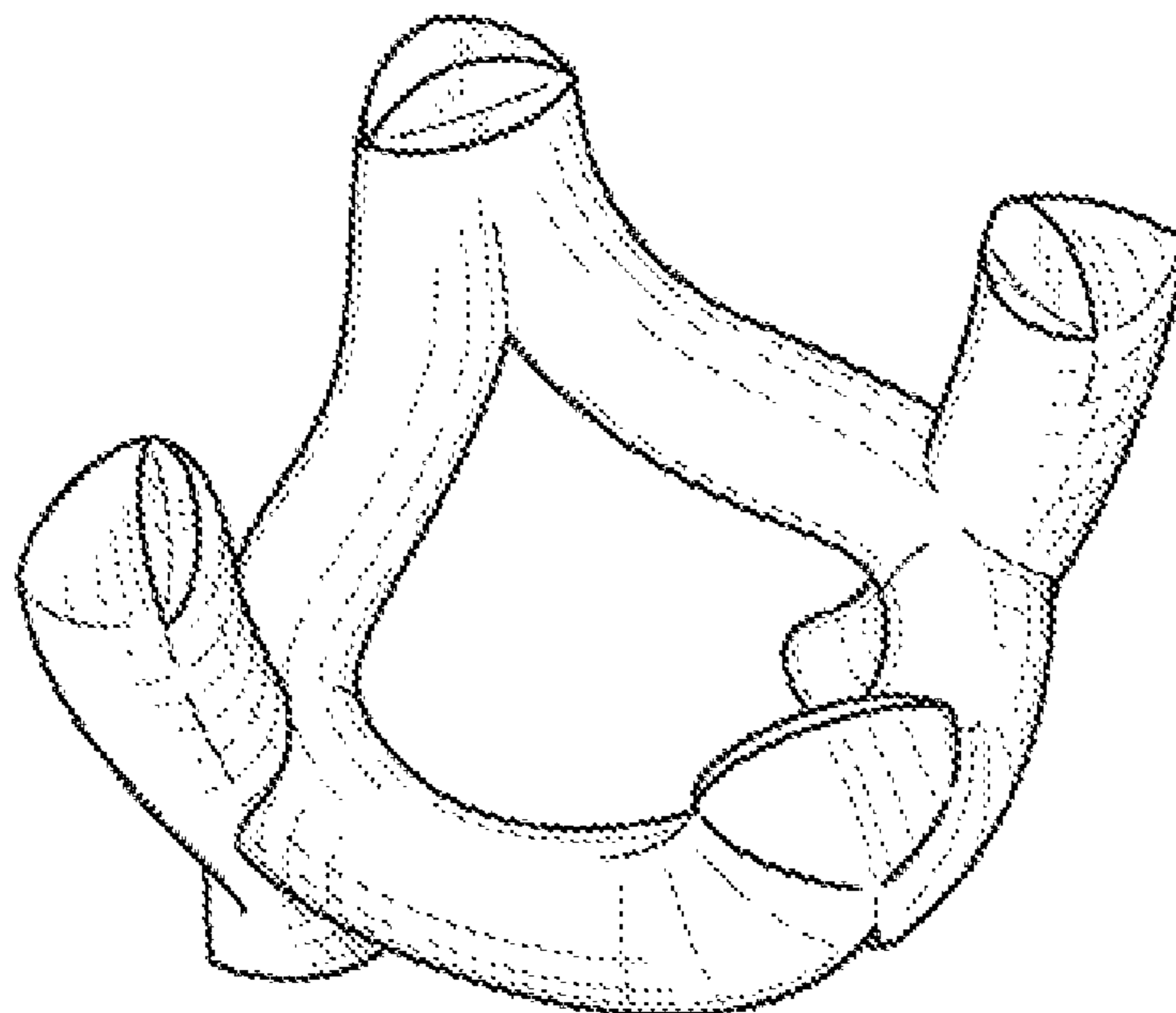
FIG. 2 is a rear perspective view of the jewelry setting illustrated in FIG. 1;

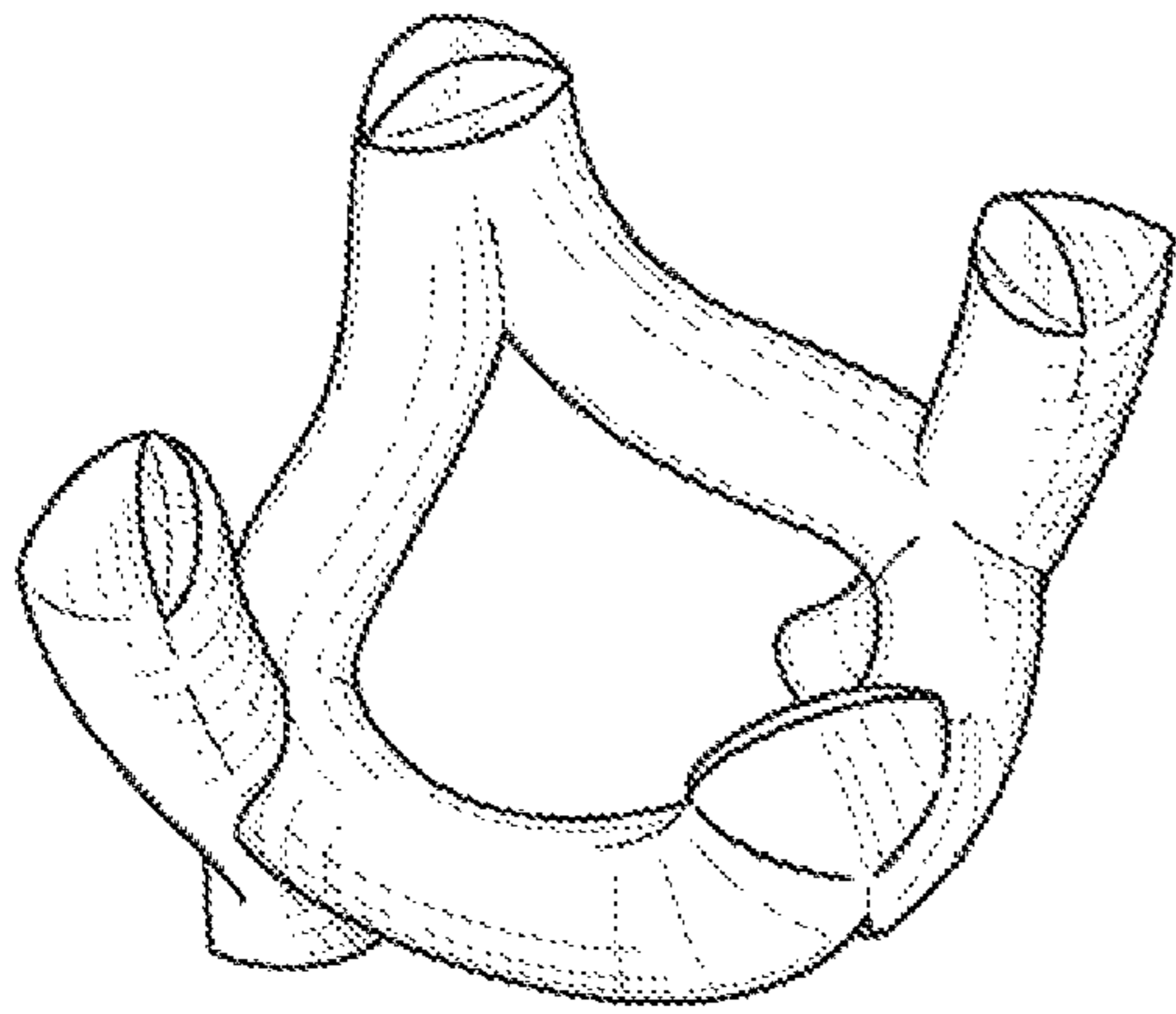

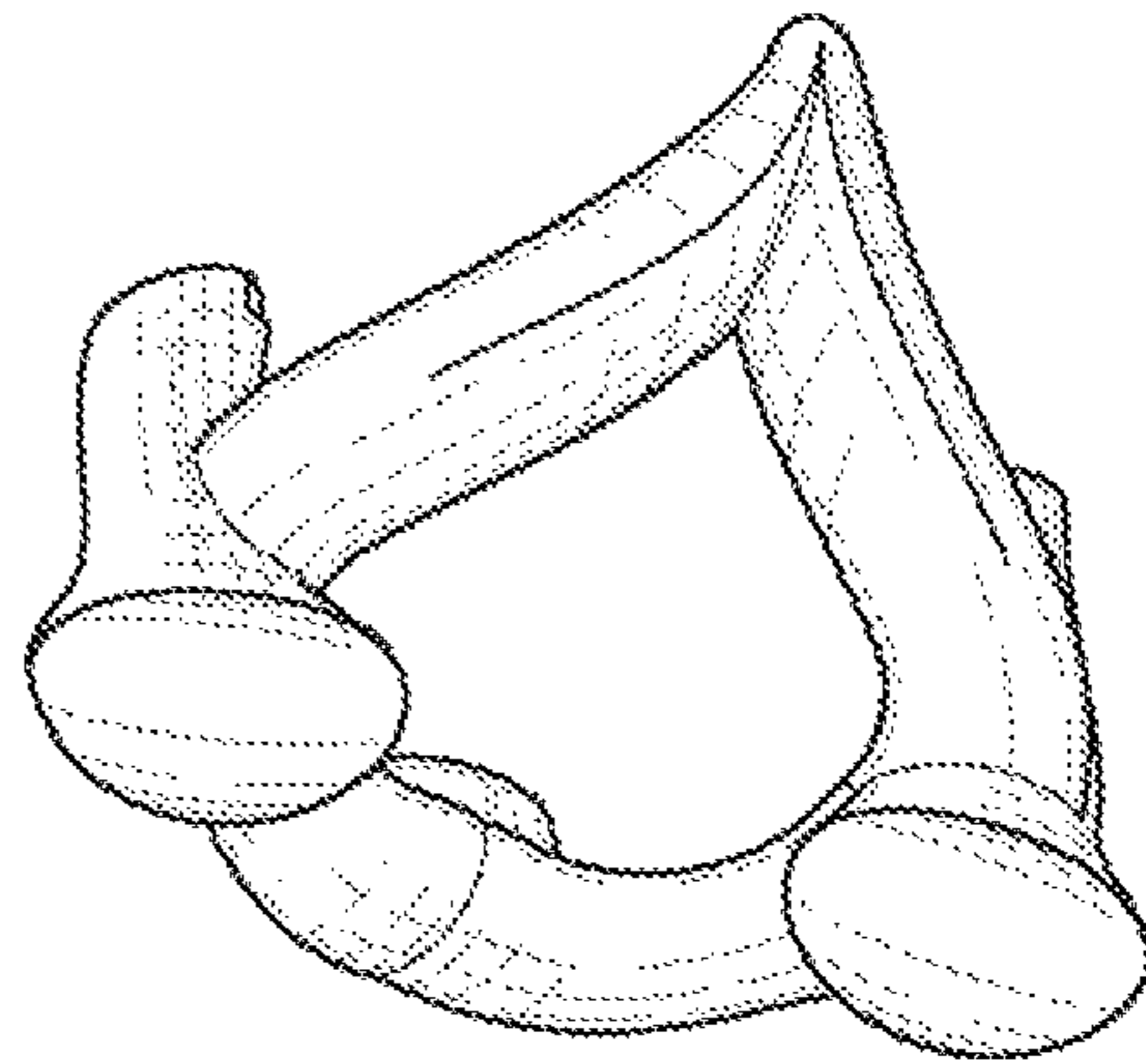

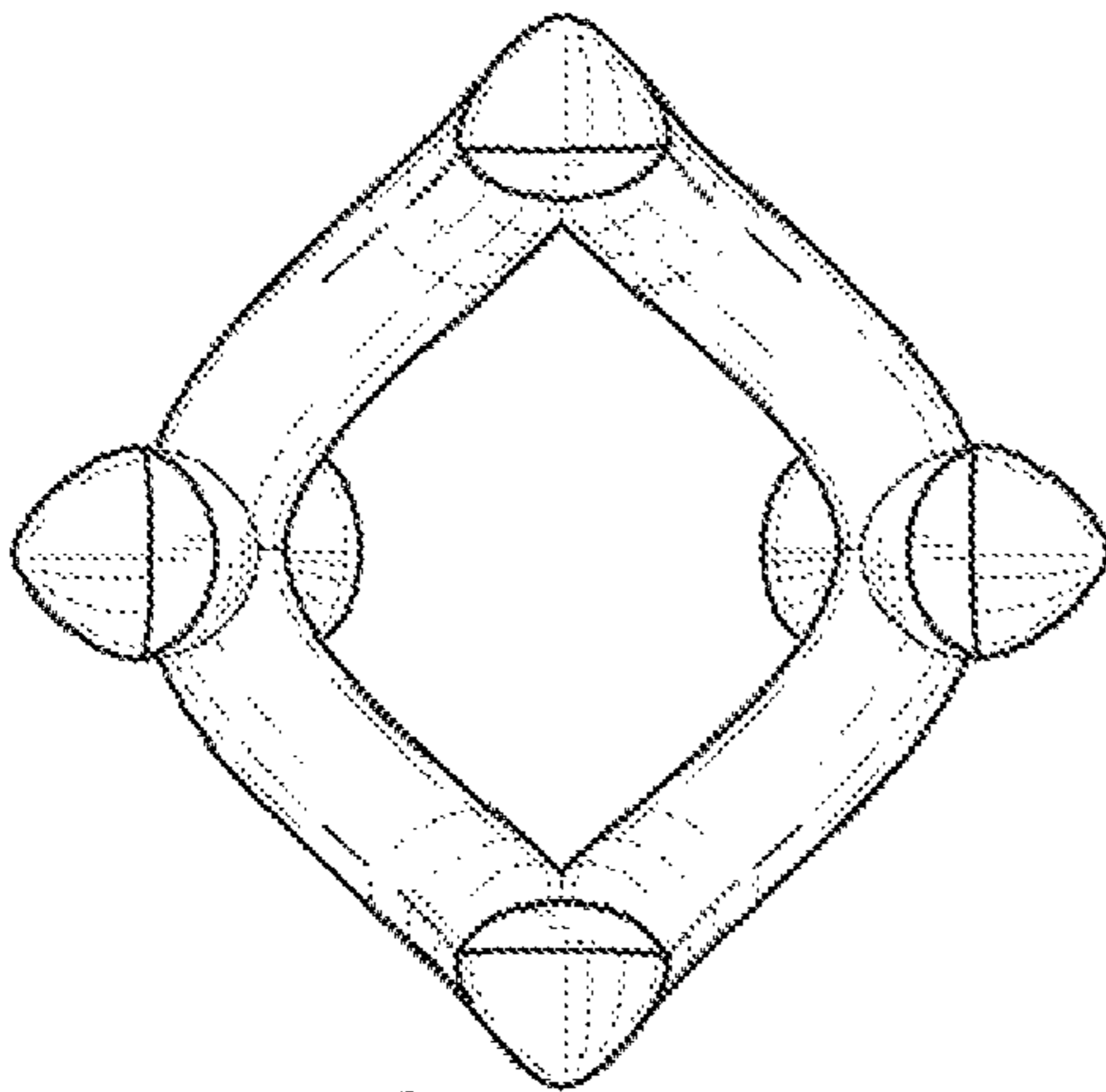

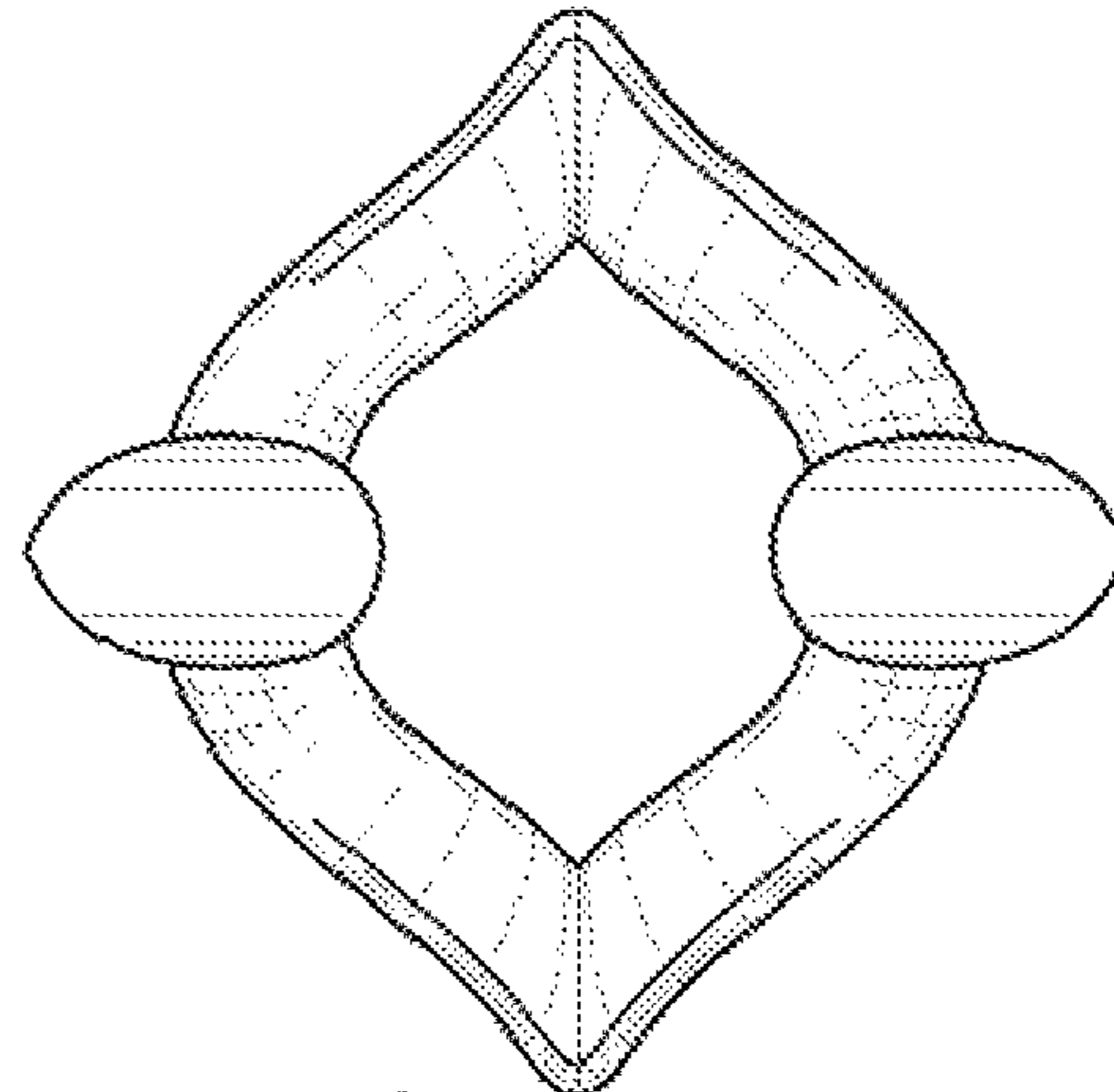

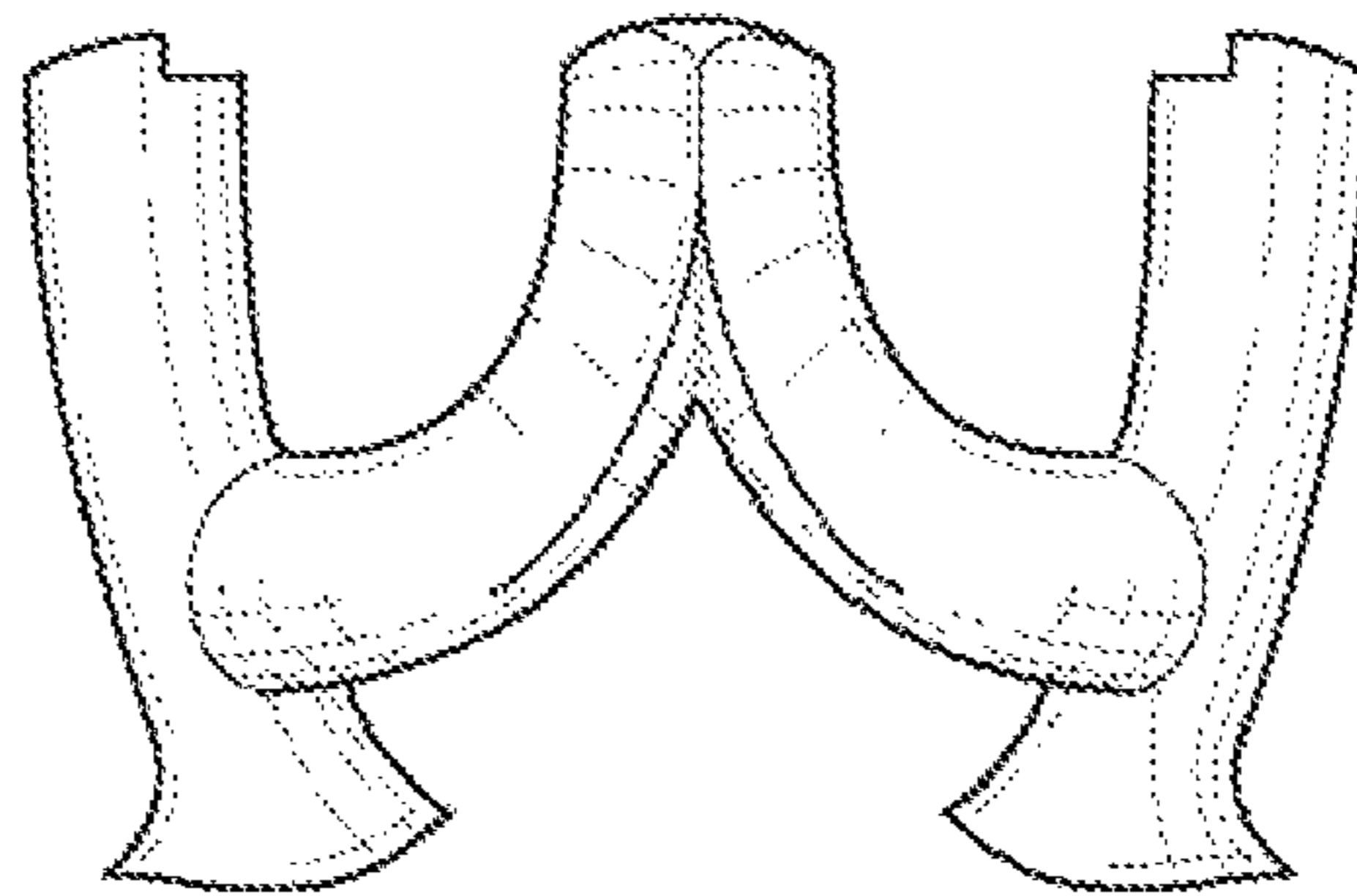
