(57) **CLAIM**

The ornamental design for an exterior protective cover for automobile rear window, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view an exterior protective cover for automobile rear window;

FIG. 2 is an isometric view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

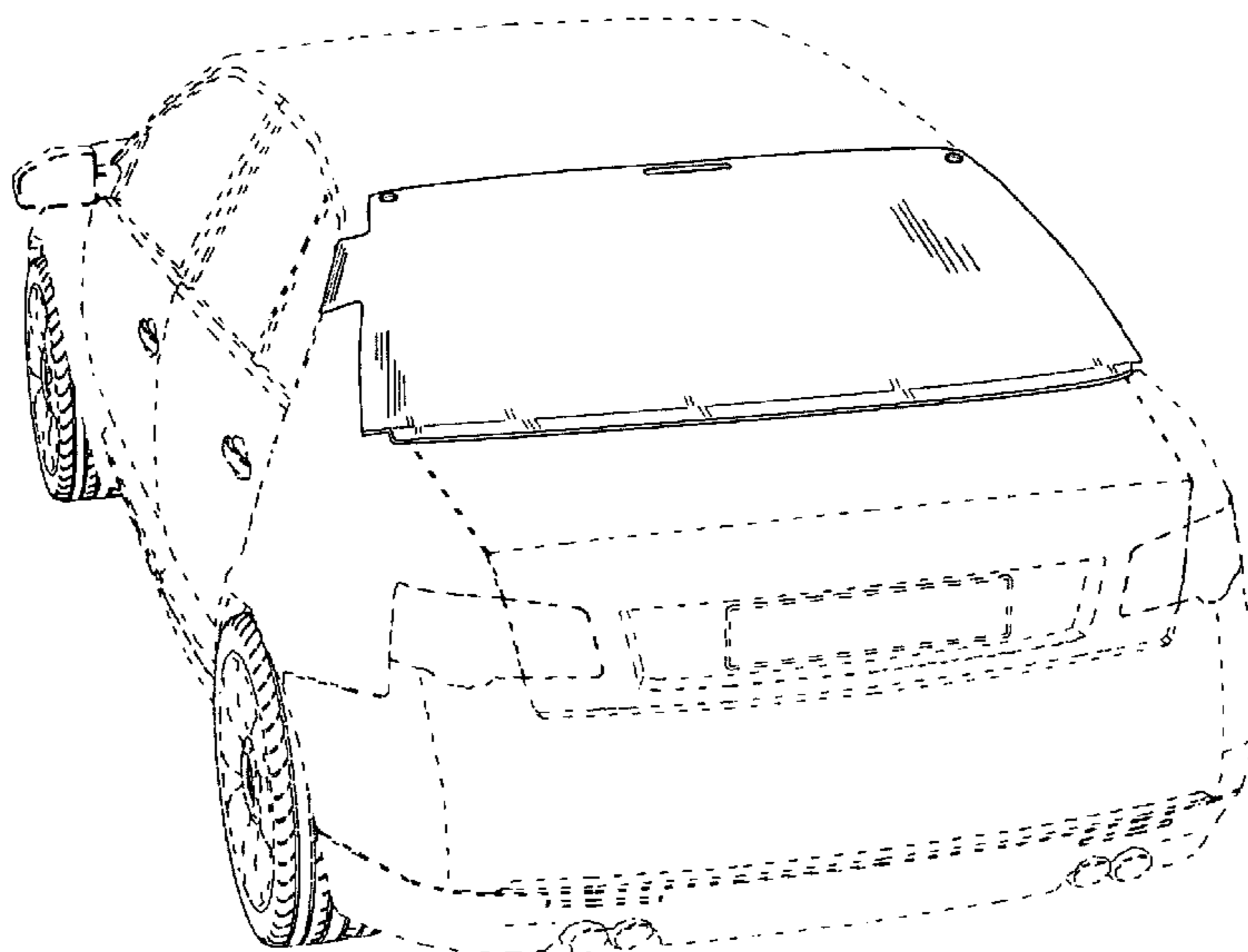
FIG. 5 is a left side view, with a right side view being a mirror image thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

For convenience of illustration, the layer on the bottom surface of the design that contacts the rear window as shown in FIG. 7 is understood to represent a layer which continues across the bottom surface.

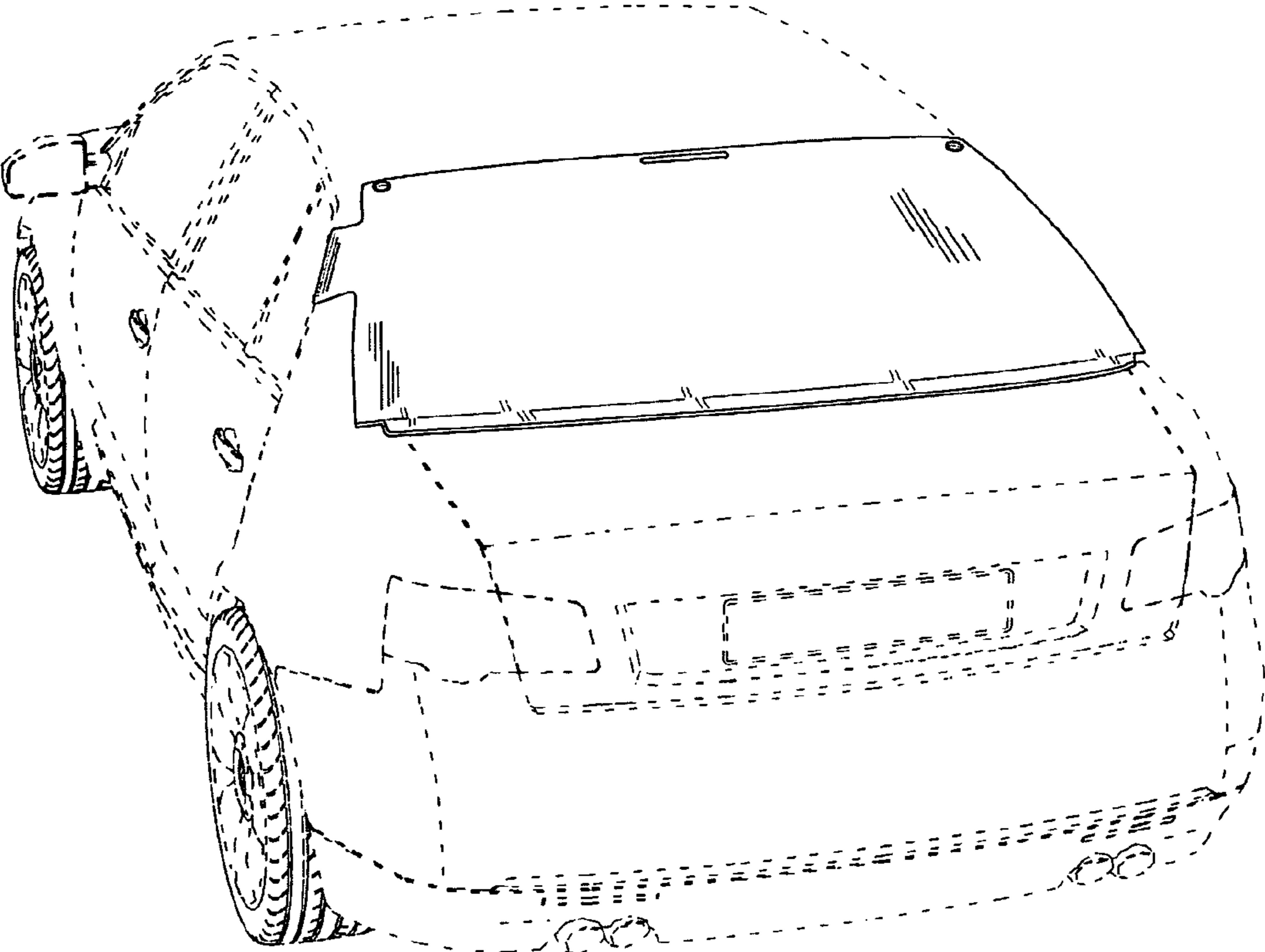

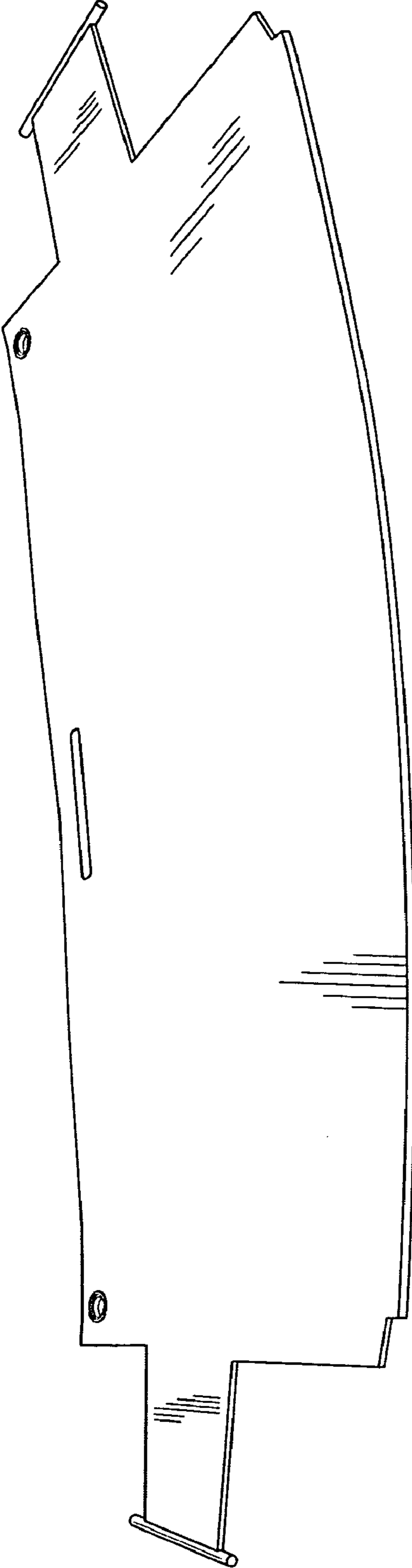

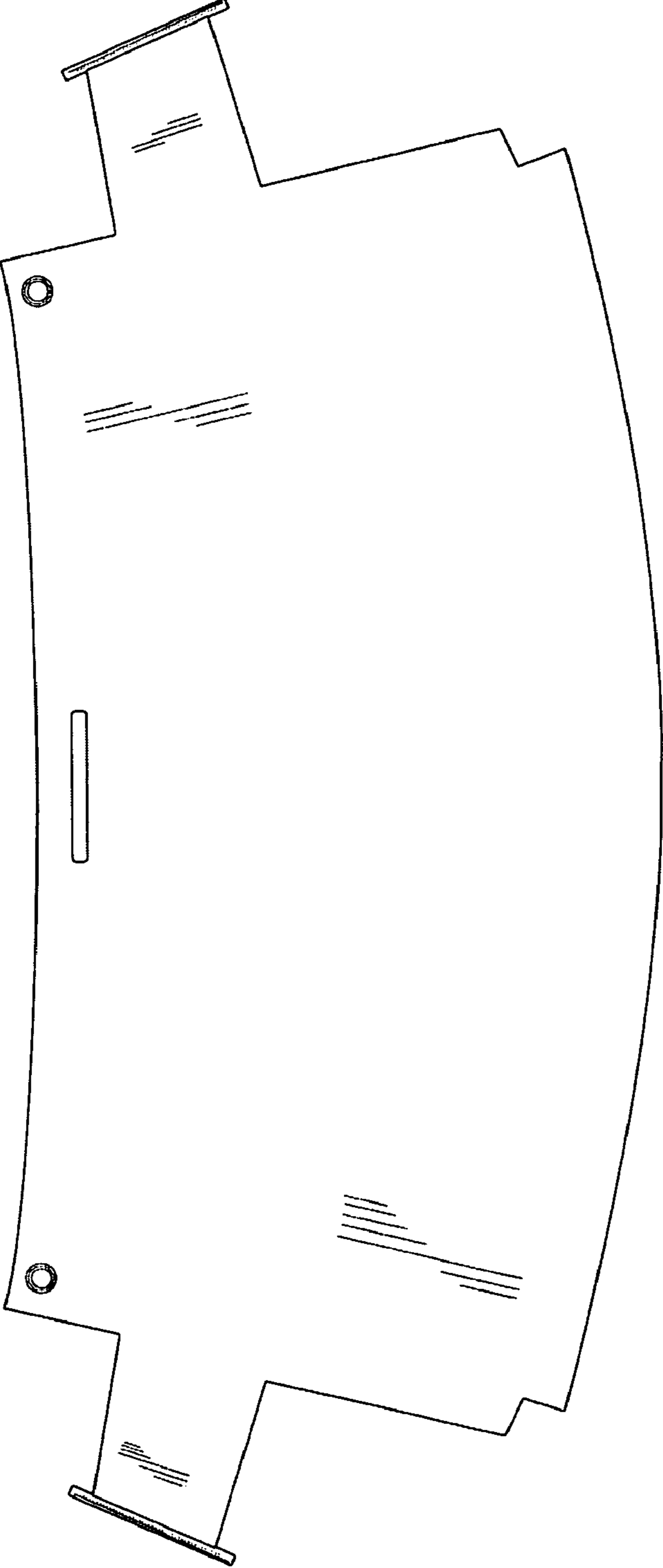

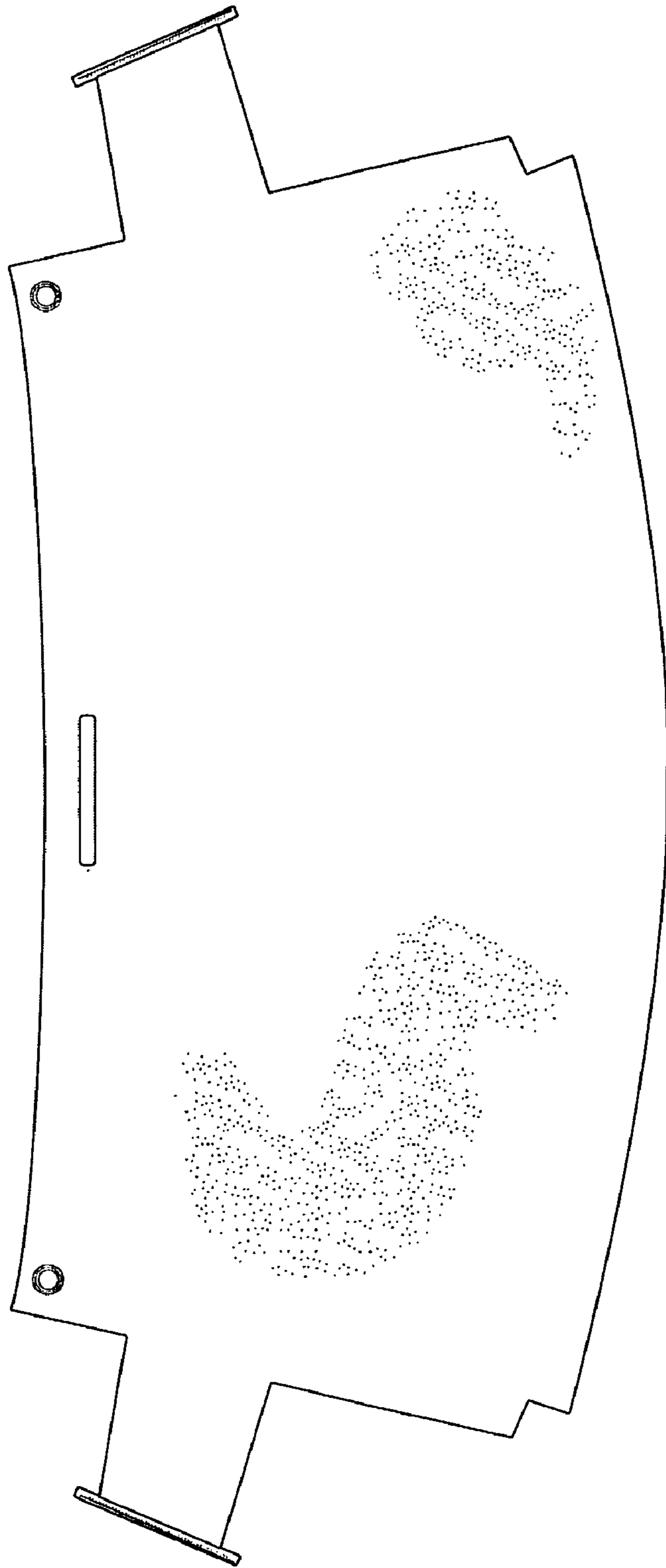
