FIG. 4 is a left-side, elevational view thereof.

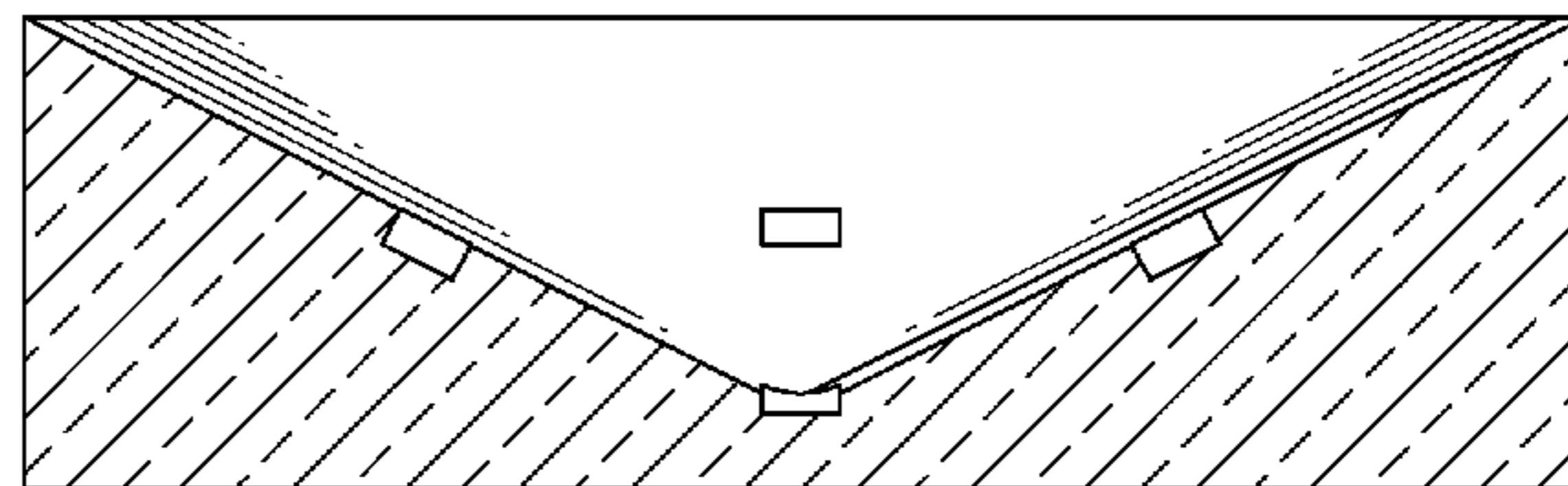
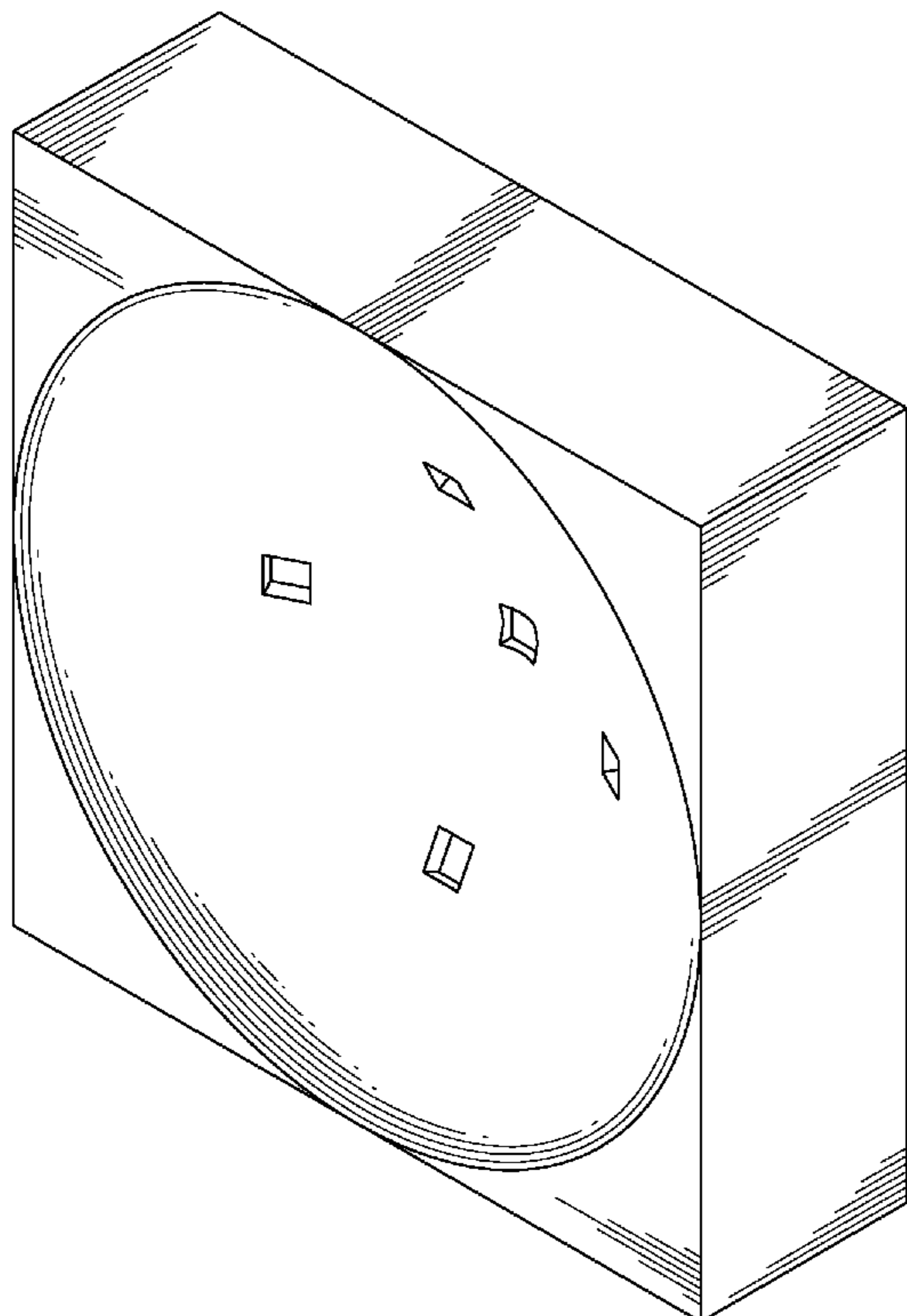
FIG. 5 is a right-side, elevational view thereof.

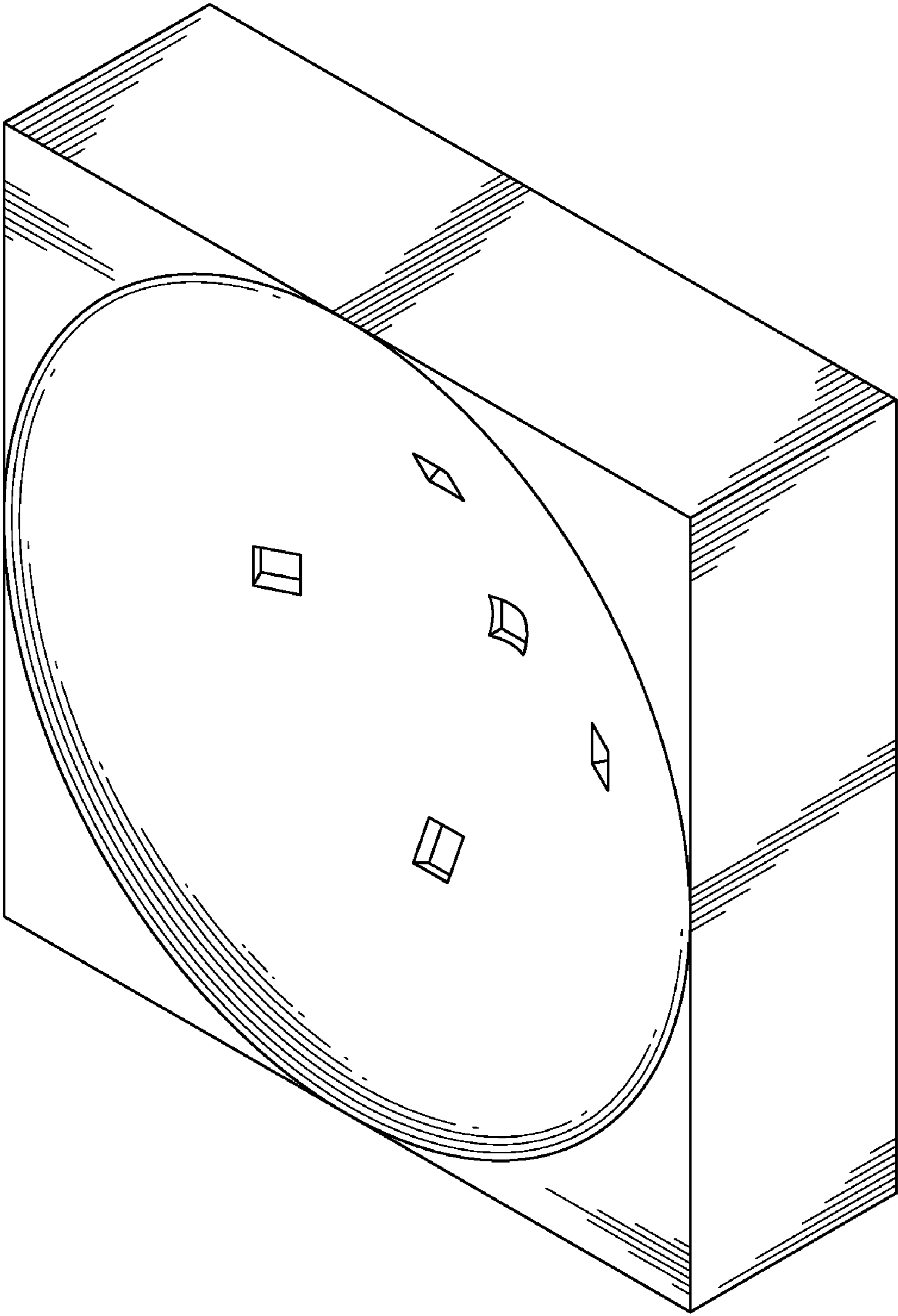

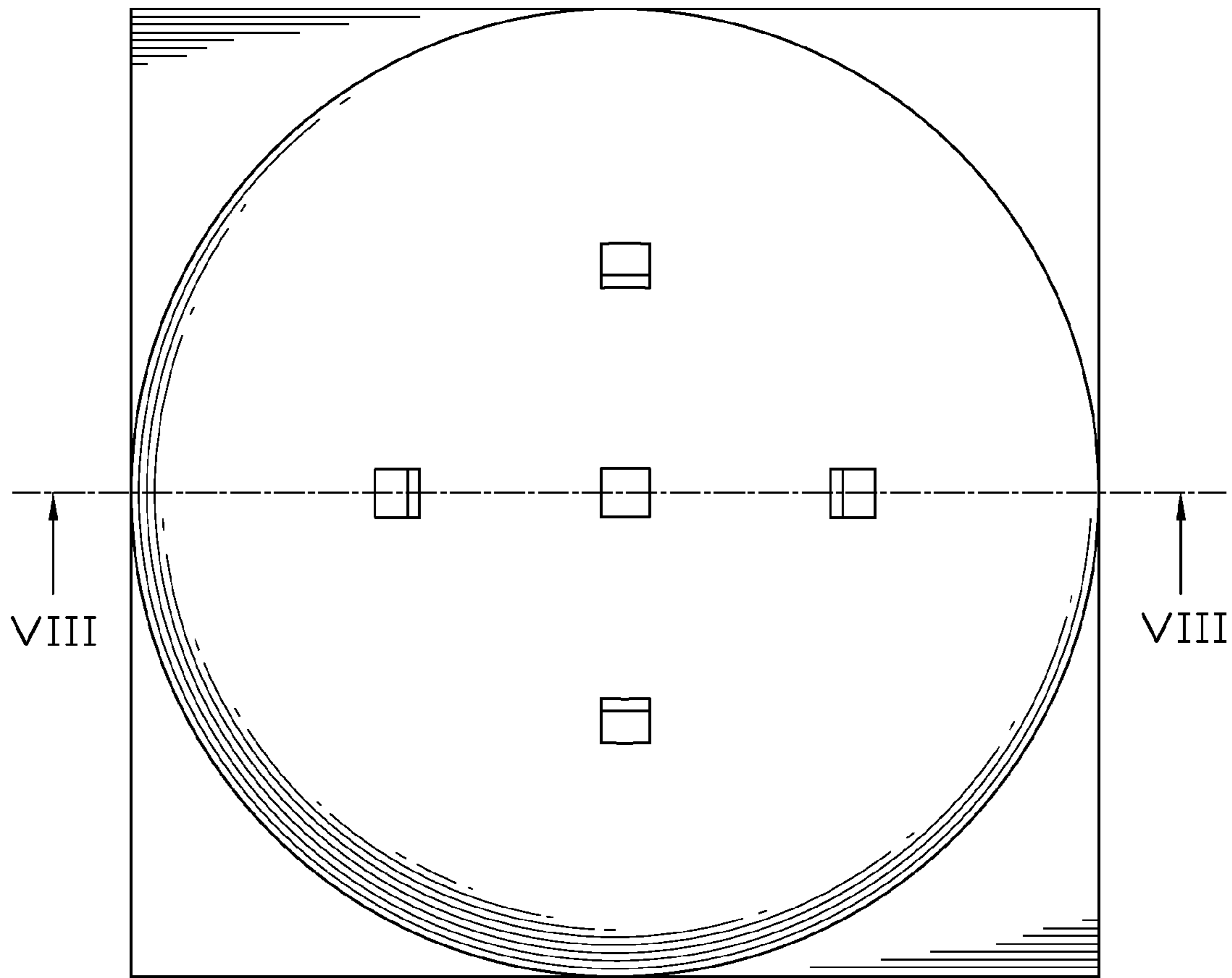

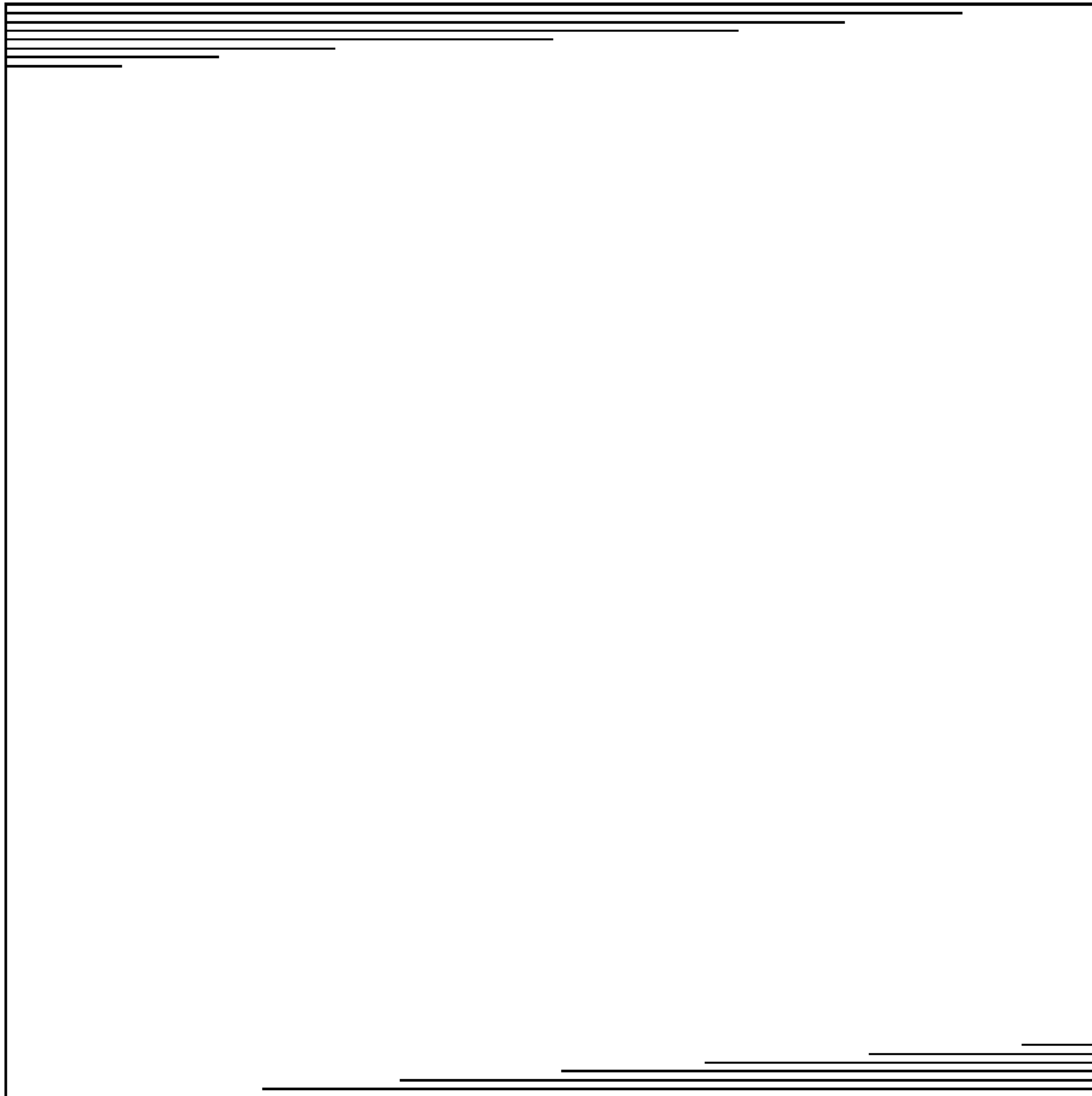

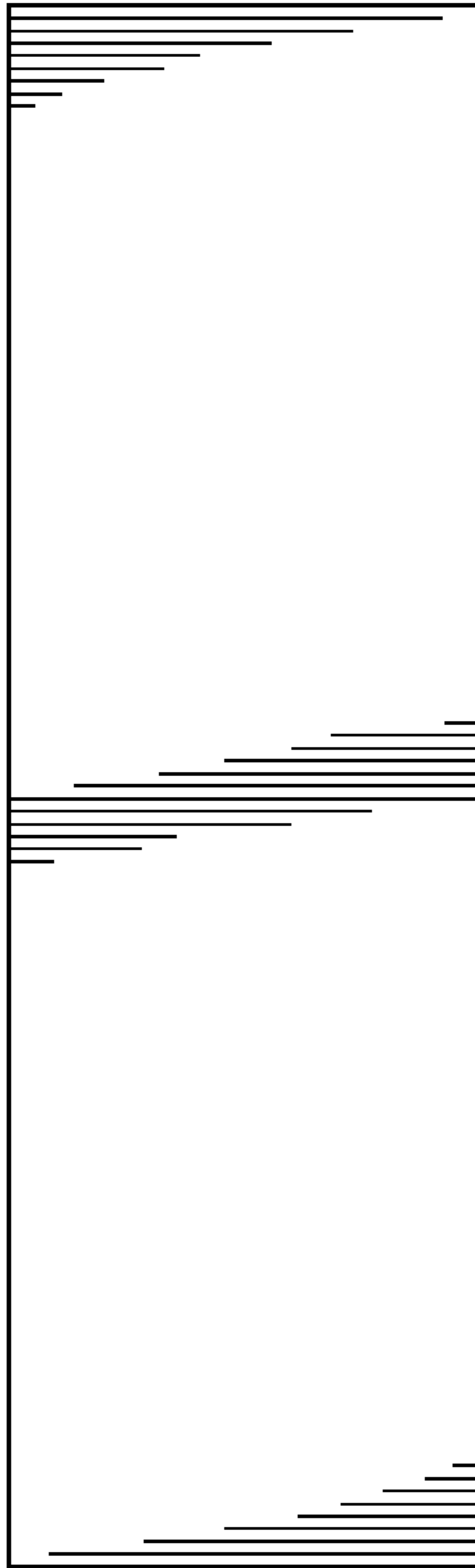

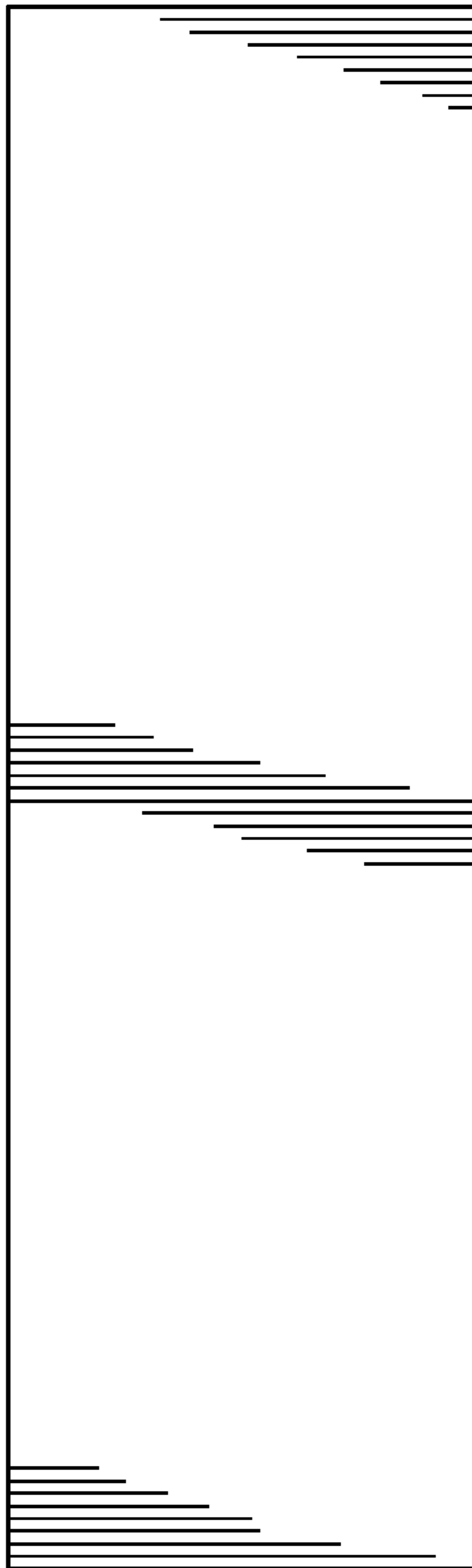

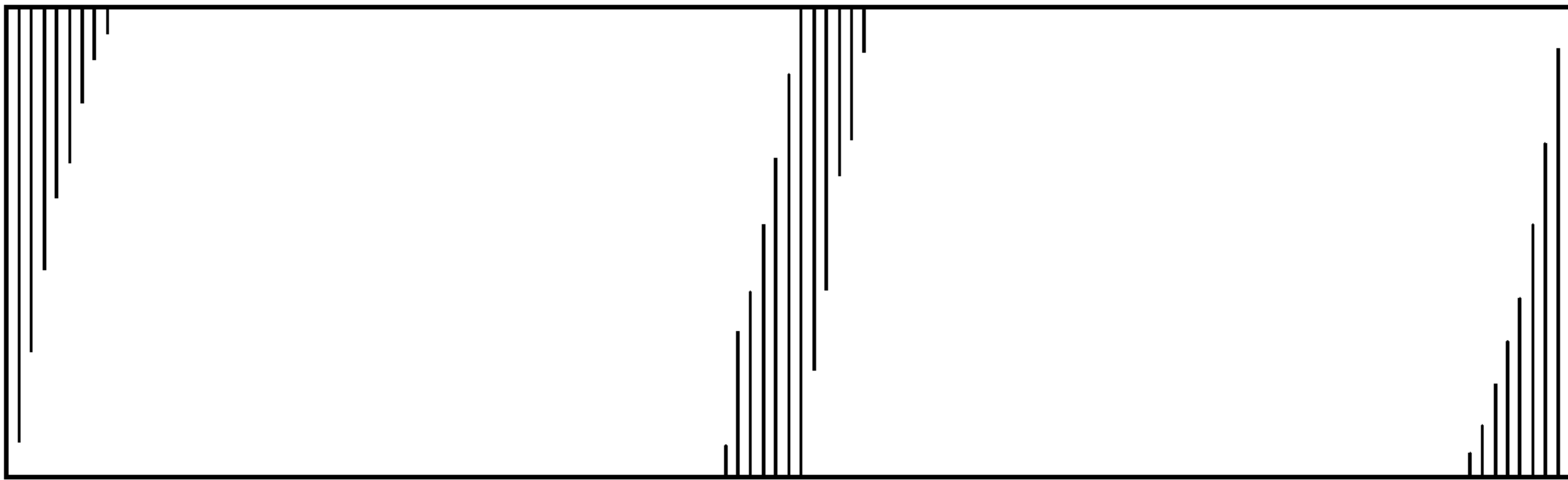

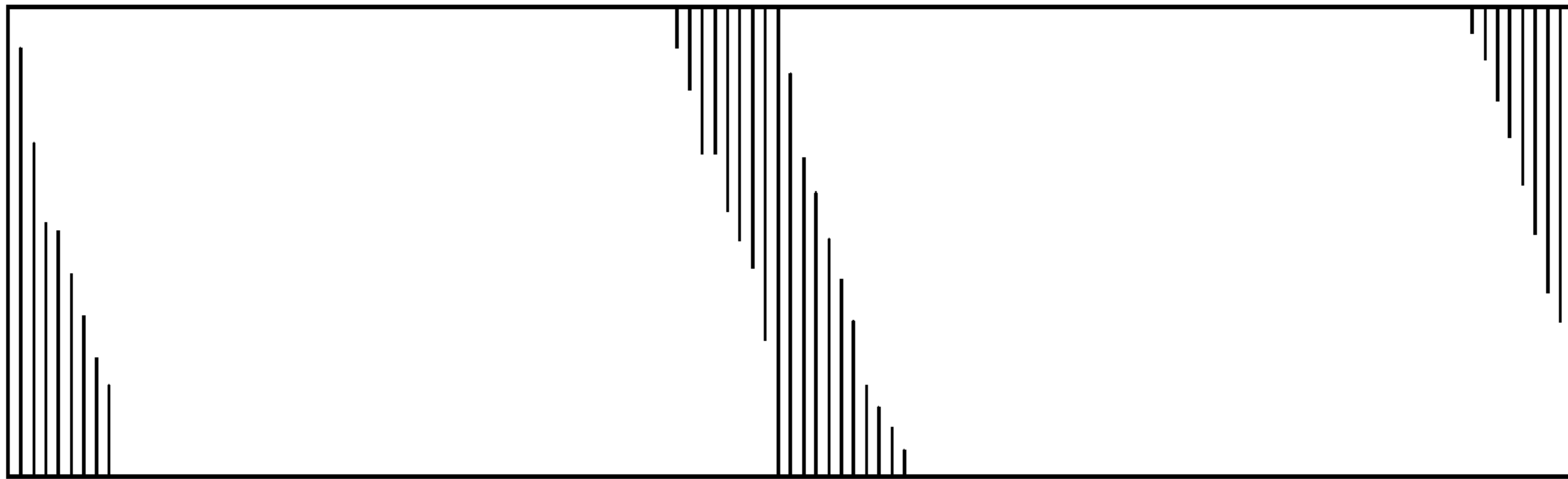

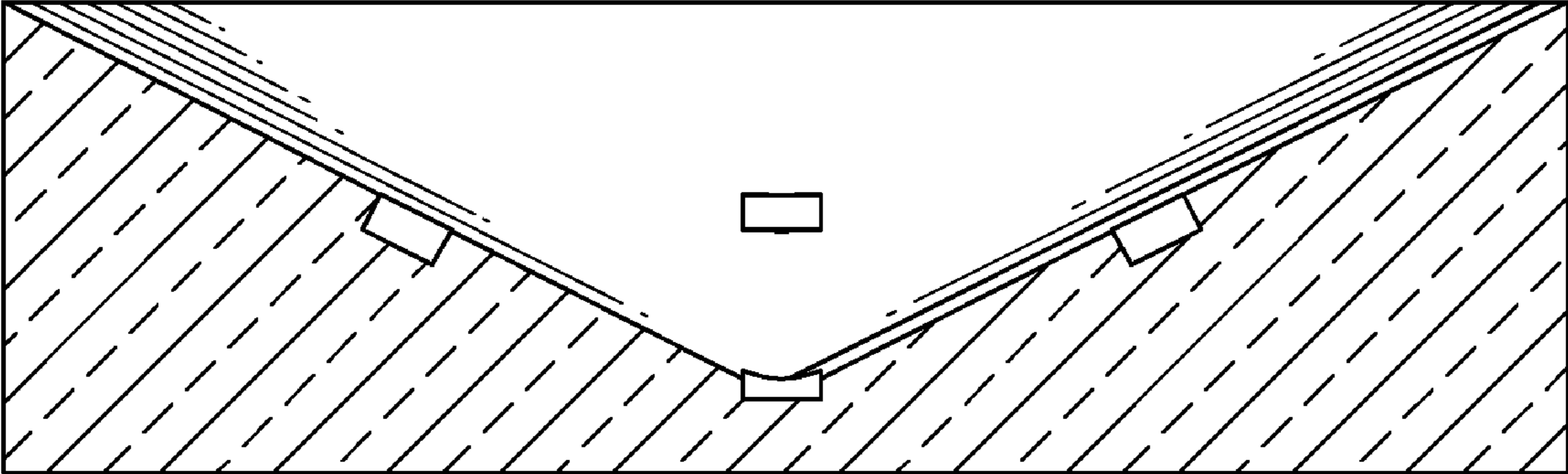
