(57) **CLAIM**

The ornamental design for a lamp socket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above of the lamp socket according to the invention;

FIG. 2 is a perspective view from below of the lamp socket;

FIG. 3 is a bottom view of the lamp socket;

FIG. 4 is a side view of the lamp socket from above in

FIG. 4, the opposite side being identical;

FIG. 5 is a side view of the lamp socket taken from the left in

FIG. 6, the opposite side being identical; and,

FIG. 6 is a top view of the lamp socket.

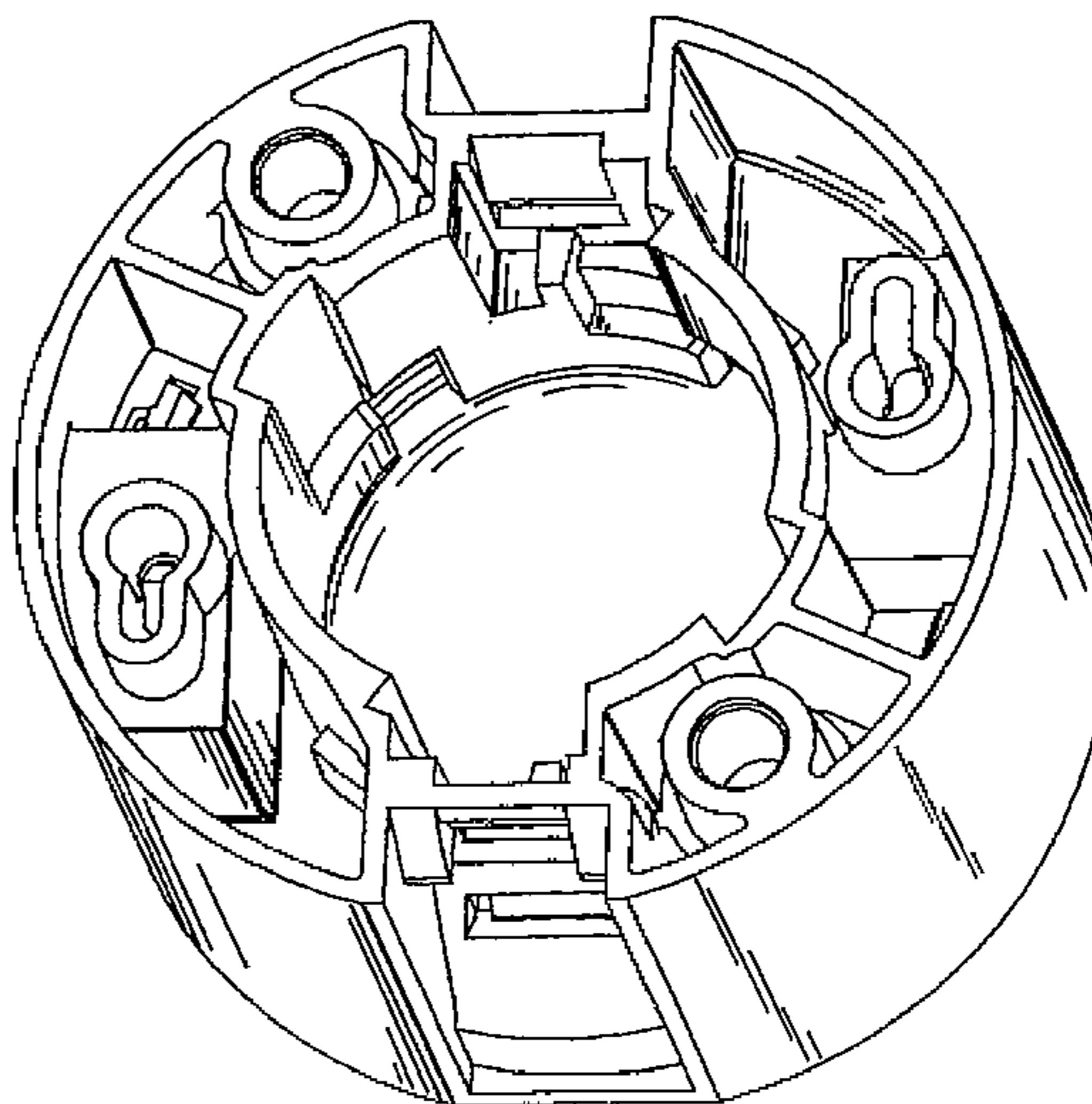
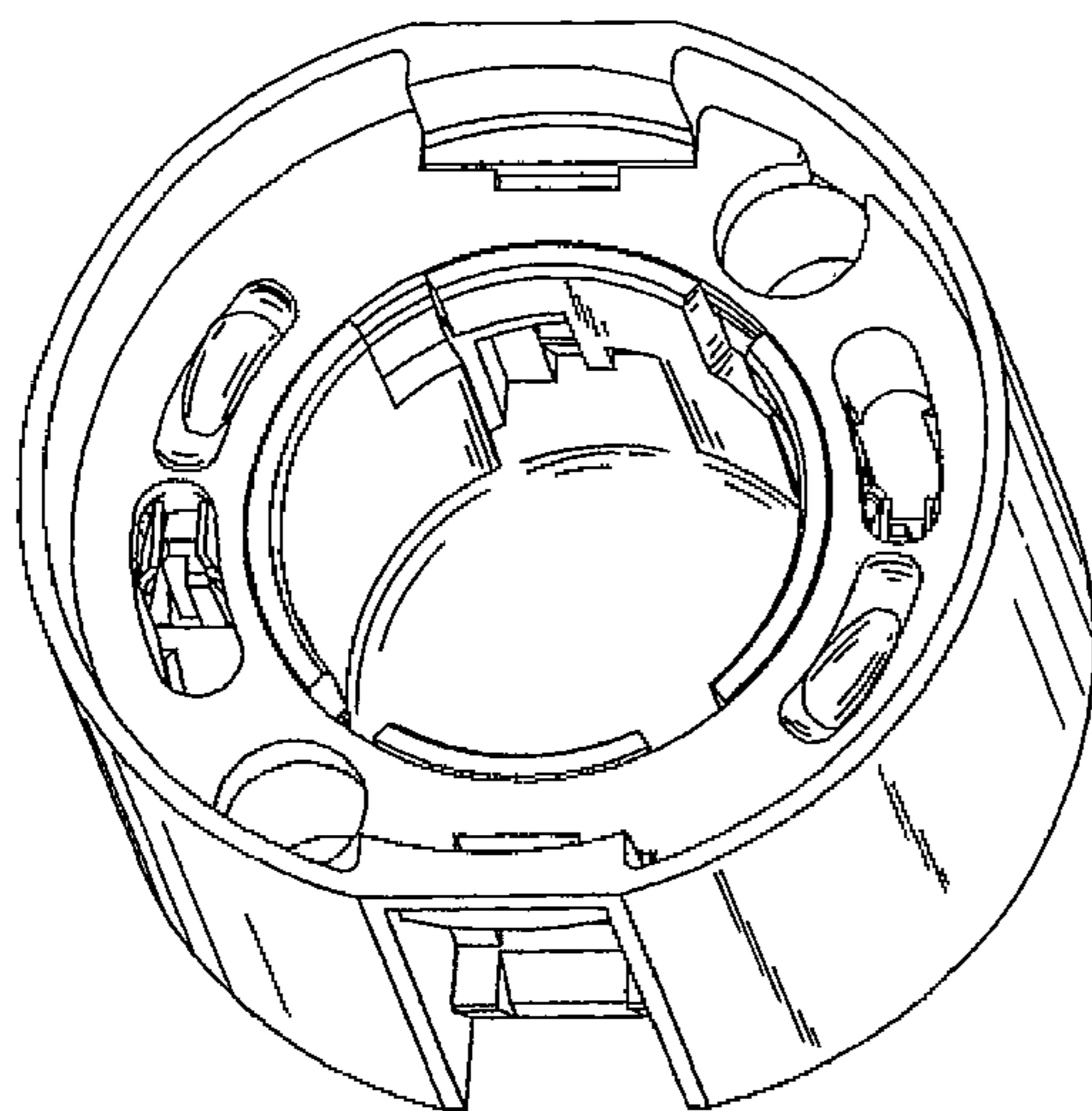

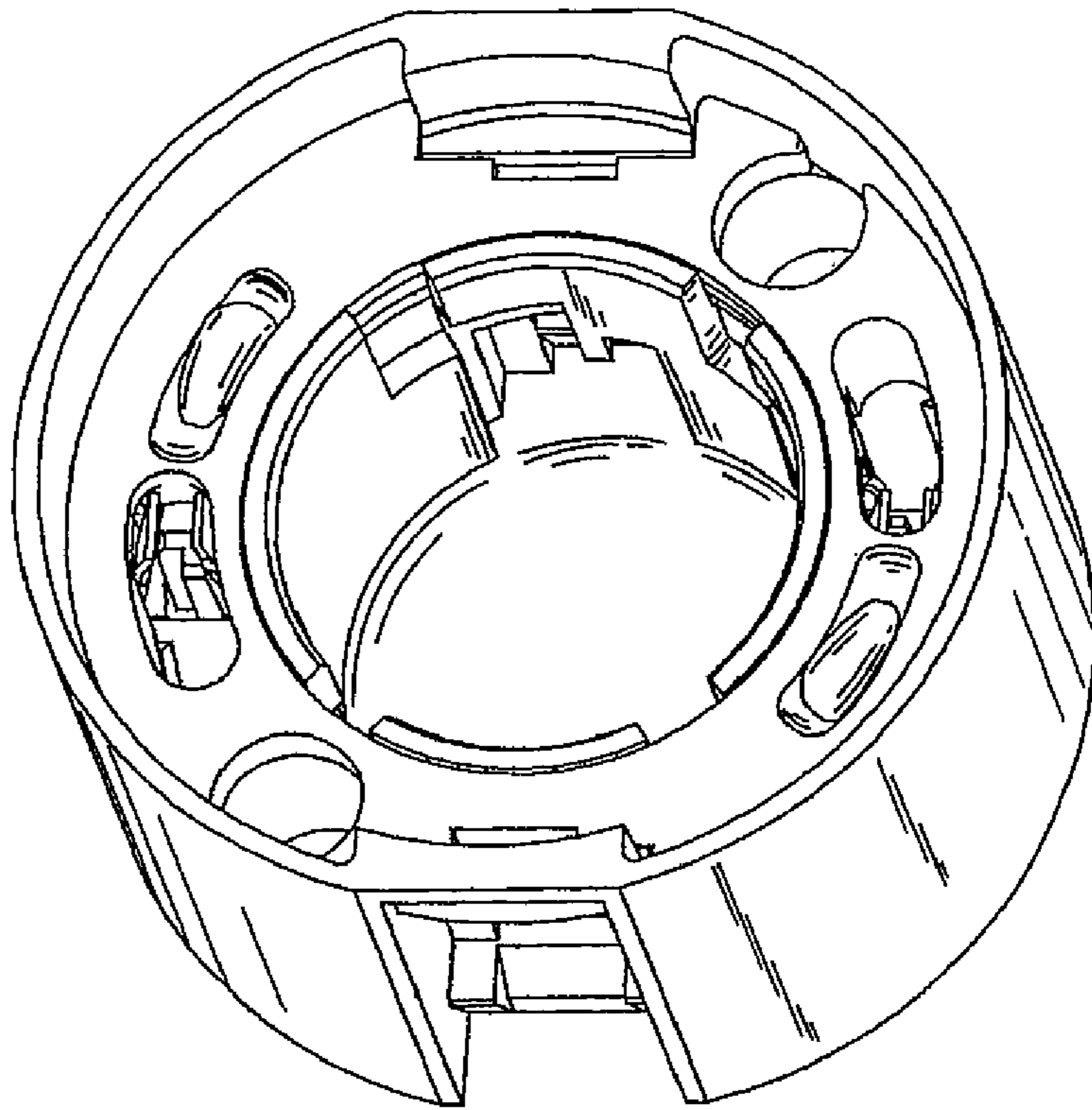

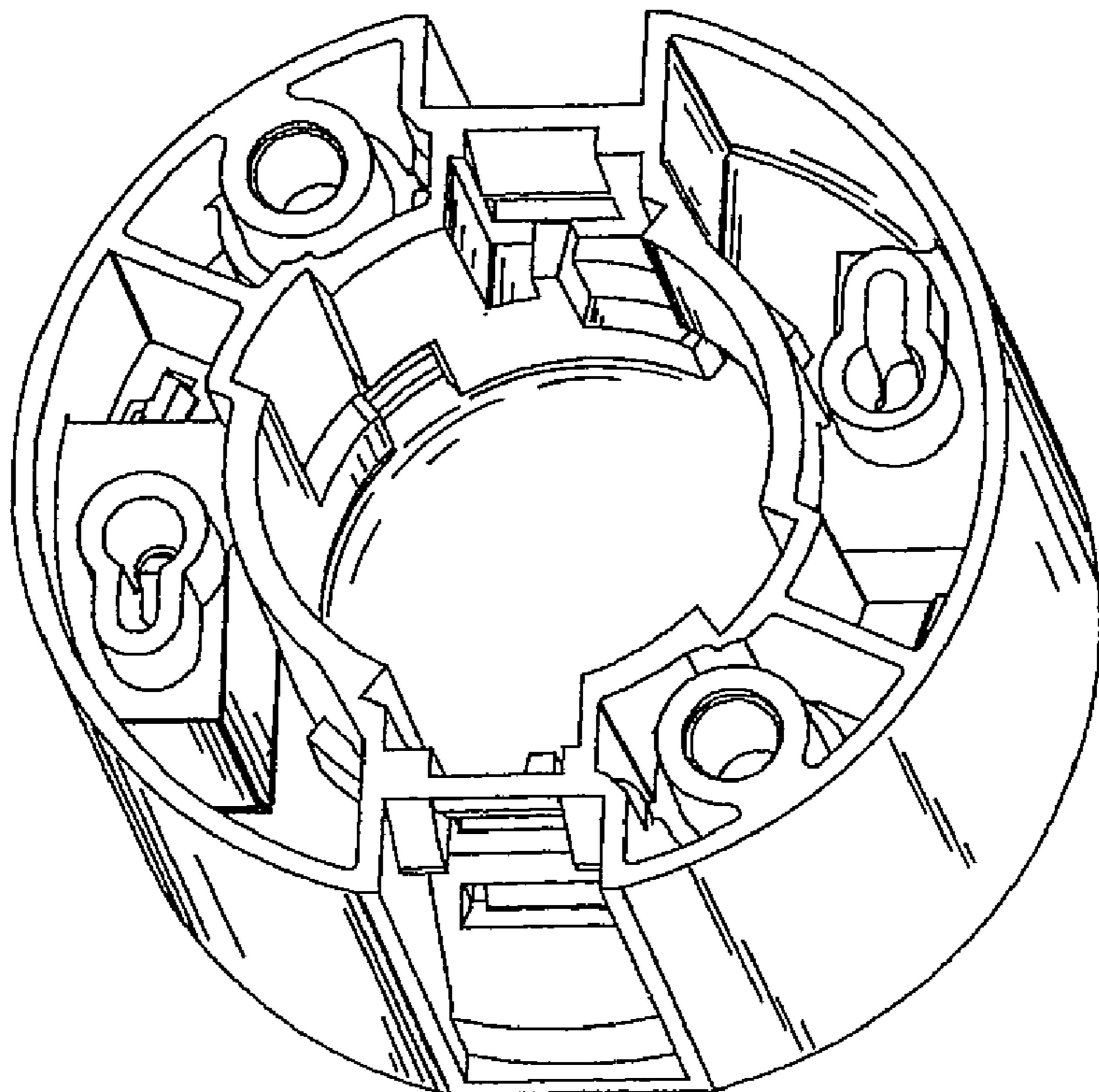

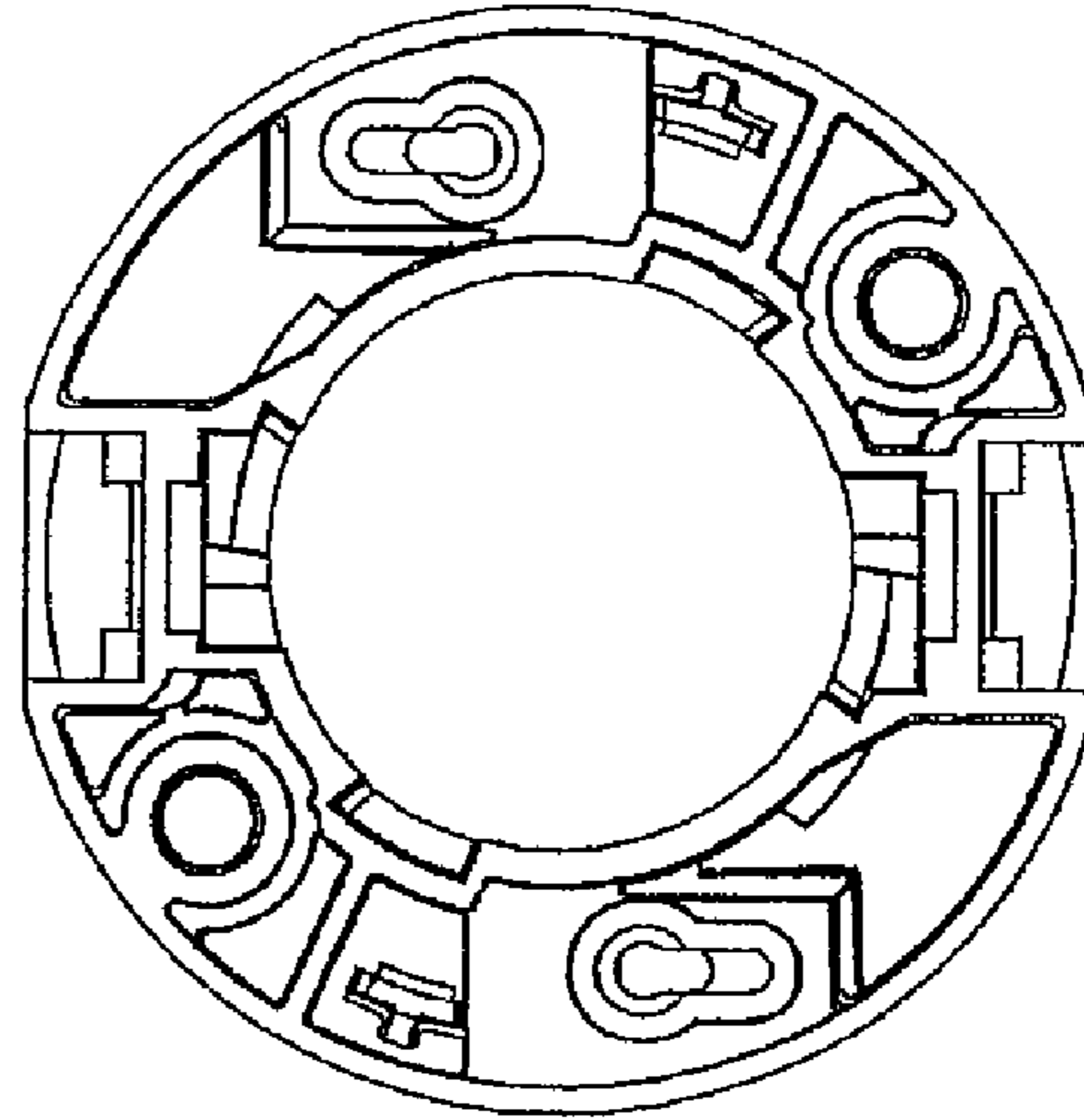

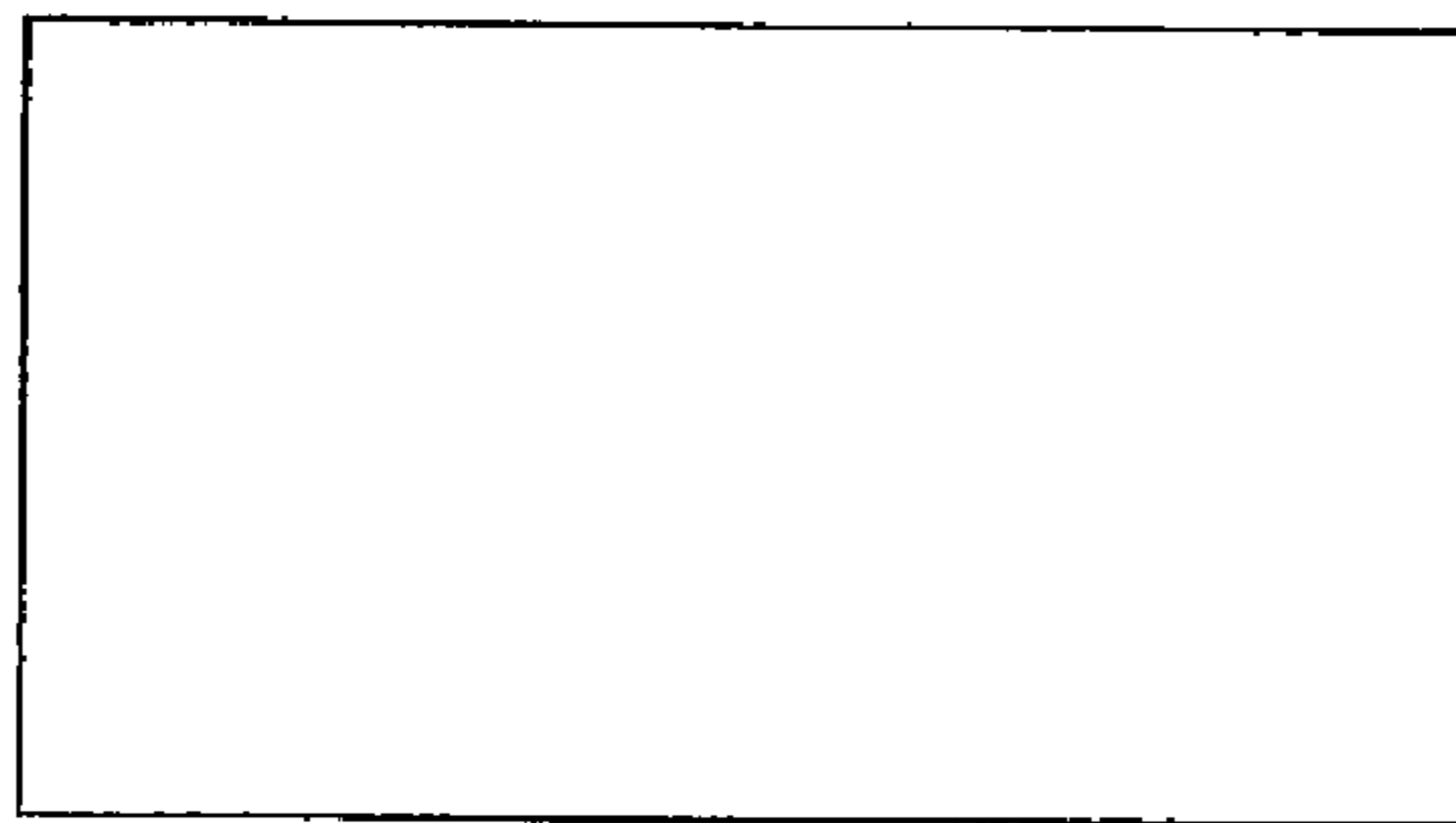

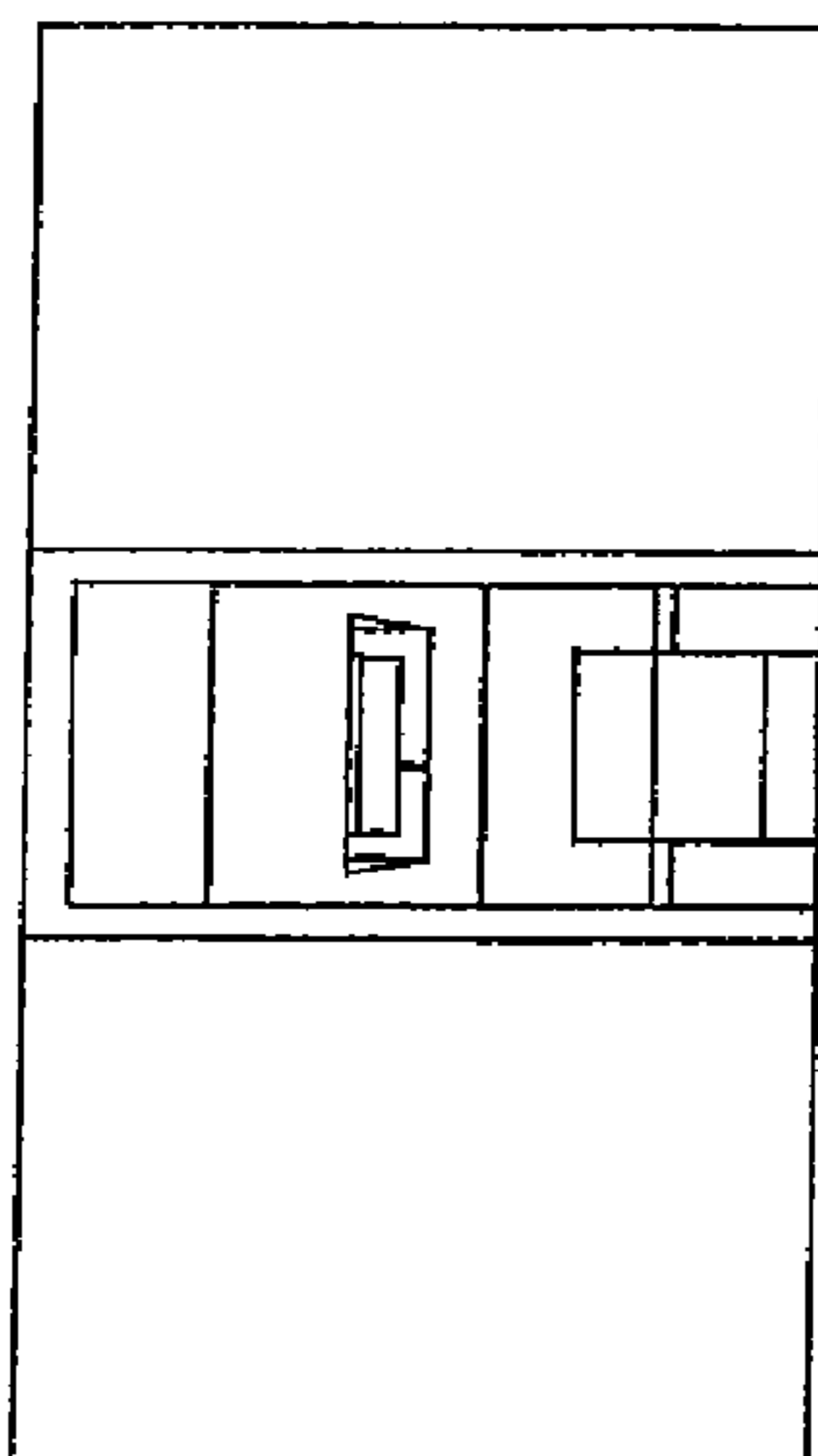
