**DESCRIPTION**

FIG. 1 is a front right top perspective view of an earphone showing my new design;

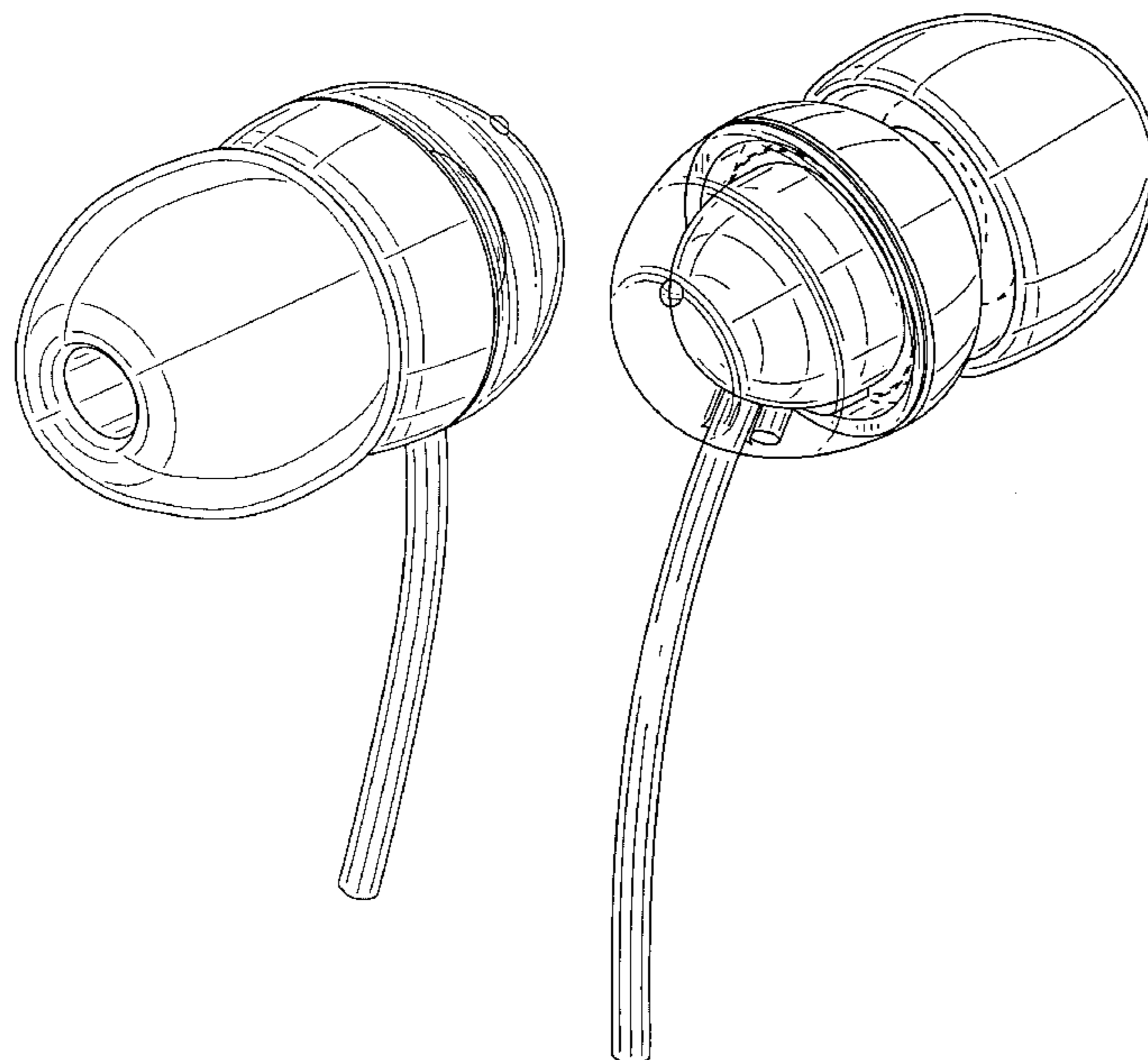

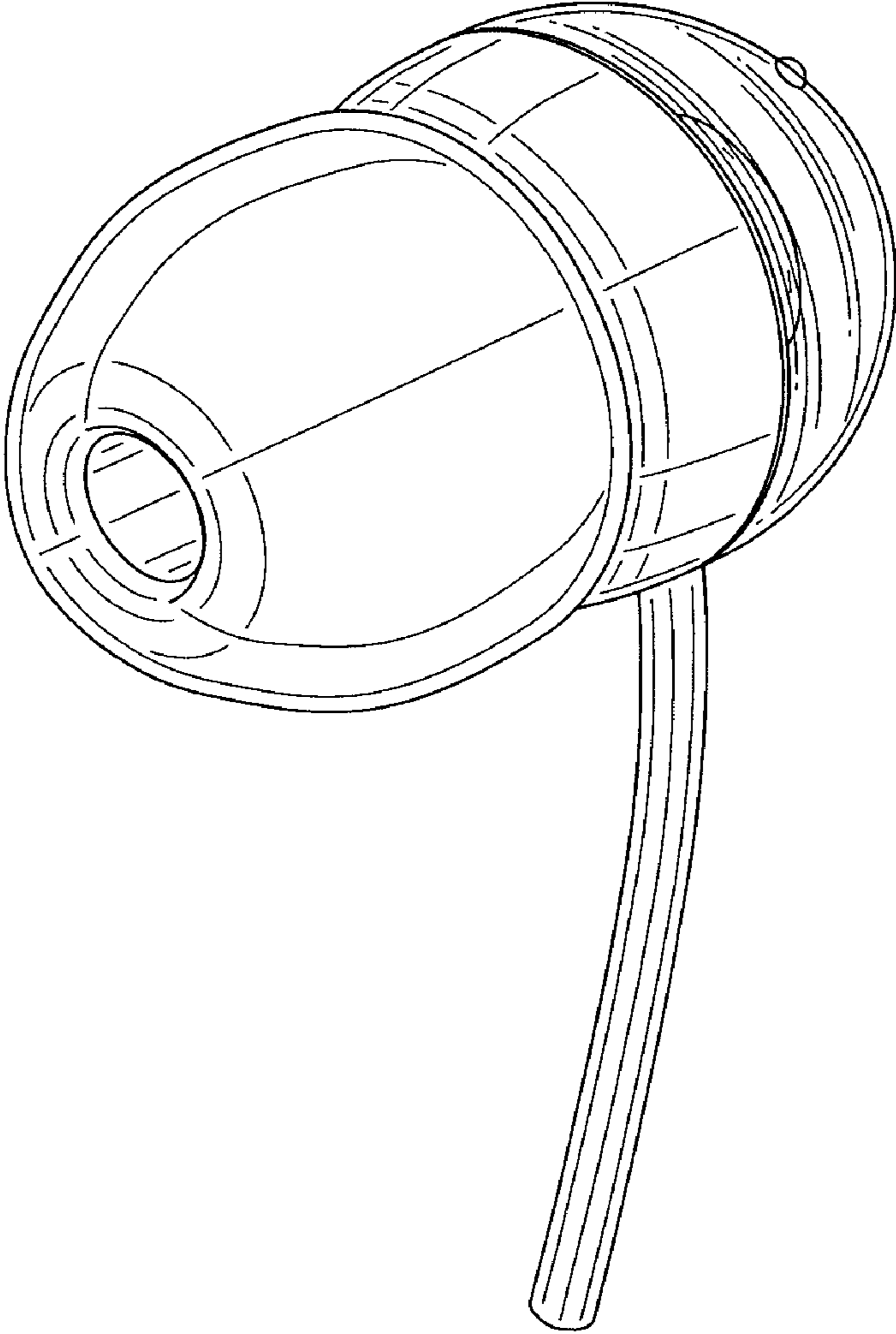

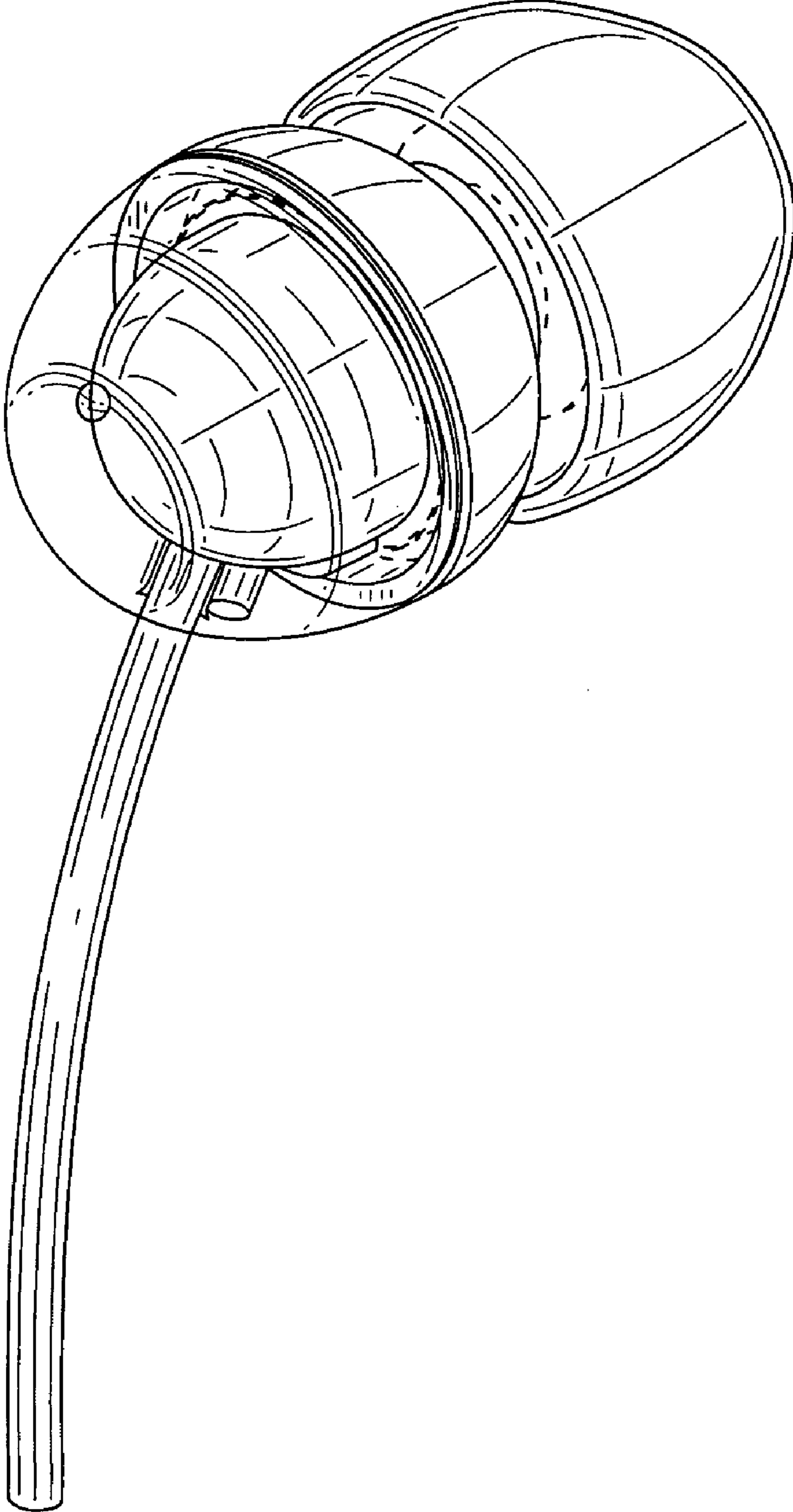

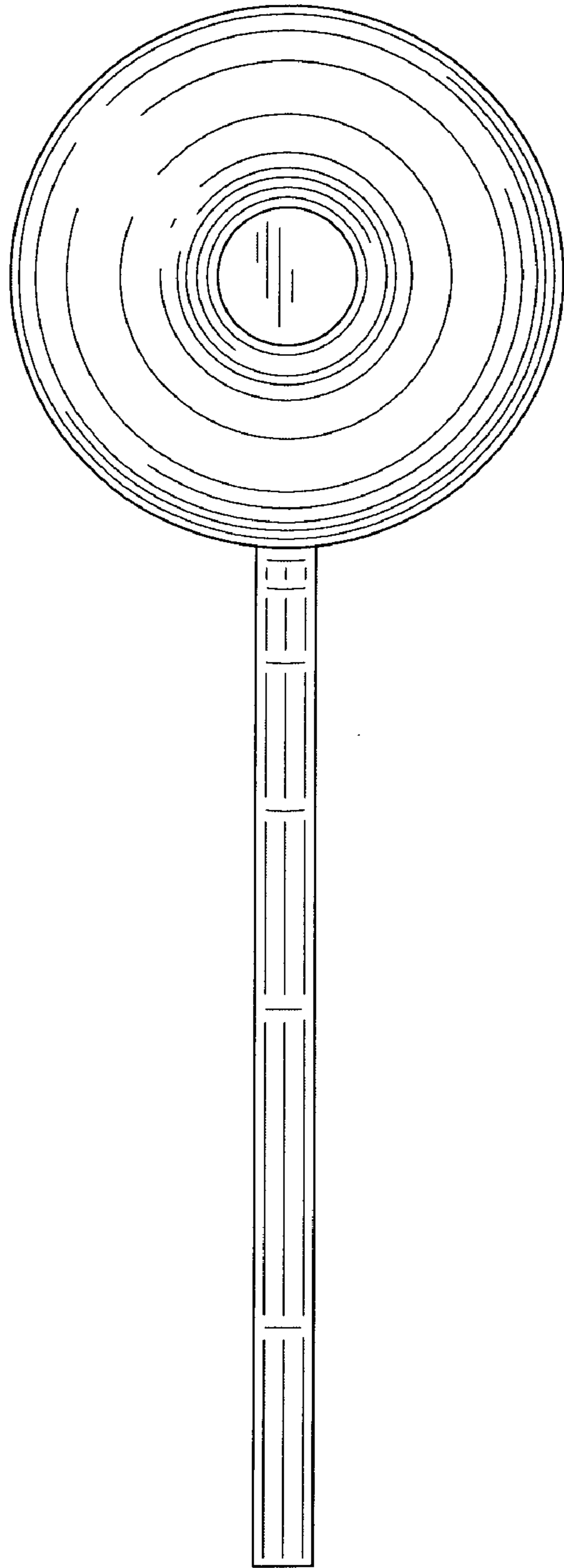

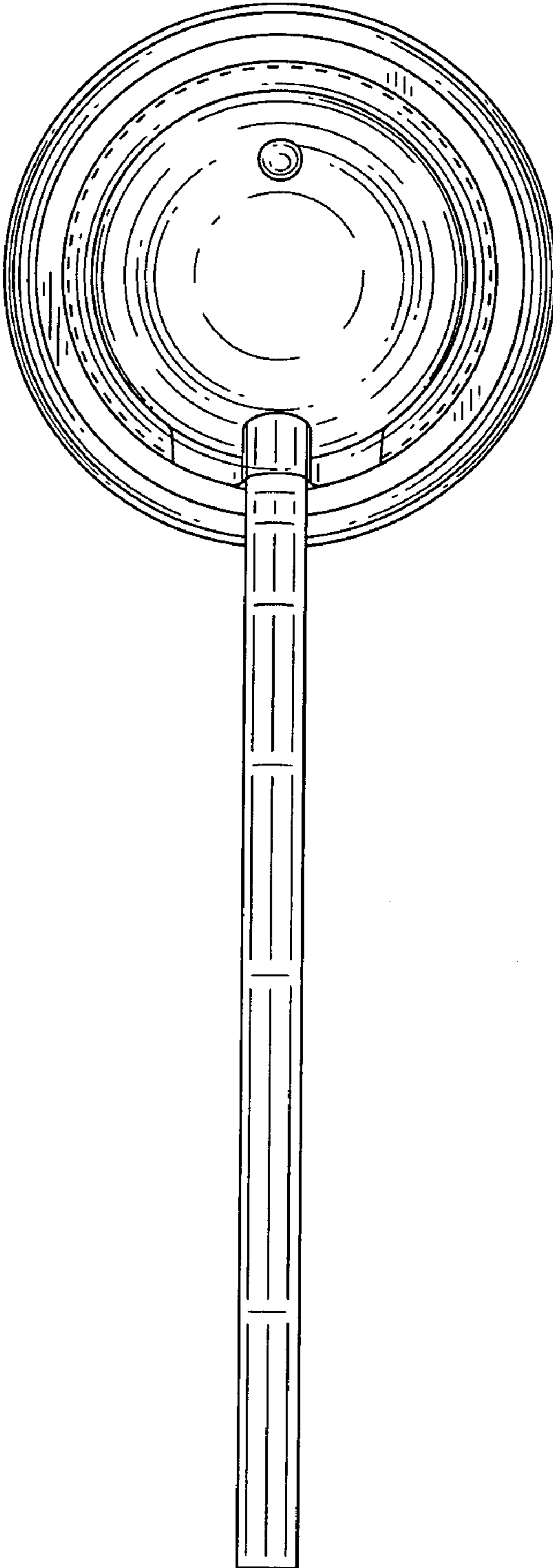

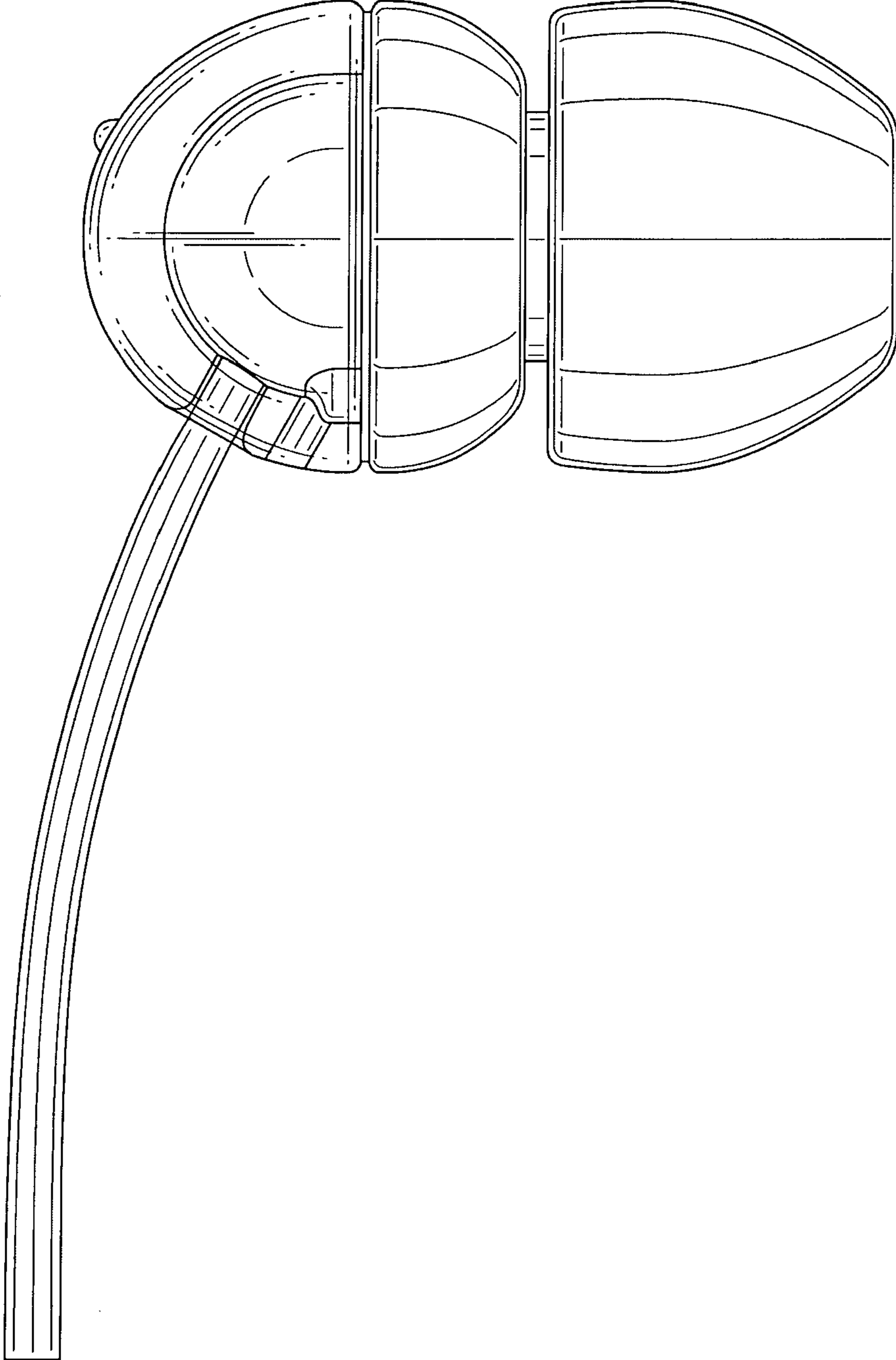

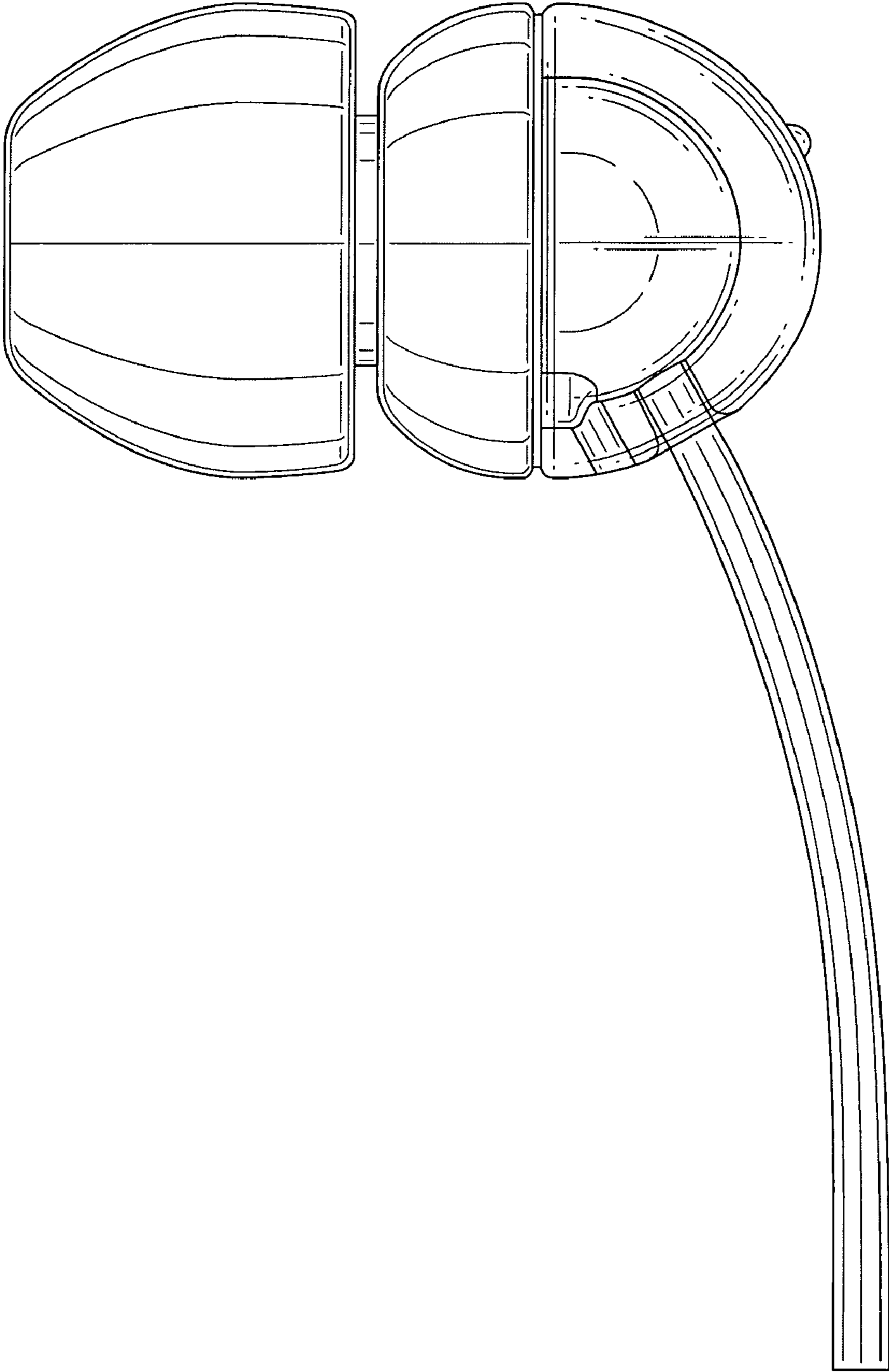

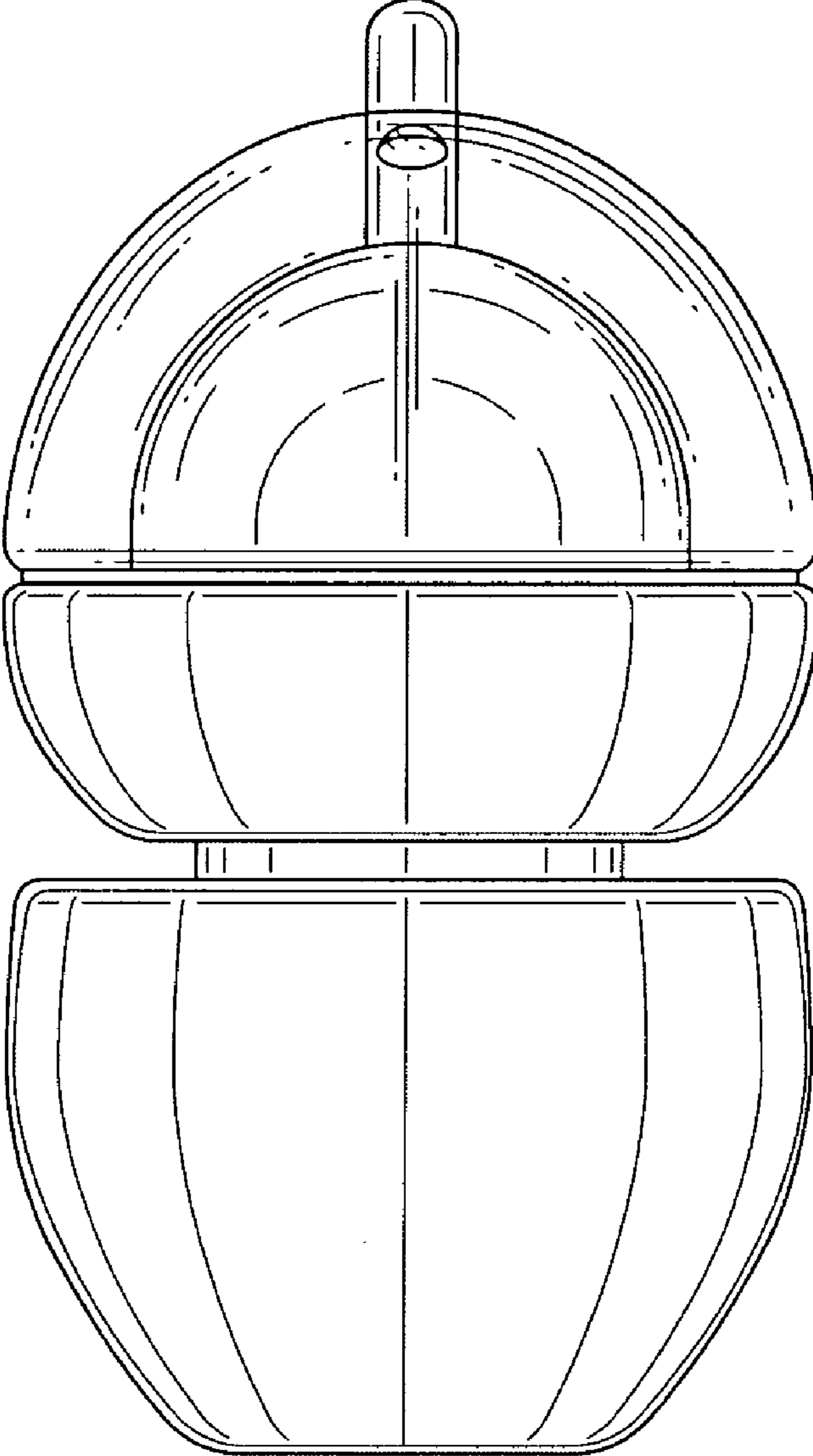
