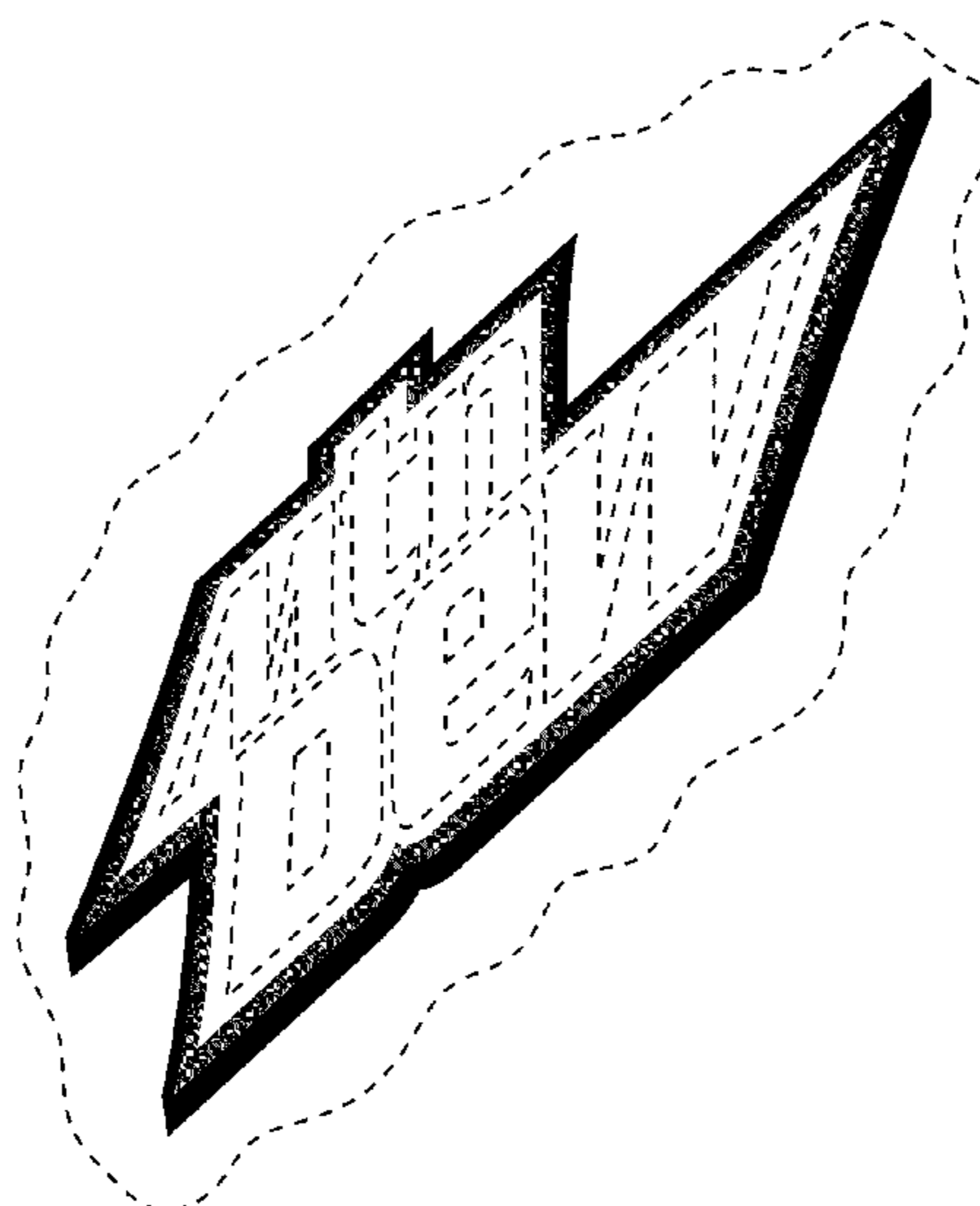
The ornamental design for display screen with icon or packaging with surface ornamentation, as shown and described.

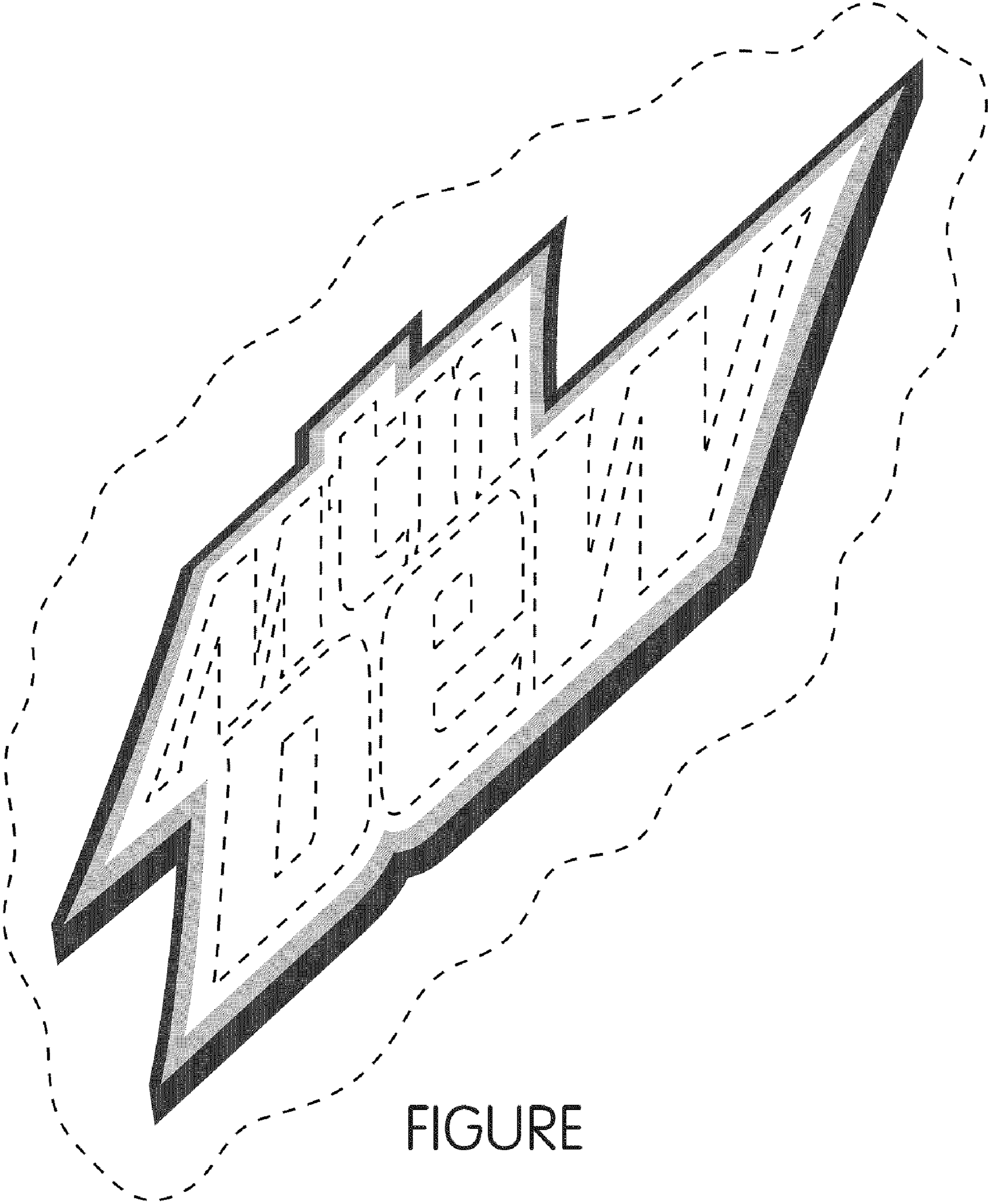
DESCRIPTION
