The ornamental design for a toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toy in a collapsed configuration, showing my new design;

FIG. 2 is a perspective view showing the toy in an extended configuration;

FIG. 3 is a front elevational view of the toy in a collapsed configuration;

FIG. 4 is a front elevational view of the toy in an extended configuration;

FIG. 5 is a rear elevational view of the toy in a collapsed configuration;

FIG. 6 is a rear elevational view of the toy in an extended configuration;

FIG. 7 is a left side elevational view of the toy in a collapsed configuration;

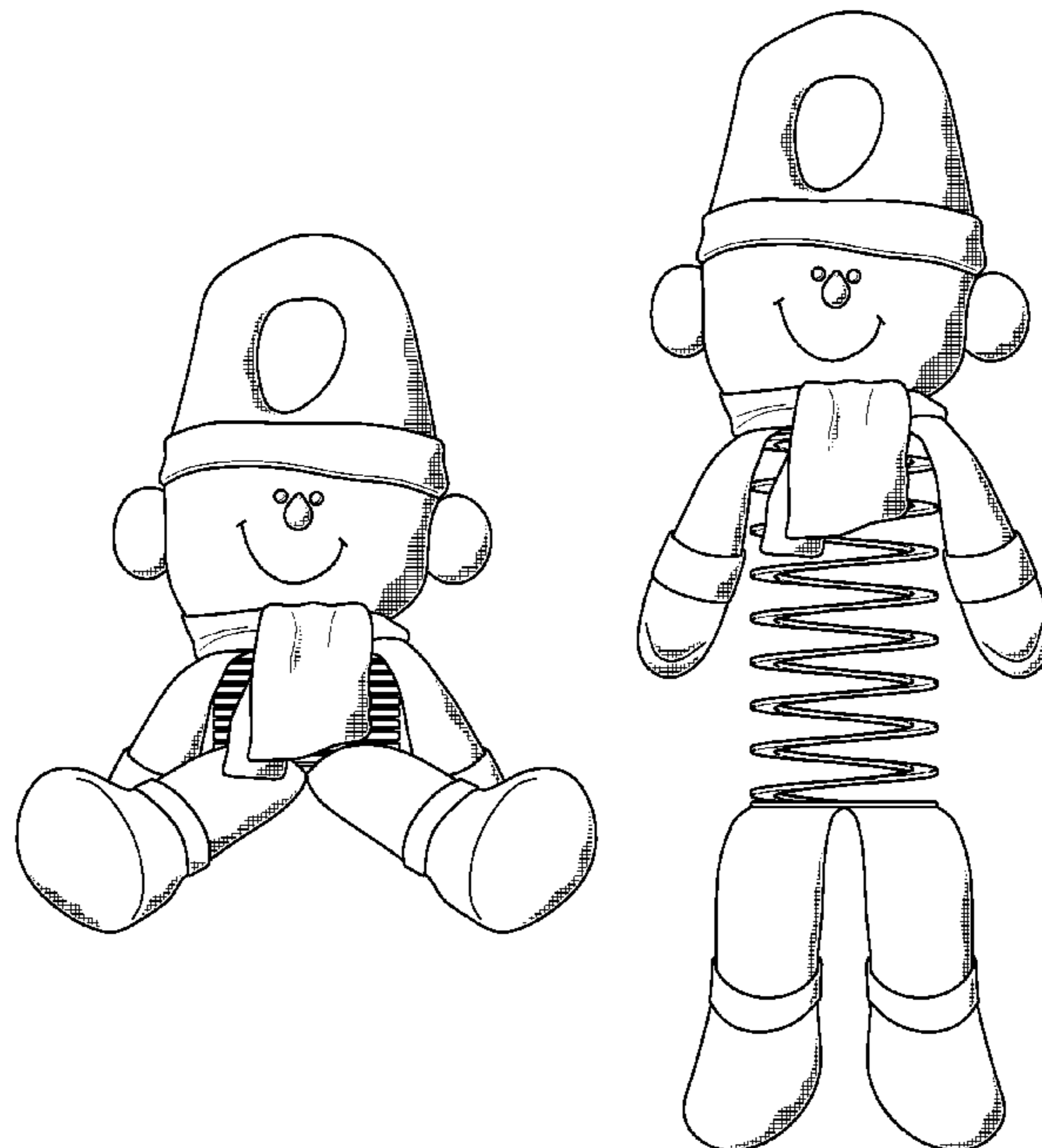
FIG. 8 is a left side elevational view of the toy in an extended configuration;

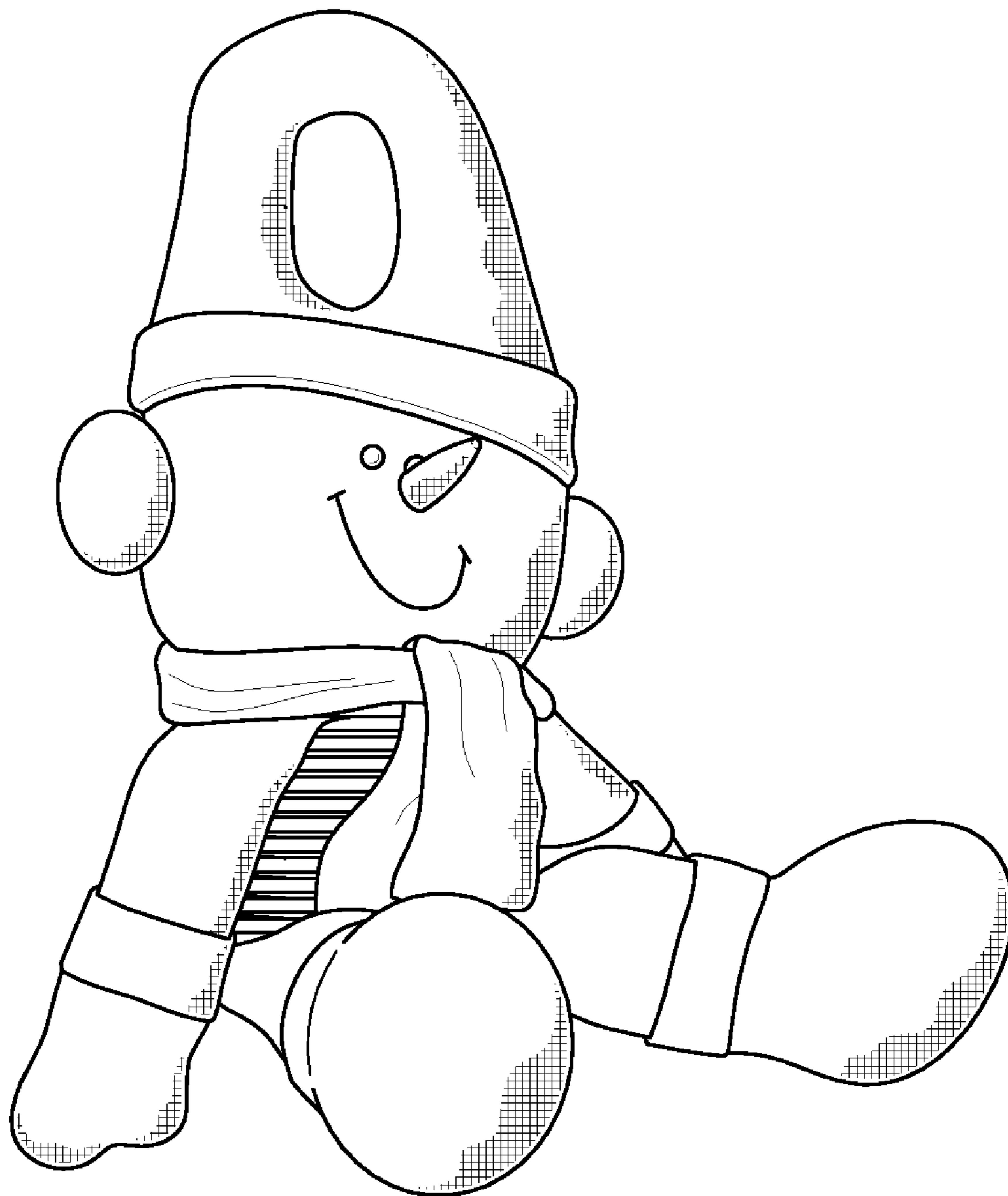

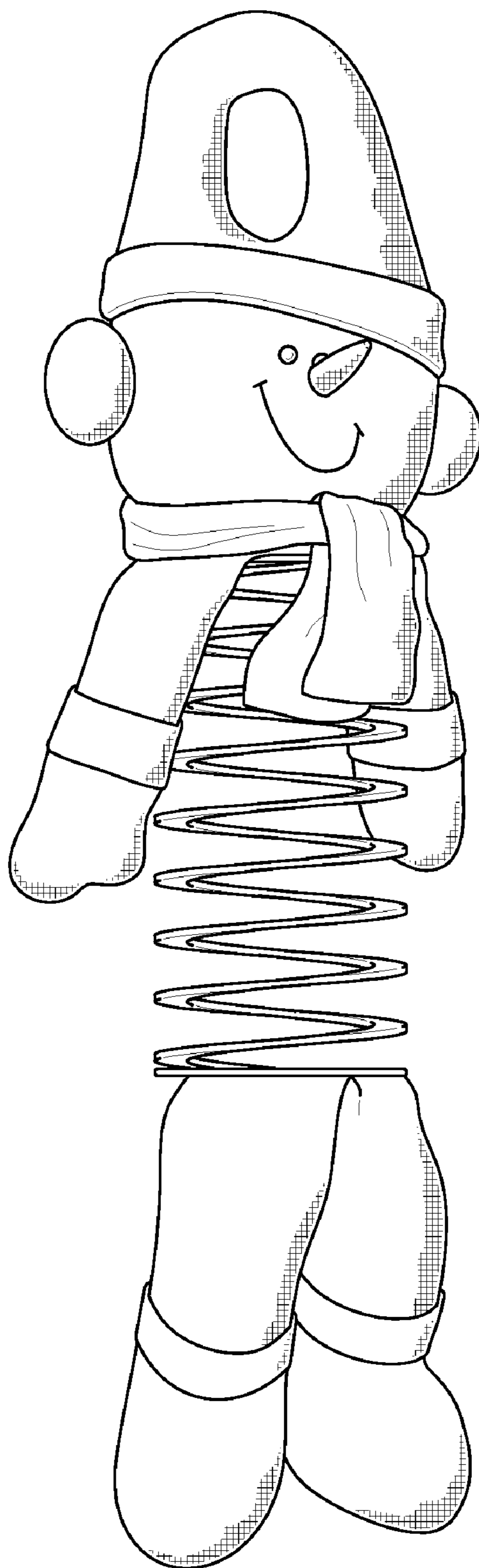

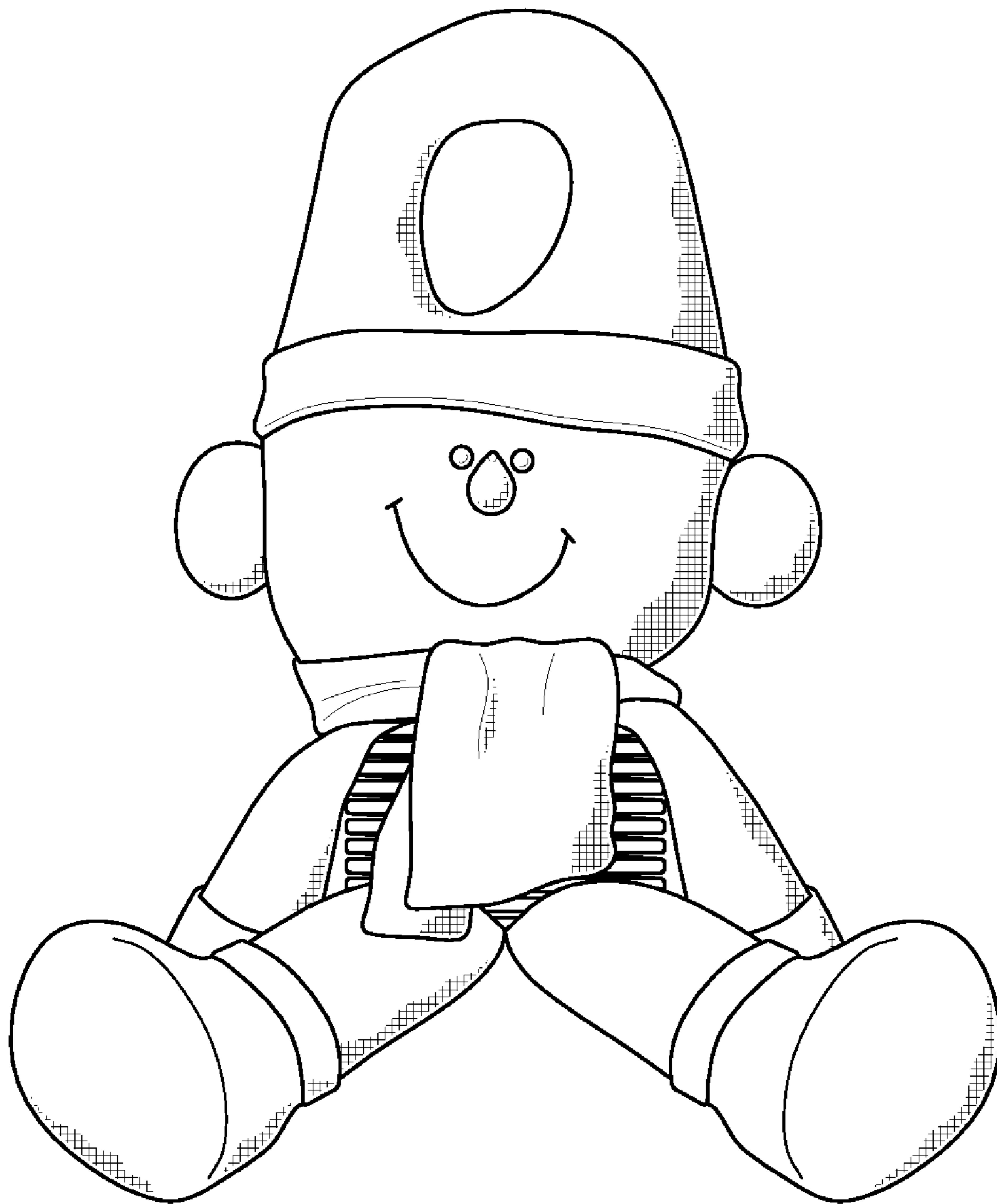

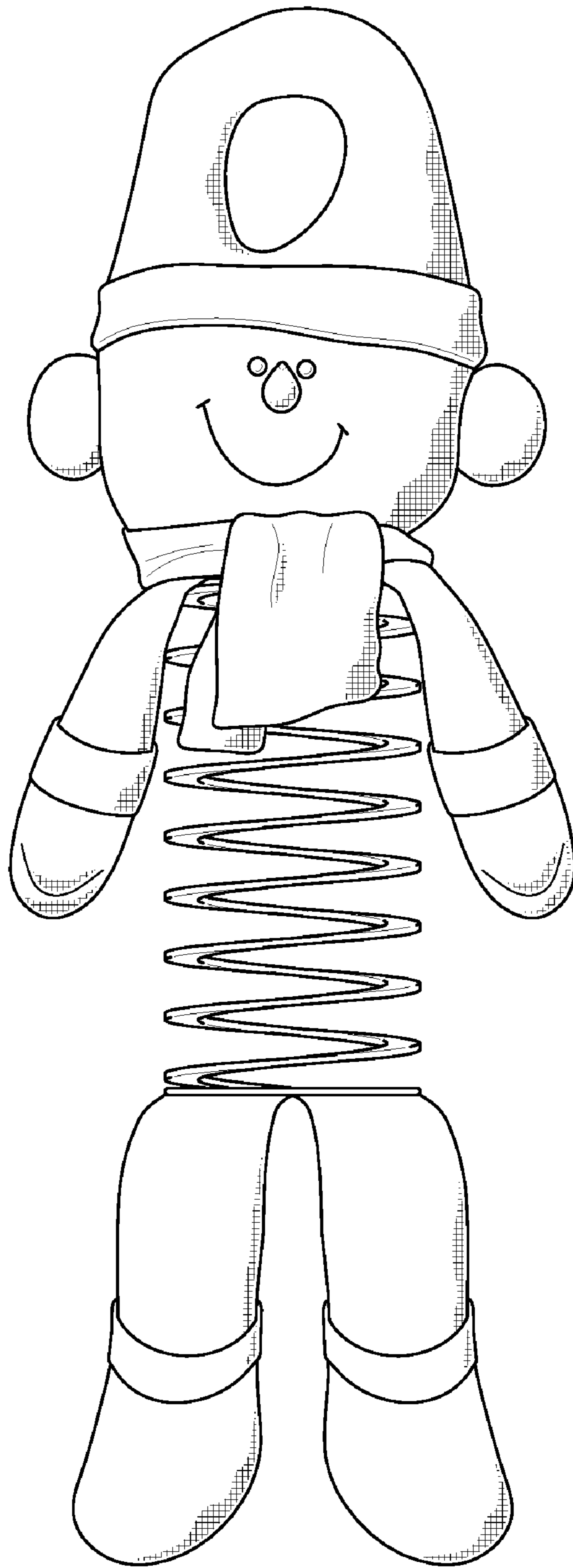

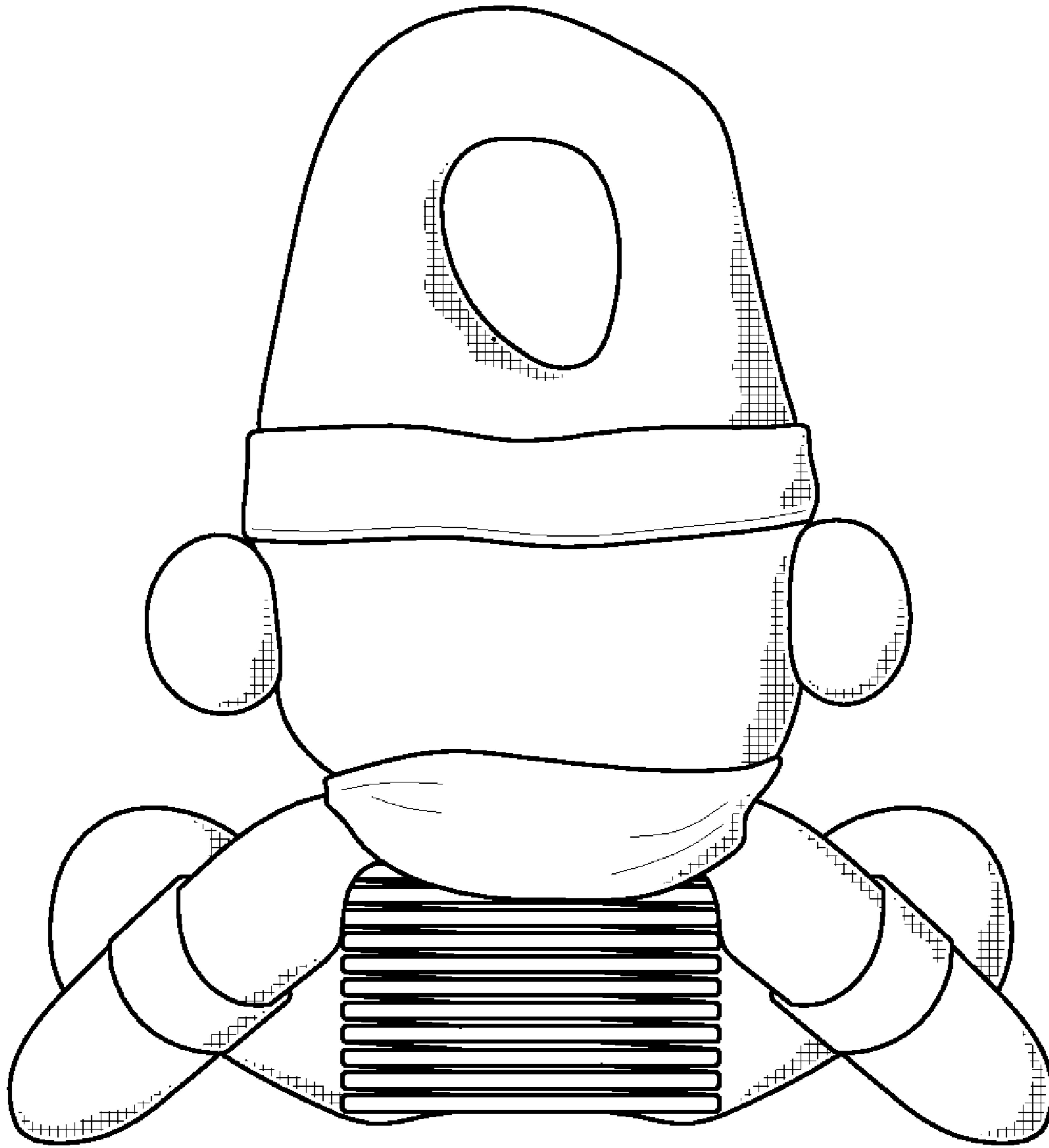

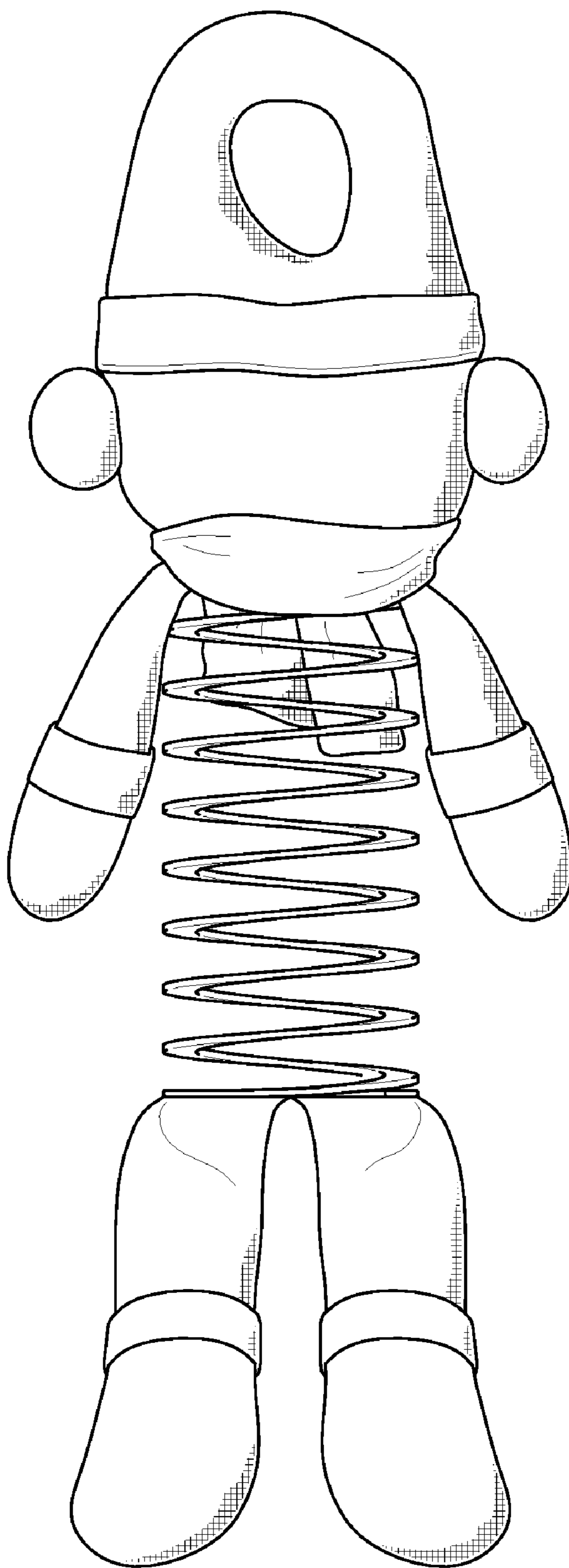

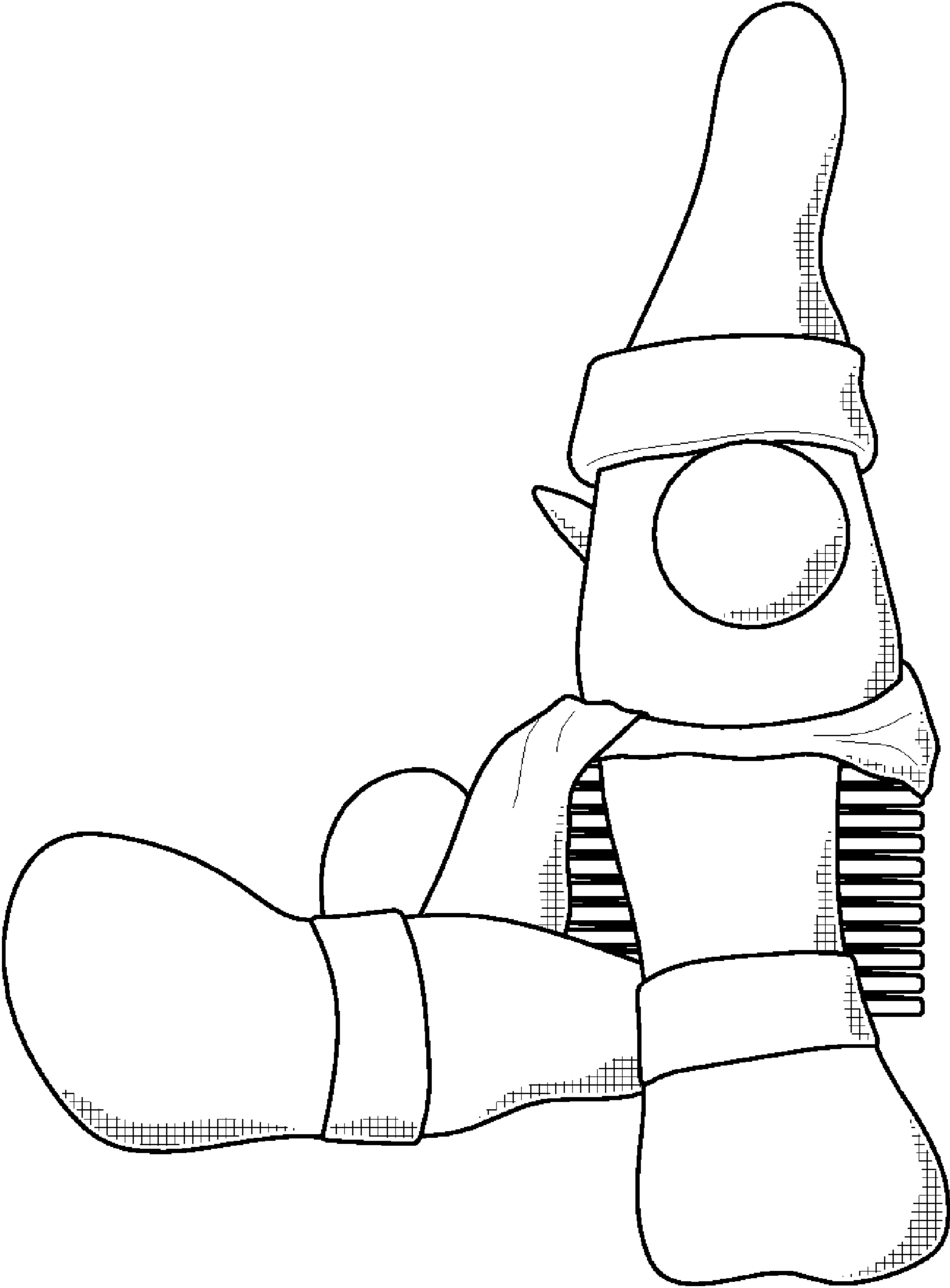

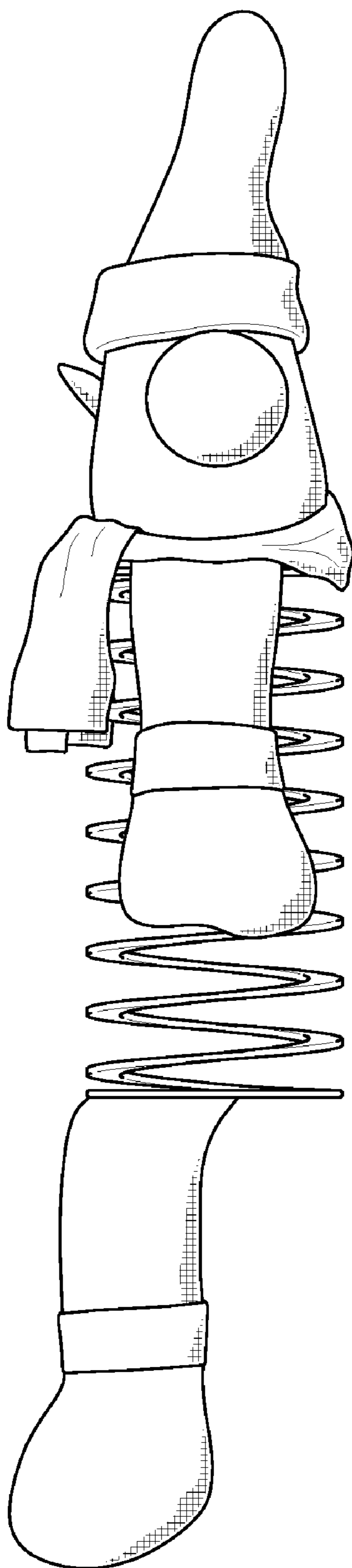

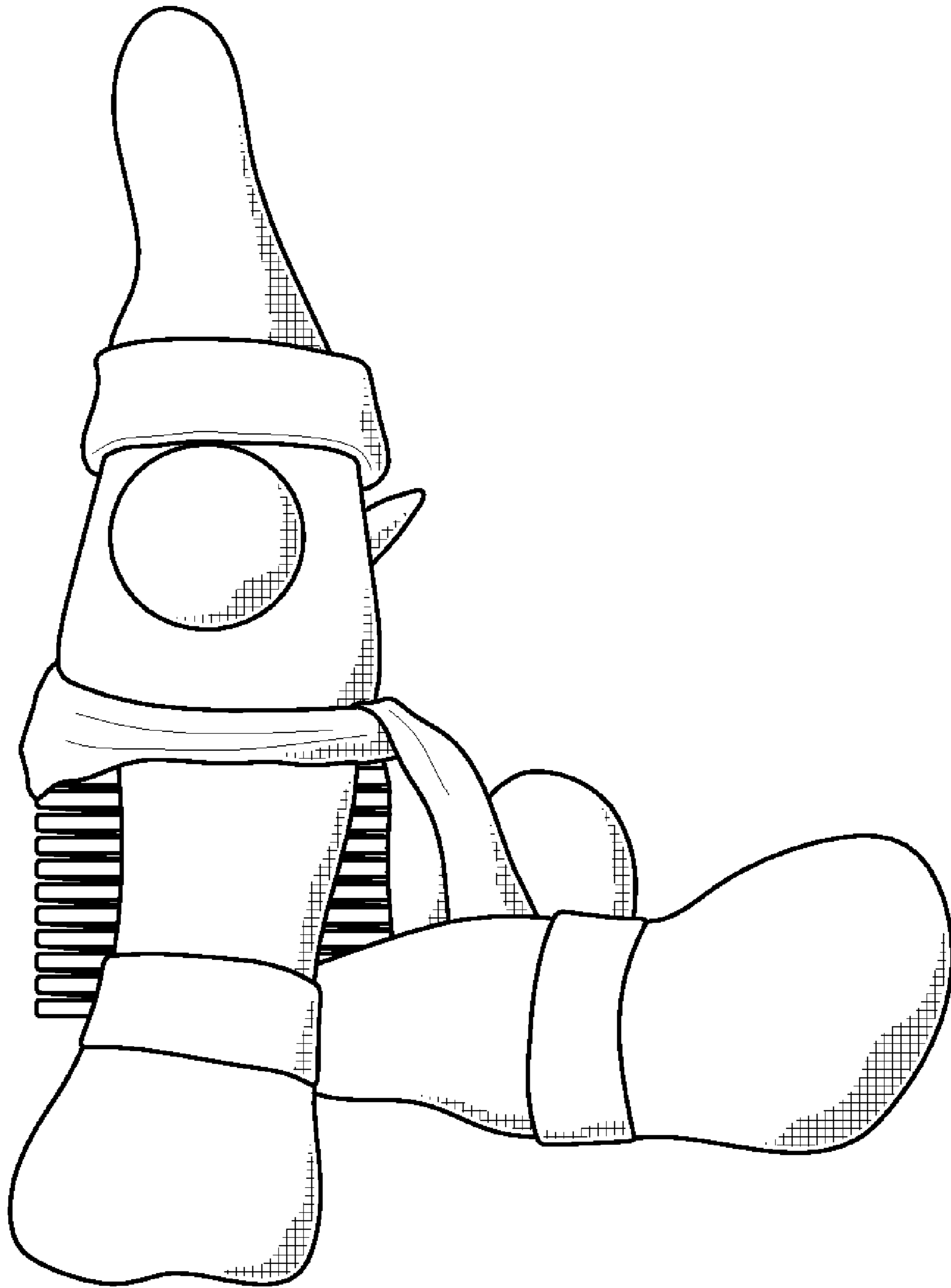

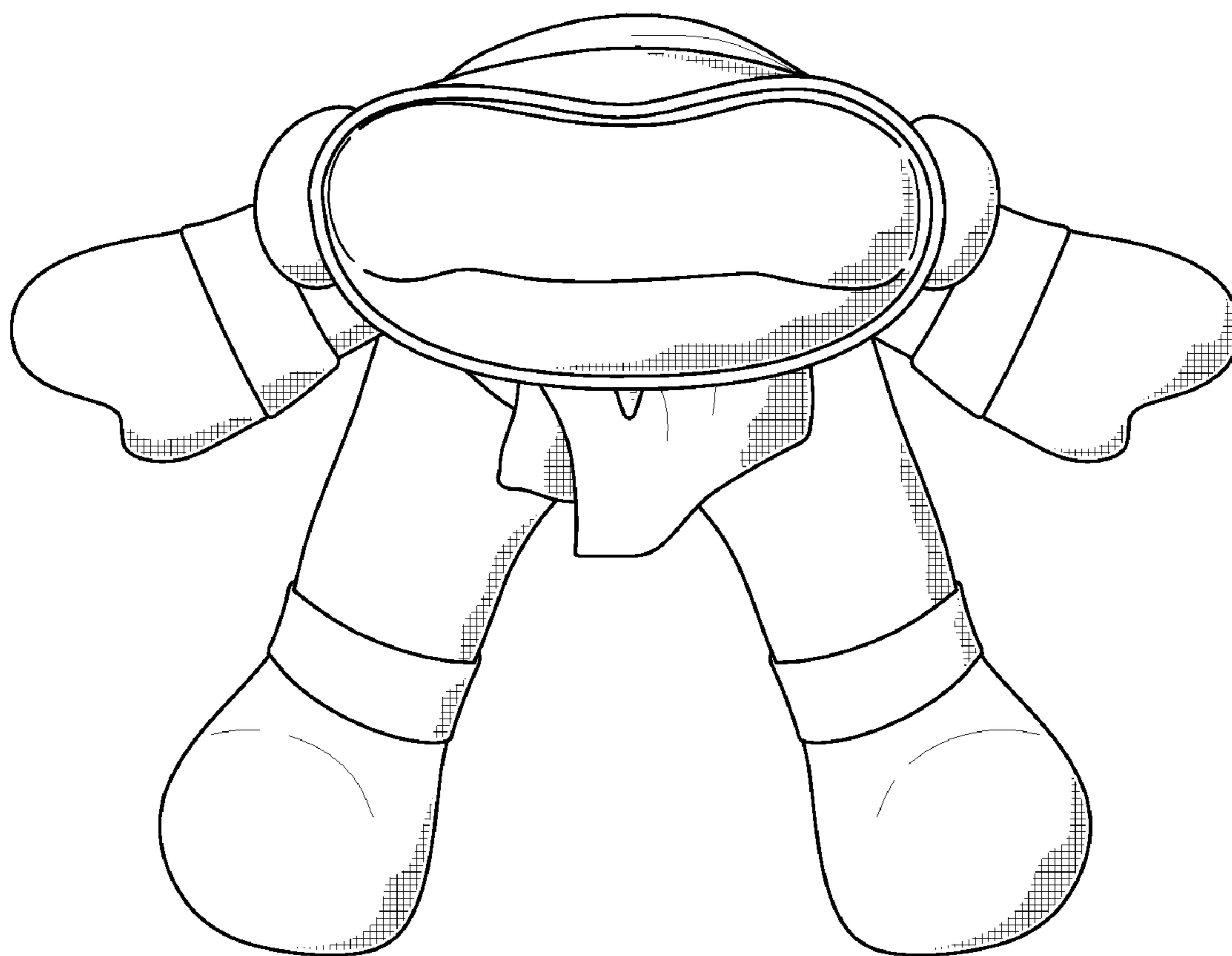

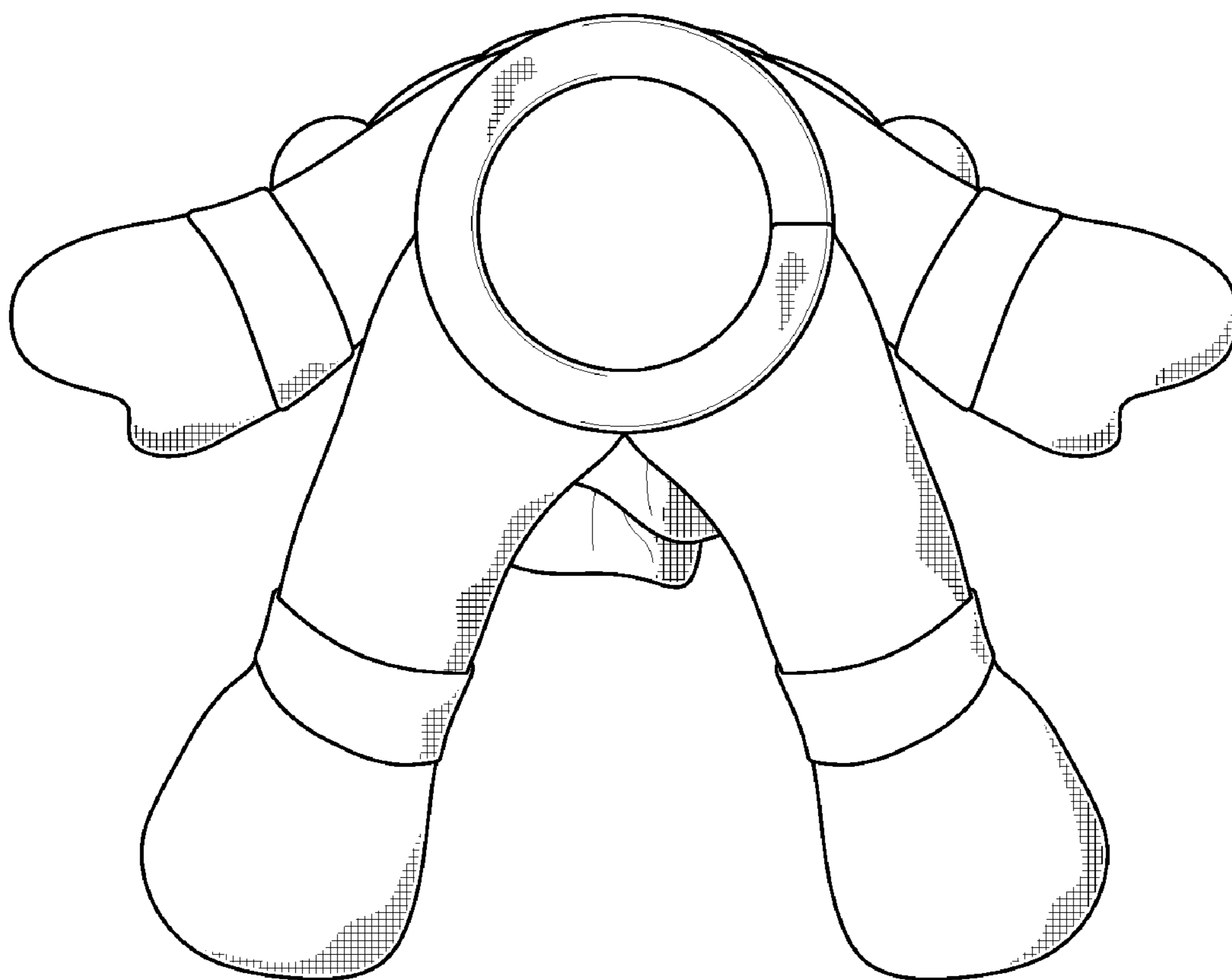
